(57) **CLAIM**

The ornamental design for a screw bit putty knife, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a screw bit putty knife showing our new design.

FIG. 2 is a bottom perspective view thereof.

FIG. 3 is a top plan view thereof.

FIG. 4 is a left elevational side view thereof.

FIG. 5 is a bottom plan view thereof

FIG. 6 is a right elevational side view thereof.

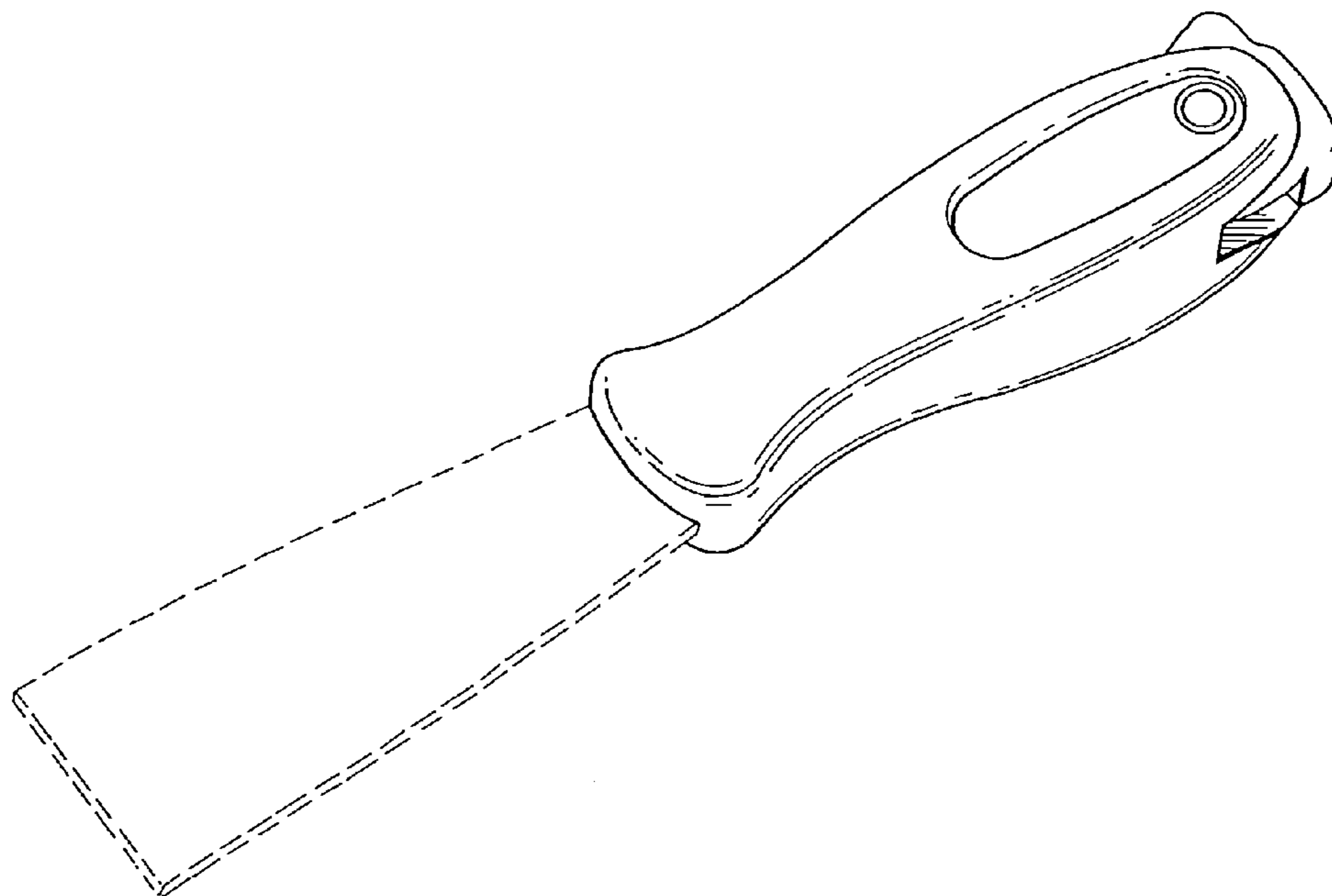
FIG. 7 is a front elevational view thereof.

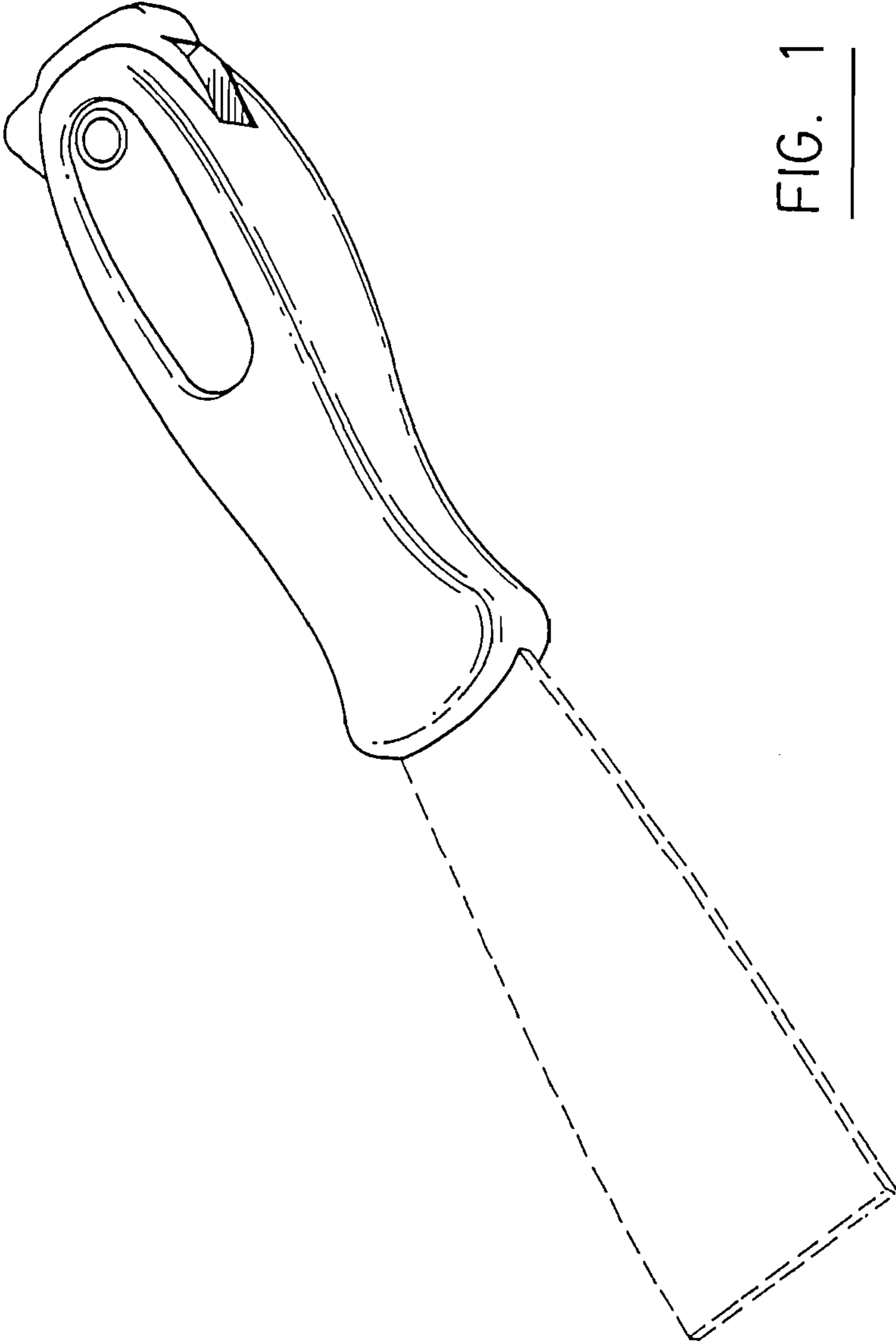

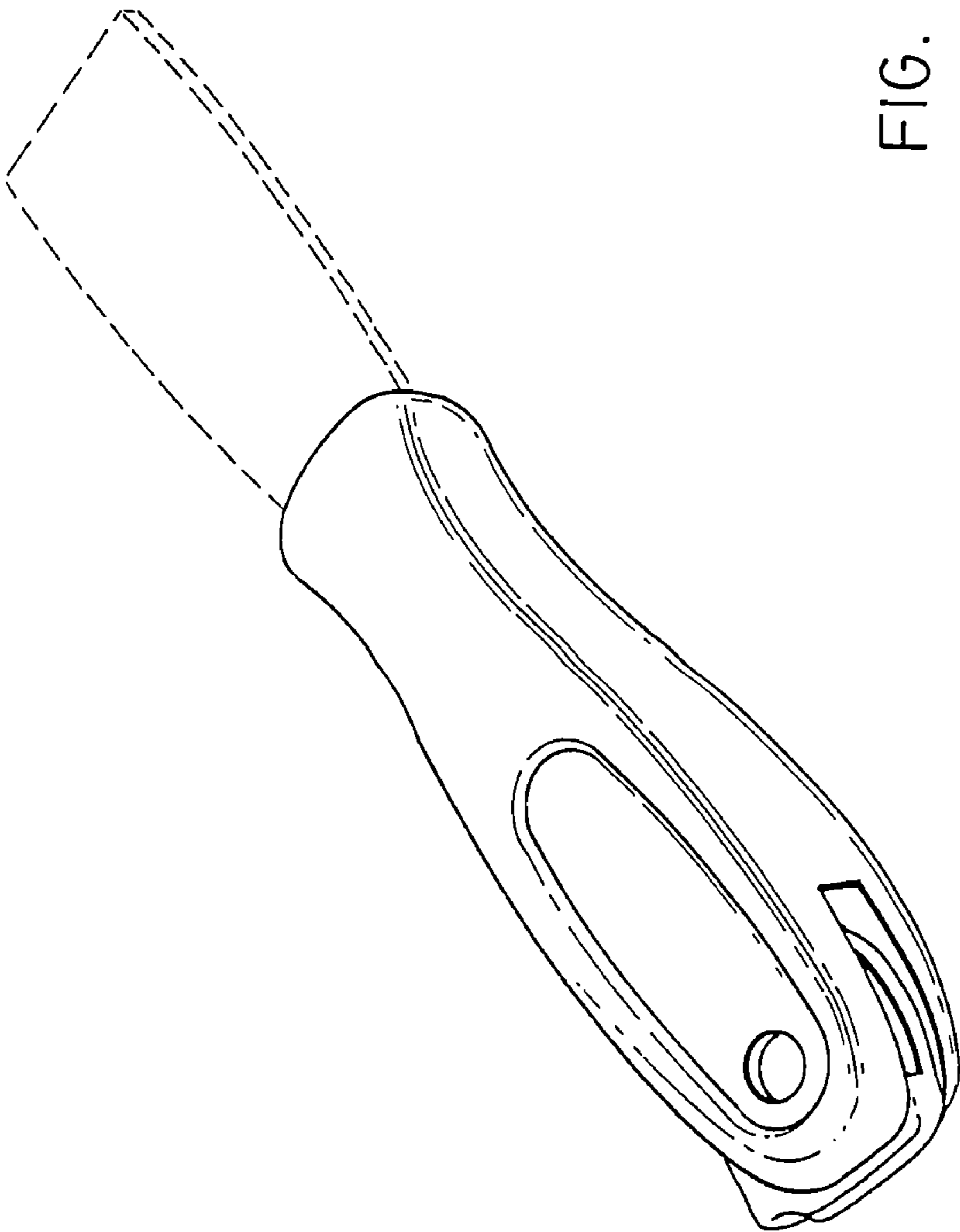

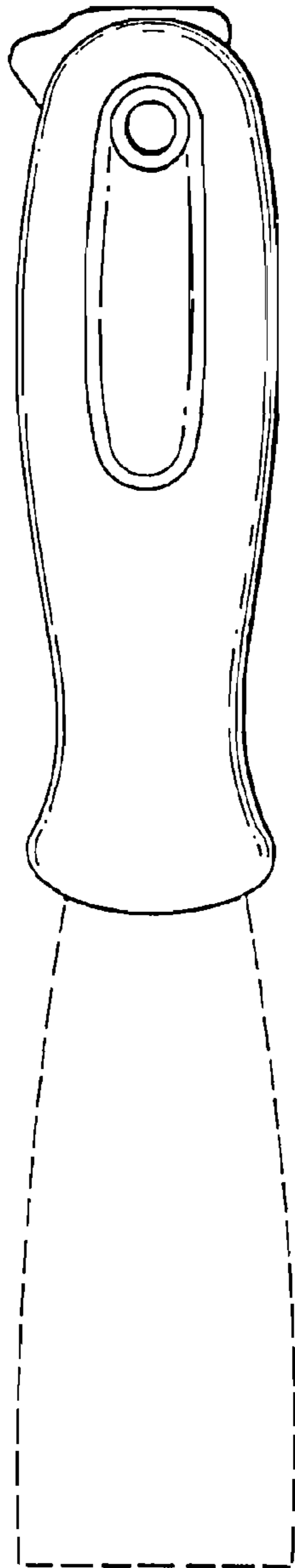

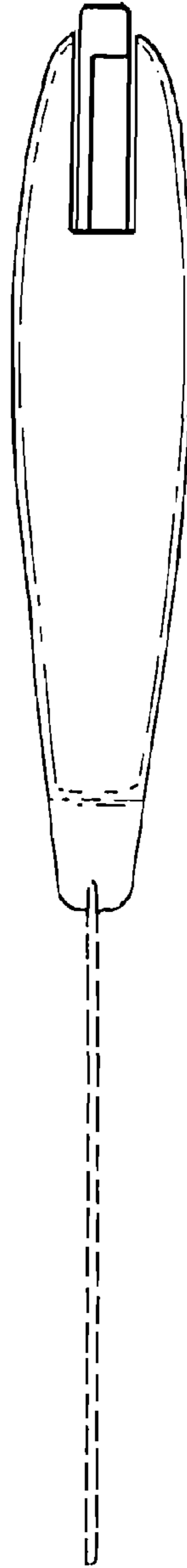

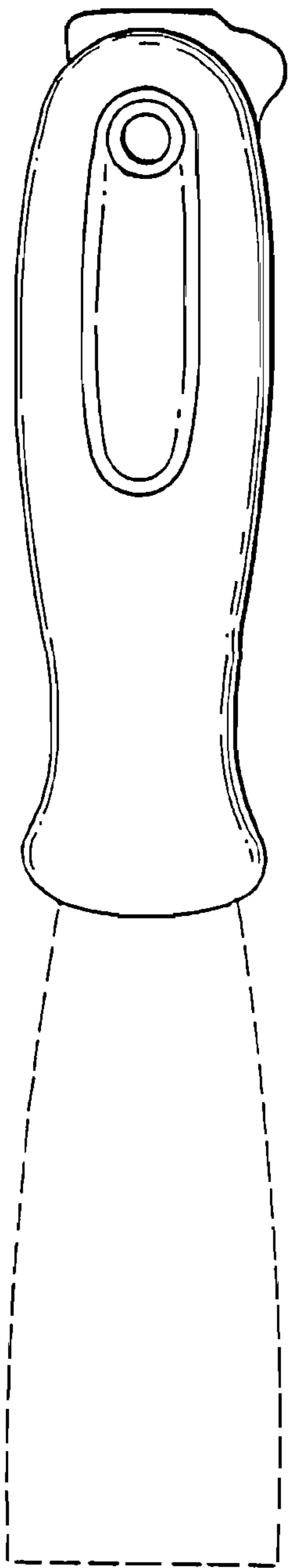

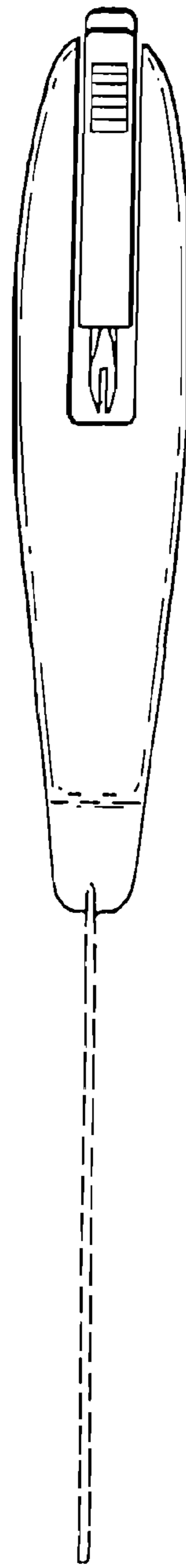

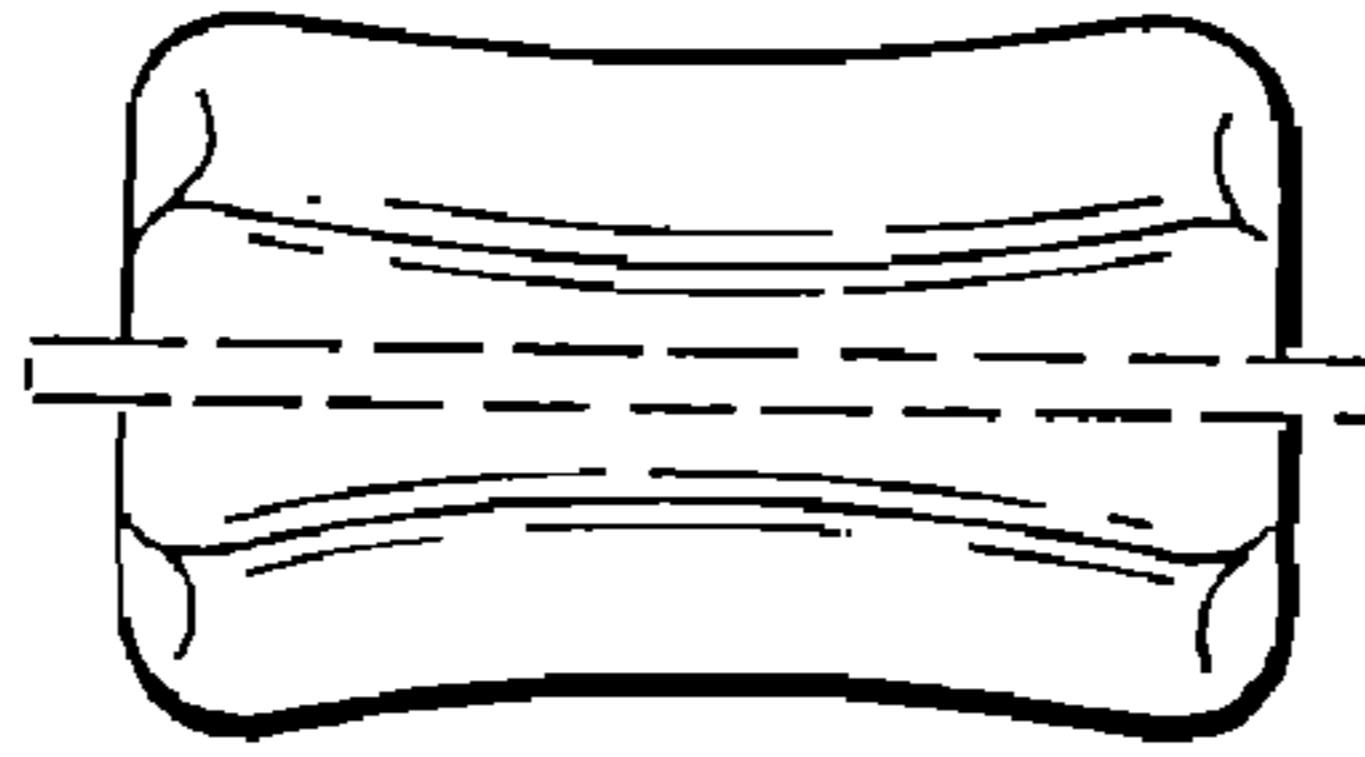

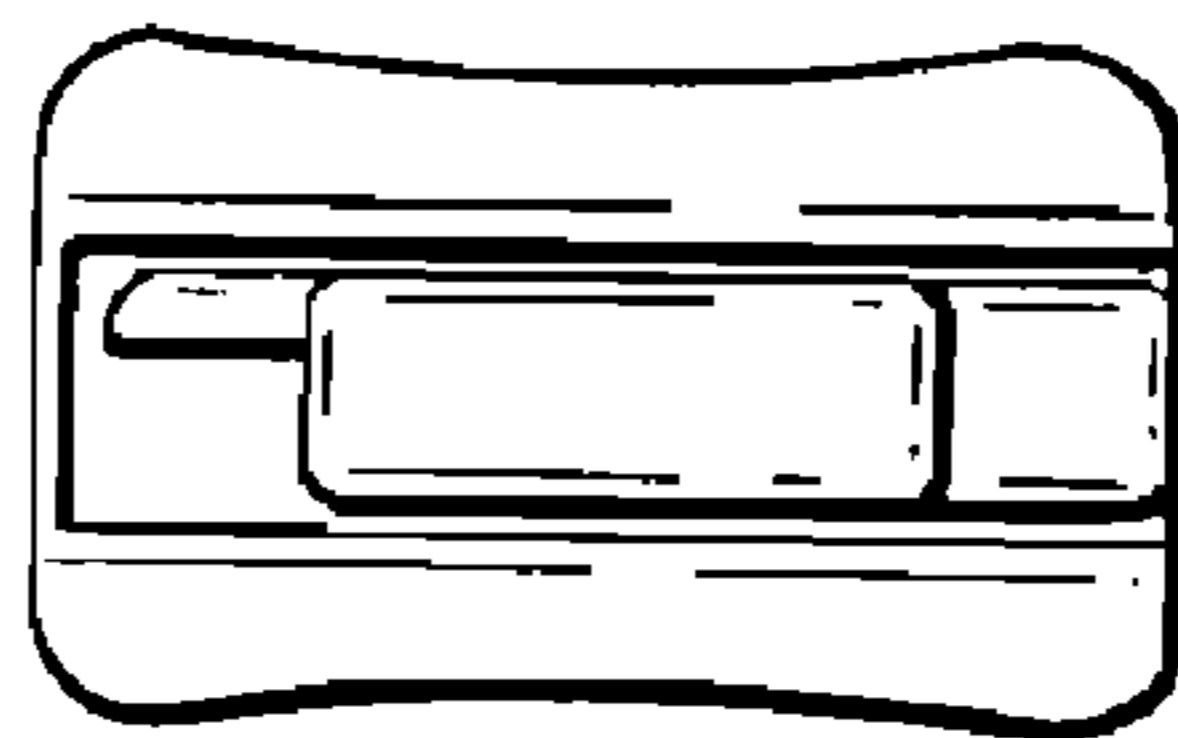

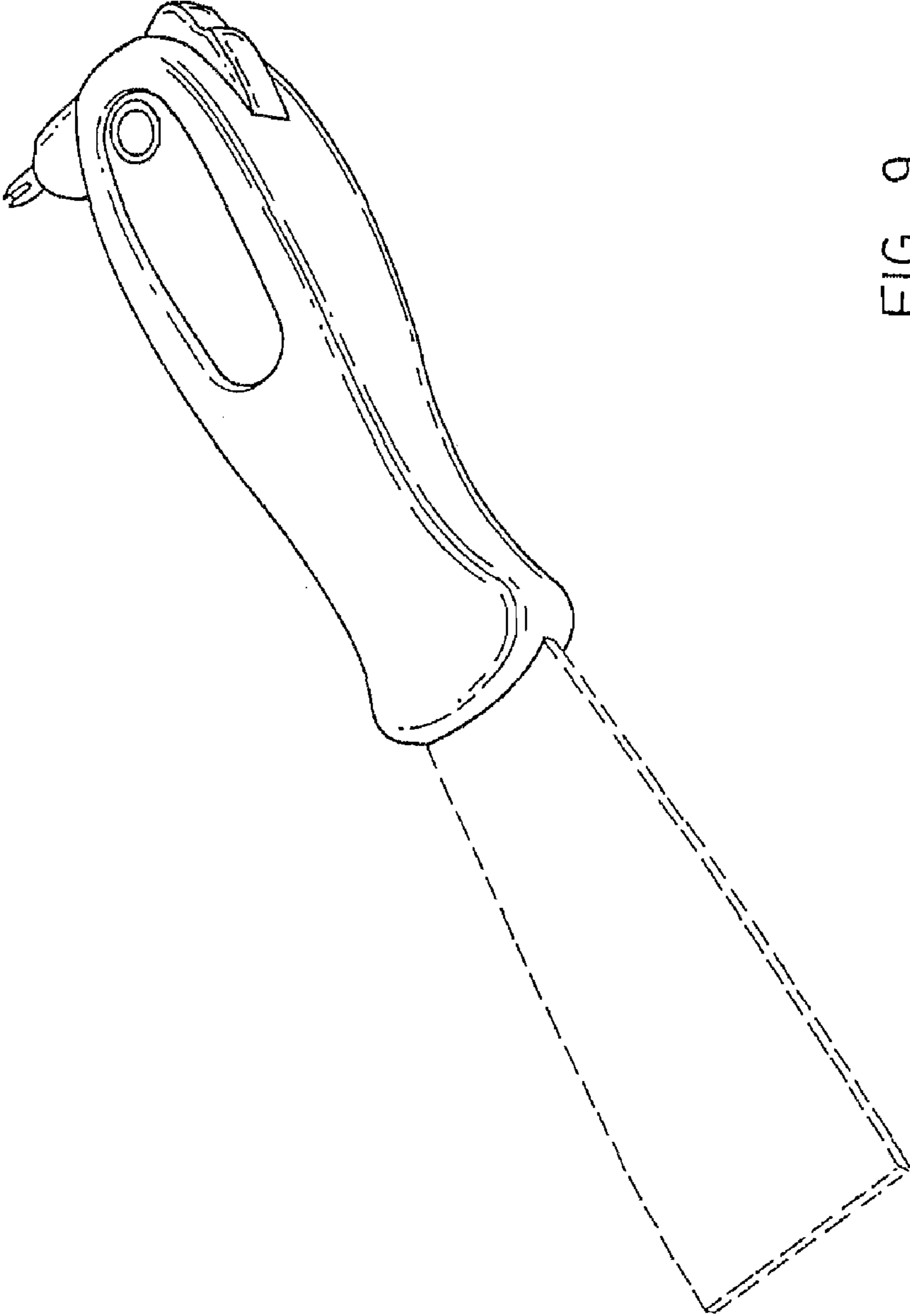
