(57) **CLAIM**

The ornamental design for a can cover, as shown and described.

DESCRIPTION

FIG. 1 is an upper perspective view of a can cover positioned on a broken line can showing the new design;

FIG. 2 is a front side elevation view of the new design, and the rear side elevation view thereof is the same as the front side elevation view;

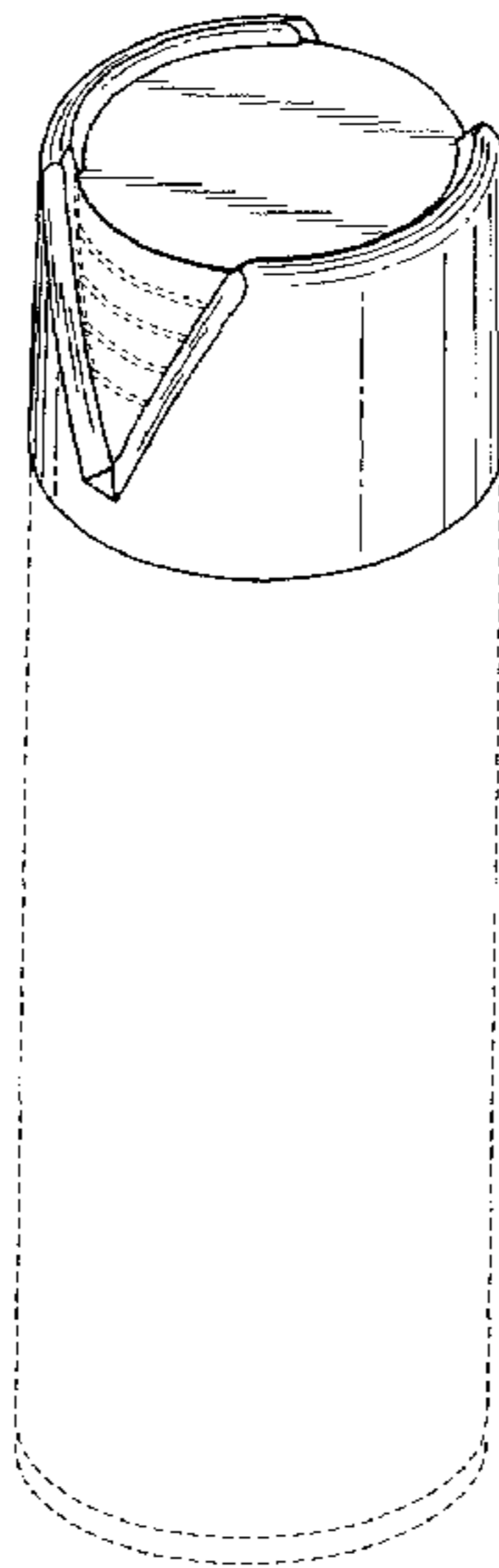
FIG. 3 is a left side elevation view of the new design, and the right side elevation view thereof is the same as the left side elevation view;

FIG. 4 is a top plan view of the new design; and,

FIG. 5 is a bottom plan view of the new design.

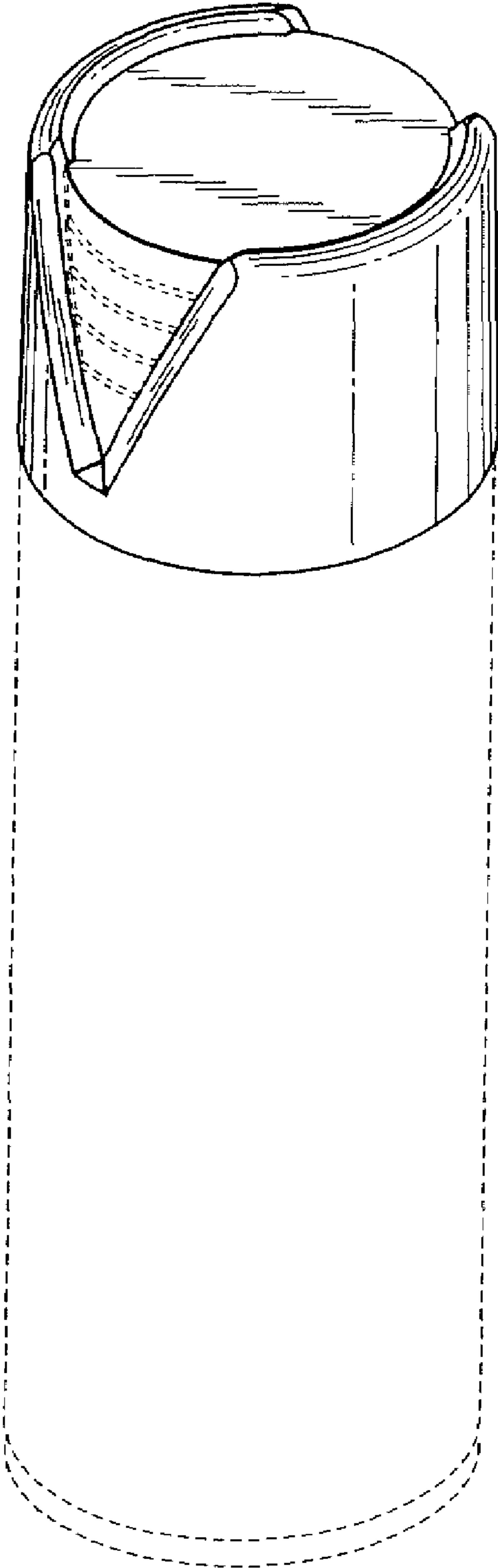

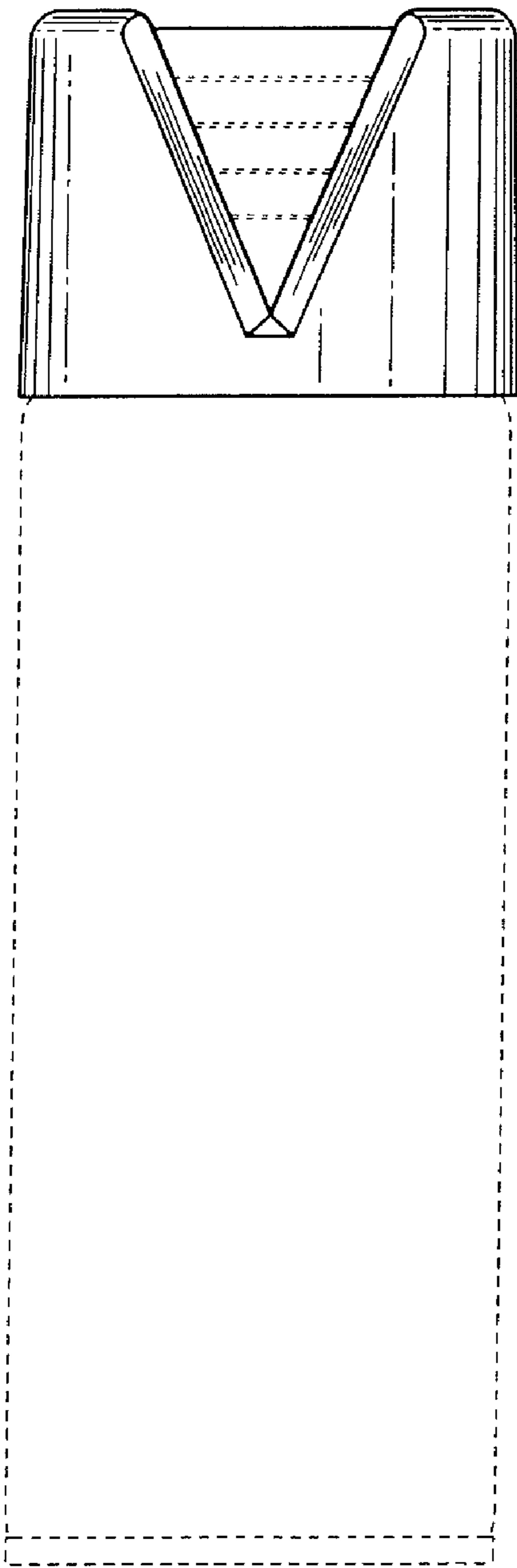

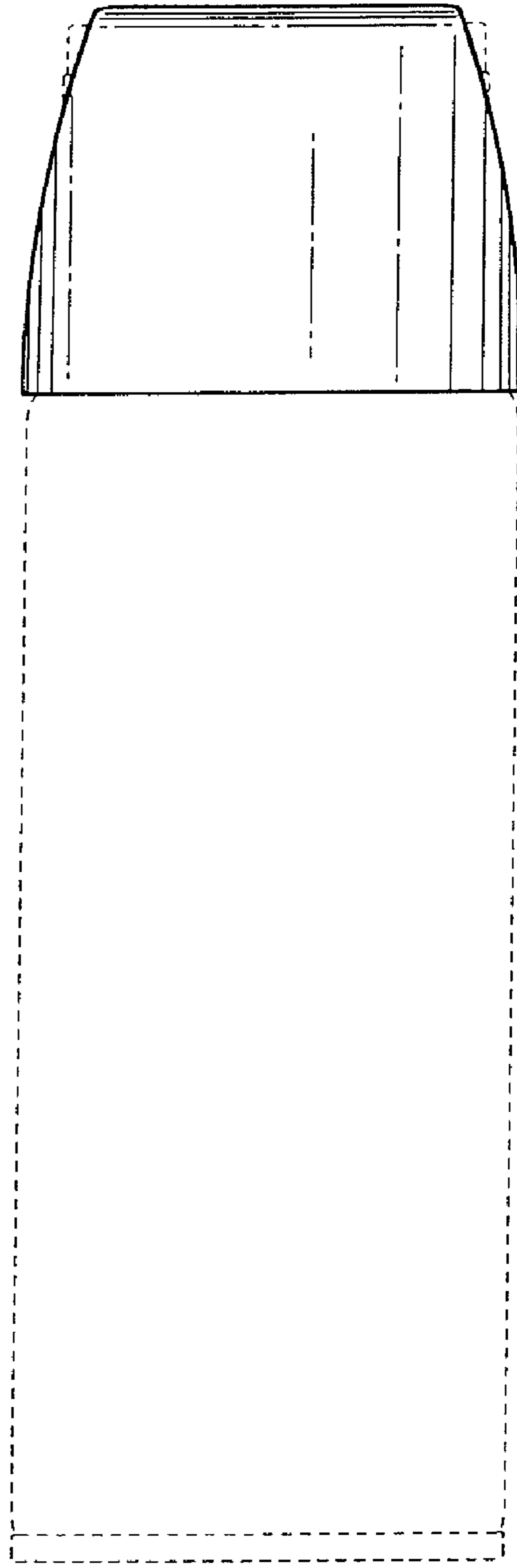

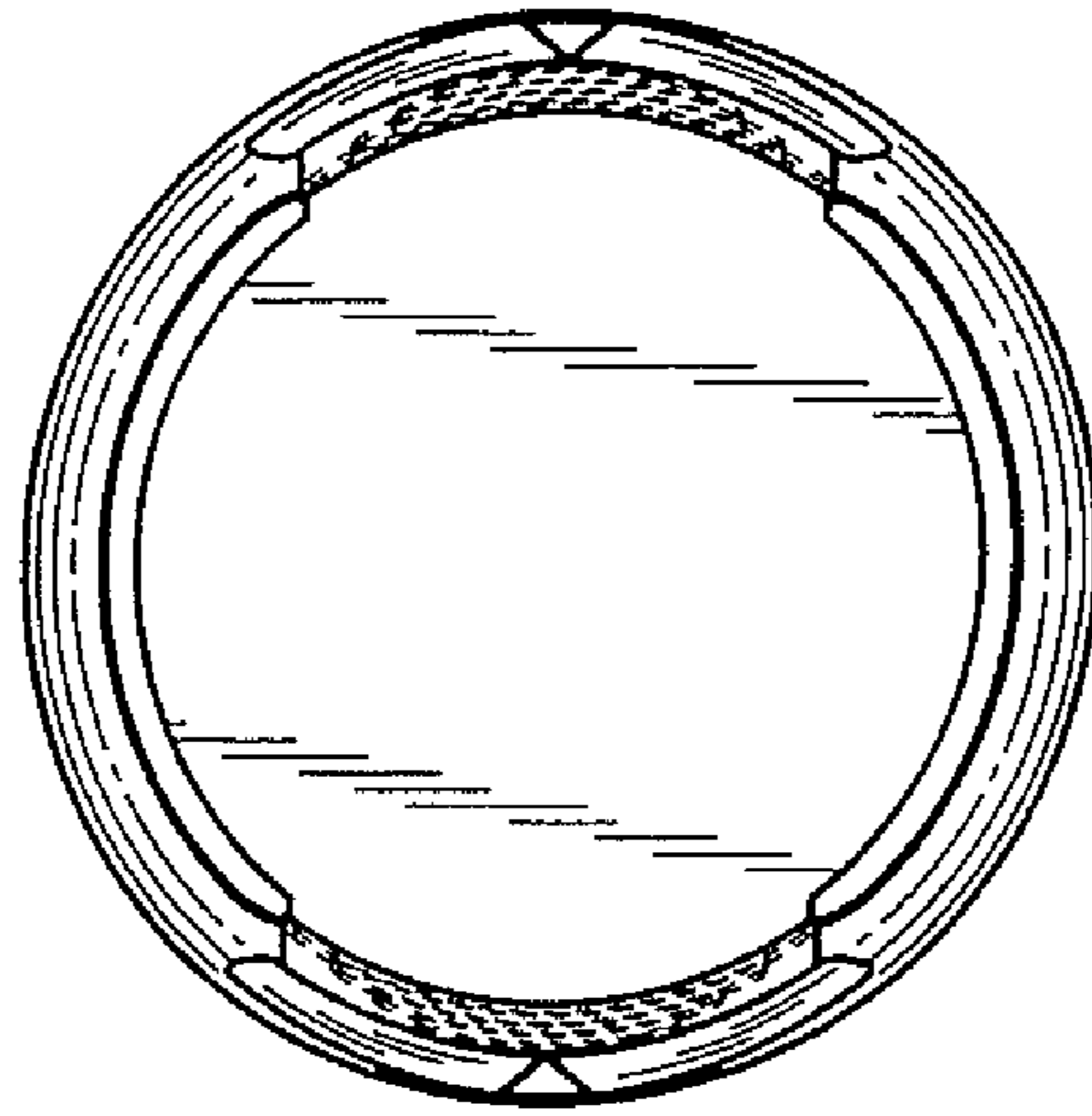

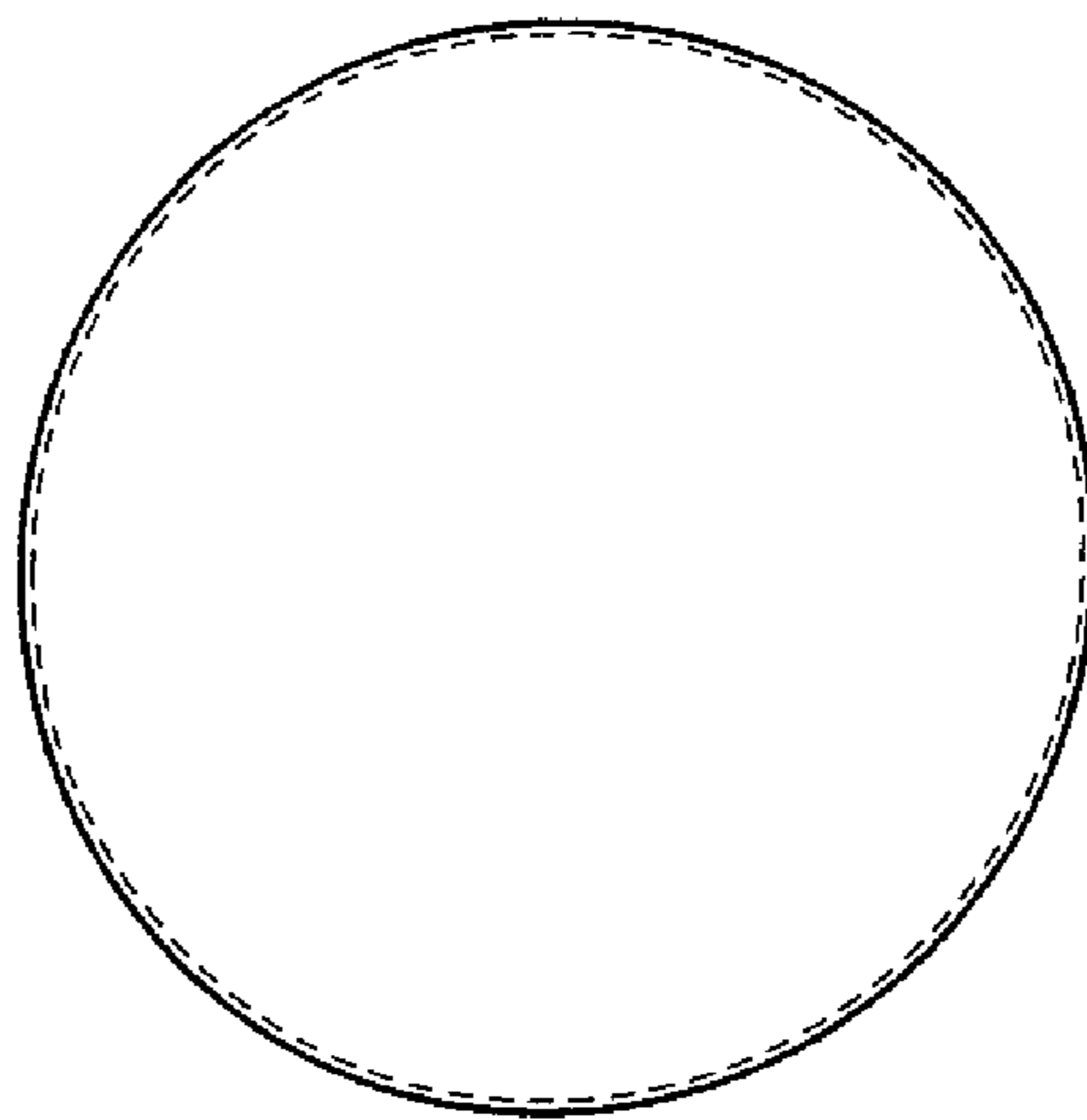
