DESCRIPTION

FIG. 1 is a front, right side and top perspective view of a package showing my new design;

FIG. 2 is a front, left side and bottom perspective view thereof.

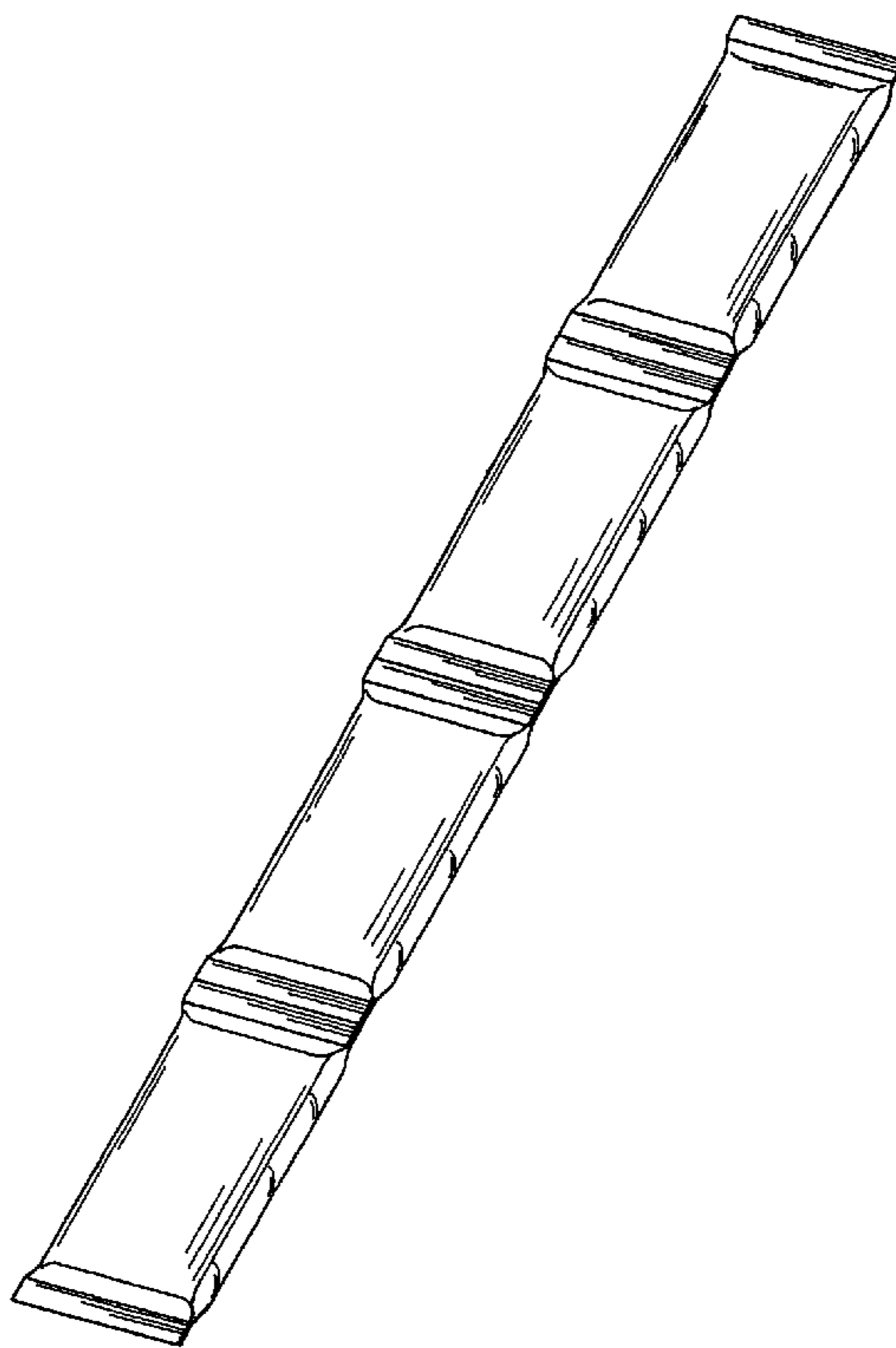
FIG. 3 is a front elevational view thereof.

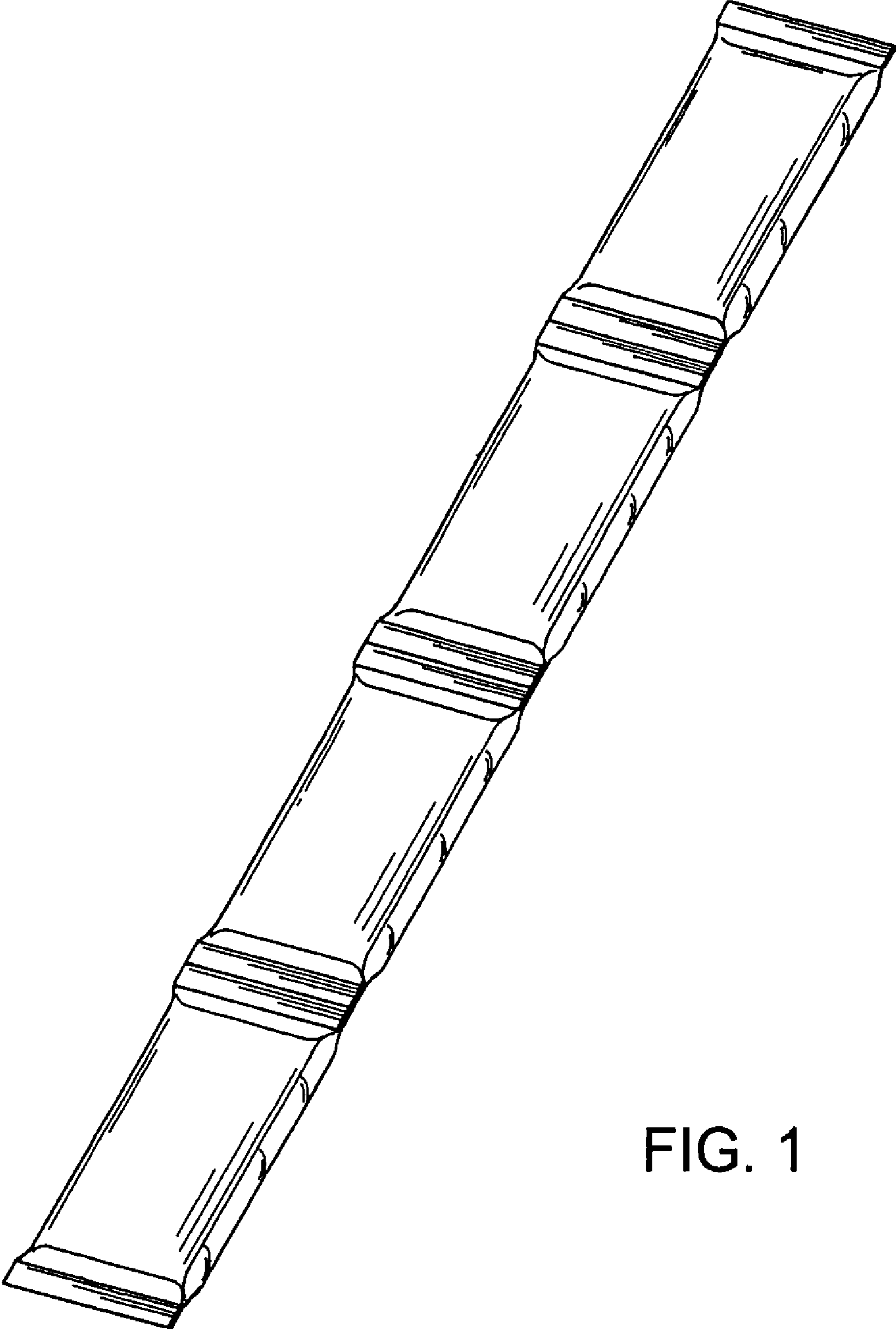

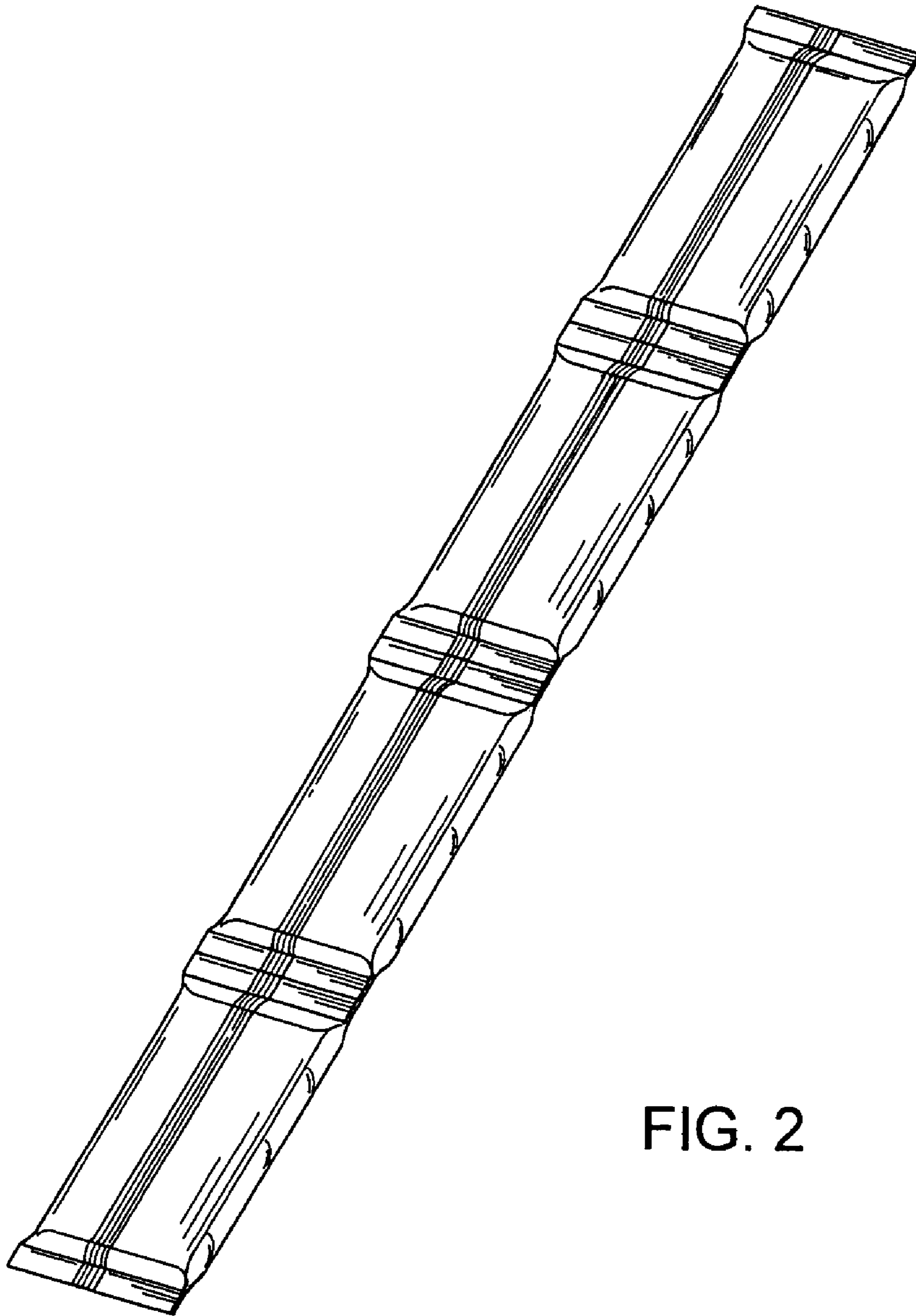

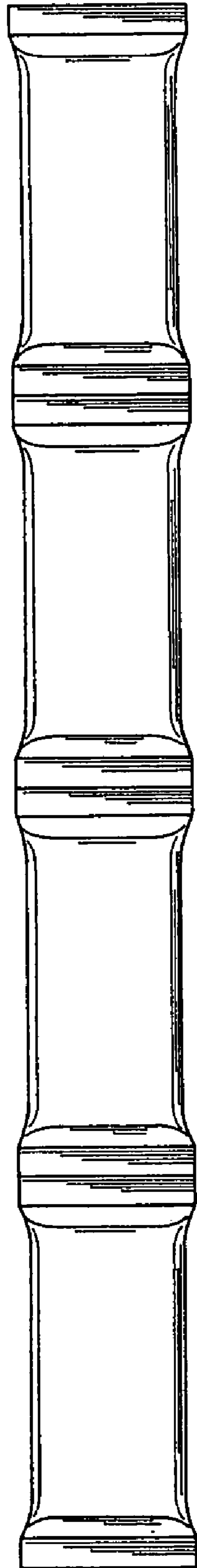

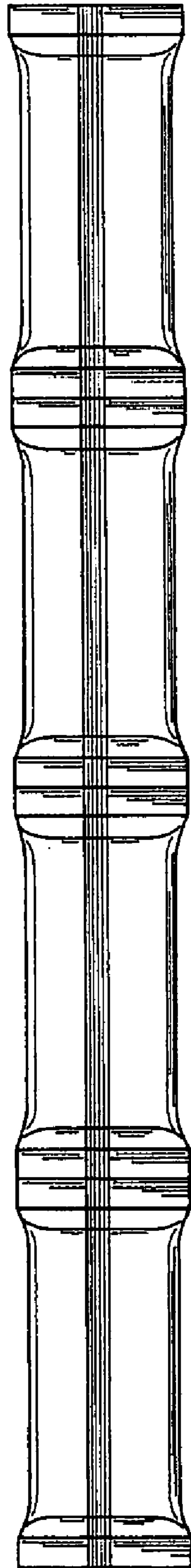

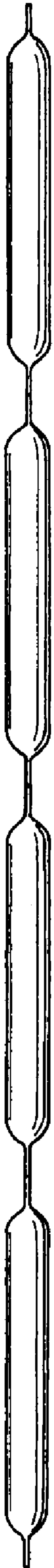

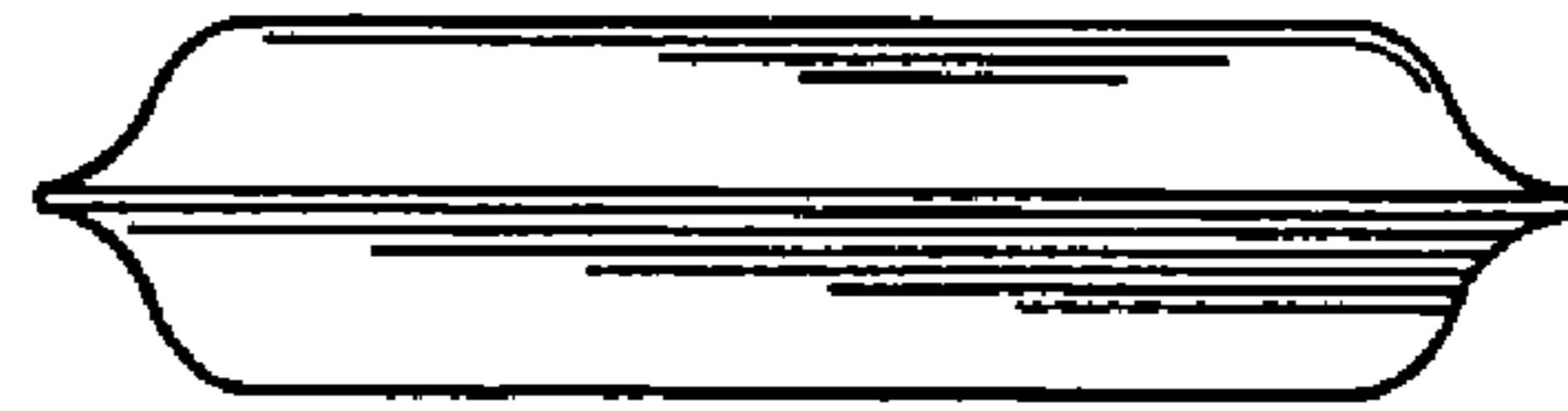
