FIG. 1 is an isometric view illustrating a second embodiment of a food tray incorporating my new design;

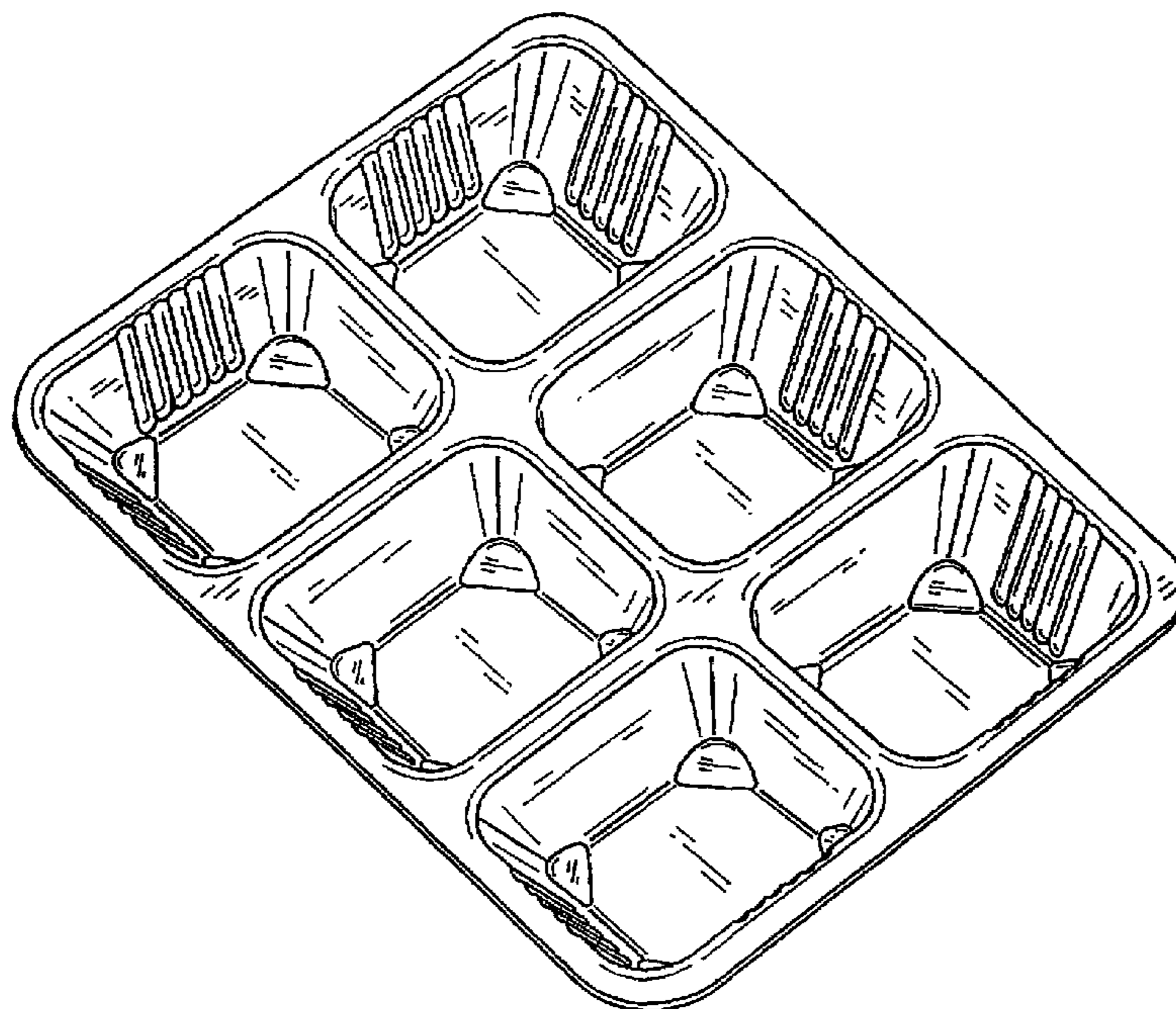
FIG. 2 is a top plan view thereof;

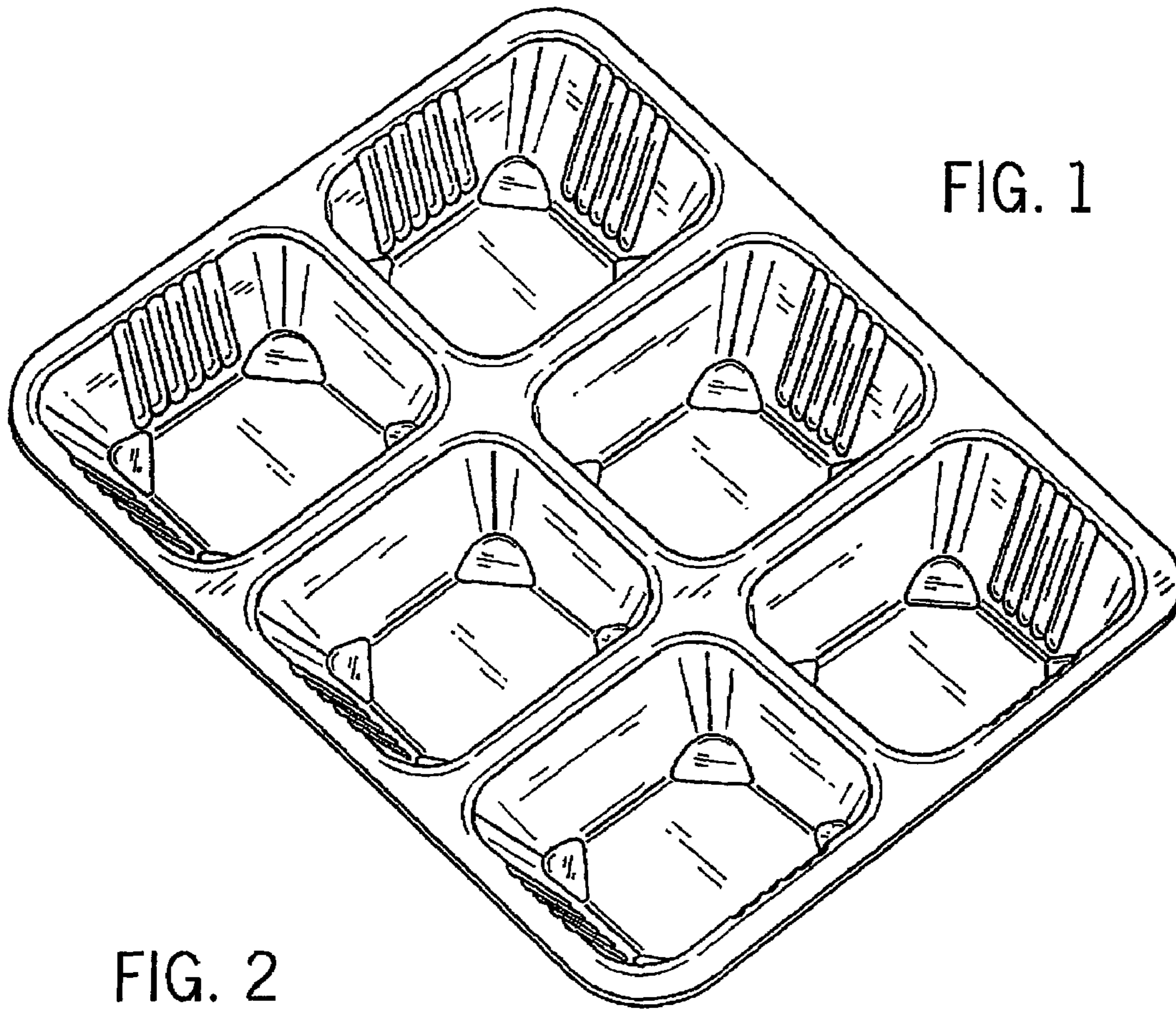
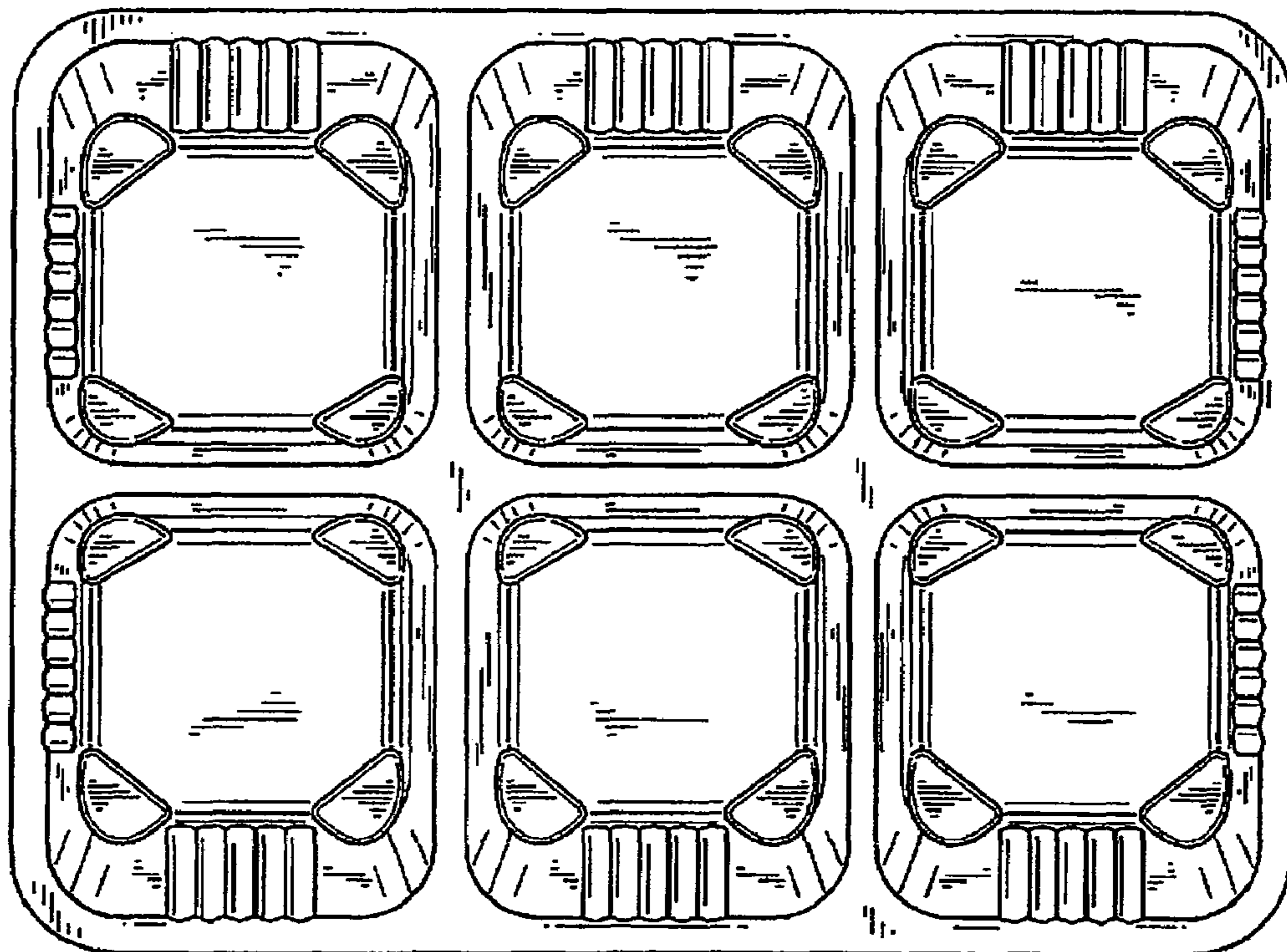

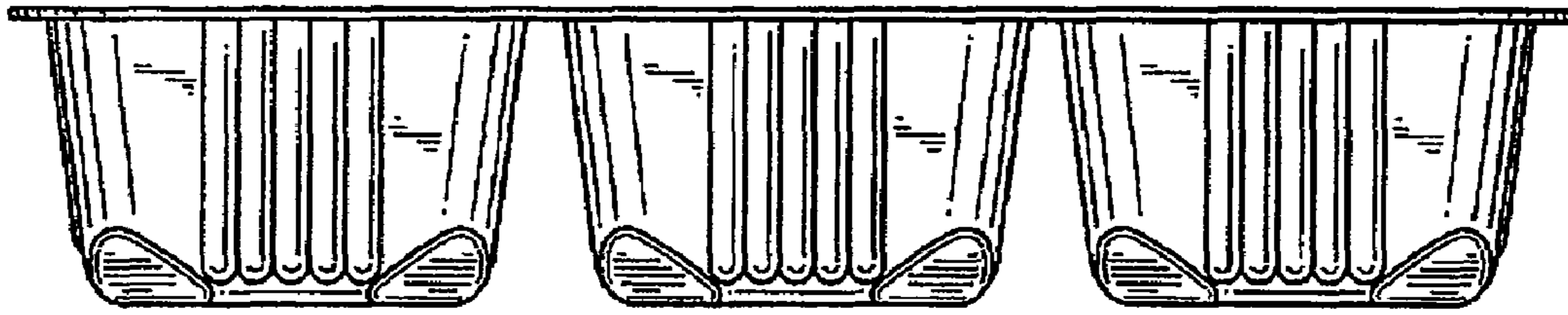

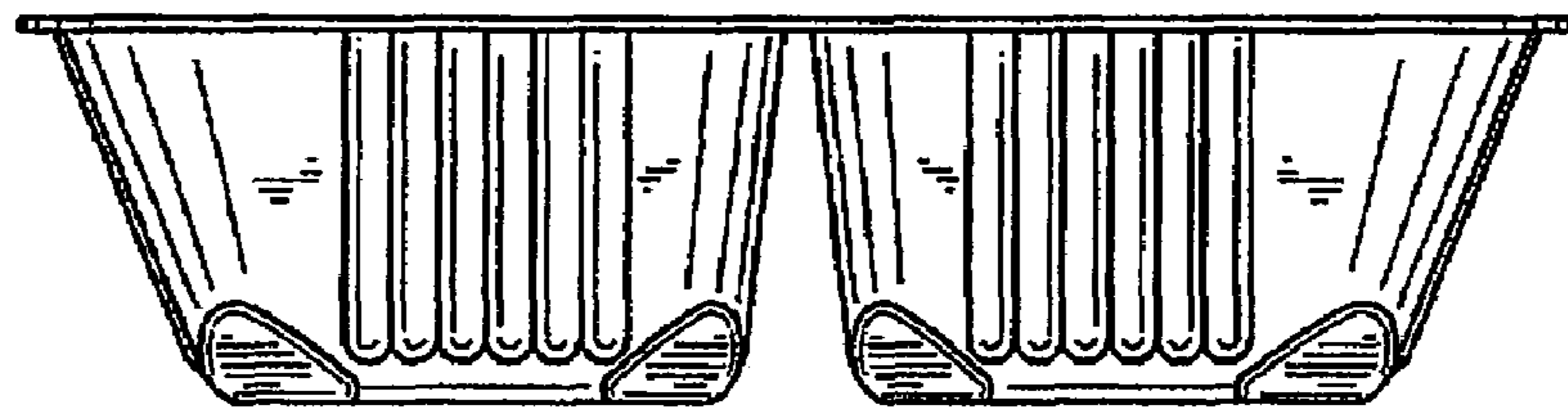

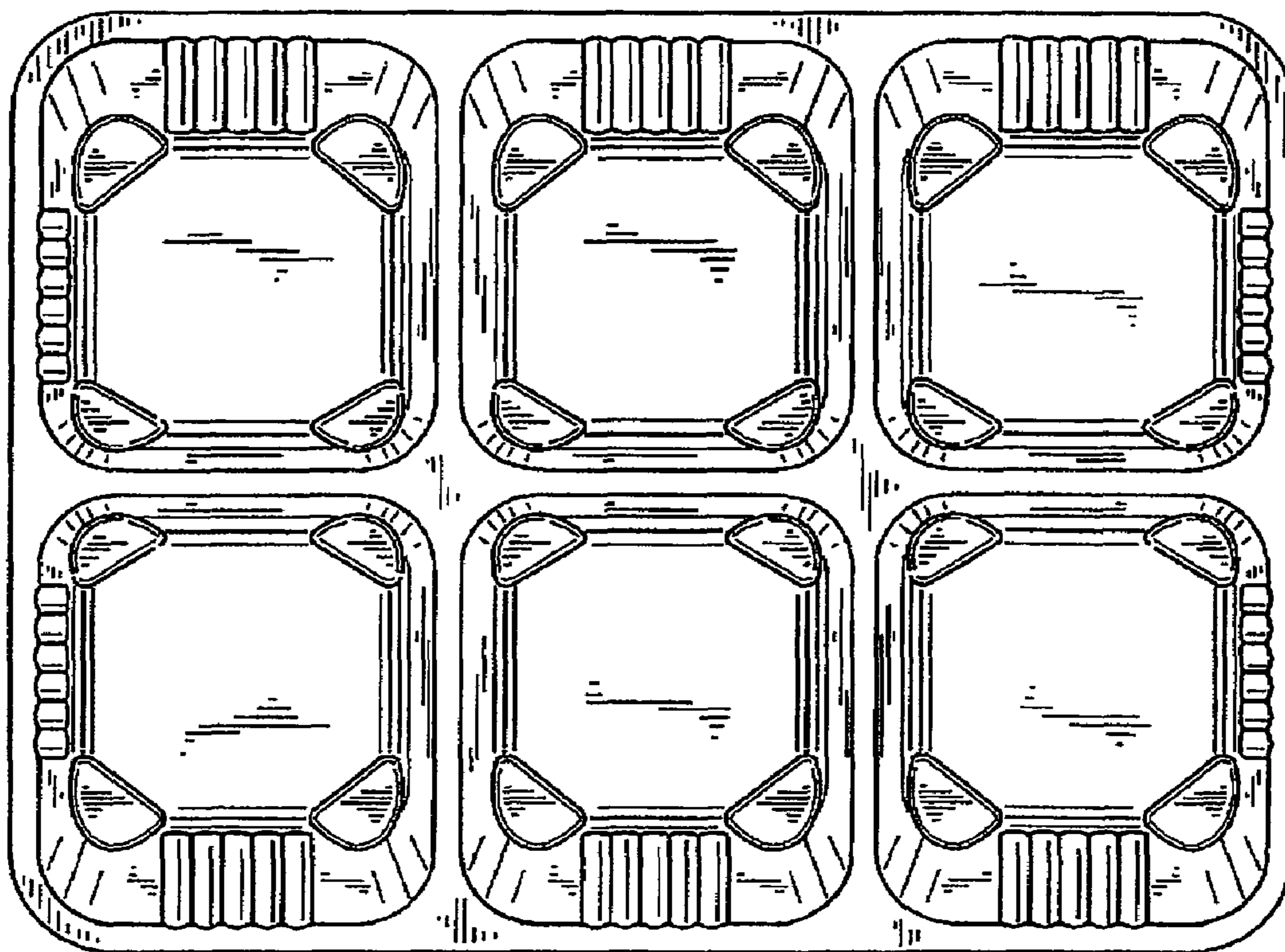
