FIG. 2 is a first side elevation view thereof;

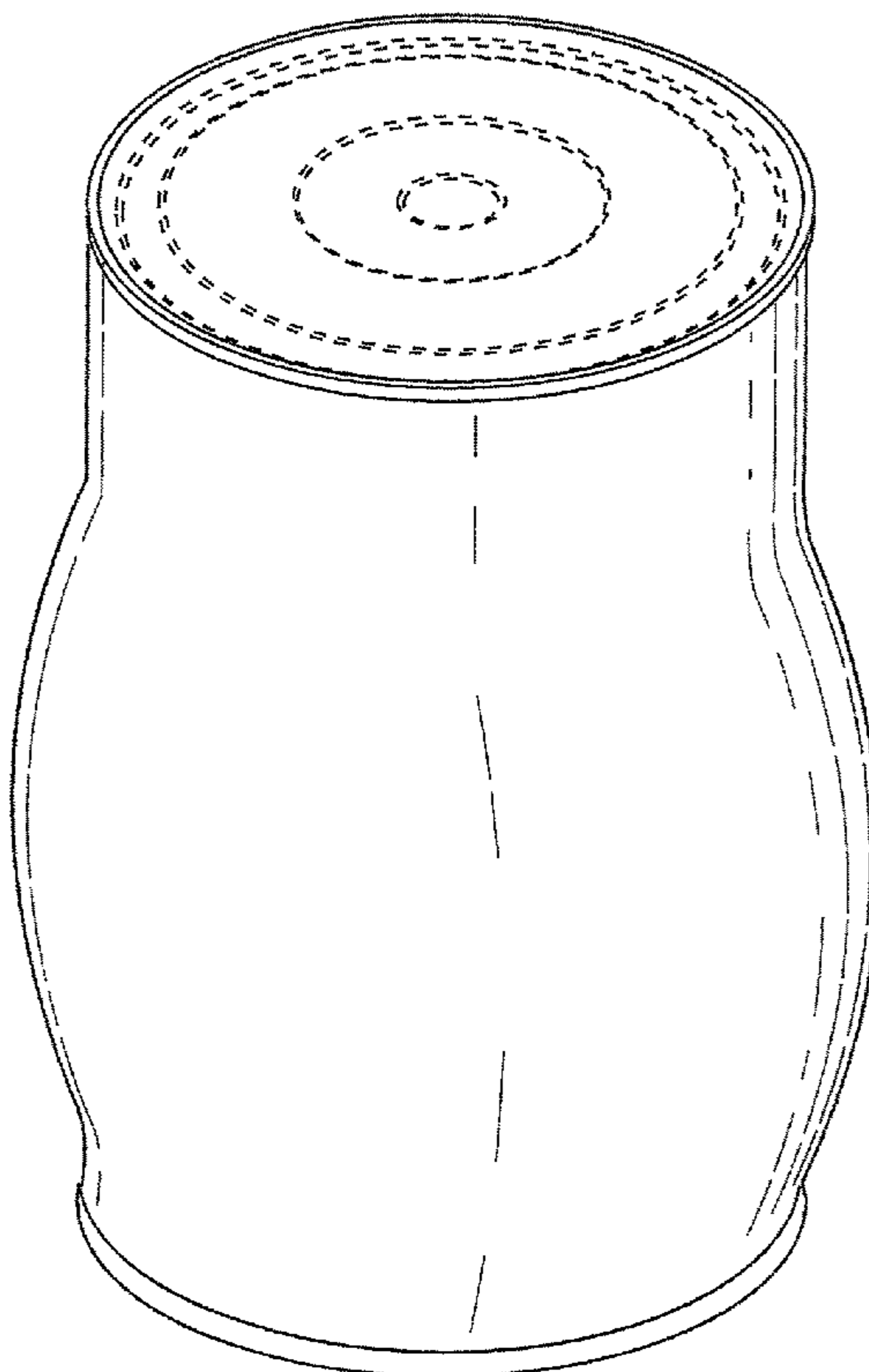
FIG. 3 is a second side elevation view thereof;

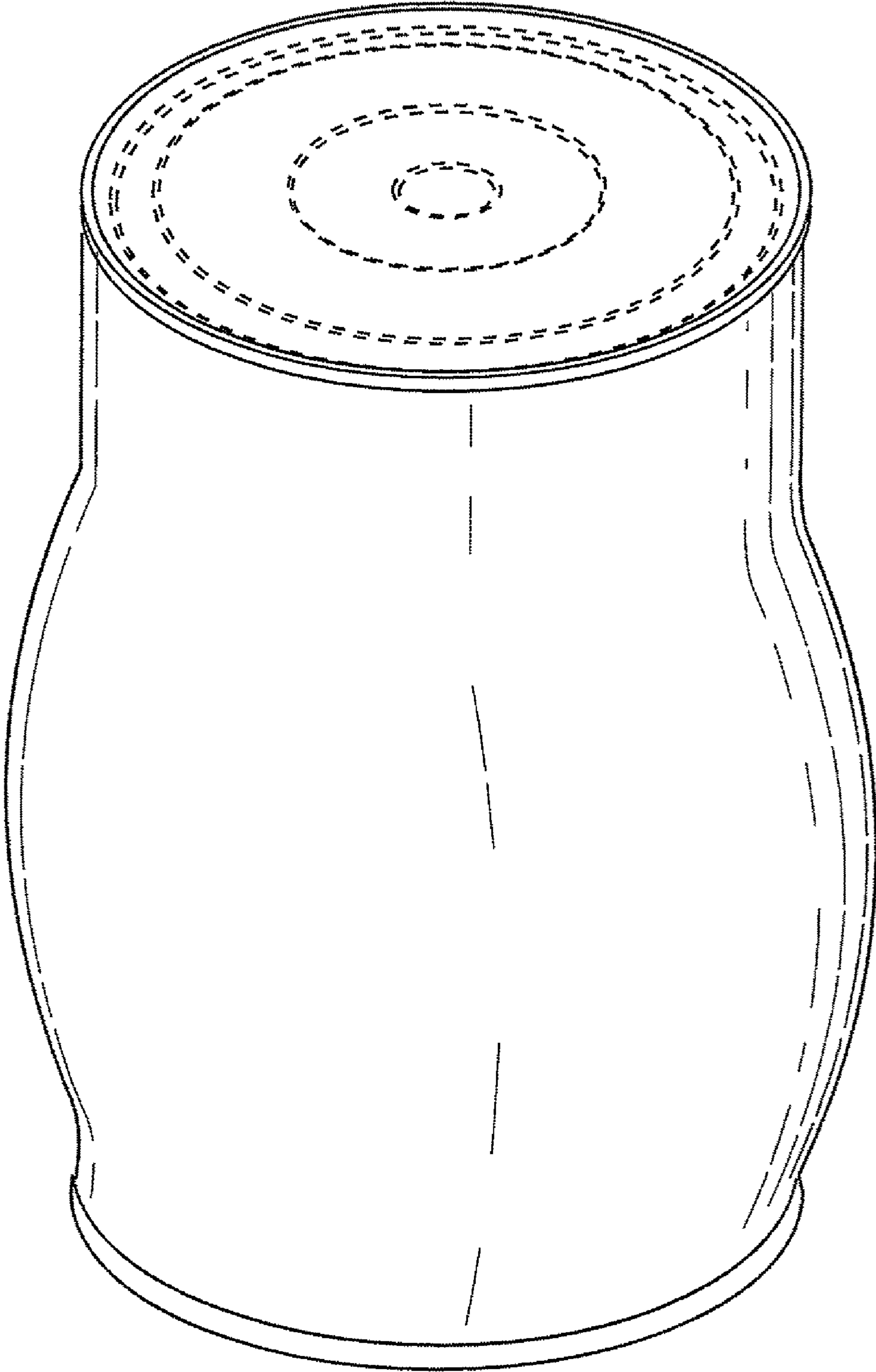
FIG. 4 is a top plan view thereof; and,

FIG. 5 is a bottom plan view thereof.

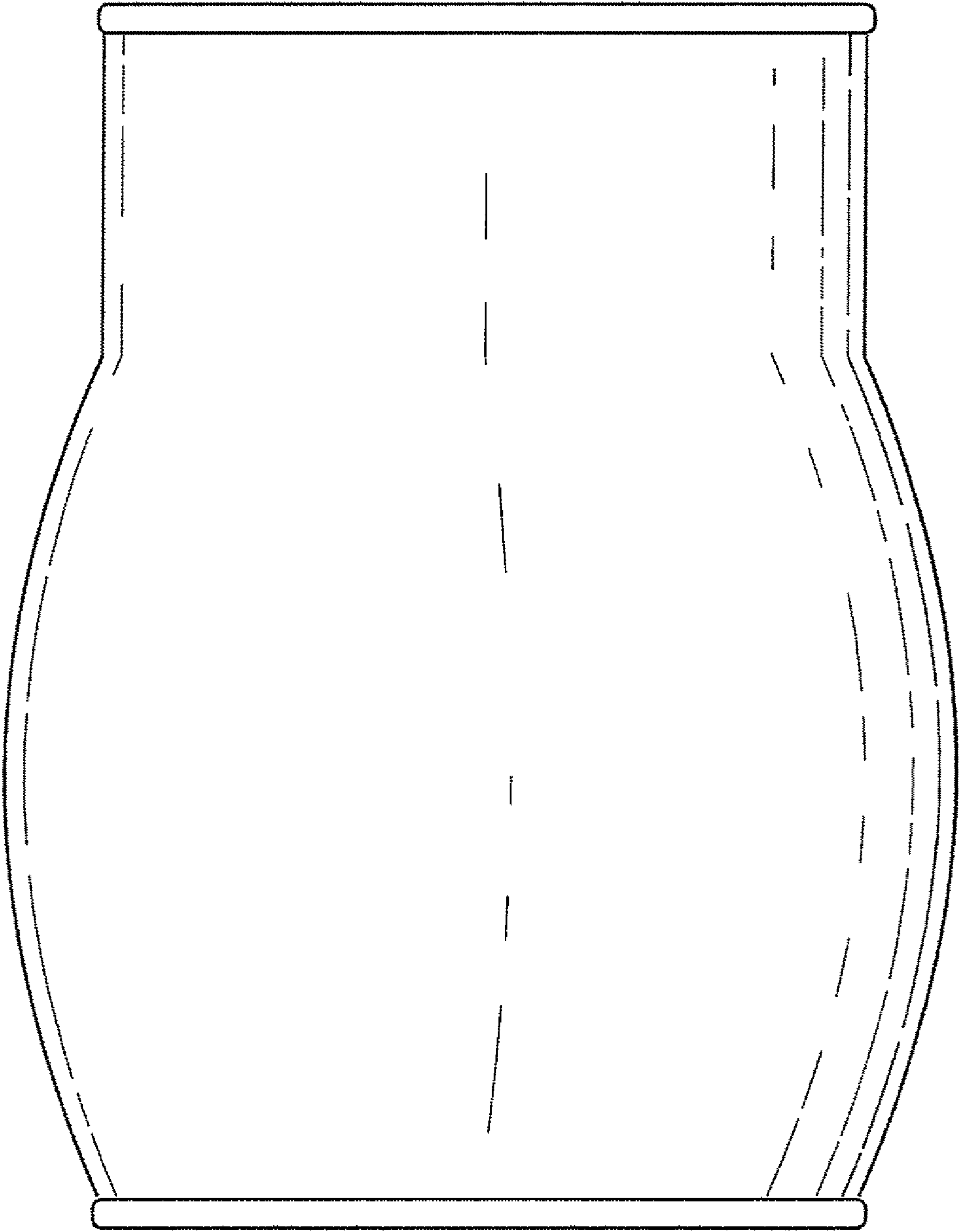

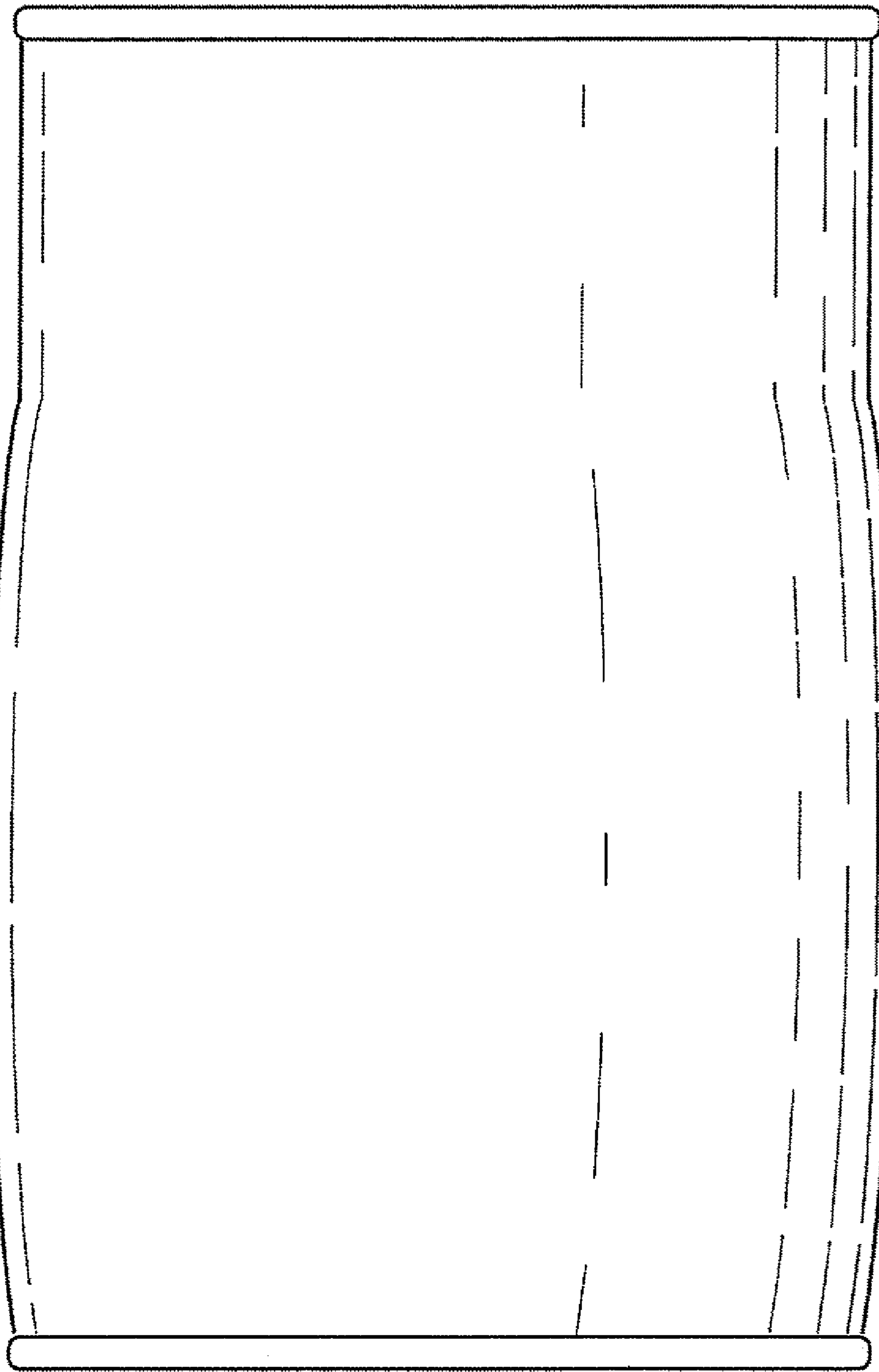




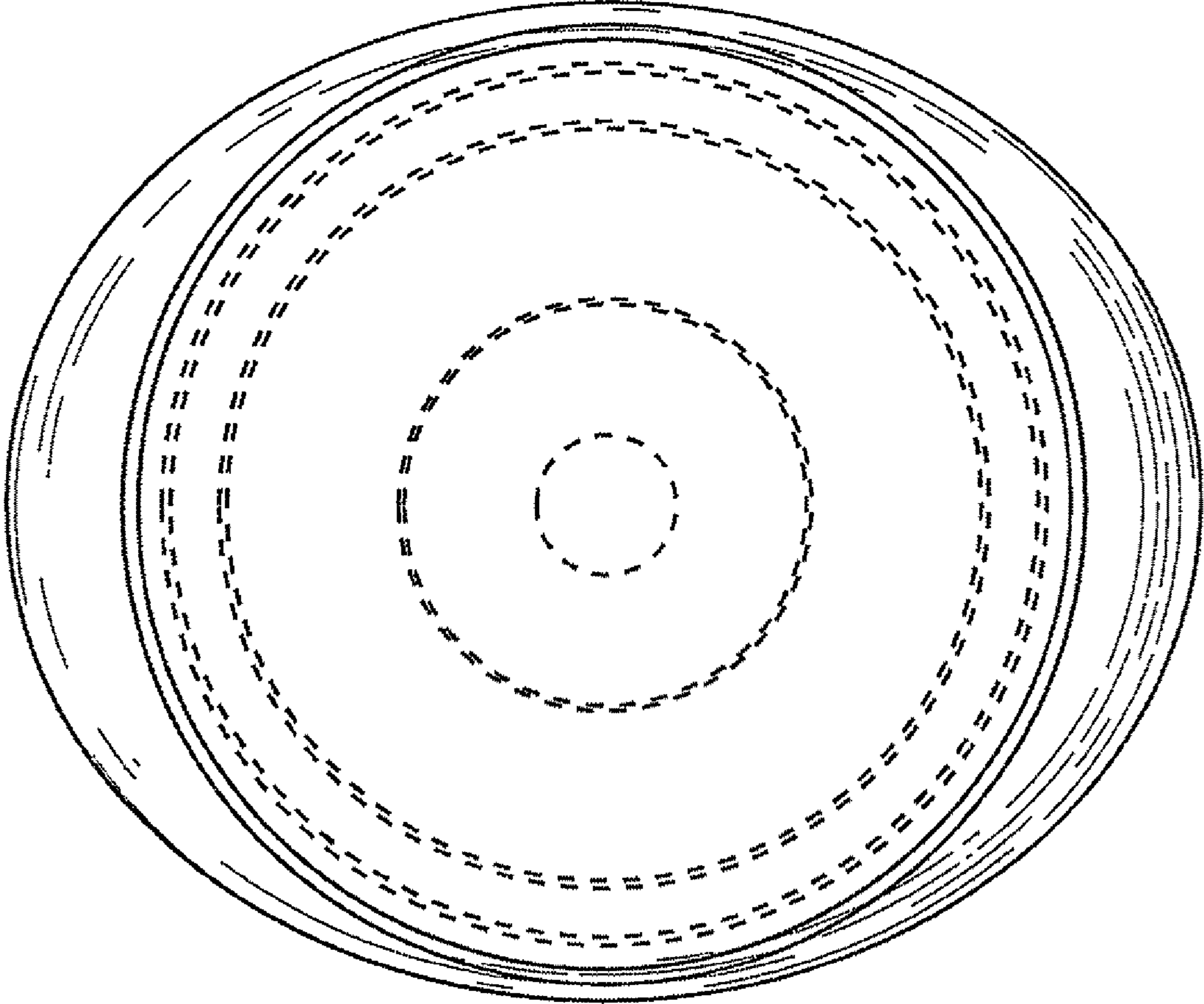

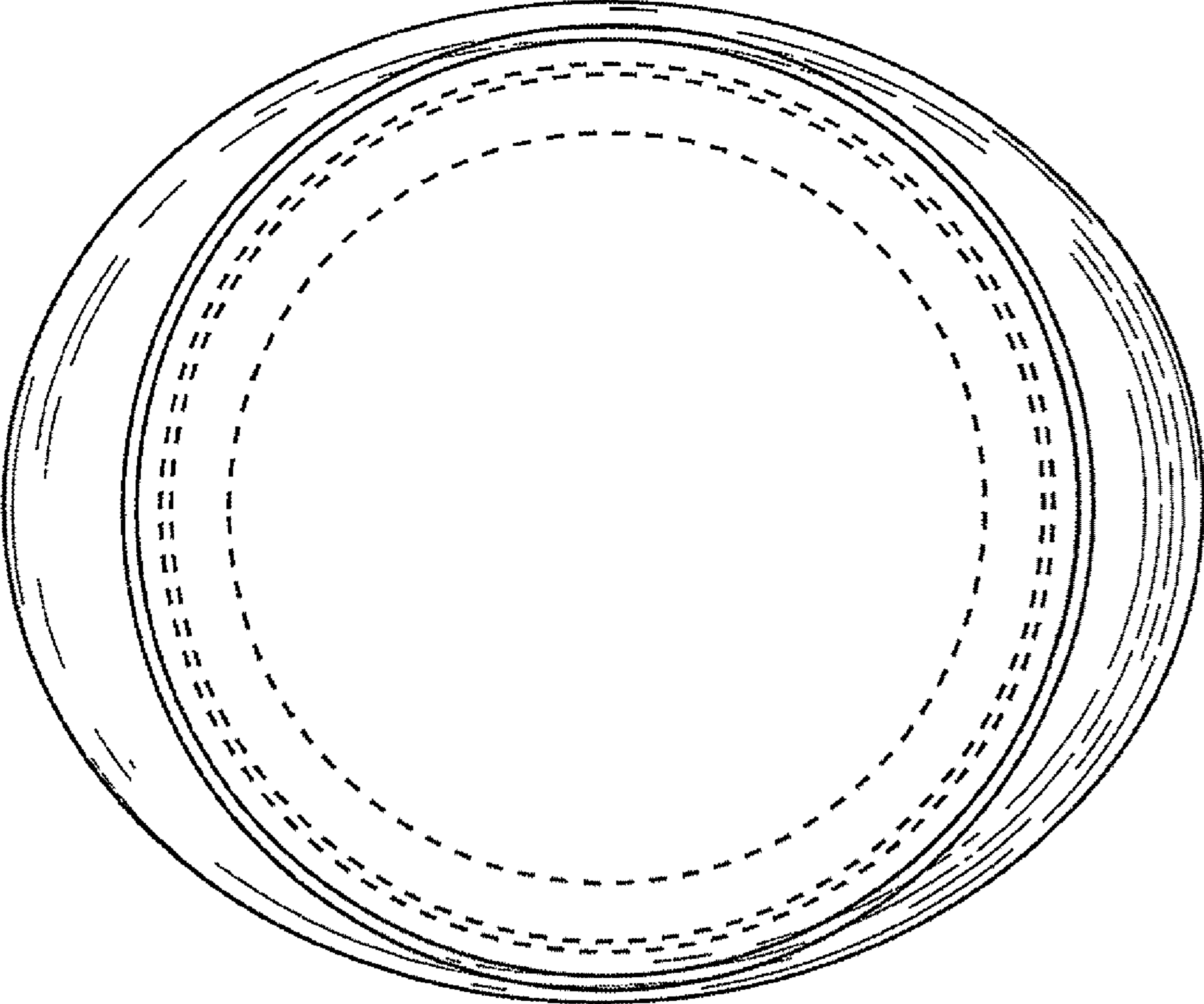
