**DESCRIPTION**

FIG. 1 is a front elevational view thereof,

FIG. 2 is a top plan view thereof,

FIG. 3 is a bottom plan view thereof,

FIG. 4 is a rear elevational view thereof,

FIG. 5 is a left side elevational view thereof, a right side elevational view being a mirror image thereof.

FIG. 6 is a top, front and right side perspective view thereof; and,

FIG. 7 is a bottom, front and left side perspective view thereof.

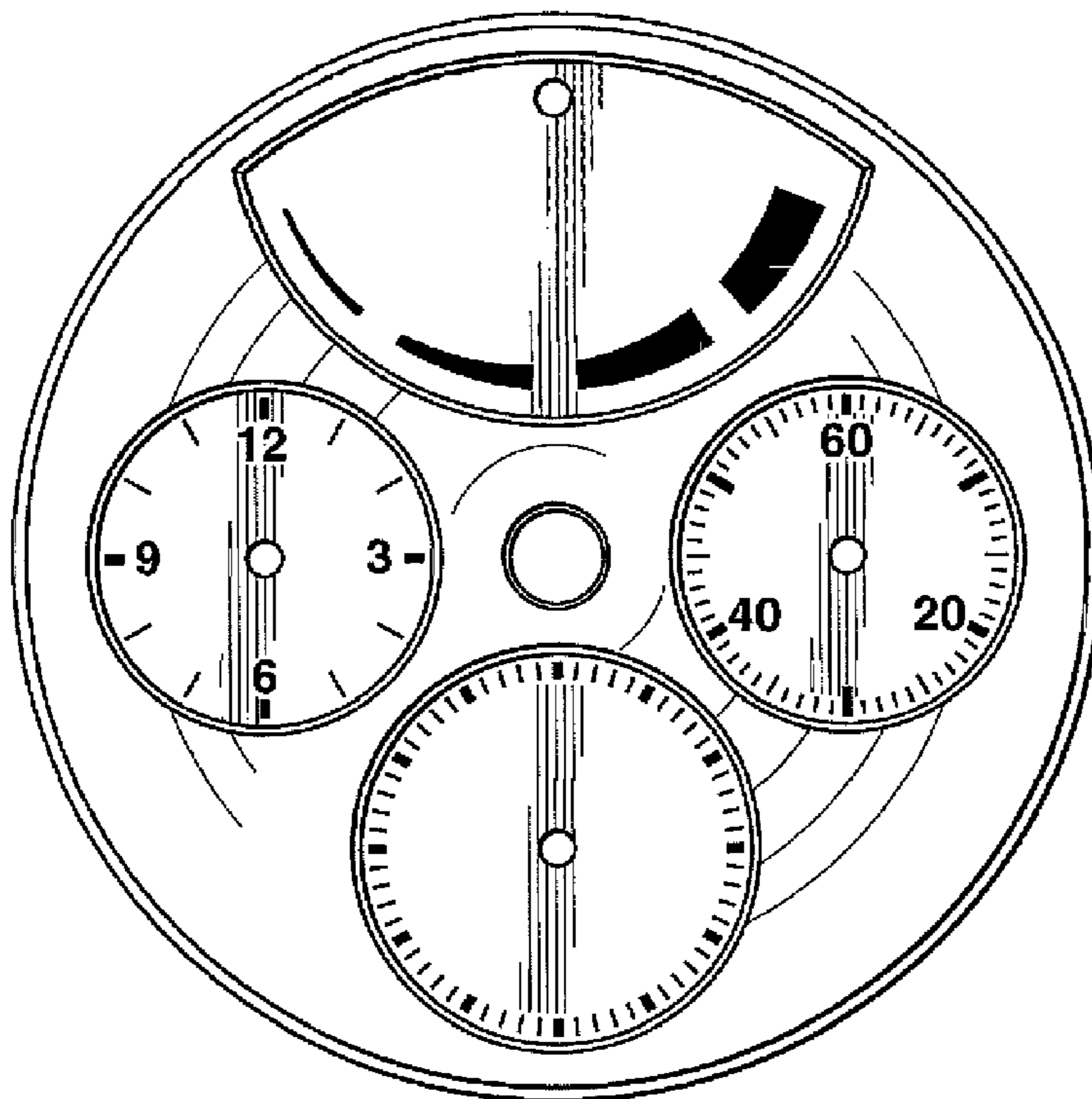

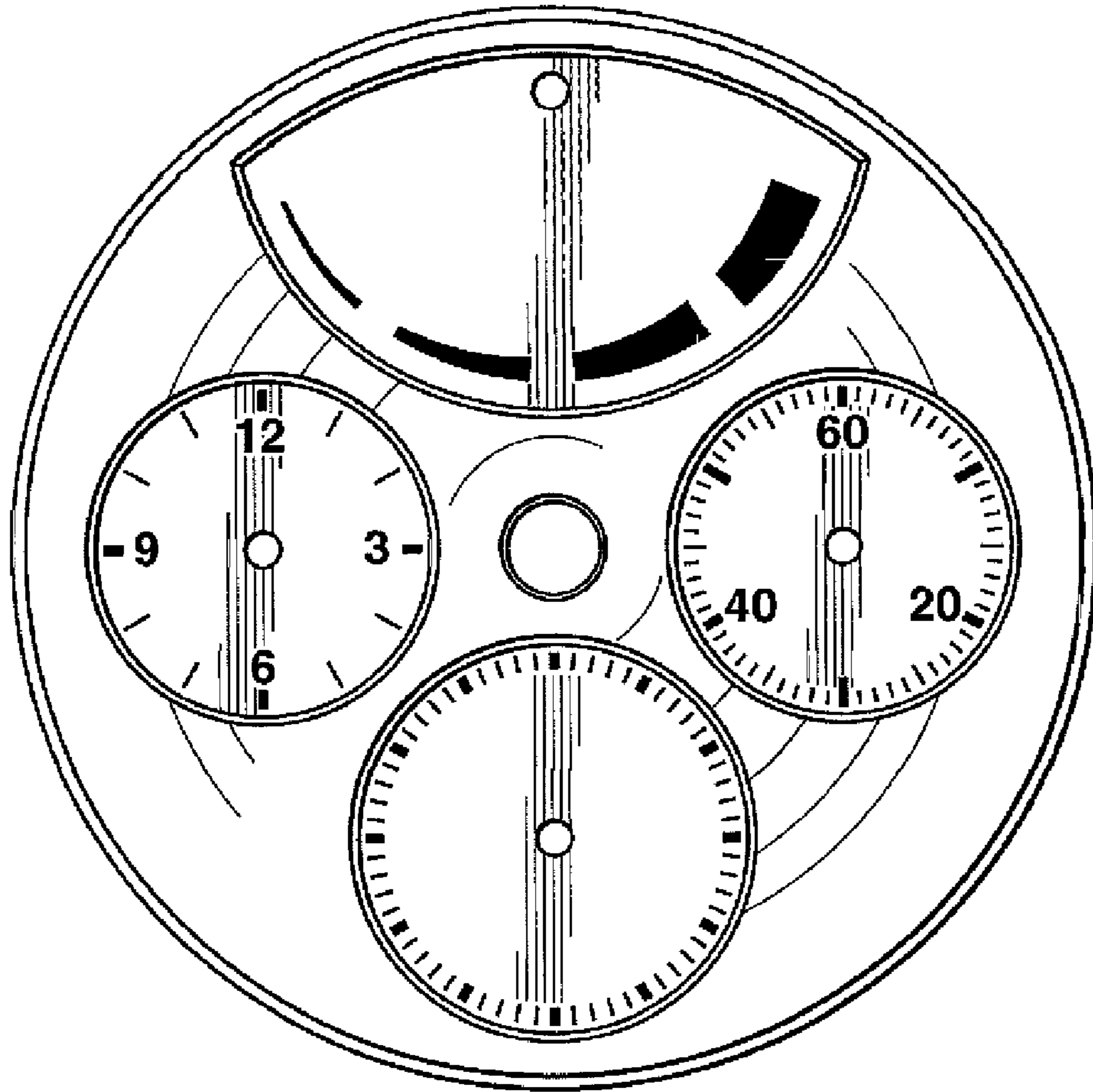

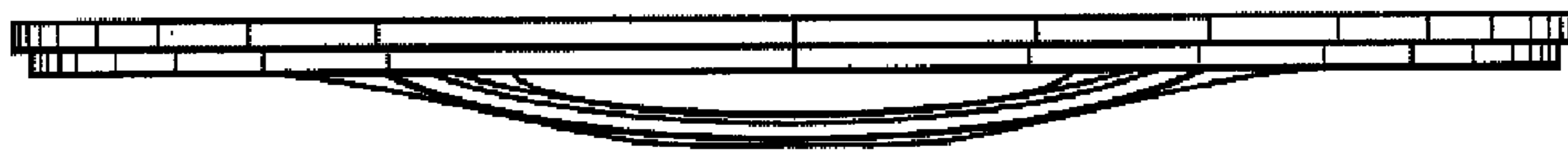

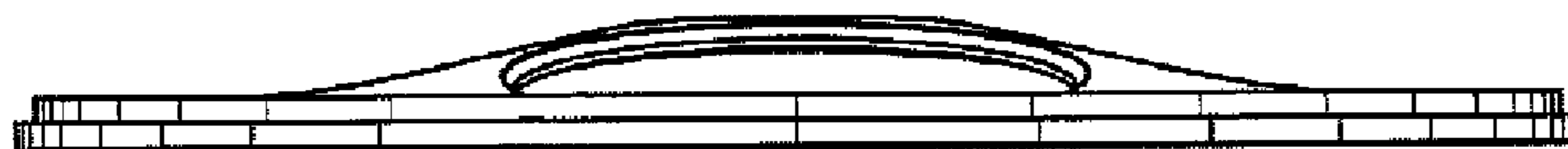

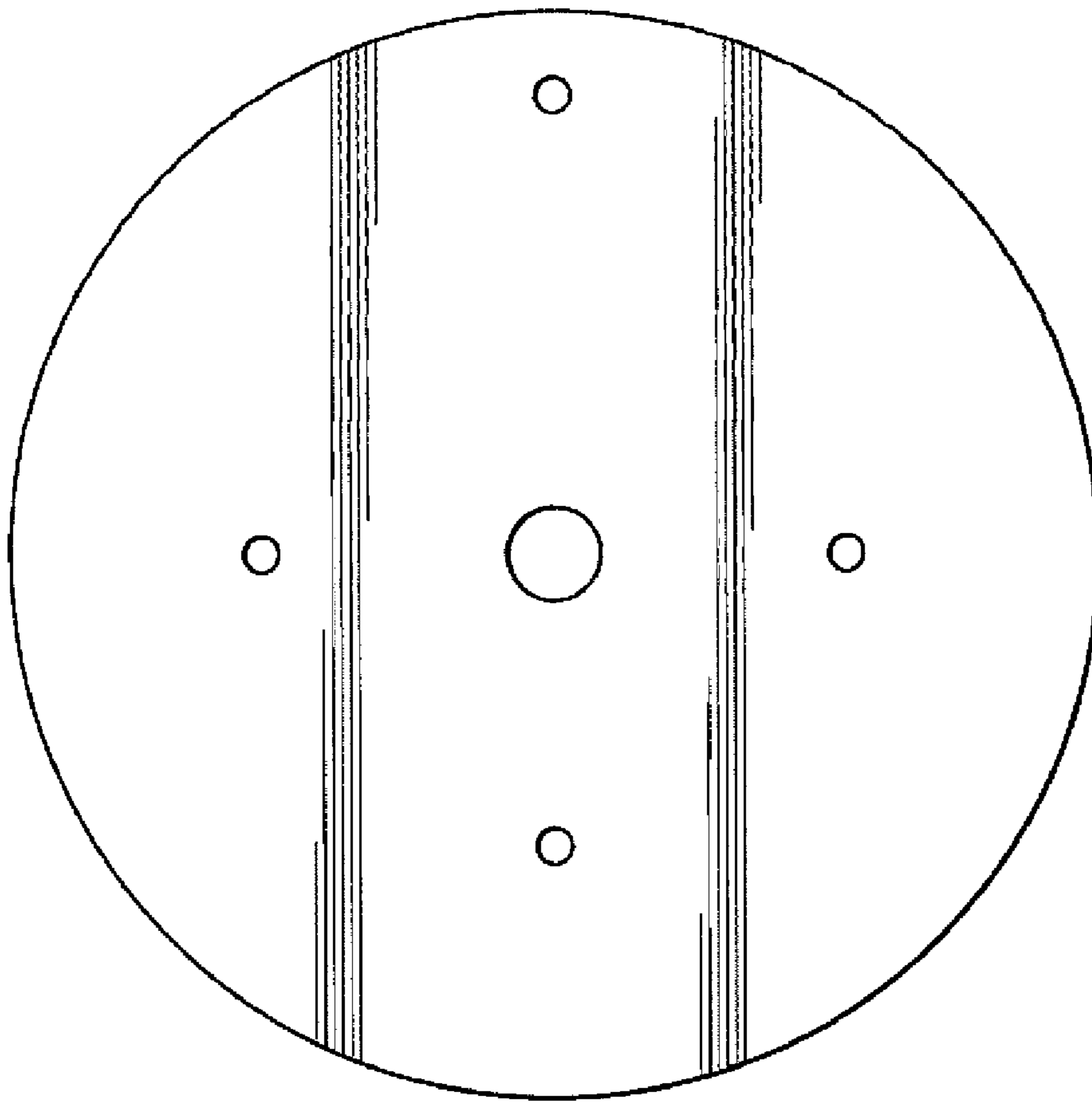

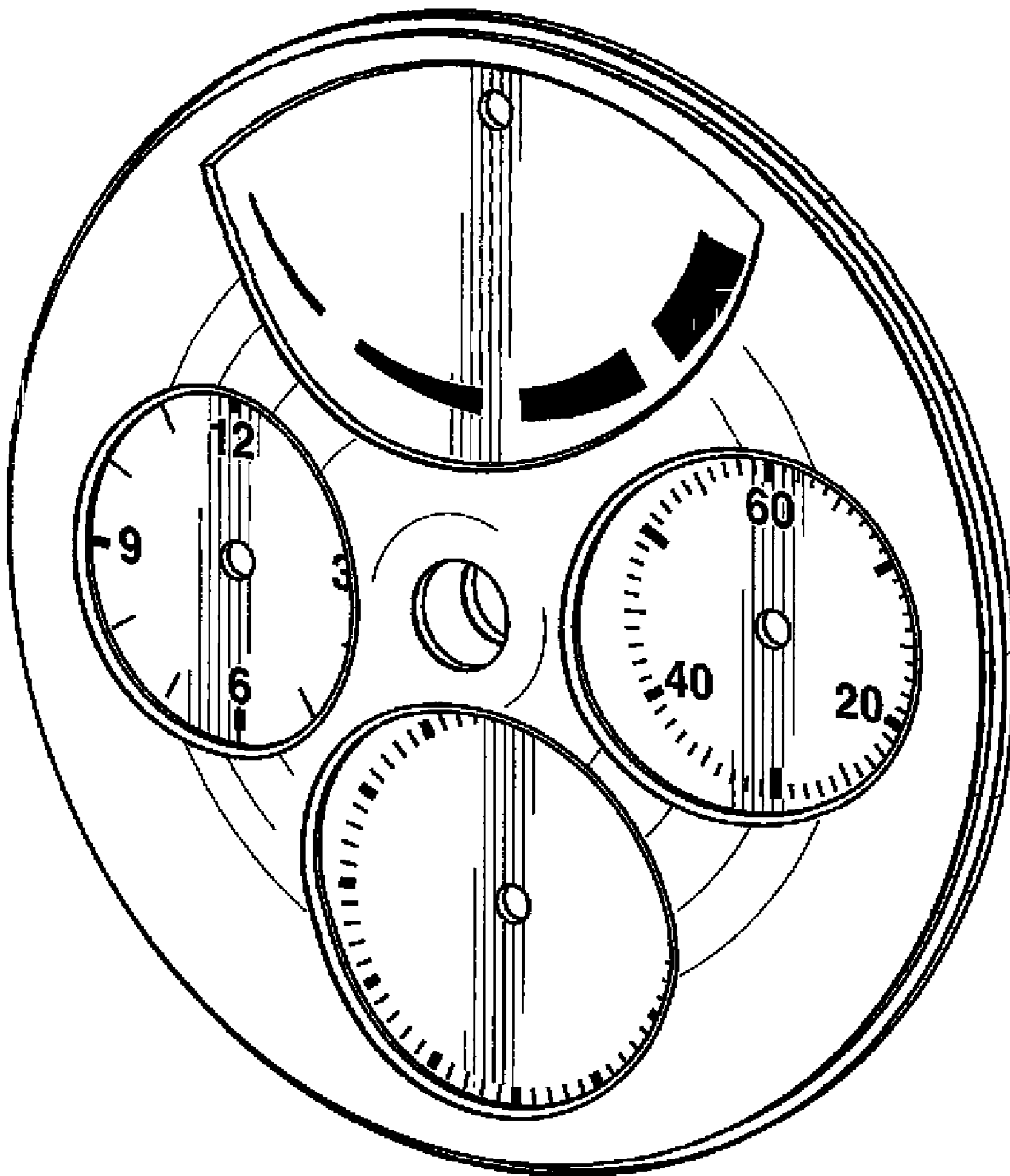
