(57) **CLAIM**

The ornamental design for a television receiver, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a television receiver showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof; and

FIG. 7 is a bottom plan view thereof.

Portions of FIGS. 1, 3, 4, 5, and 6 that is shown in broken lines are illustrative purposes only and forms no part of the claimed design.

FIG. 8 is a reference front elevational view thereof, showing a line IX—IX and portions X, XI, and XII;

FIG. 9 is a reference cross-sectional view thereof, taken along a line IX-IX in a direction of arrows of FIG. 8;

FIG. 10 is a reference enlarged view of a portion X of FIG. 8;

FIG. 11 is a reference enlarged view of a portion XI of FIG. 8; and,

FIG. 12 is a reference enlarged view of a portion XII of FIG. 8.

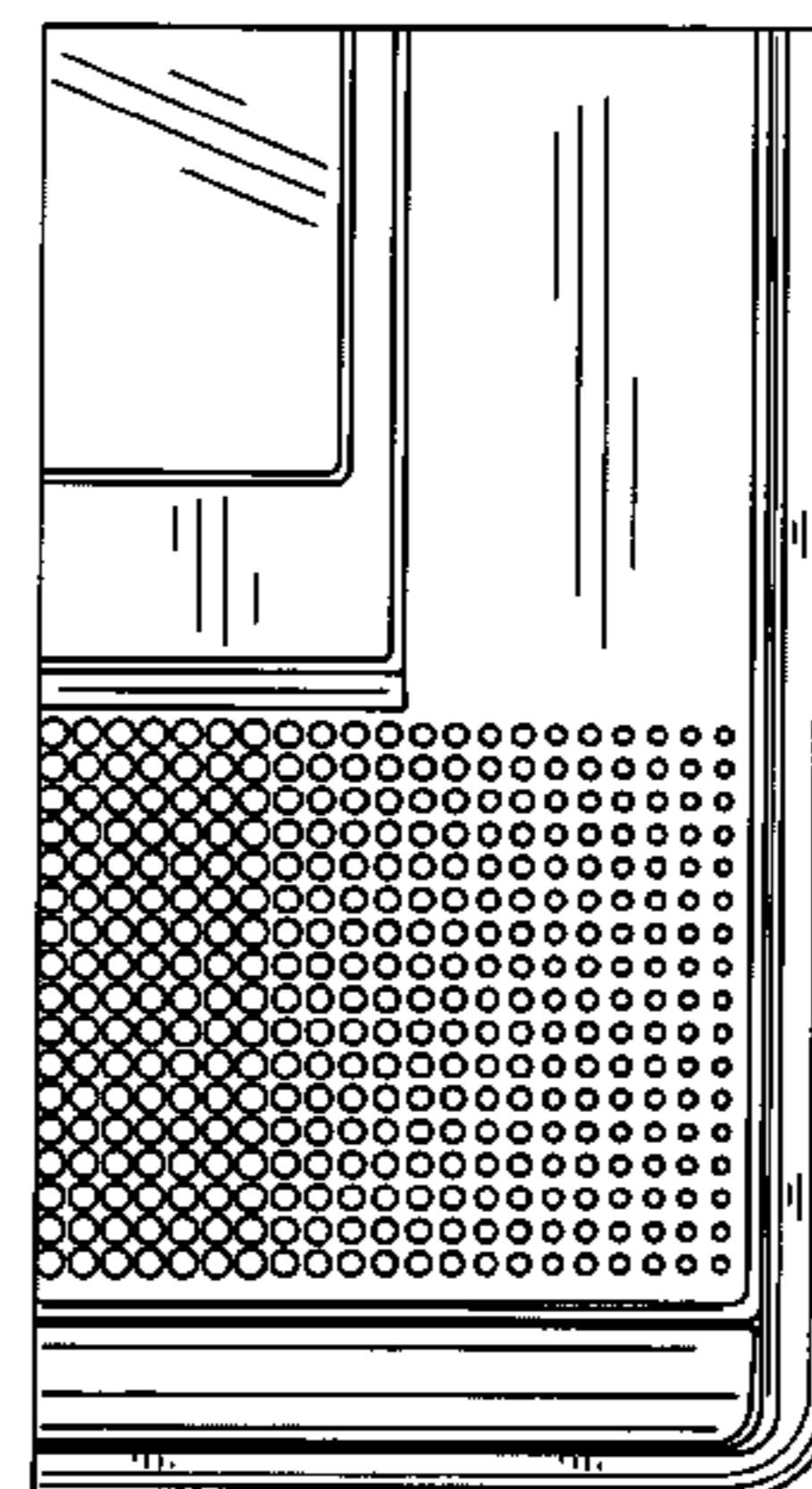
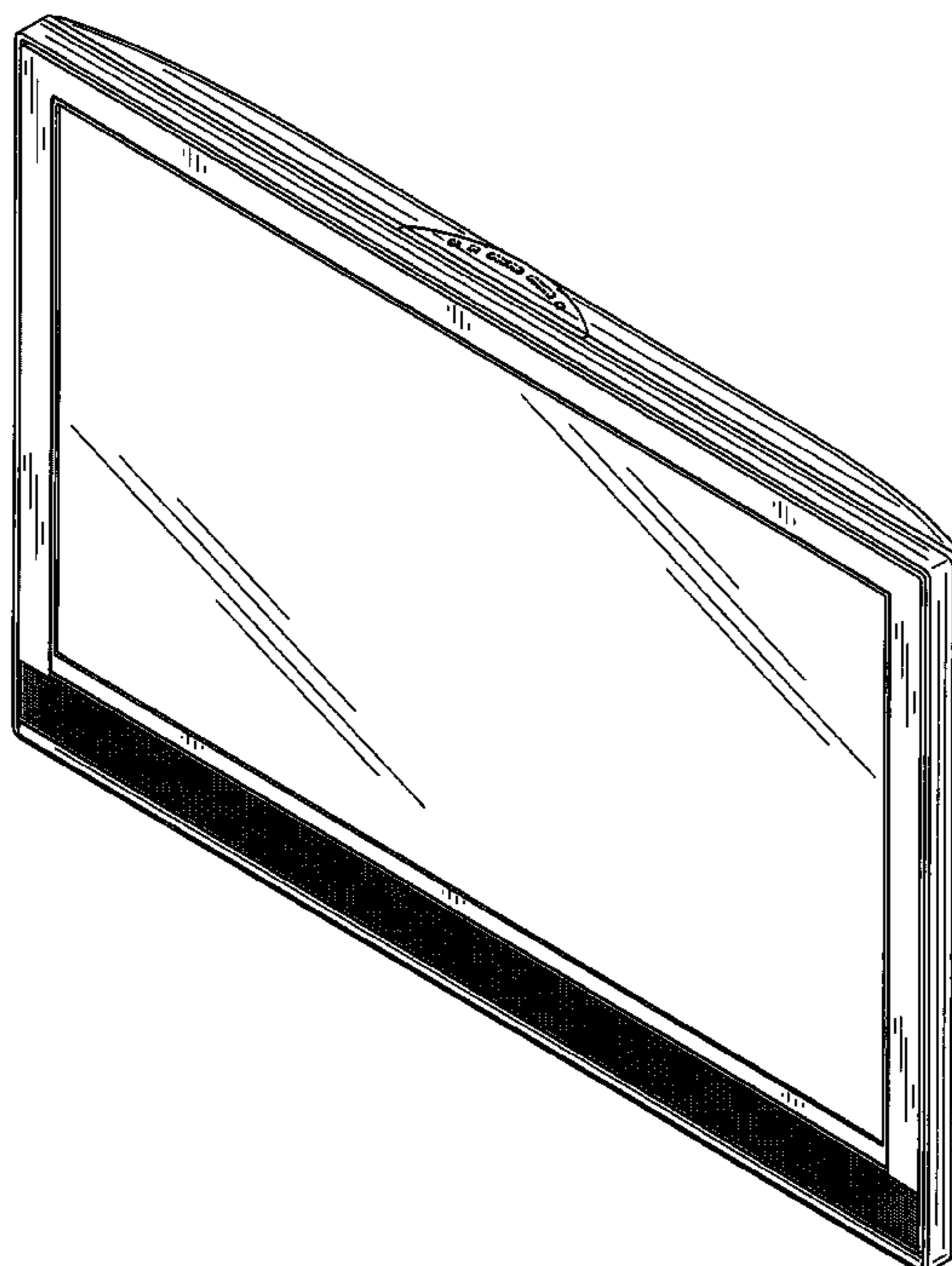

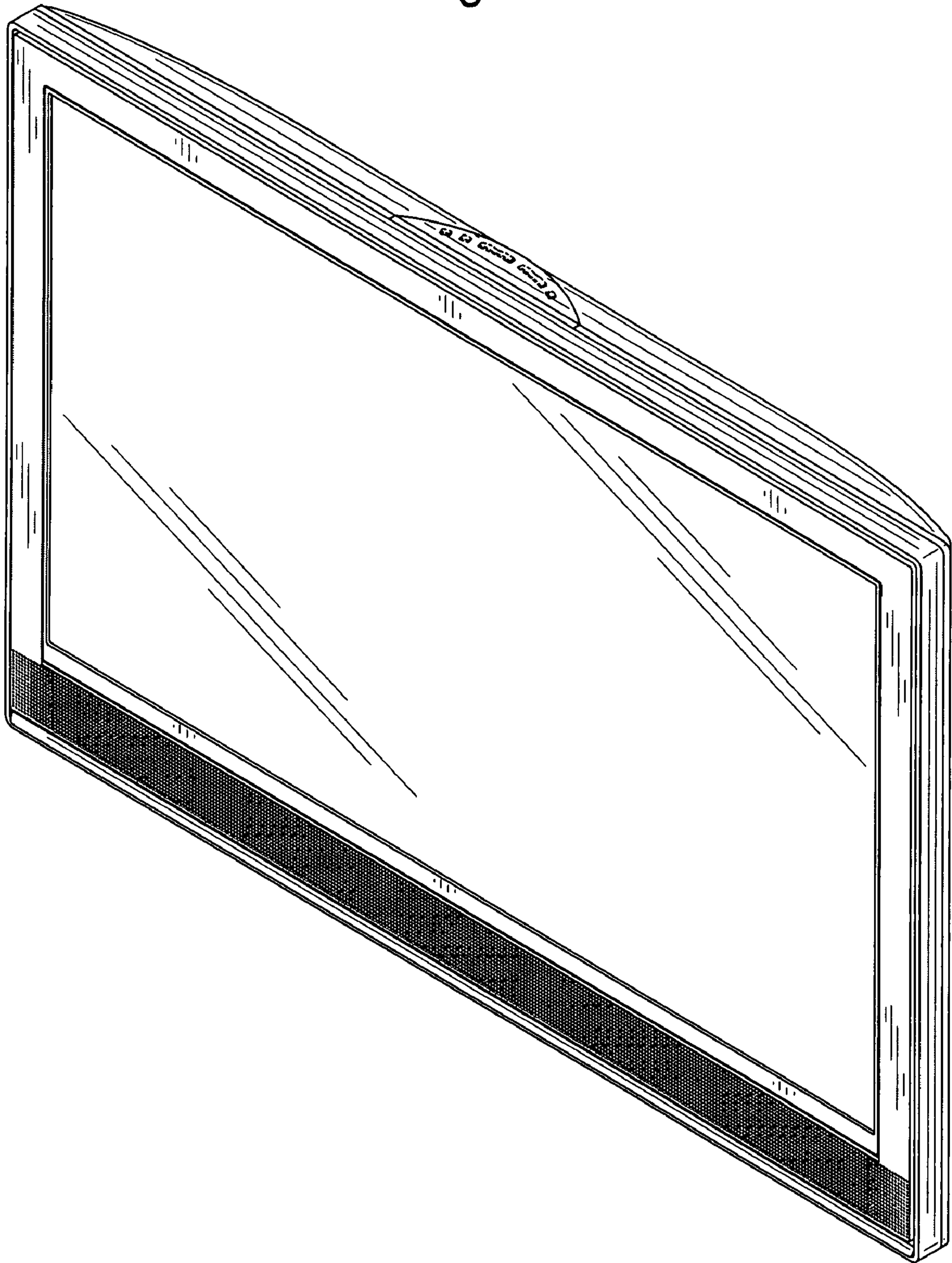

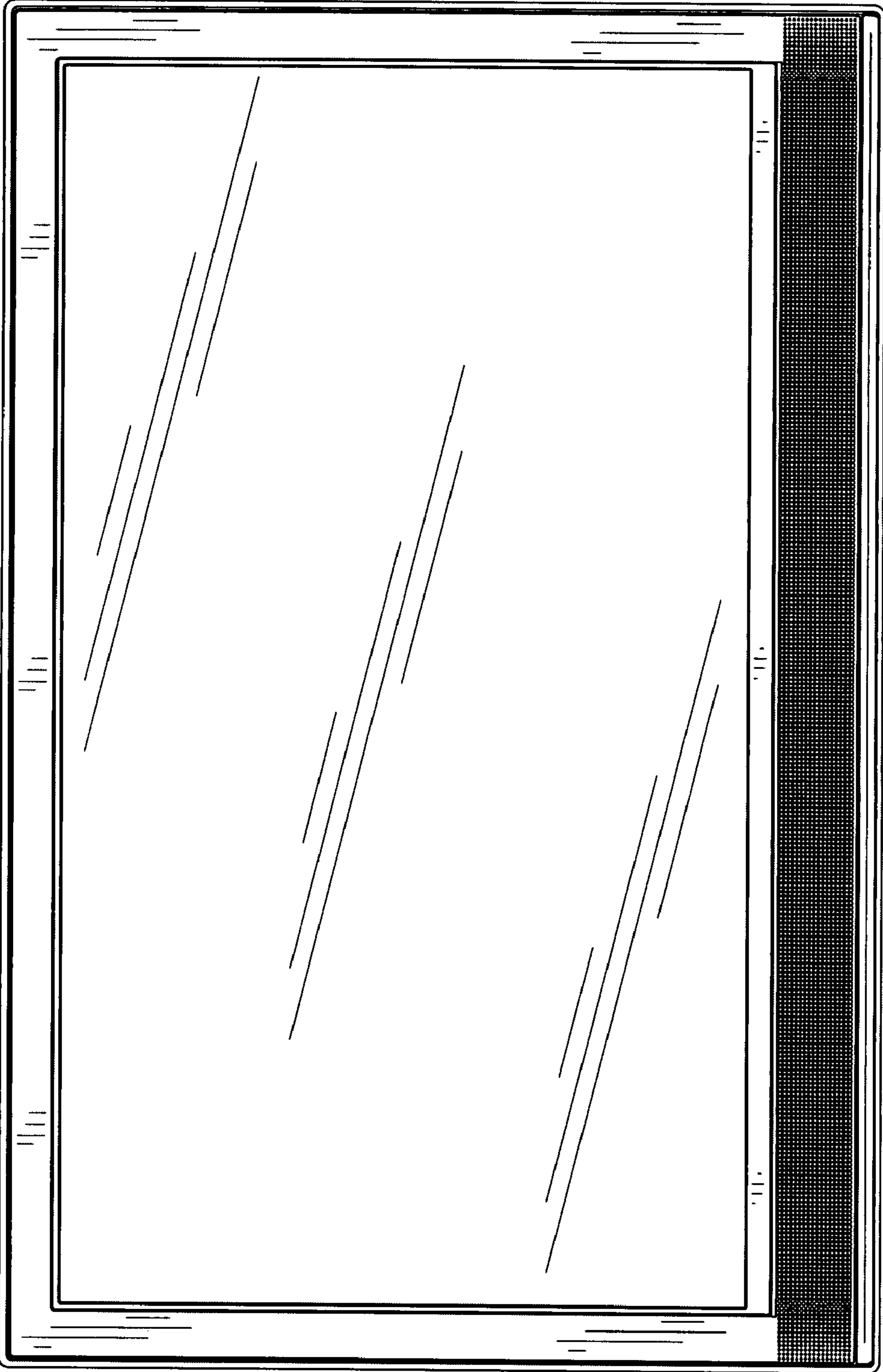

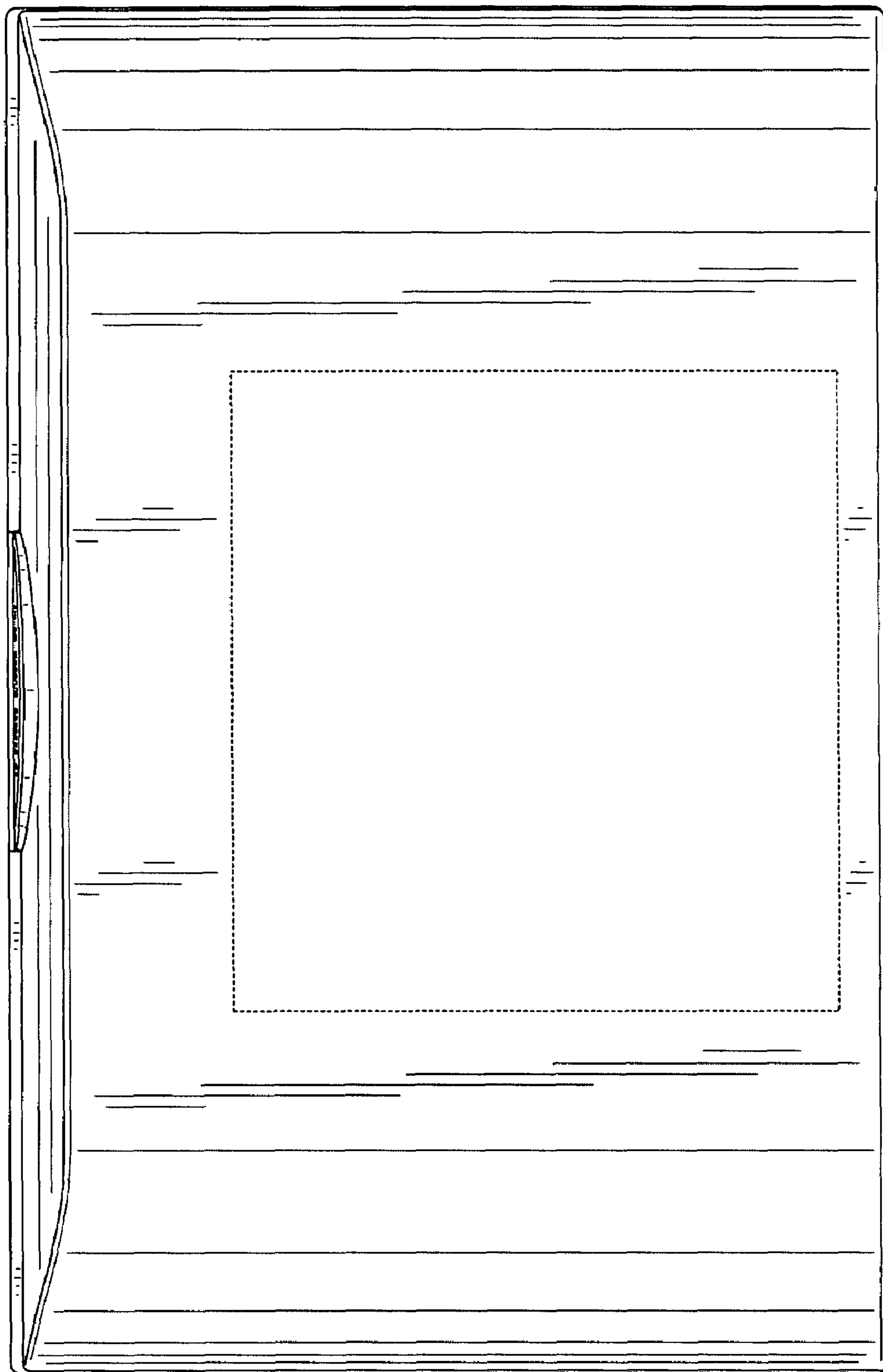

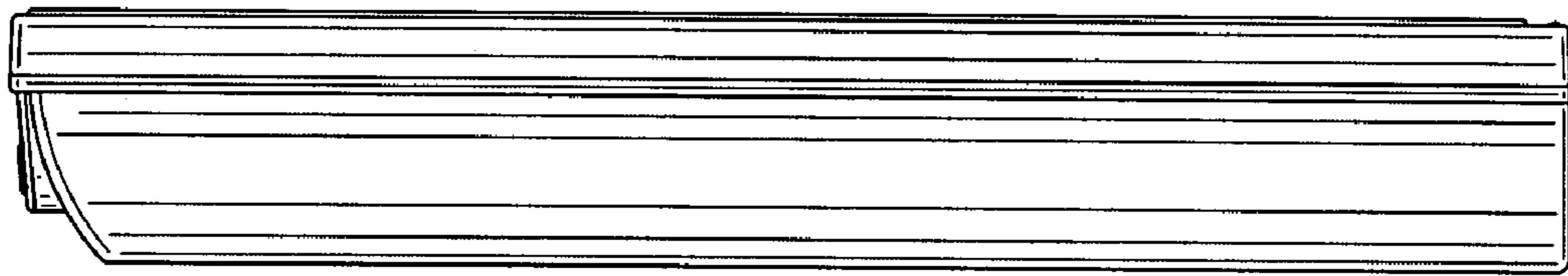

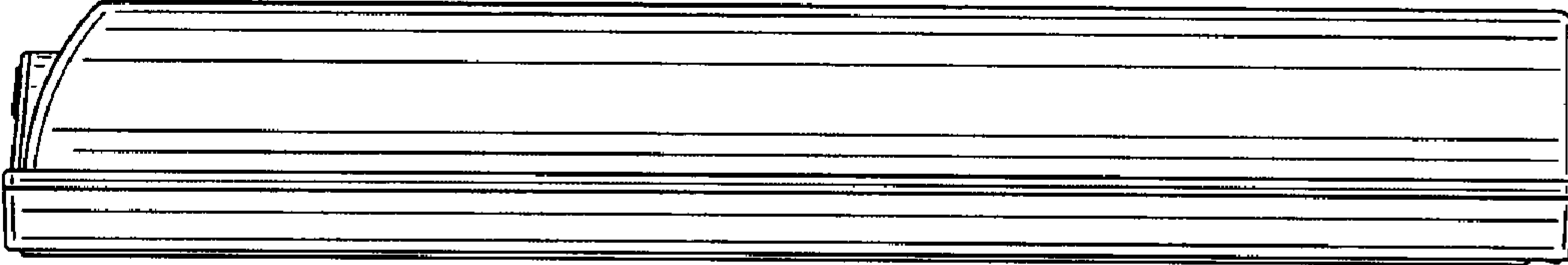

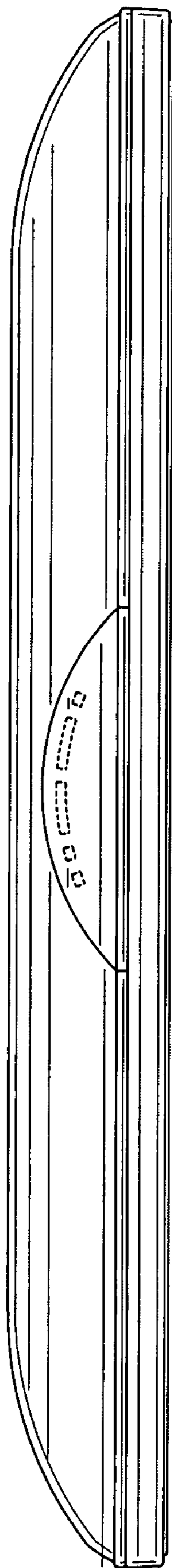
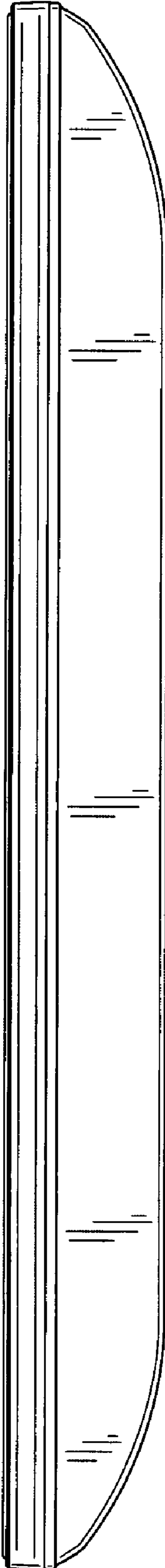

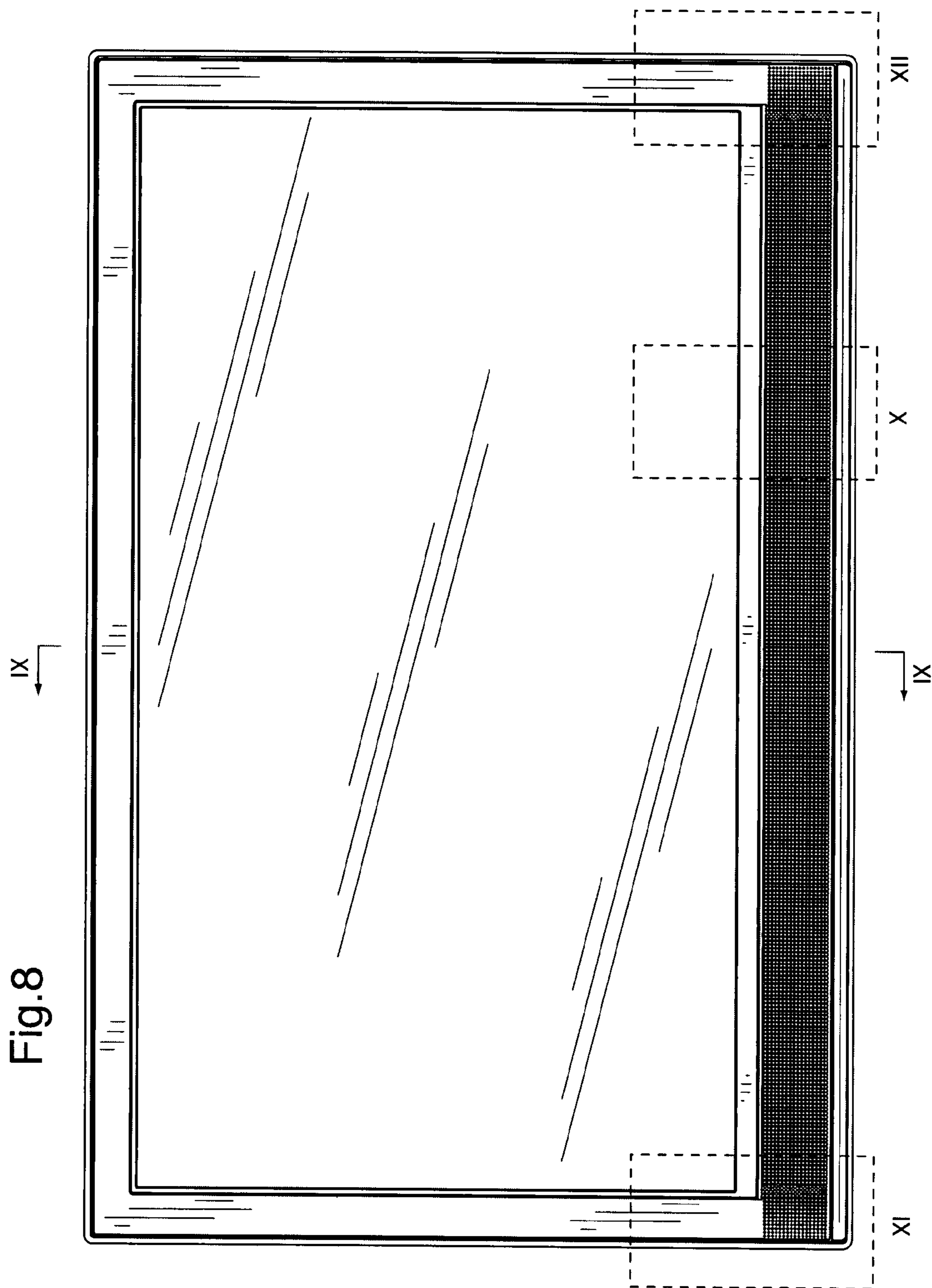

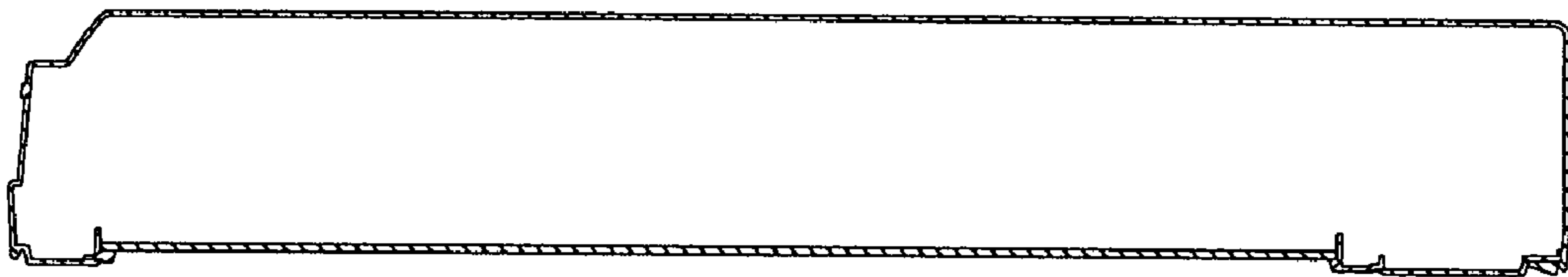

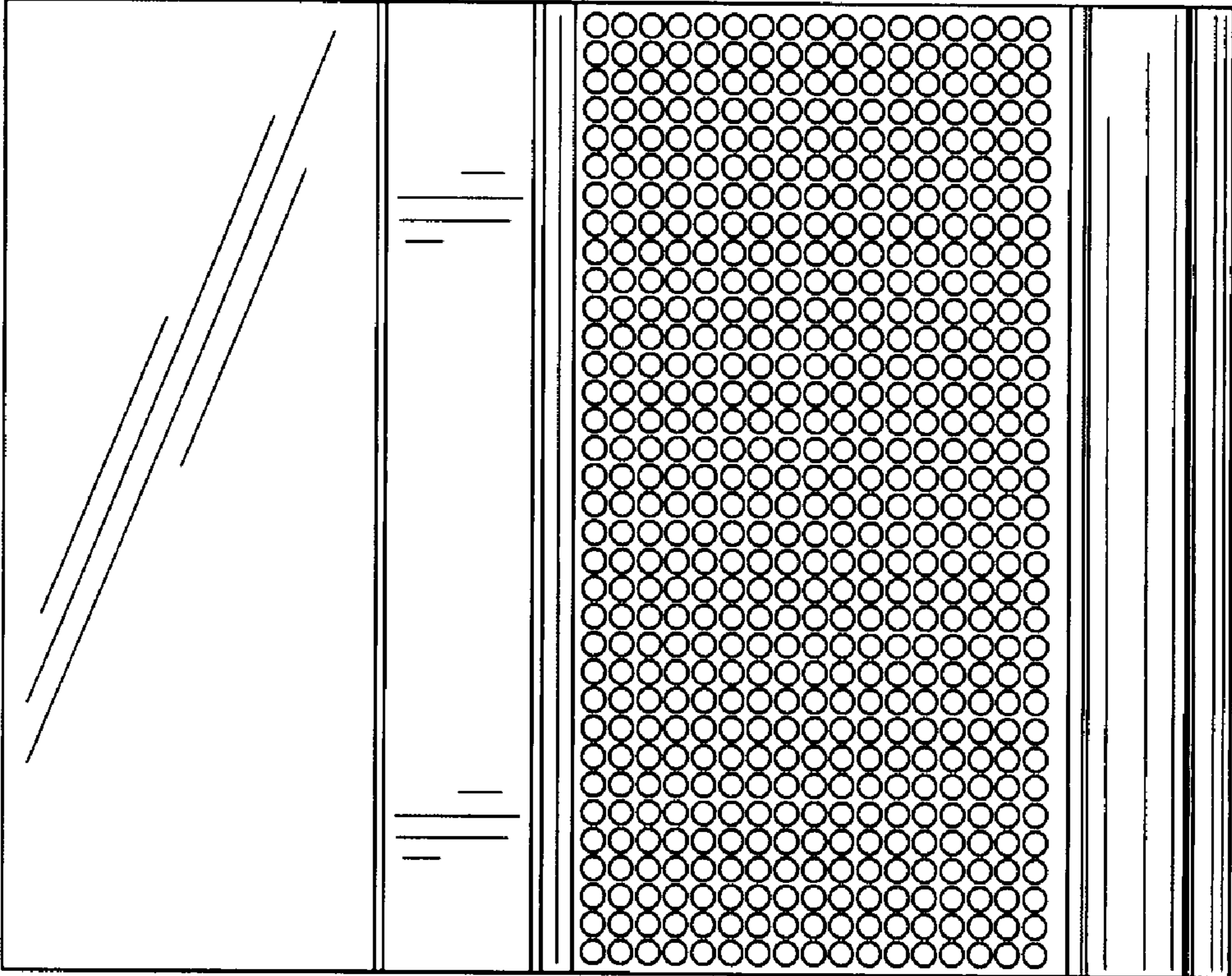

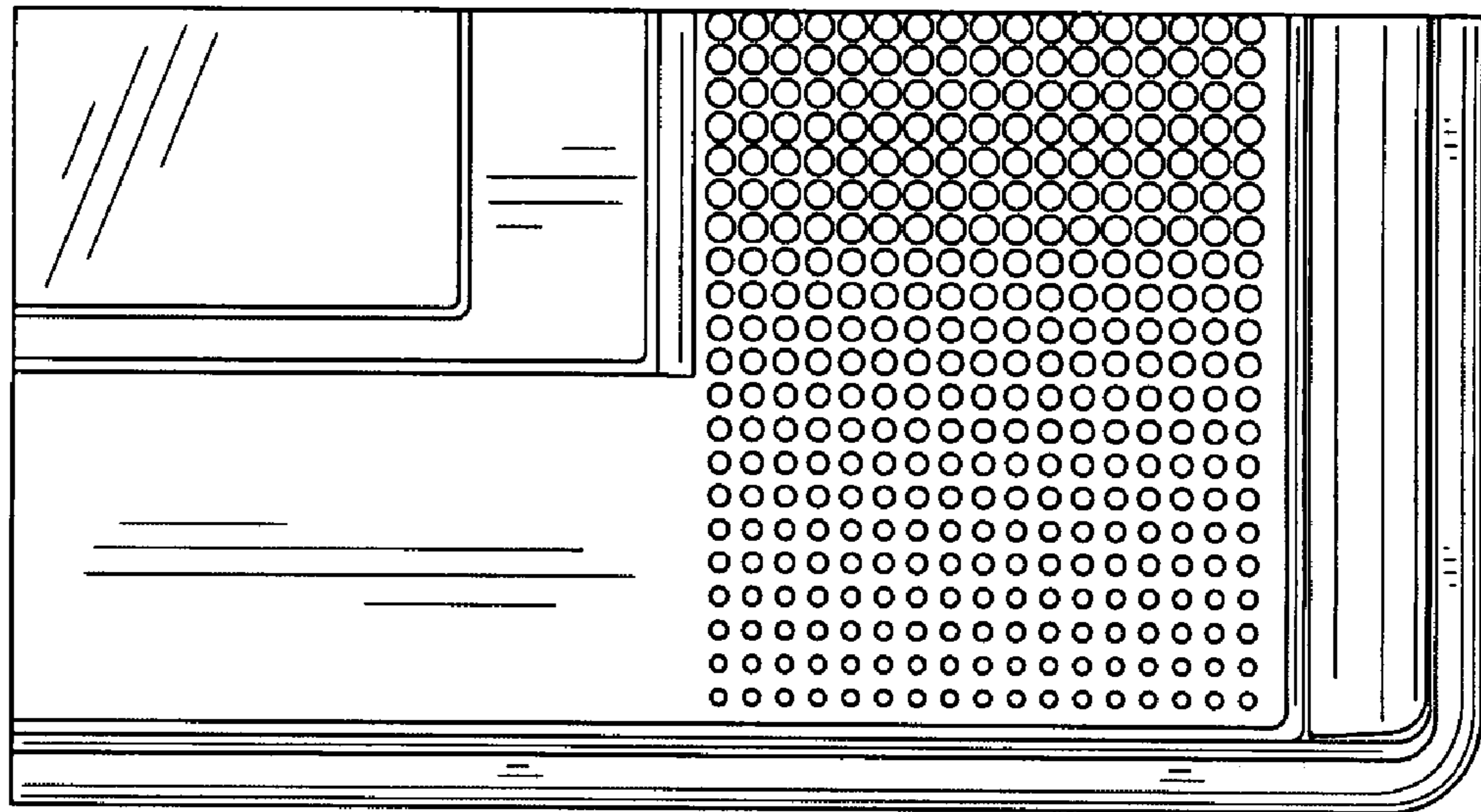
