(57) **CLAIM**

The ornamental design for a magnetic clip with calculator holder, as shown and described.

DESCRIPTION

FIG. 1 is a front bottom side perspective view of the magnetic clip with calculator holder showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof, which is a mirror image of the left side thereof;

FIG. 4 is a bottom plan view thereof;

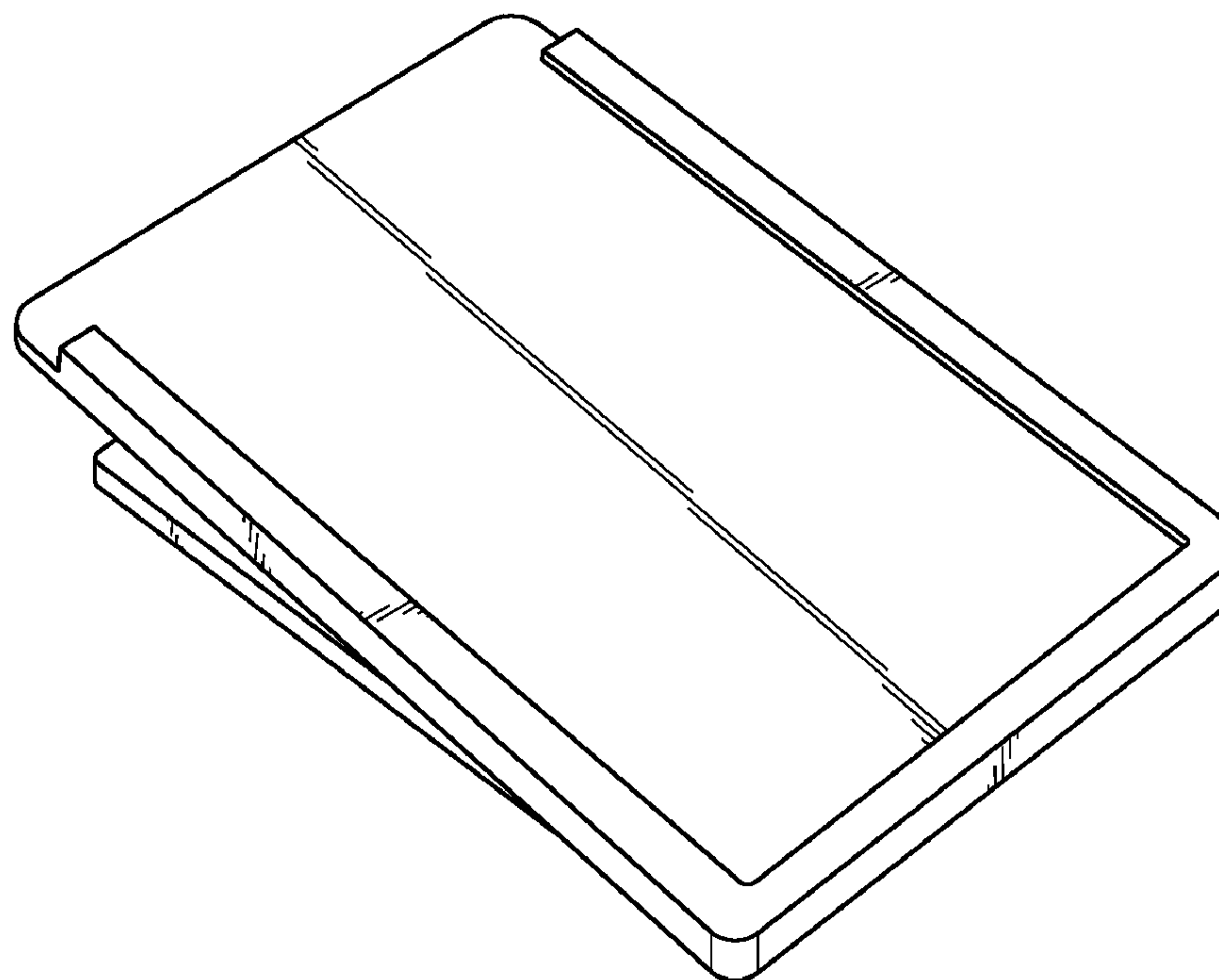
FIG. 5 is a top plan view thereof;

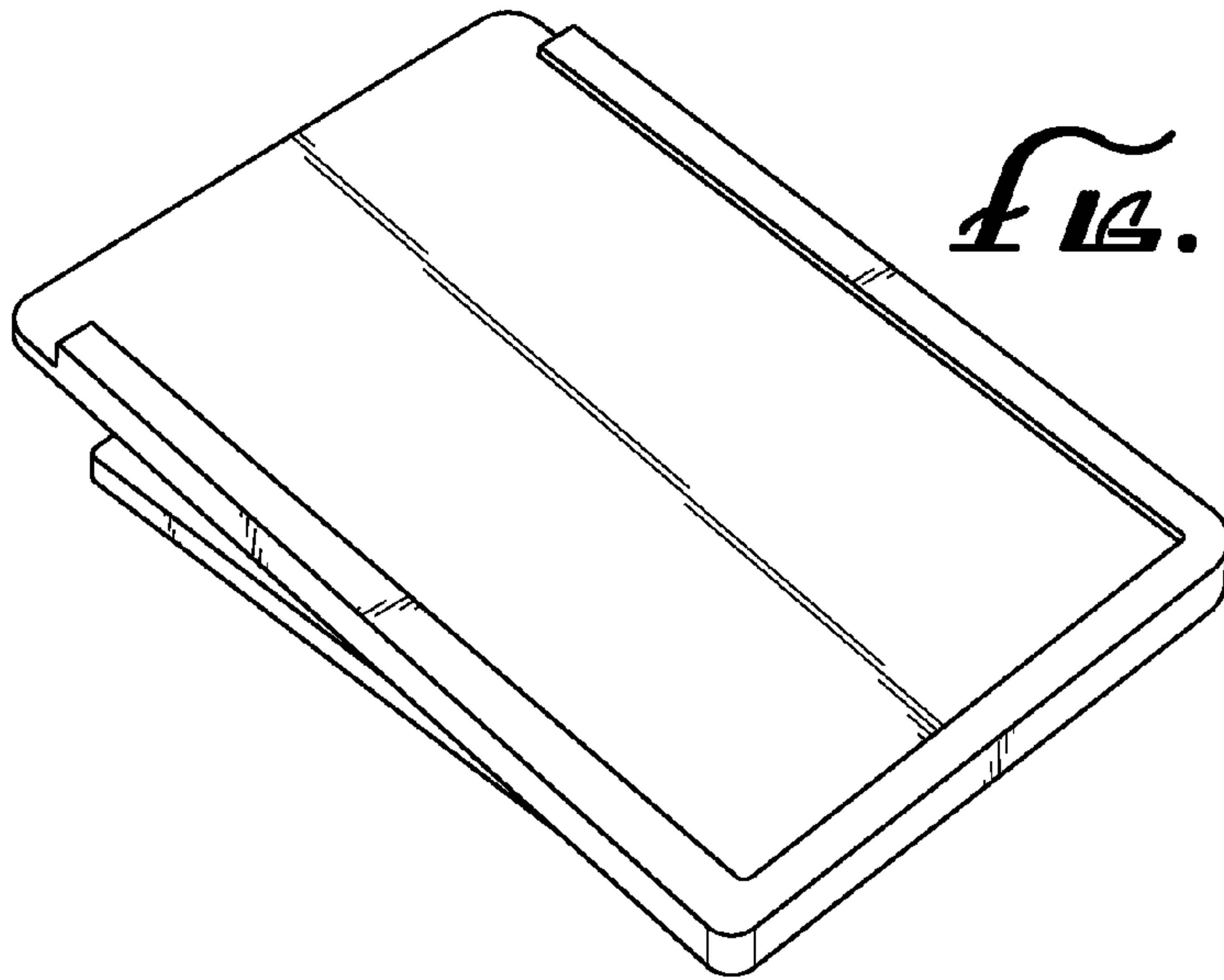

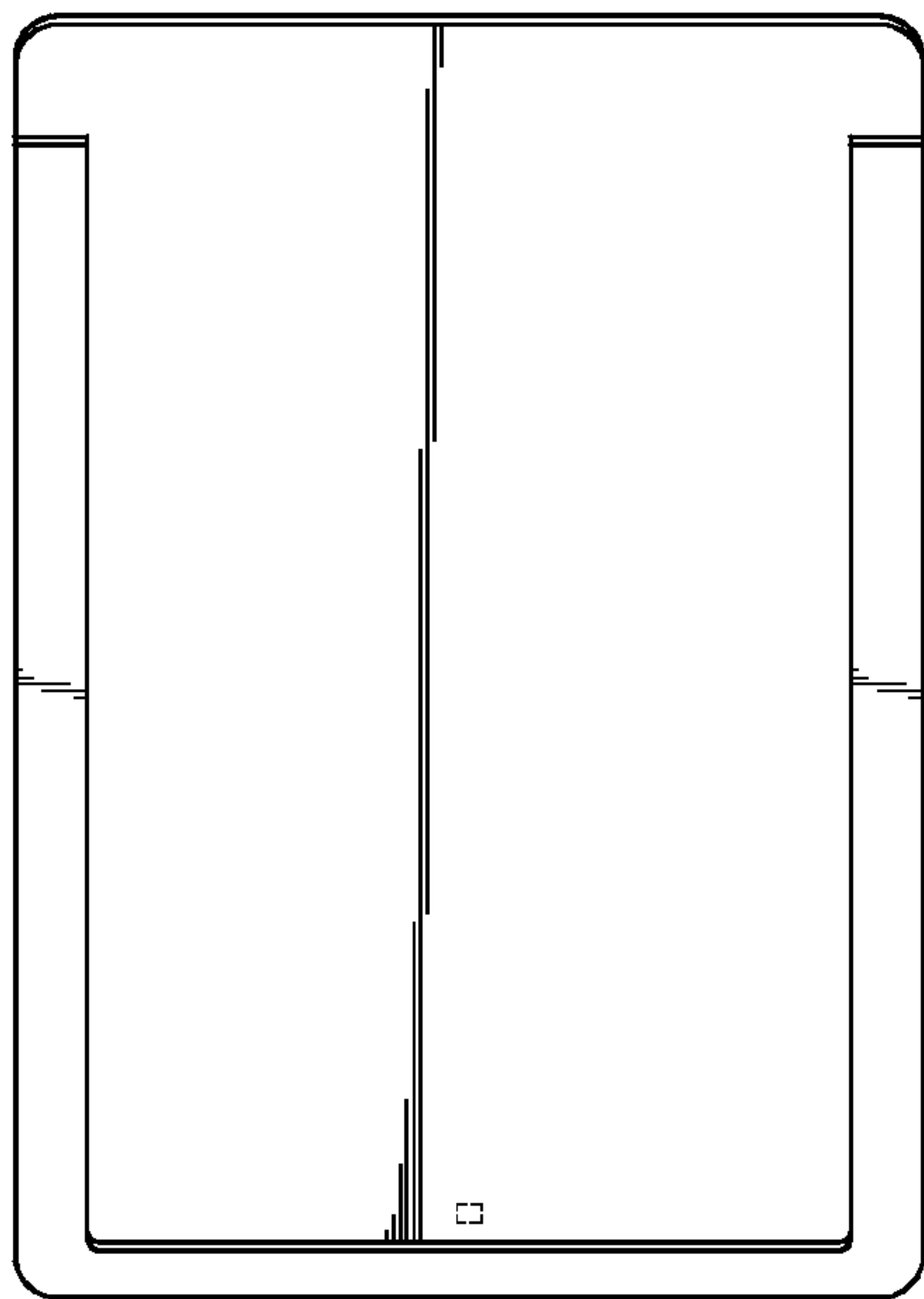

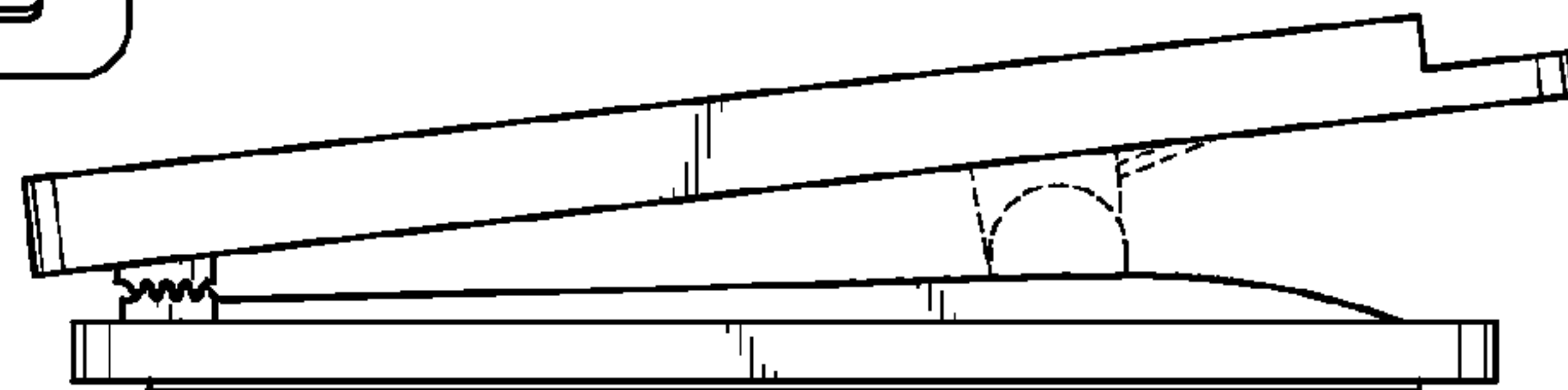

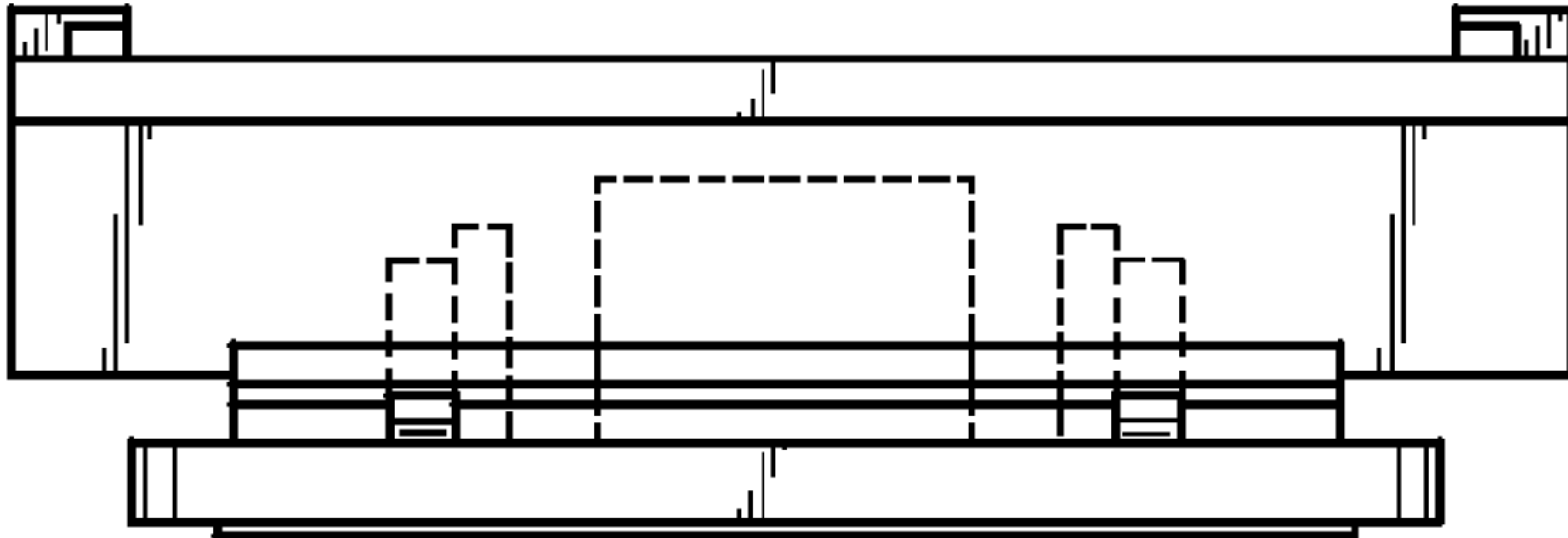

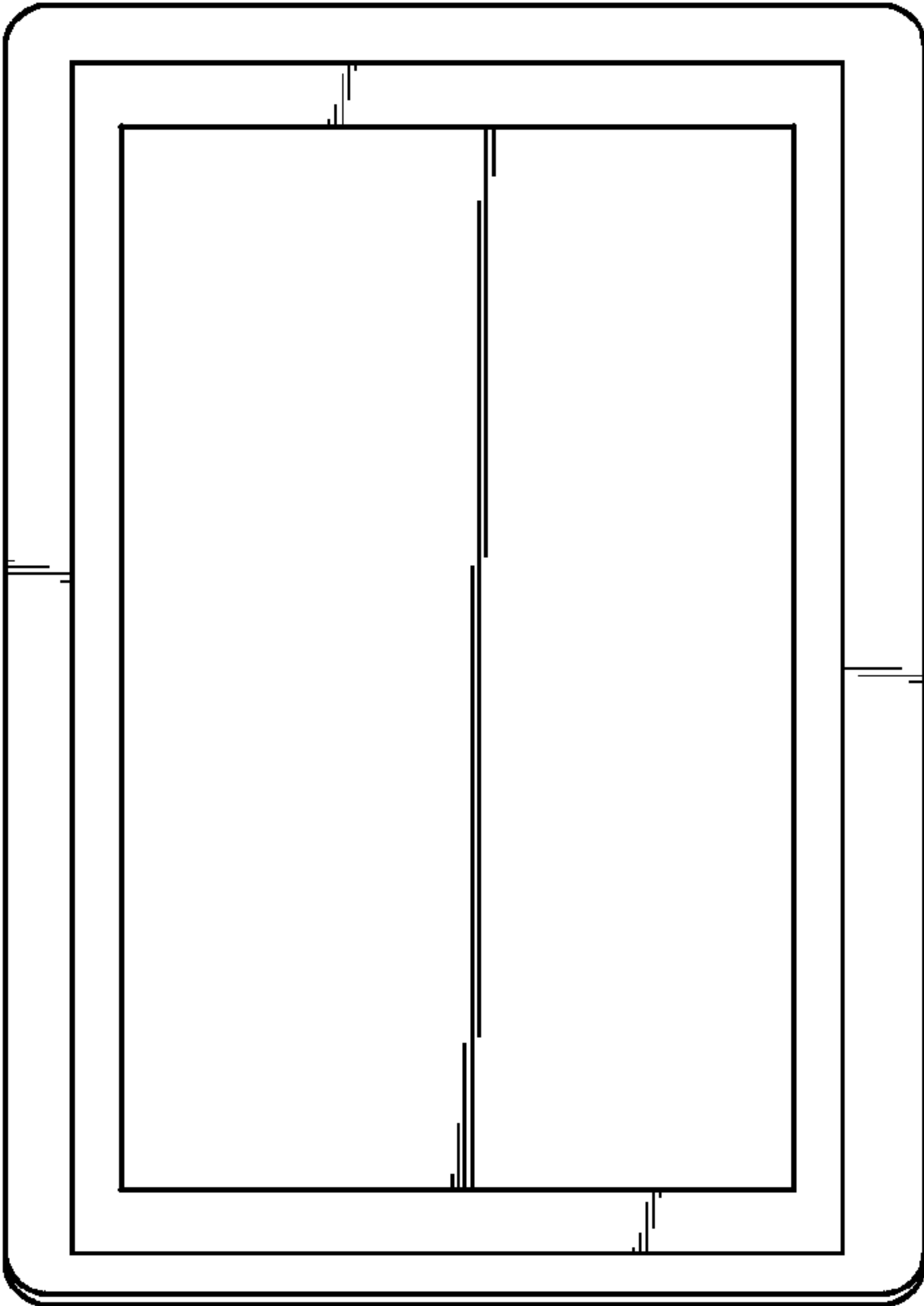

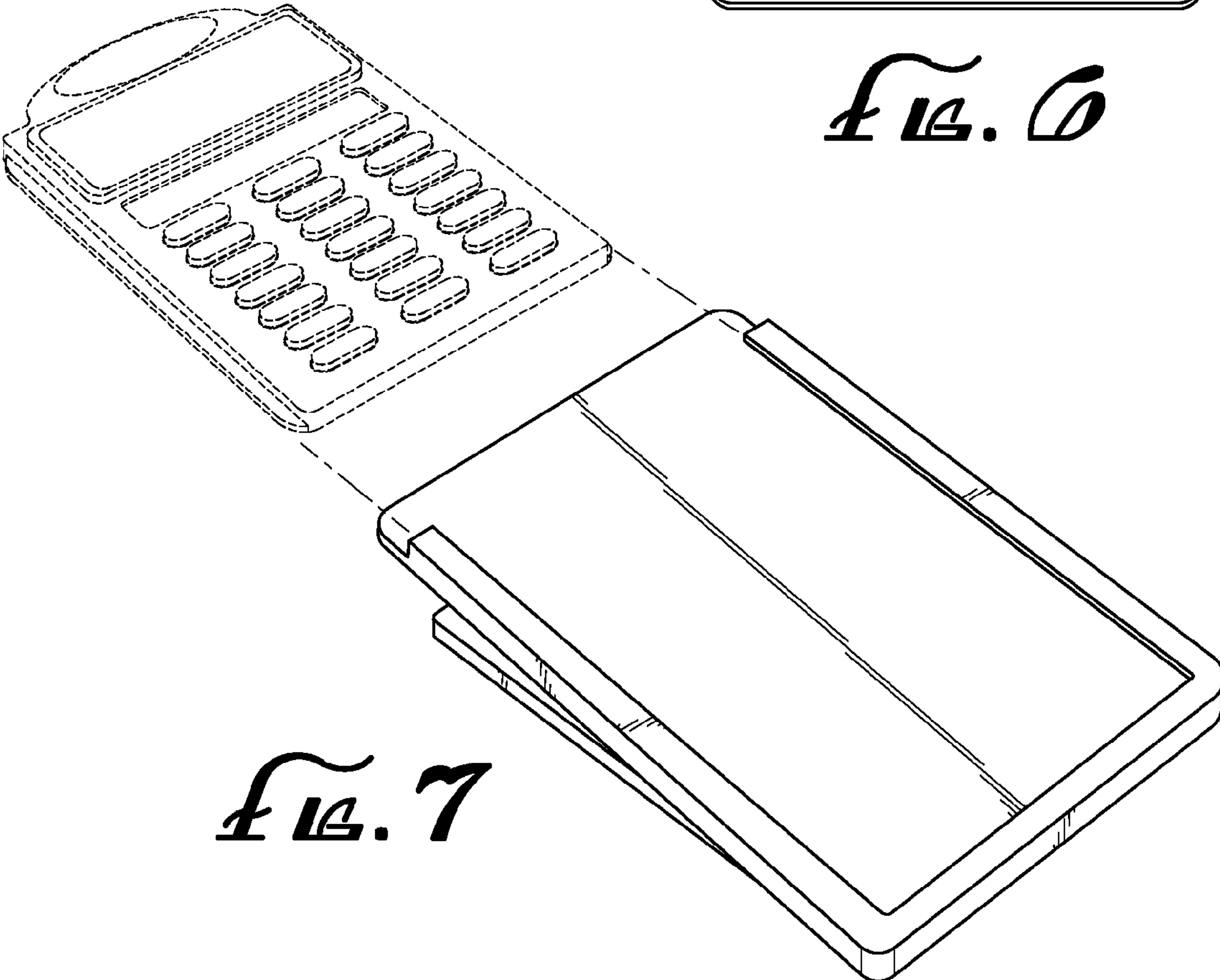
