(57) **CLAIM**

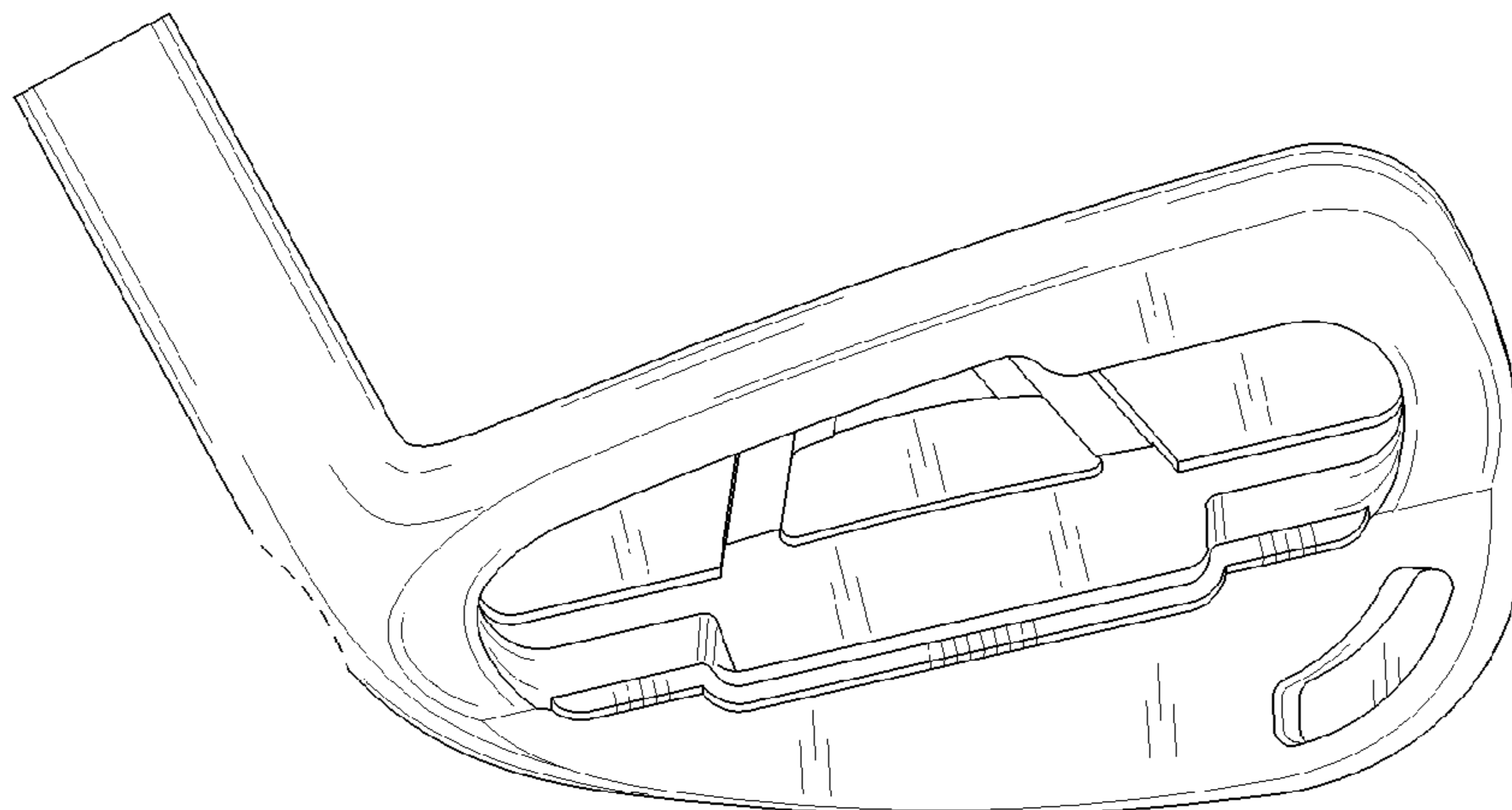
The ornamental design for a golf iron head, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of an example golf iron head; FIG. 2 is a bottom perspective view of the golf iron head of FIG. 1; FIG. 3 is a front elevational view of the golf iron head of FIG. 1; FIG. 4 is a rear elevational view of the golf iron head of FIG. 1; FIG. 5 is a top view of the golf iron head of FIG. 1; FIG. 6 is a bottom view of the golf iron head of FIG. 1; FIG. 7 is a heel end view of the golf iron head of FIG. 1; and, FIG. 8 is a toe end view of the golf iron head of FIG. 1.

The broken lines shown in FIGS. 1, 2, 3, 4, 5, 6, and 7 are for illustrative purposes only and form no part of the claimed design.

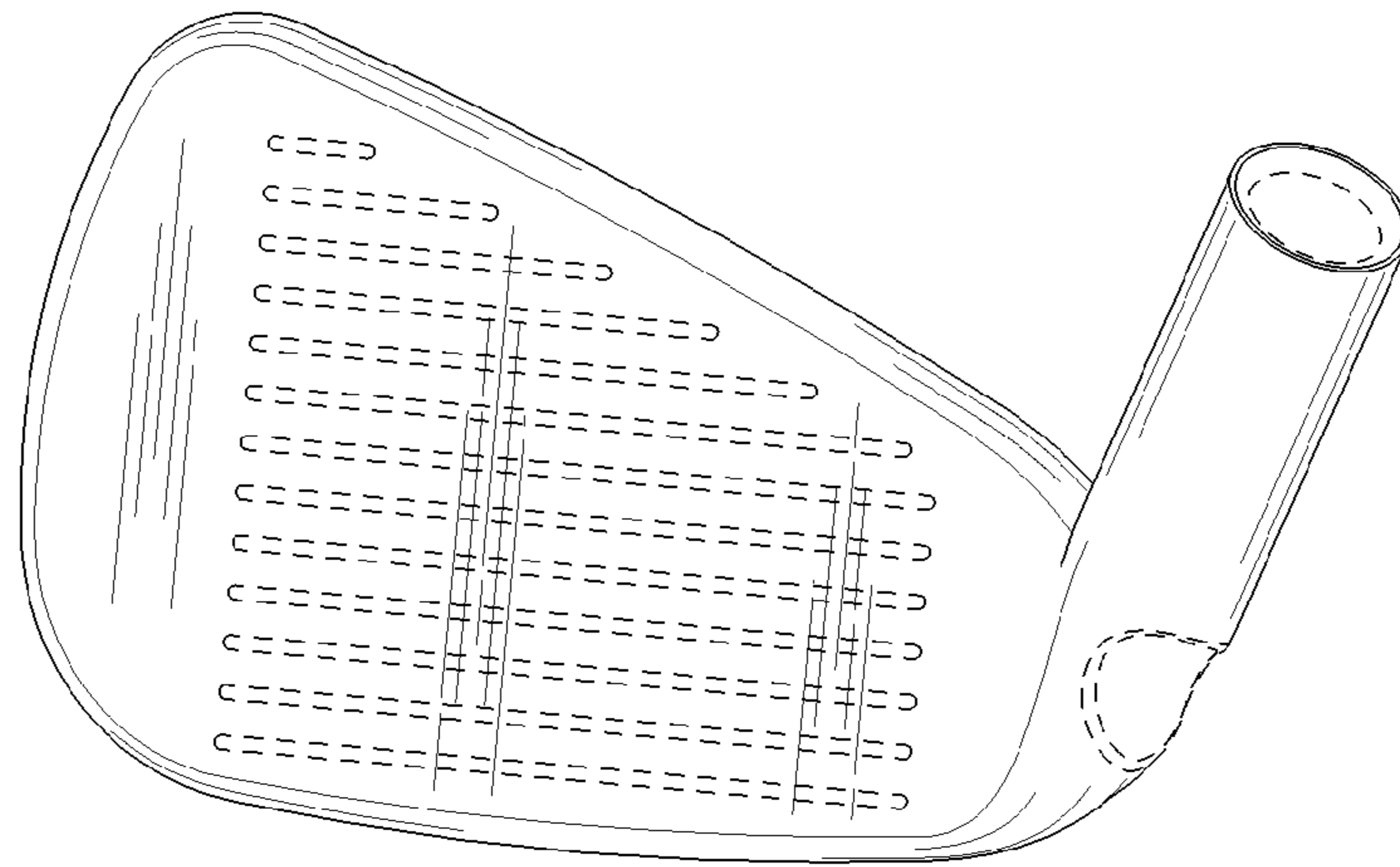

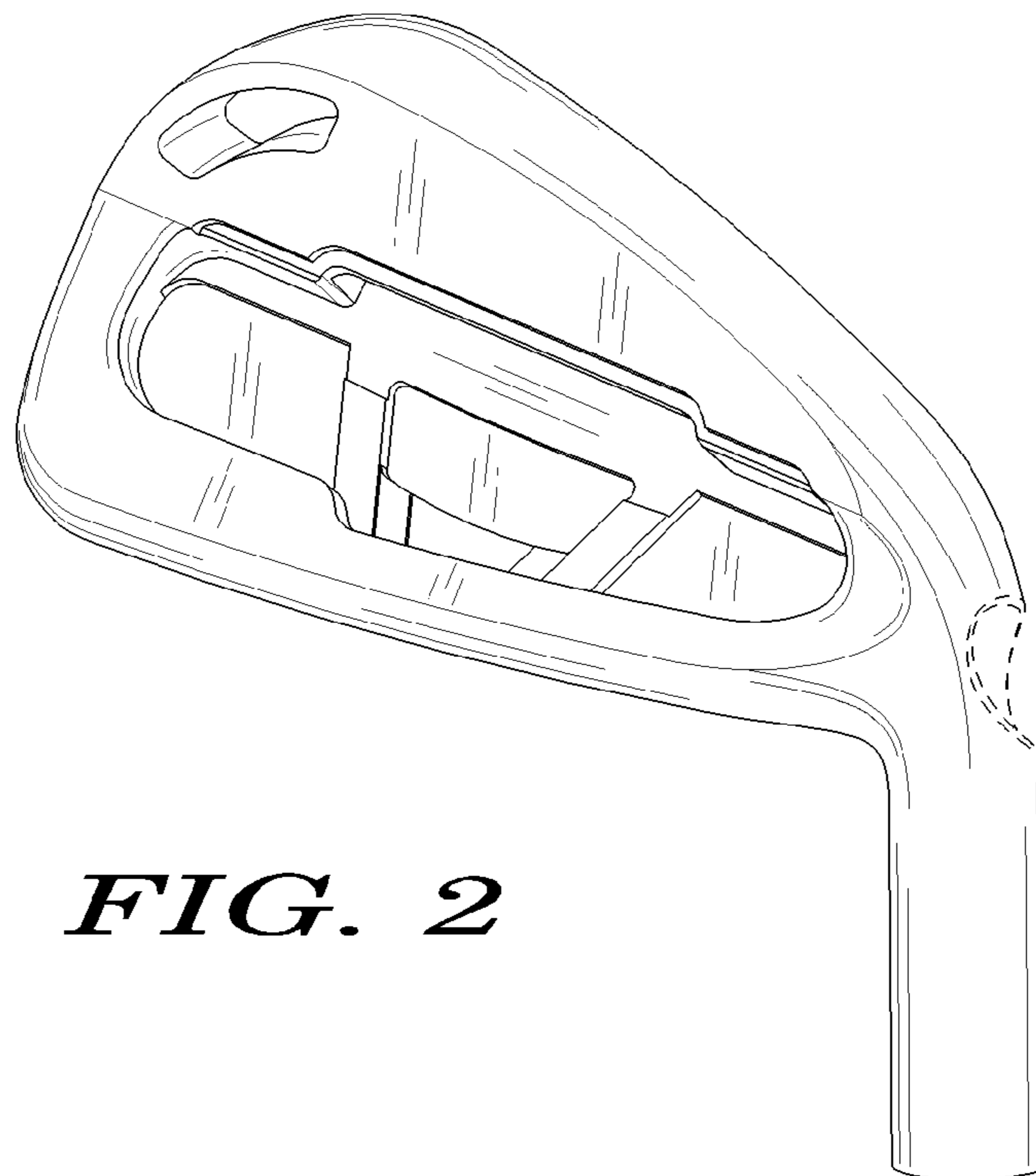

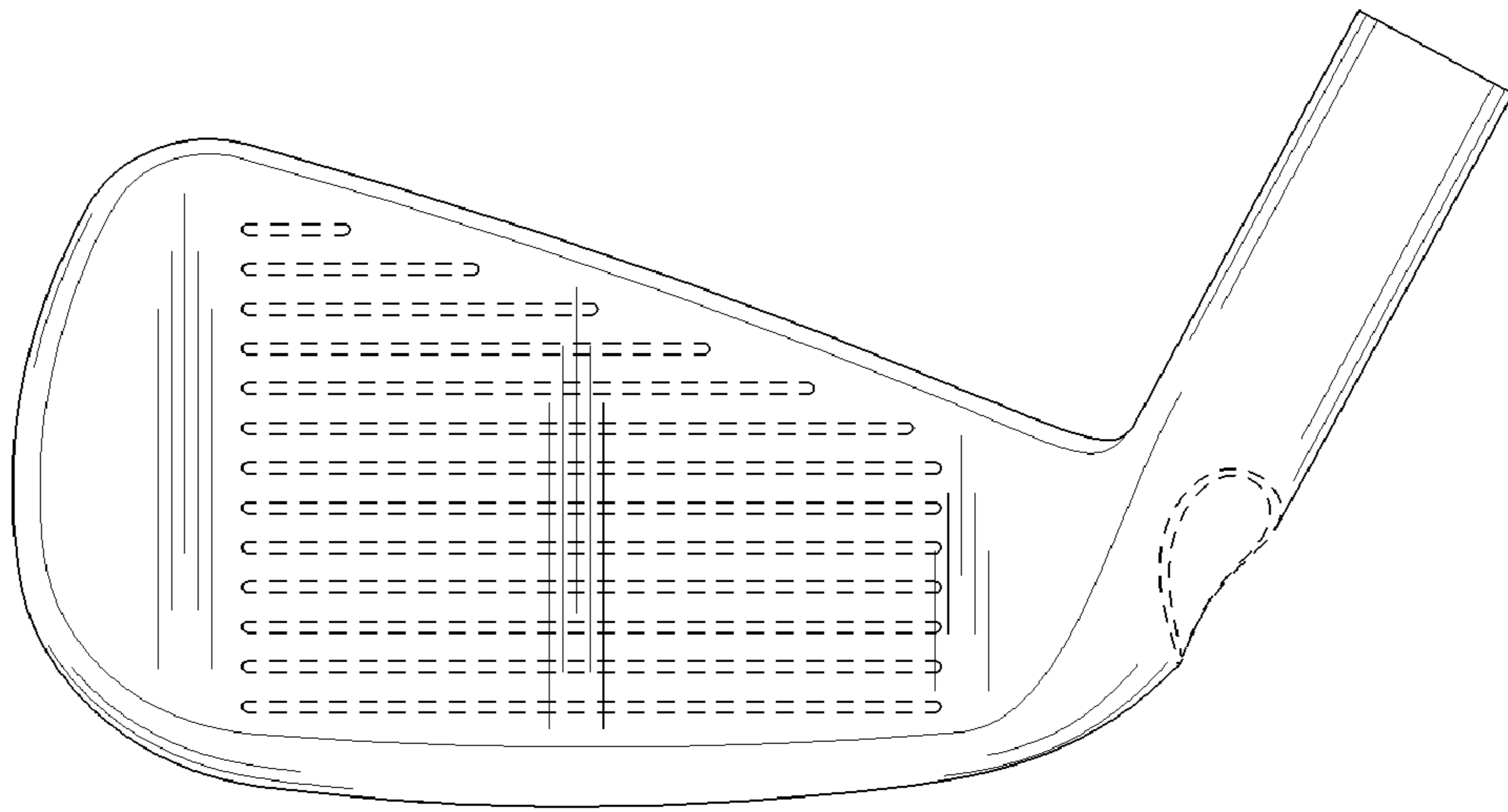

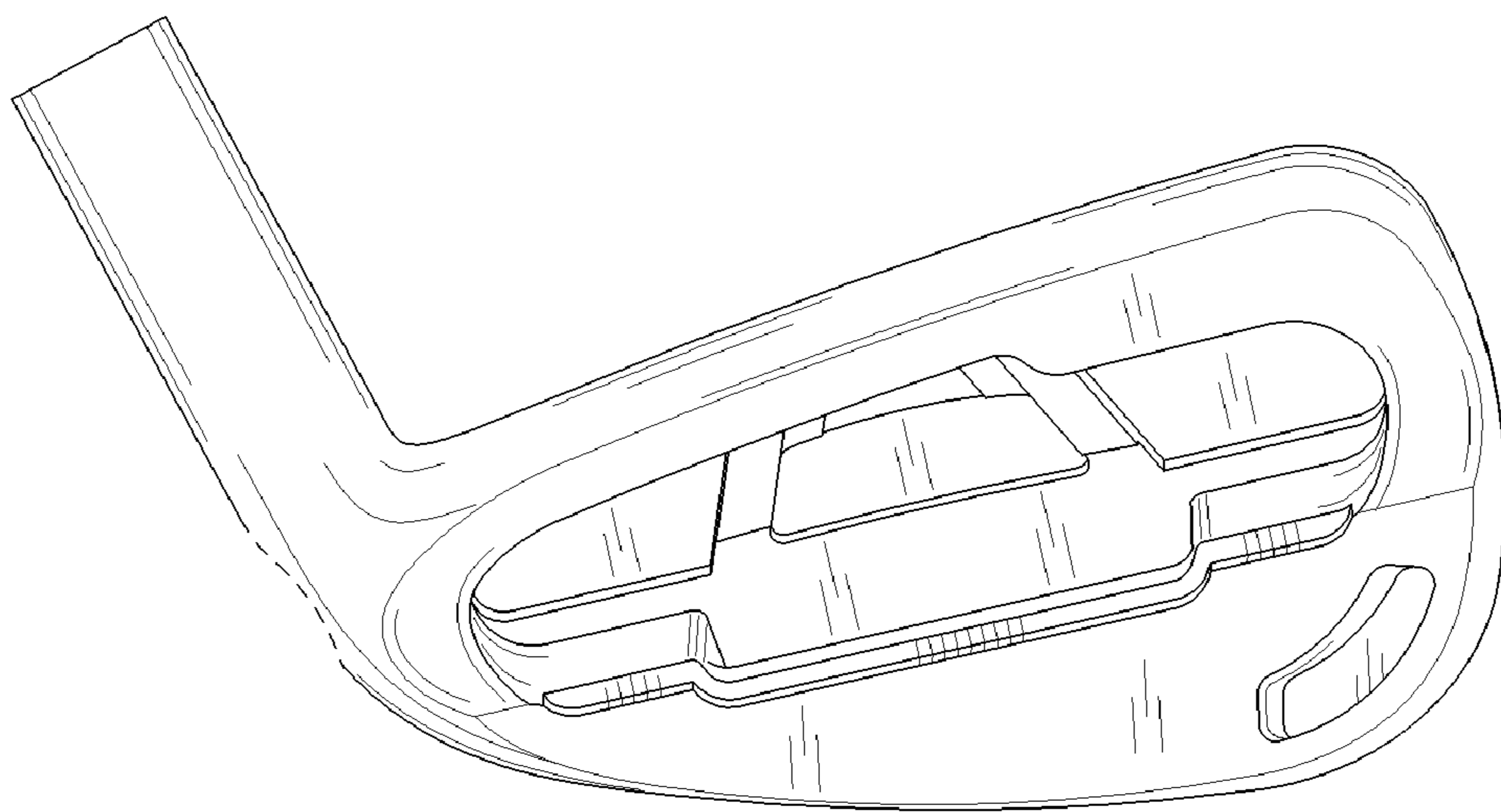

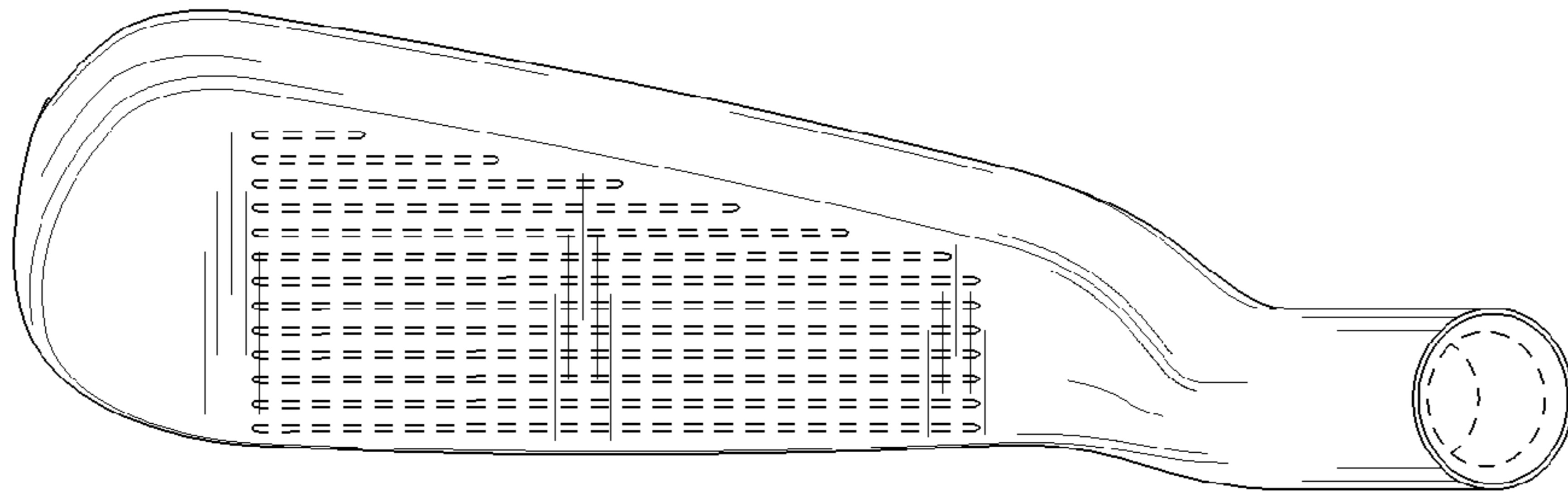

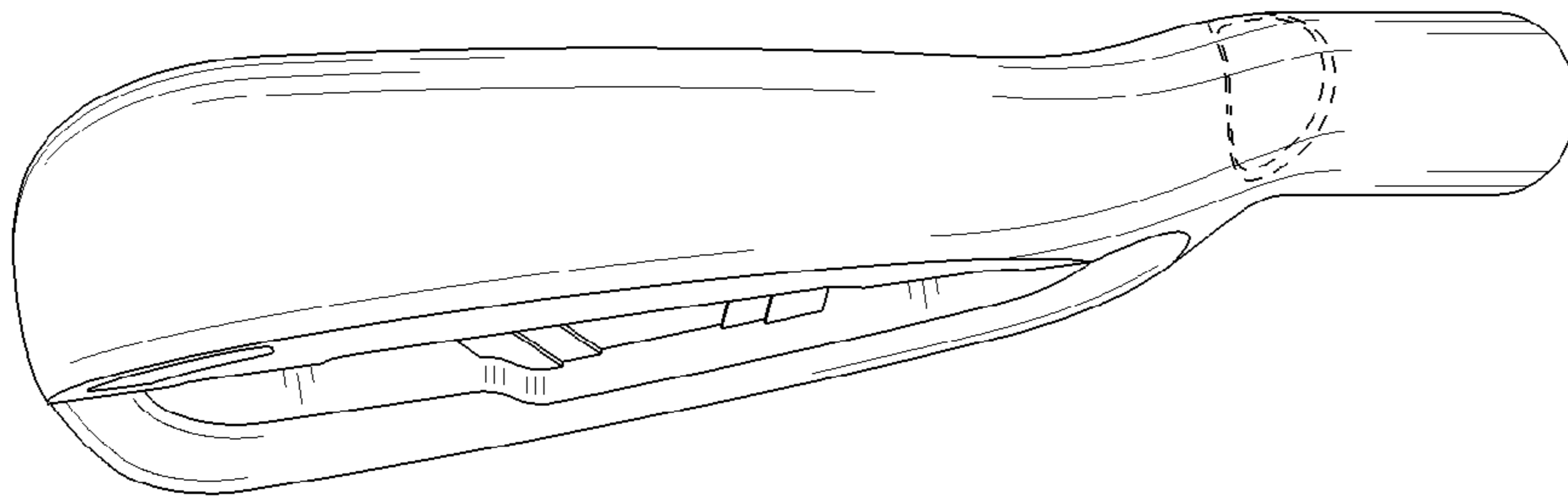

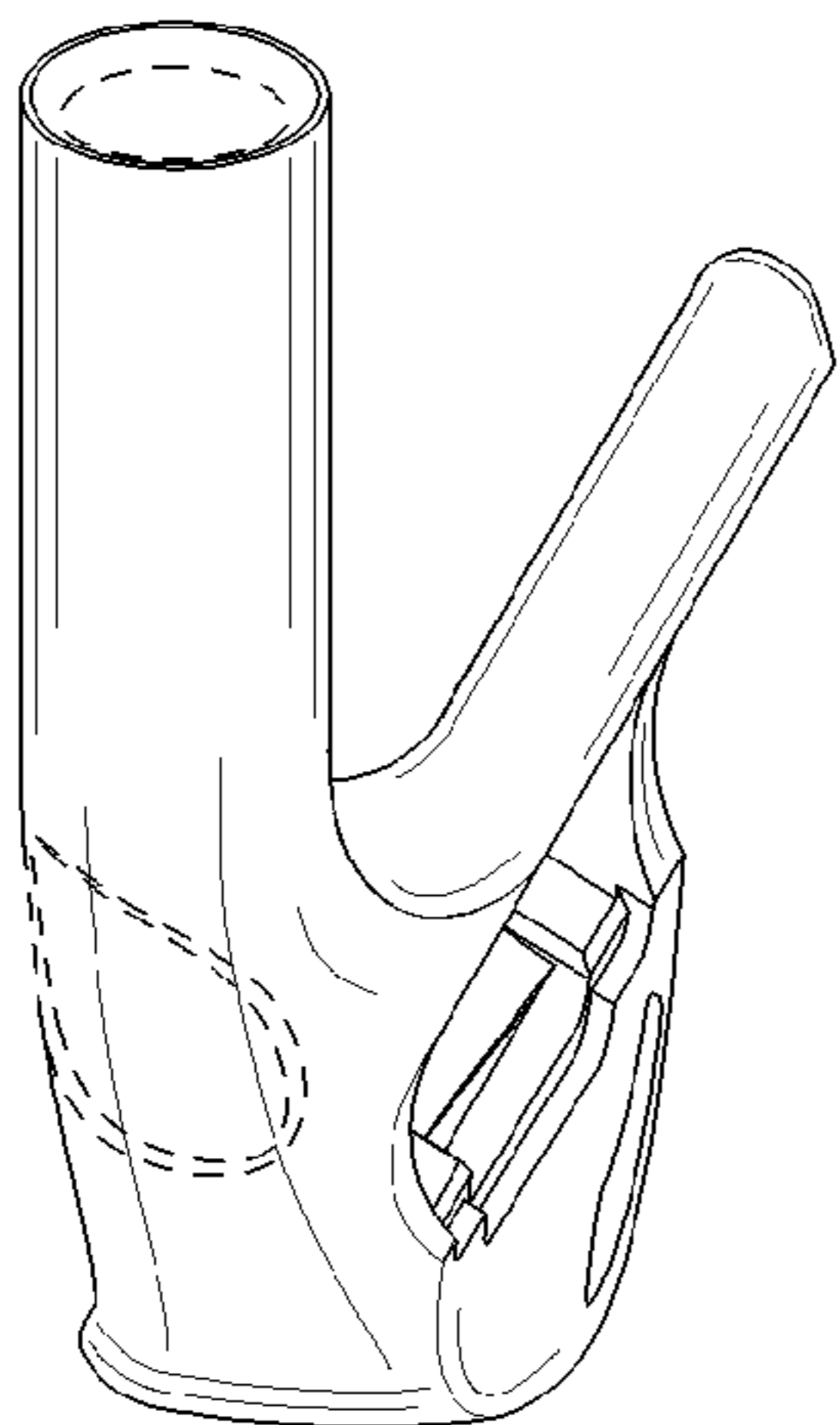

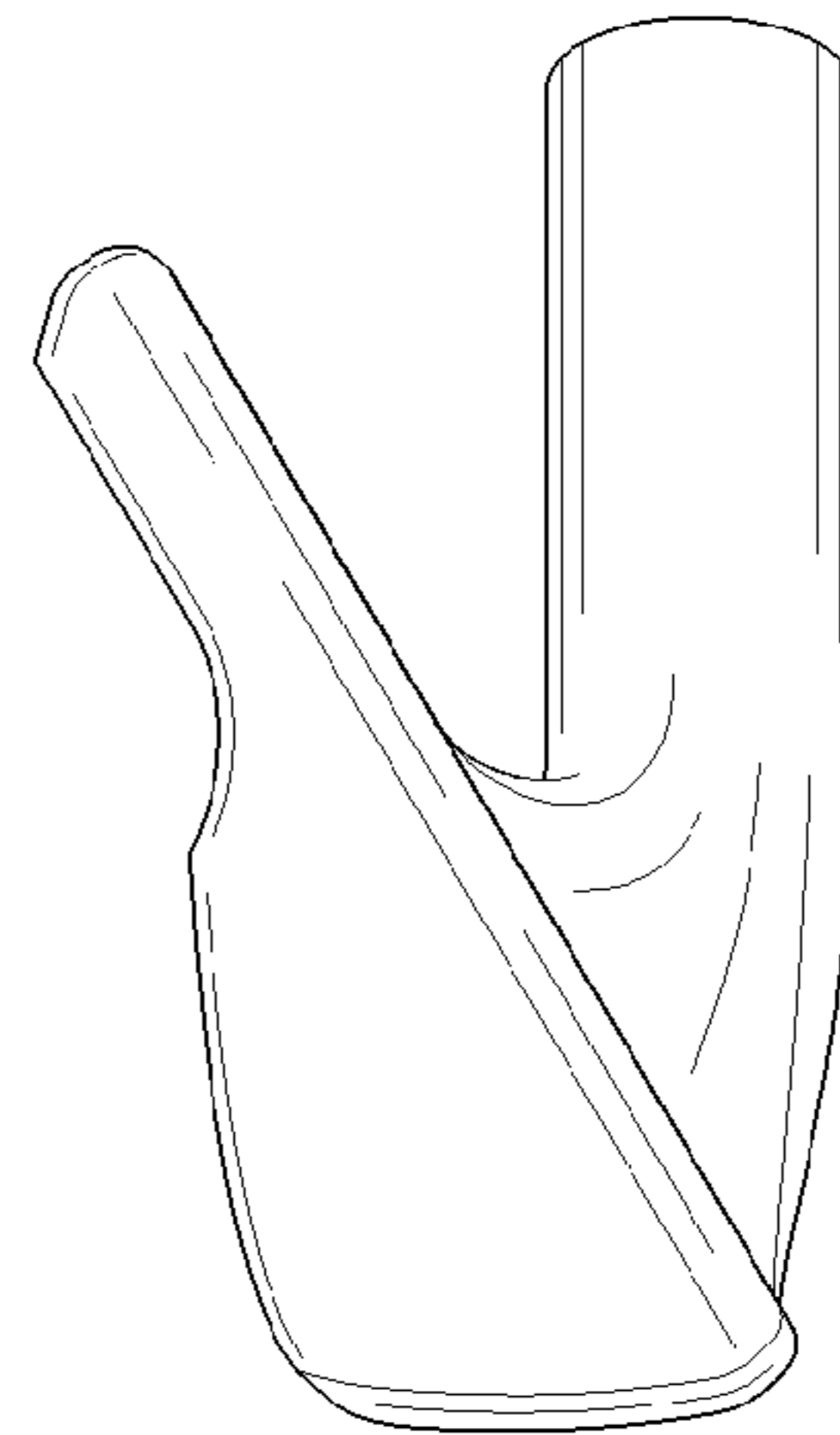
