FIG. 2 is a right side elevational view of the golf club grip of FIG. 1;

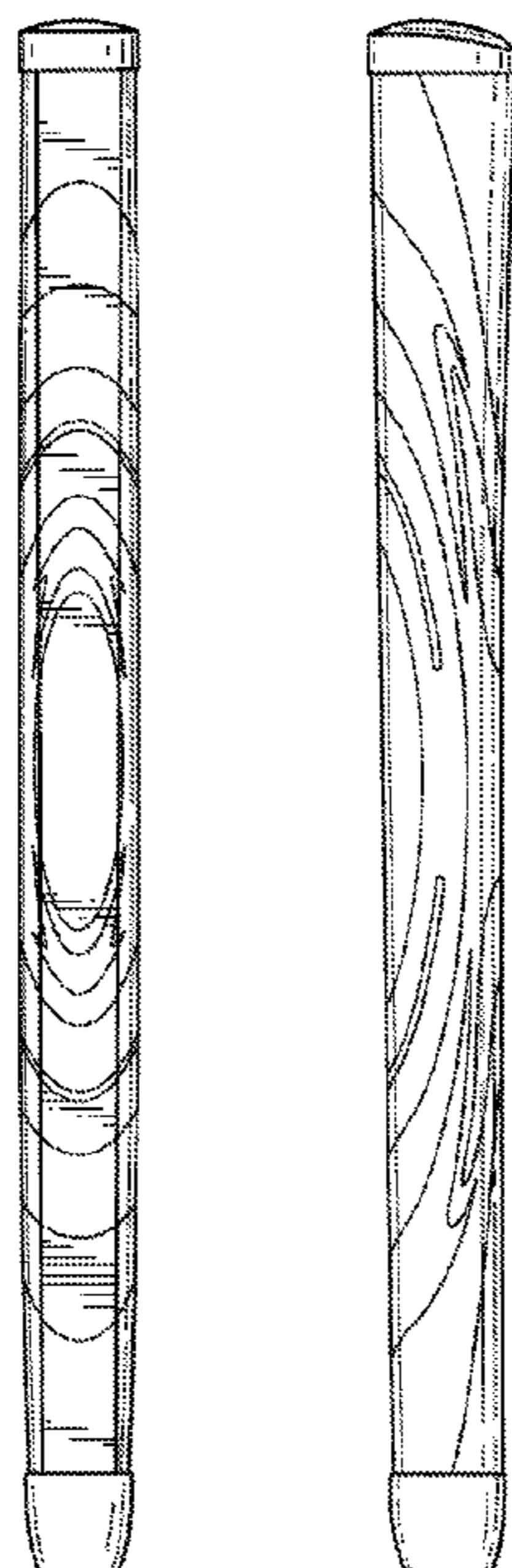
FIG. 3 is a left side elevational view of the golf club grip of FIG. 1;

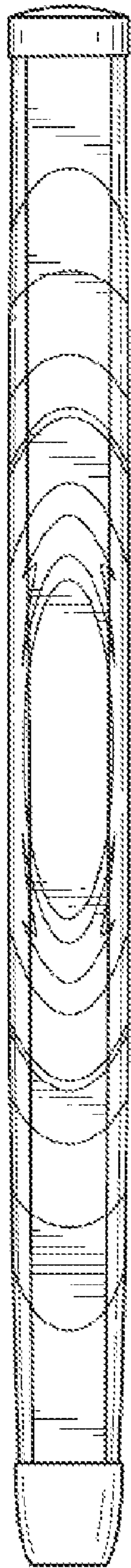

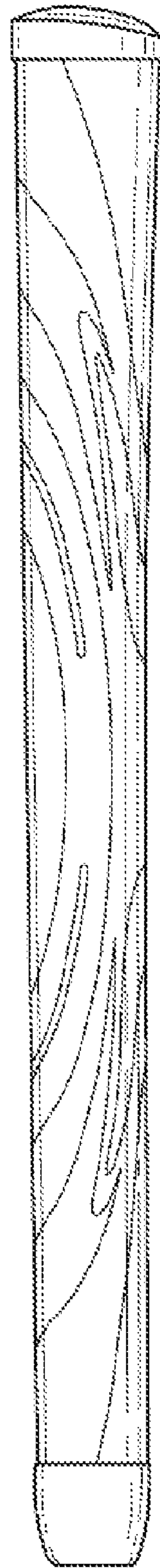

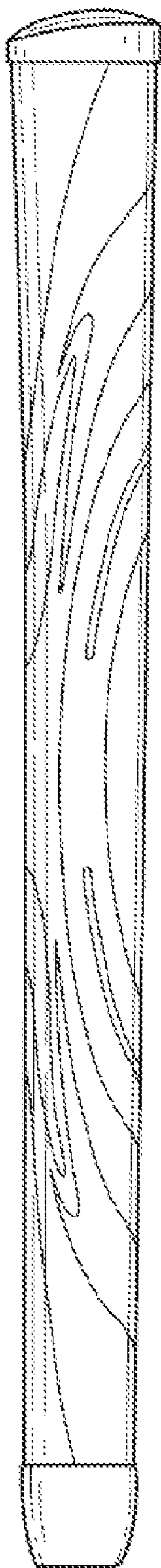

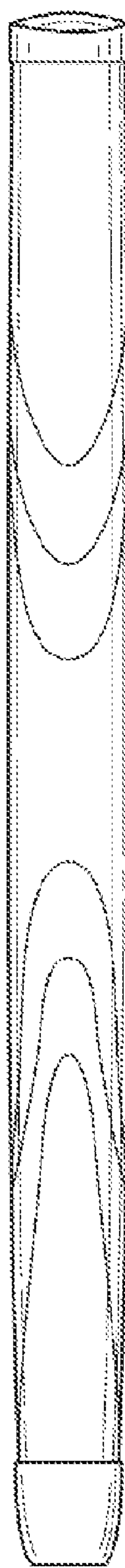

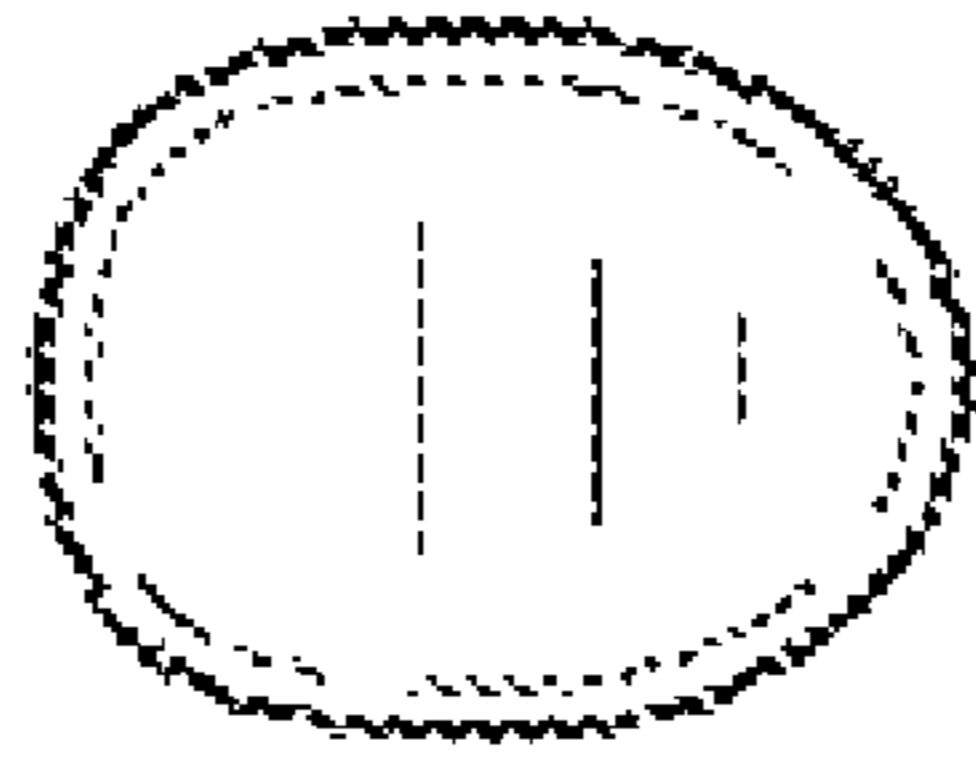

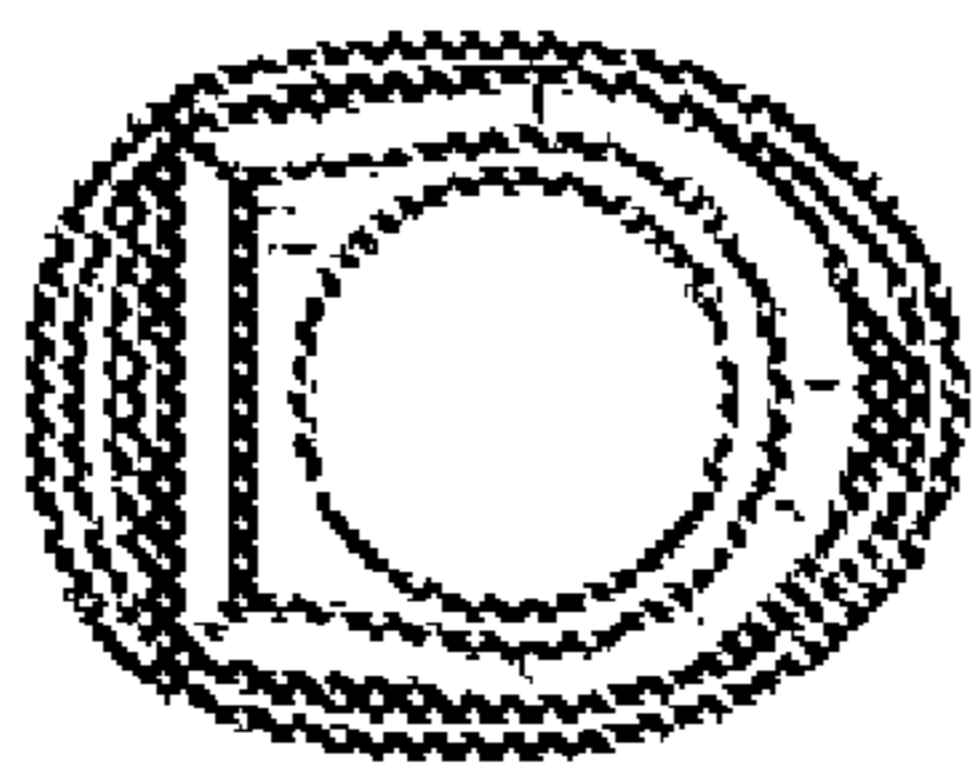
