(57) **CLAIM**

The ornamental design for a plunger rod for syringe, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a plunger rod for syringe showing my new design;

FIG. 2 is a bottom perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a right side elevational view thereof;

FIG. 7 is a top plan view thereof;

FIG. 8 is a bottom plan view thereof;

FIG. 9 is a sectional view thereof taken along line 9—9 of FIG. 7;

FIG. 10 is a sectional view thereof taken along line 10—10 of FIG. 8;

FIG. 12 is a sectional view thereof taken along line 12—12 of FIG. 3;

FIG. 13 is a sectional view thereof taken along line 13—13 of FIG. 3; and,

FIG. 14 is a bottom perspective view thereof.

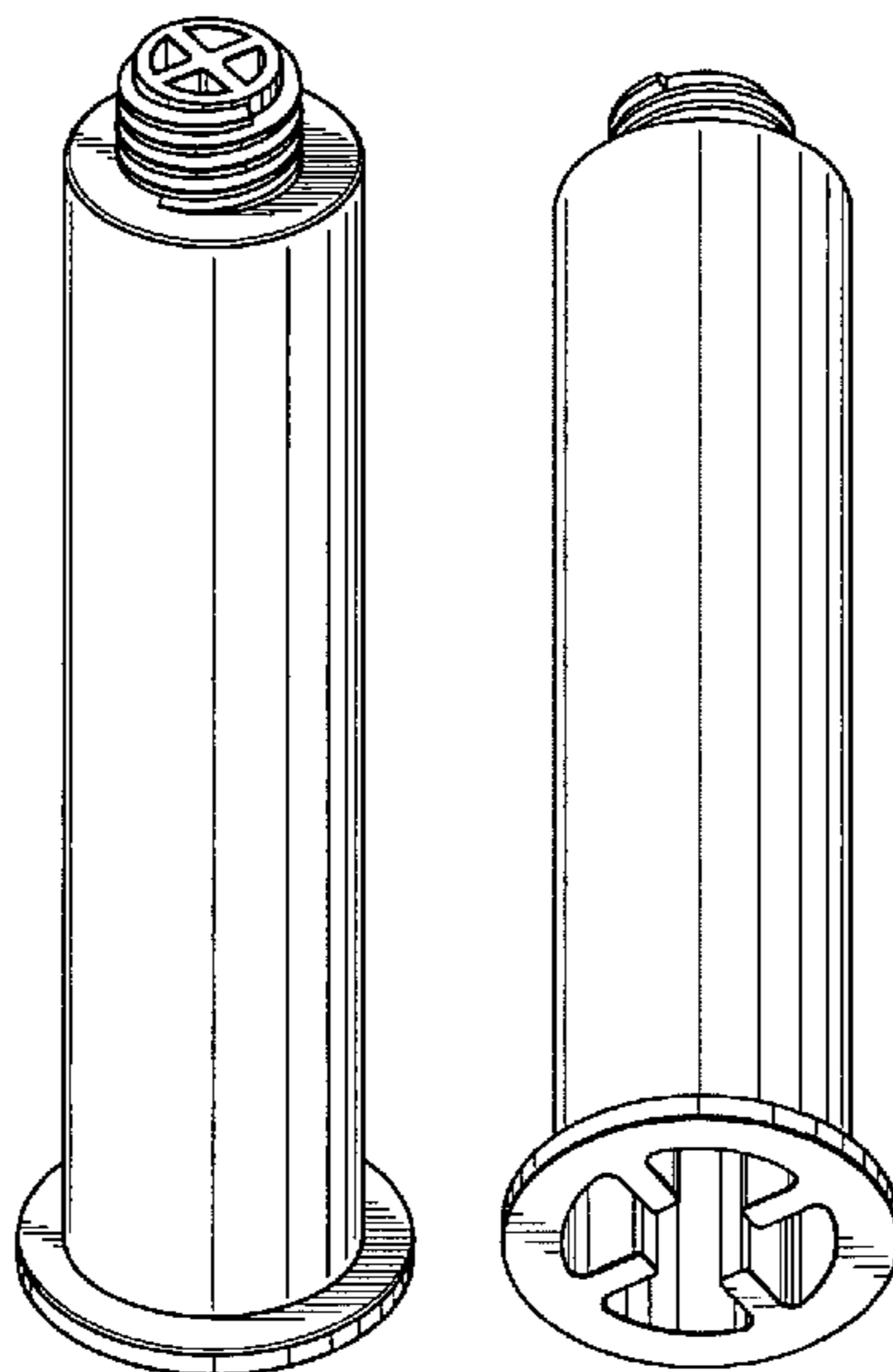

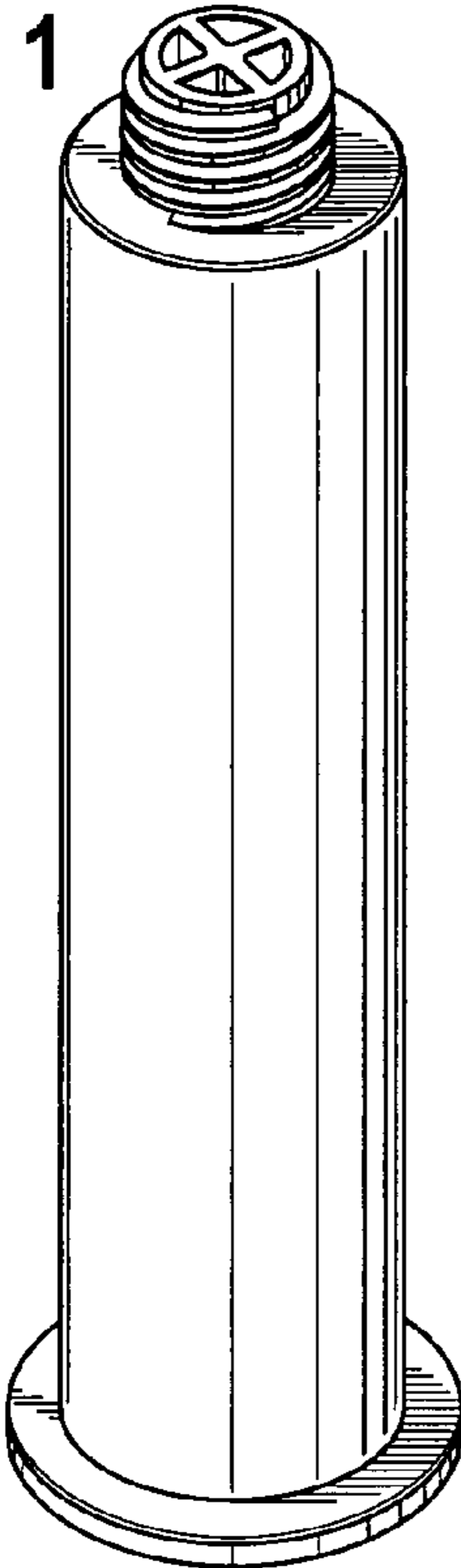

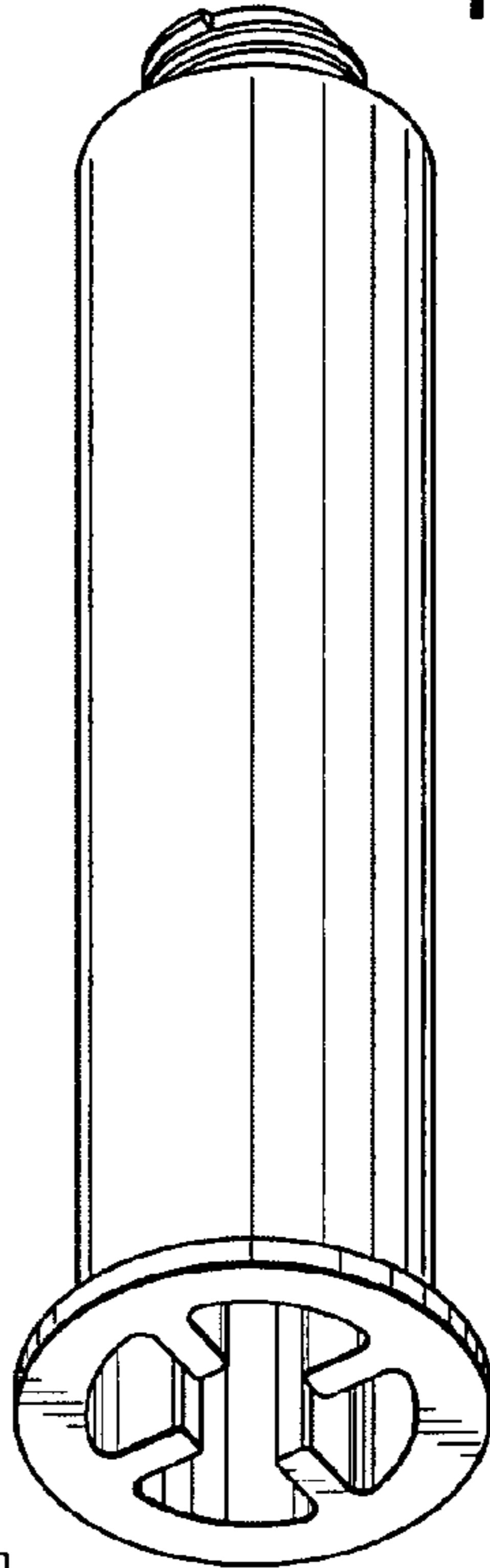

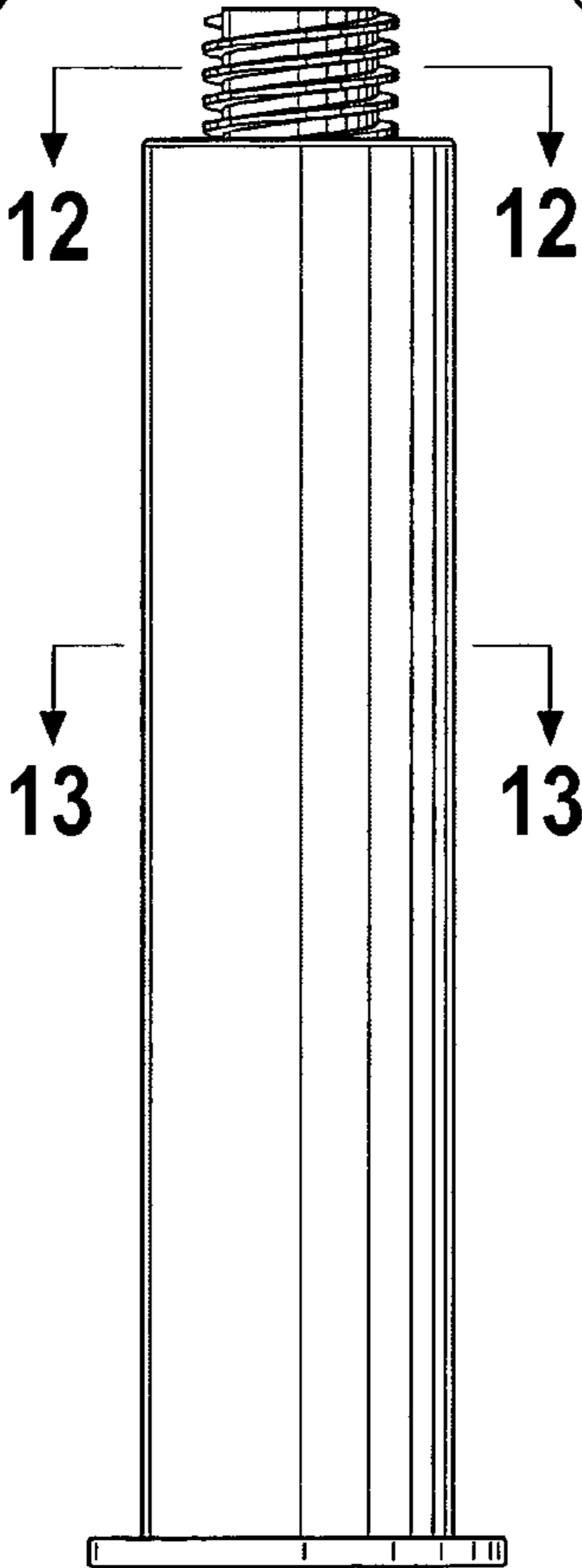

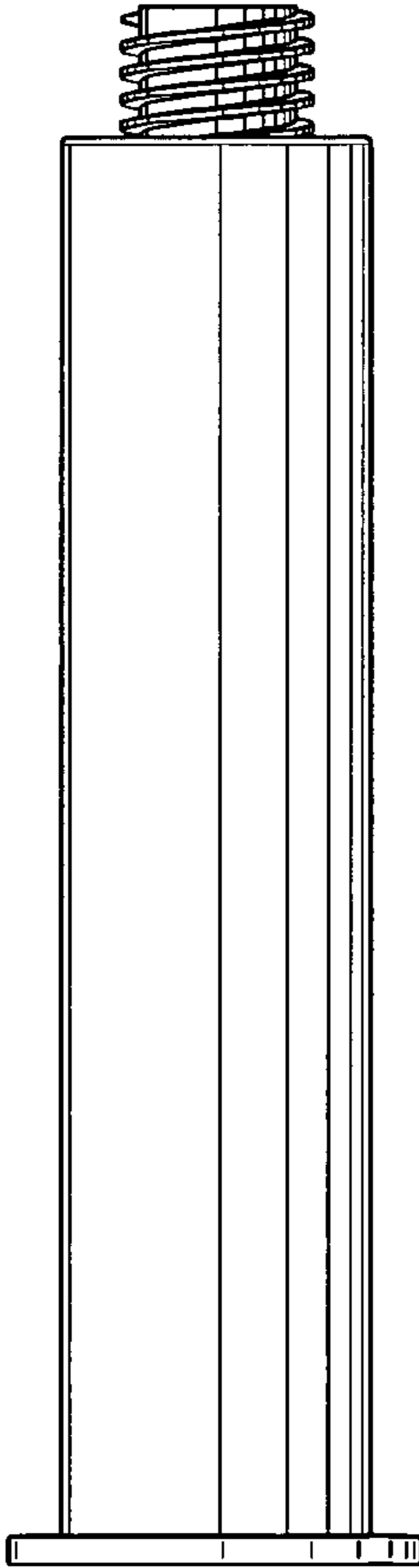

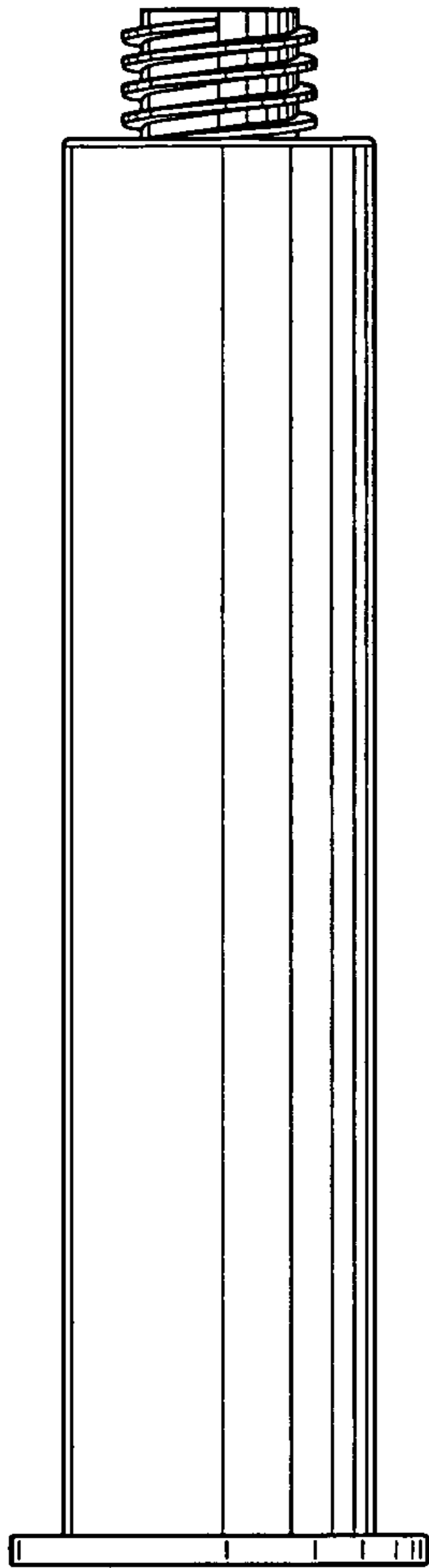

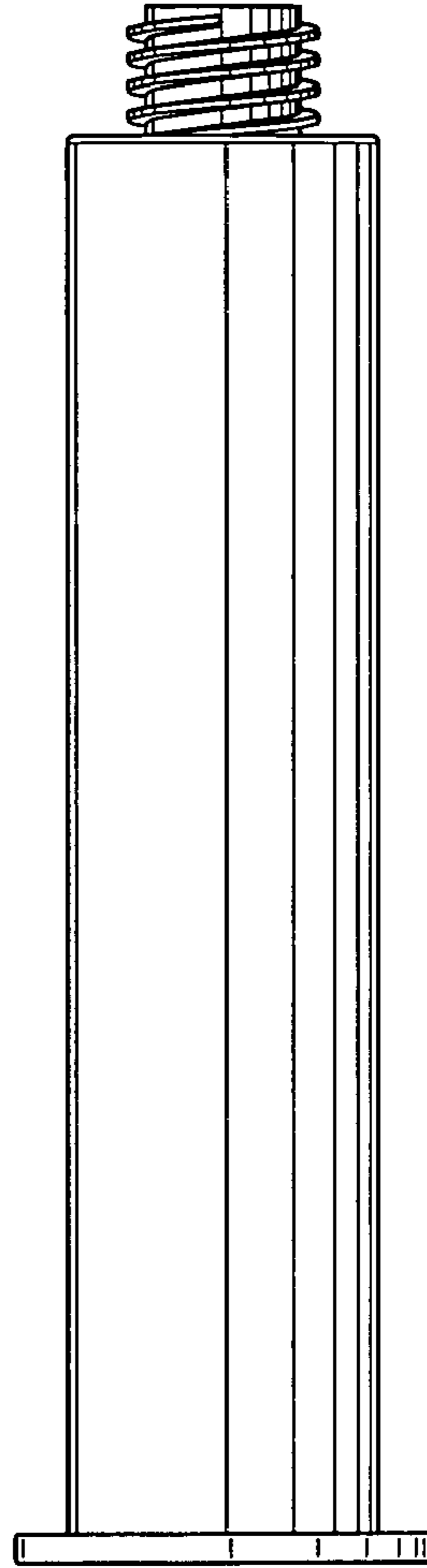

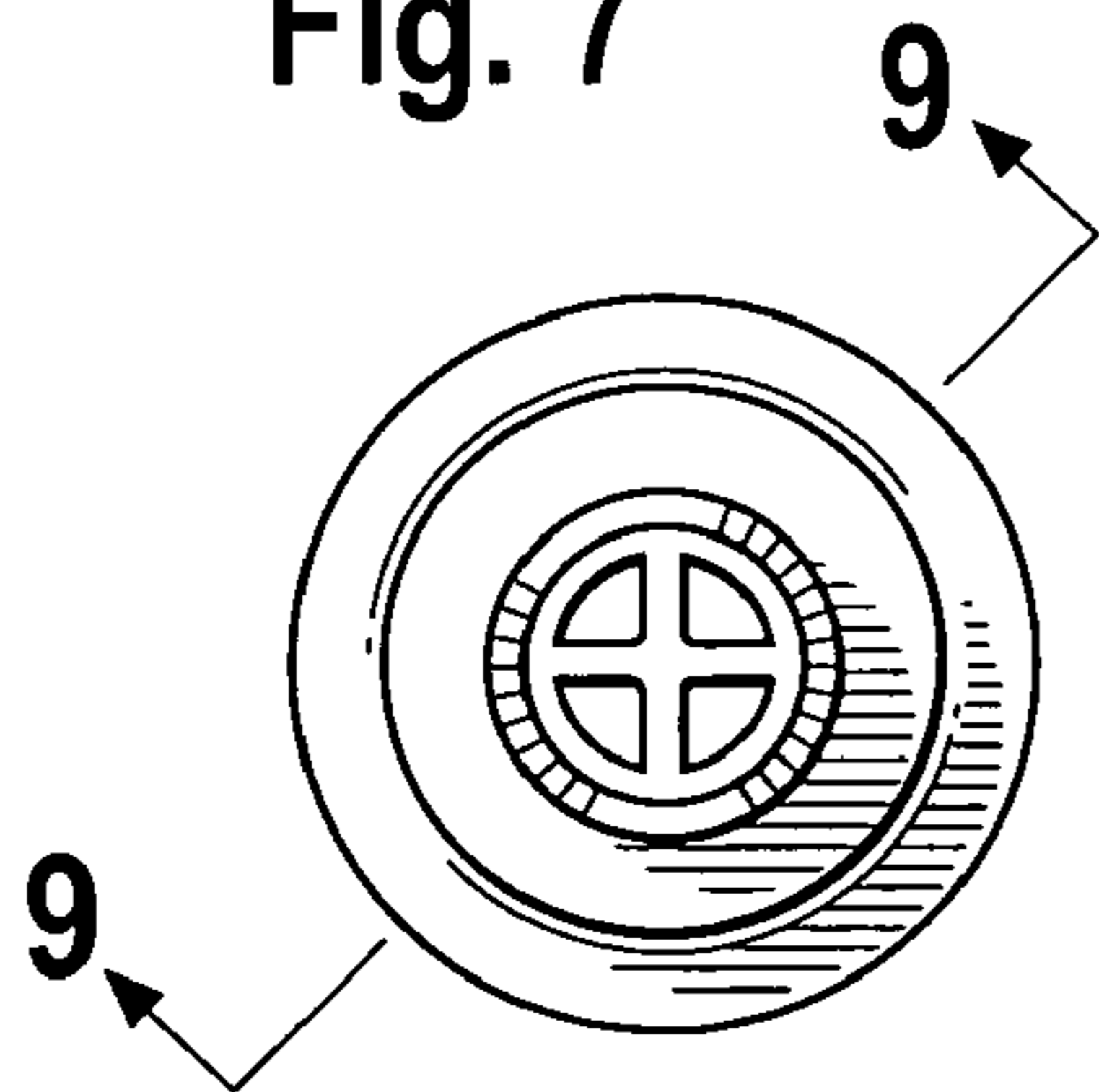

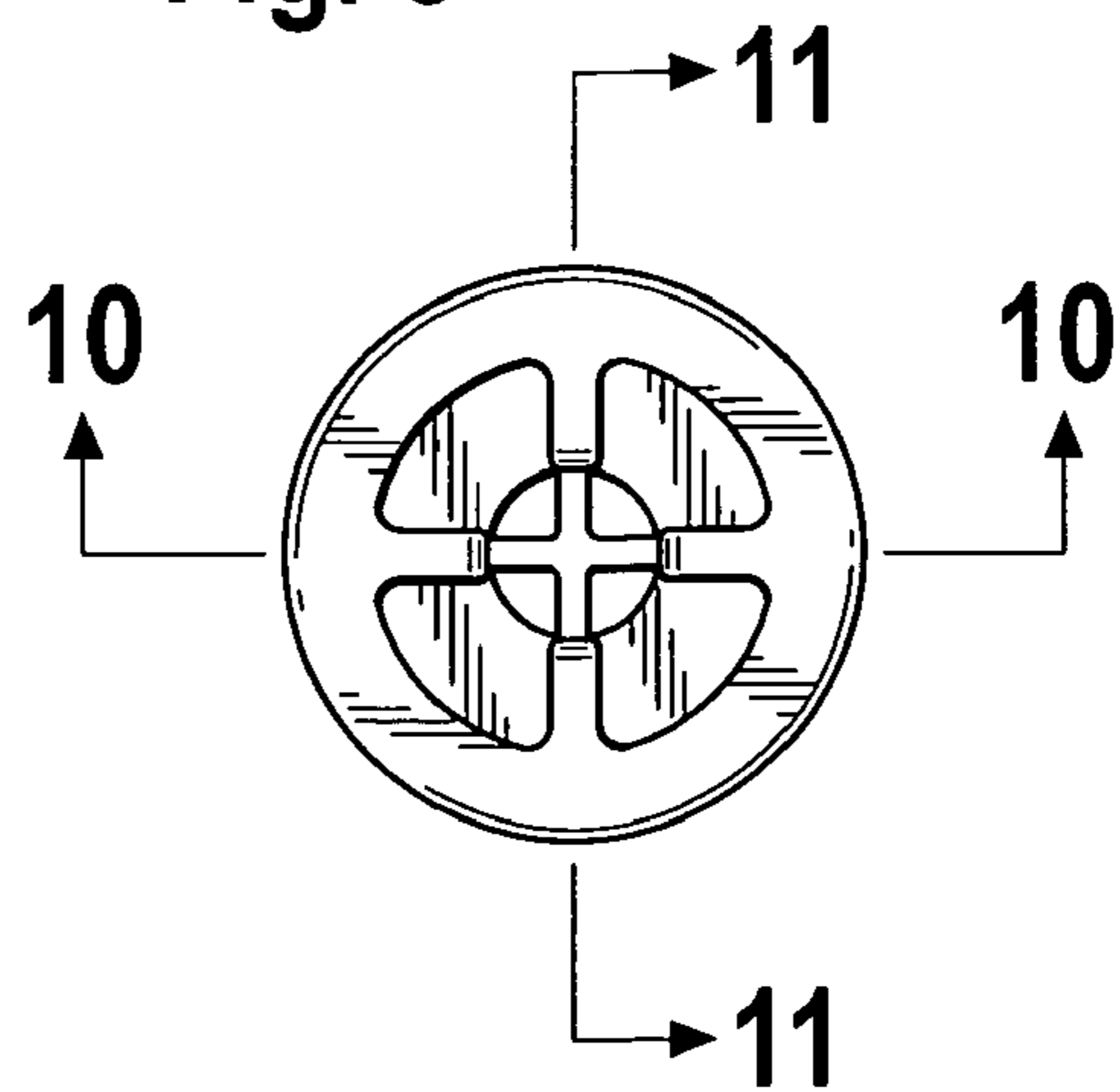

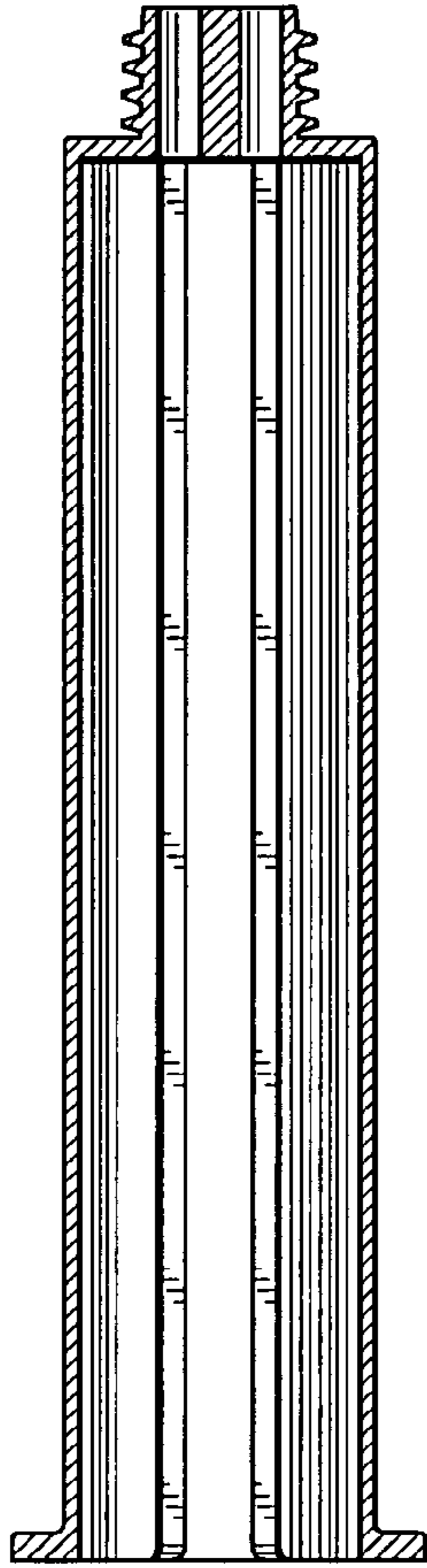

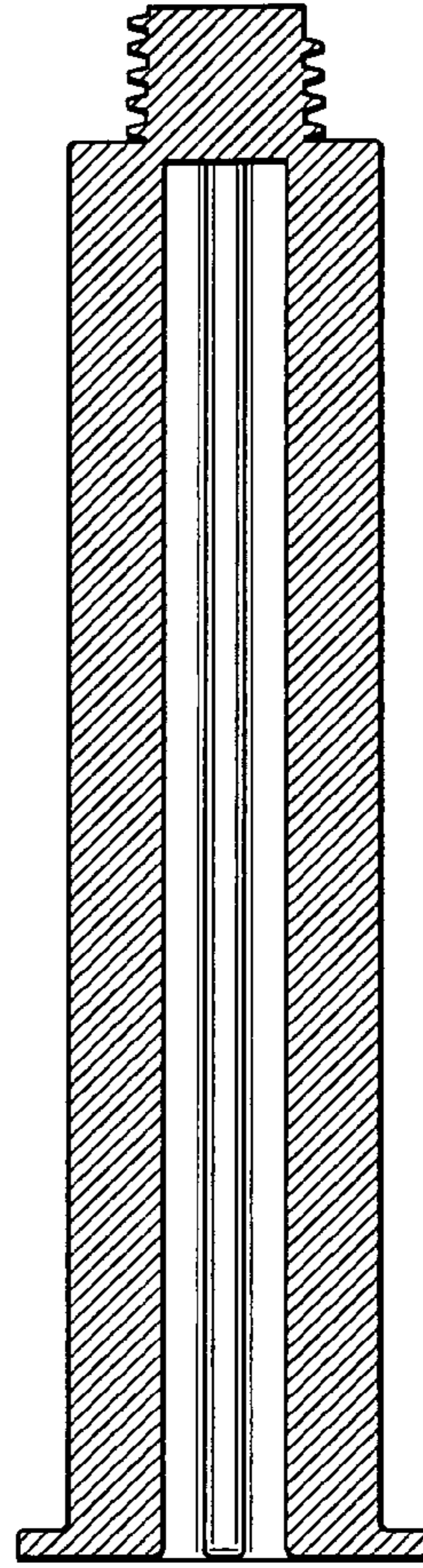

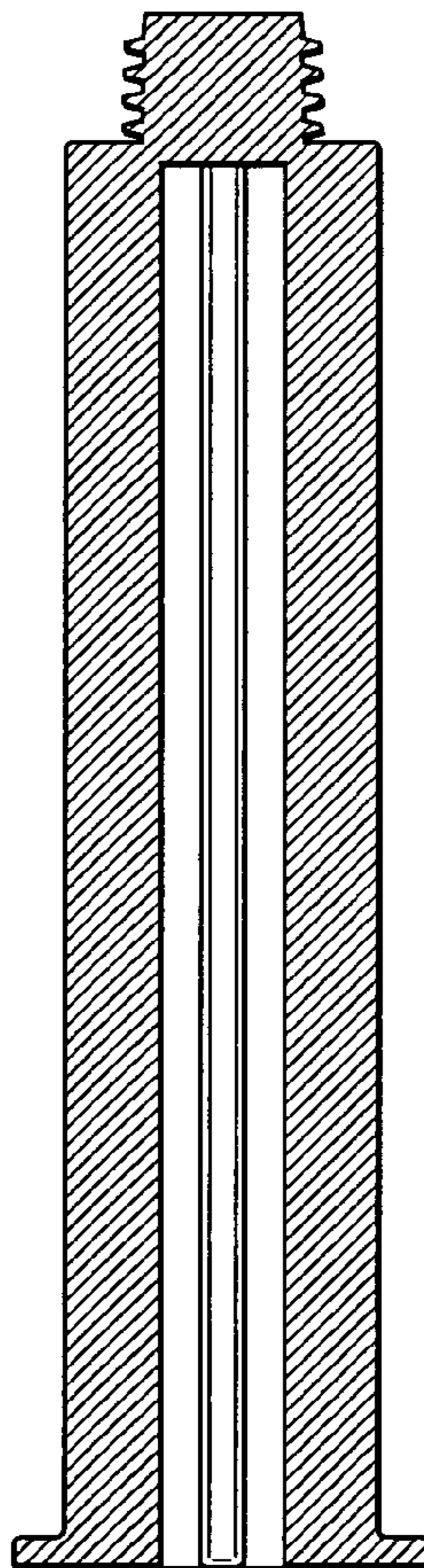
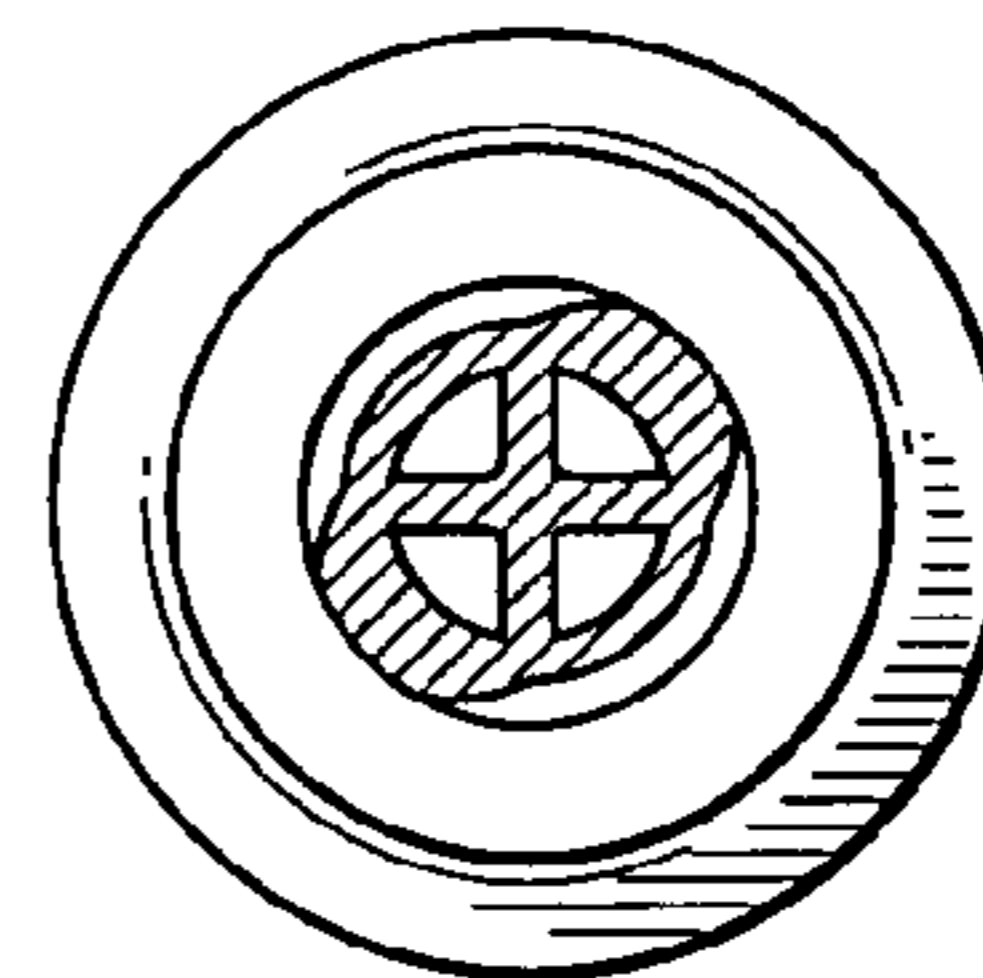
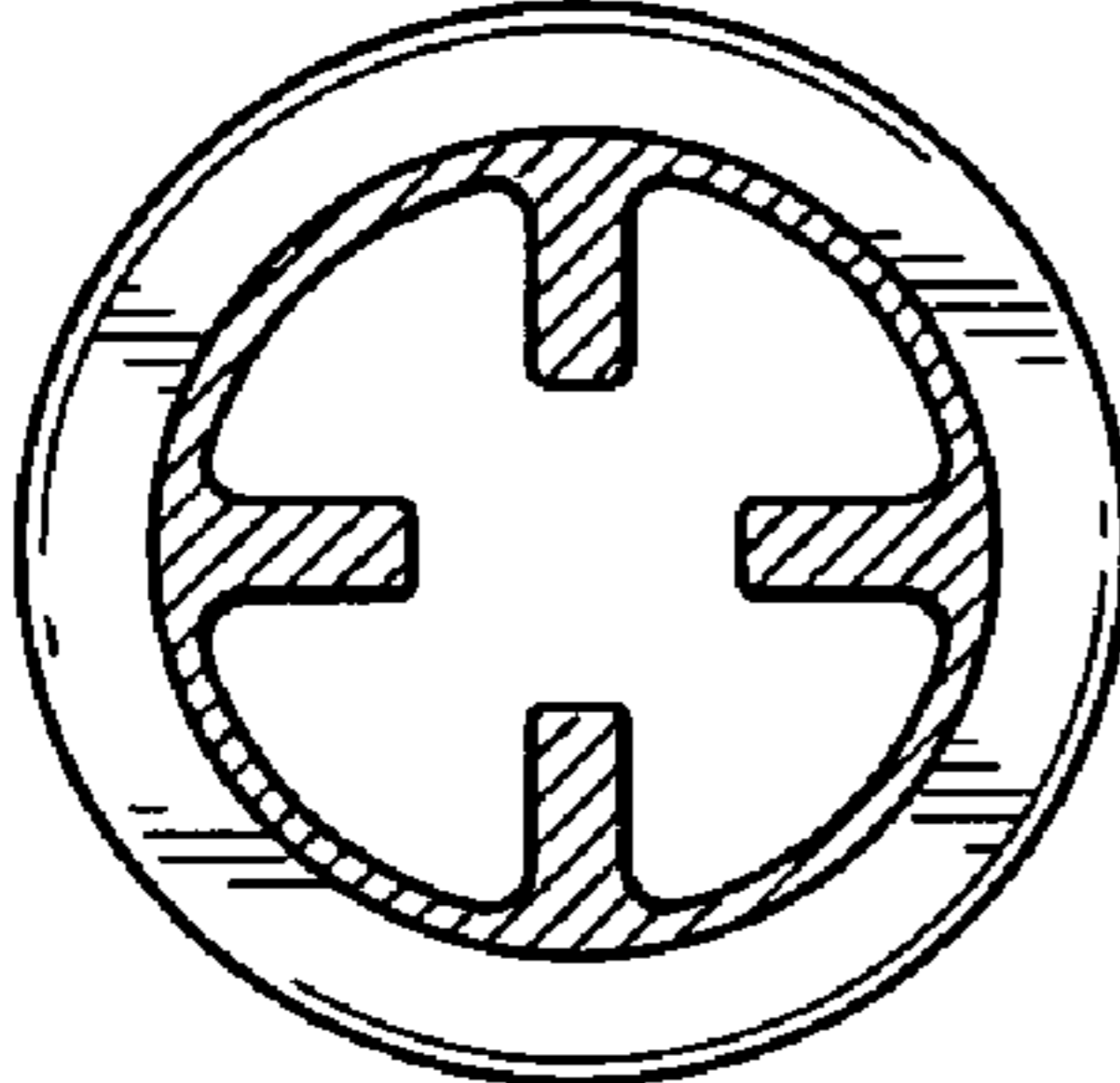
