(57) **CLAIM**

The ornamental design for a dynamic spinal plate implant, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a dynamic spinal plate implant showing my new design;

FIG. 2 is left side perspective view thereof;

FIG. 3 is a right side perspective view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a front elevational view thereof;

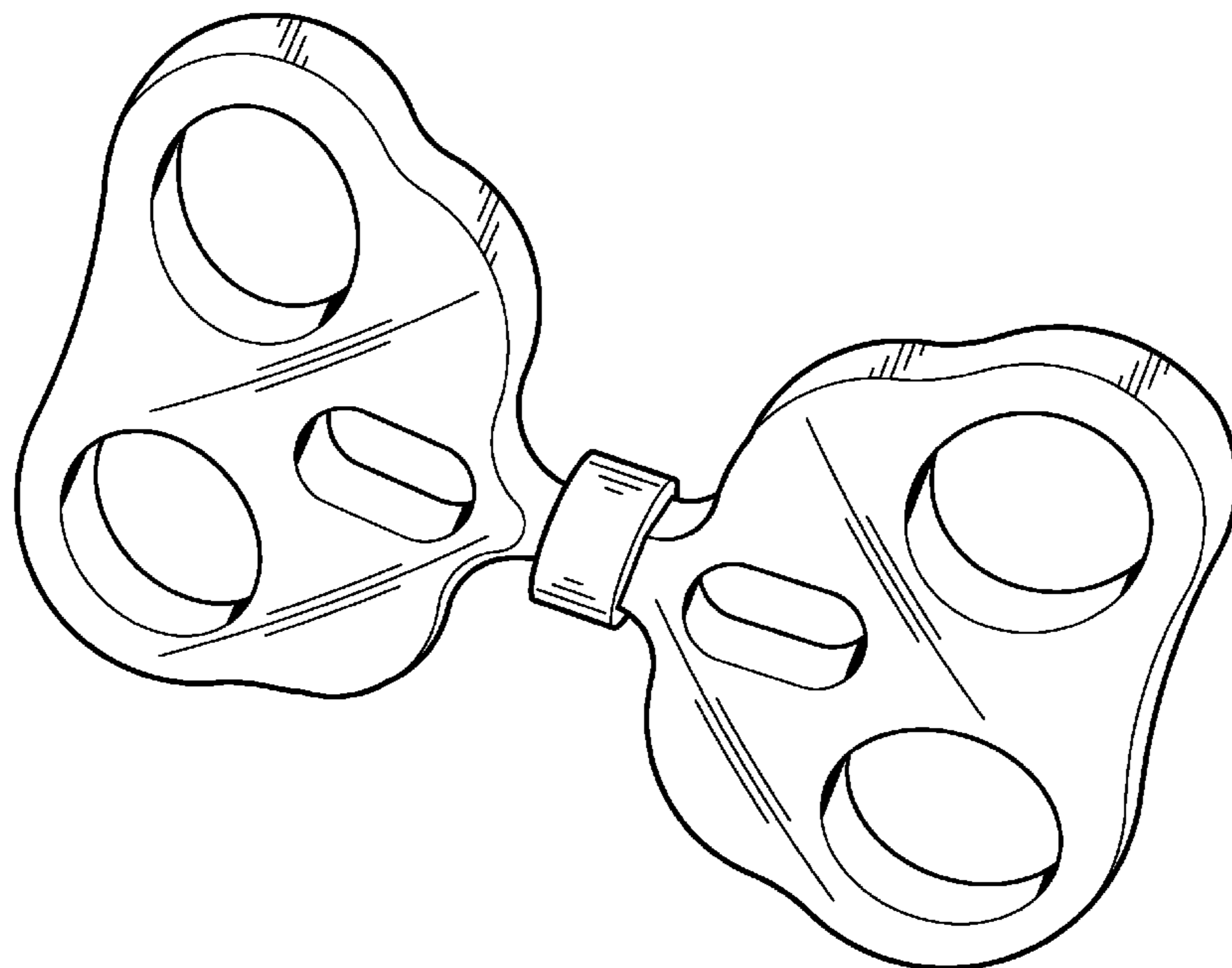
FIG. 6 is a bottom plan view thereof;

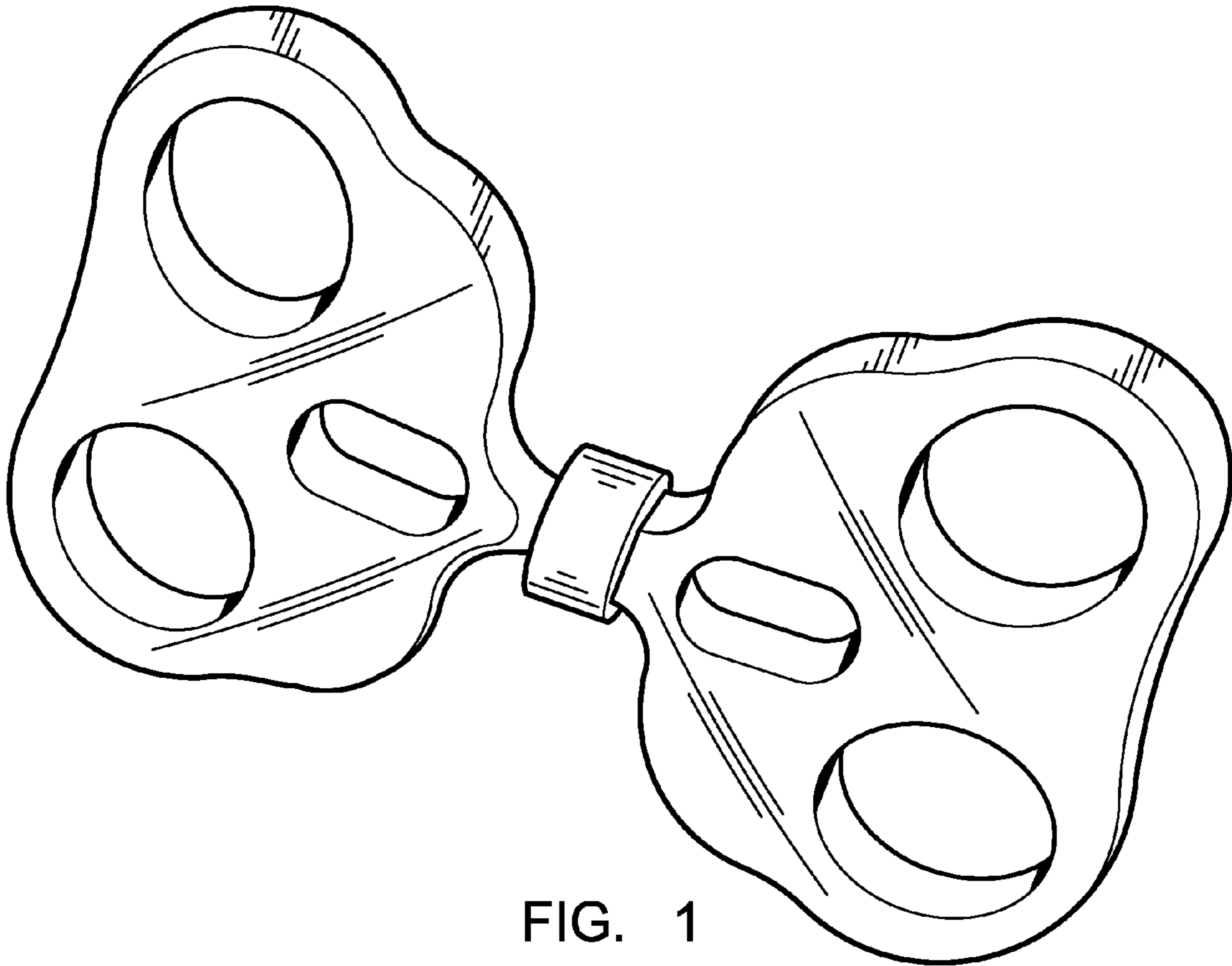

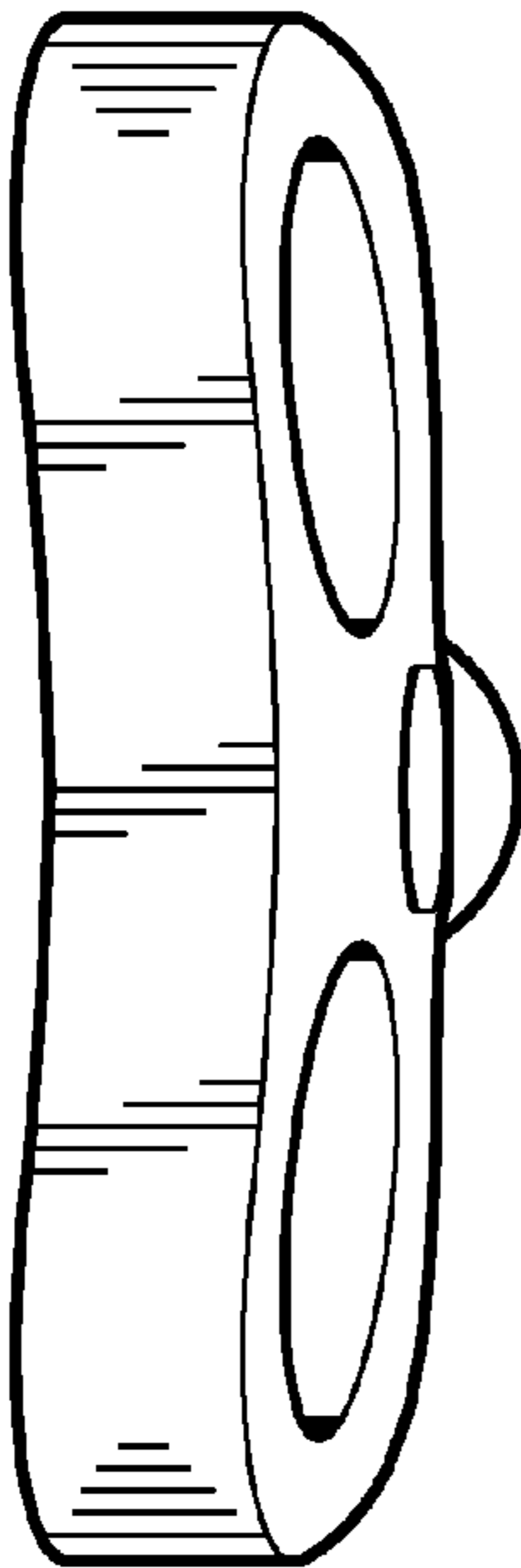

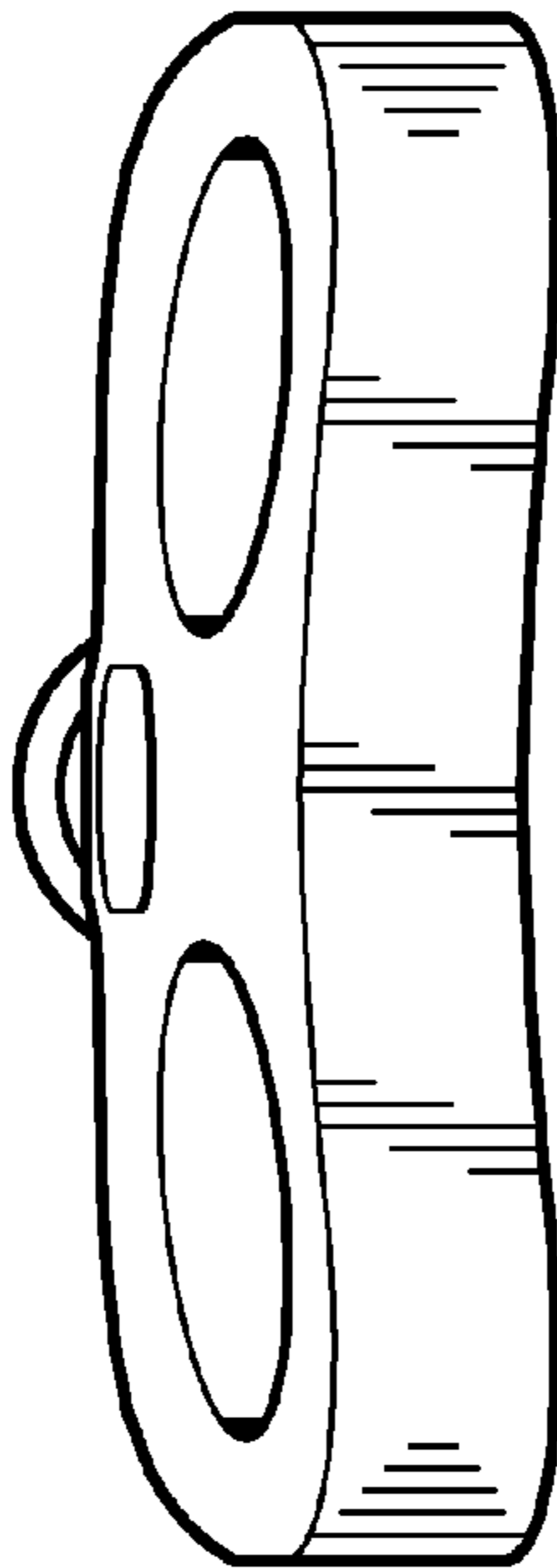

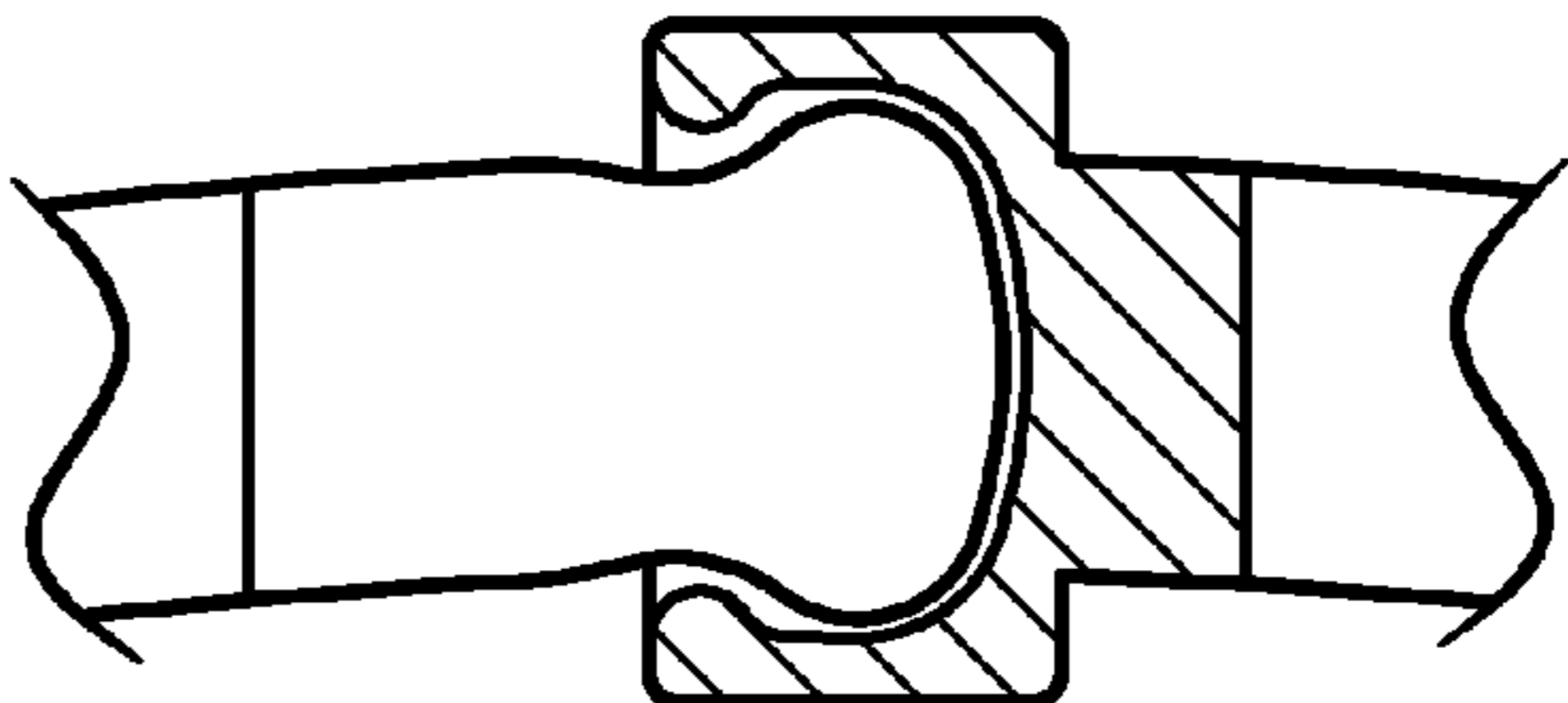

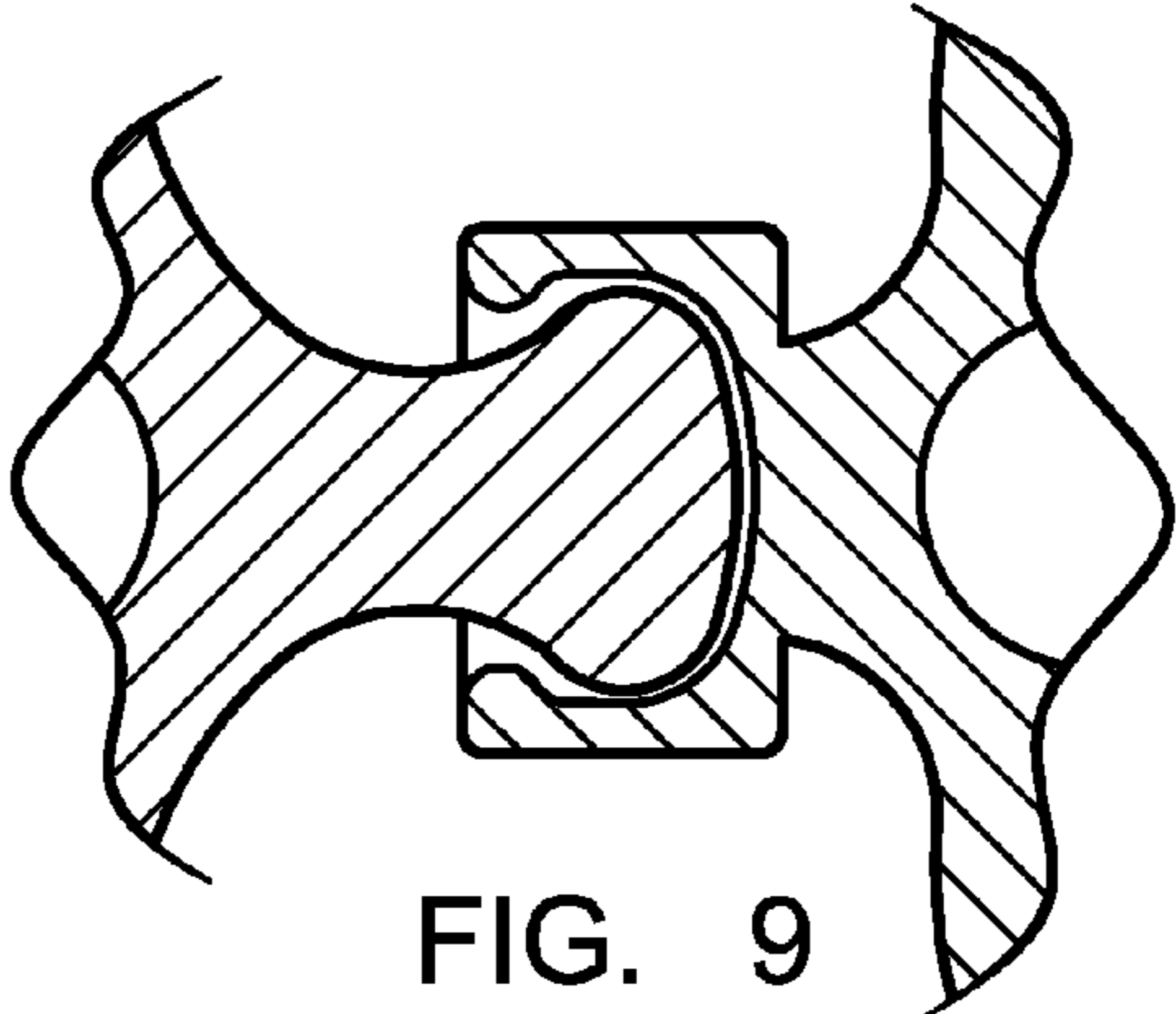

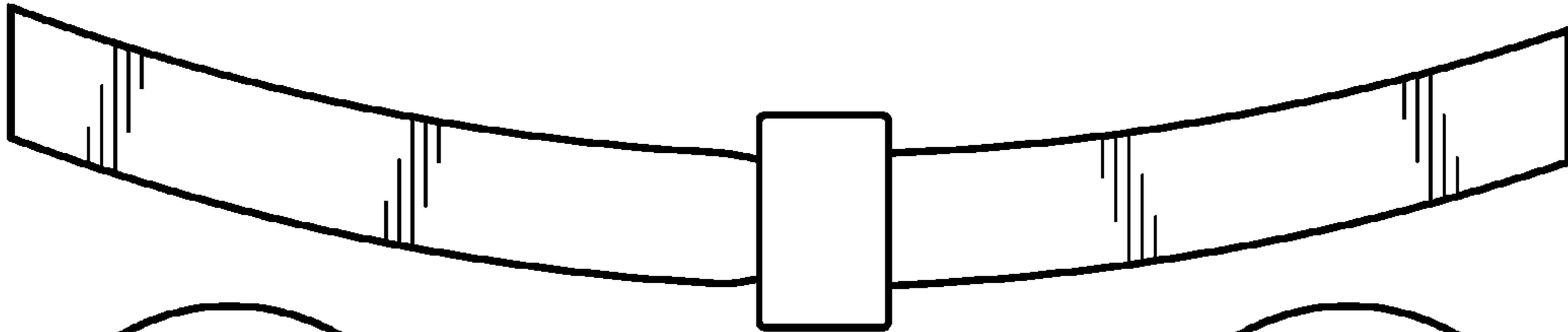

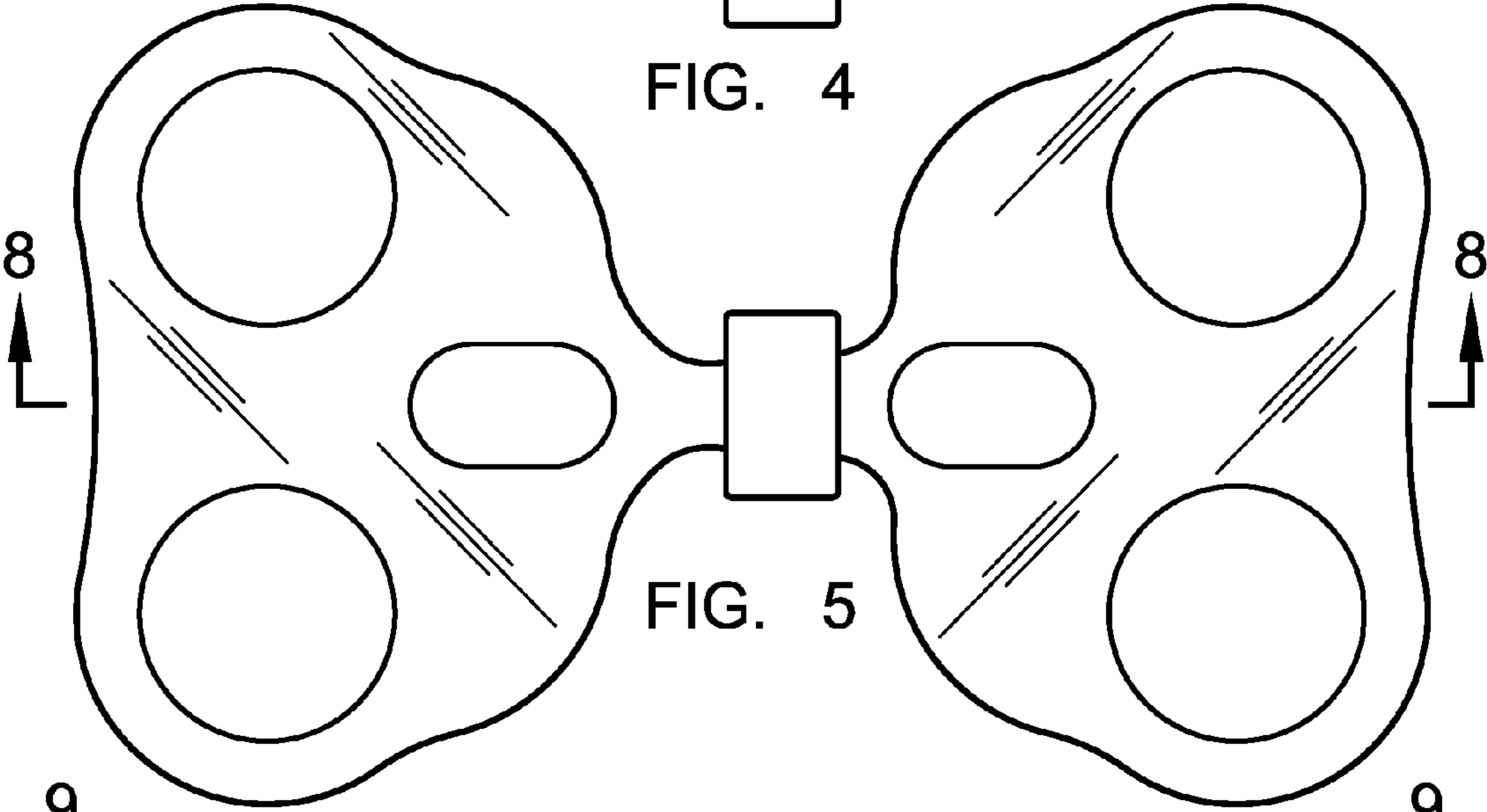

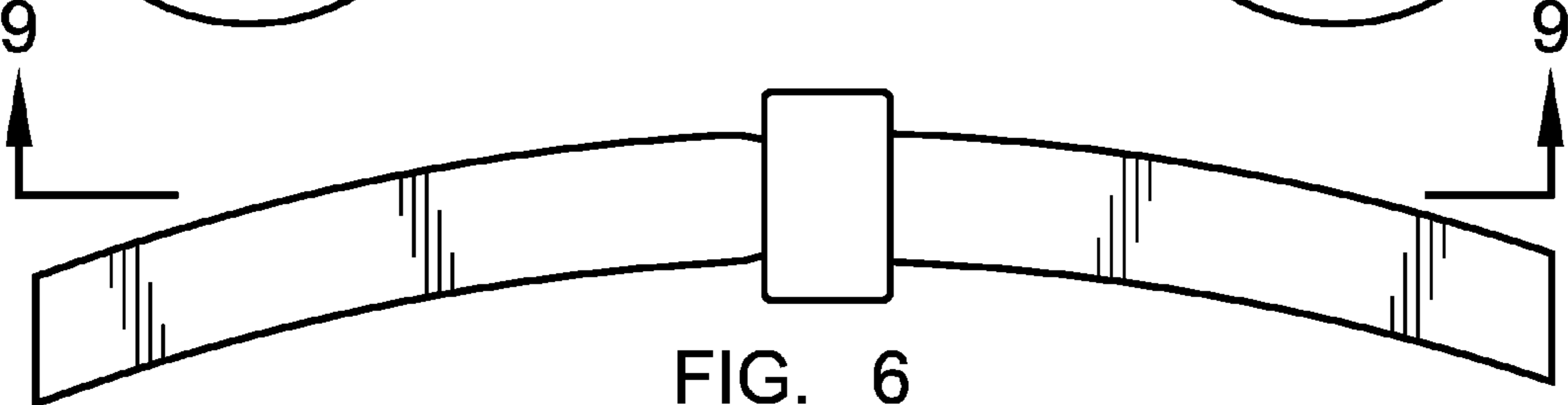

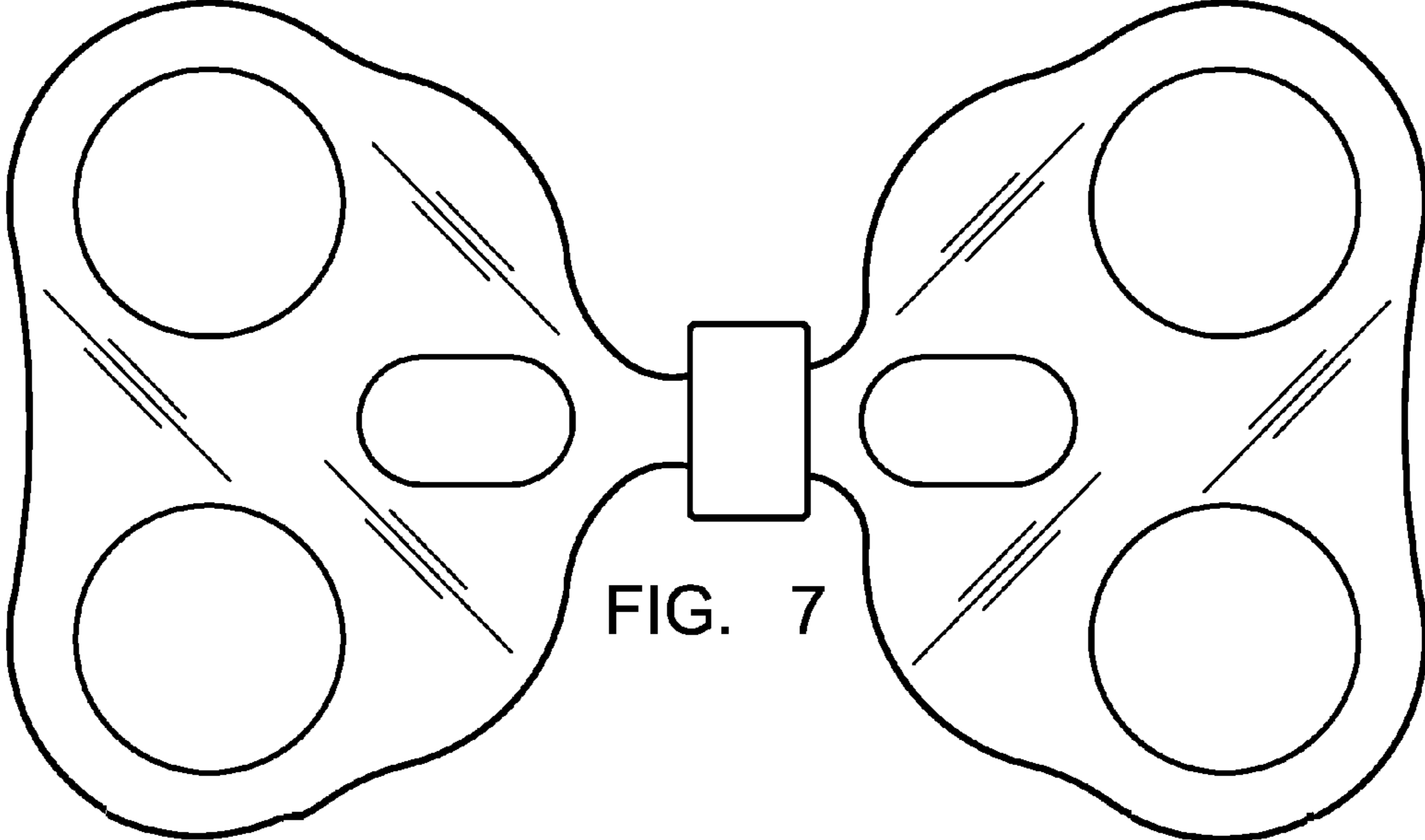
