(57) **CLAIM**

I claim the ornamental design for a star bulb, as shown and described.

DESCRIPTION

The present application is related to co-pending U.S. patent application Ser. No. 29/295,942 filed on the same day herewith by Vickie Jean Van Dyn Hoven, the full disclosure of which is hereby incorporated by reference. The present application is related to co-pending U.S. patent application Ser. Nos. 29/263,370; 29/263,389 and 29/263,371 by Victoria Jean Van Dyn Hoven, each of which is filed on Jul. 21, 2006 and are entitled star bulb.

FIG. 1 is a top perspective view of a star bulb;

FIG. 2 is a front elevational view thereof, the rear elevational view being the same as the front elevational view shown;

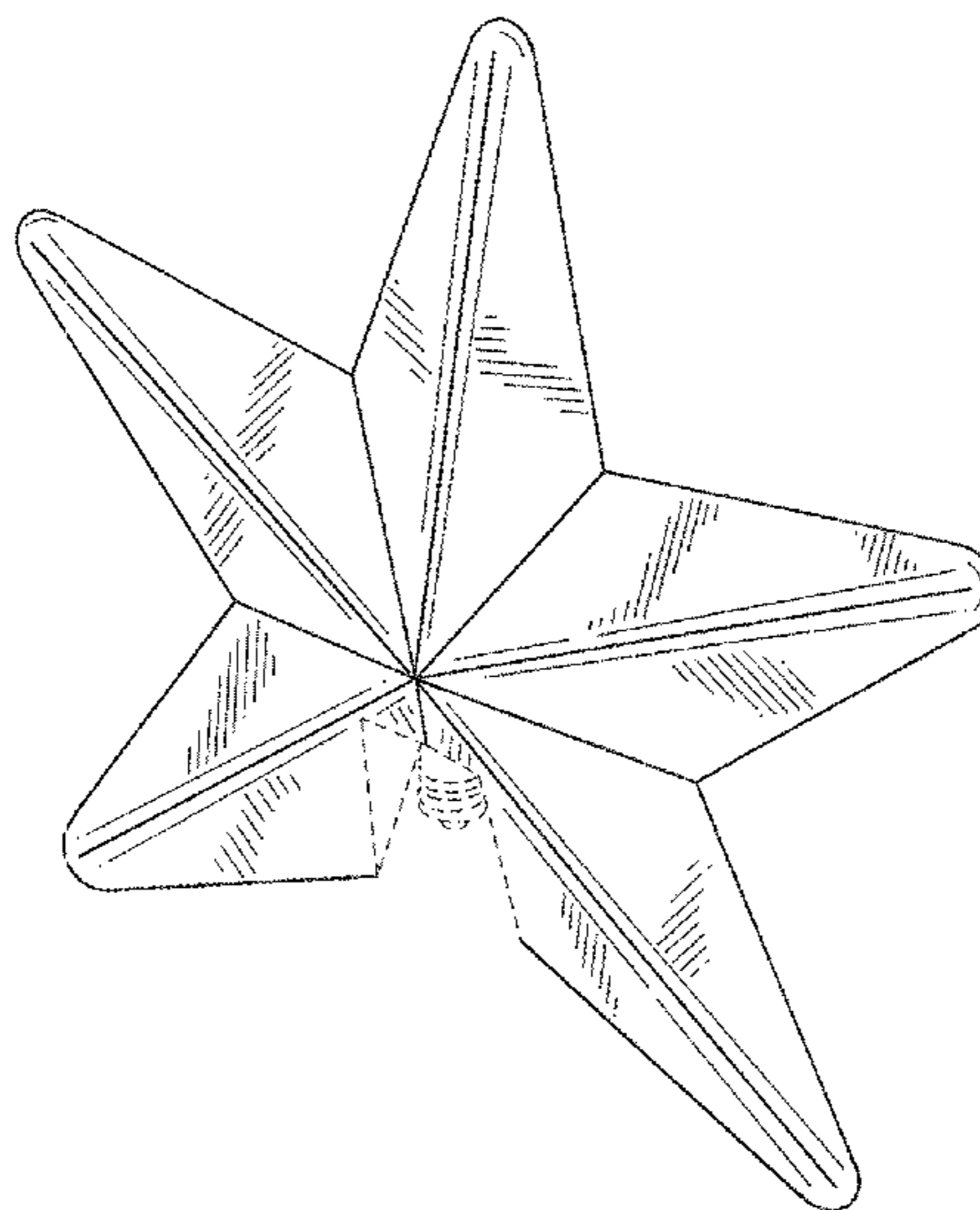
FIG. 3 is a right side elevational view thereof, the left side elevational view being the same as the left elevational view shown;

FIG. 4 is a top plan view thereof; and,

FIG. 5 is a bottom plan view thereof.

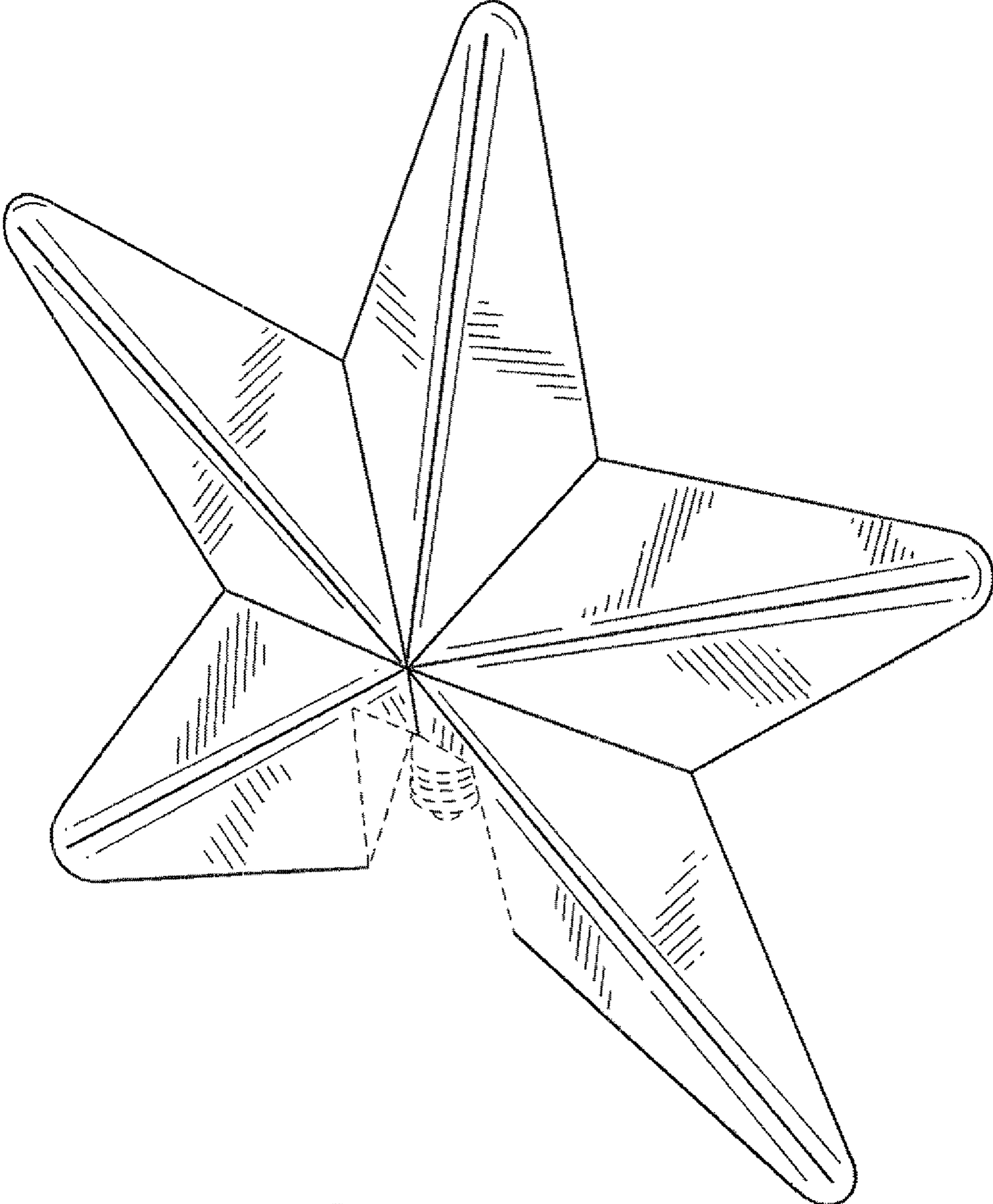

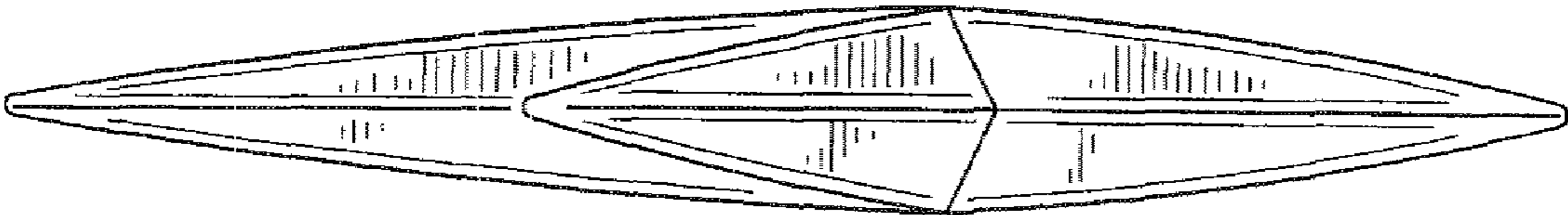

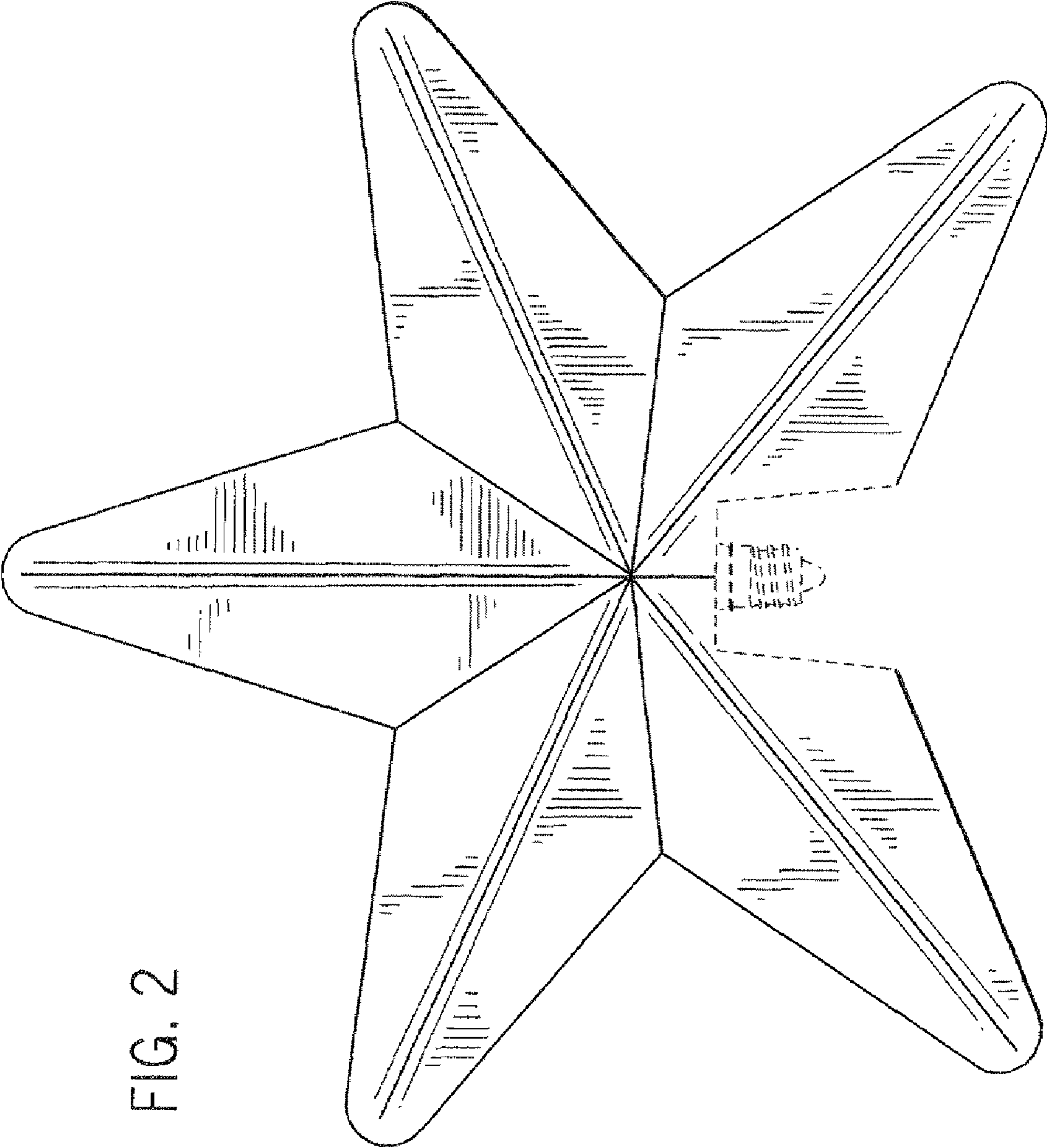

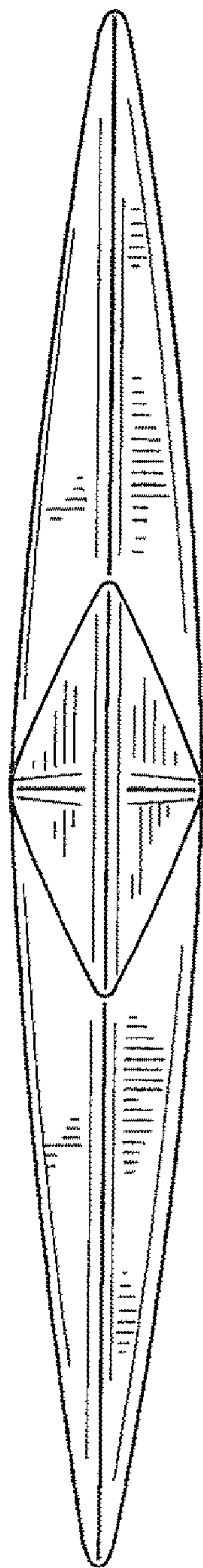

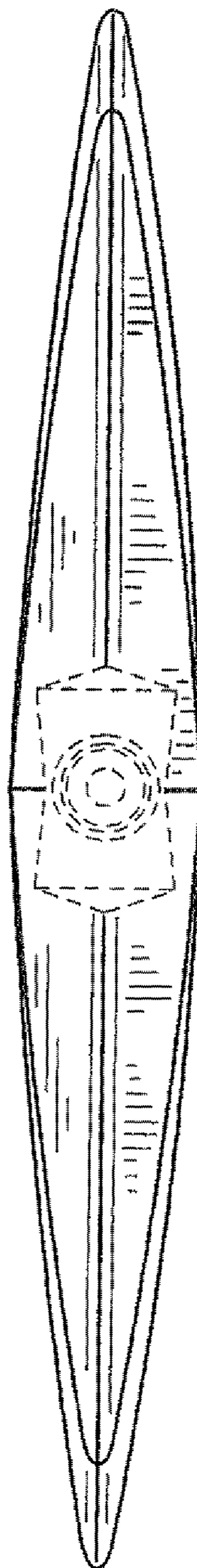
