FIG. 2 is a bottom view of the design of the present invention;

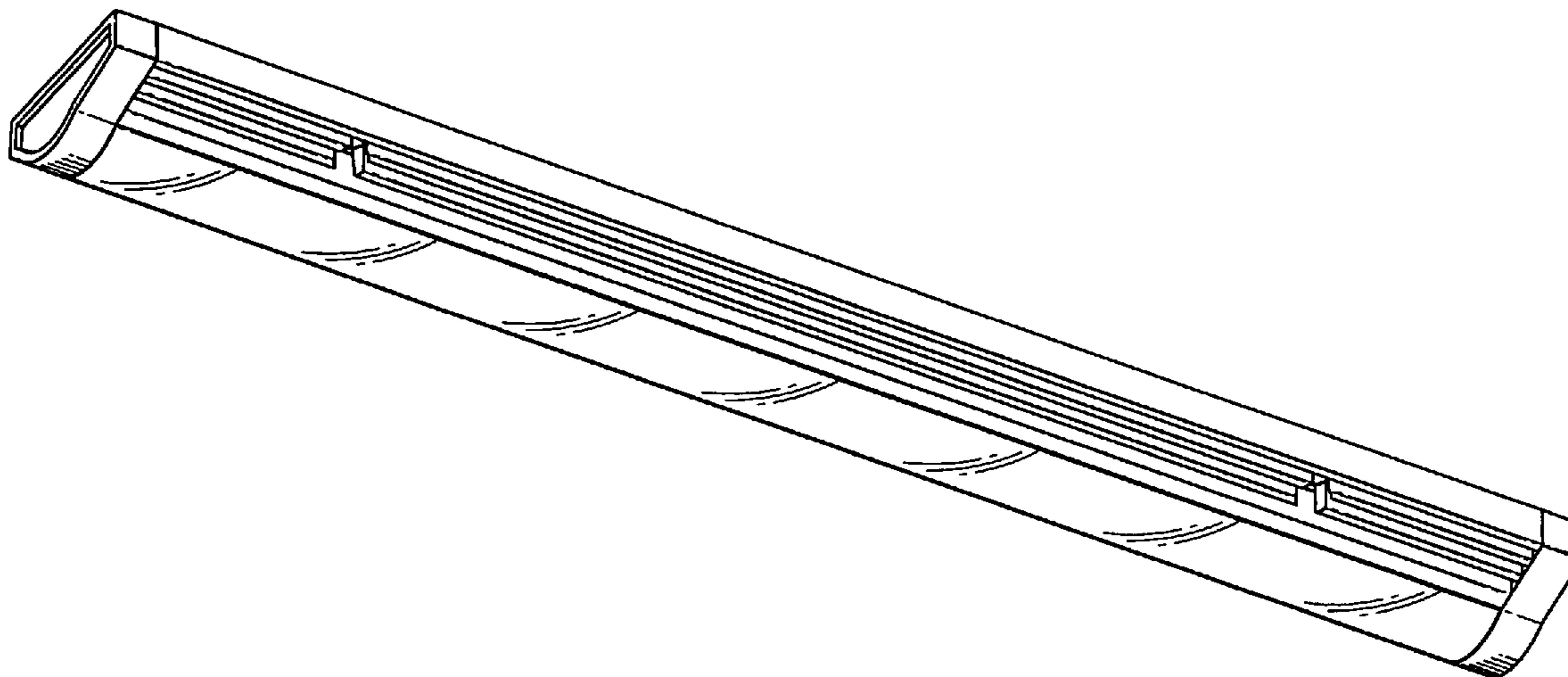
FIG. 3 is a front view of the design of the present invention;

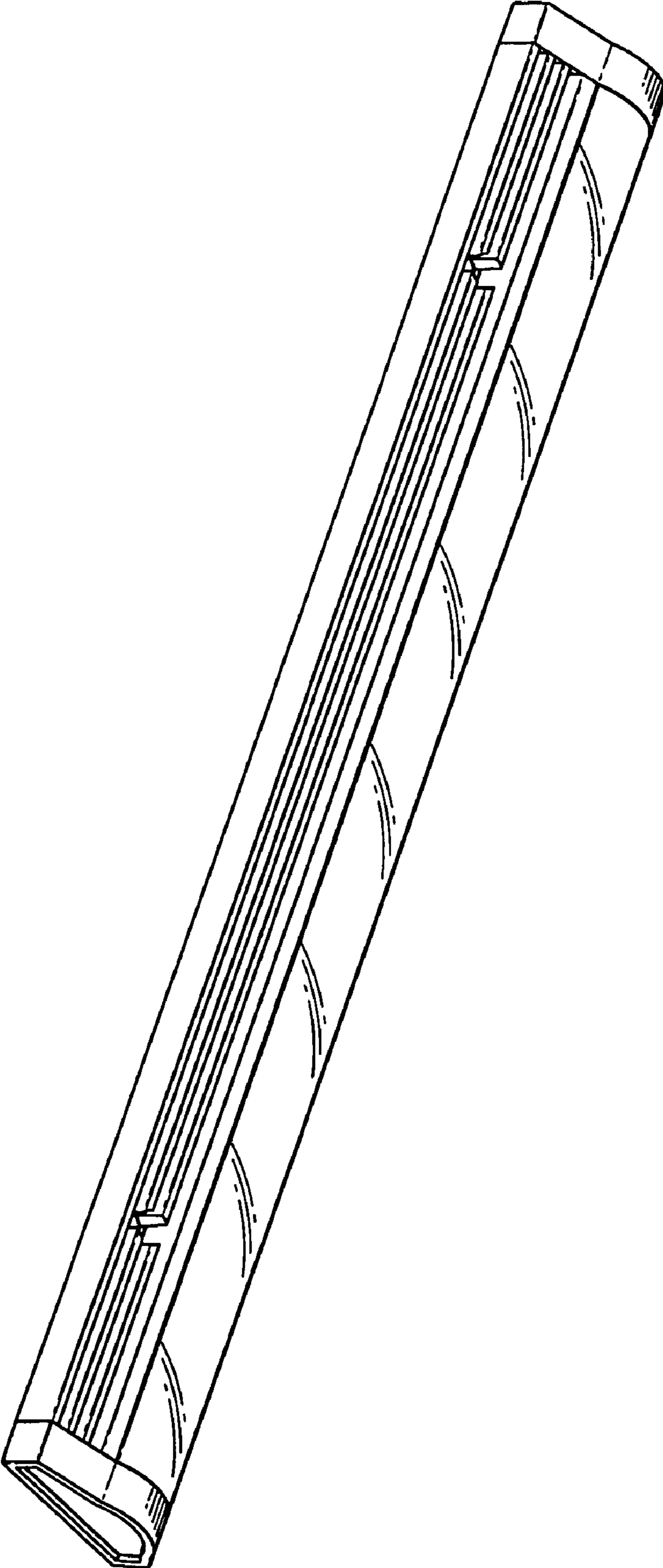

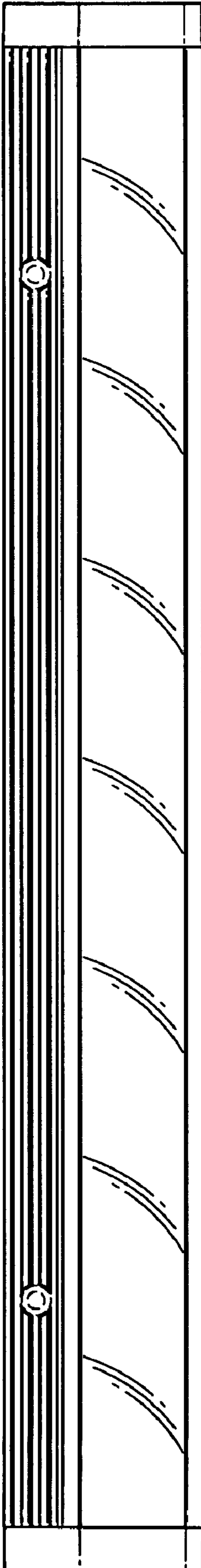

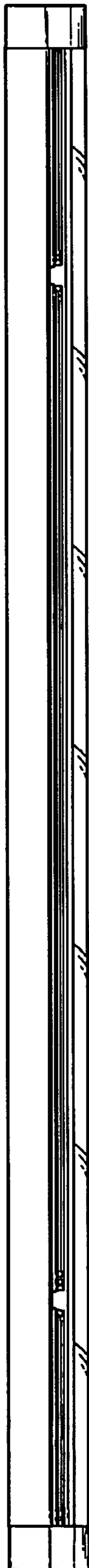

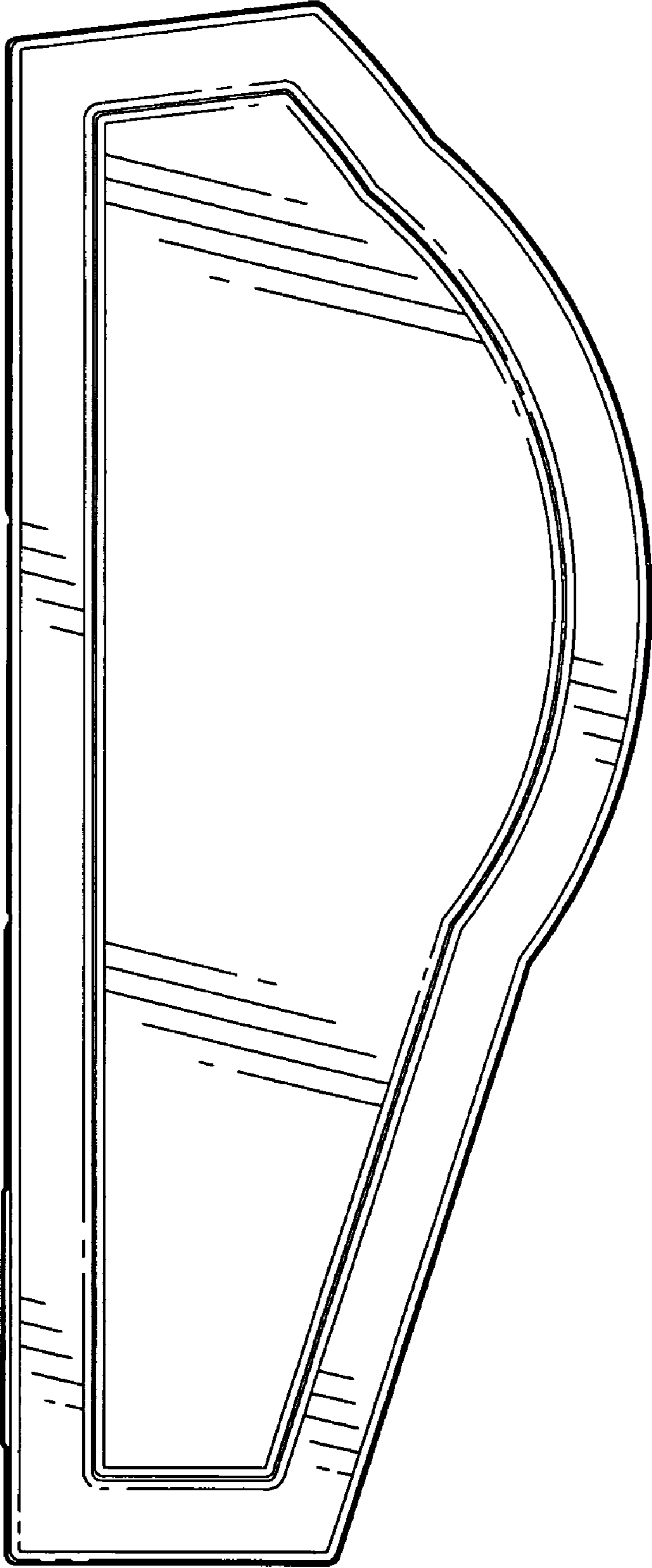
