(57) **CLAIM**

The ornamental design for a weightlifting glove, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper right front perspective view of a weightlifting glove showing my new design, with the thumb and fingers of a wearer shown in broken lines;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a front elevational view thereof, with the body of the glove flattened and the support strap unwrapped from the body of the glove;

FIG. 9 is a right side elevational view thereof, with the body of the glove flattened and the support strap unwrapped from the body;

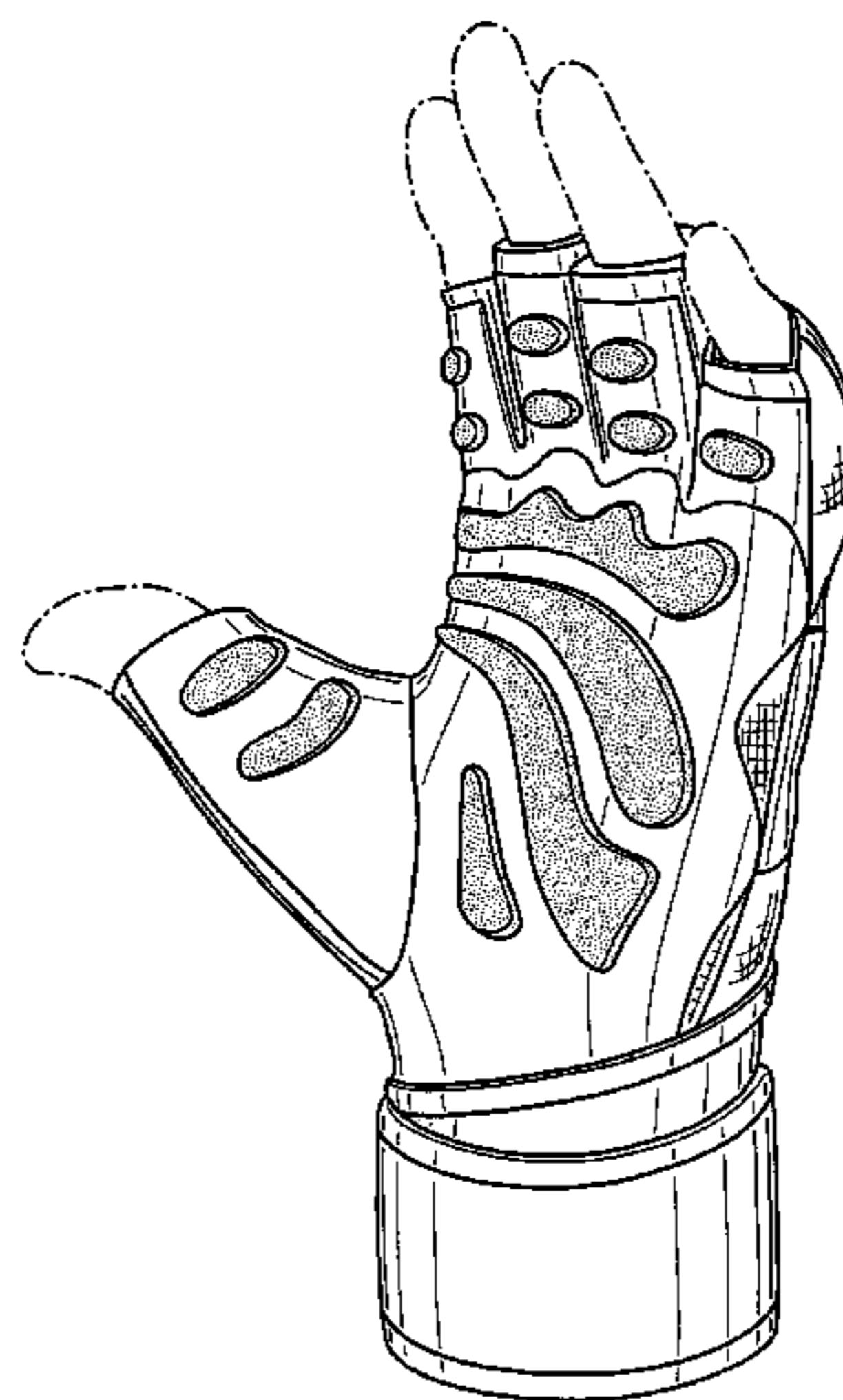
FIG. 10 is a rear elevational view thereof, with the body of the glove flattened and the support strap unwrapped from the body;

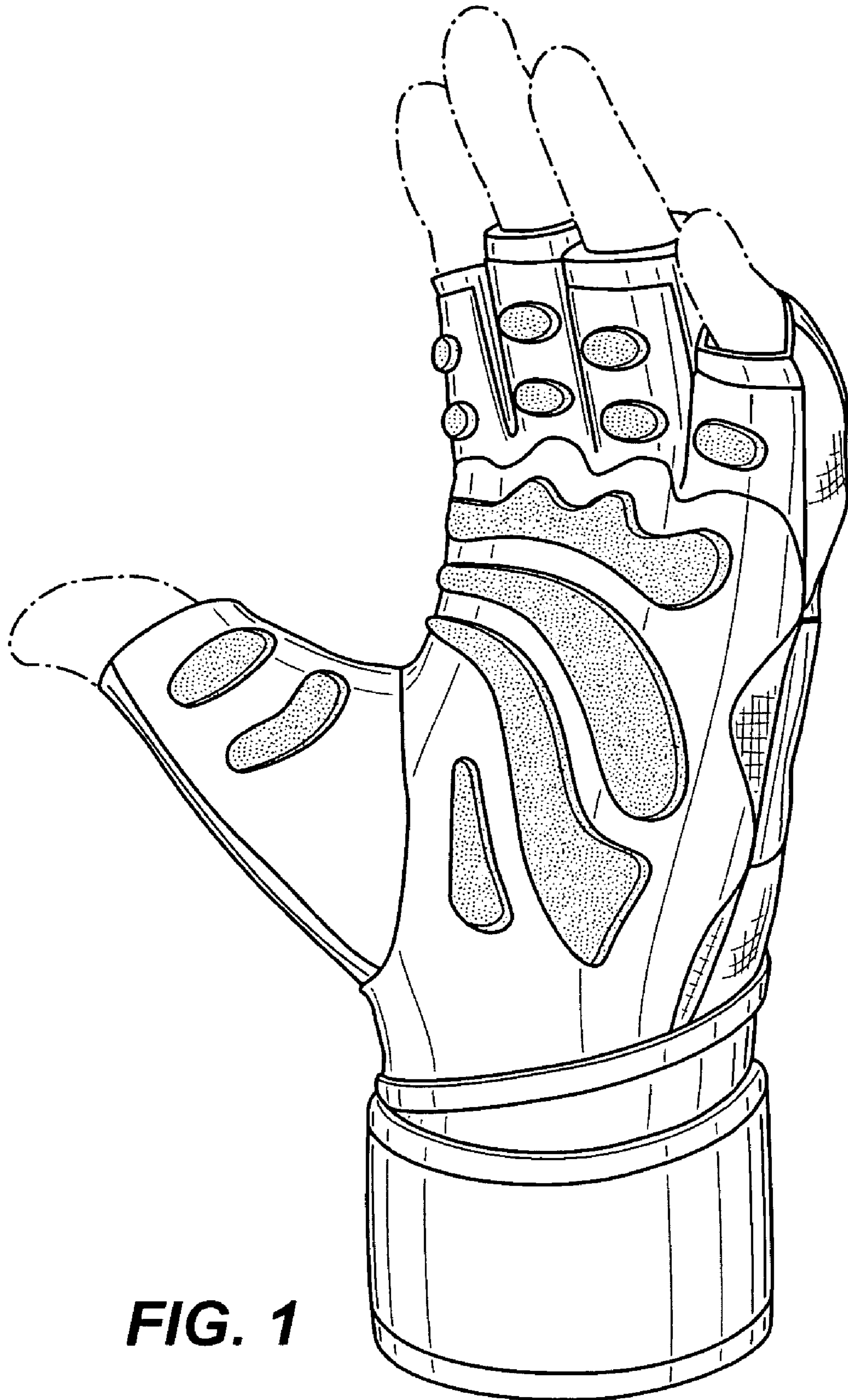
FIG. 11 is a left side elevational view thereof, with the body of the glove flattened and the support strap unwrapped from the body;

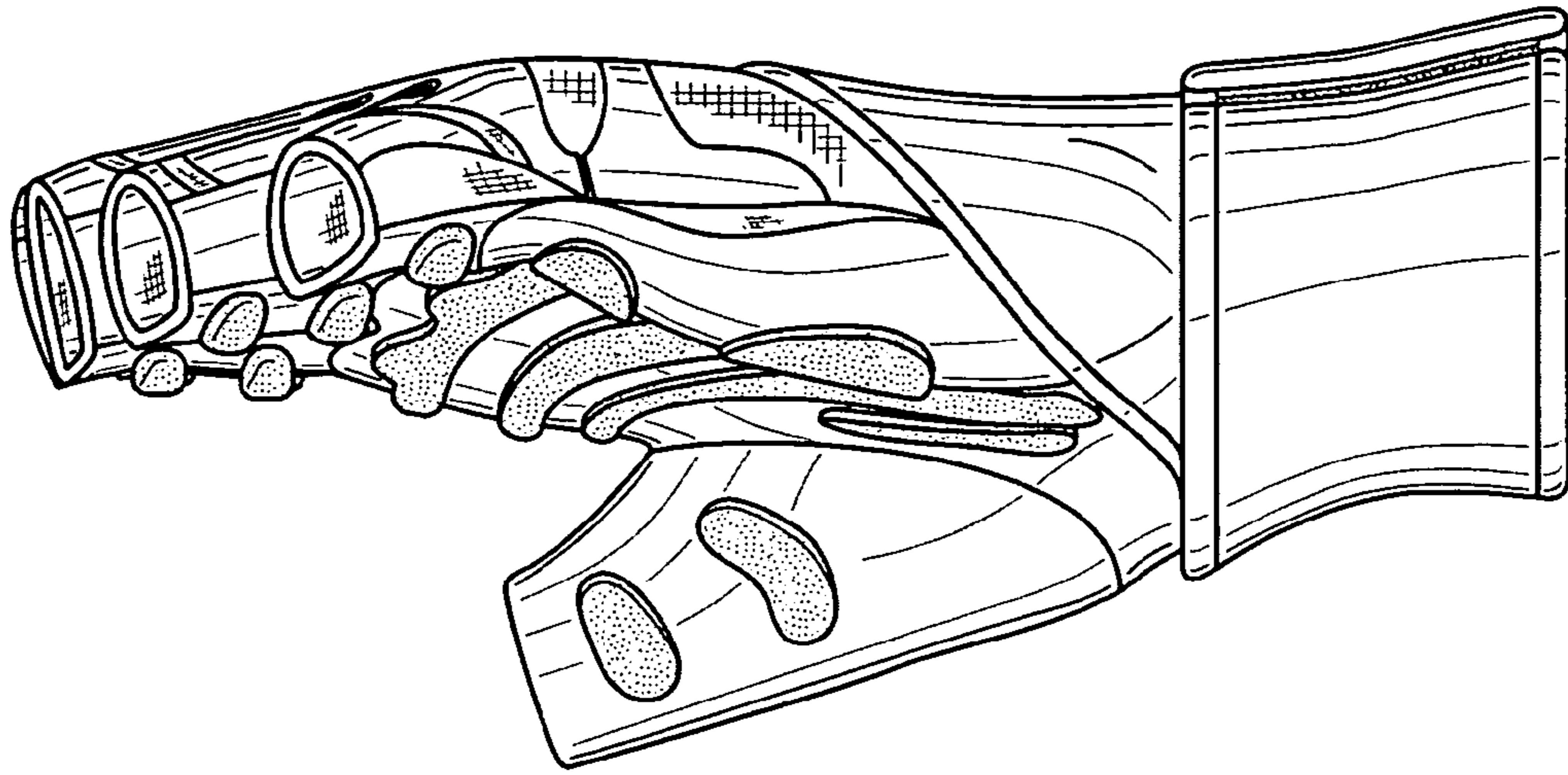

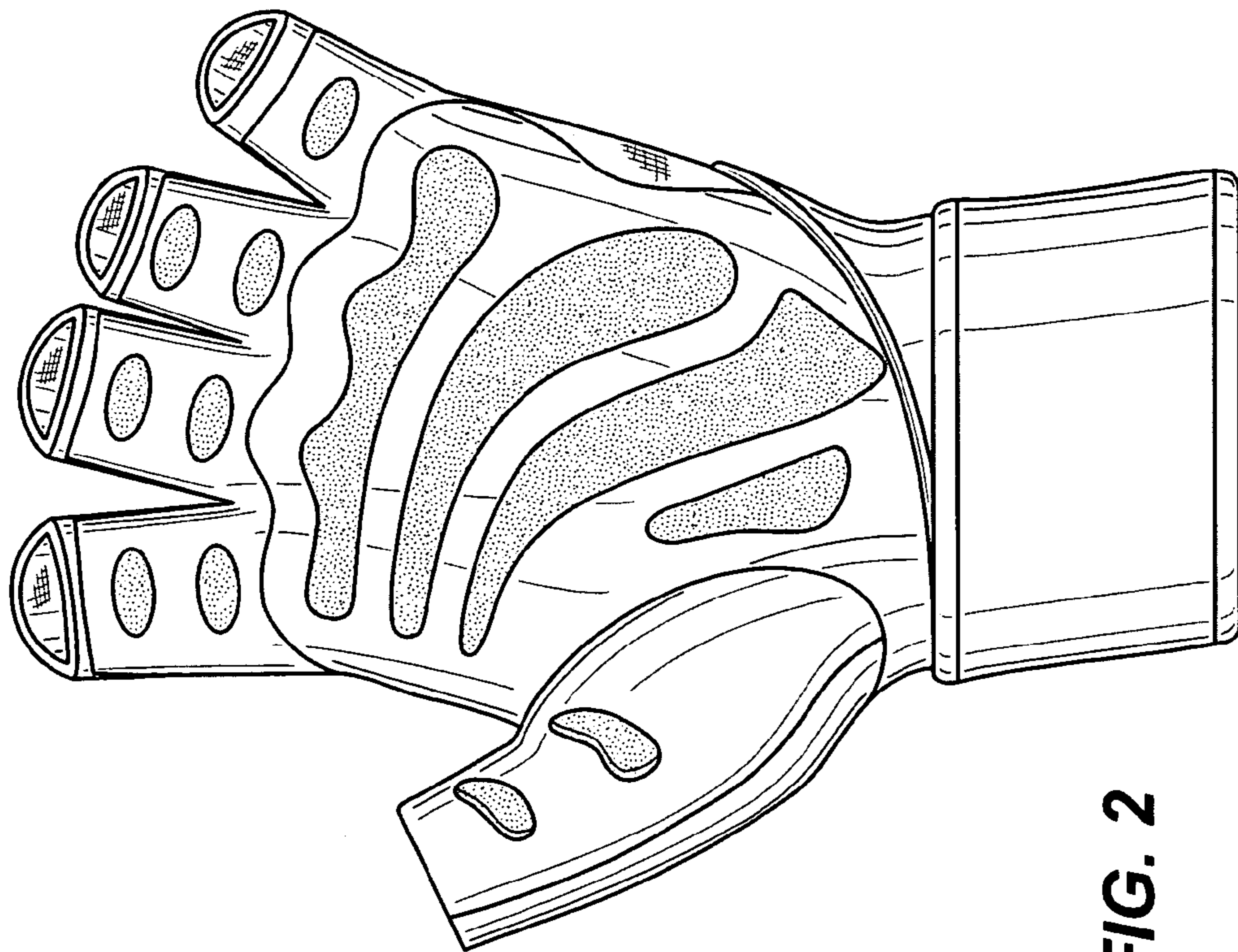

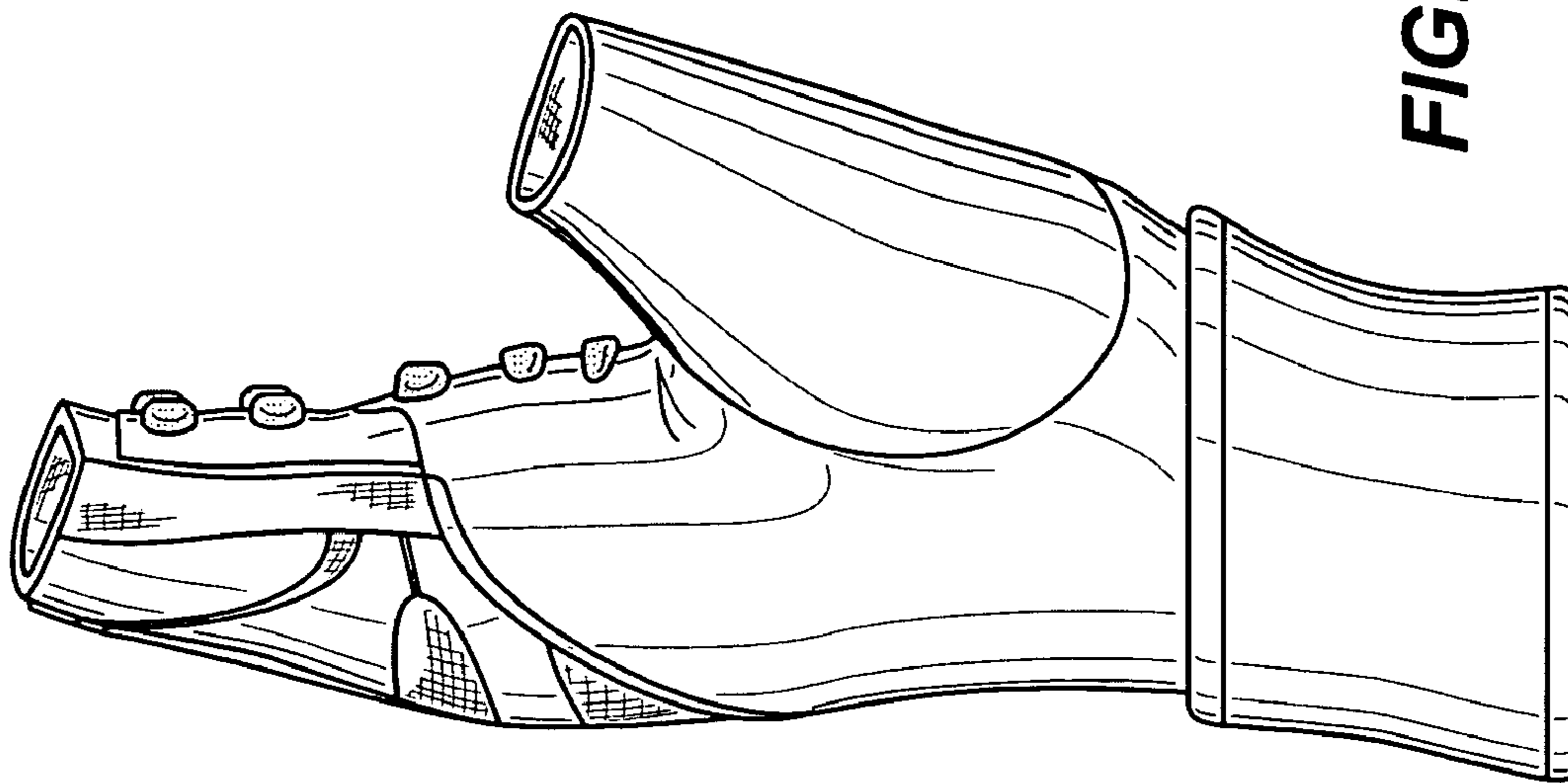

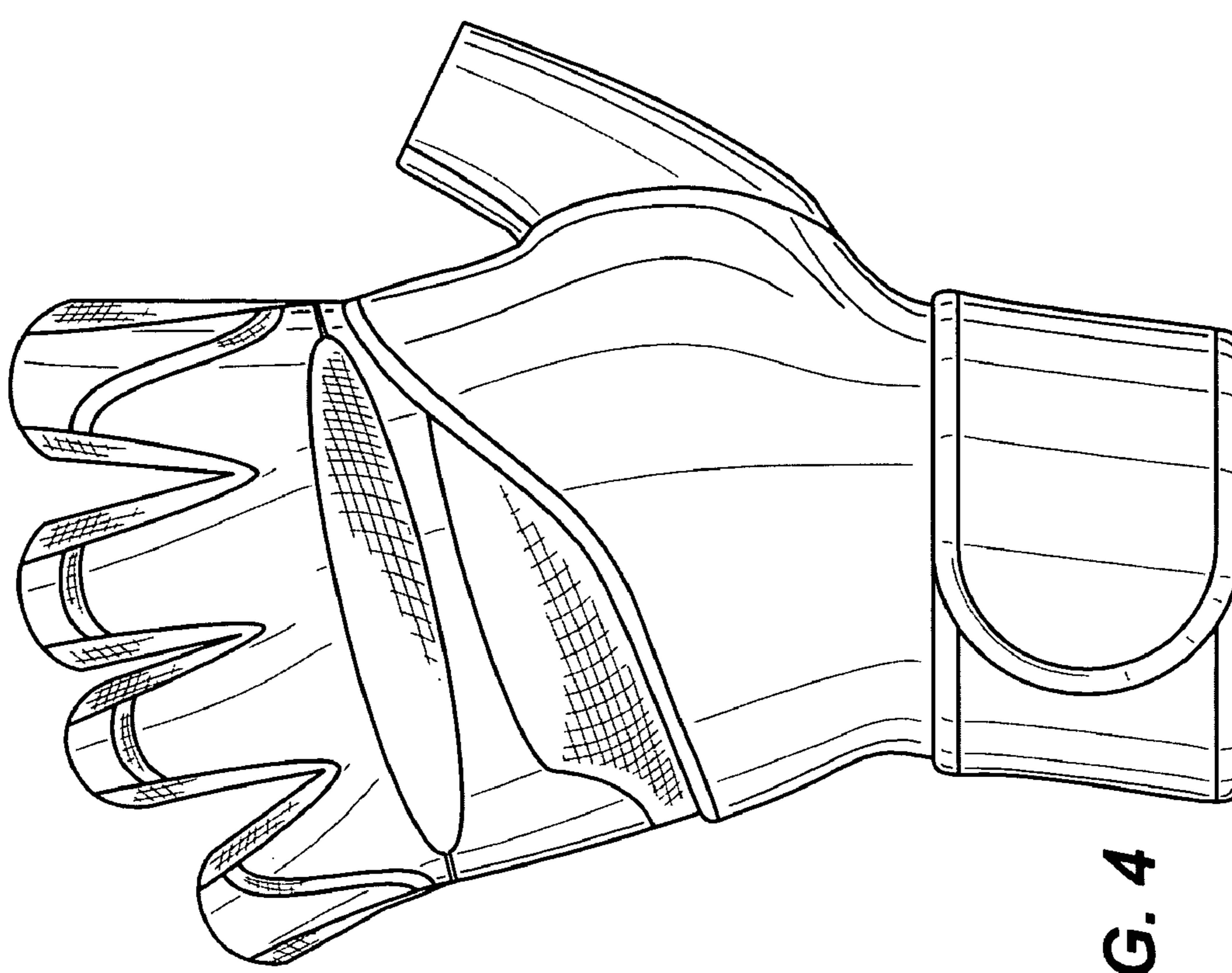
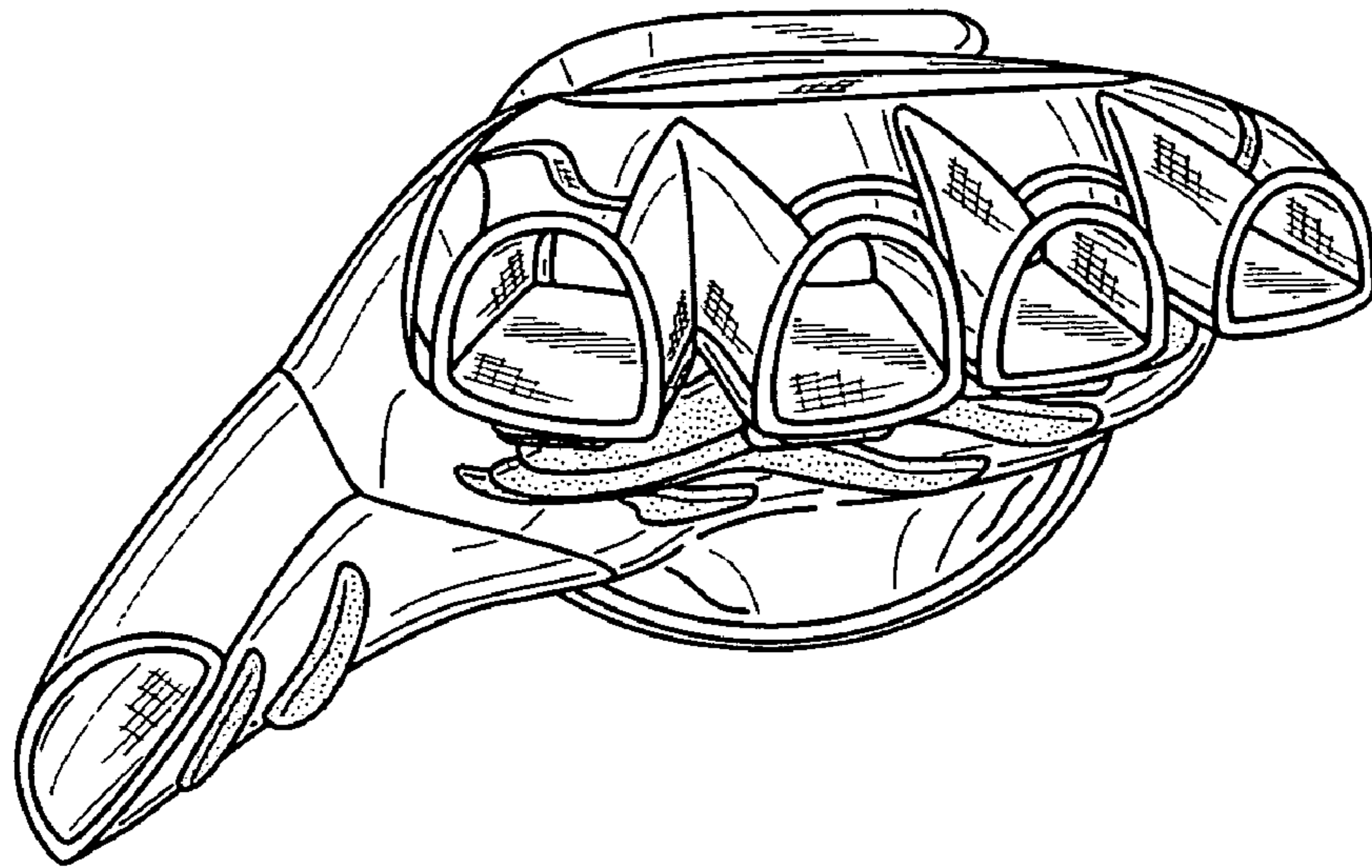
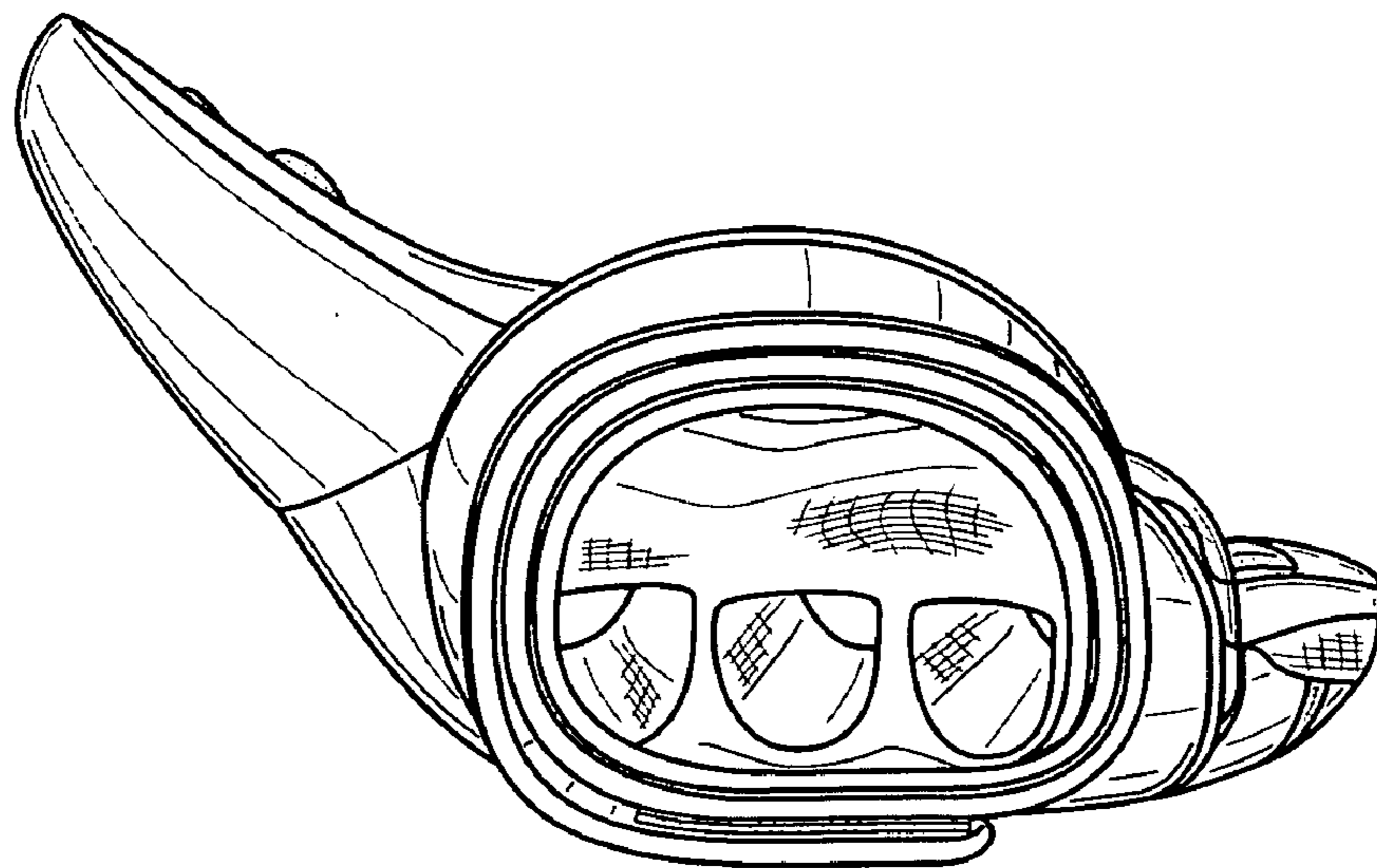

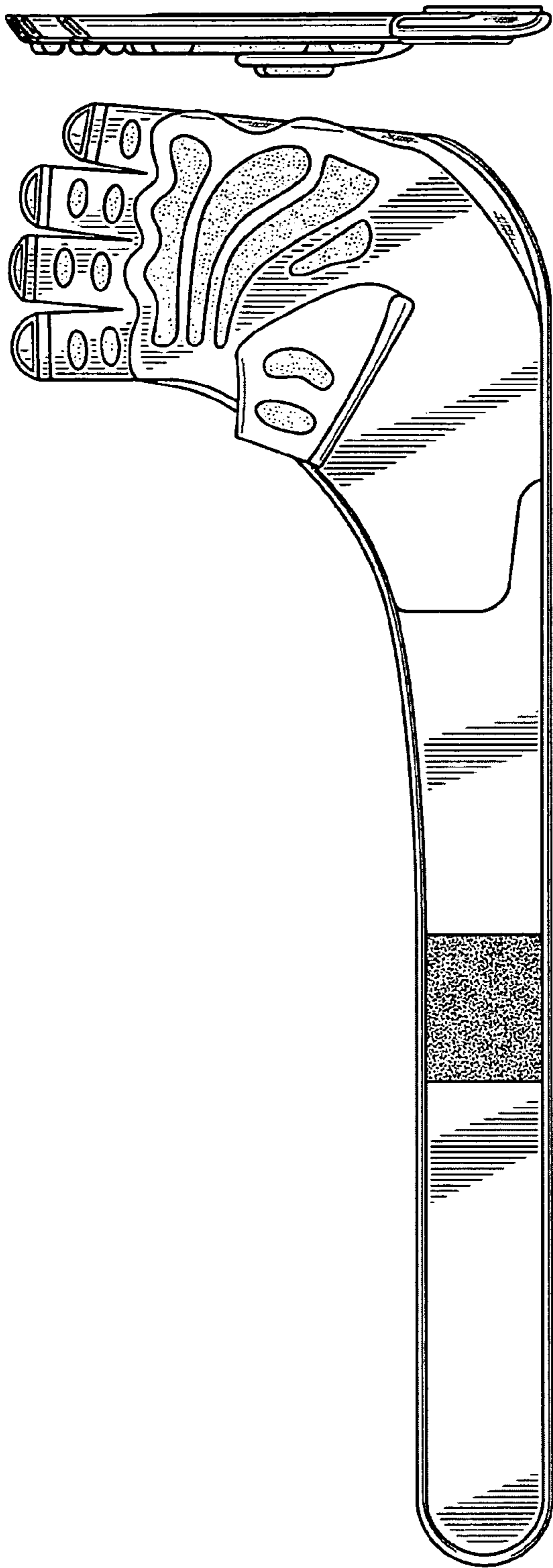

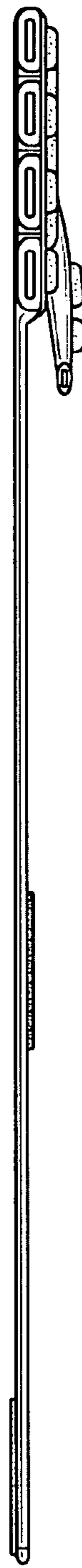
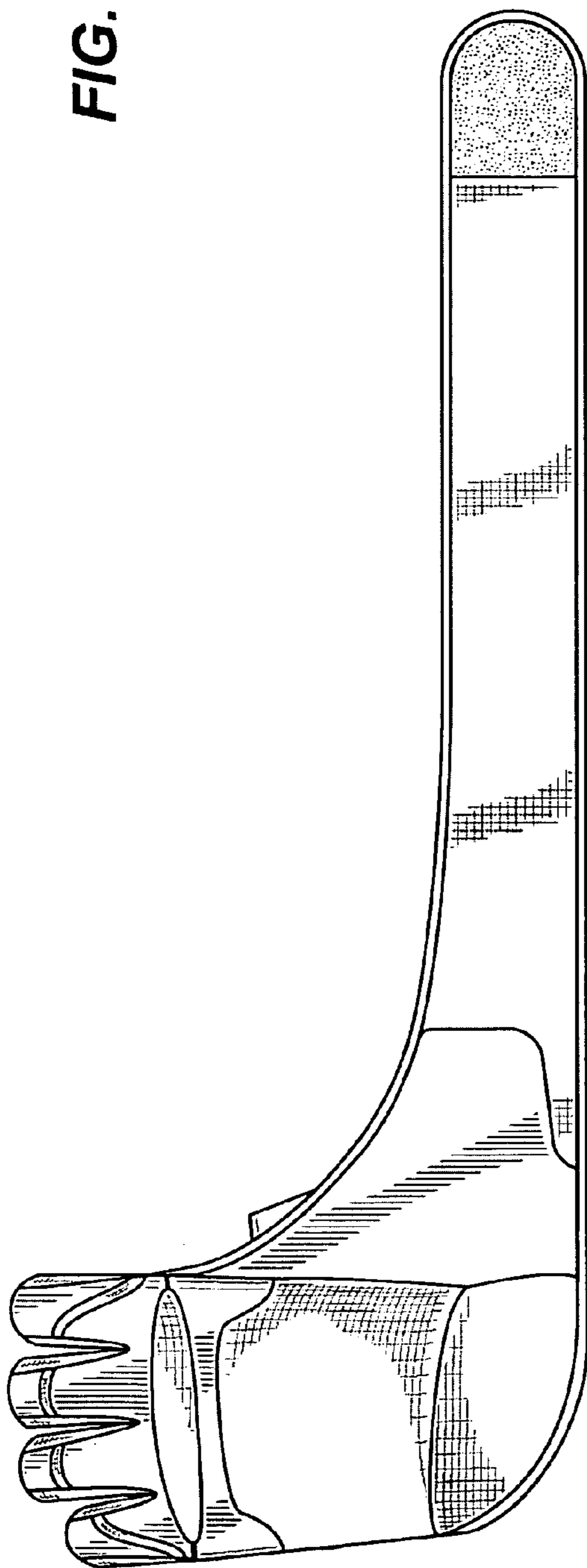


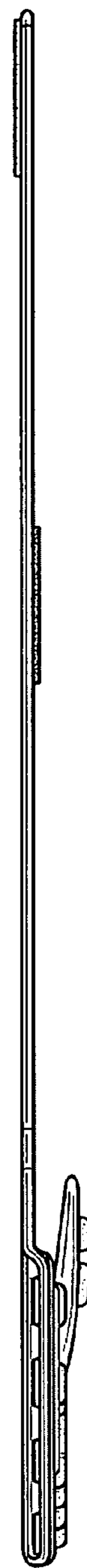
