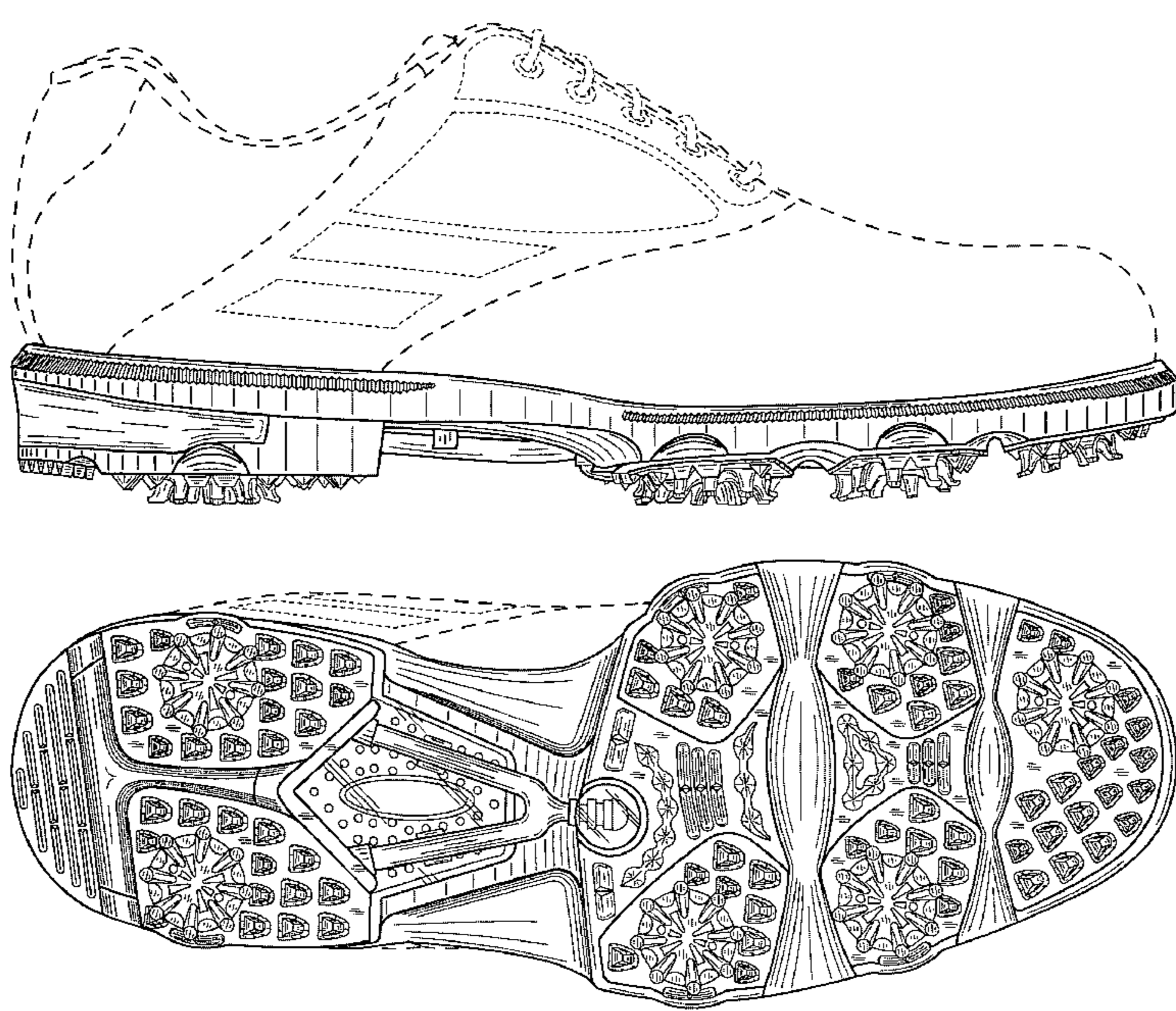

(57) **CLAIM**  
The ornamental design for a golf shoe outsole, as shown and described.

**DESCRIPTION**  
FIG. 1 is a bottom perspective view of a golf shoe outsole showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a left side elevational view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The oval shaped broken line in FIG. 3 represent the boundary of the design with the line itself and the area within forming no part of the claim. The broken line showing of the upper portion of the shoe is for illustrative purposes only and forms no part of the claimed design.

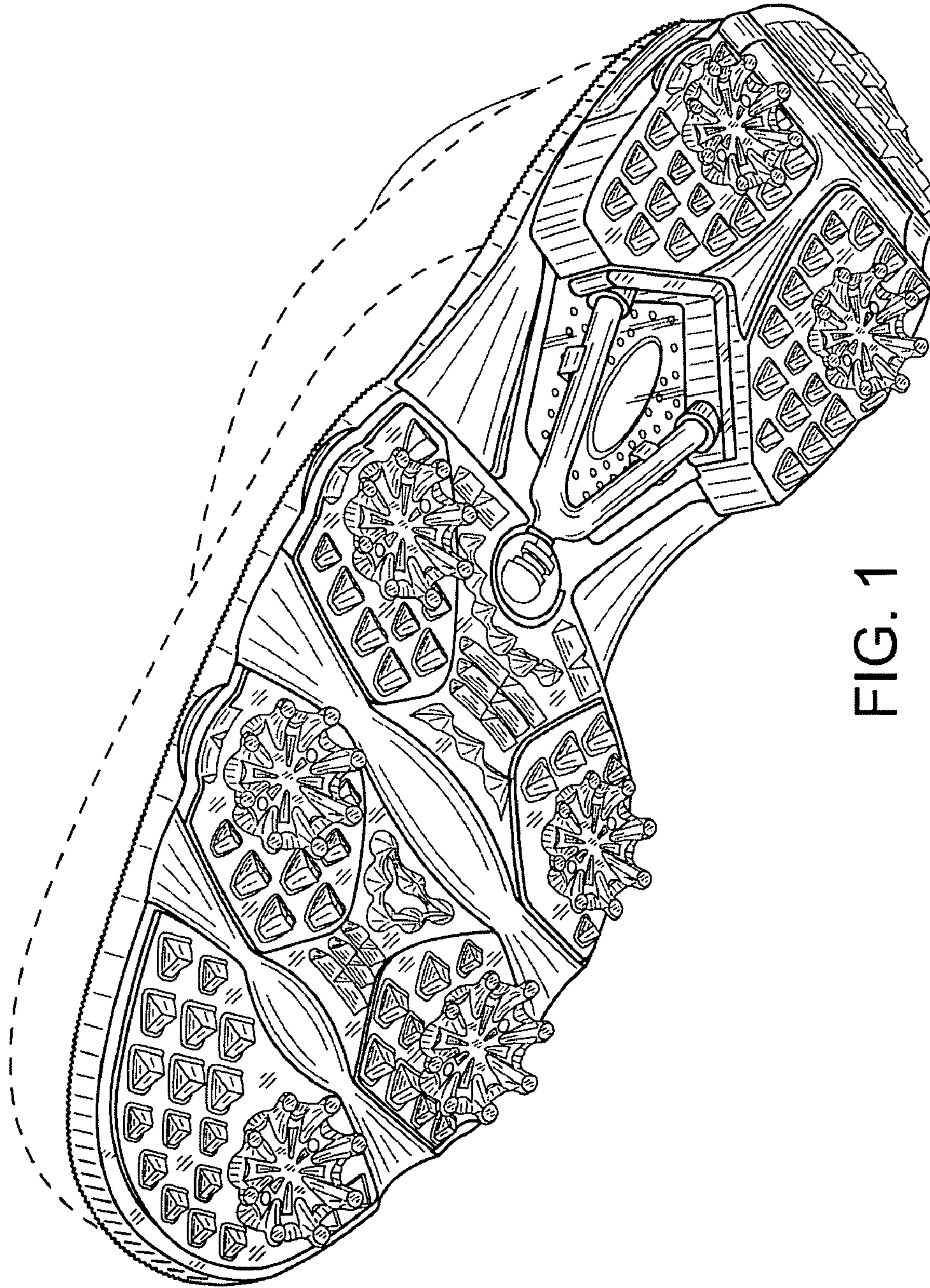

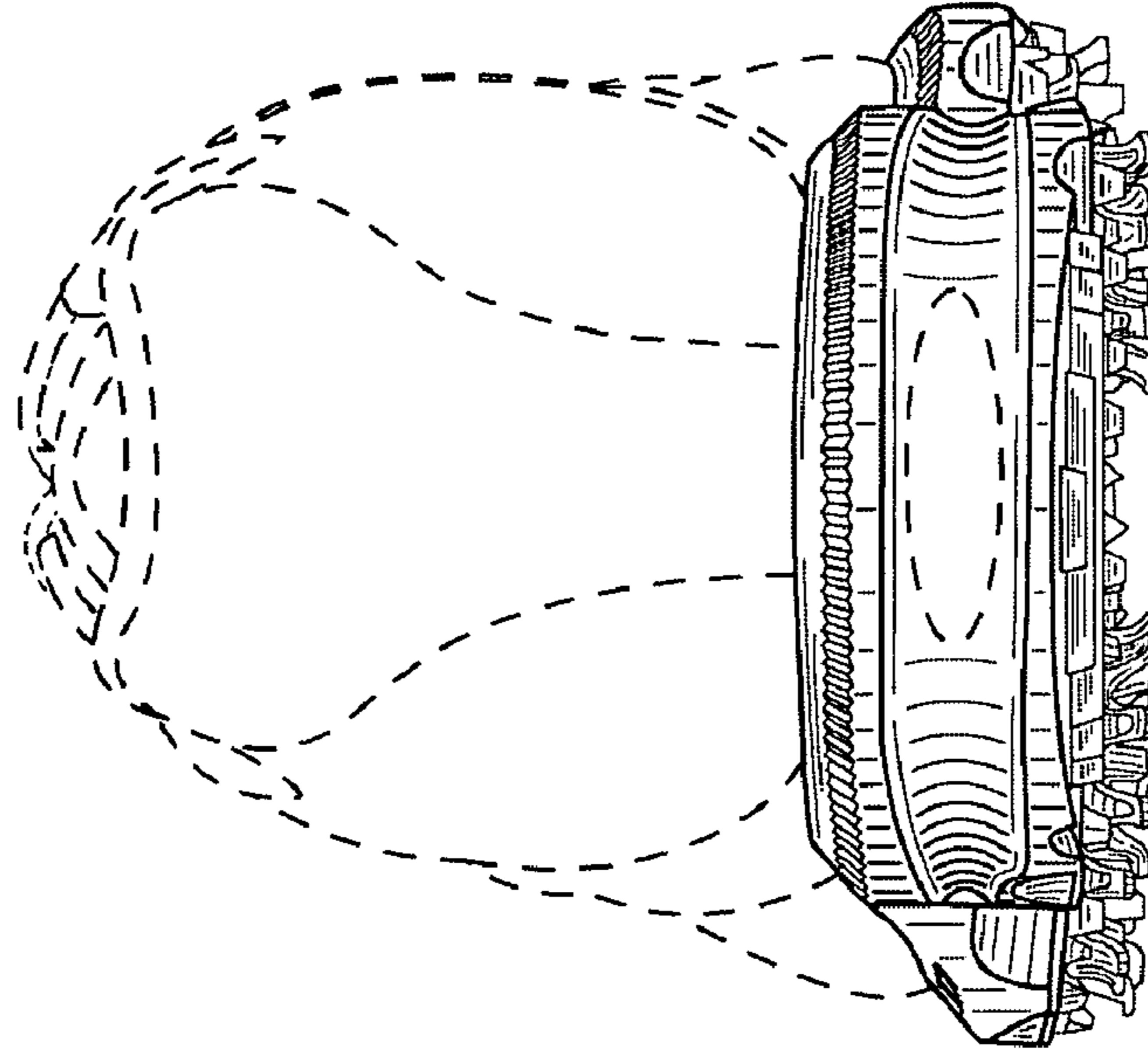

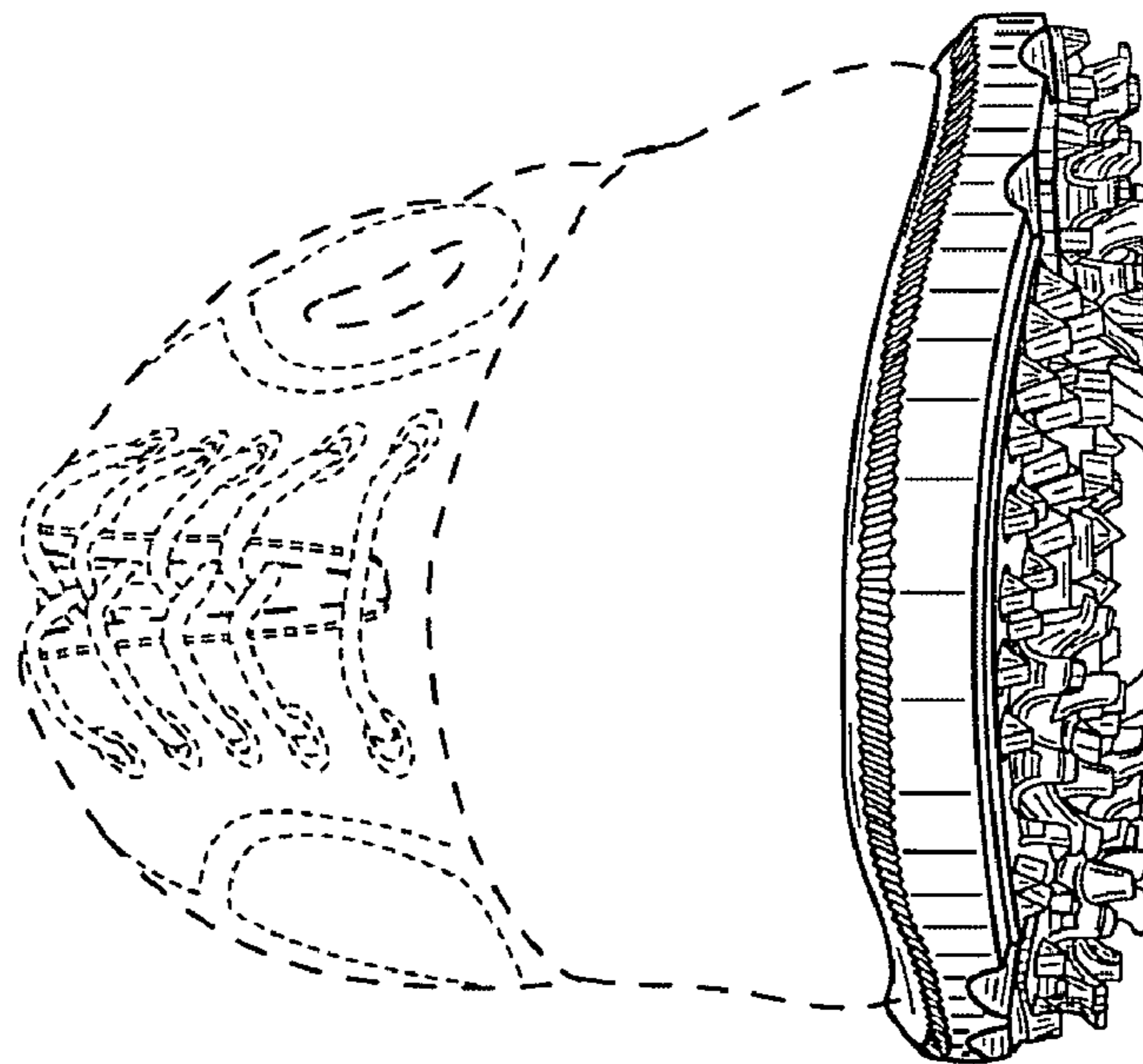

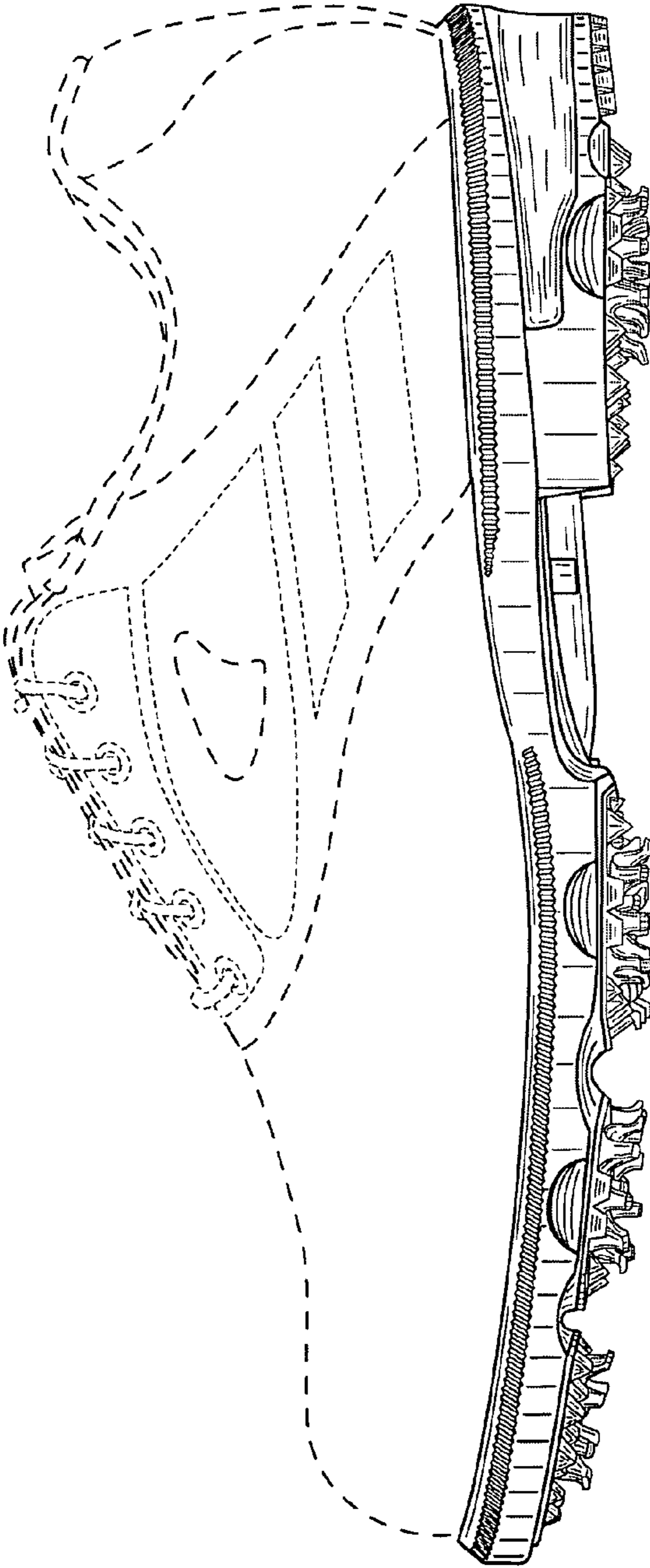
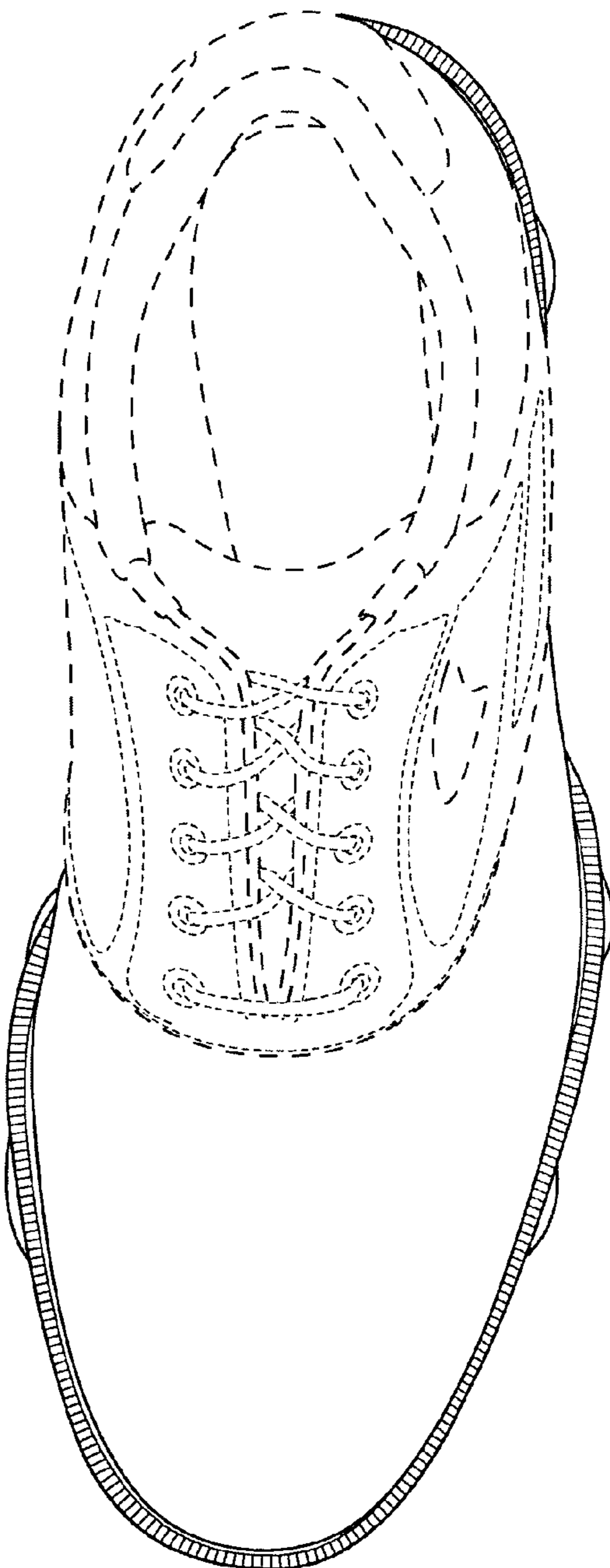

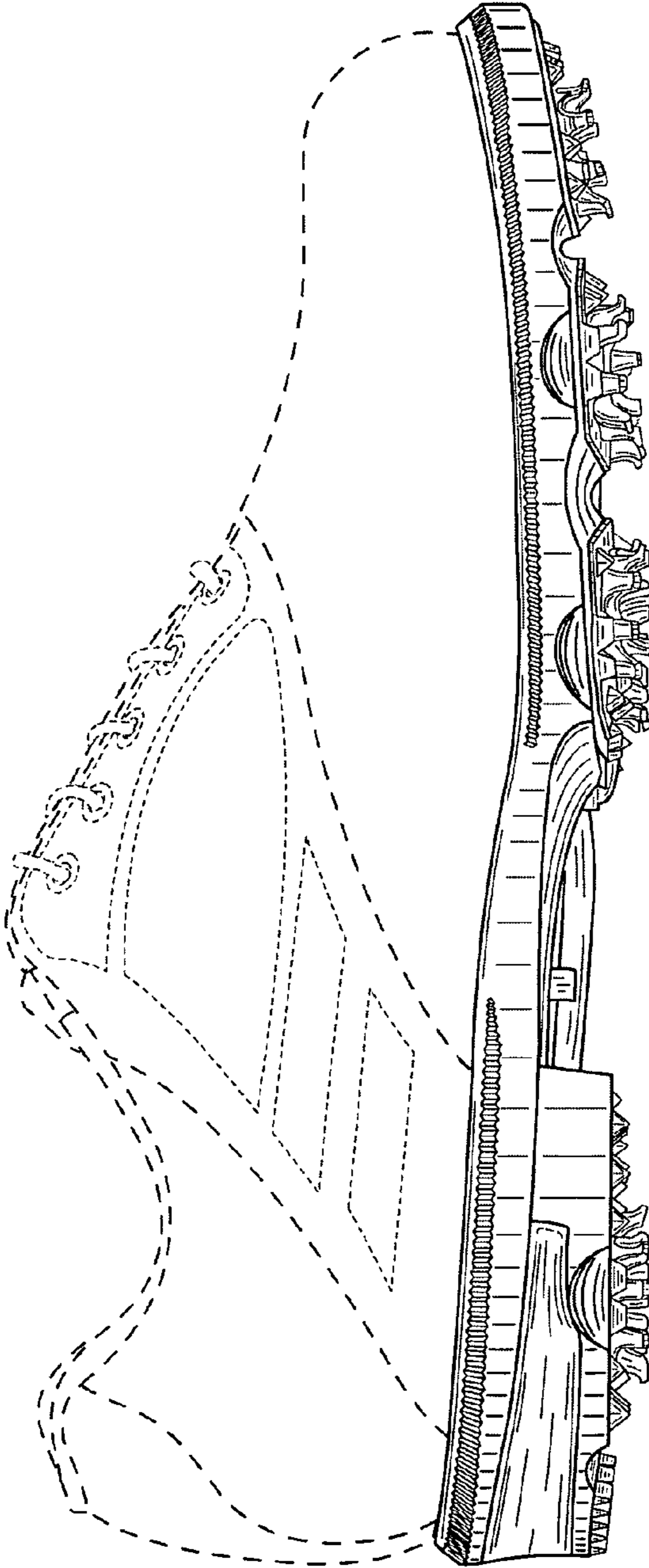

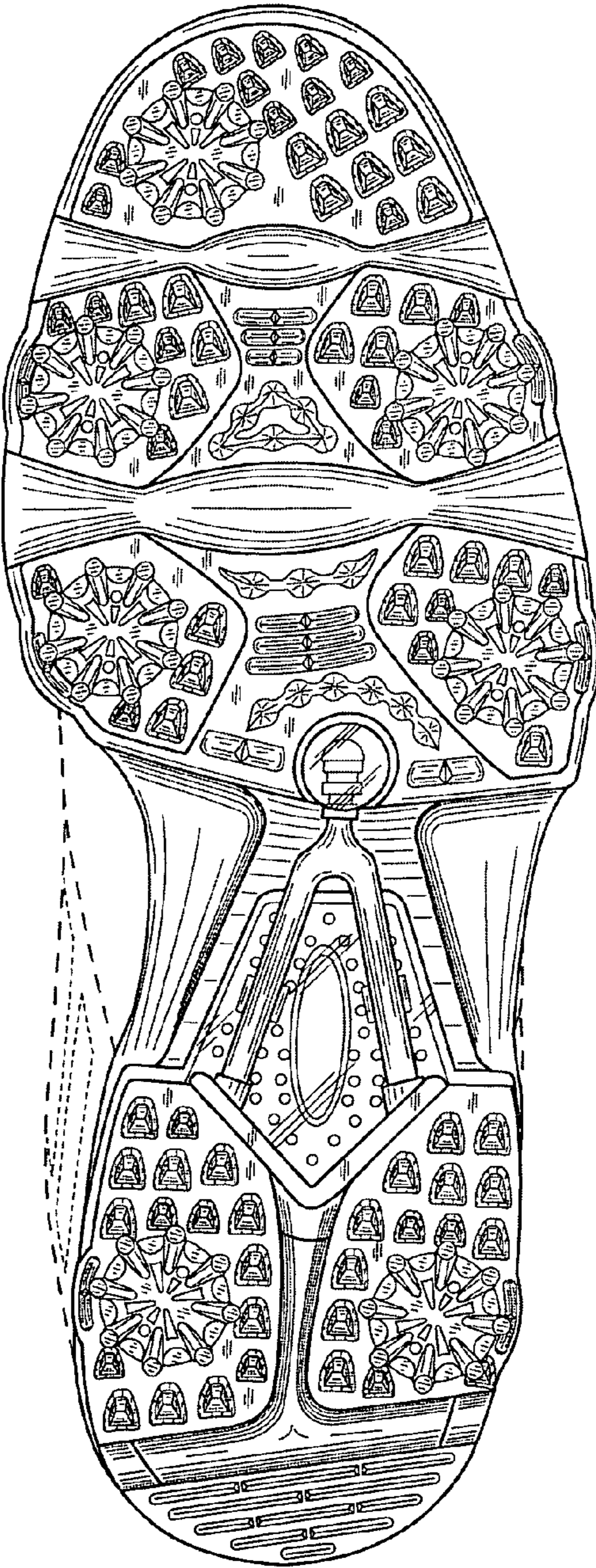
