(57) **CLAIM**

The ornamental design for a recipe box and easel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the recipe box and easel of the present invention, with the easel extended;

FIG. 2 is a perspective view of the recipe box and easel of the present invention, with the easel collapsed;

FIG. 3 is a top plan view of the recipe box and easel of the present invention;

FIG. 4 is a left side elevation view of the recipe box and easel of the present invention, with the right side elevation view being a mirror image of the left side;

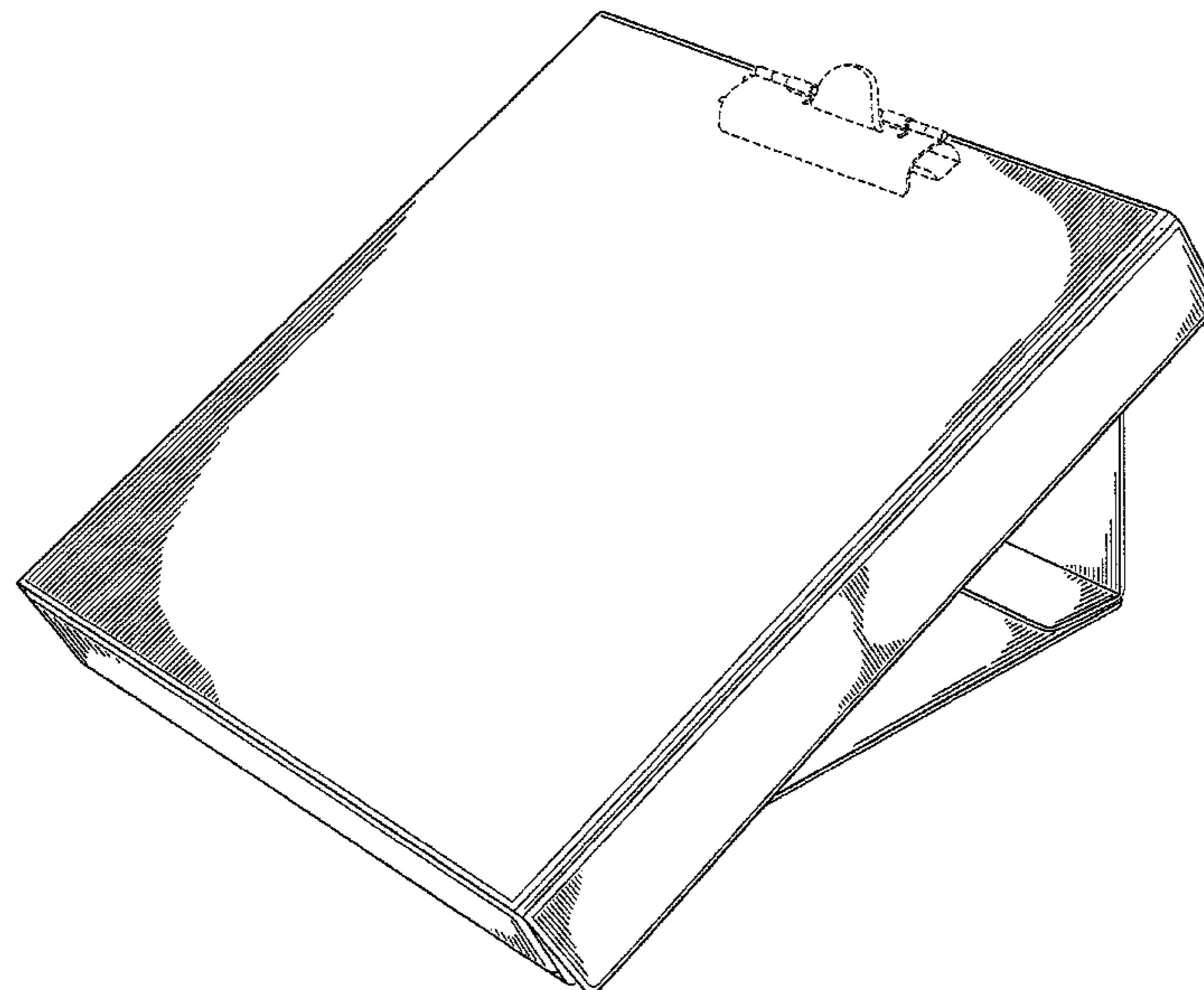
FIG. 5 is a bottom plan view of the recipe box and easel of the present invention;

FIG. 6 is a perspective view of the recipe box and easel of the present invention, with the lid open; and,

FIG. 7 is another perspective view of the recipe box and easel of the present invention, with the easel extended.

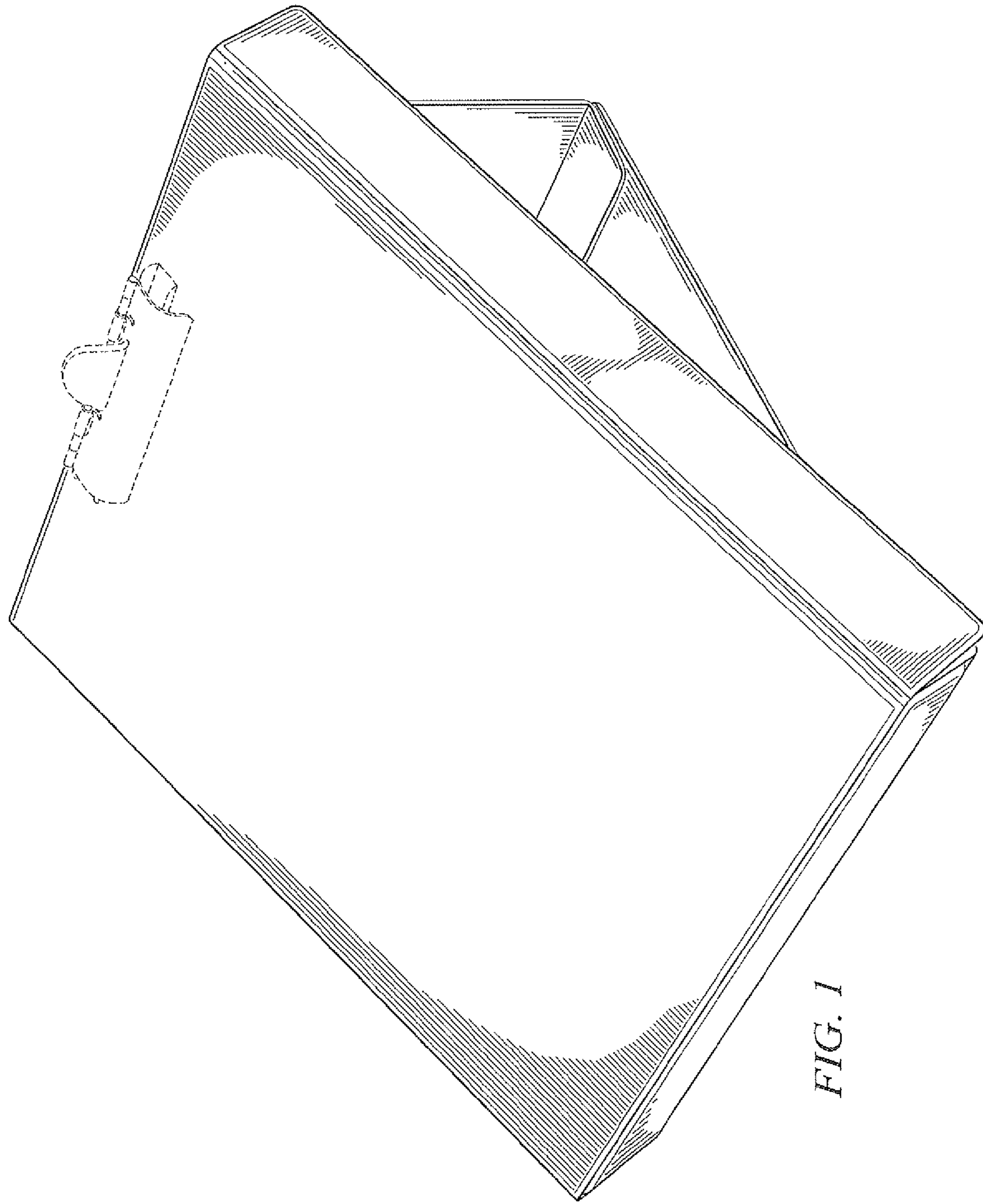

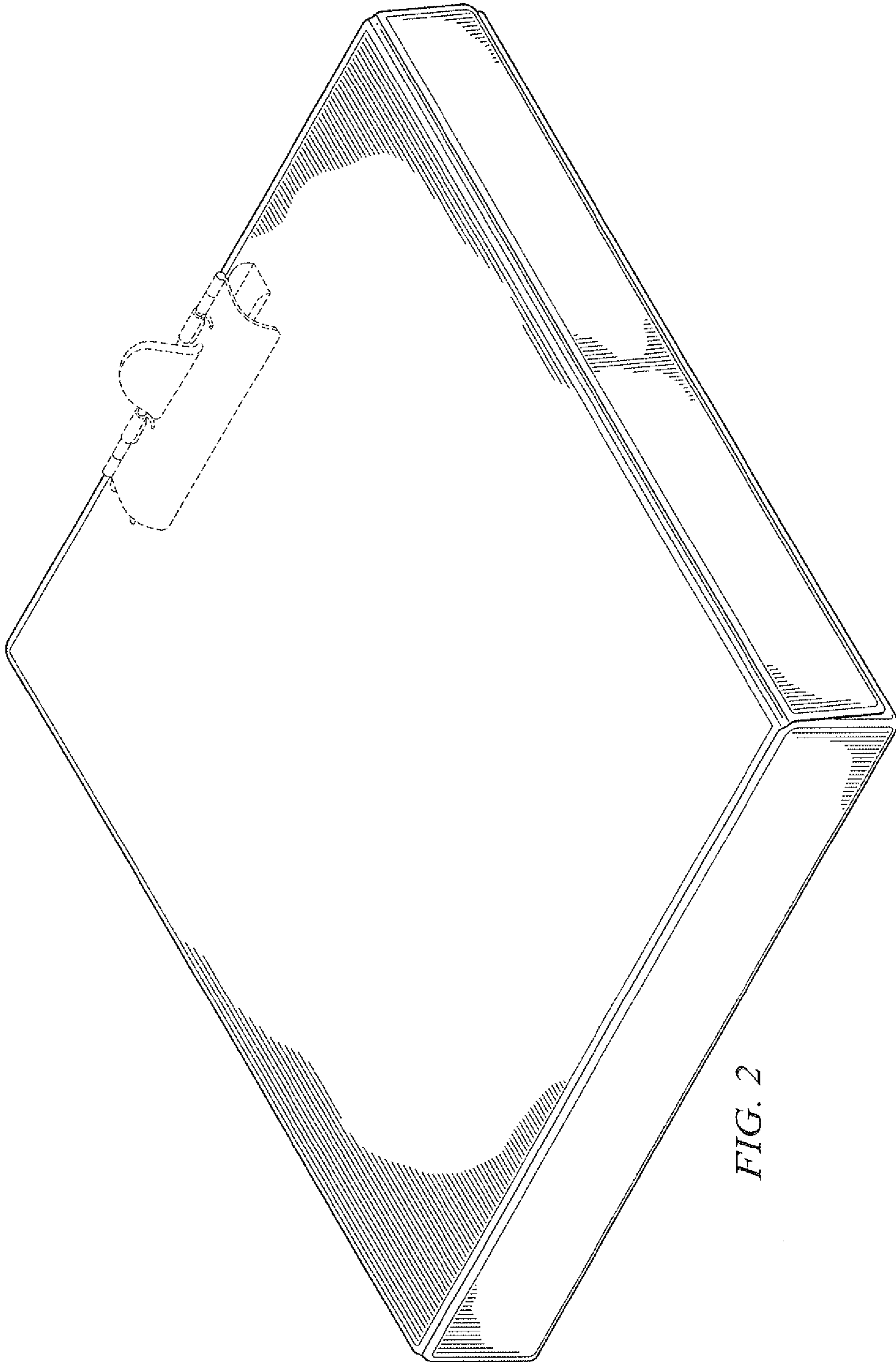

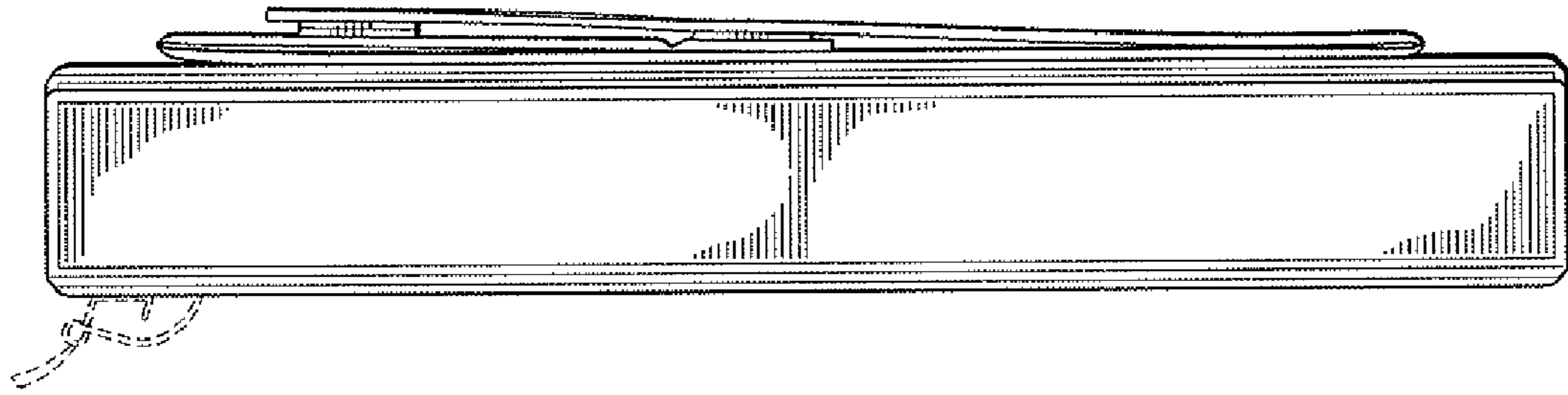

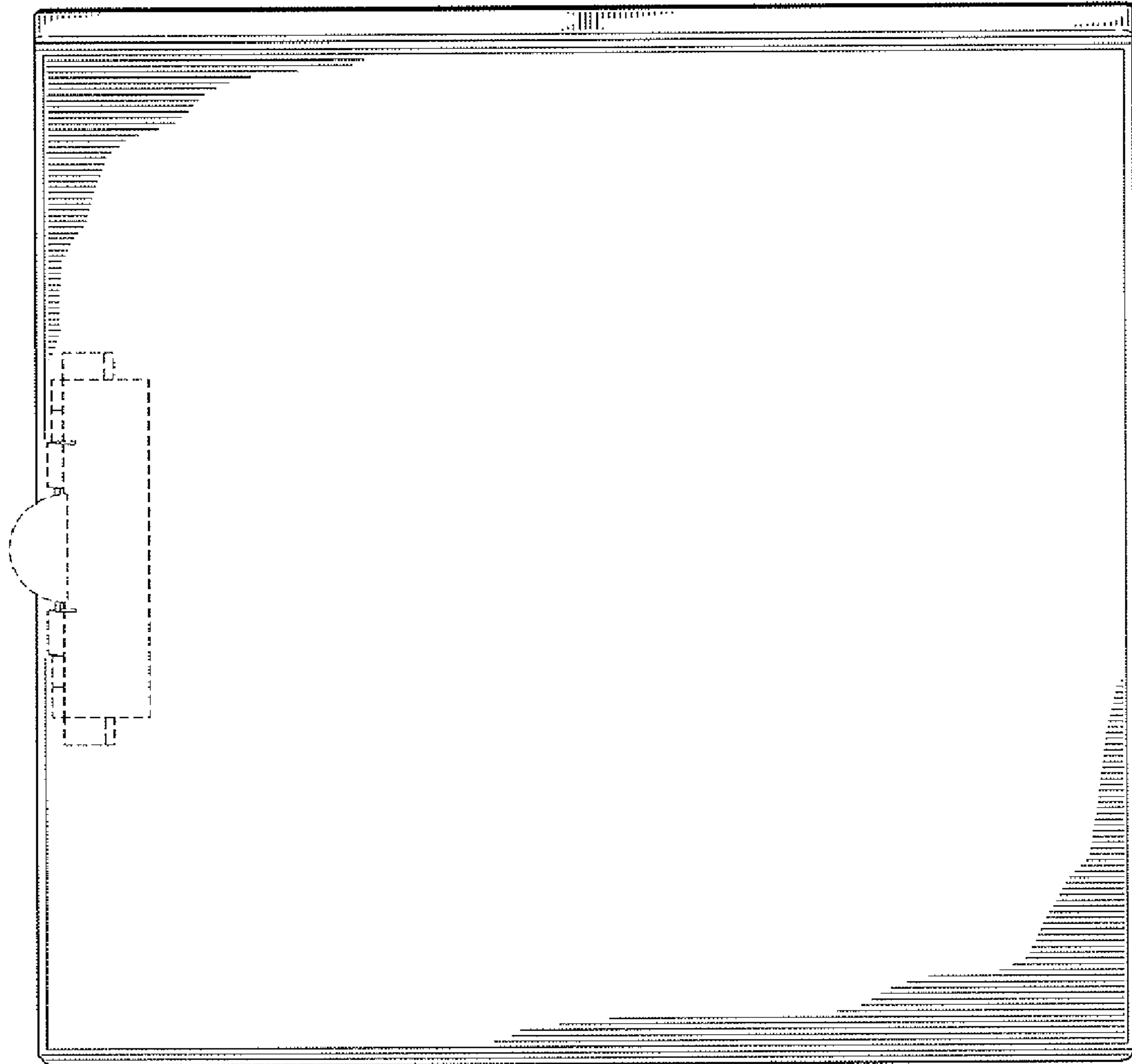

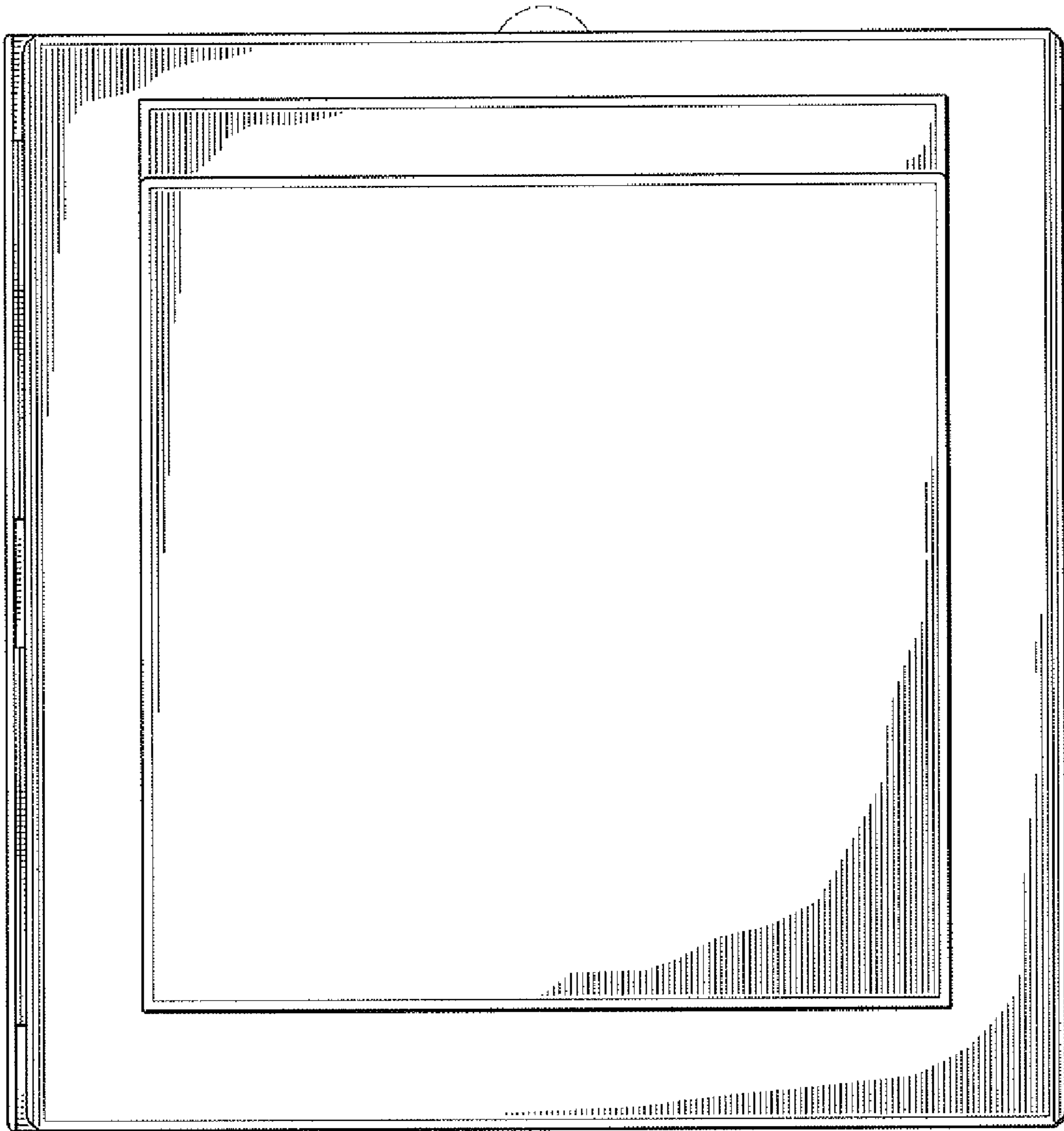

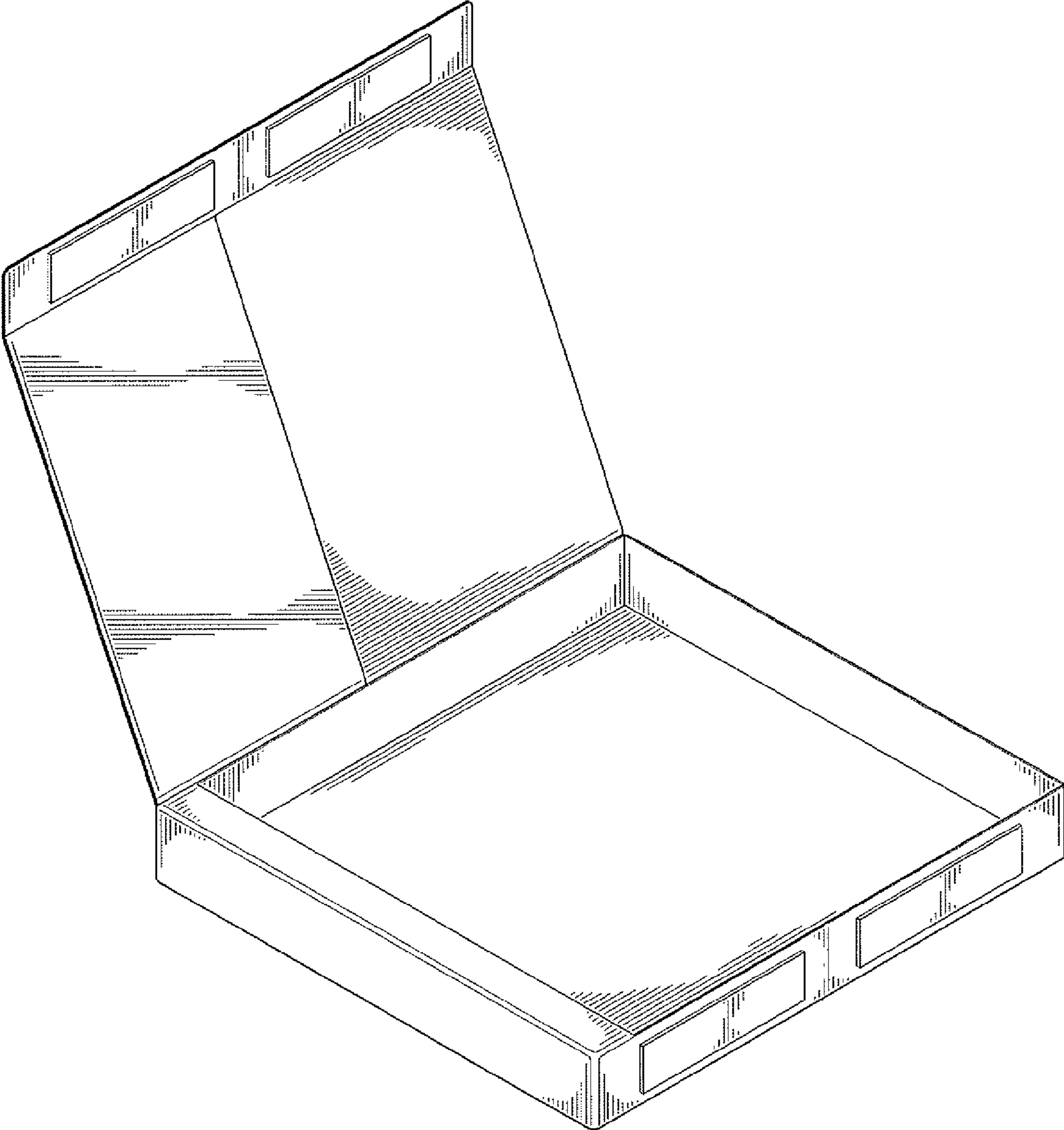

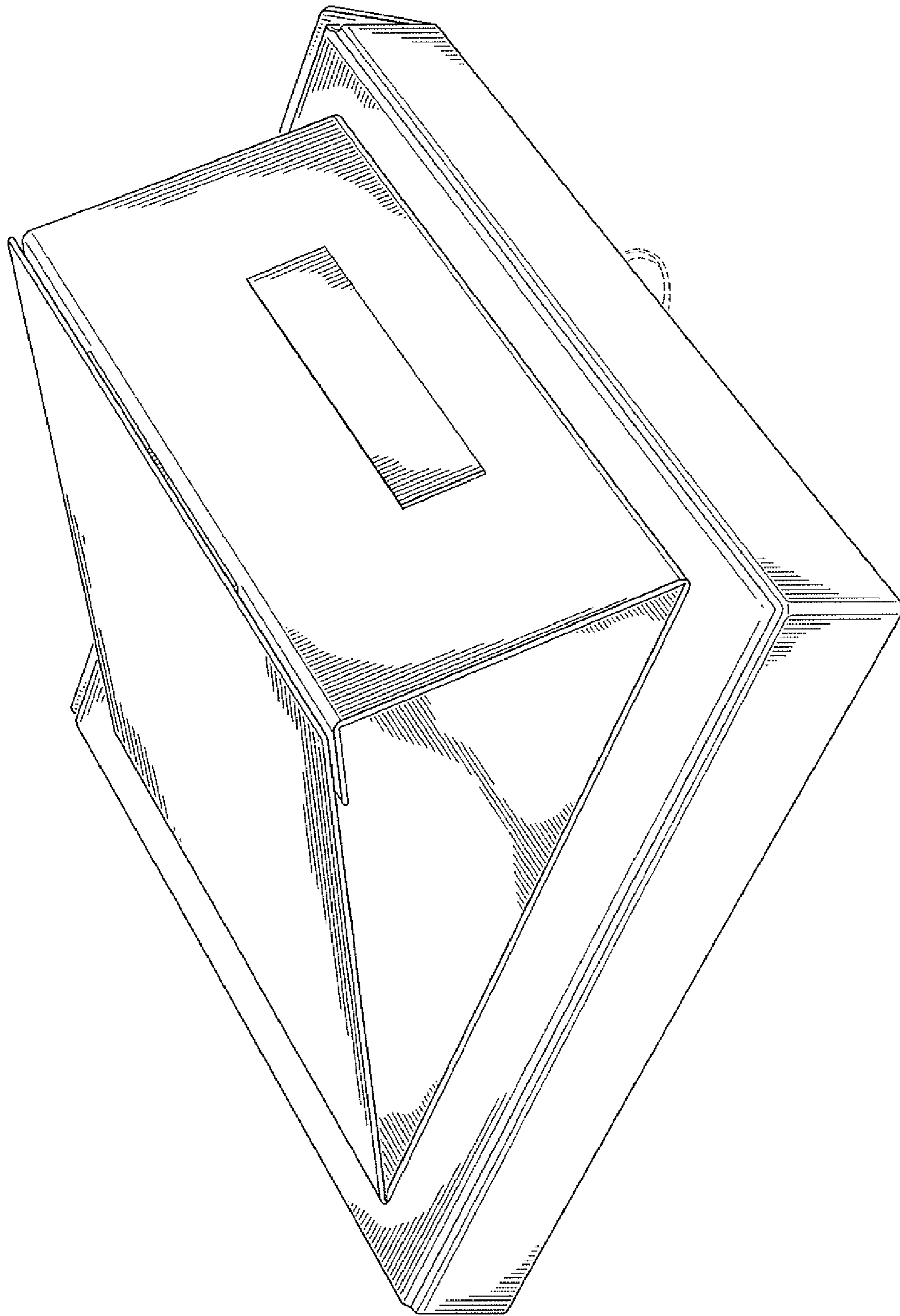
