The ornamental design for a saucer, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a saucer showing my new design;  
FIG. 2 is a front elevation thereof;  
FIG. 3 is a rear elevation thereof;  
FIG. 4 is a top perspective view thereof;  
FIG. 5 is a left side elevation thereof; and,  
FIG. 6 is a right side elevation thereof.

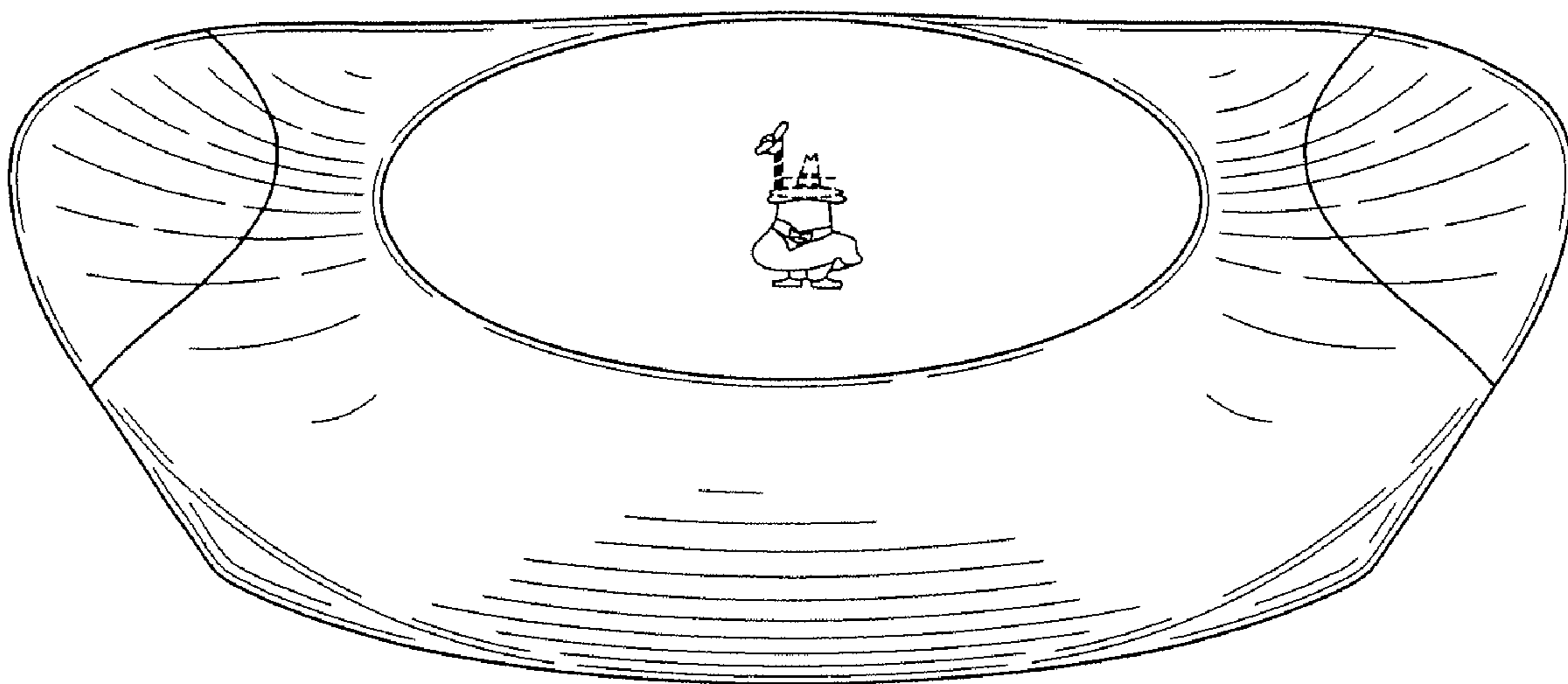

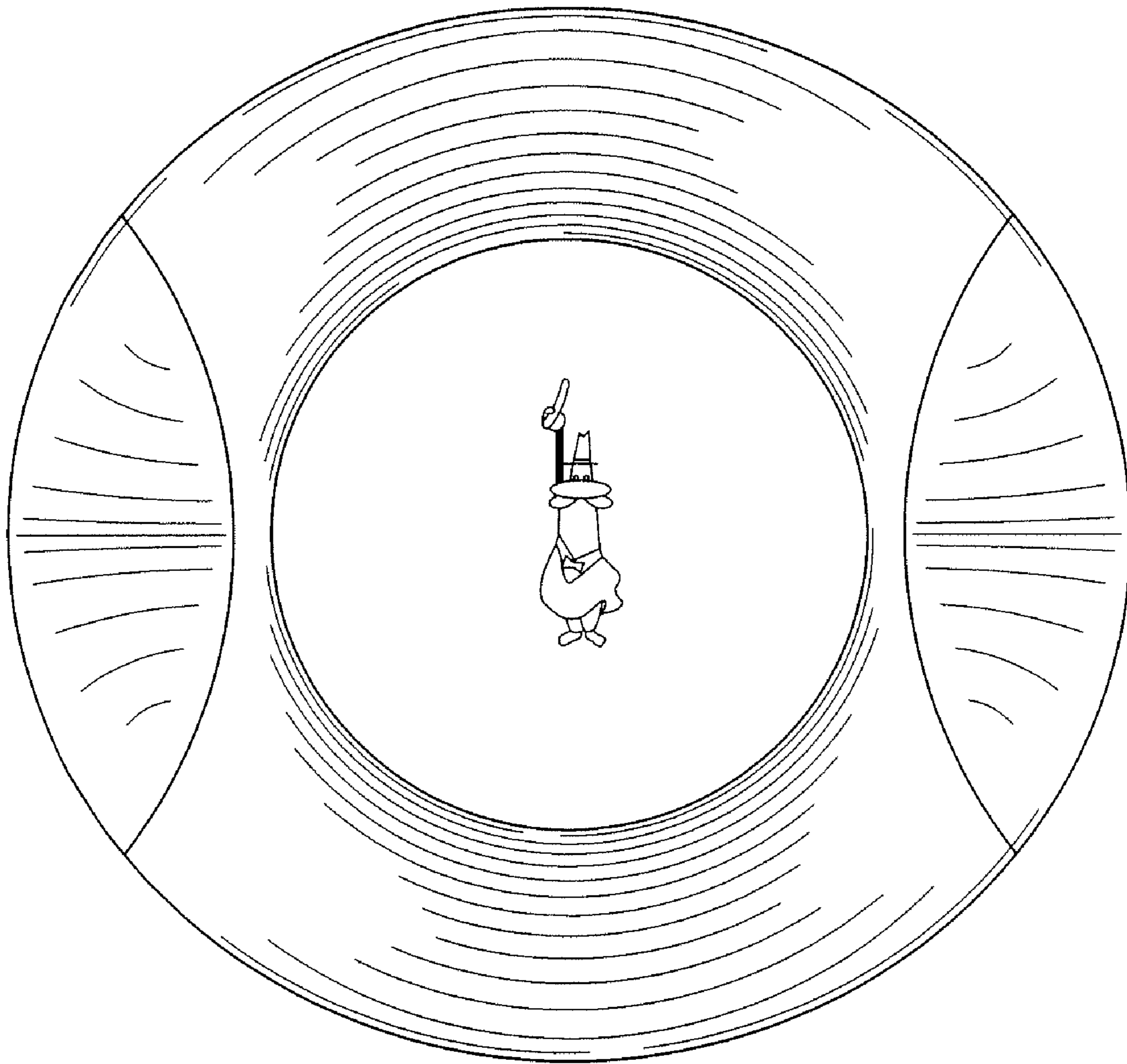

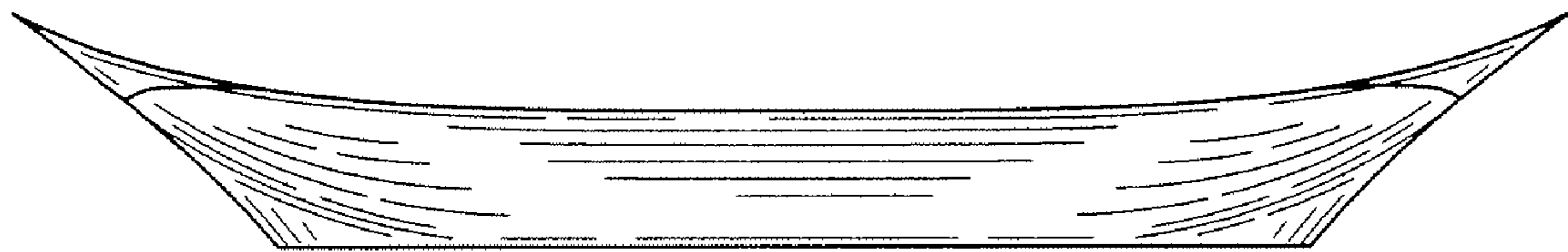

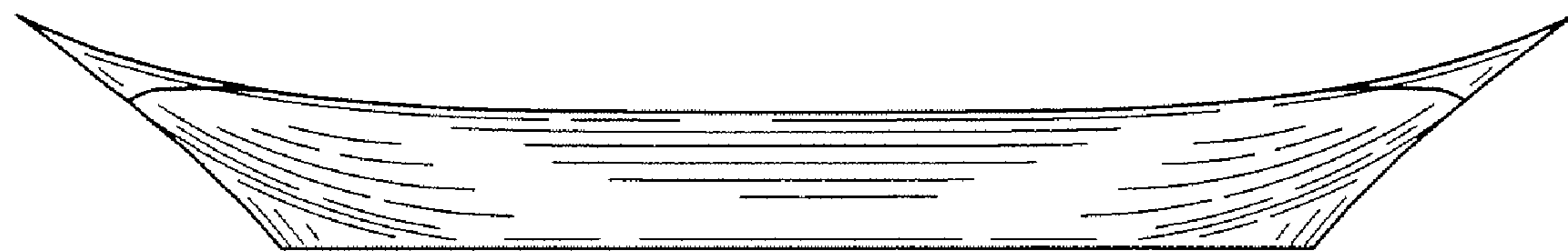

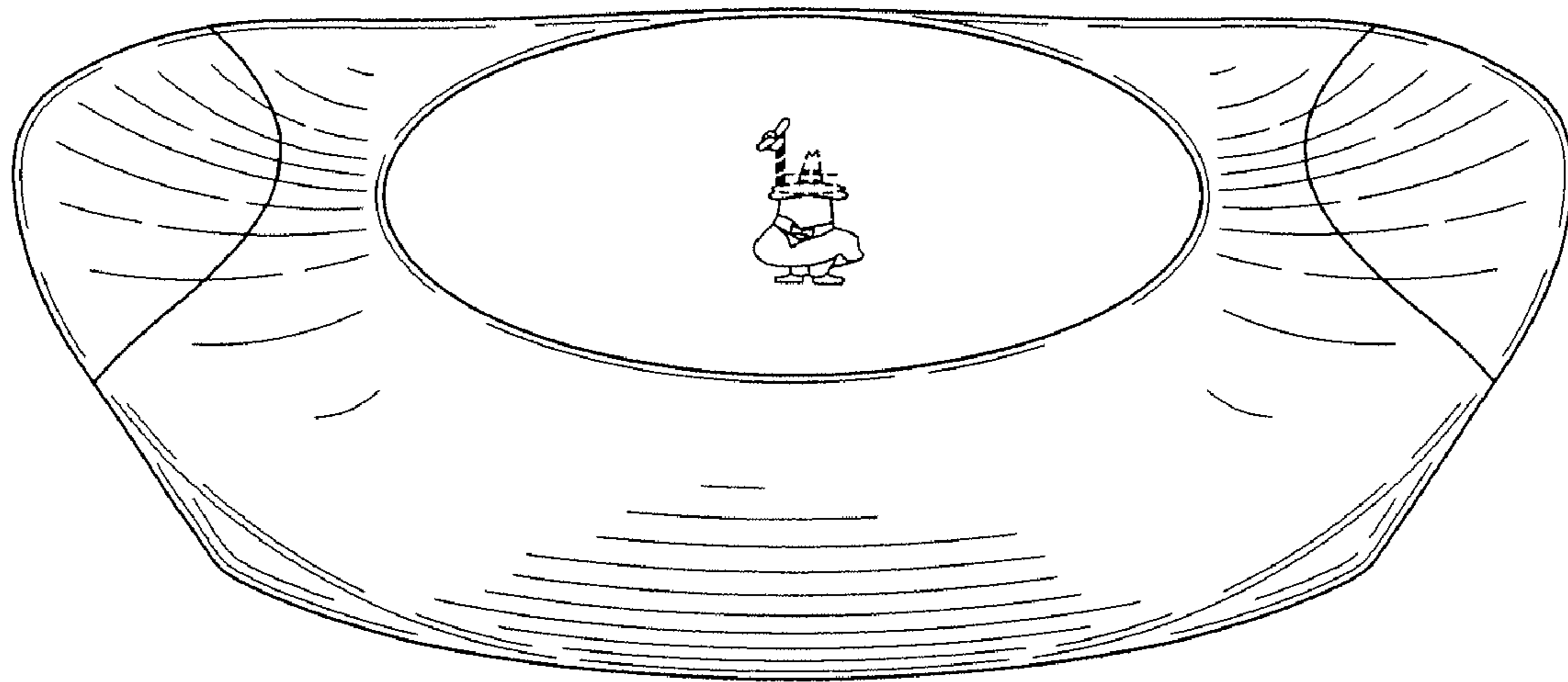

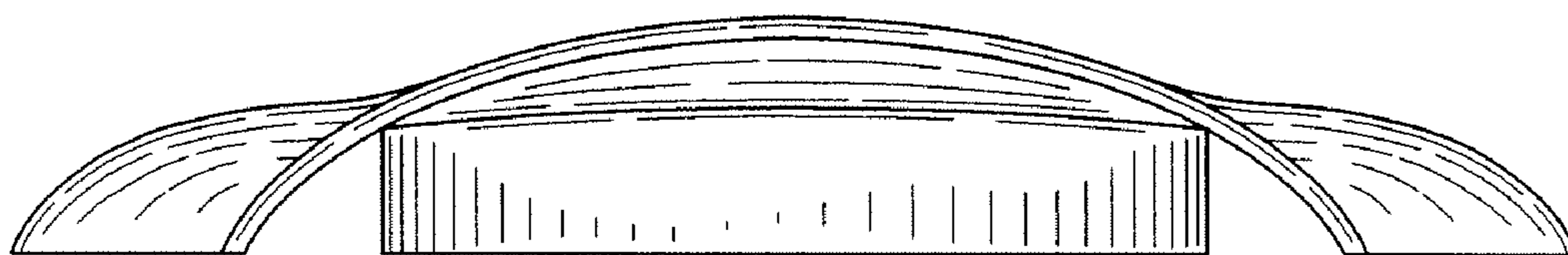
