DESCRIPTION

FIG. 1 is a left-side perspective view of a stapler embodying the present invention.

FIG. 2 is a left side view of the stapler.

FIG. 3 is a right side view of the stapler.

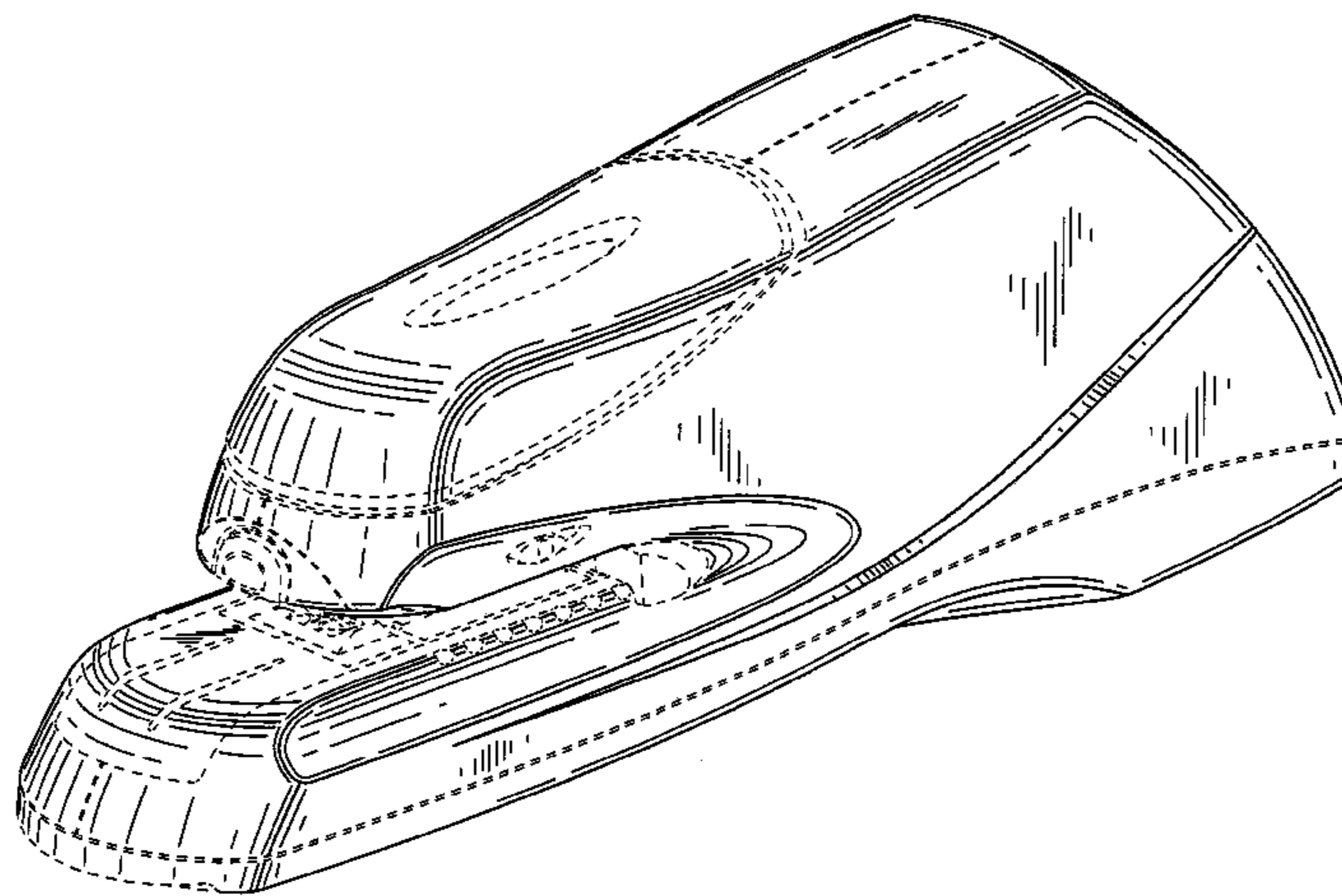
FIG. 4 is a front view of the stapler.

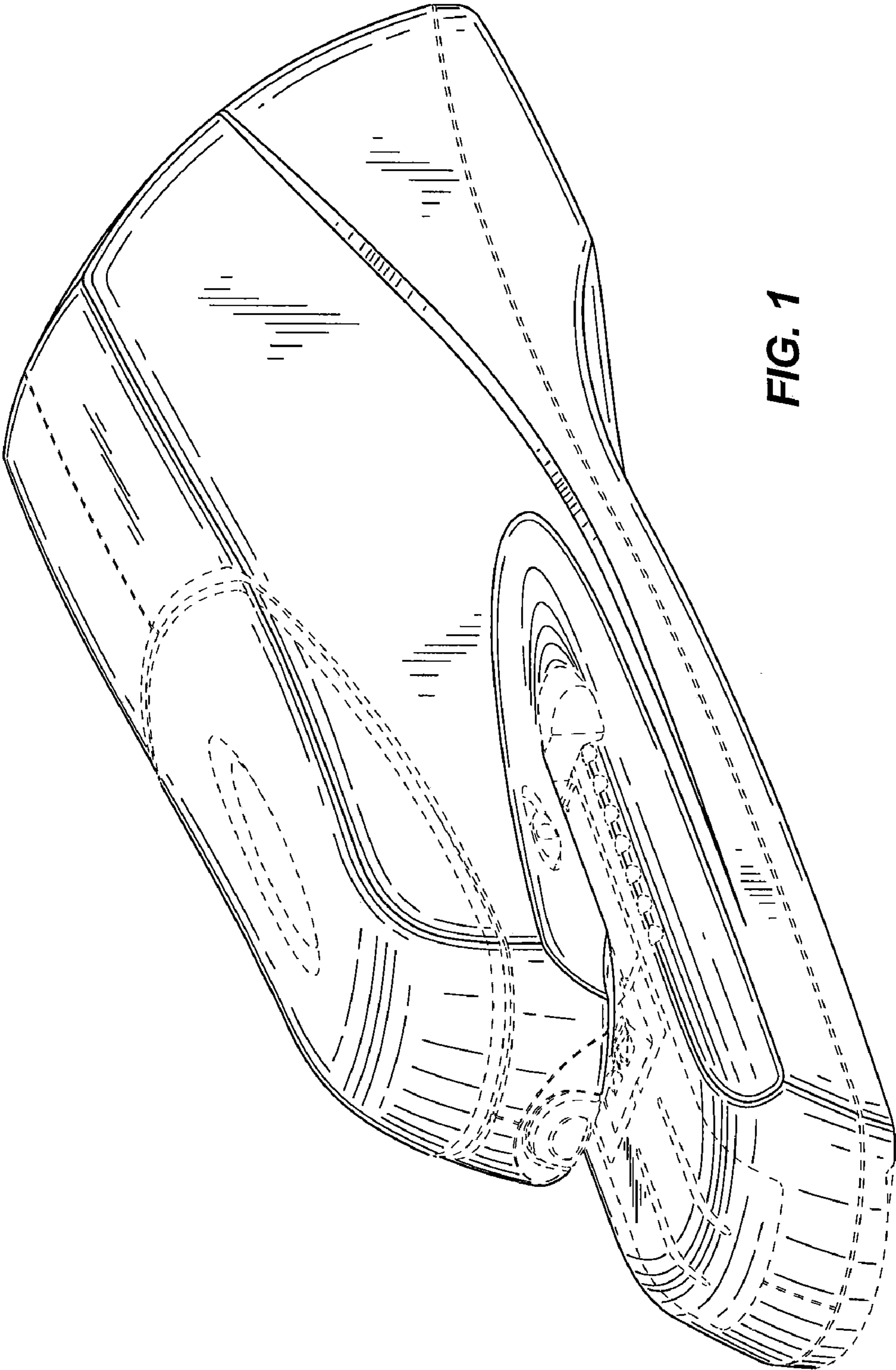

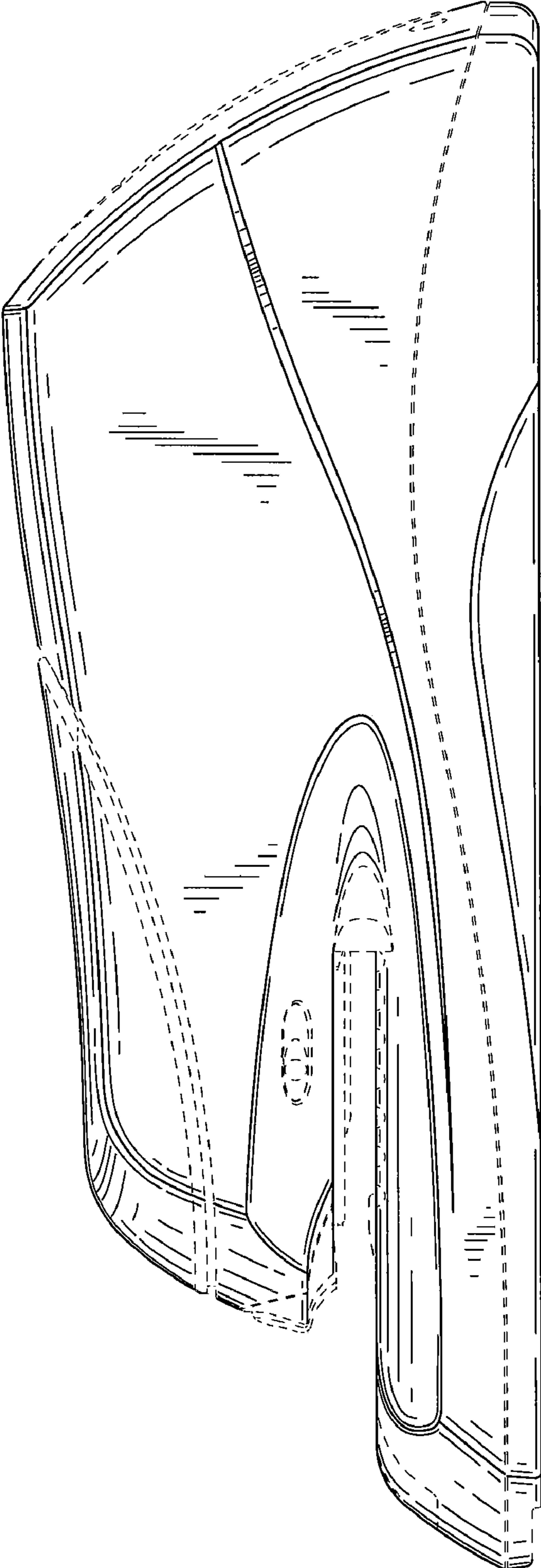

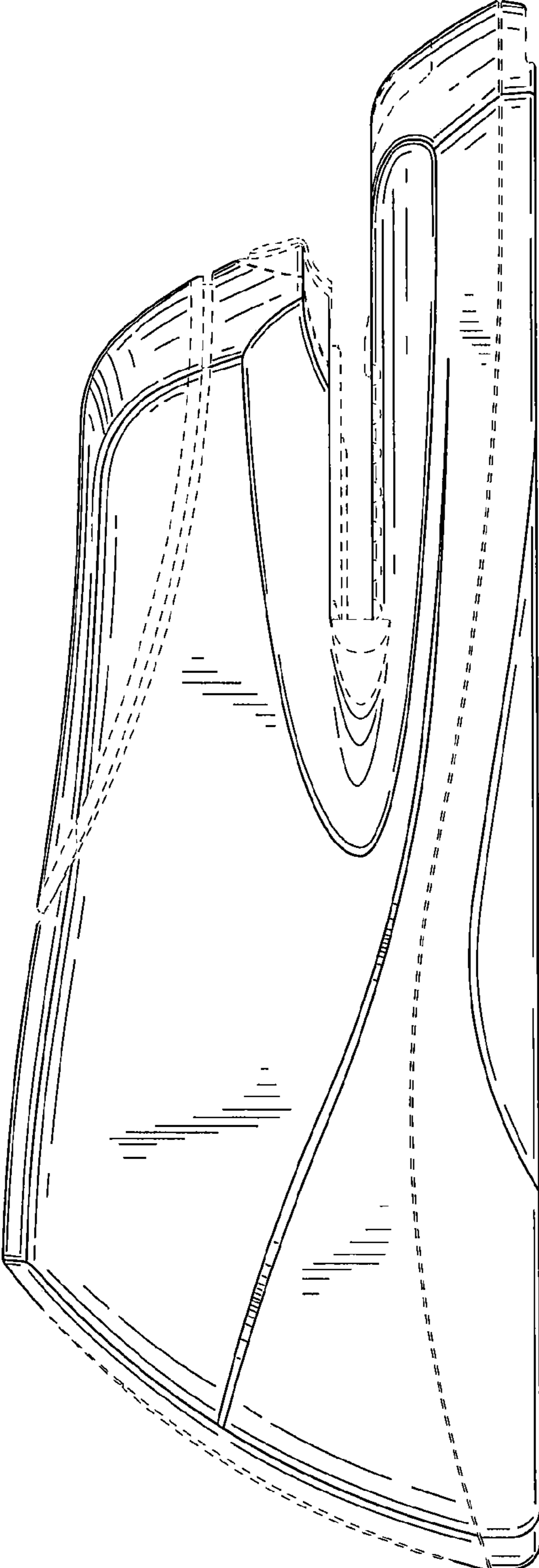

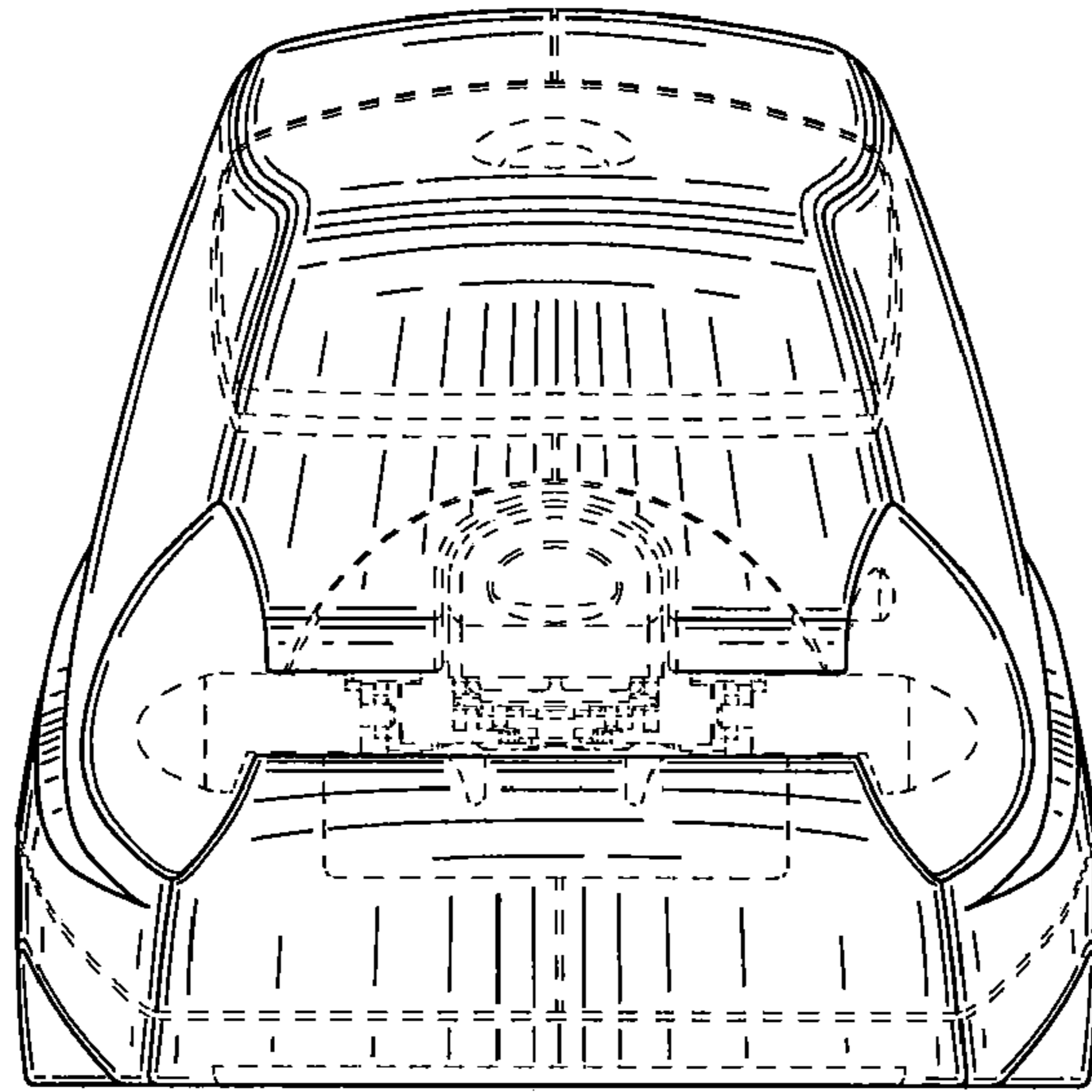

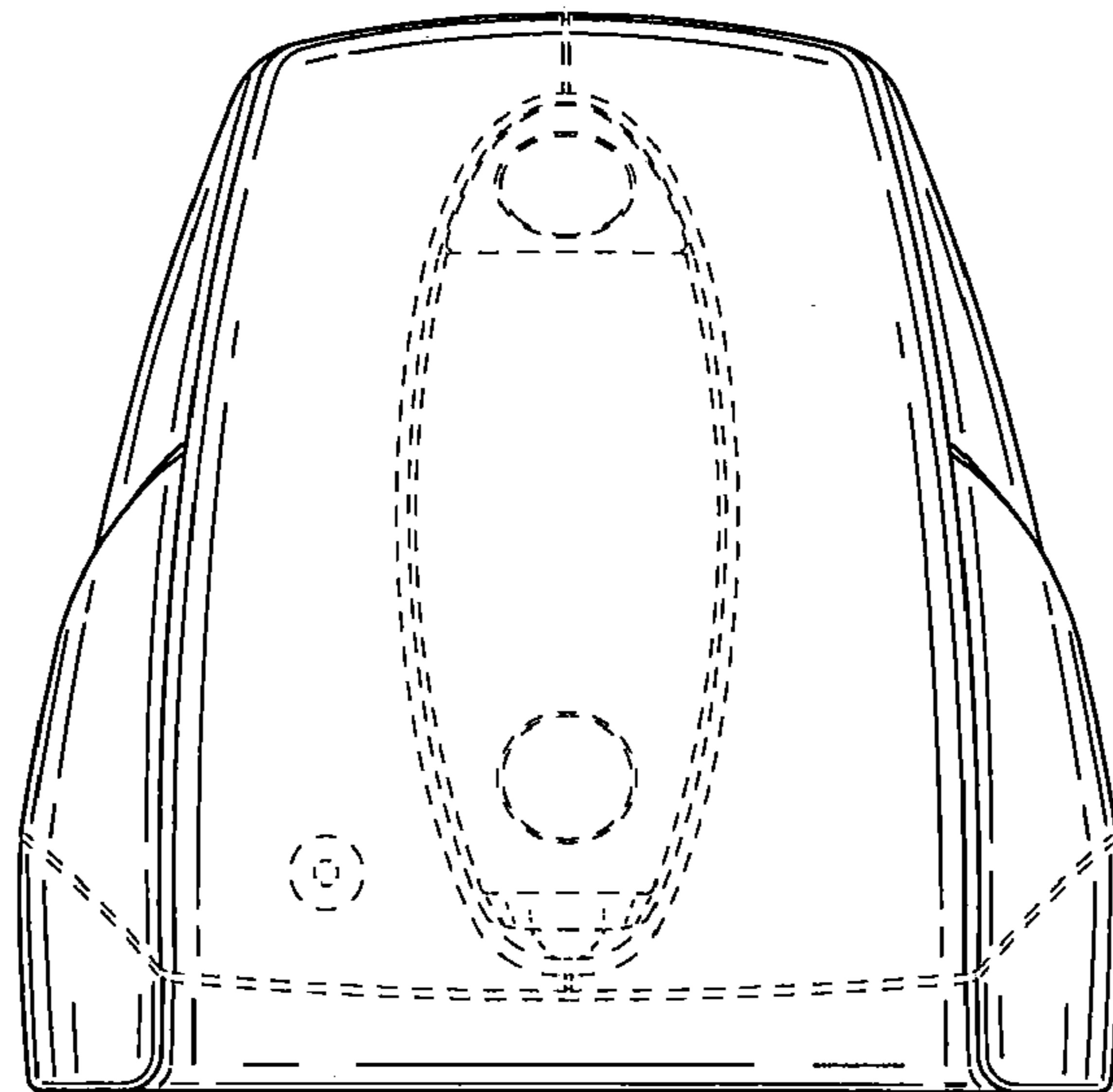

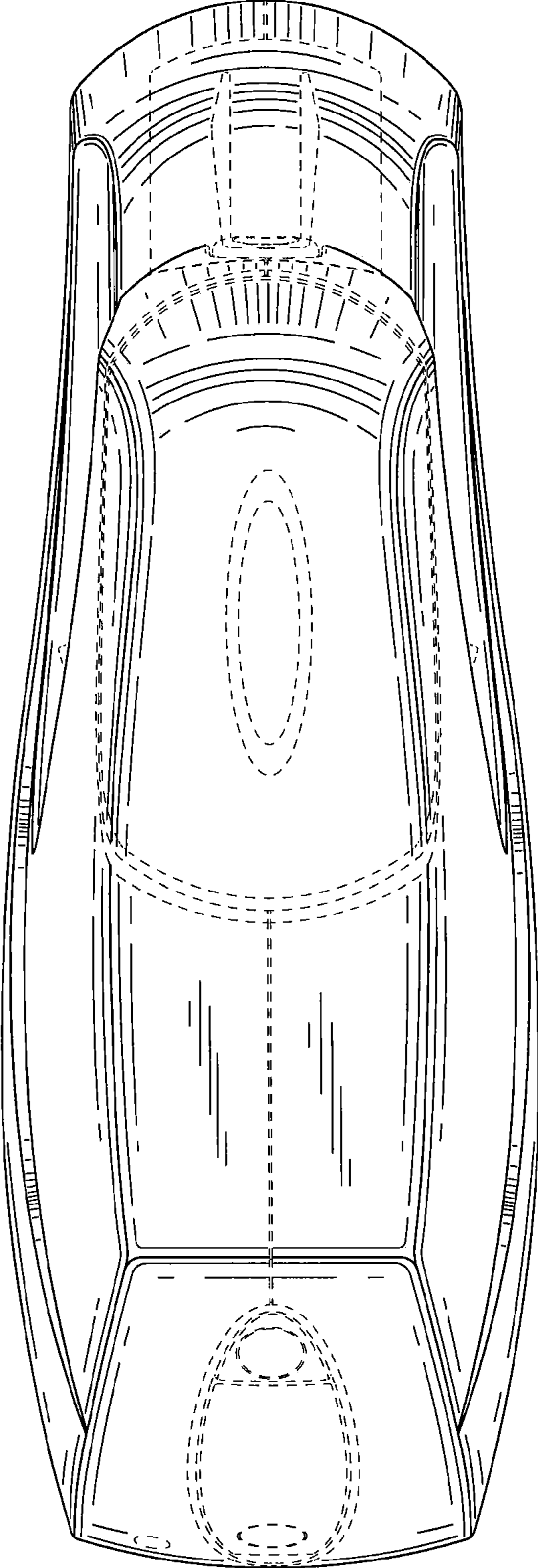
