FIG. 4 is a front view of the design of the present invention in an open position;

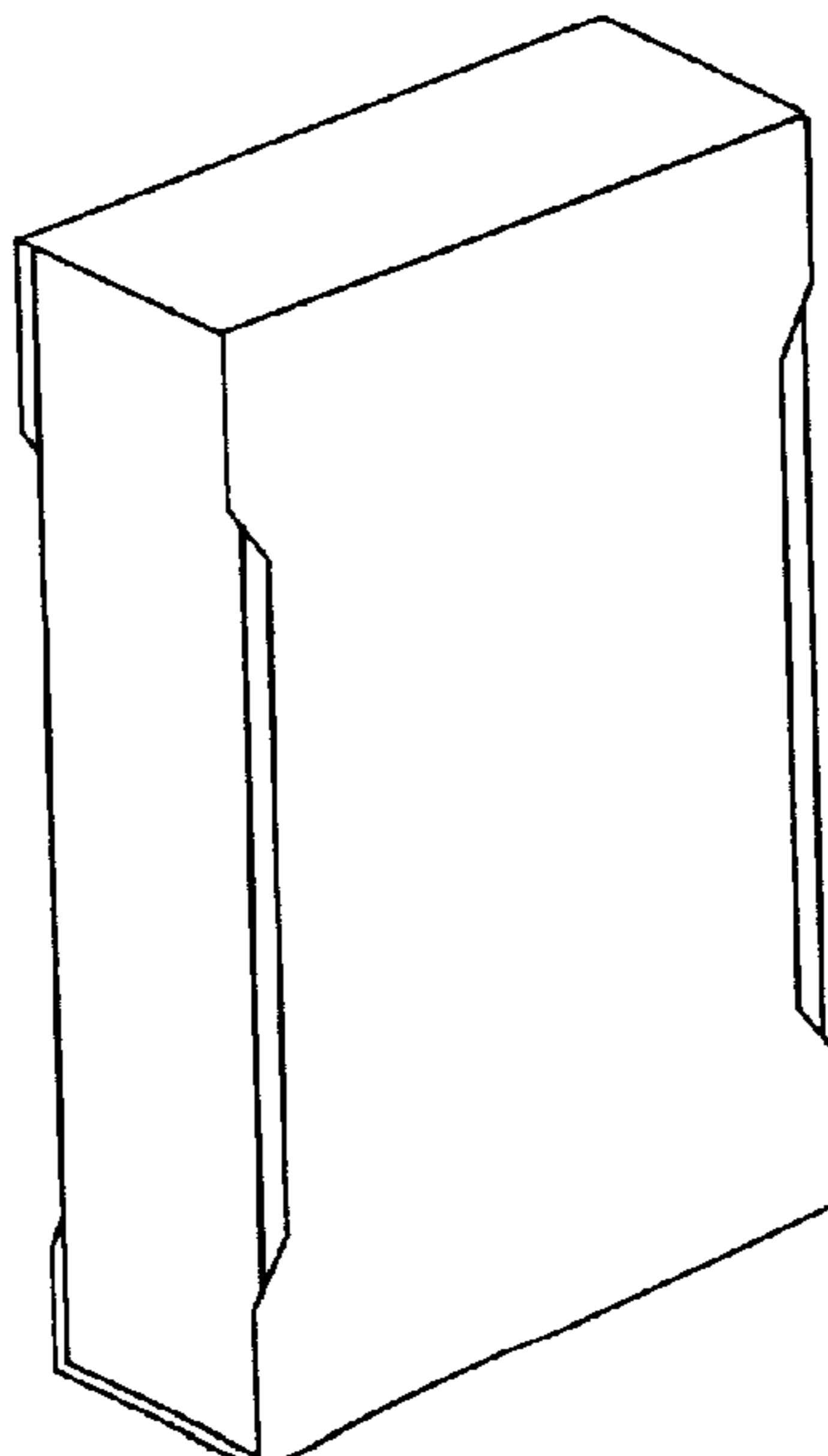
FIG. 5 is a rear view of the design of the present invention in an open position;

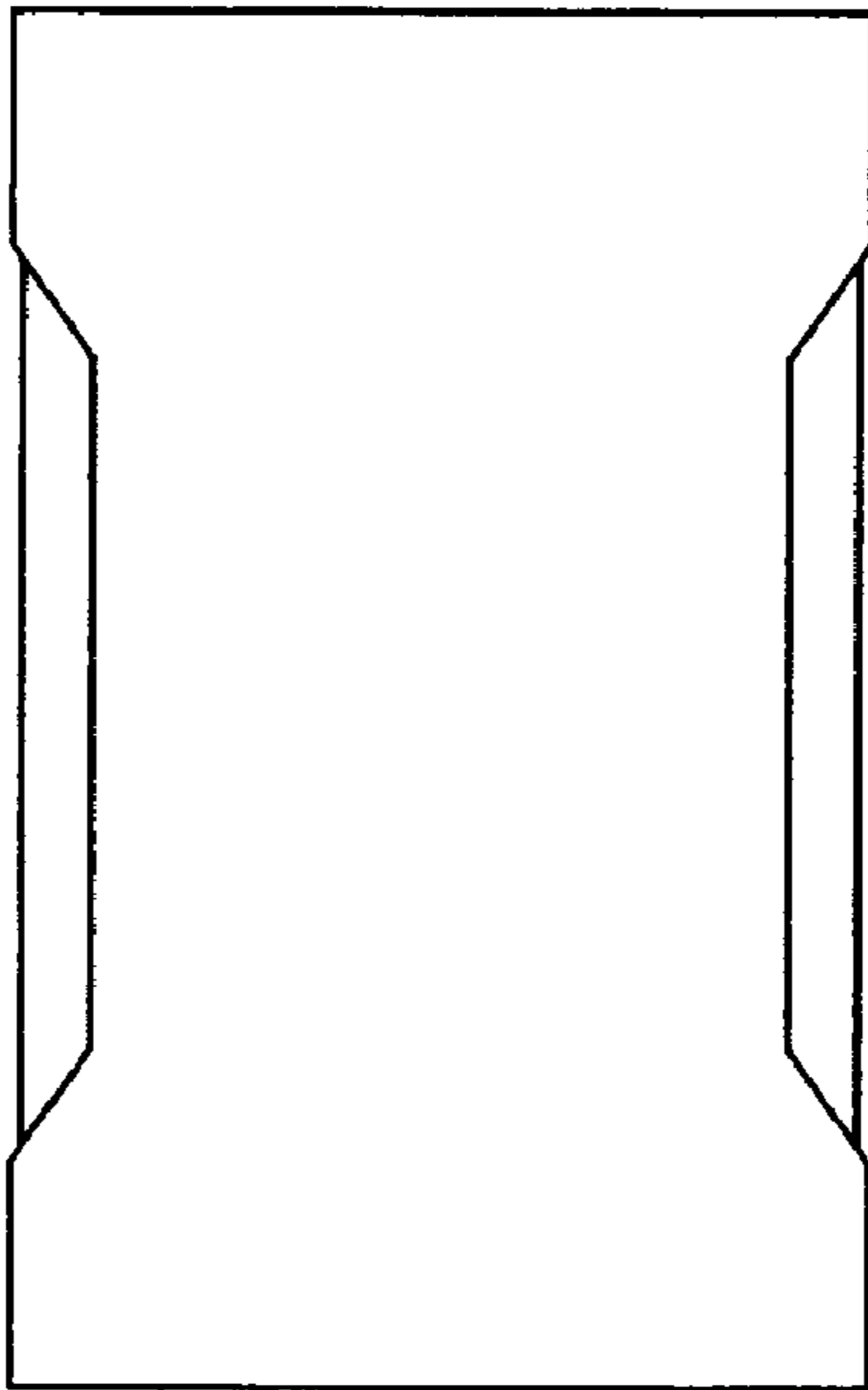

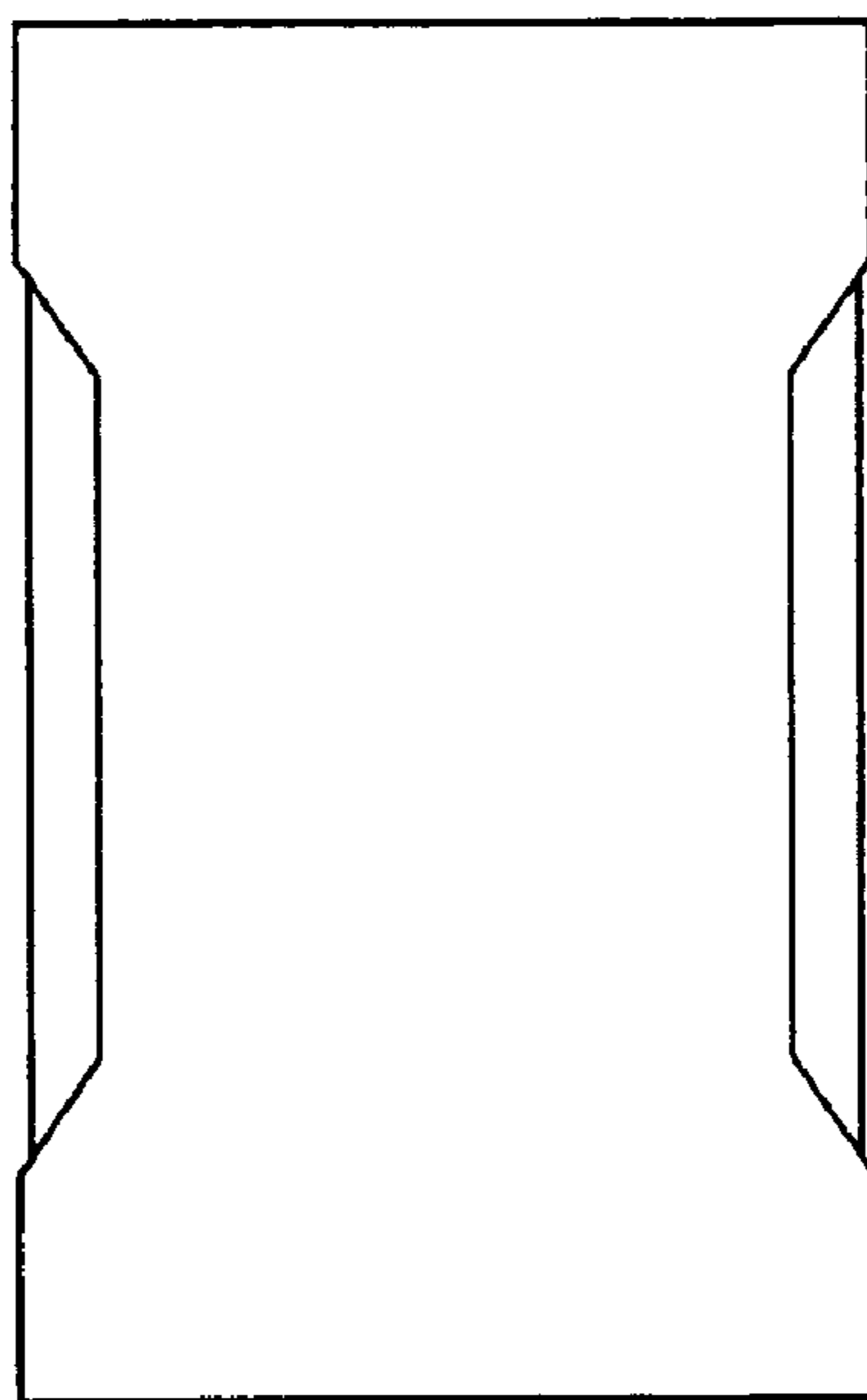

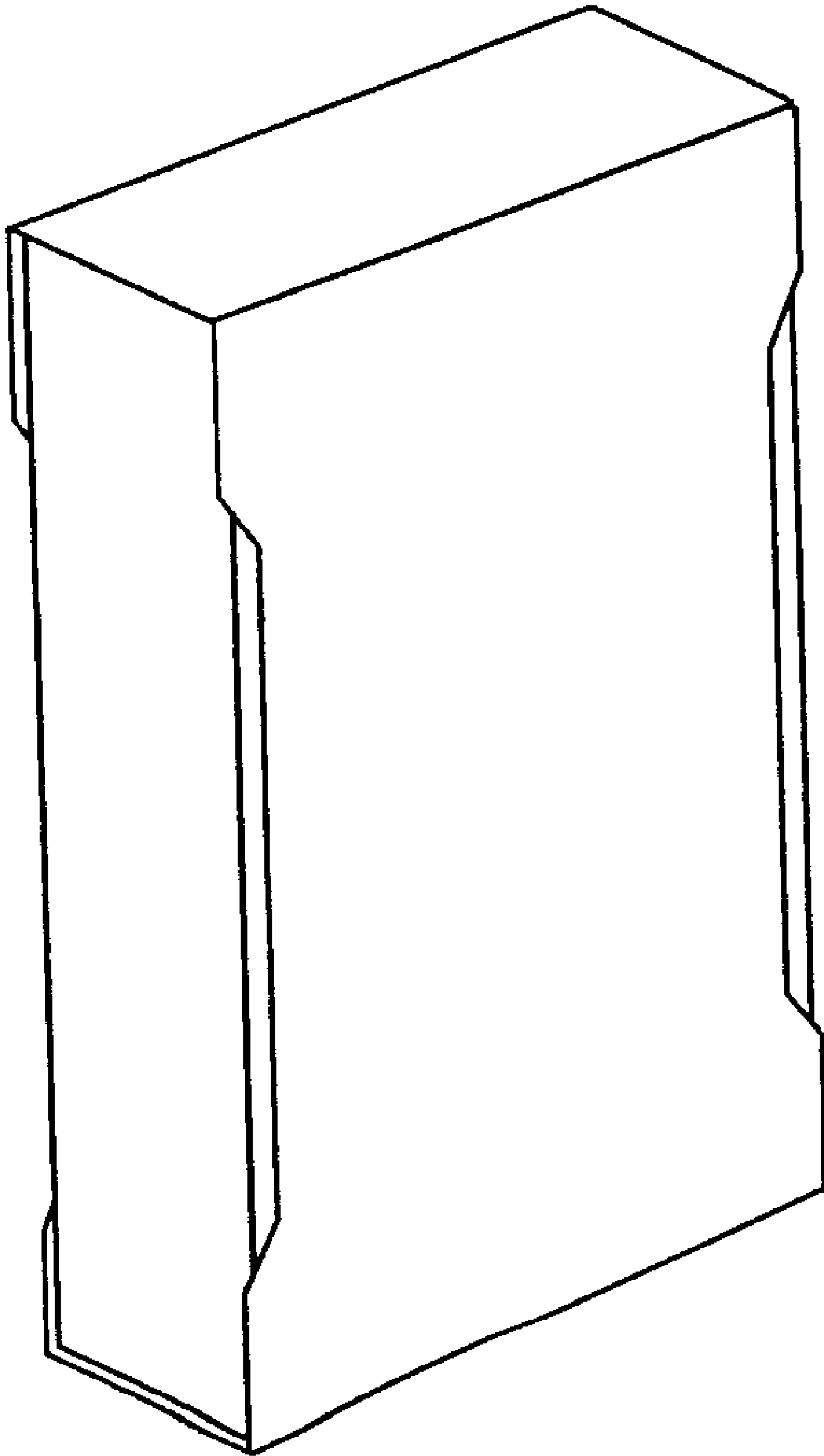

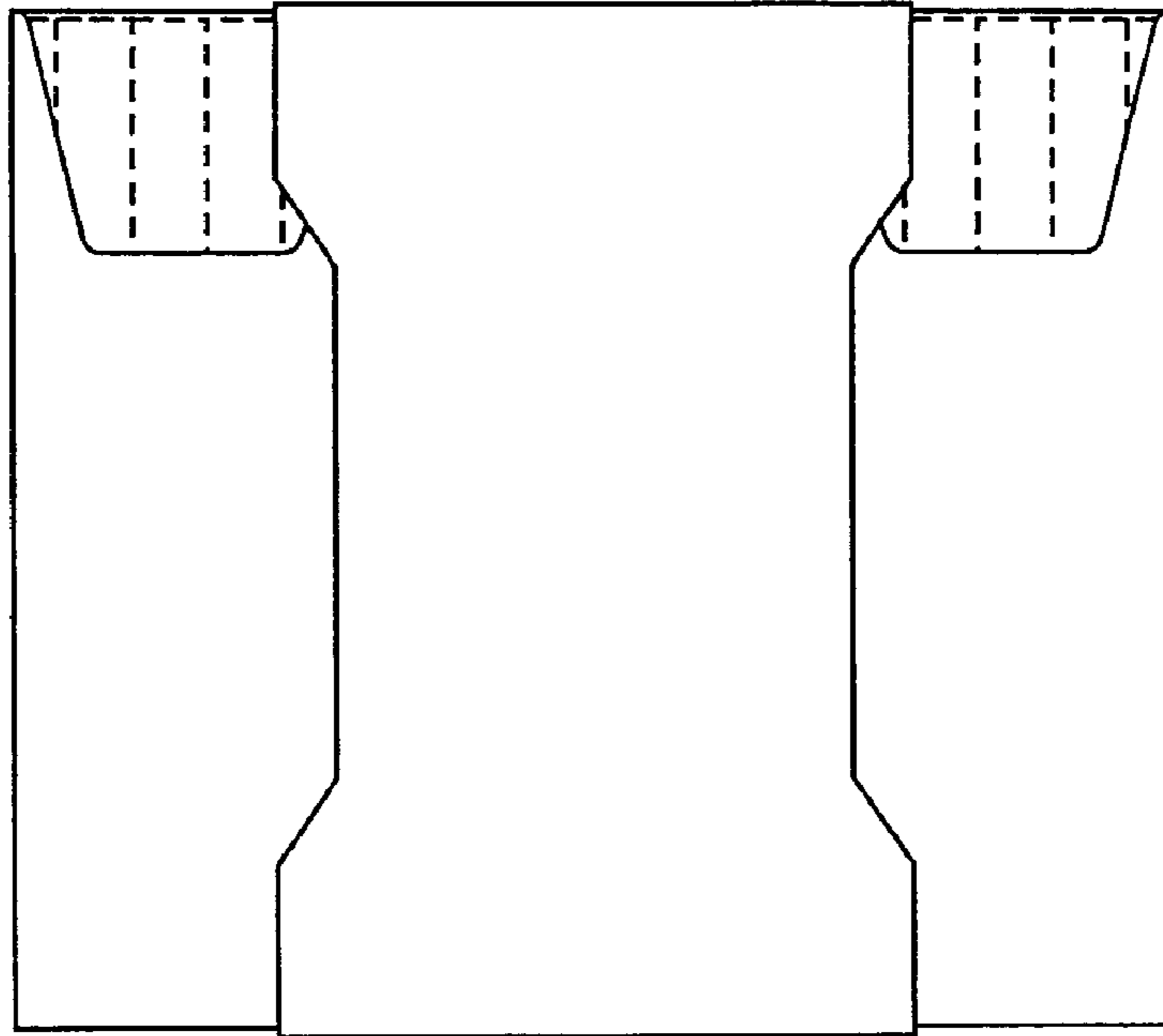

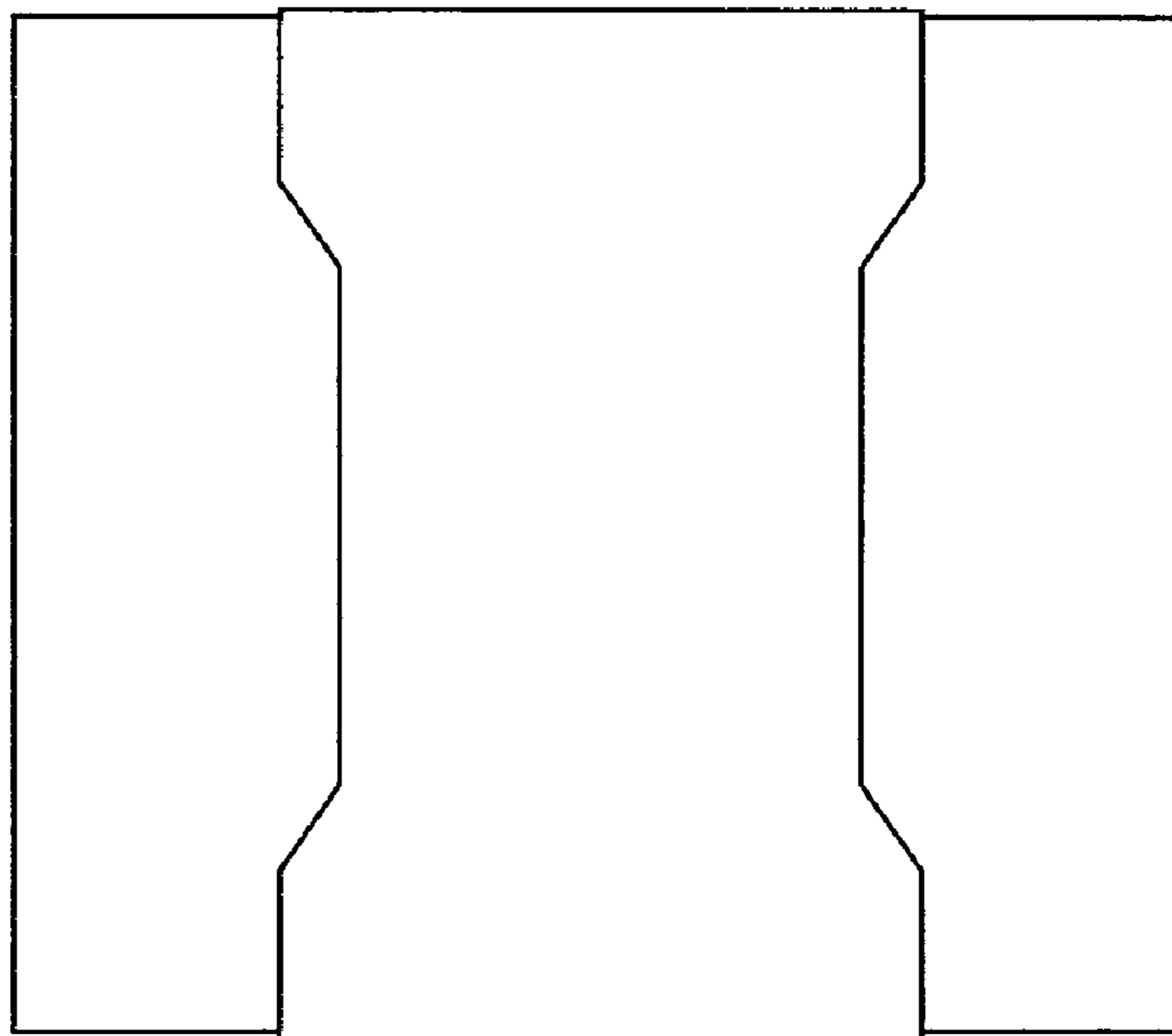

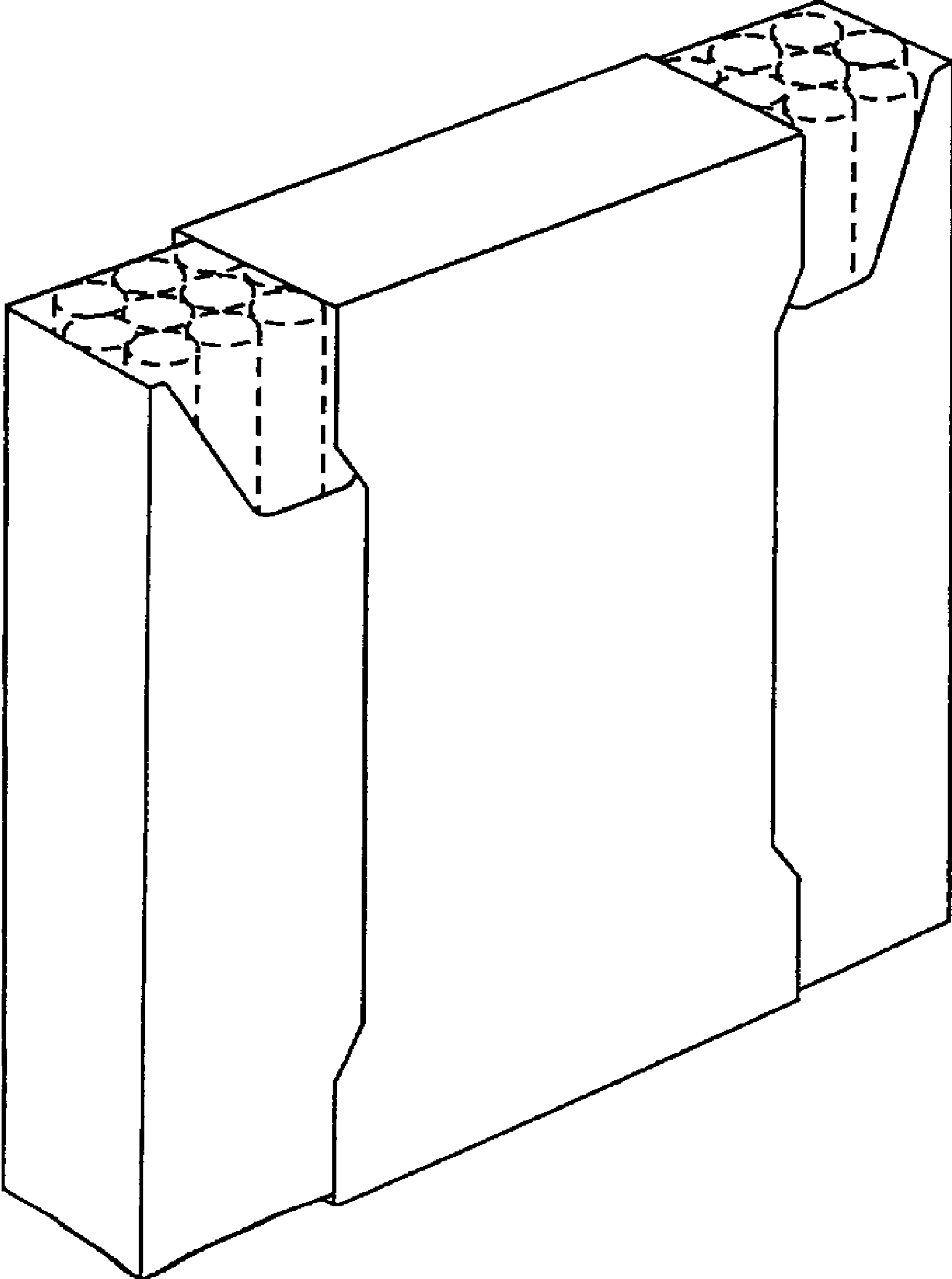
