We claim the ornamental design for a packaging, as shown
and described.

DESCRIPTION

FIG. 1 is a top, right perspective view of a packaging showing
the new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

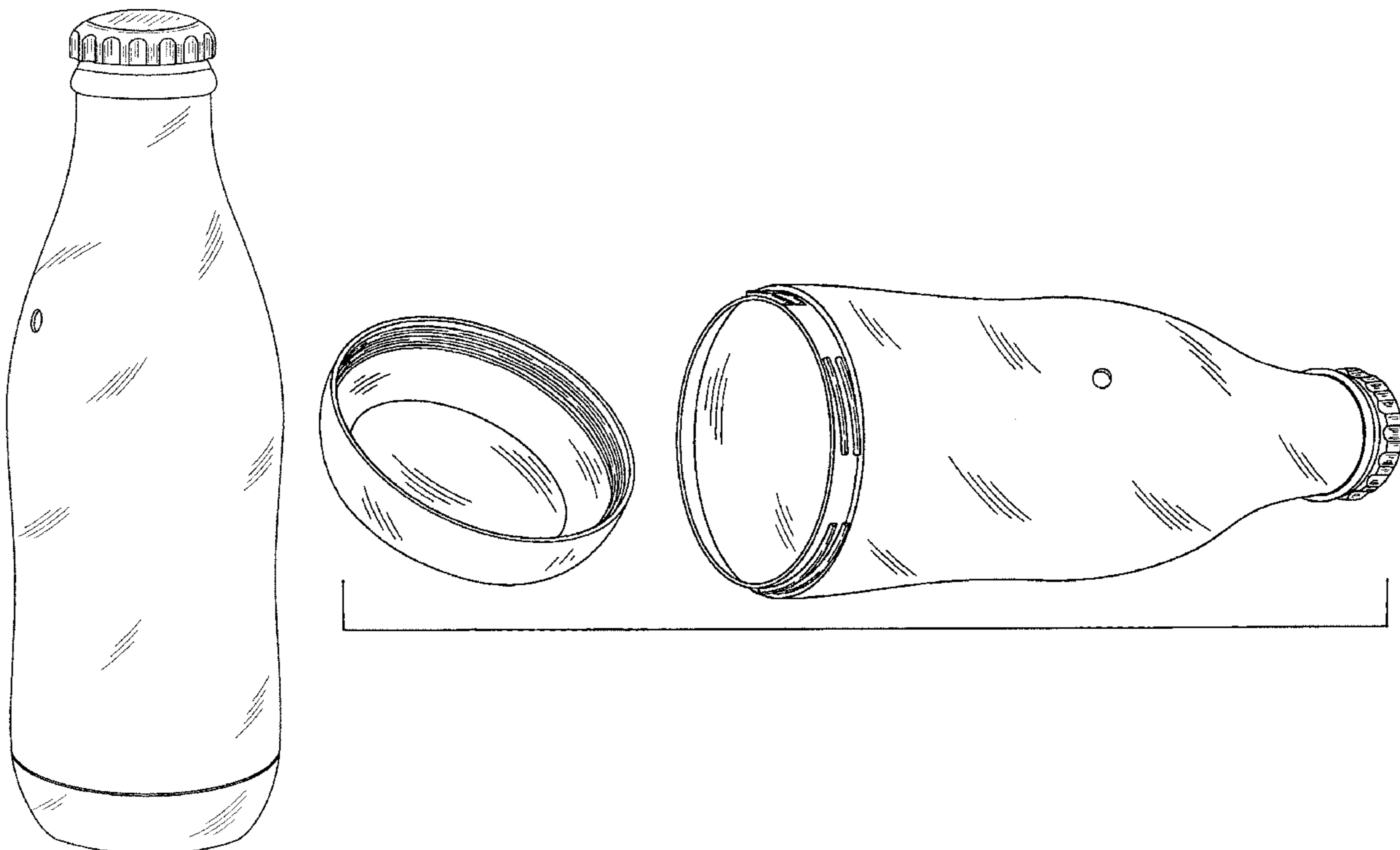
FIG. 4 is a left side elevational view, the right side elevational
view being a mirror image thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is an exploded perspective view thereof, the bottom

in design.

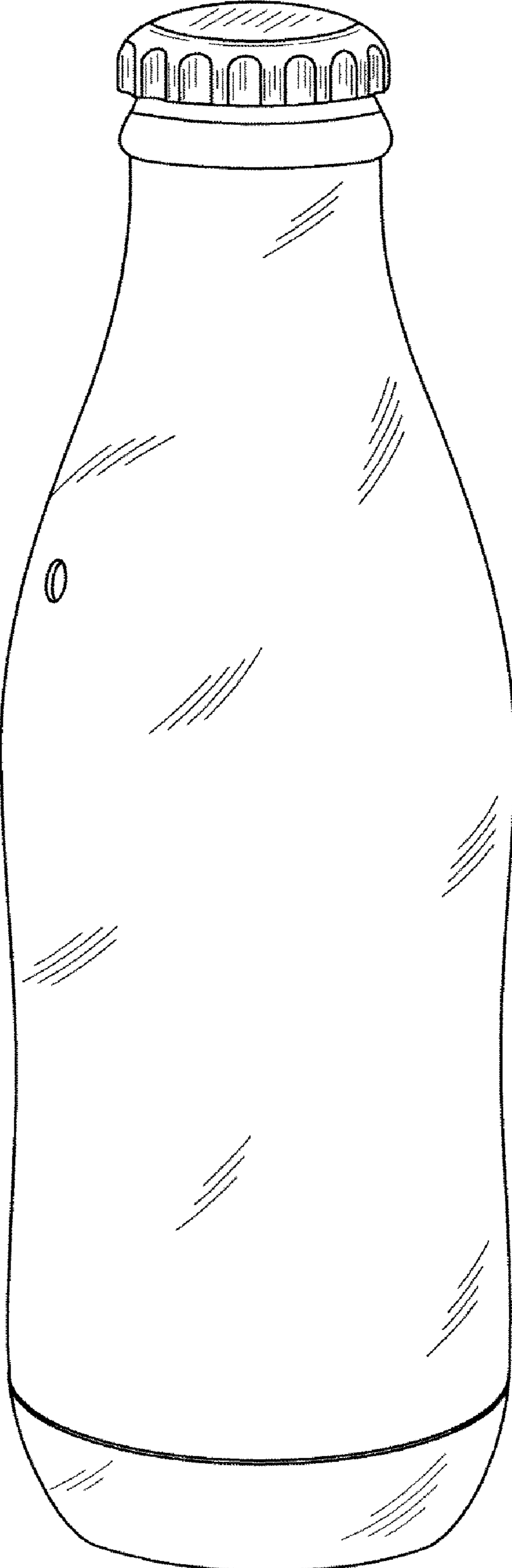

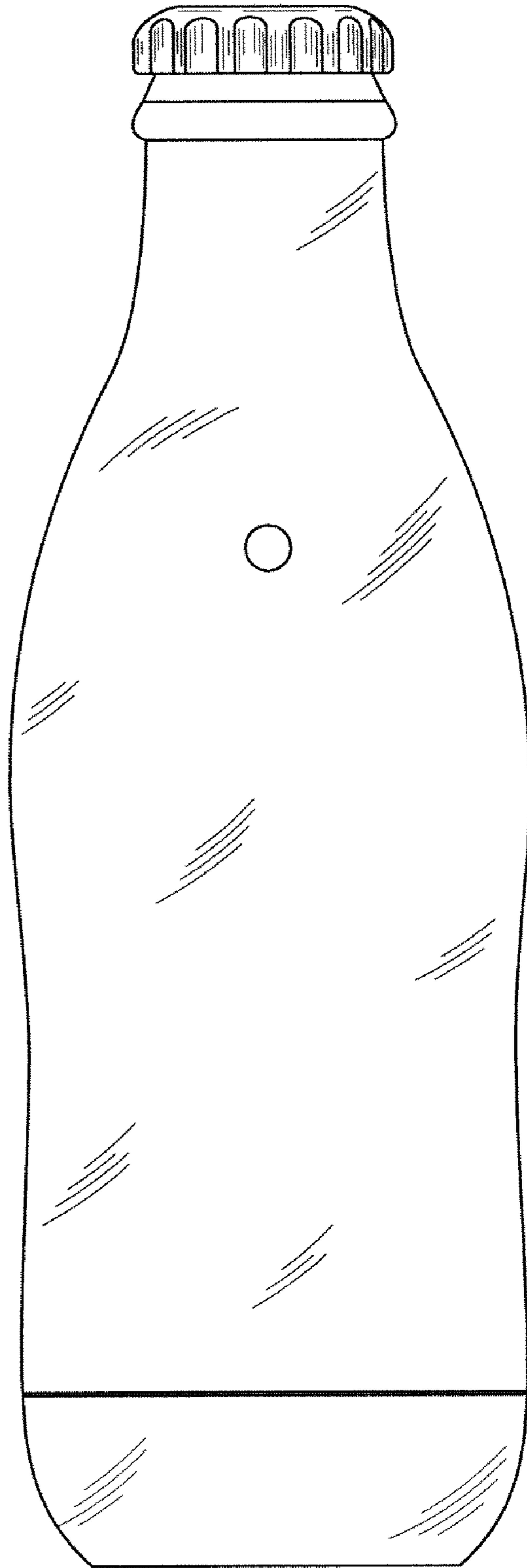

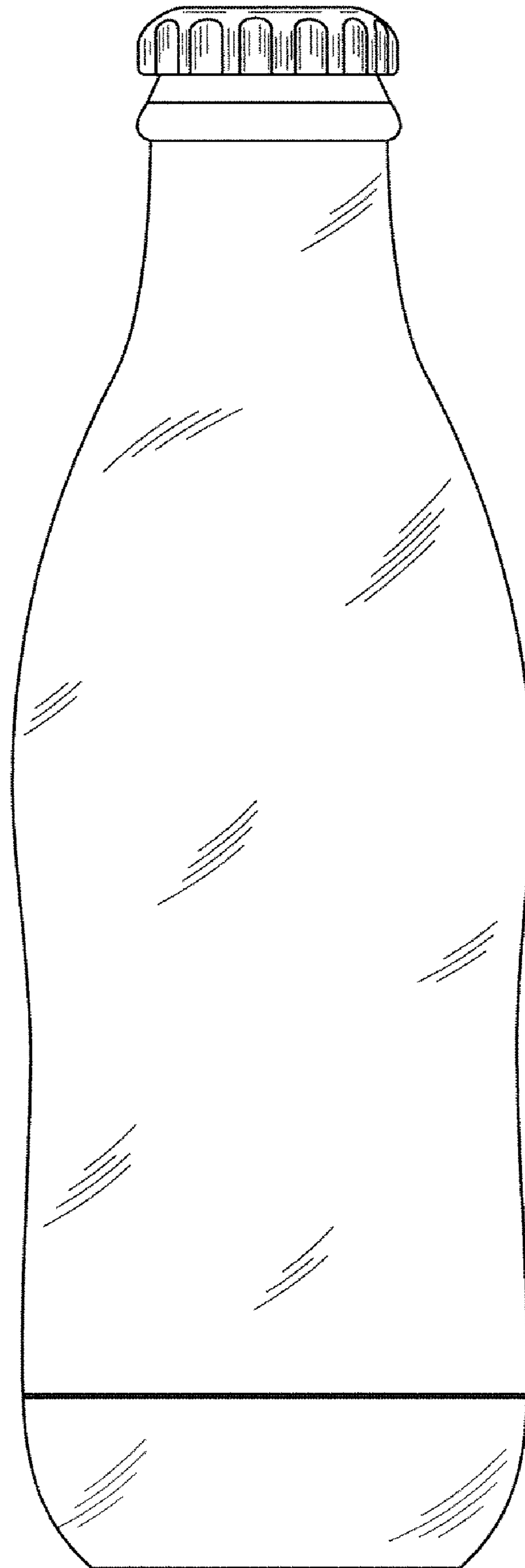

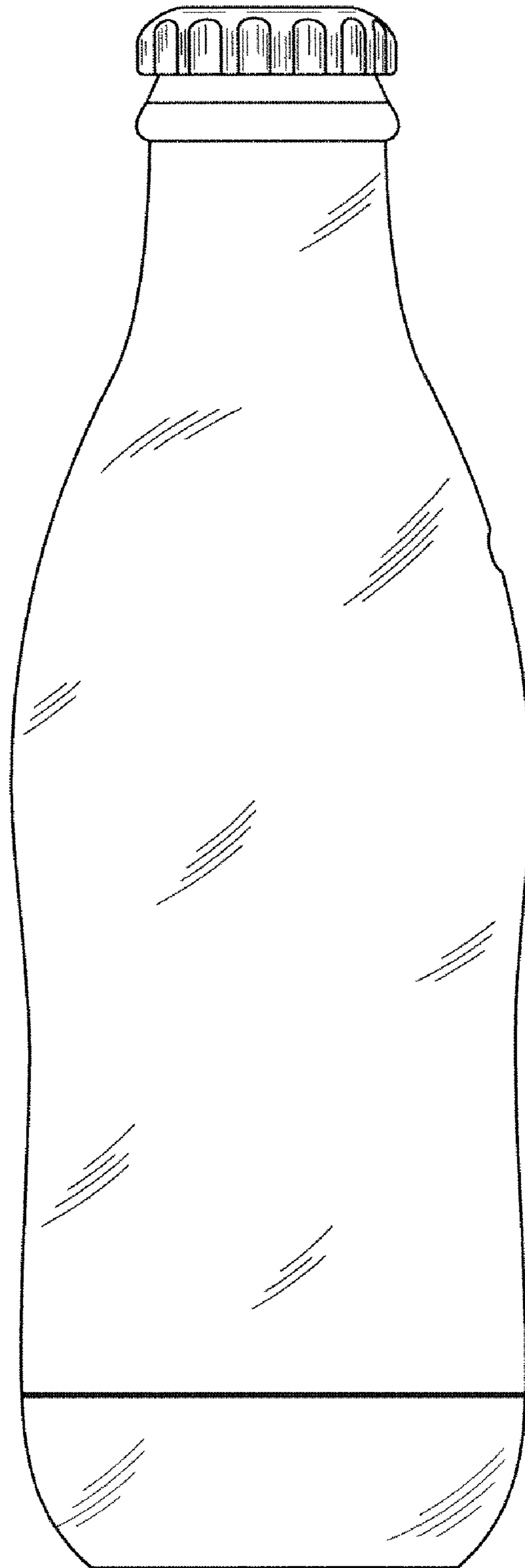

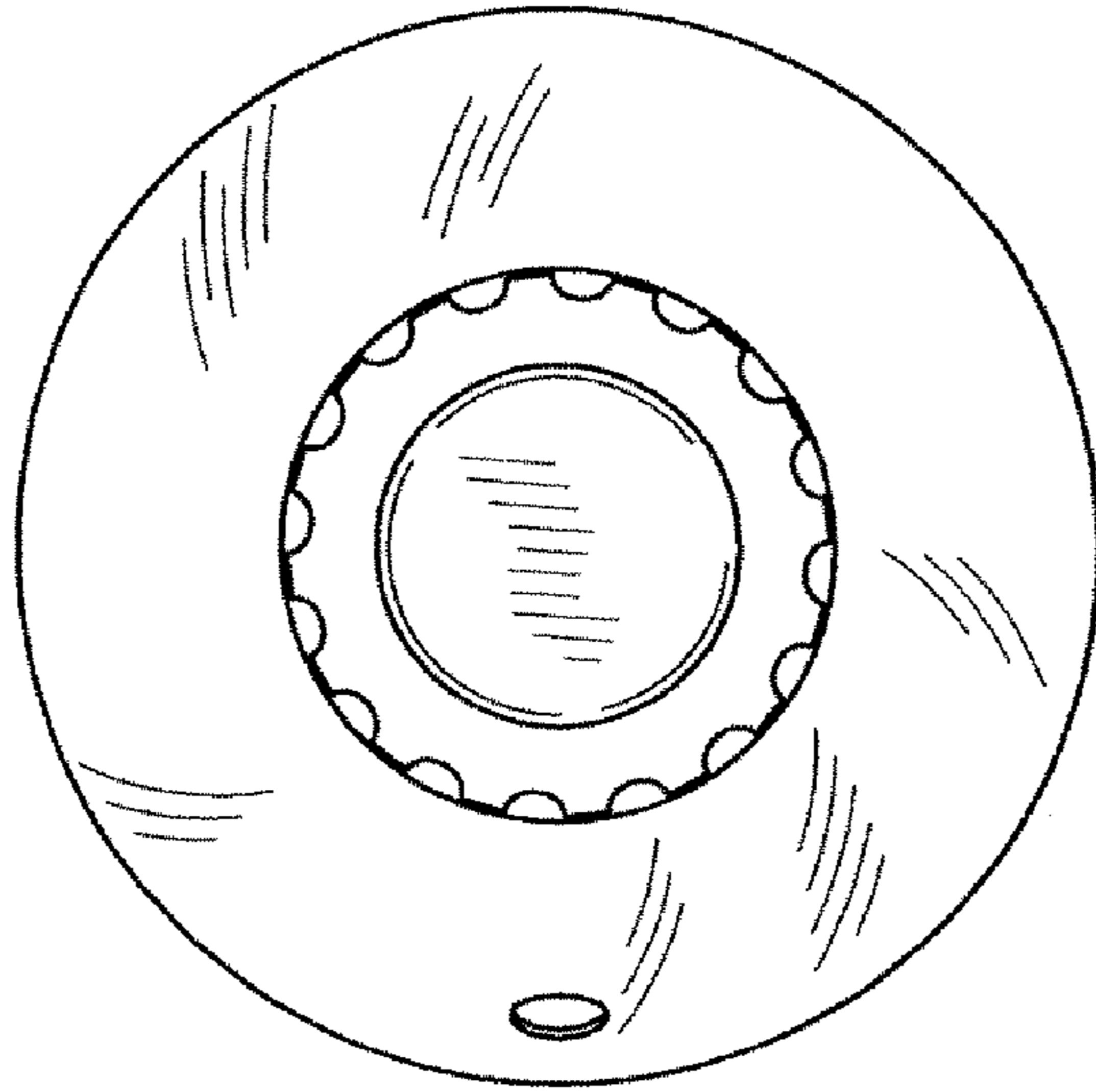

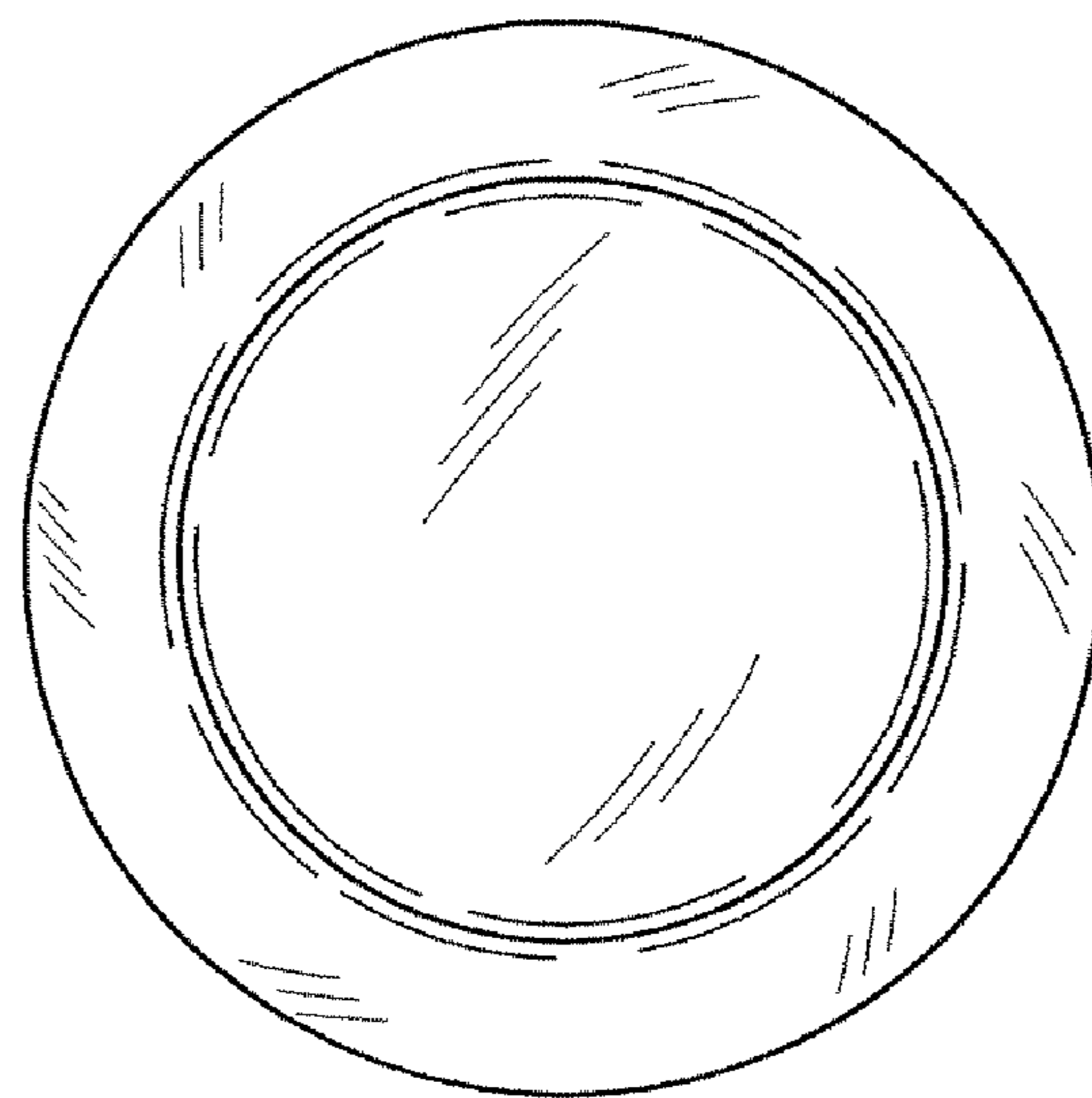

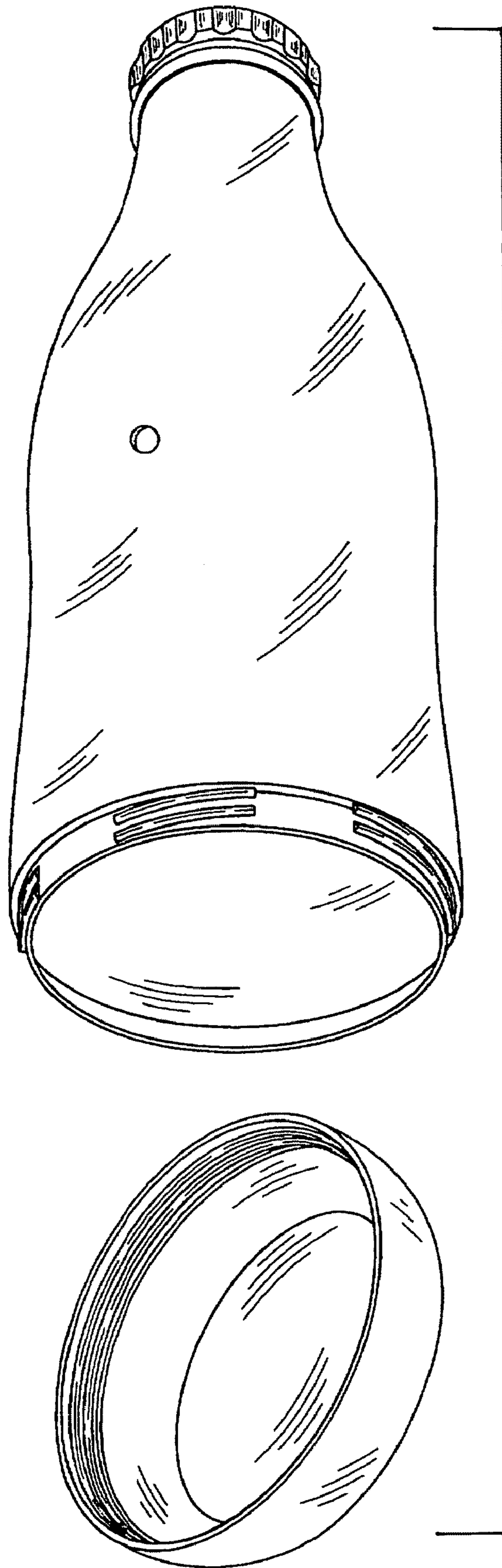
