The ornamental design for a bottle and cap, as shown and described.

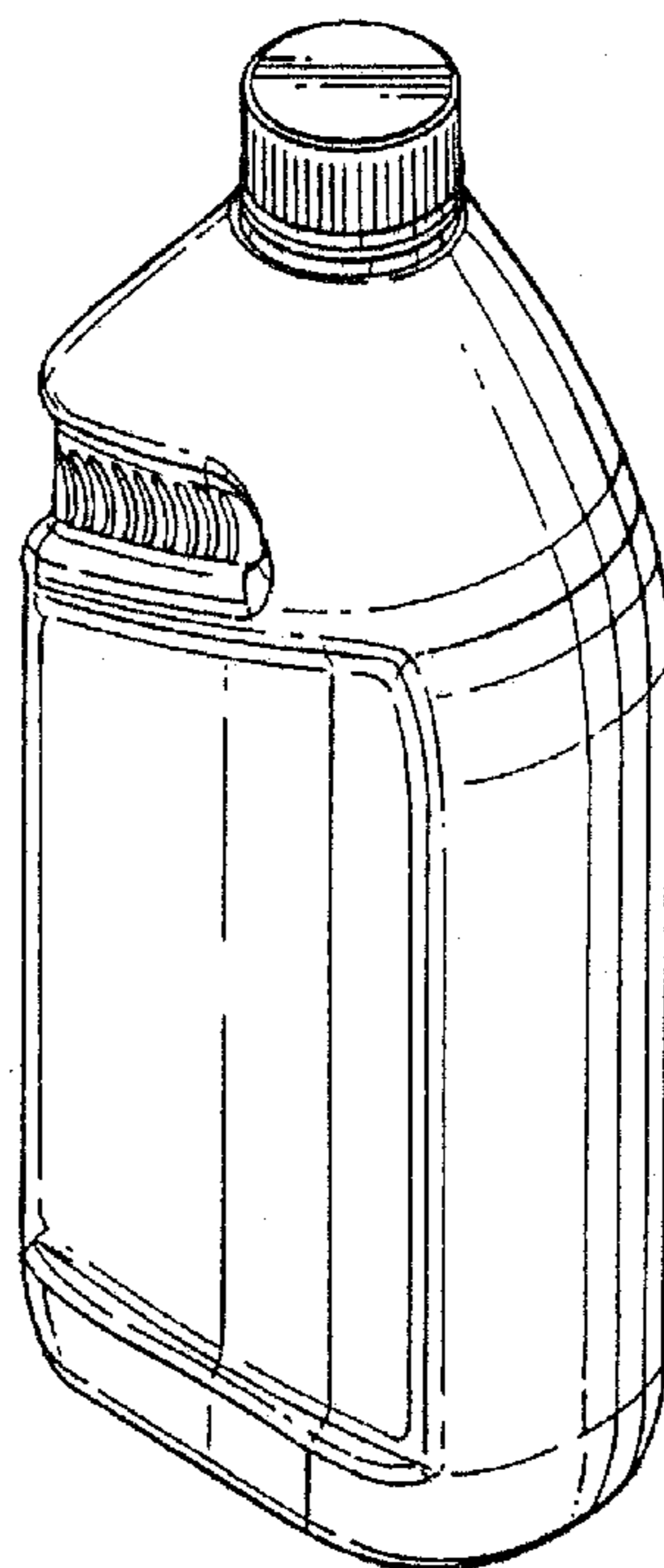
DESCRIPTION

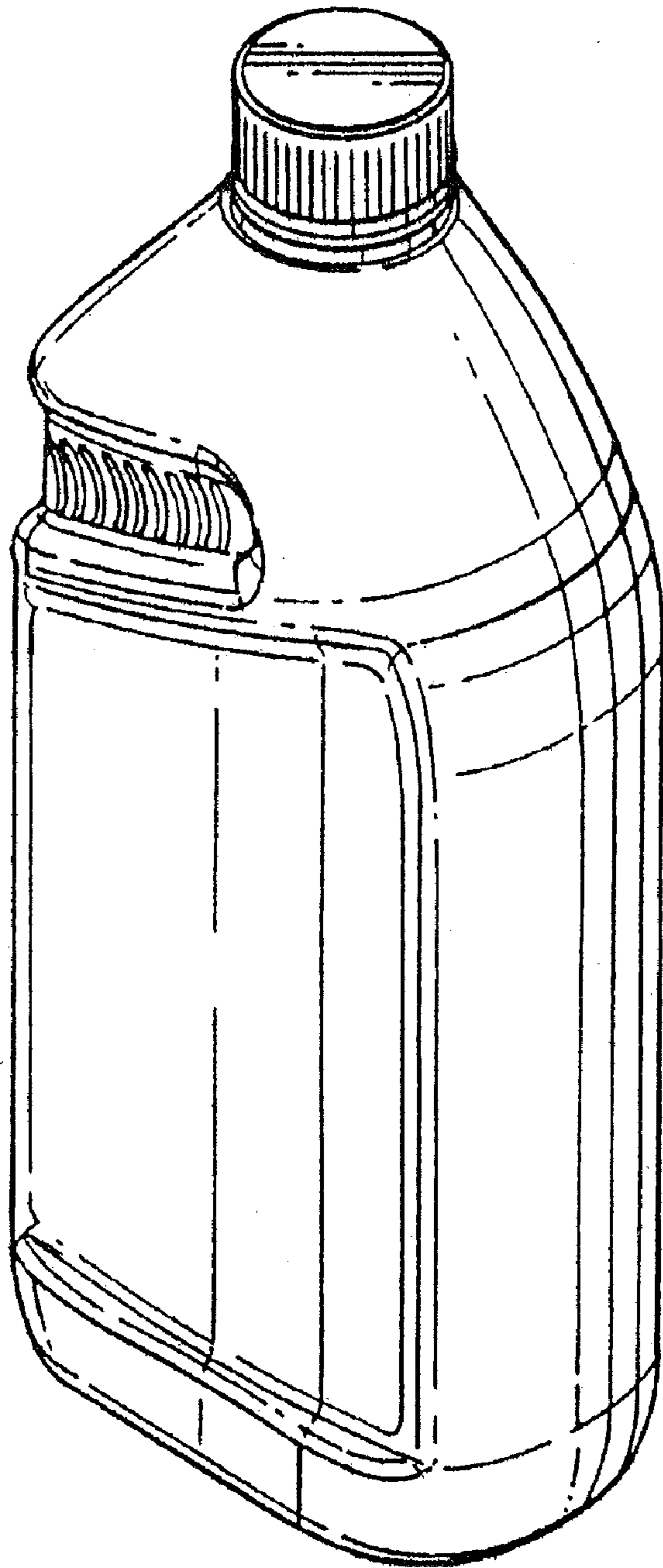

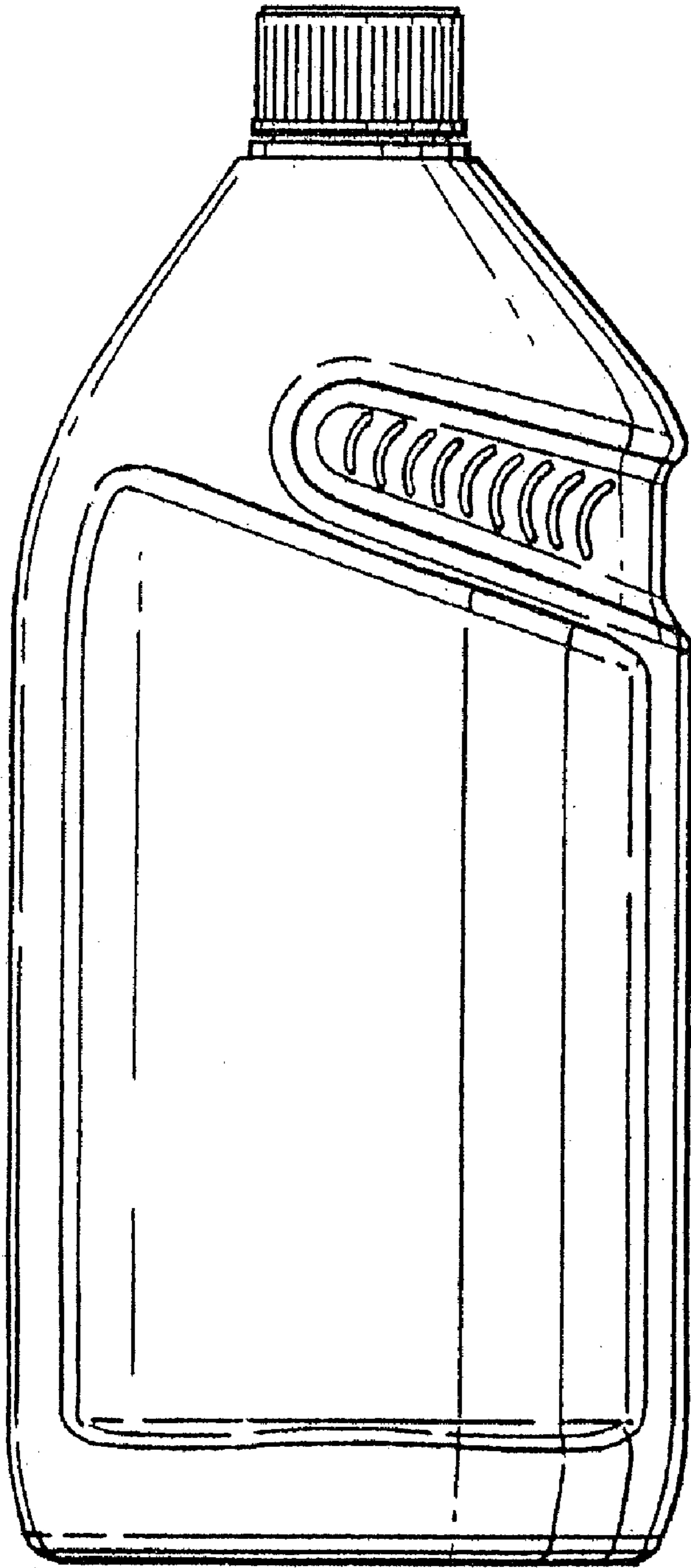

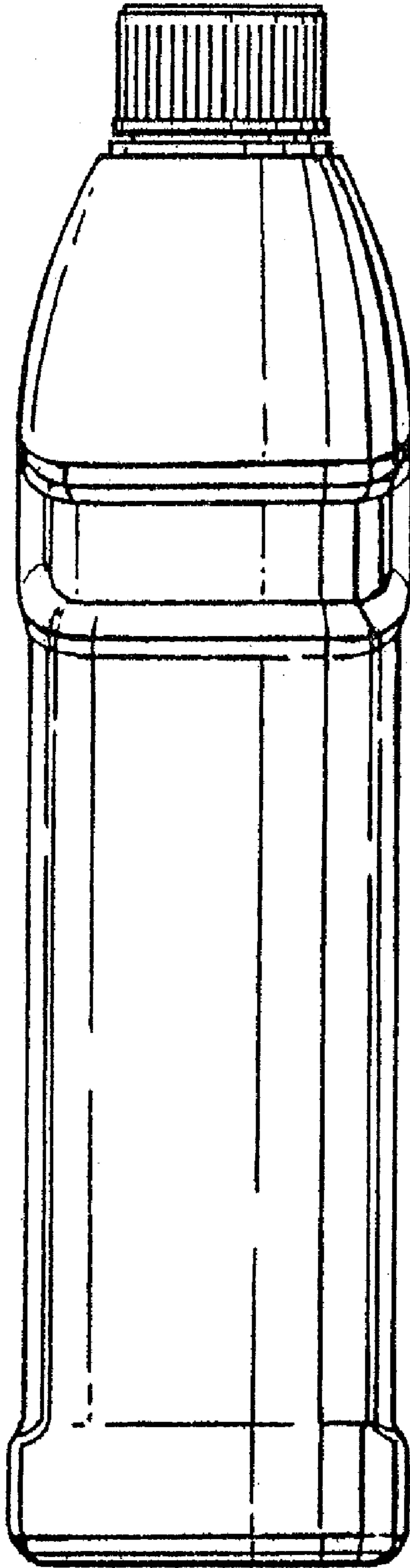
