The ornamental design for storage bottle, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a storage bottle;

FIG. 2 is a side view of the storage bottle rotated 45 degrees from FIG. 1;

FIG. 3 is a side view of the storage bottle rotated 45 degrees from FIG. 2;

FIG. 4 is a side view of the storage bottle rotated 45 degrees from FIG. 3;

FIG. 5 is a side view of the storage bottle rotated 45 degrees from FIG. 4;

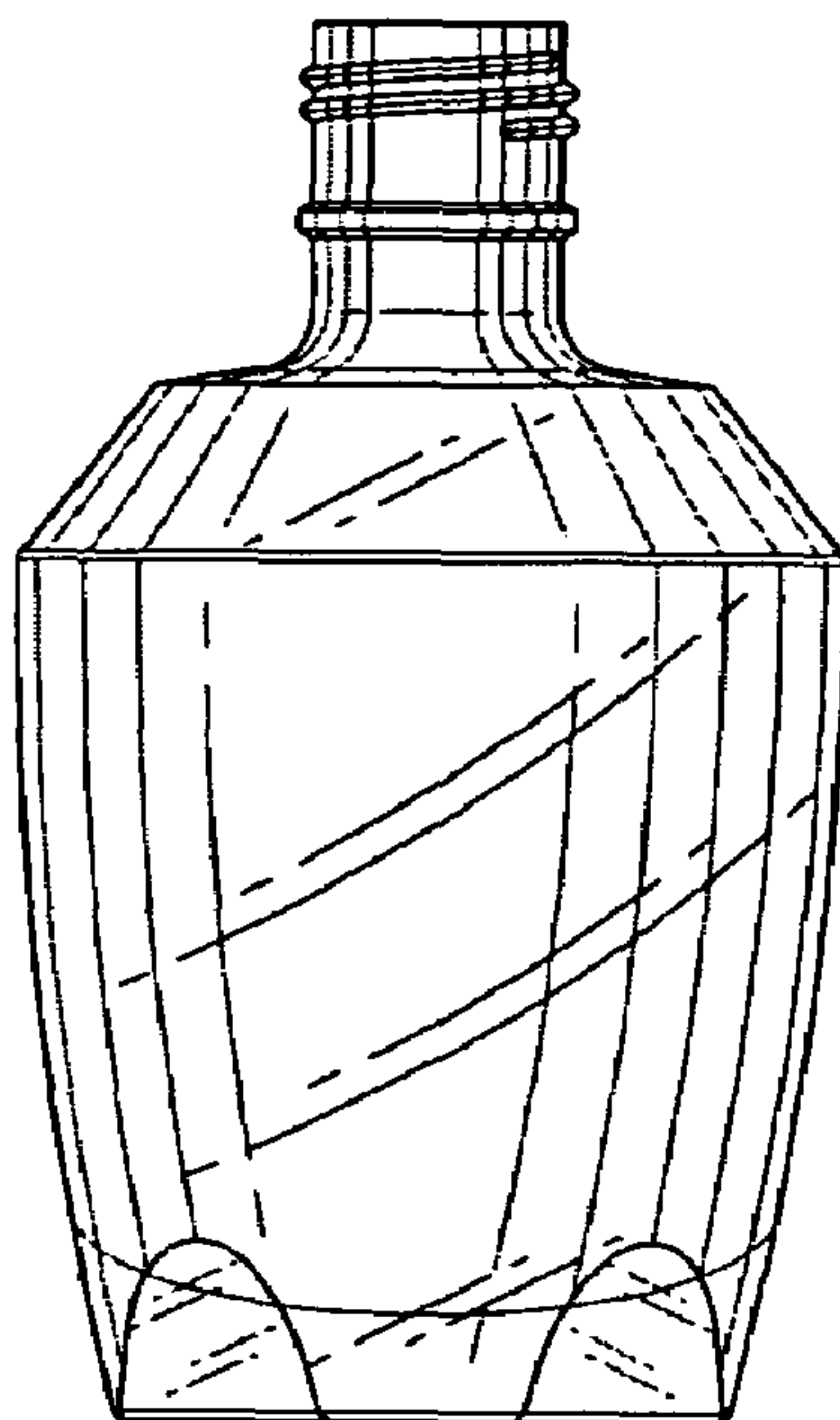
FIG. 6 is a side view of the storage bottle rotated 45 degrees from FIG. 5;

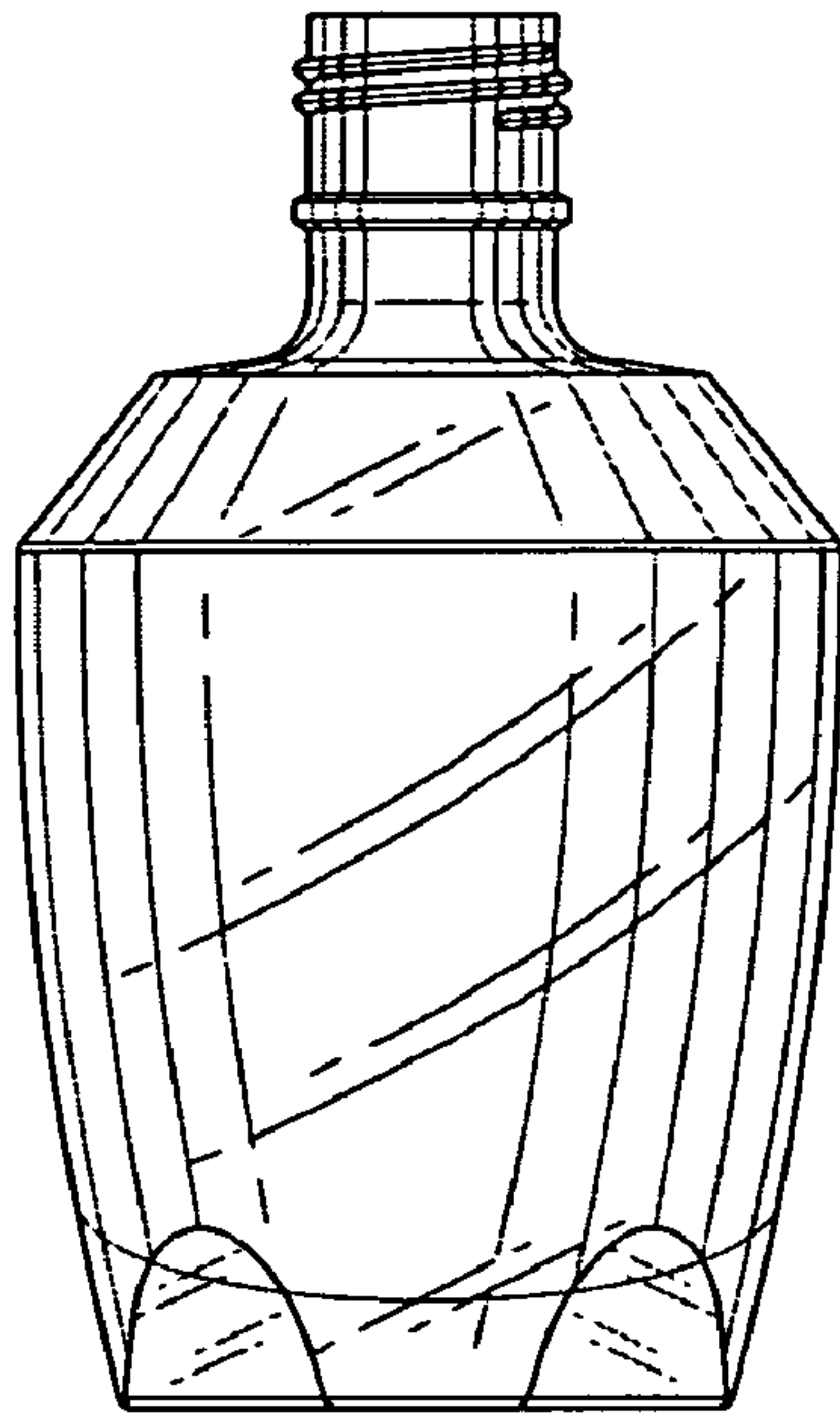

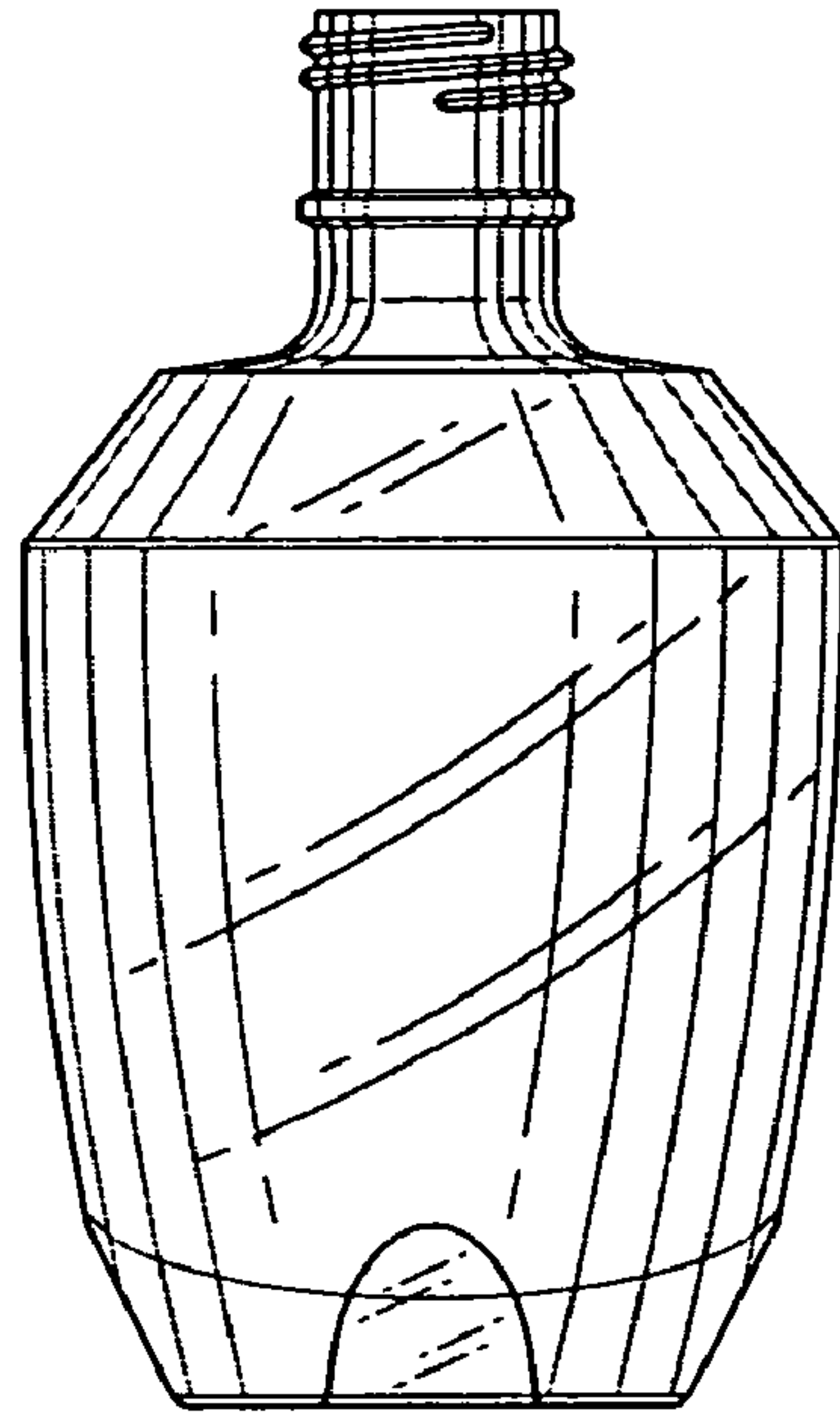

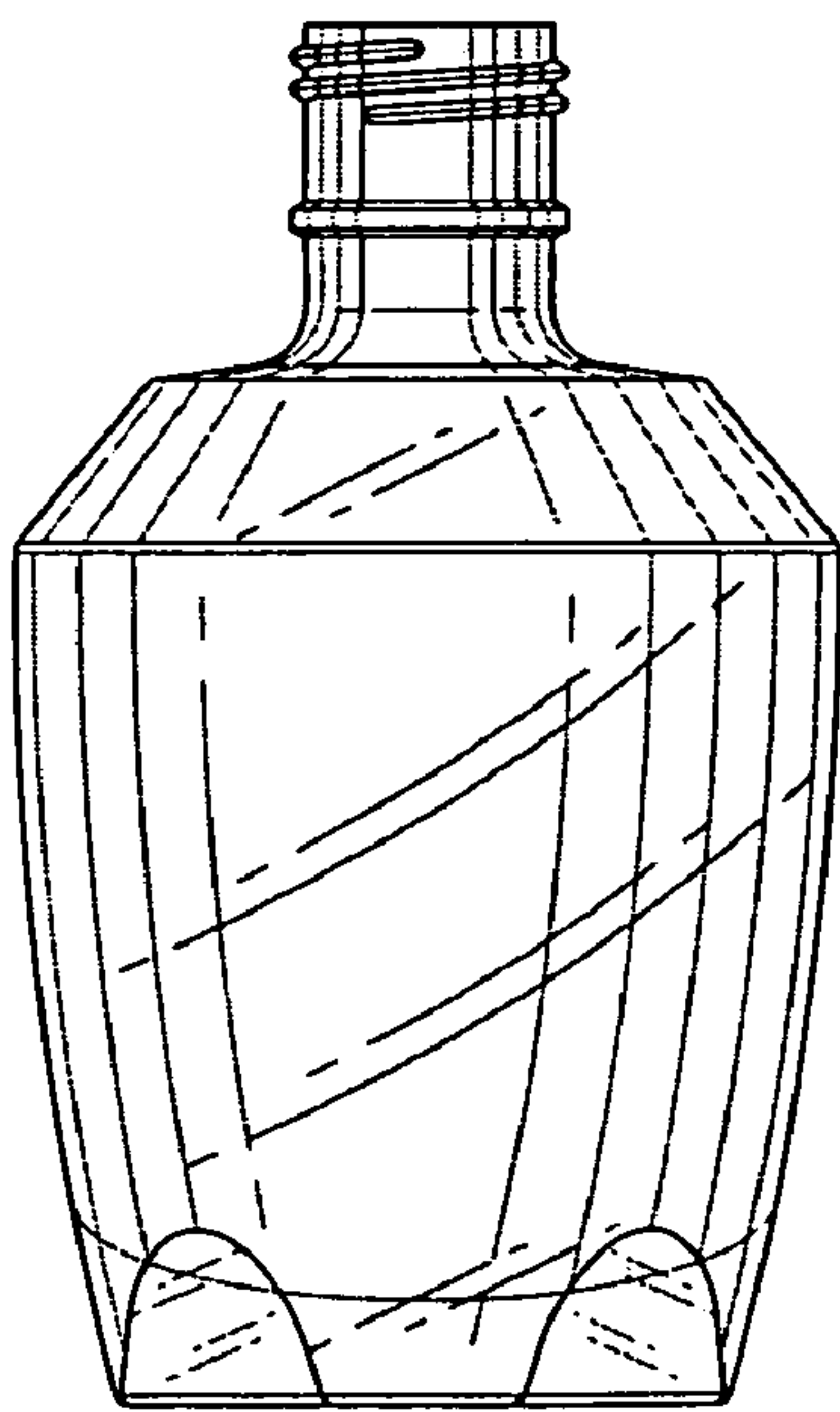

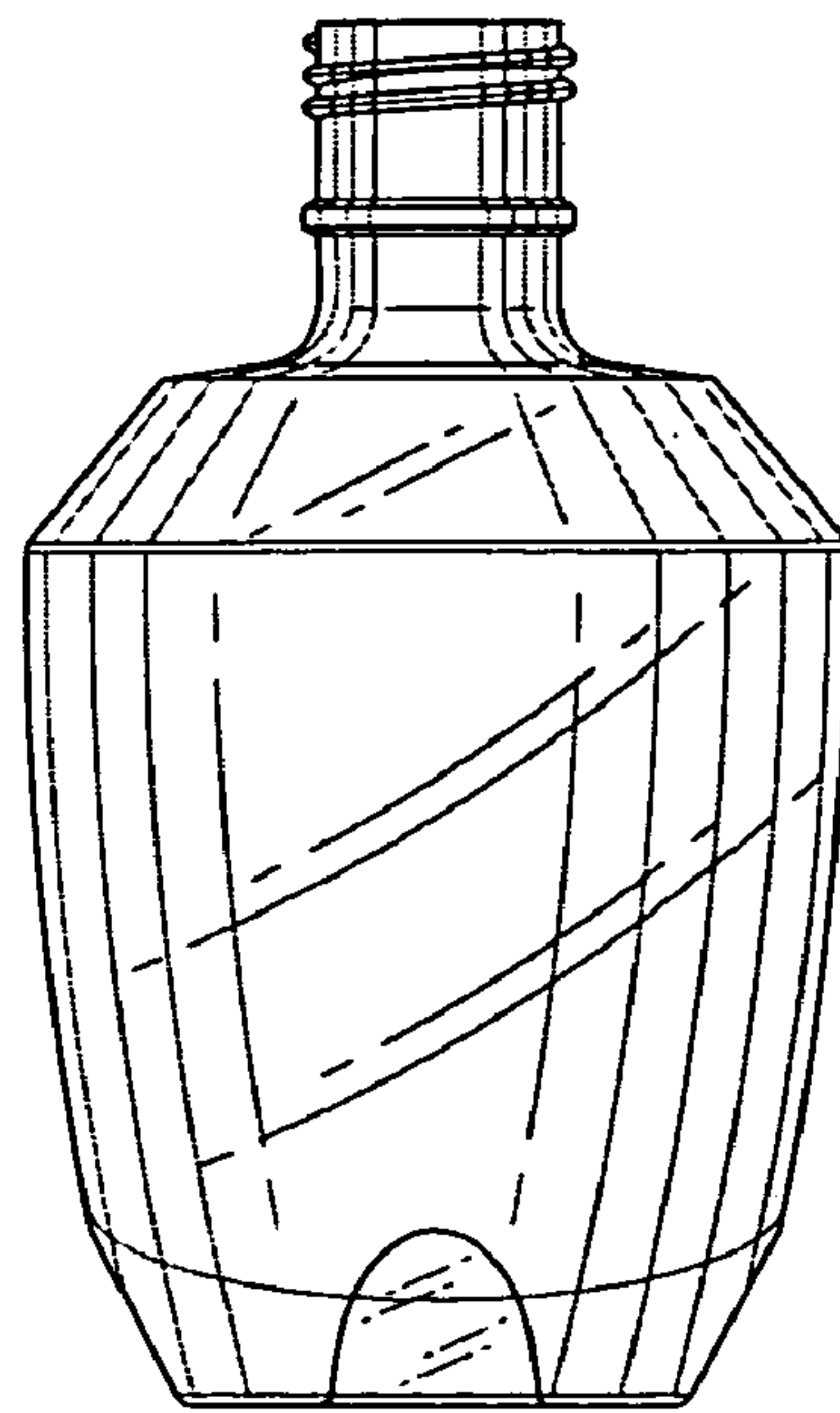

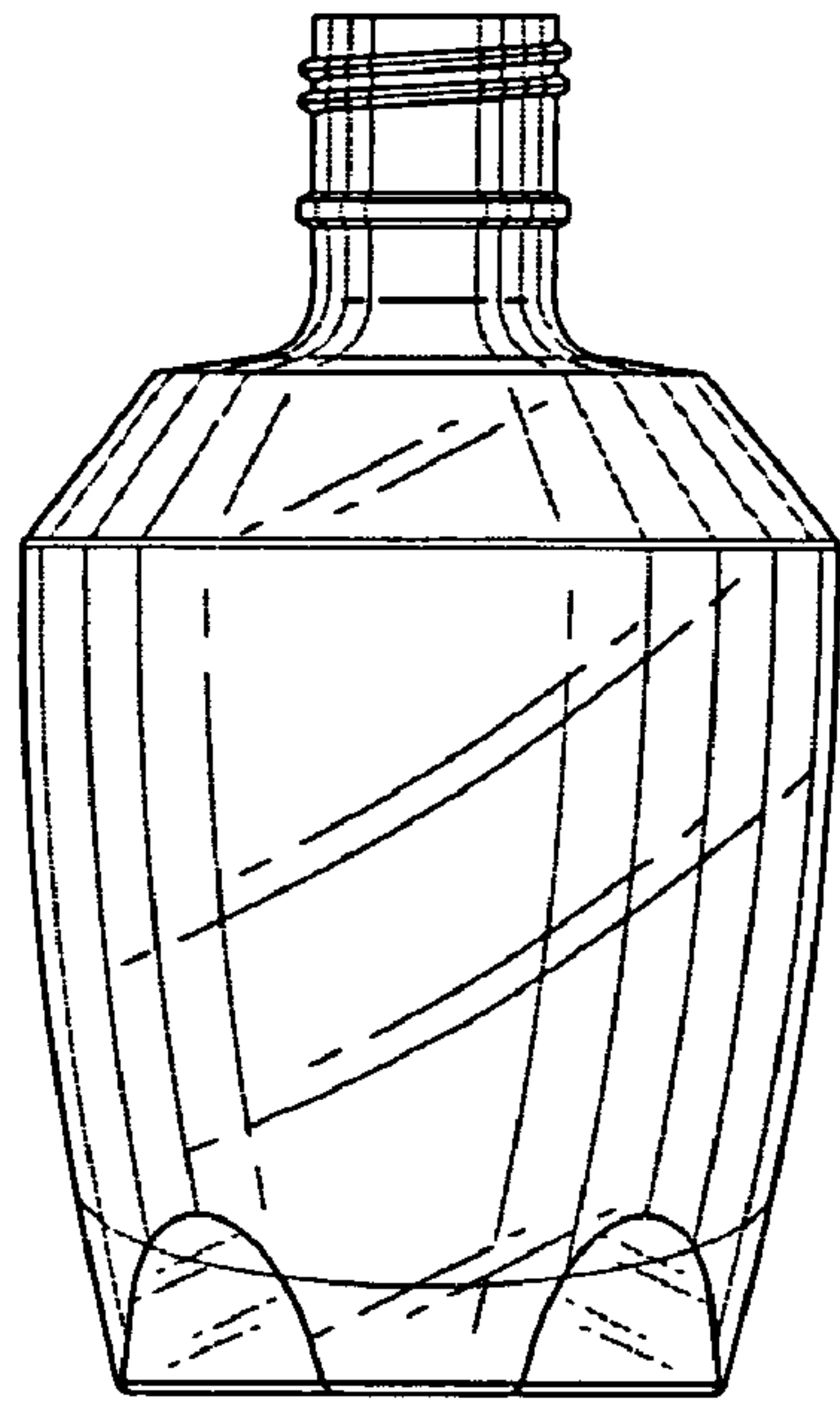

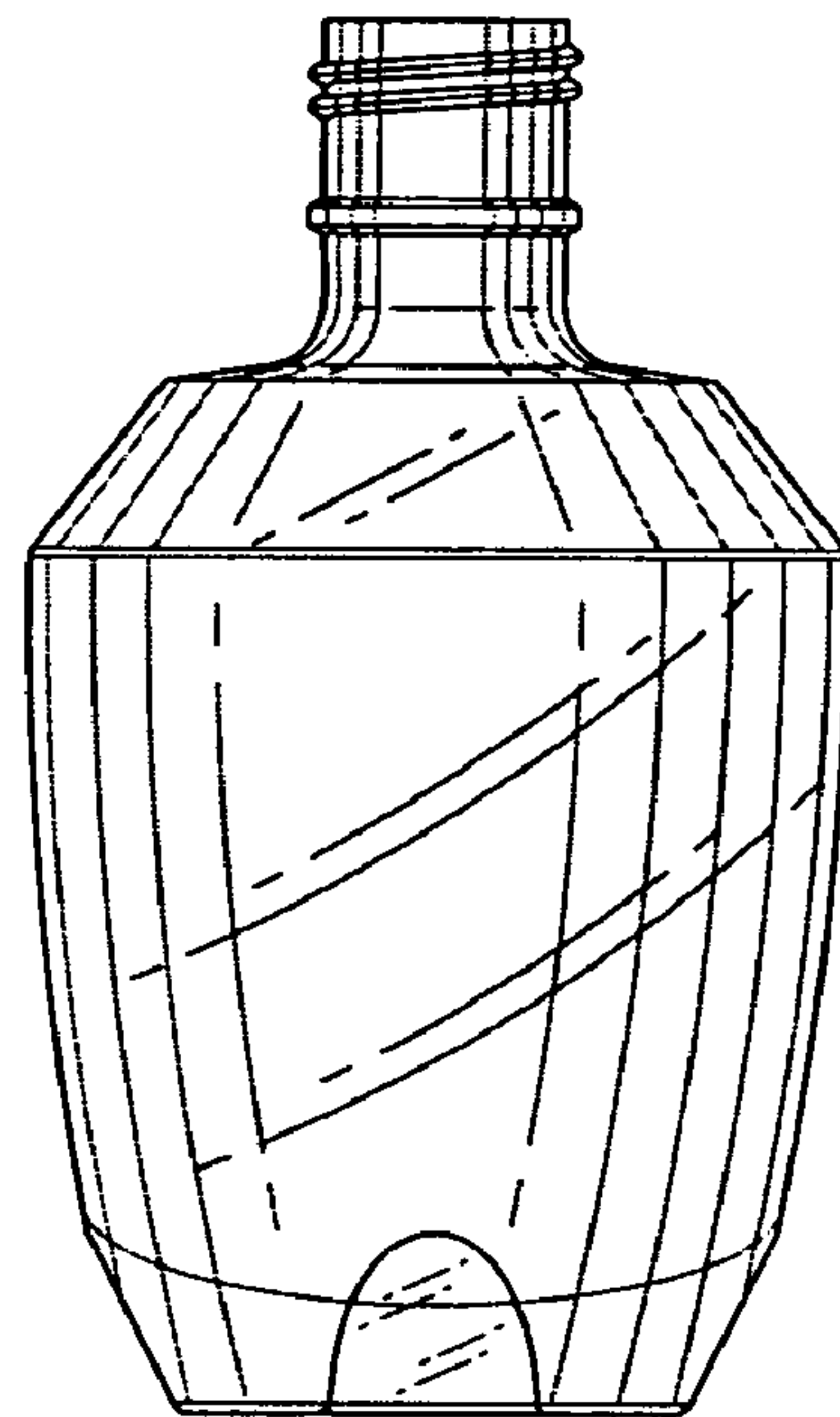

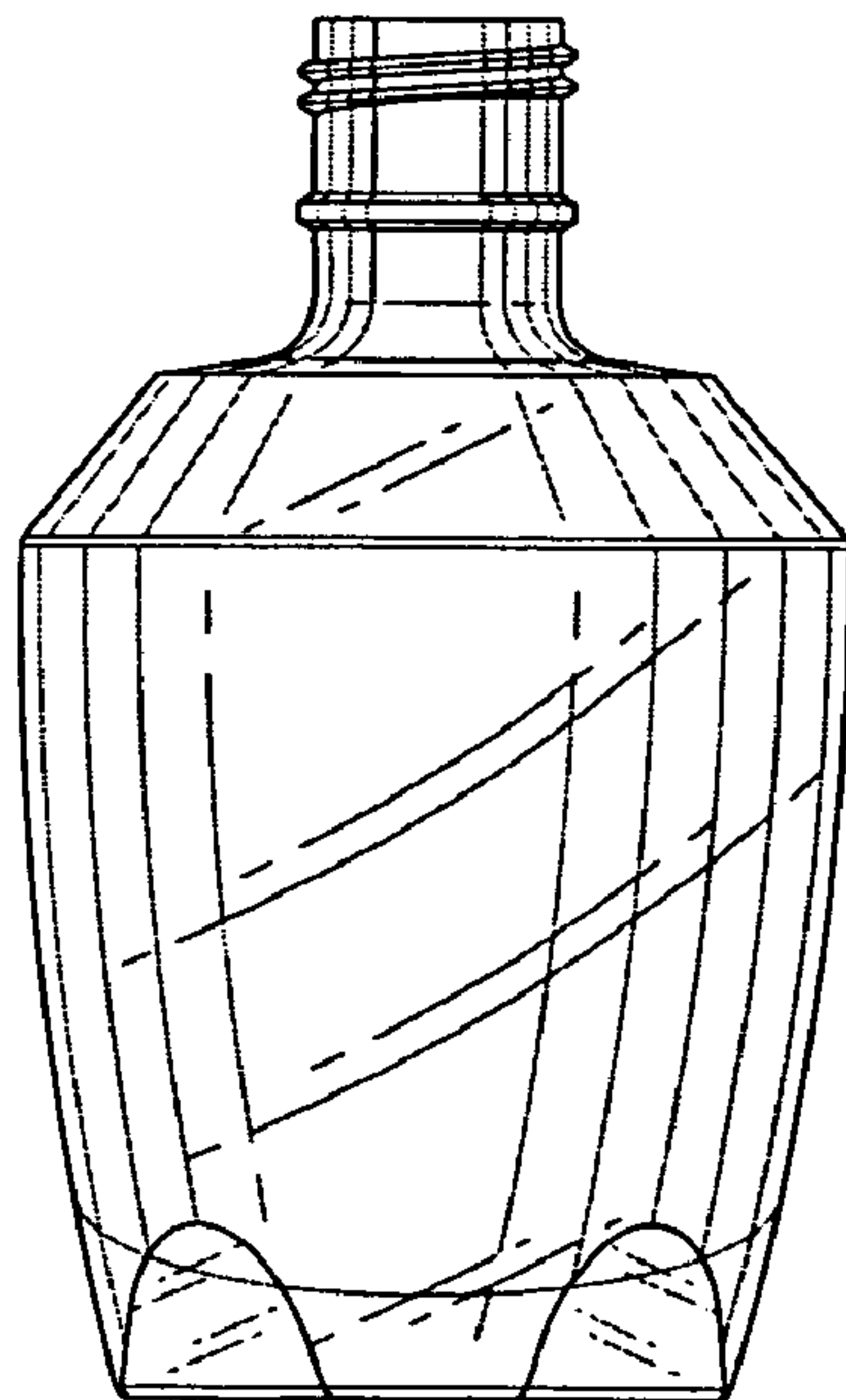

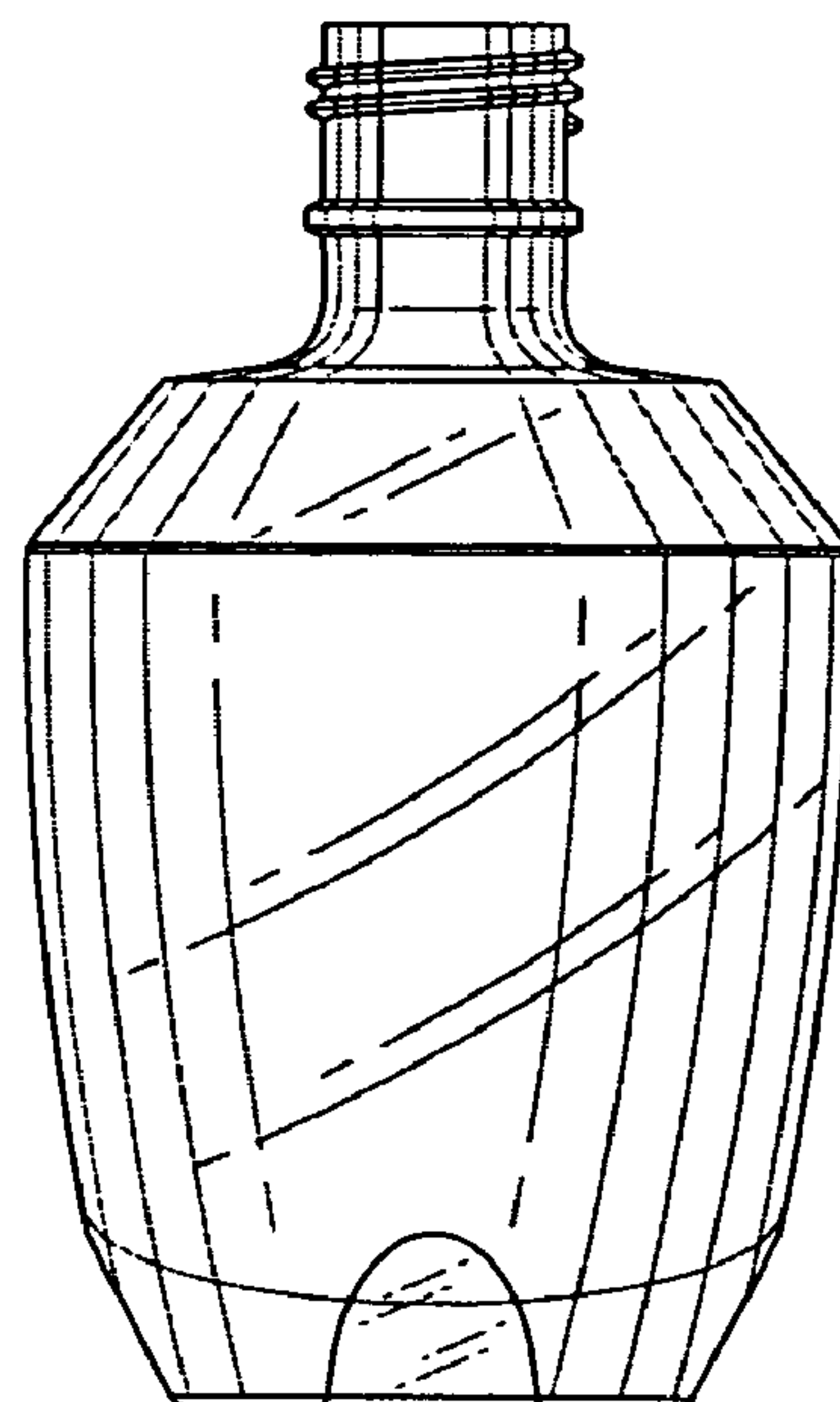

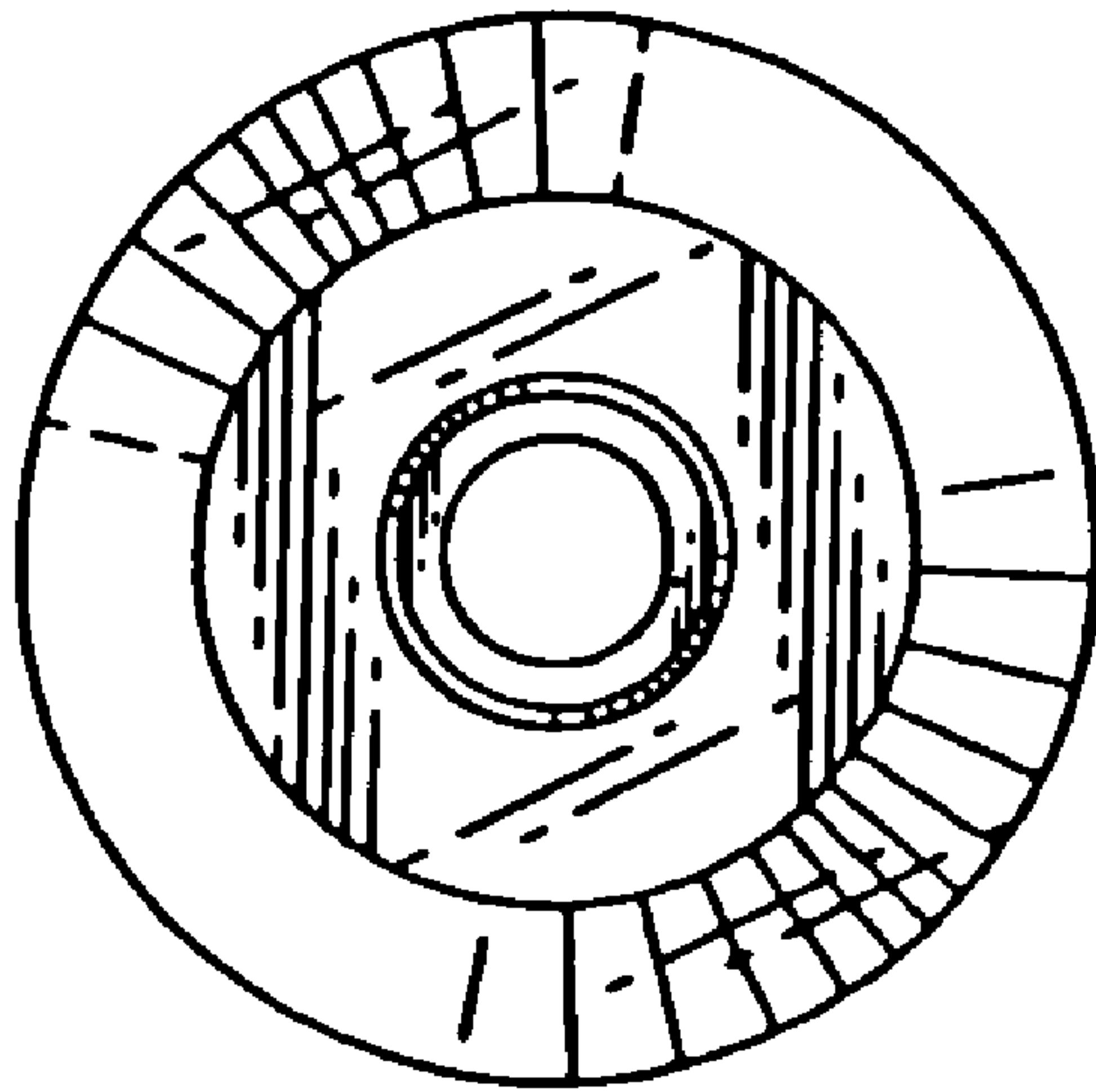
