**DESCRIPTION**

FIG. 15 is a top plan view thereof;

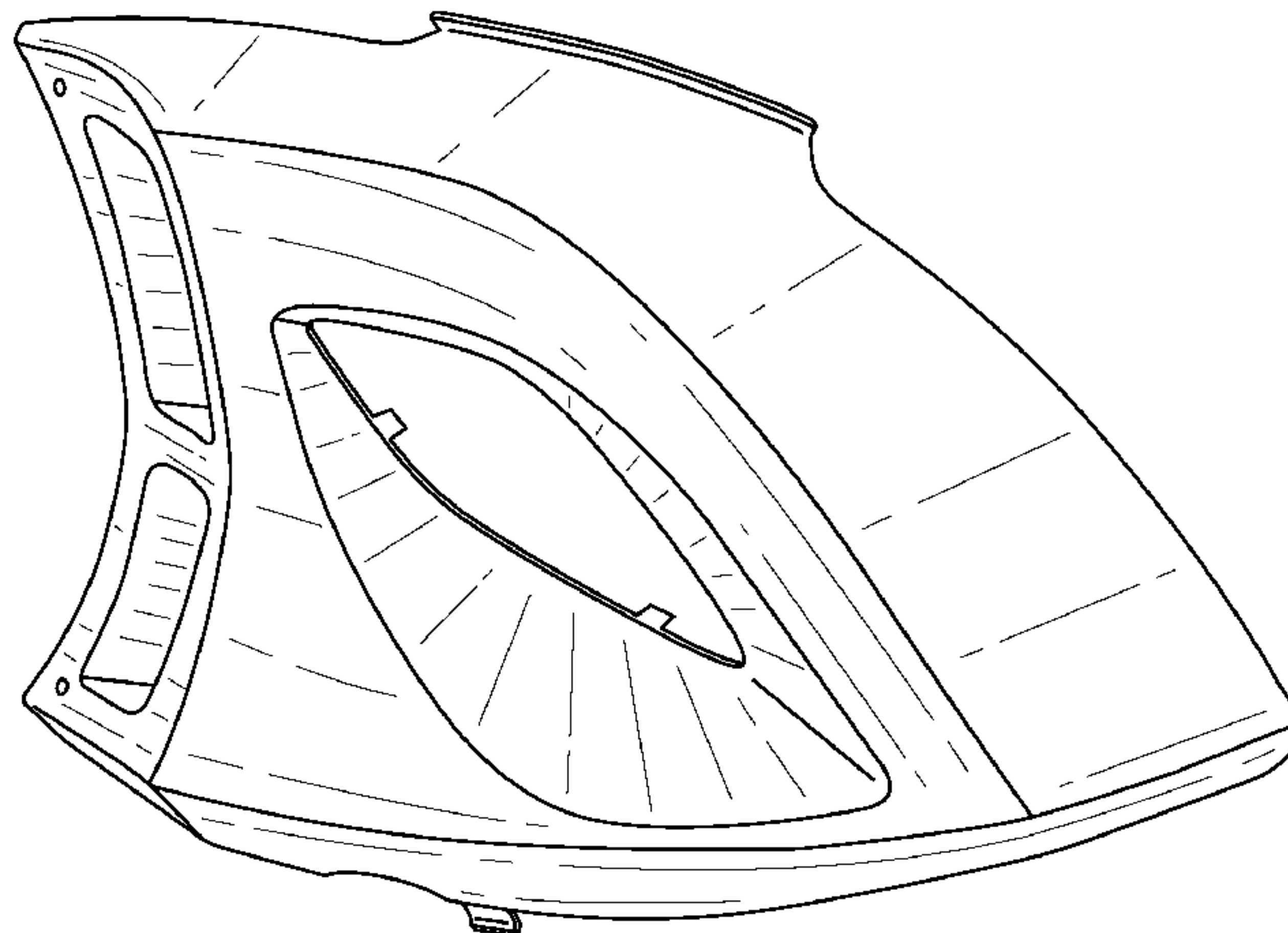
FIG. 16 is a bottom plan view thereof;

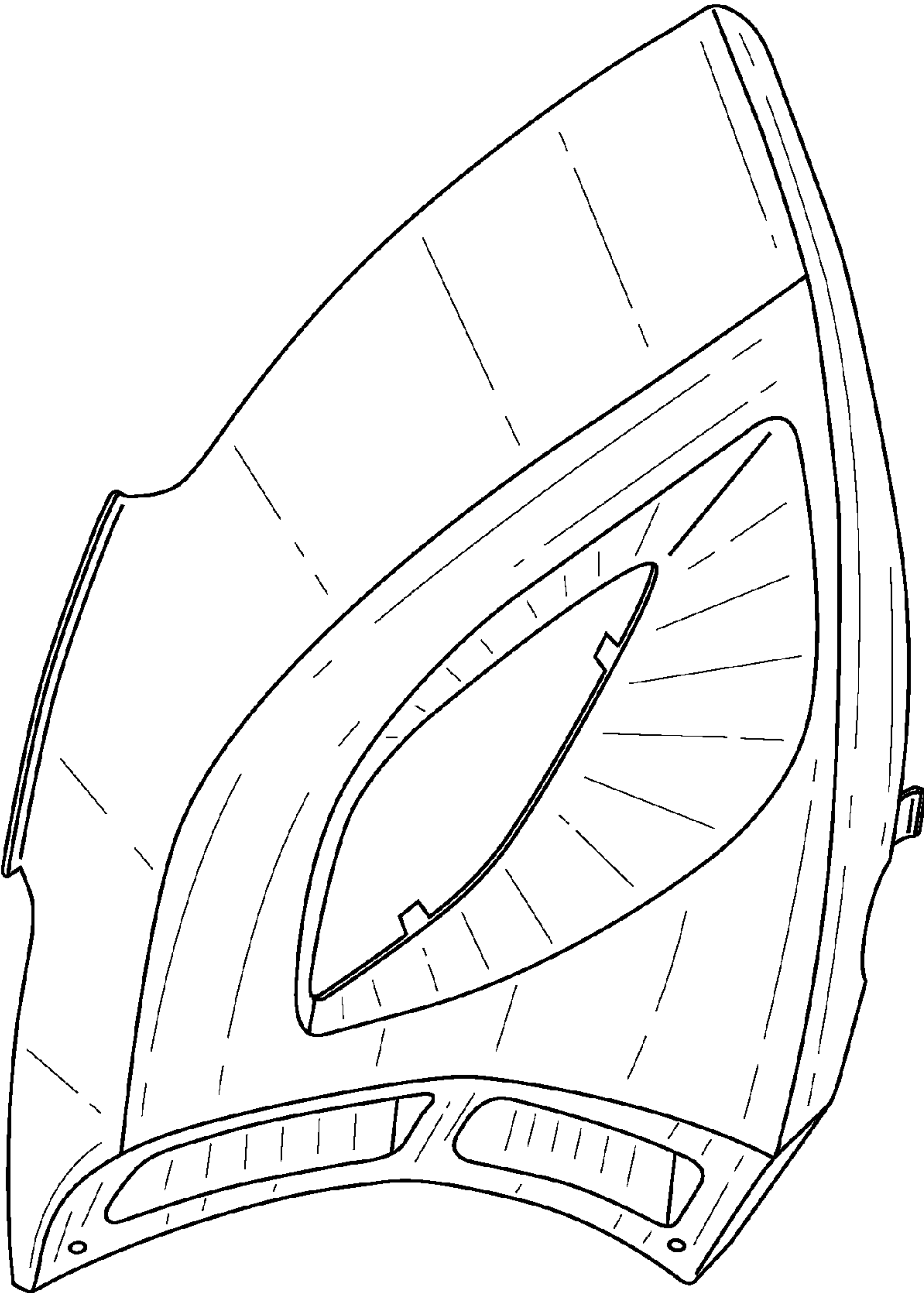

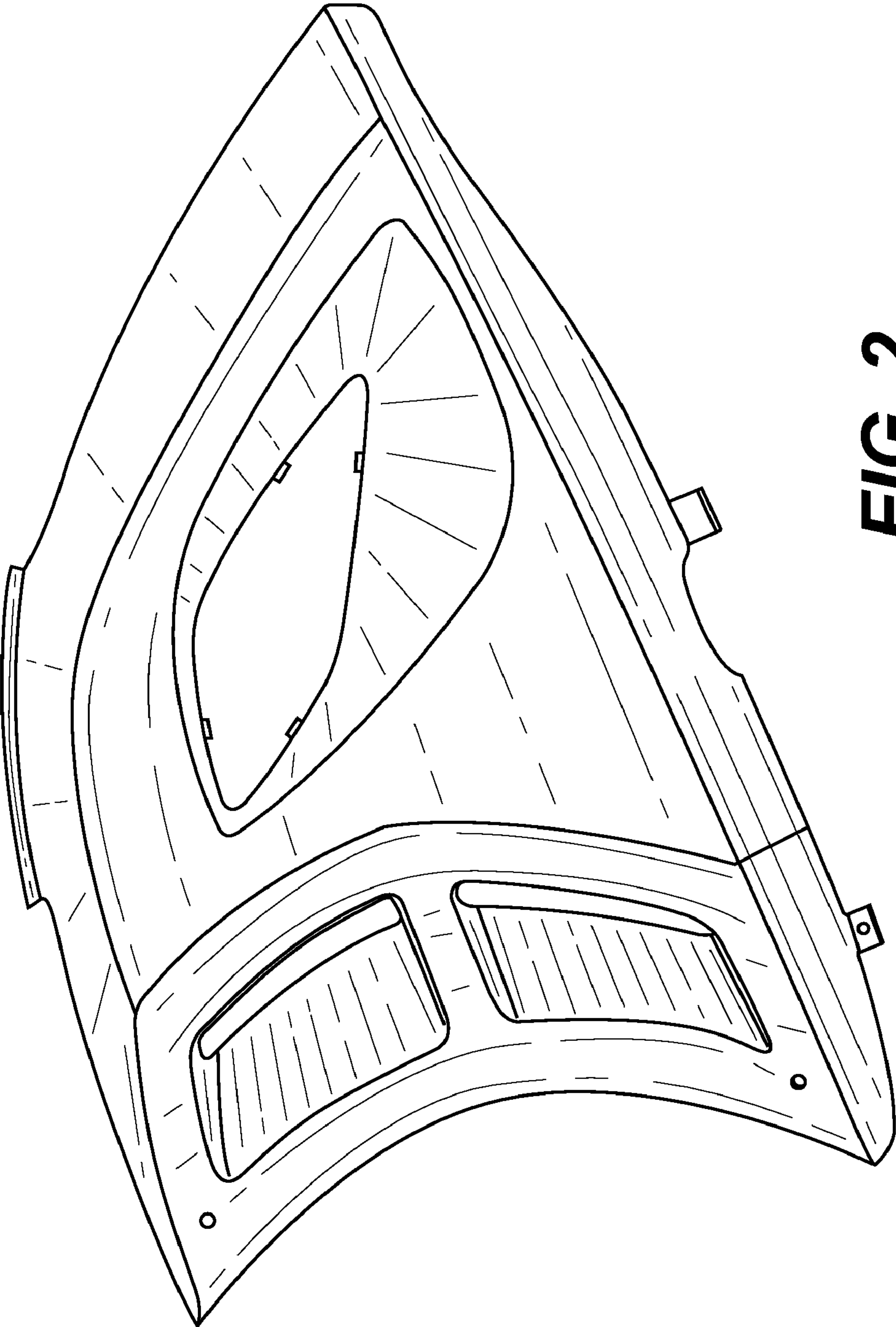
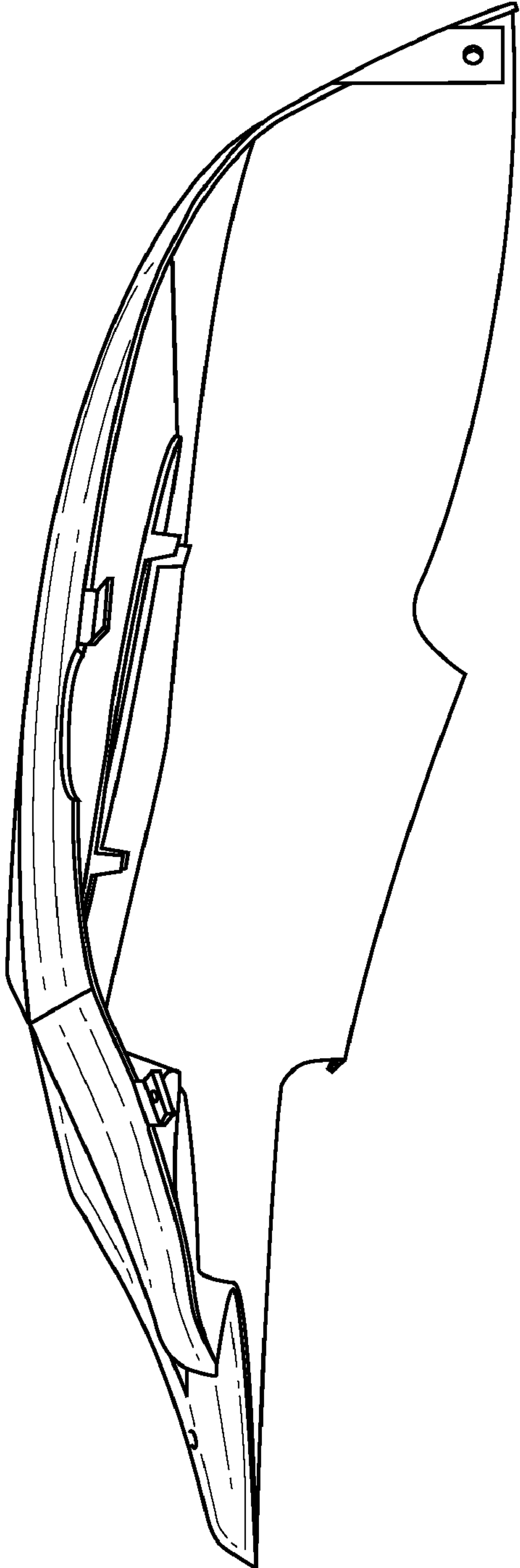

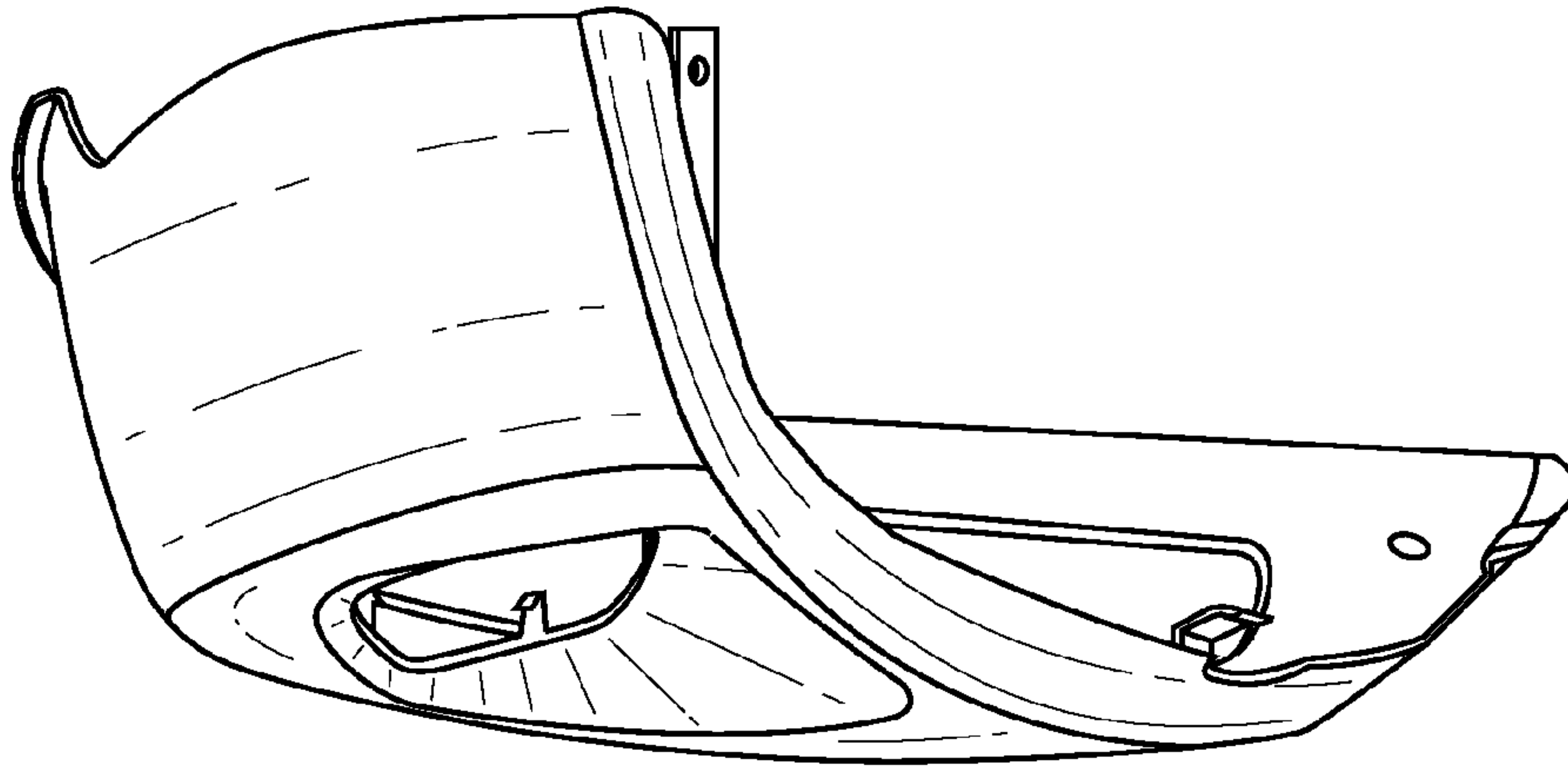

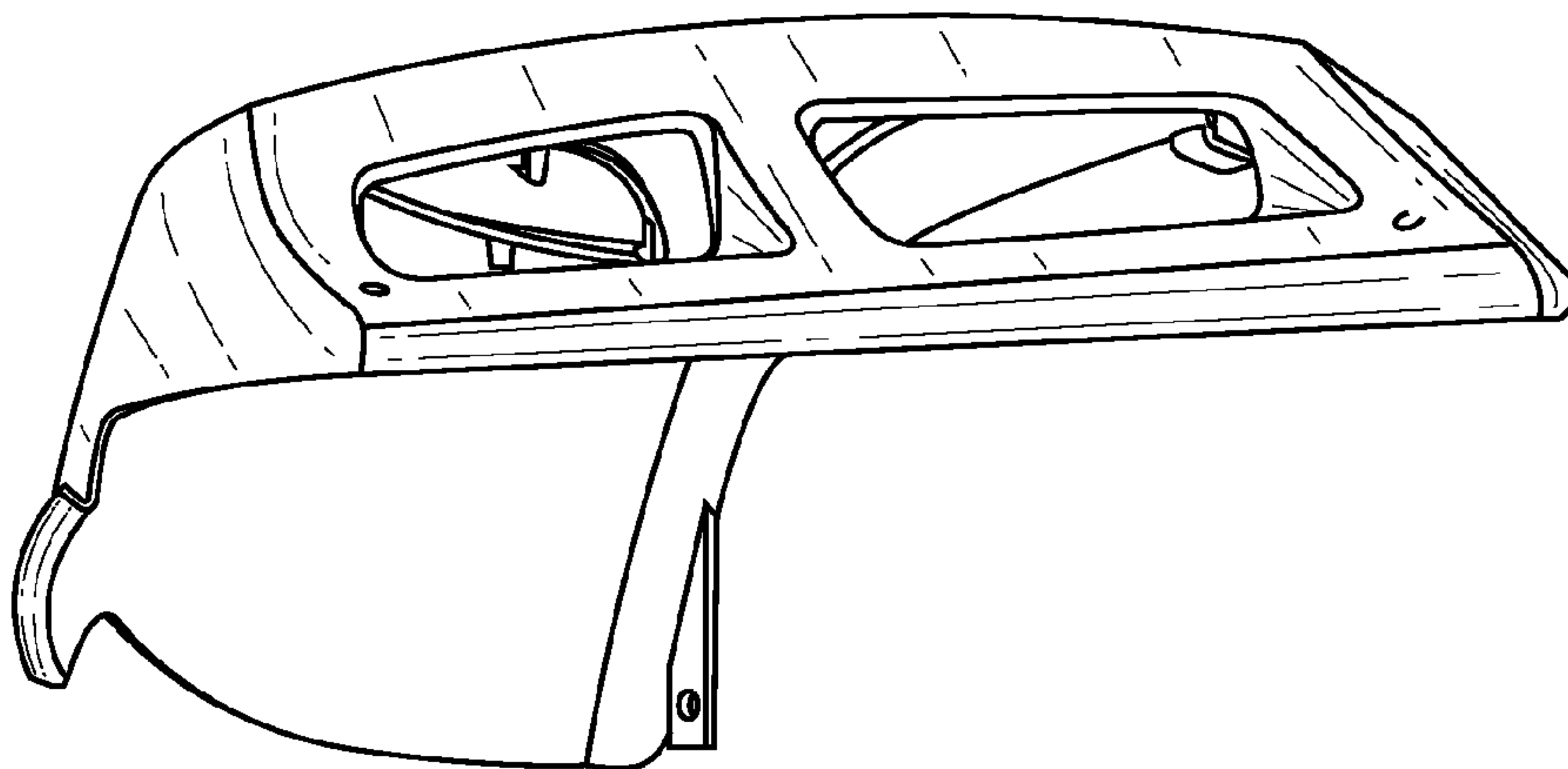




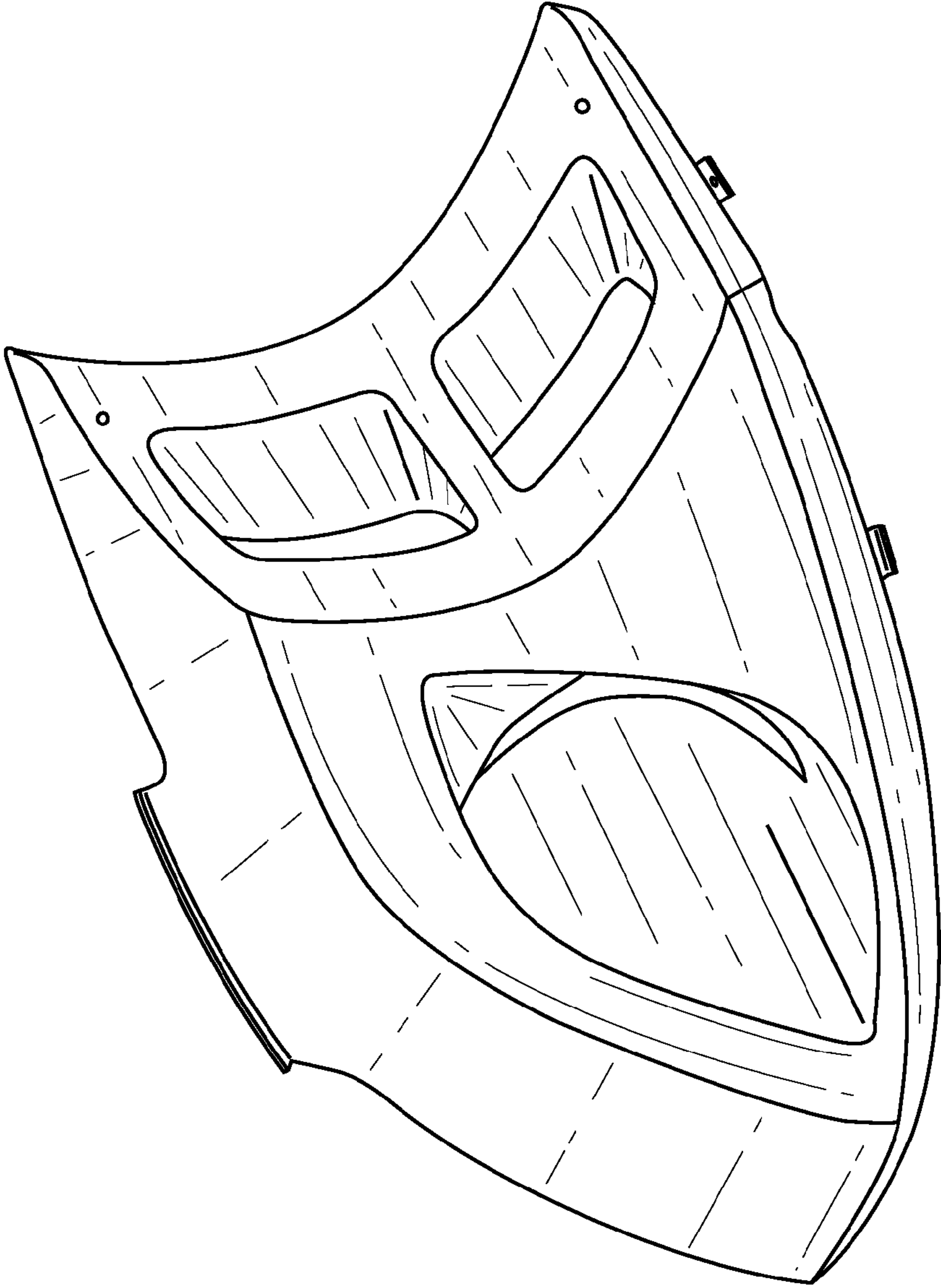

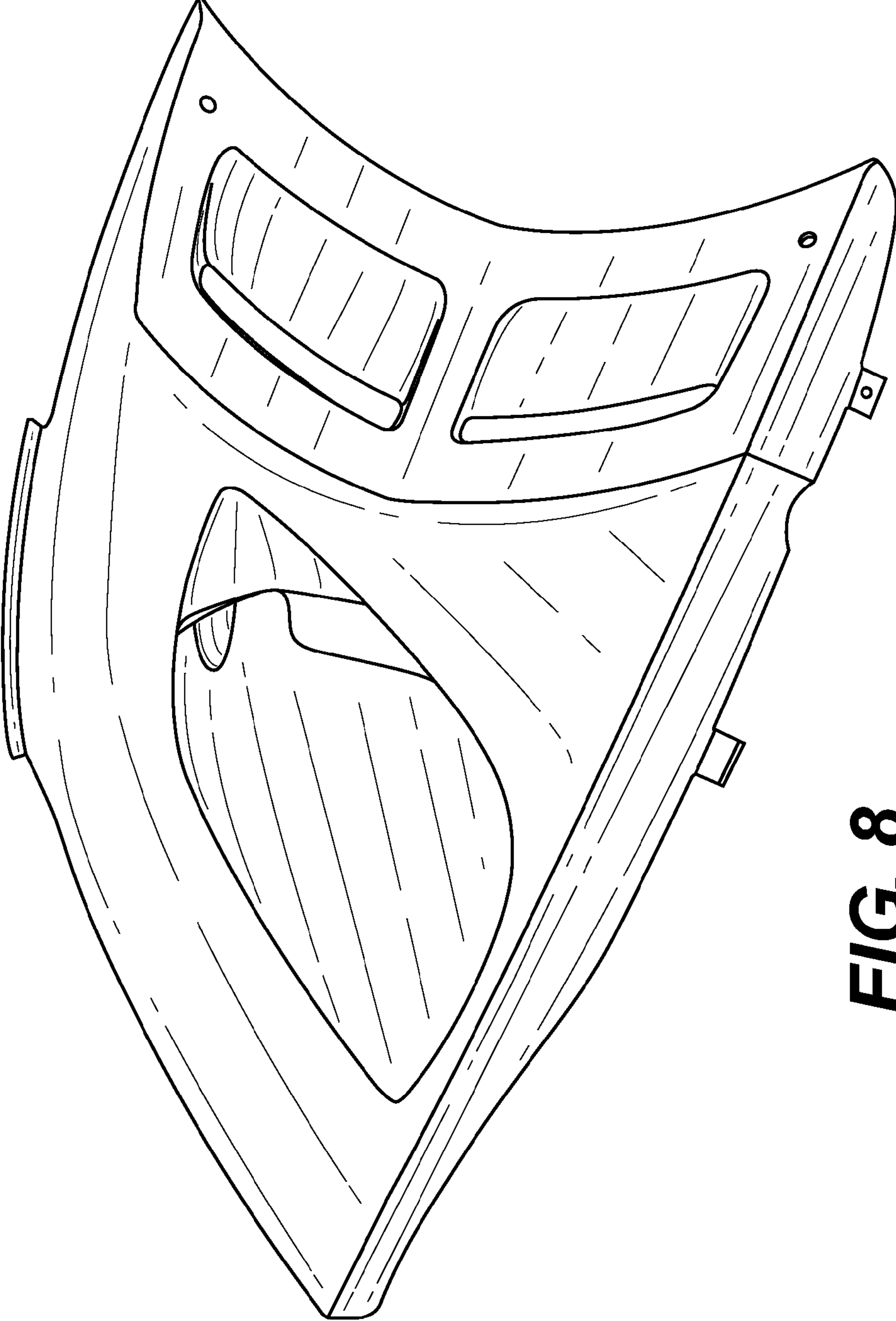

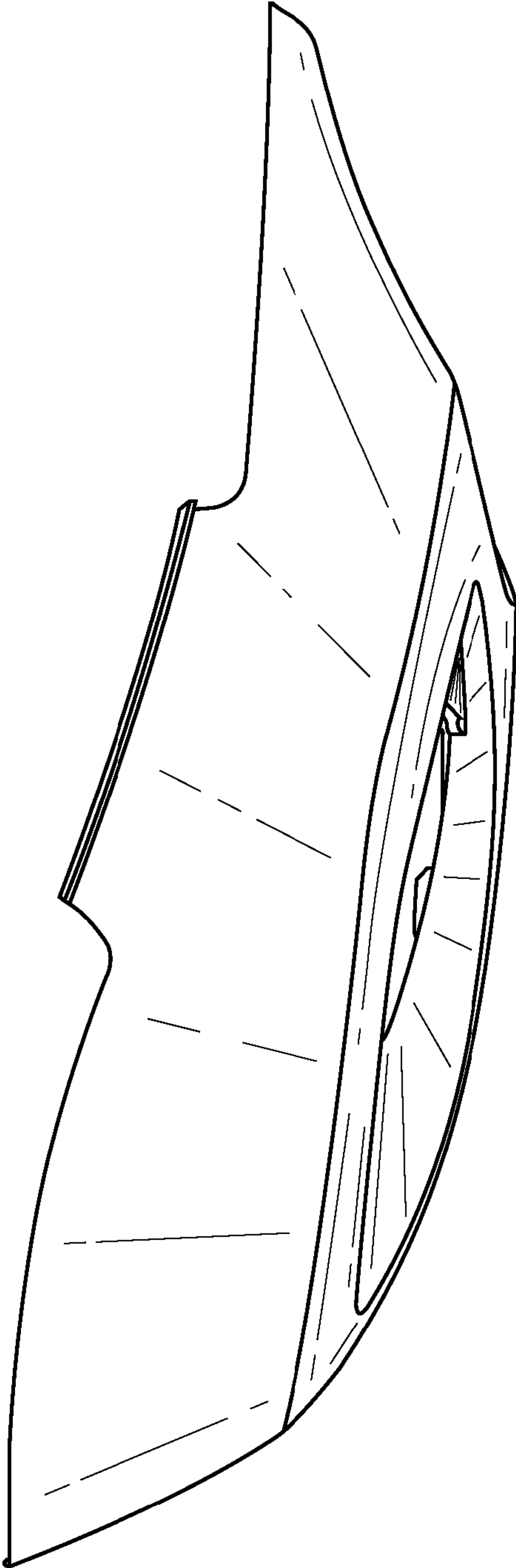

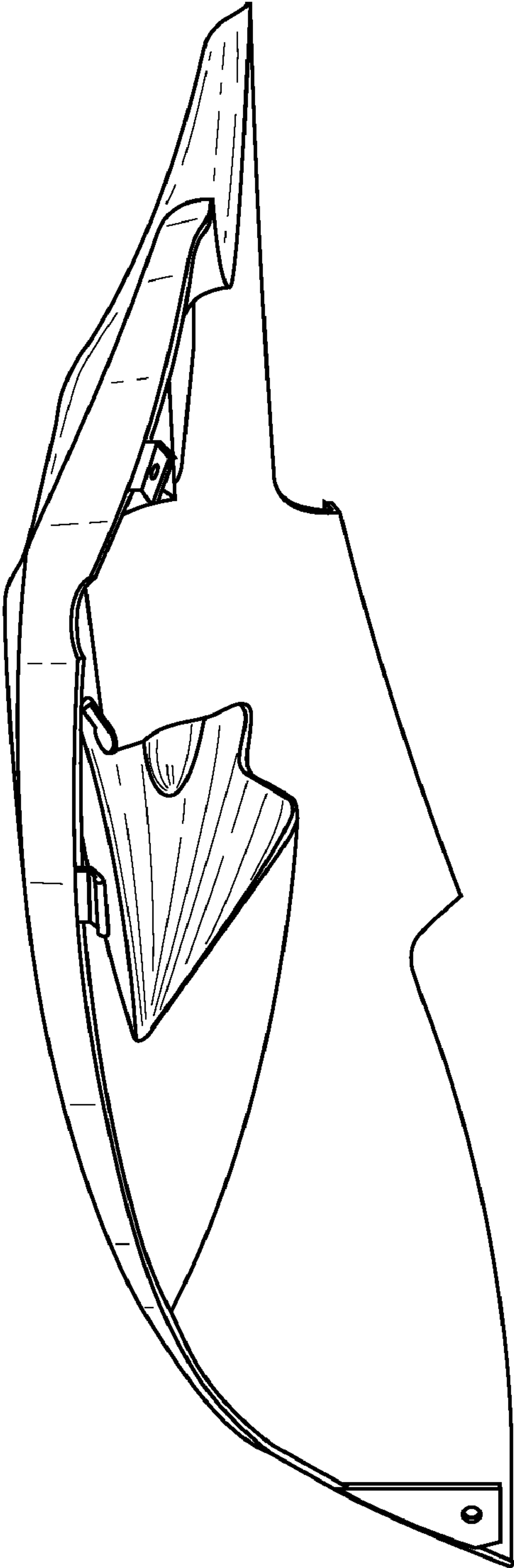




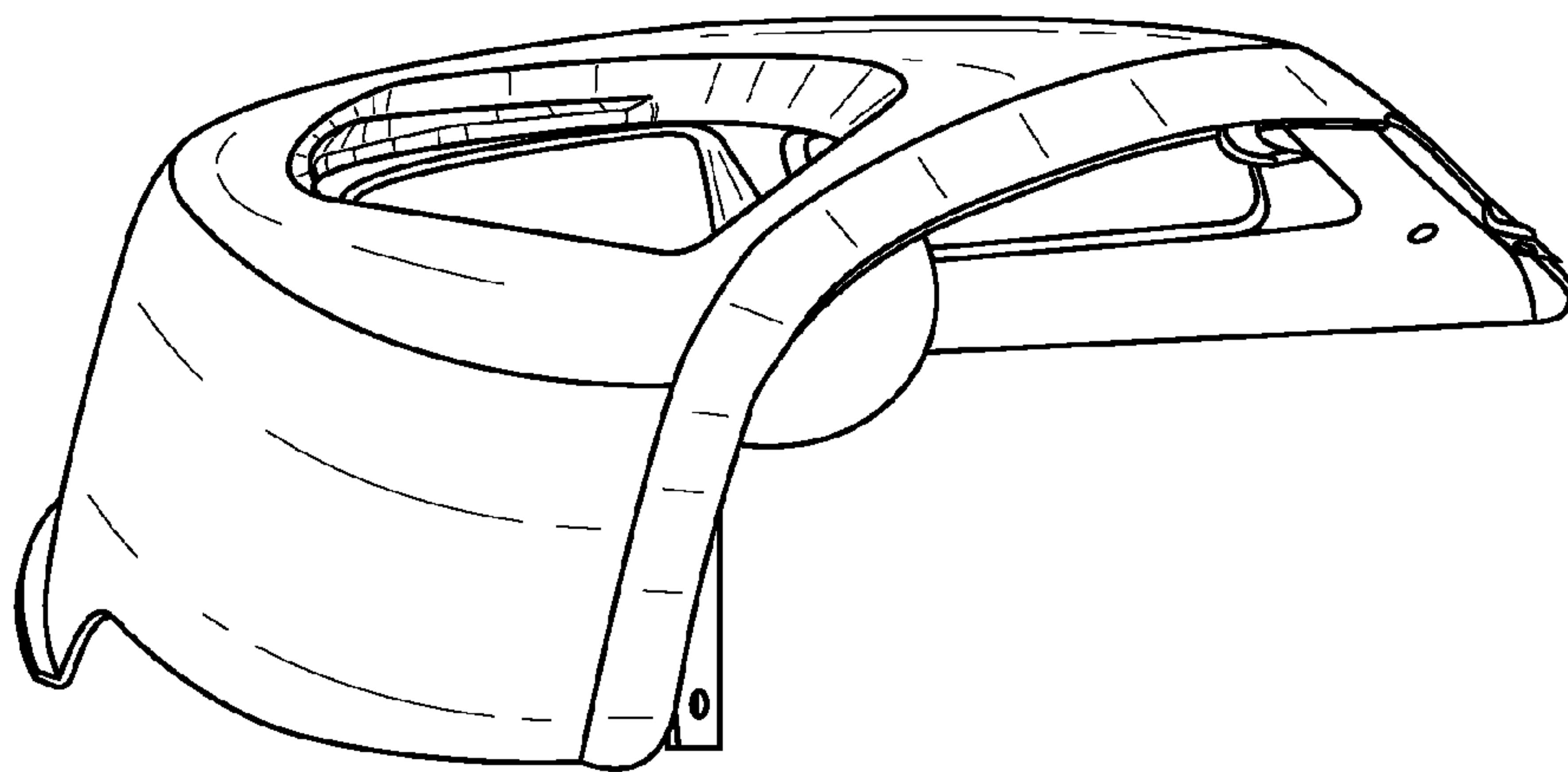

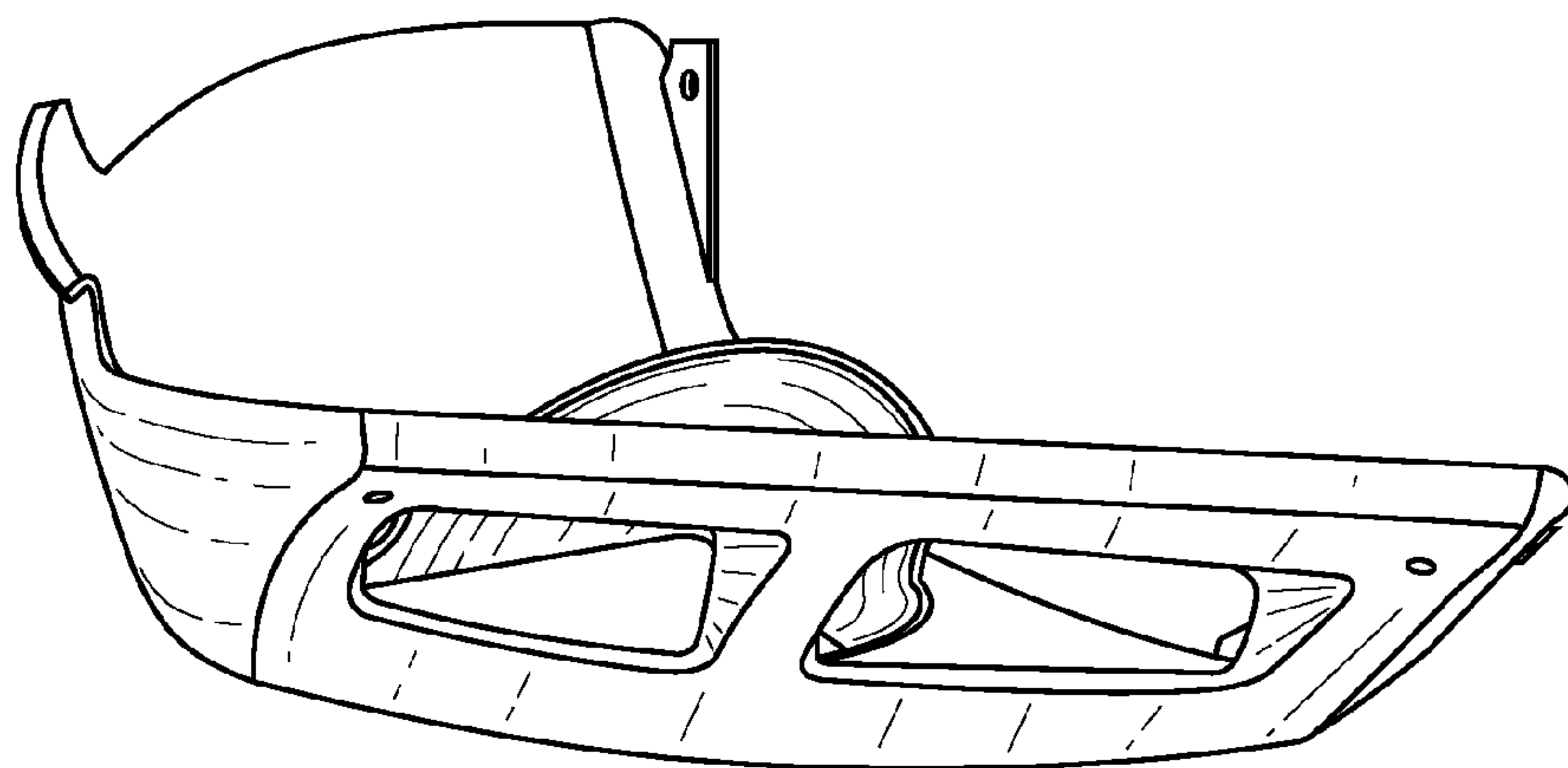

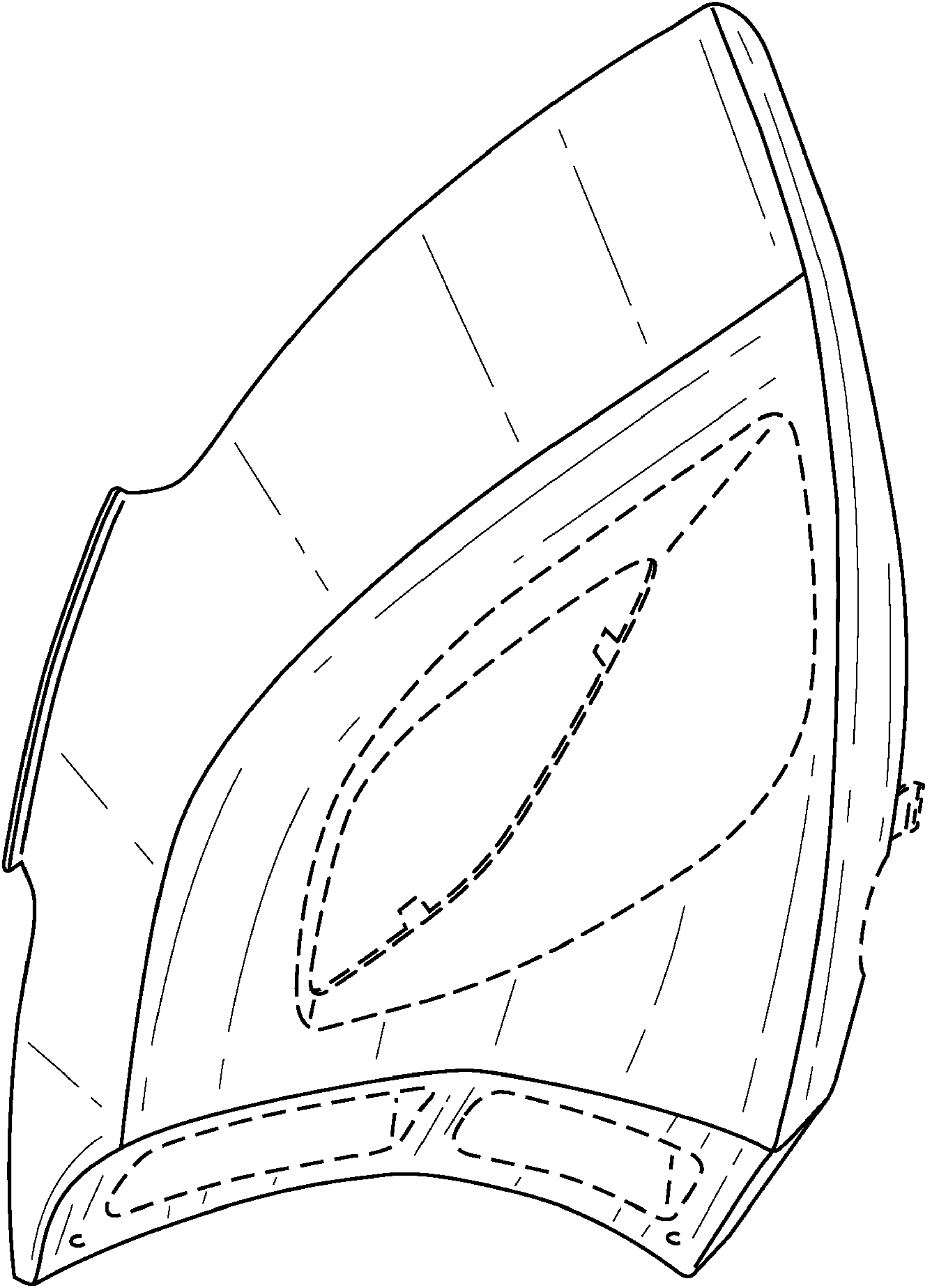

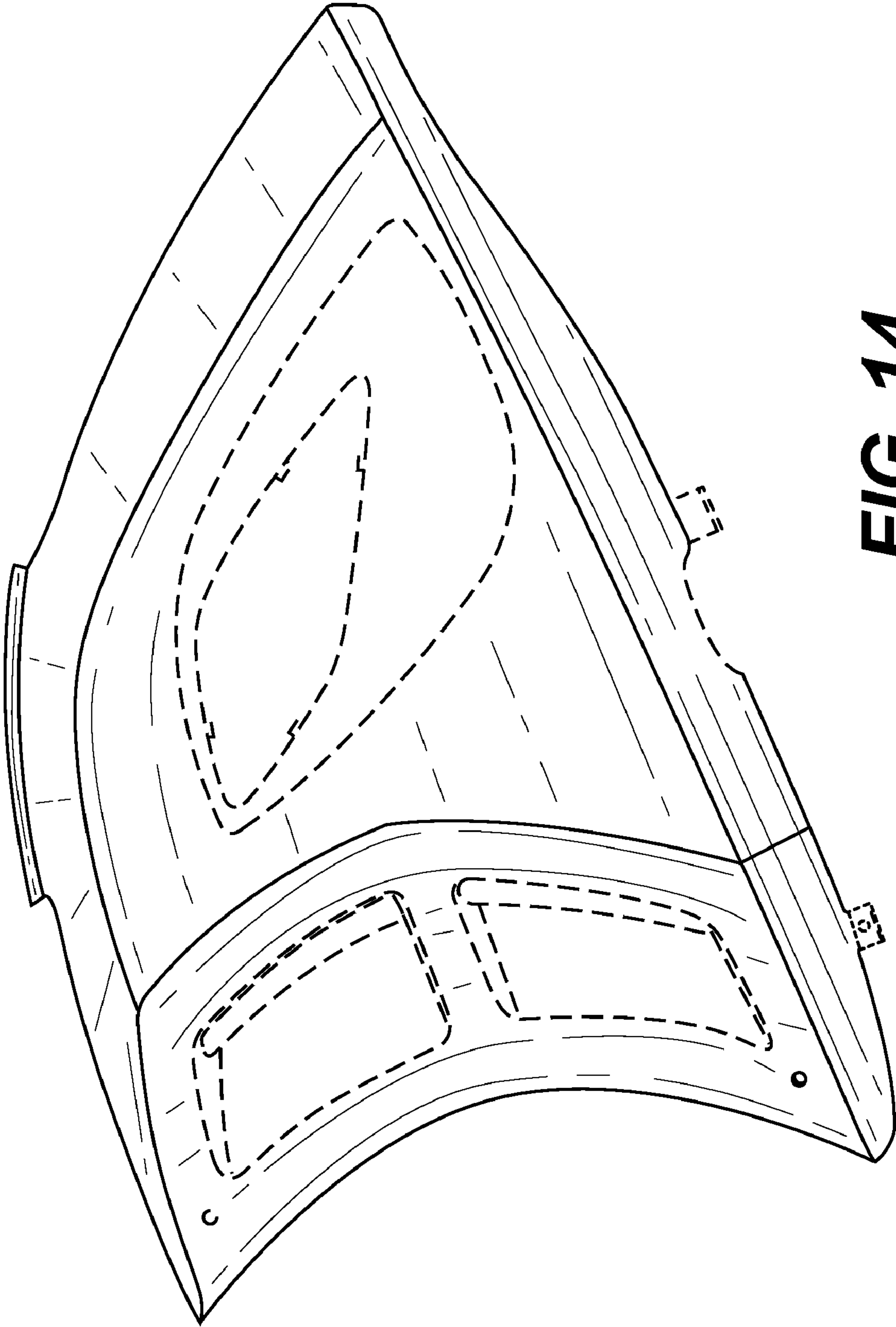

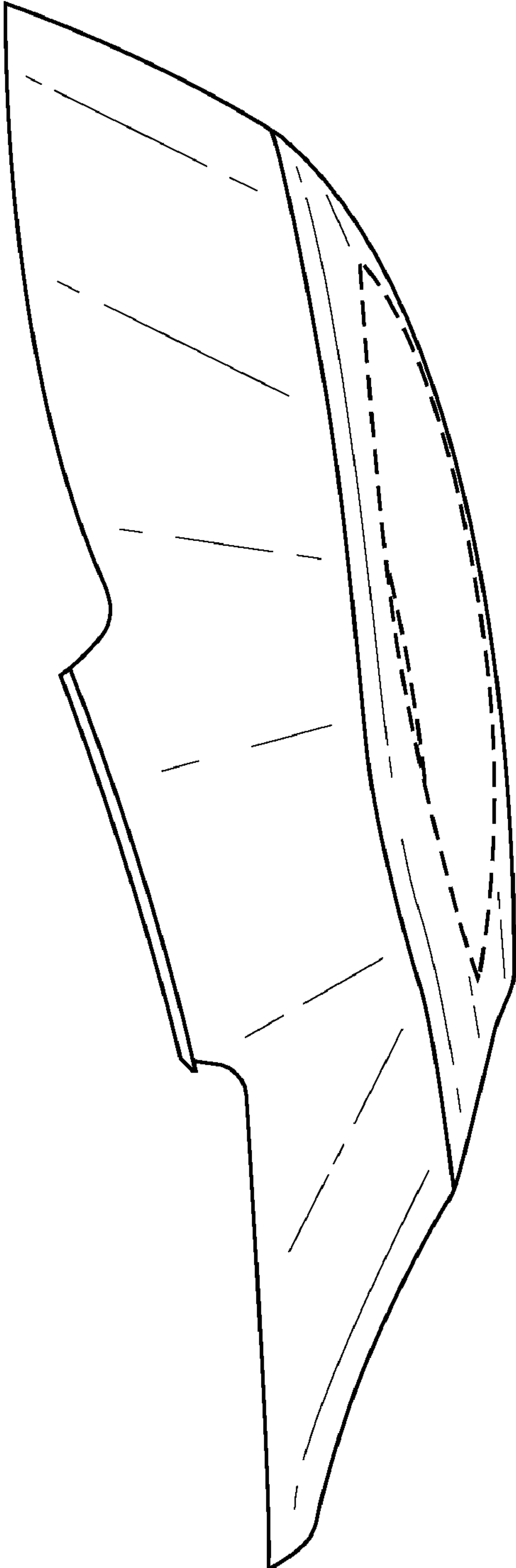

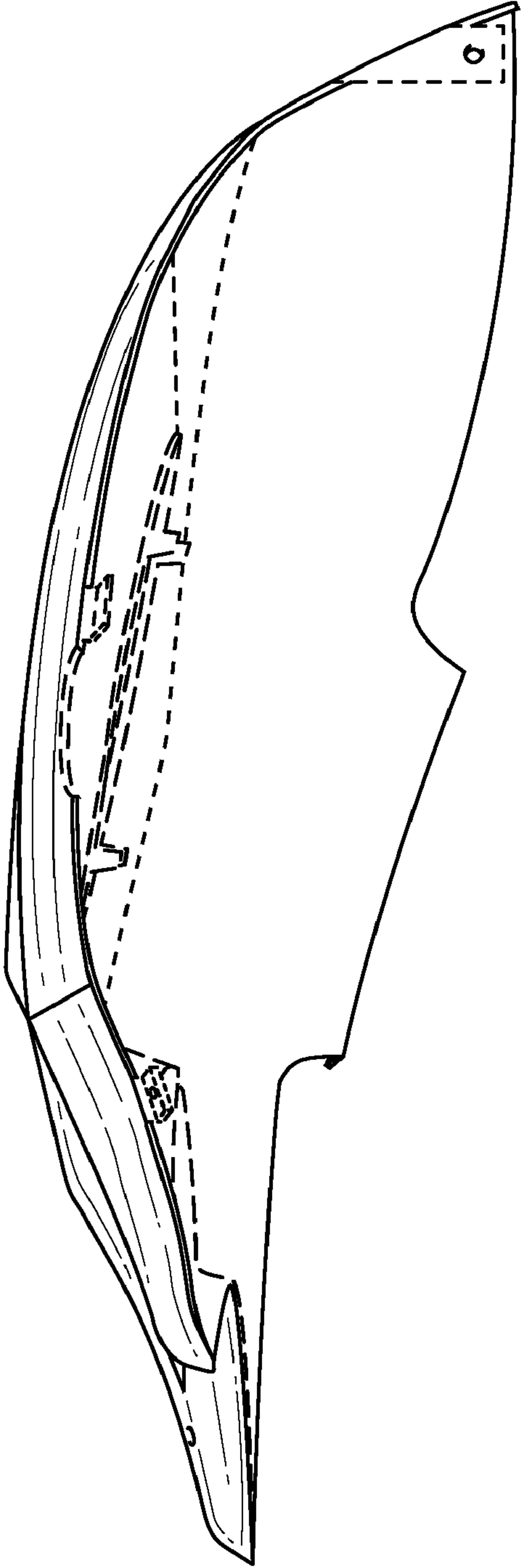




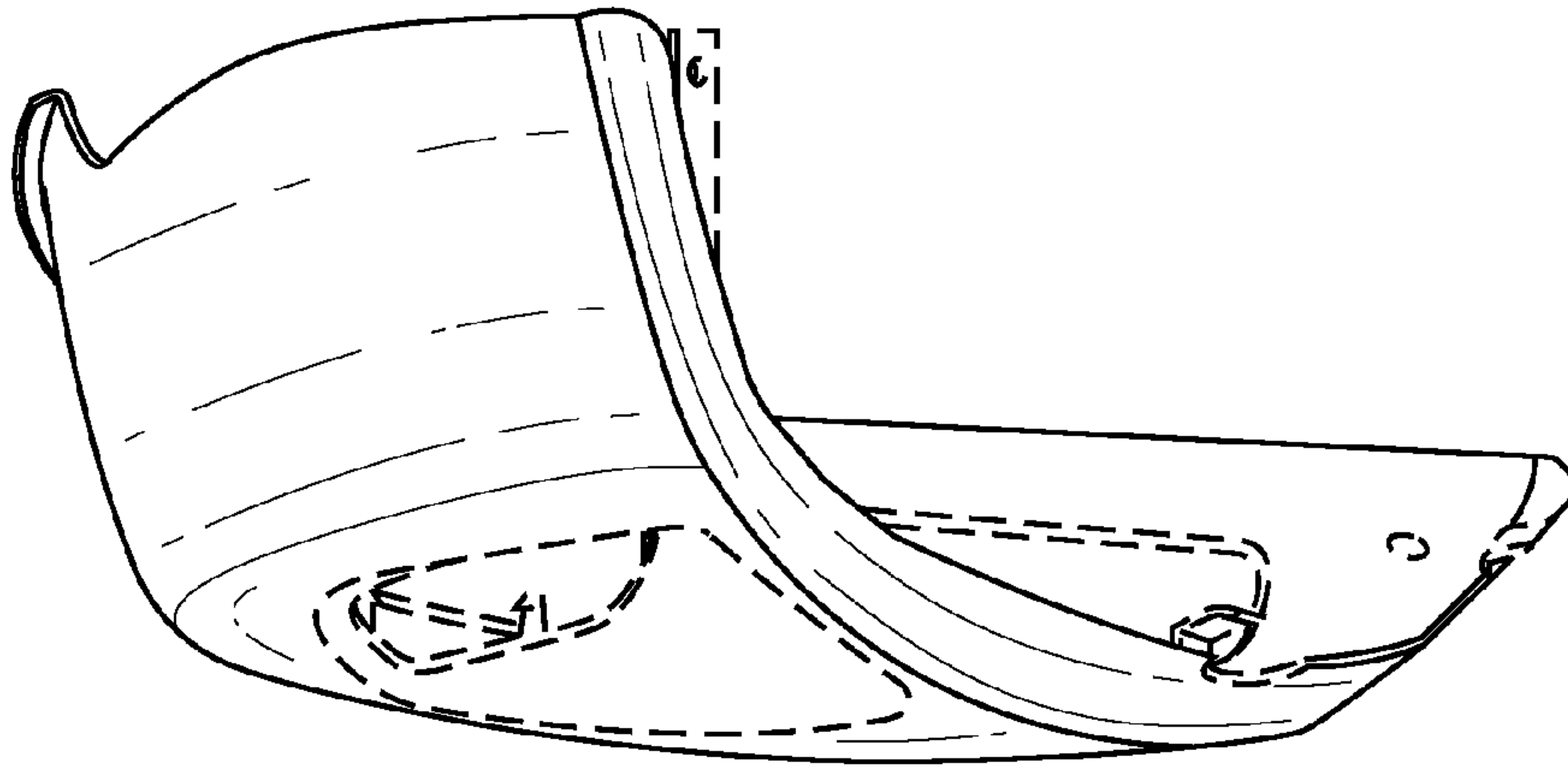

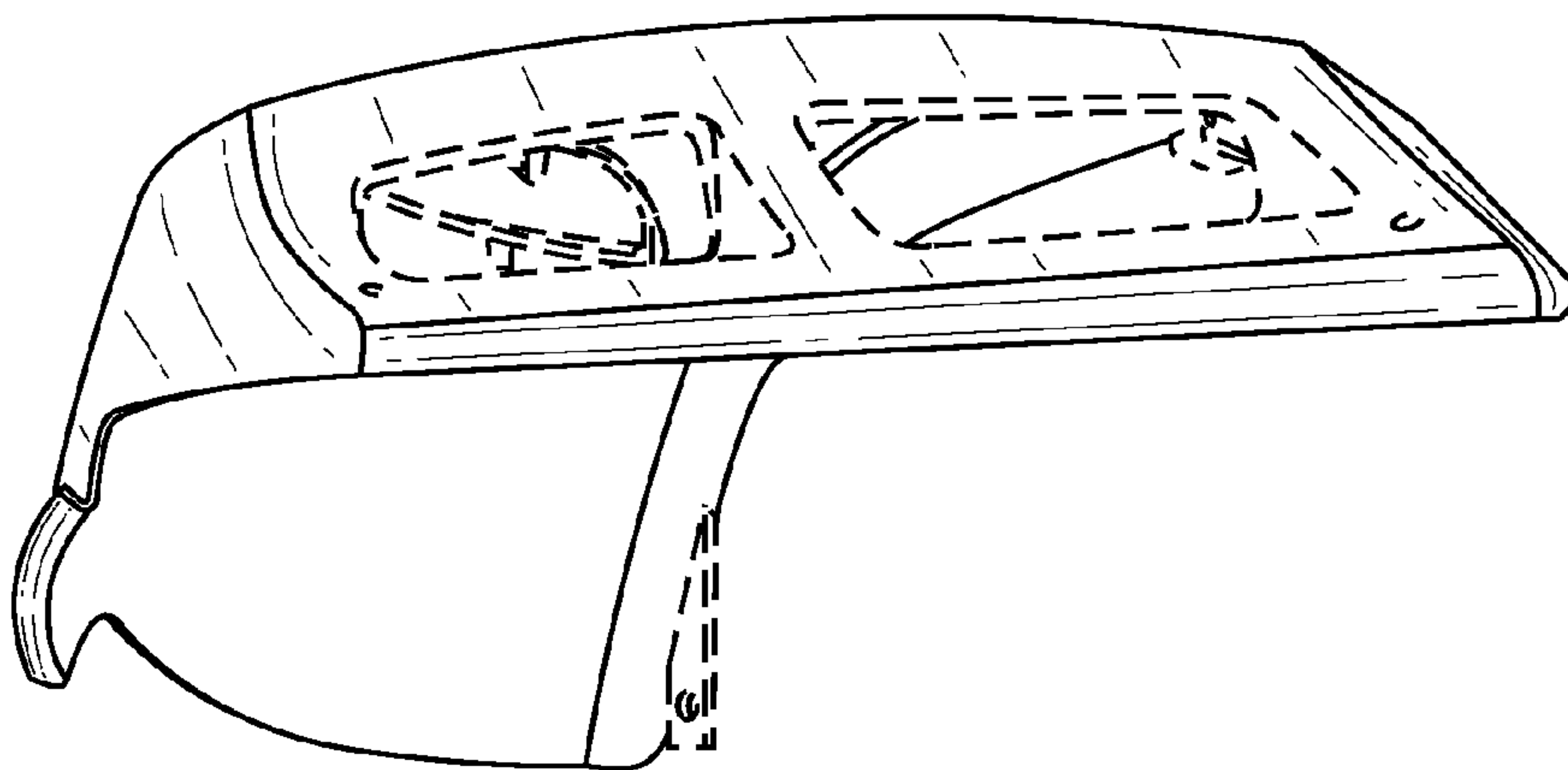
