(57) **CLAIM**

The ornamental design of an element of an aircraft body, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of an element of an aircraft body showing my new design;

FIG. 2 is a bottom, rear, right side perspective view thereof;

FIG. 3 is a right side elevation view thereof;

FIG. 4 is a top plan view thereof;

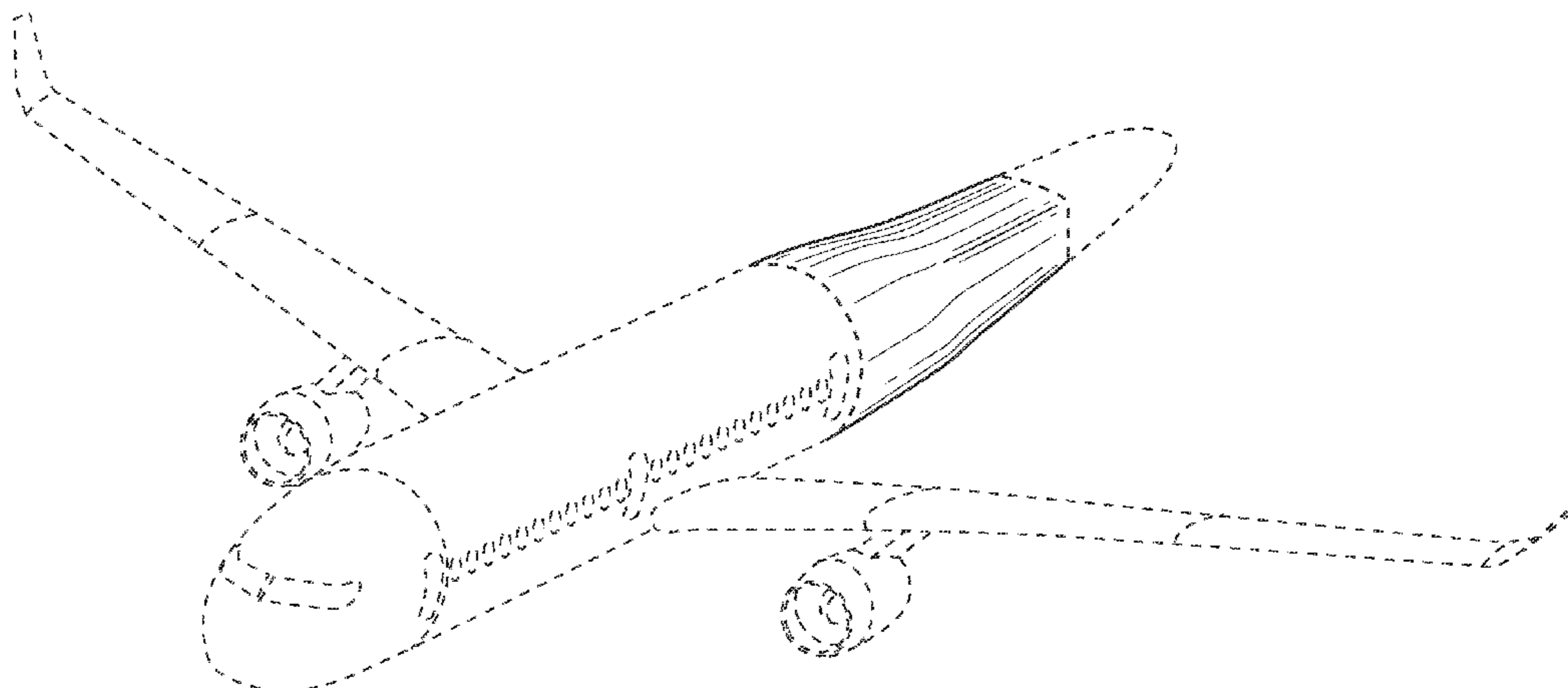
FIG. 5 is a bottom plan view;

FIG. 6 is a top, front, right side perspective view of the element of an aircraft body shown applied to an aircraft; and,

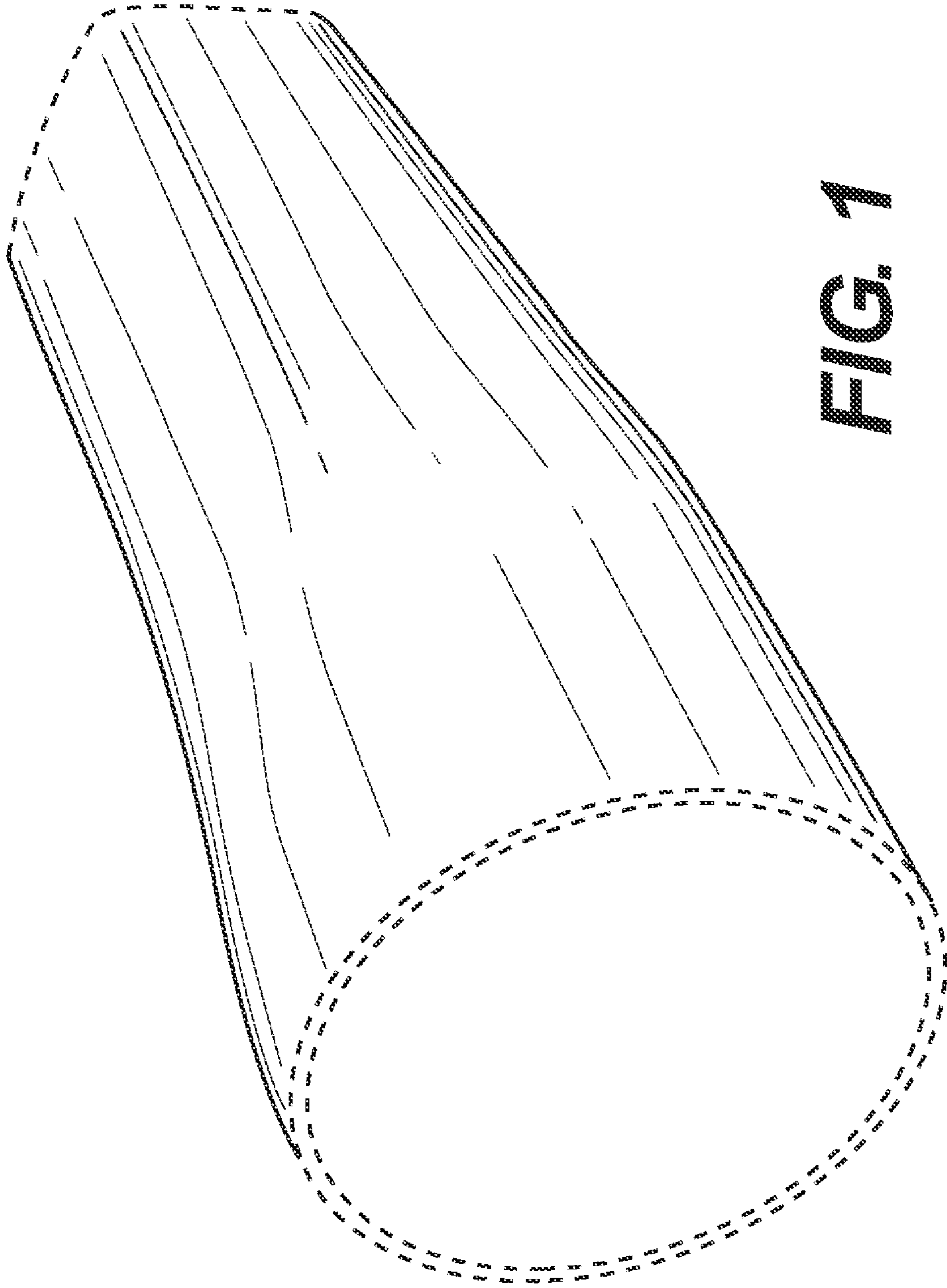

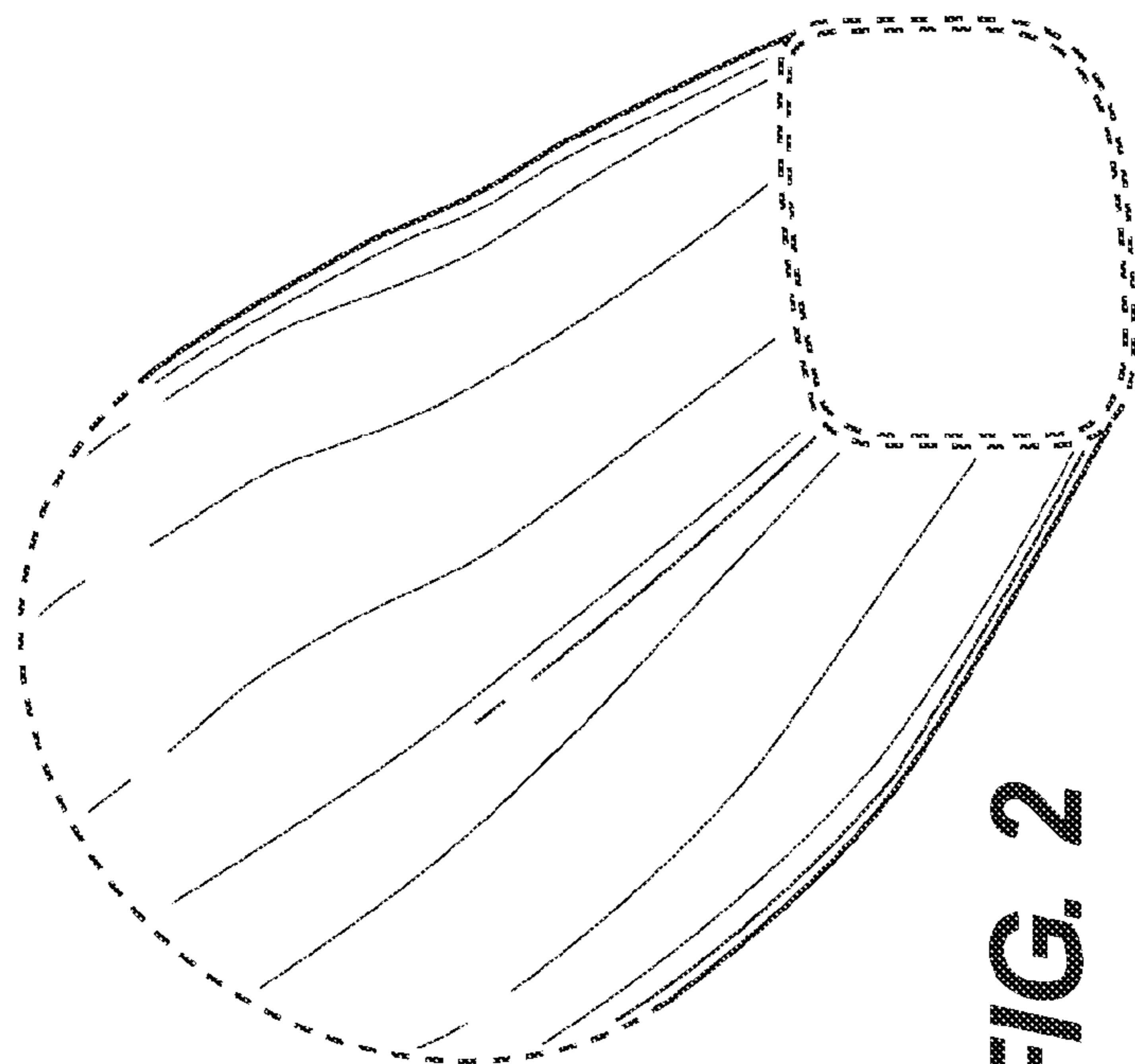

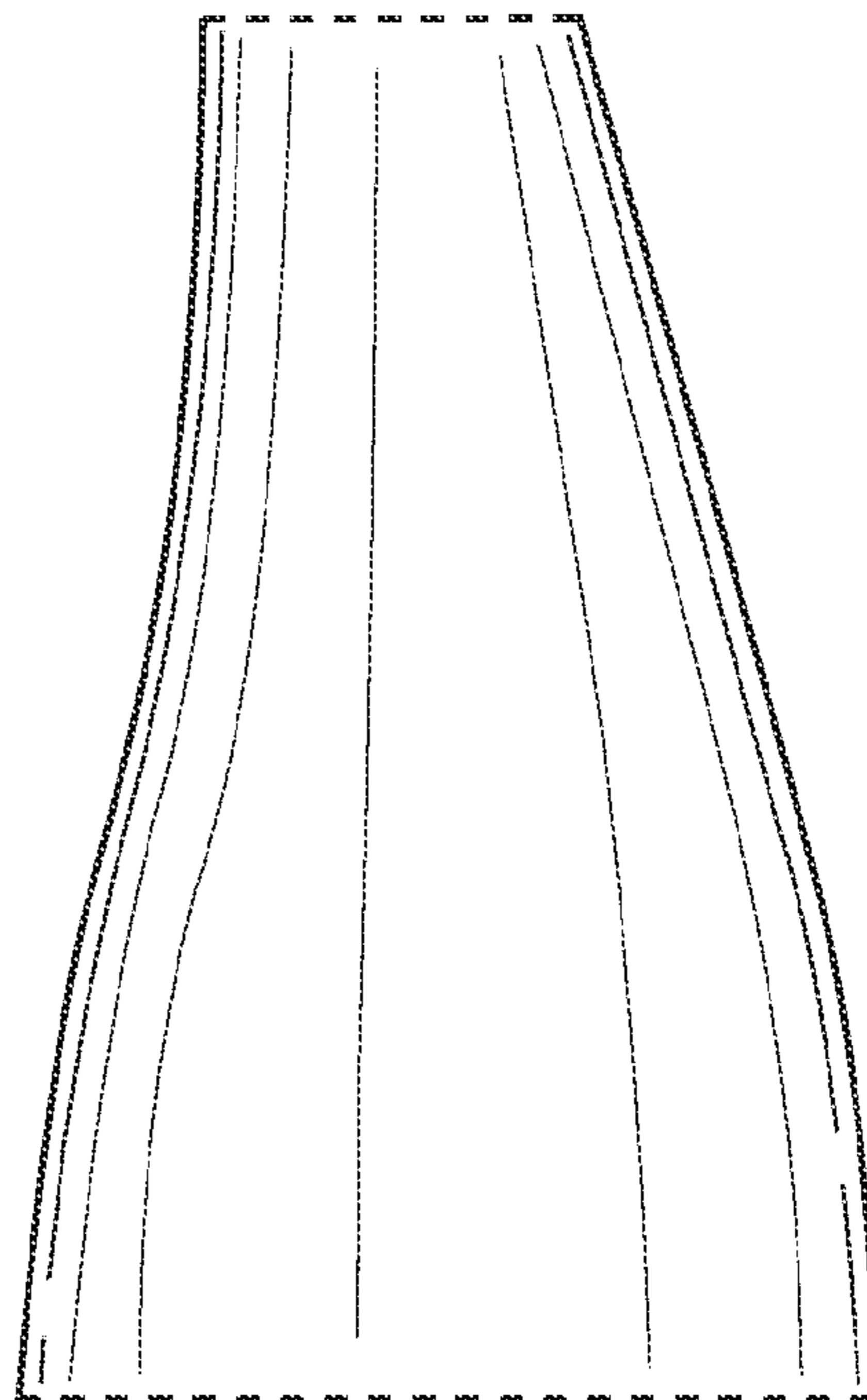

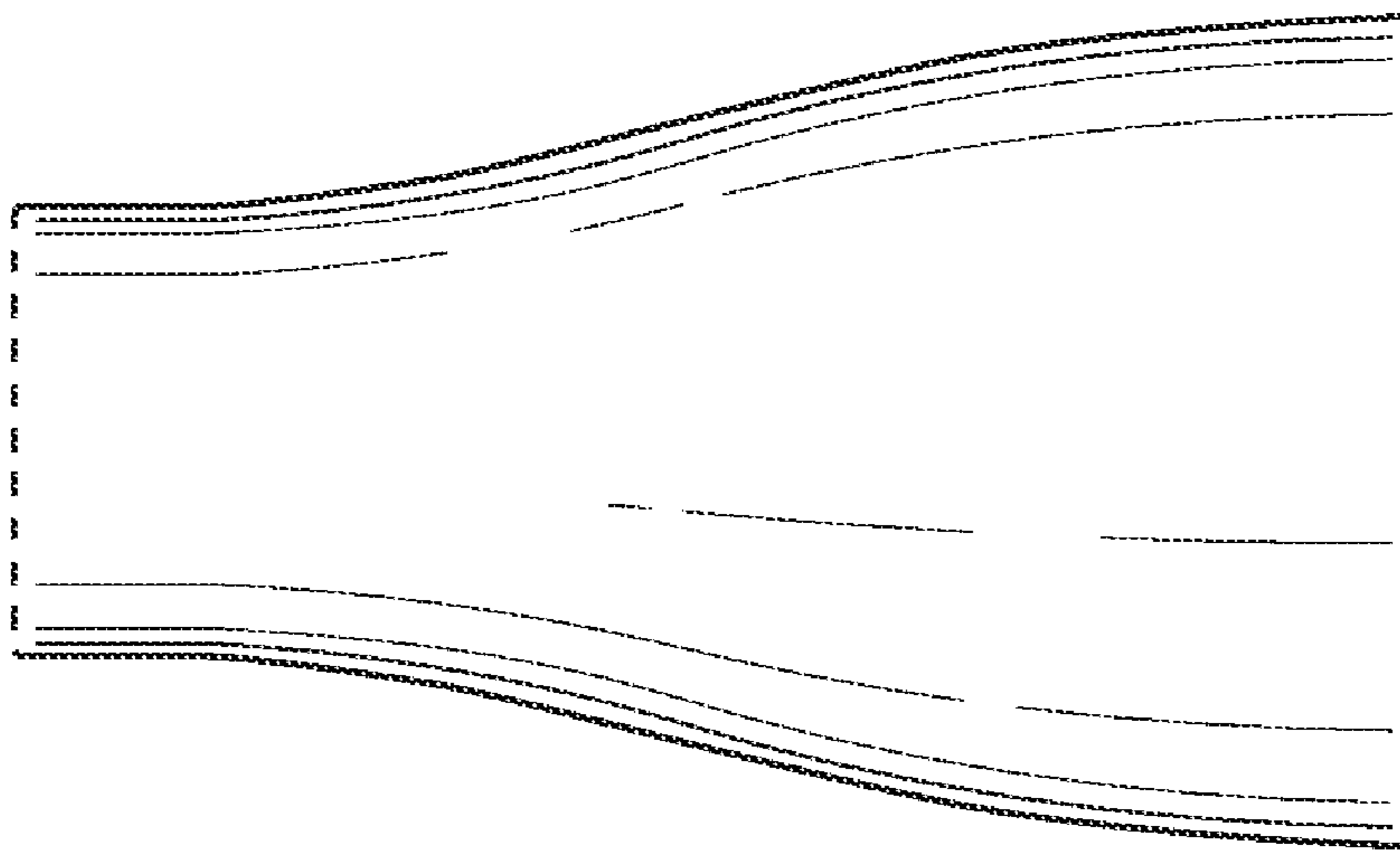

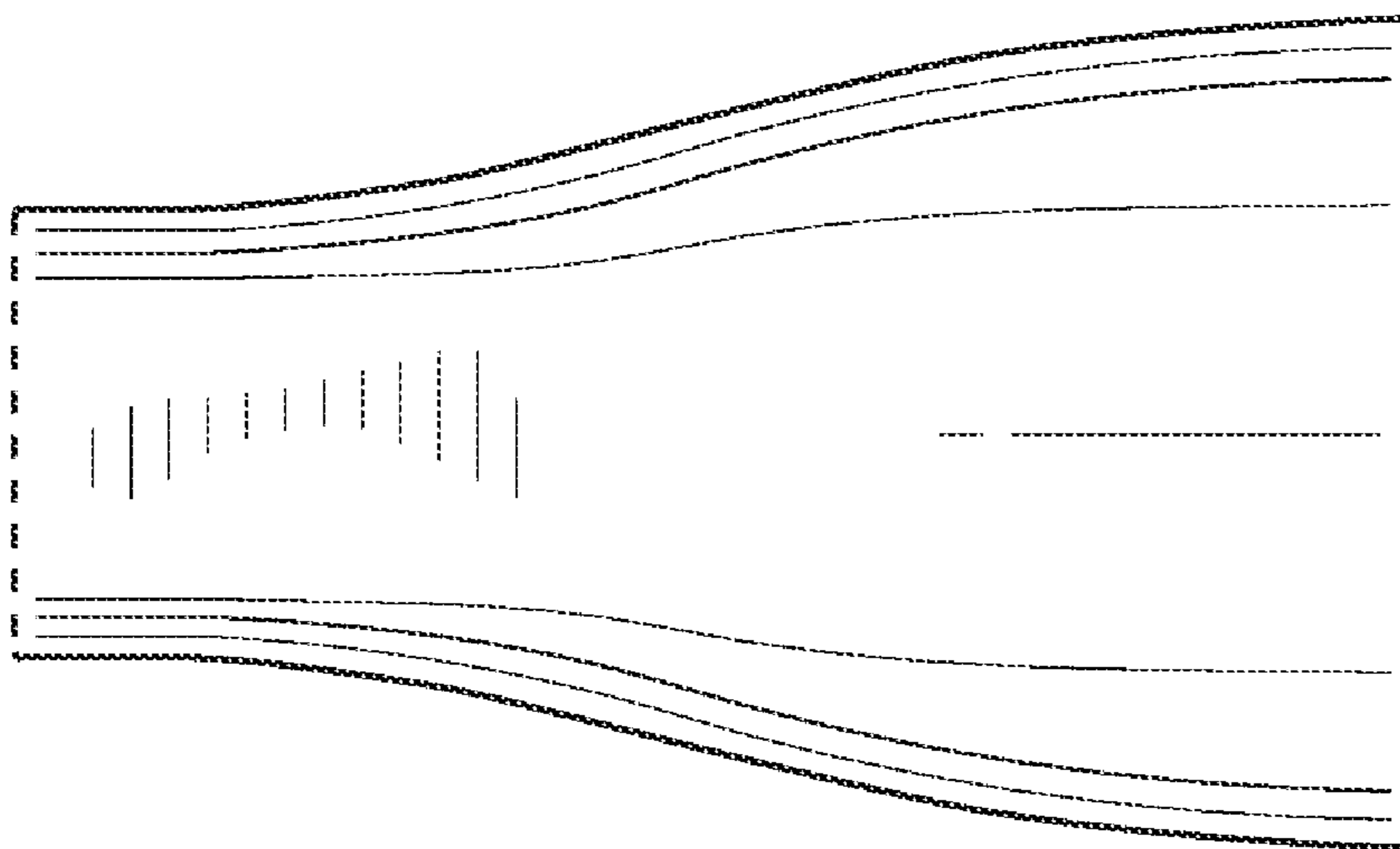

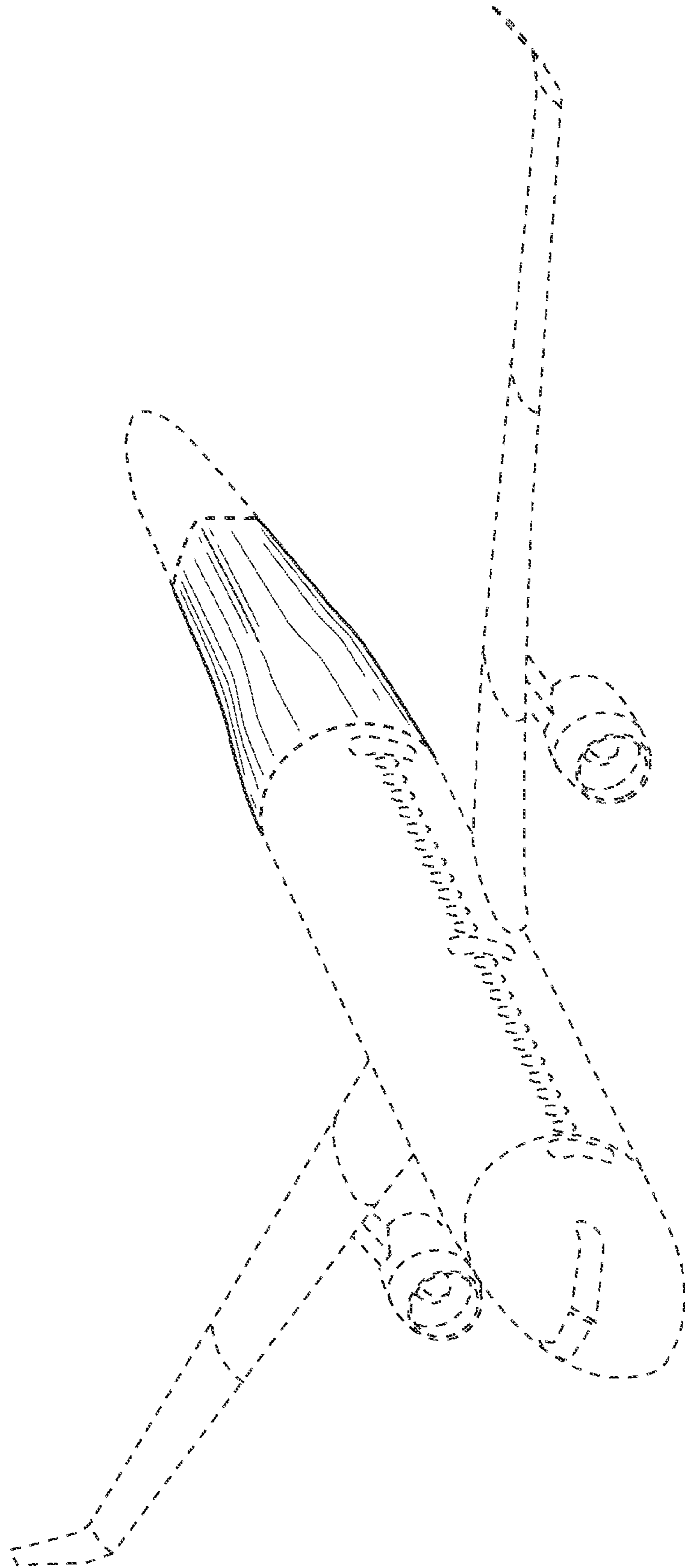

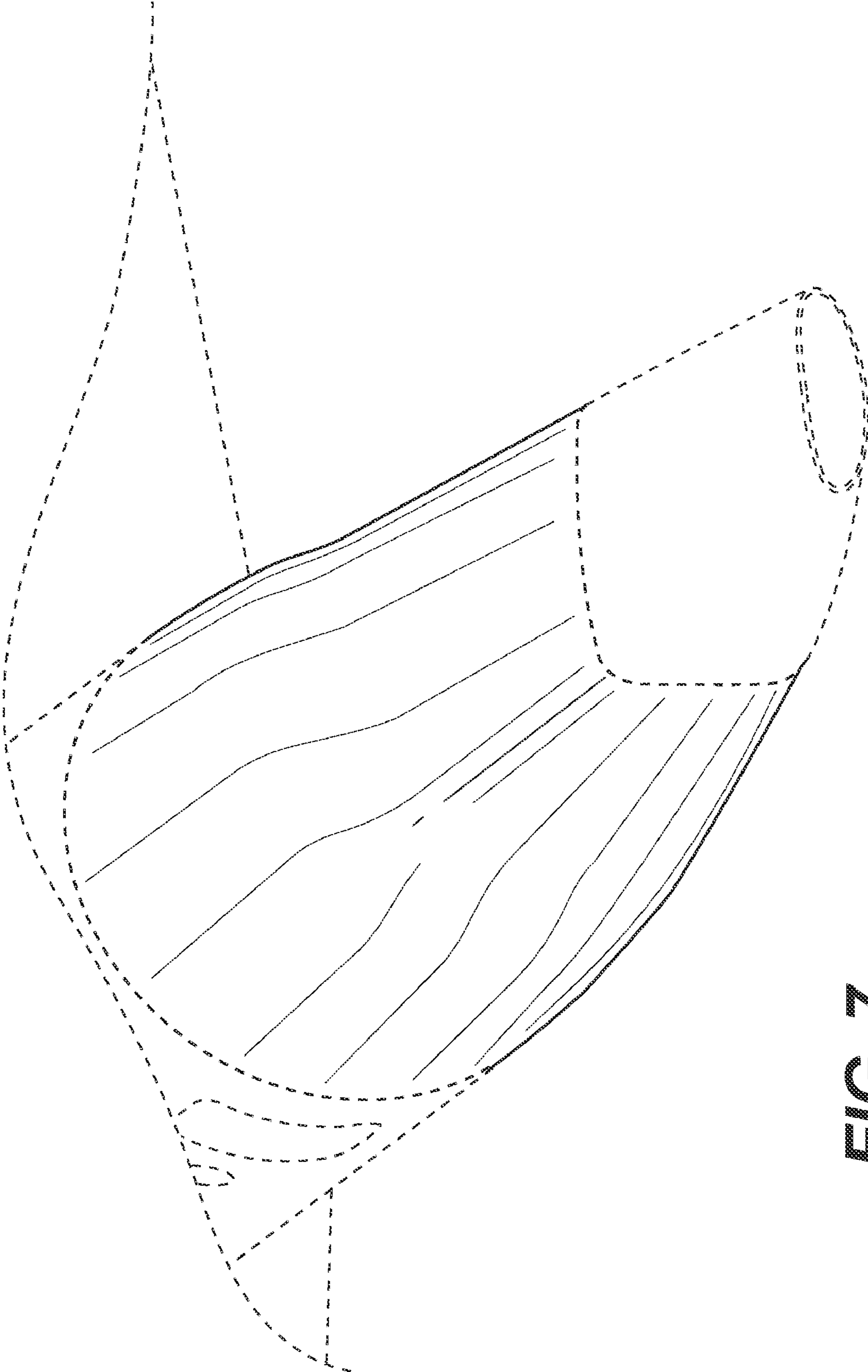
