**DESCRIPTION**

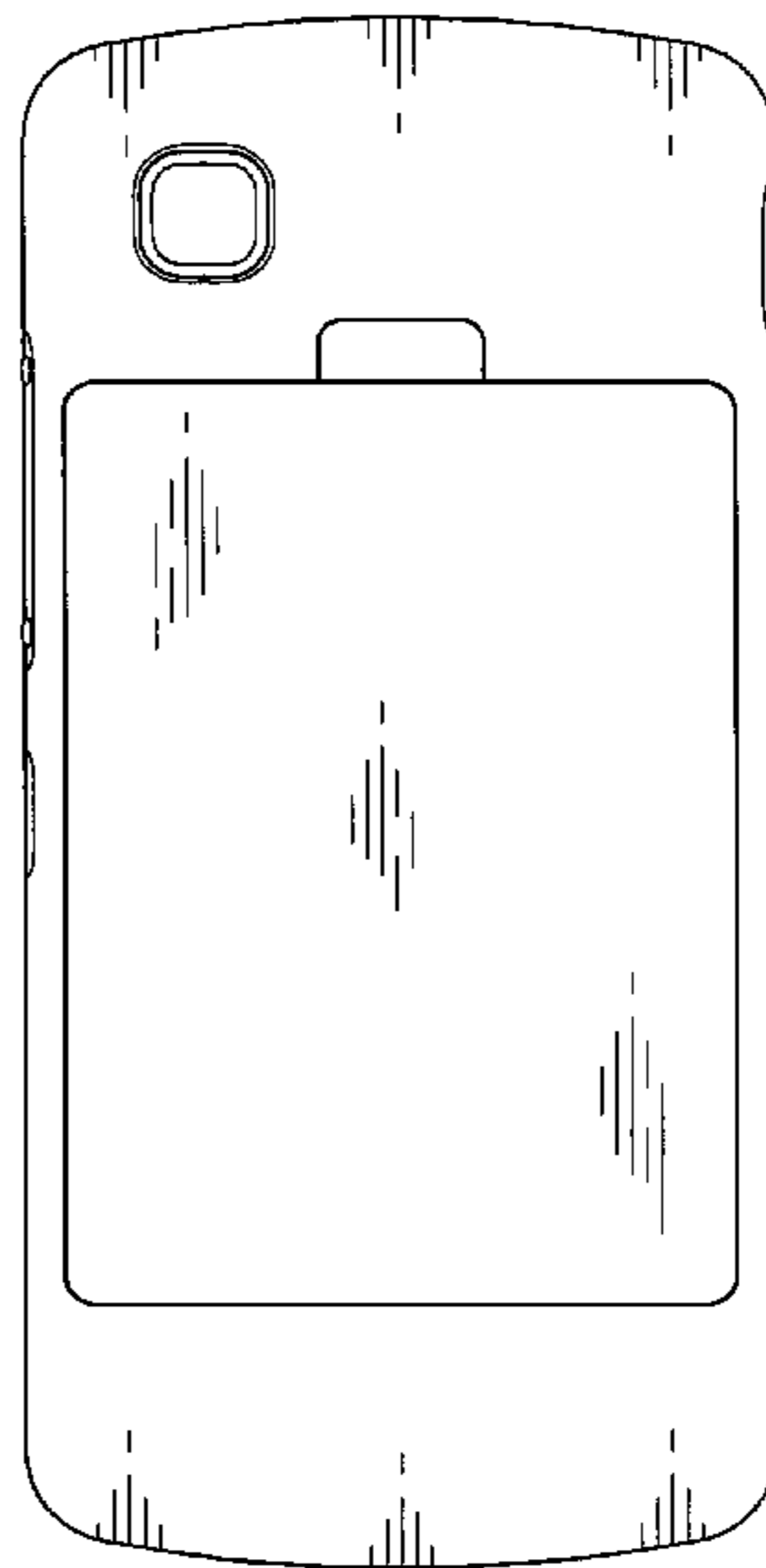
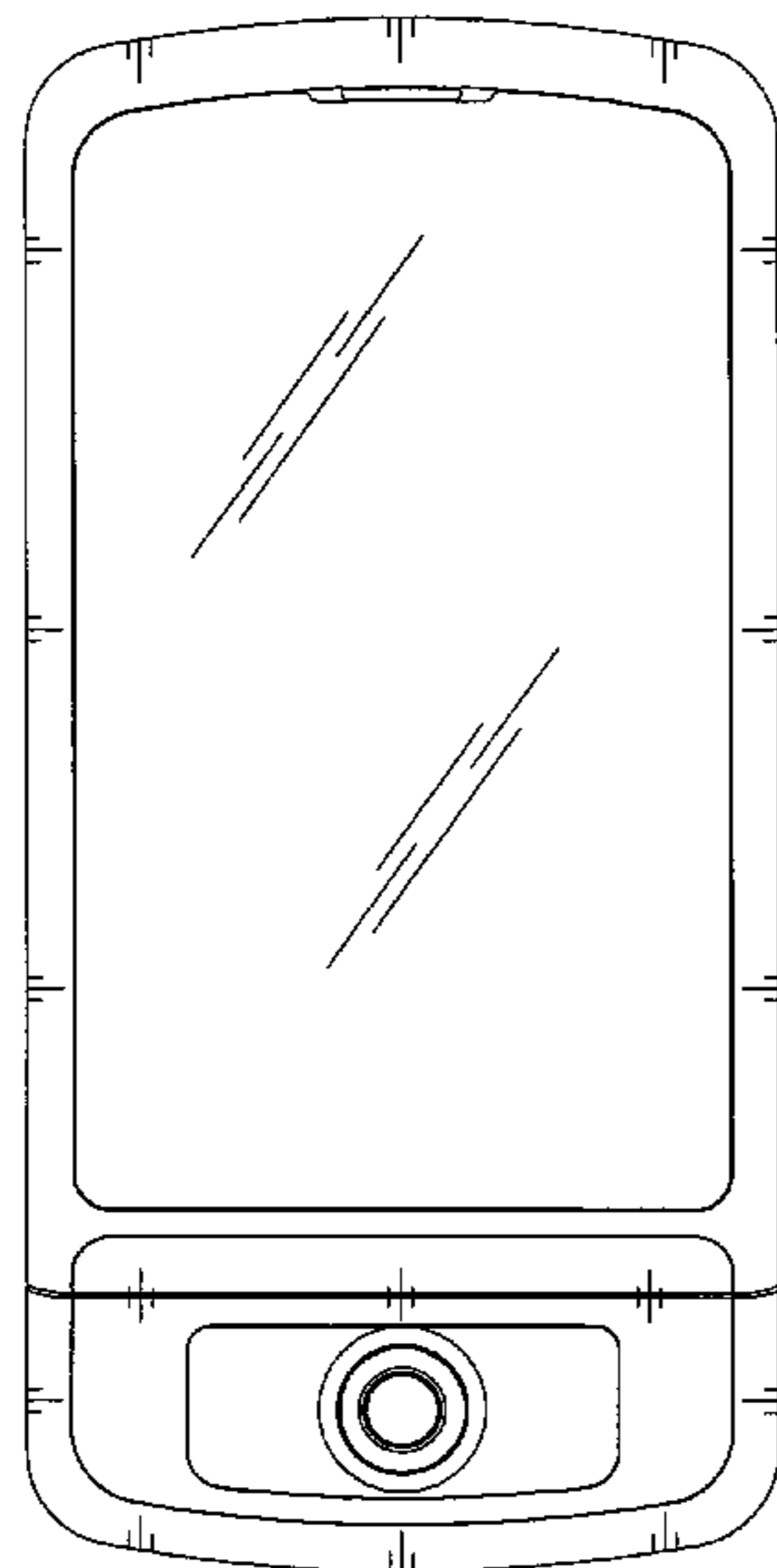

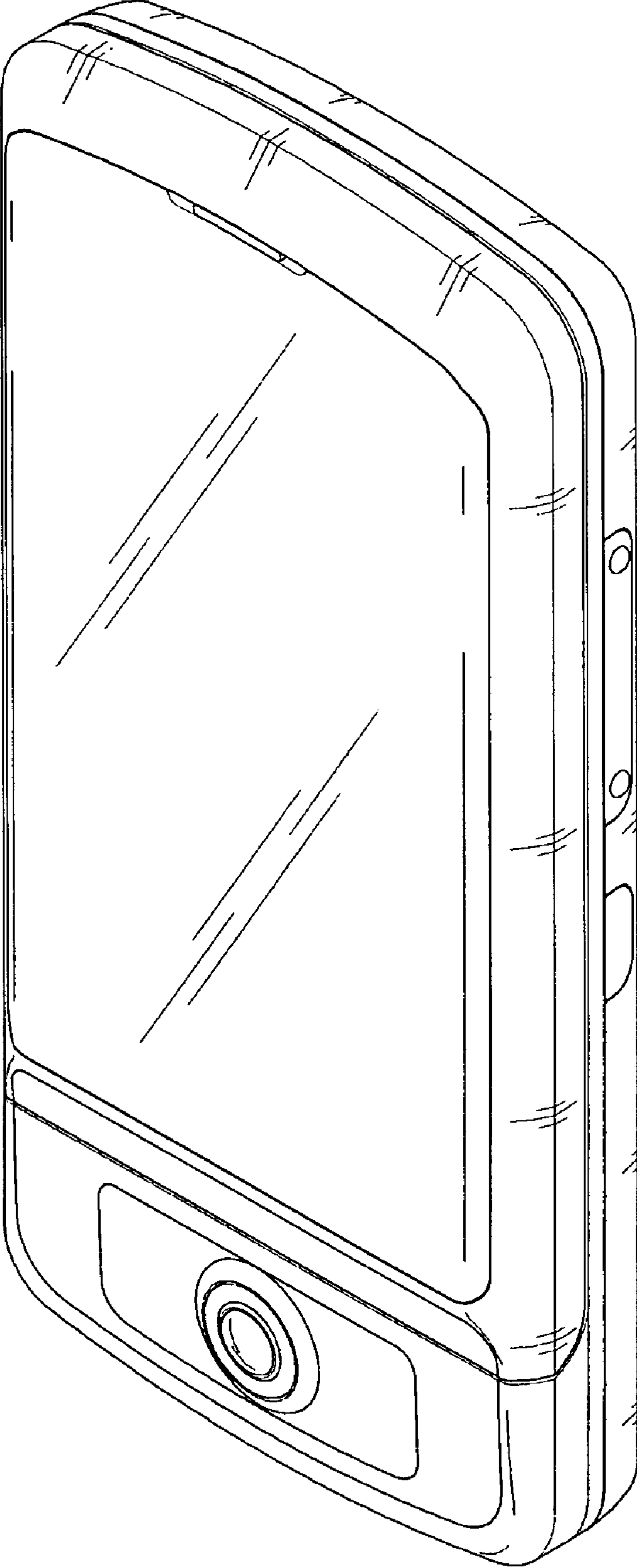

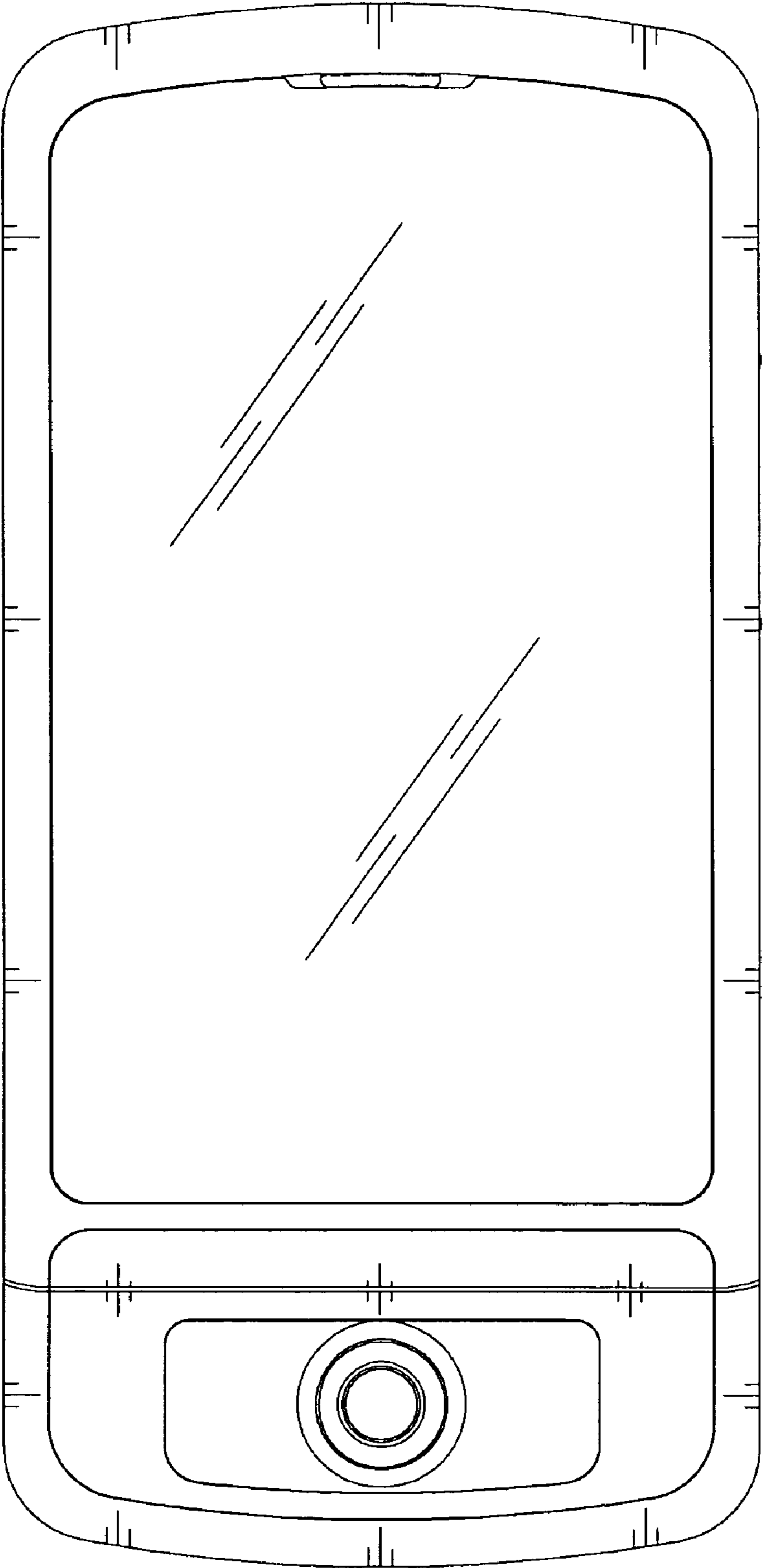

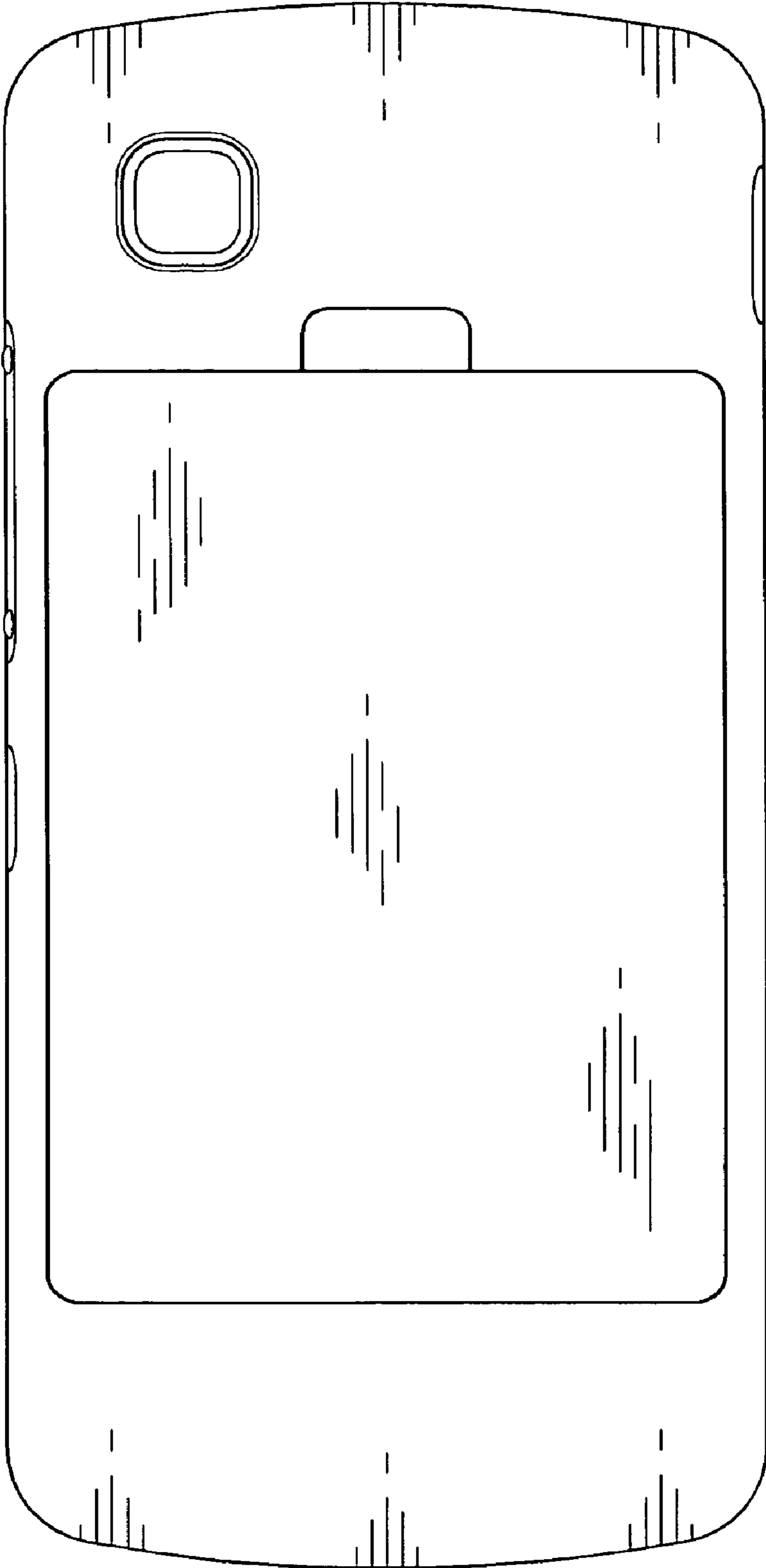

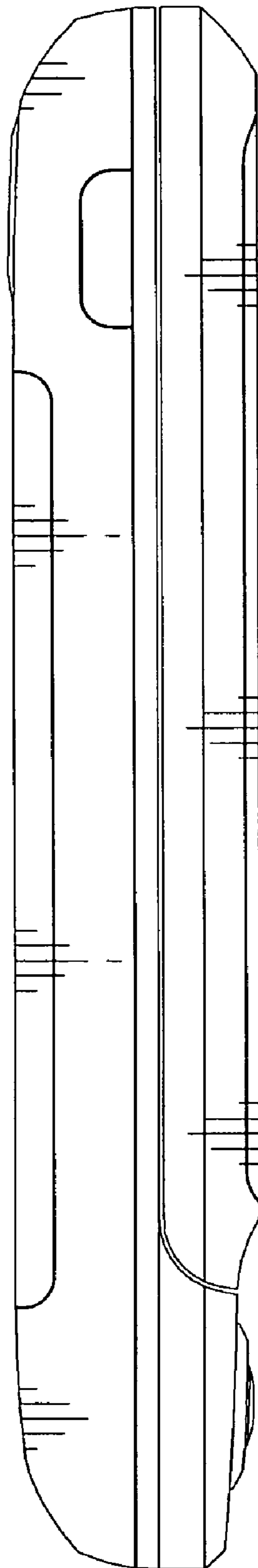

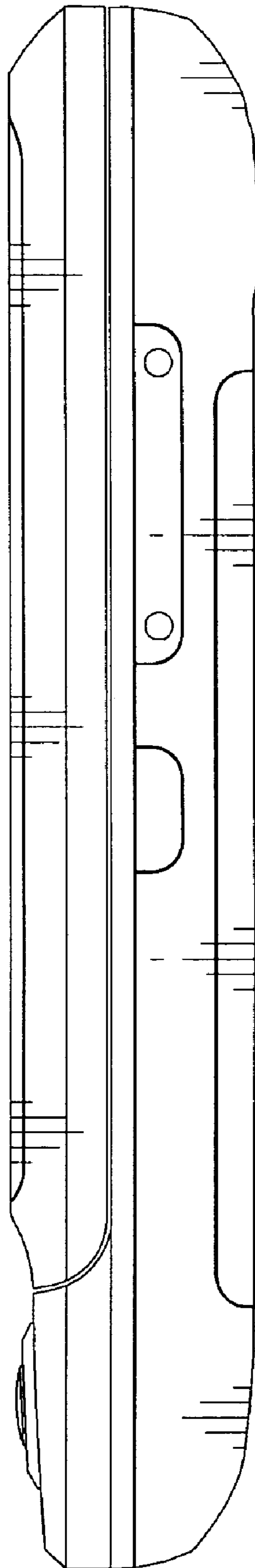

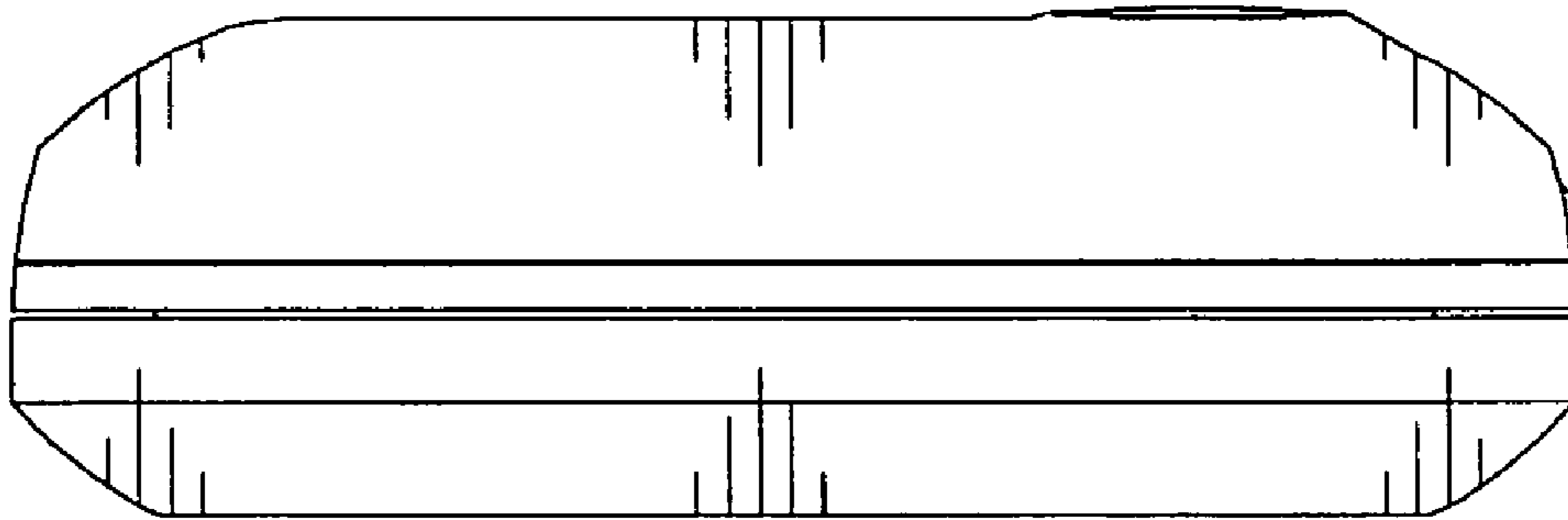

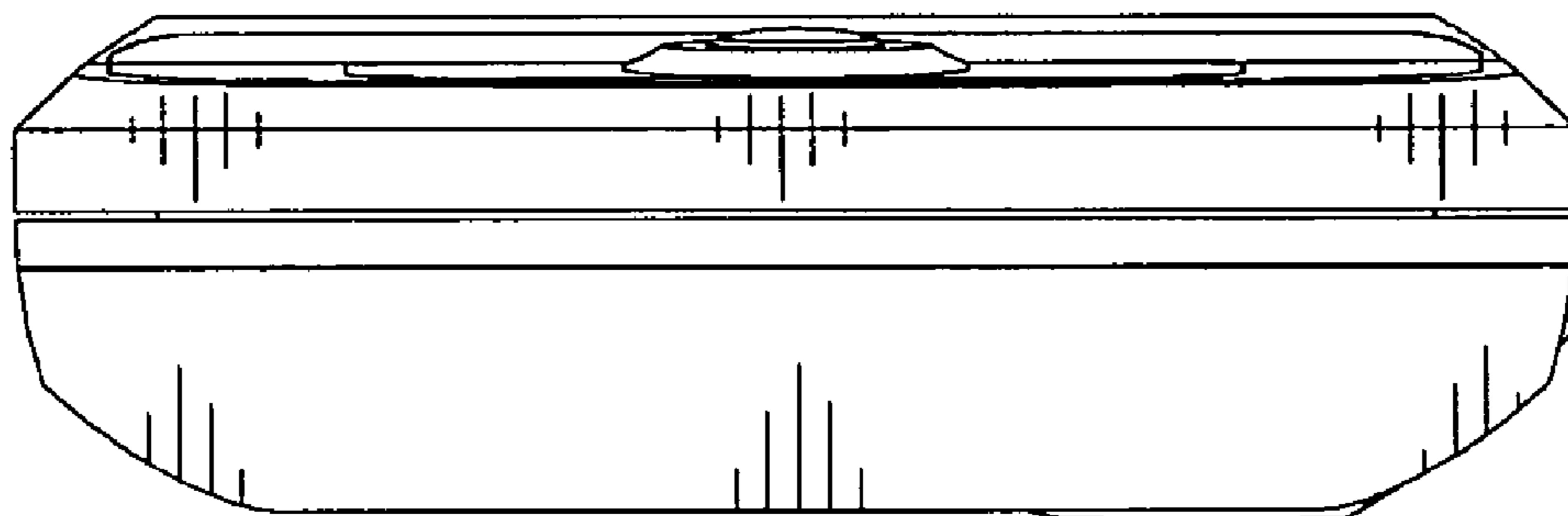
