DESCRIPTION

FIG. 1 is a front, right perspective of the cellular phone showing my new design;

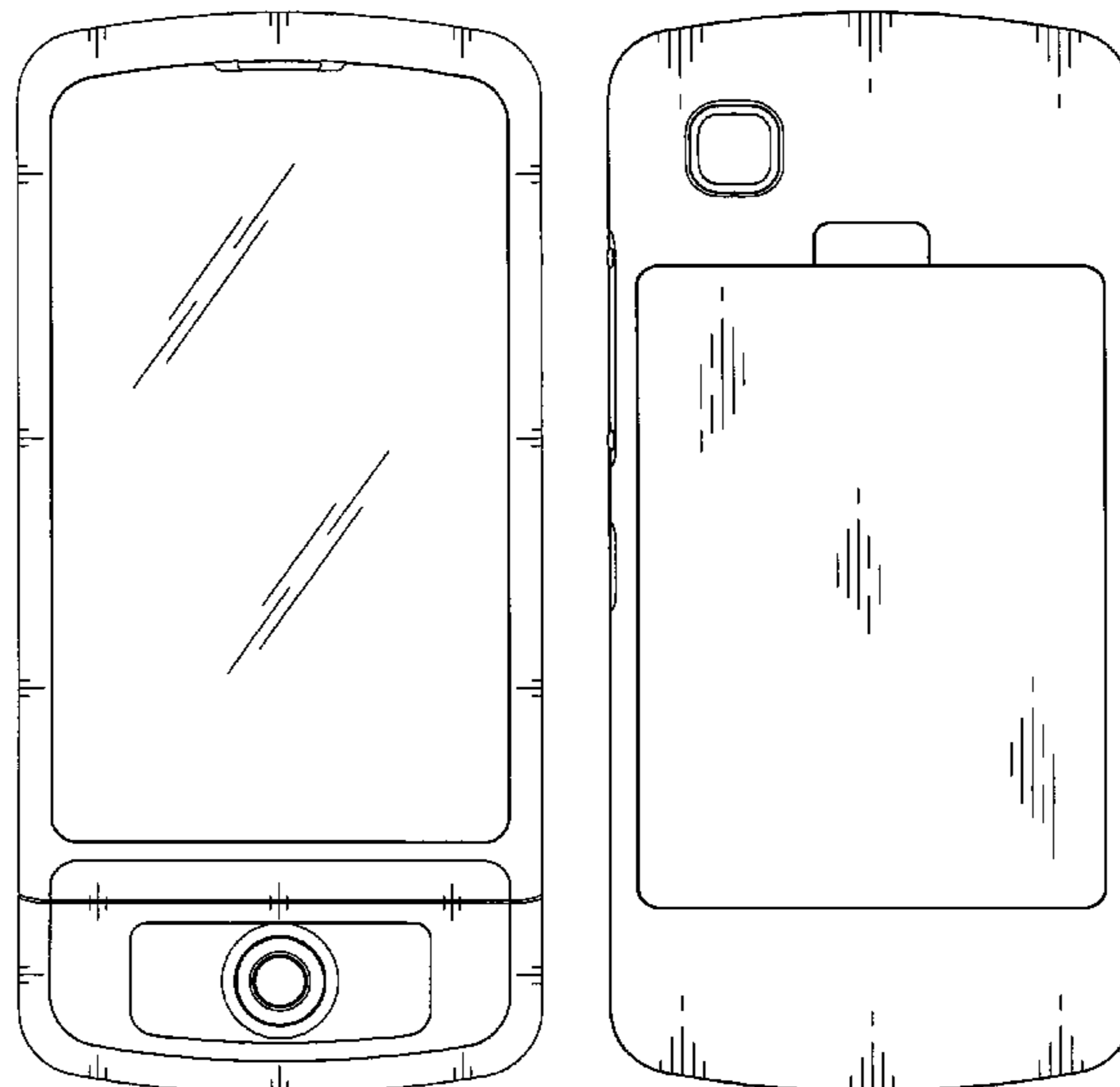

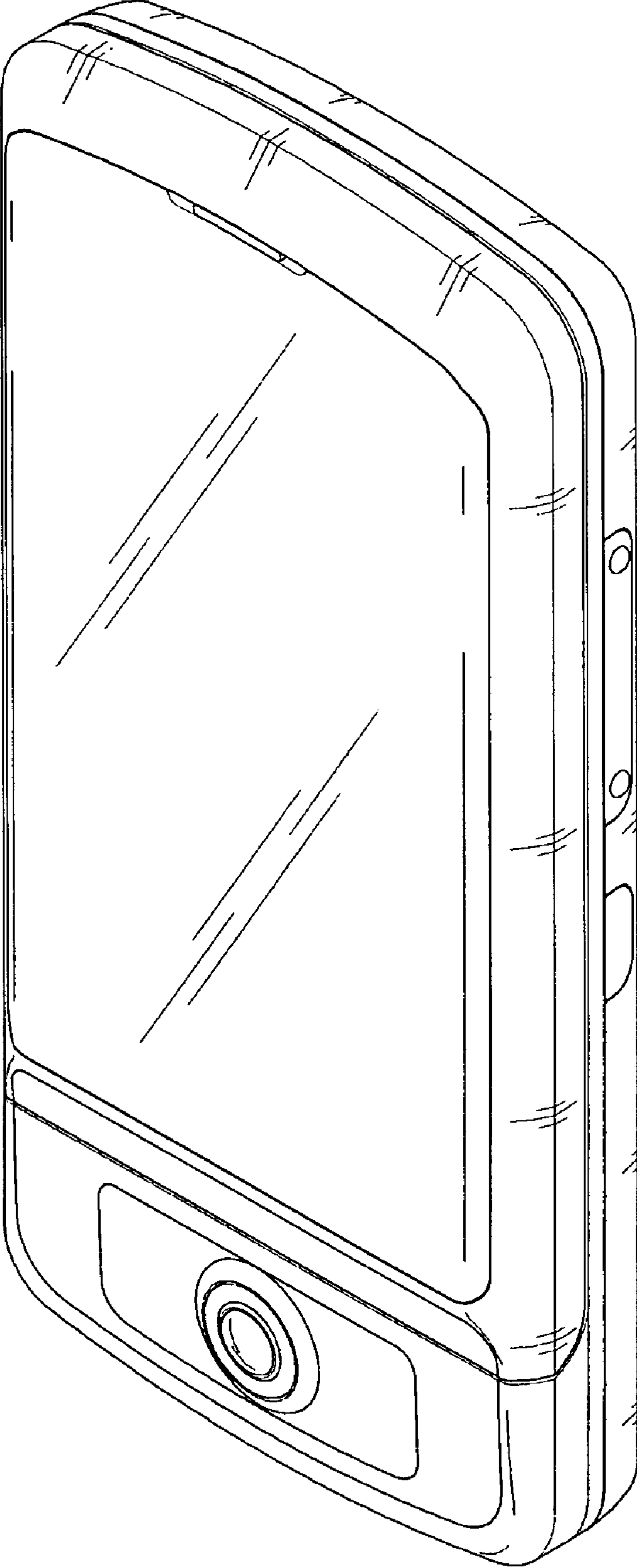

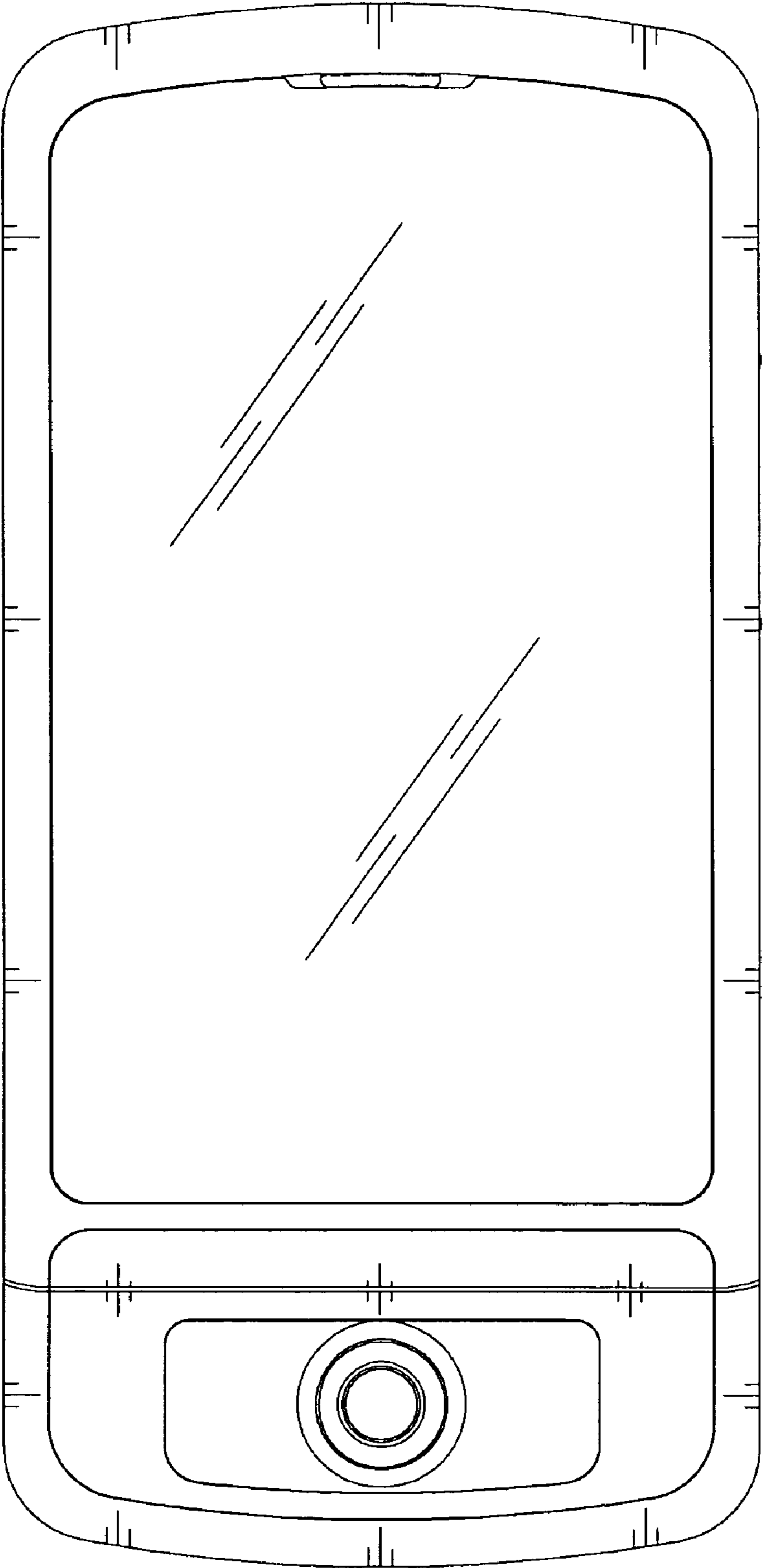

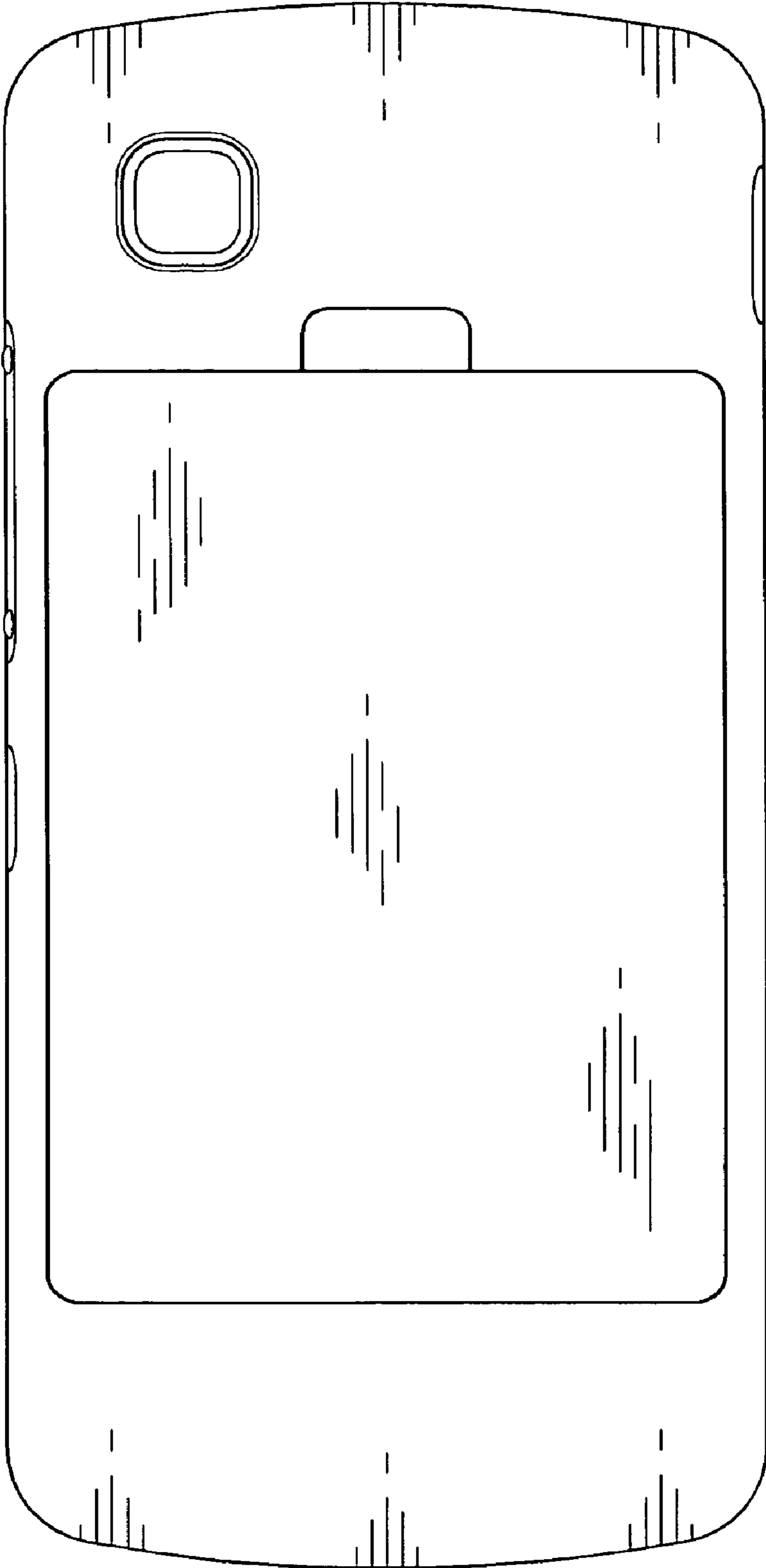

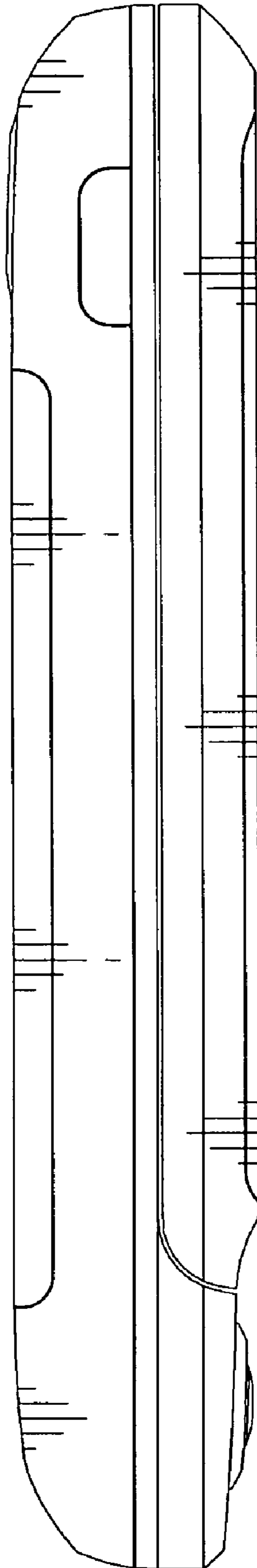

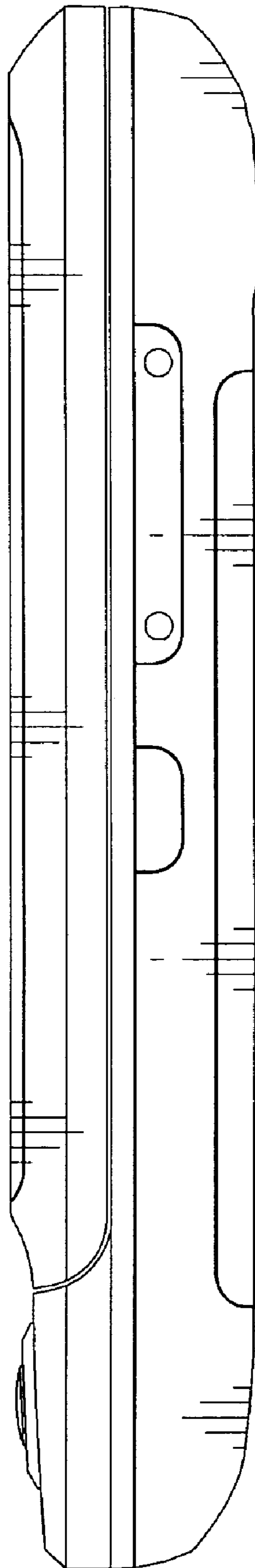

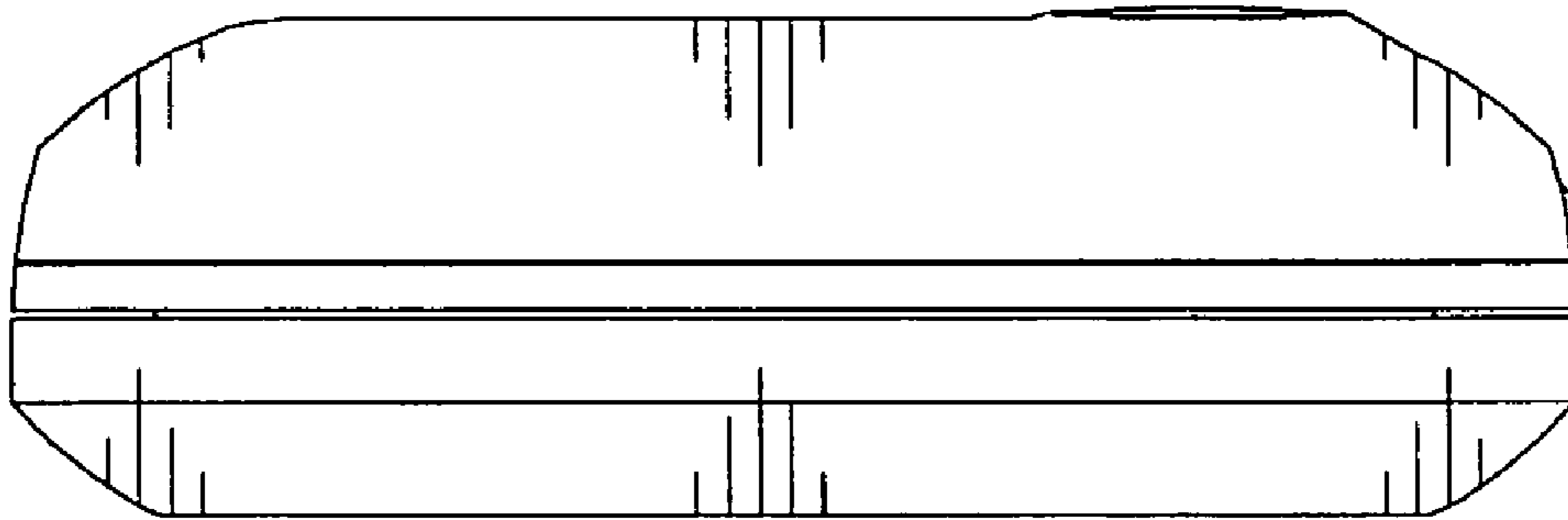

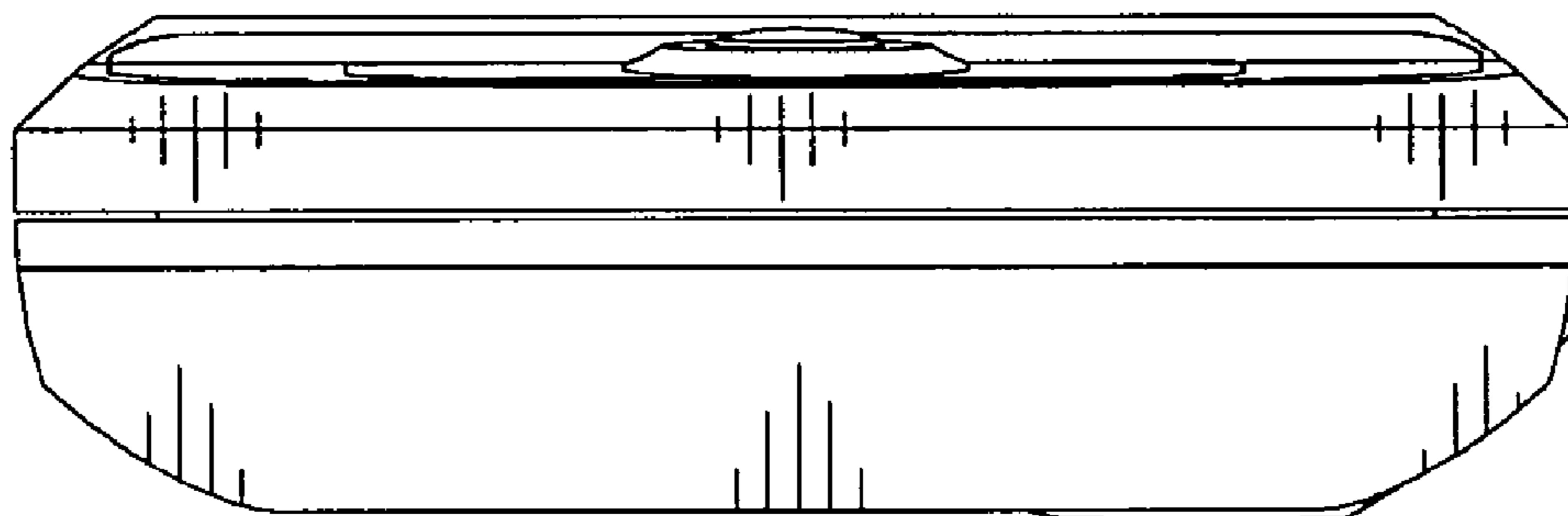
