DESCRIPTION

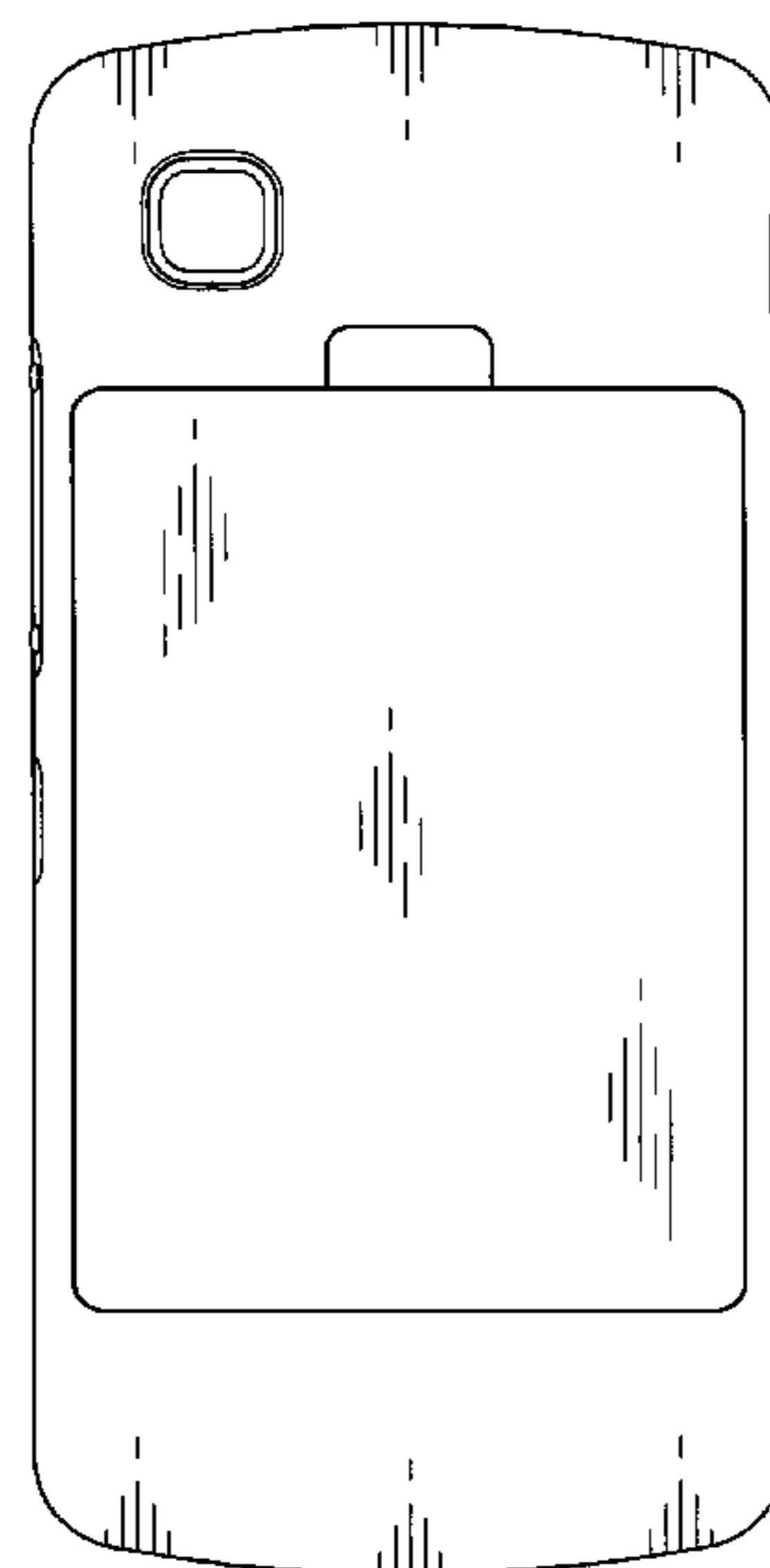
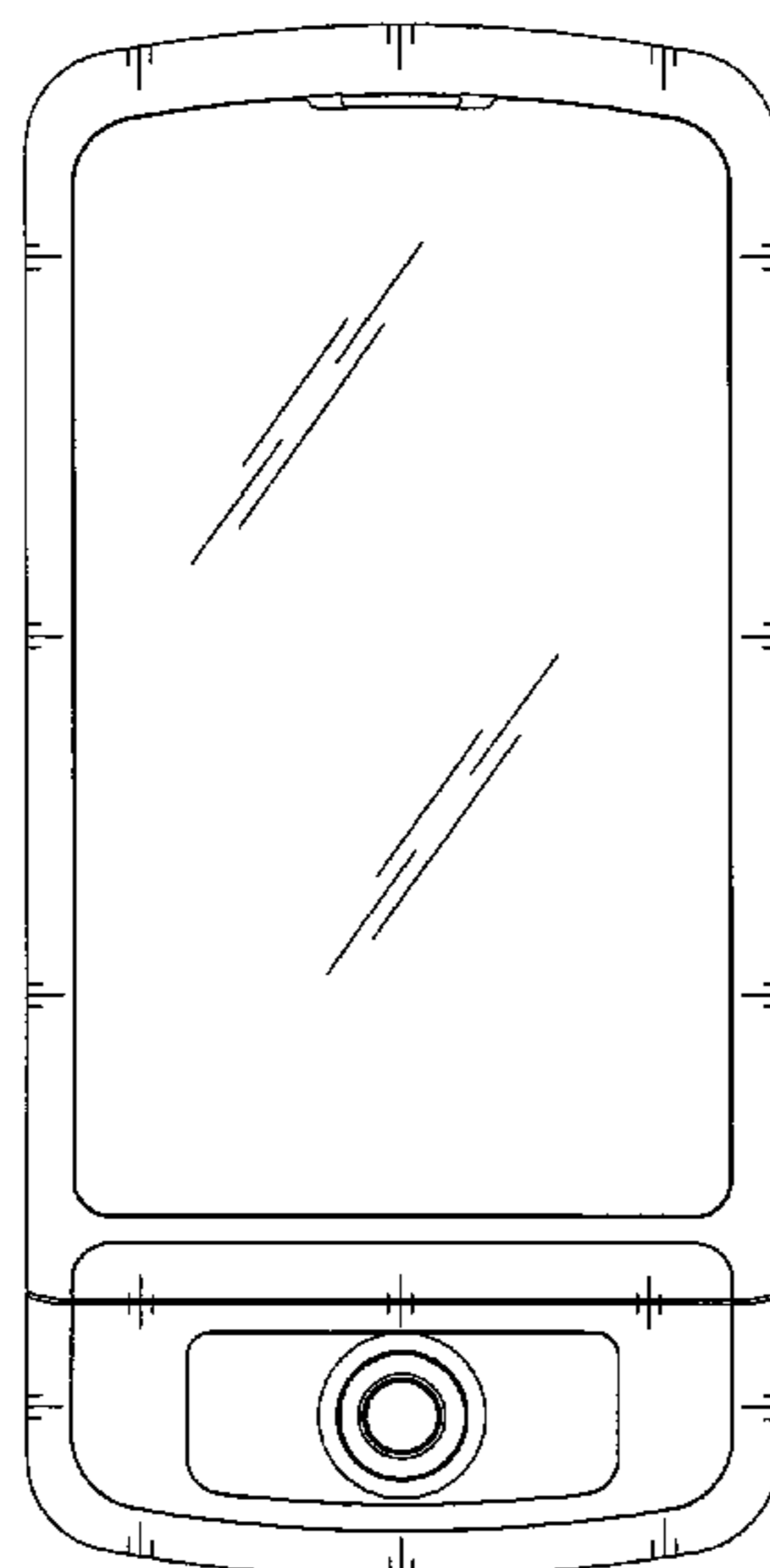

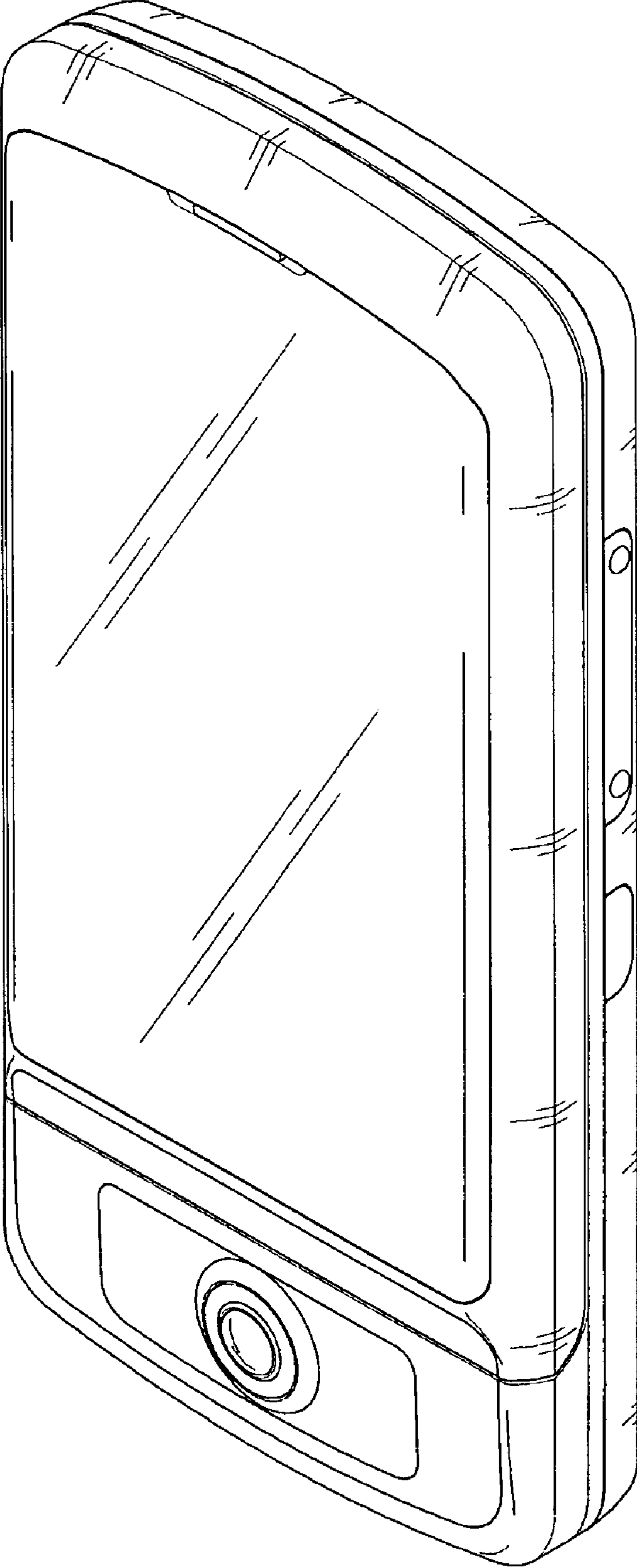

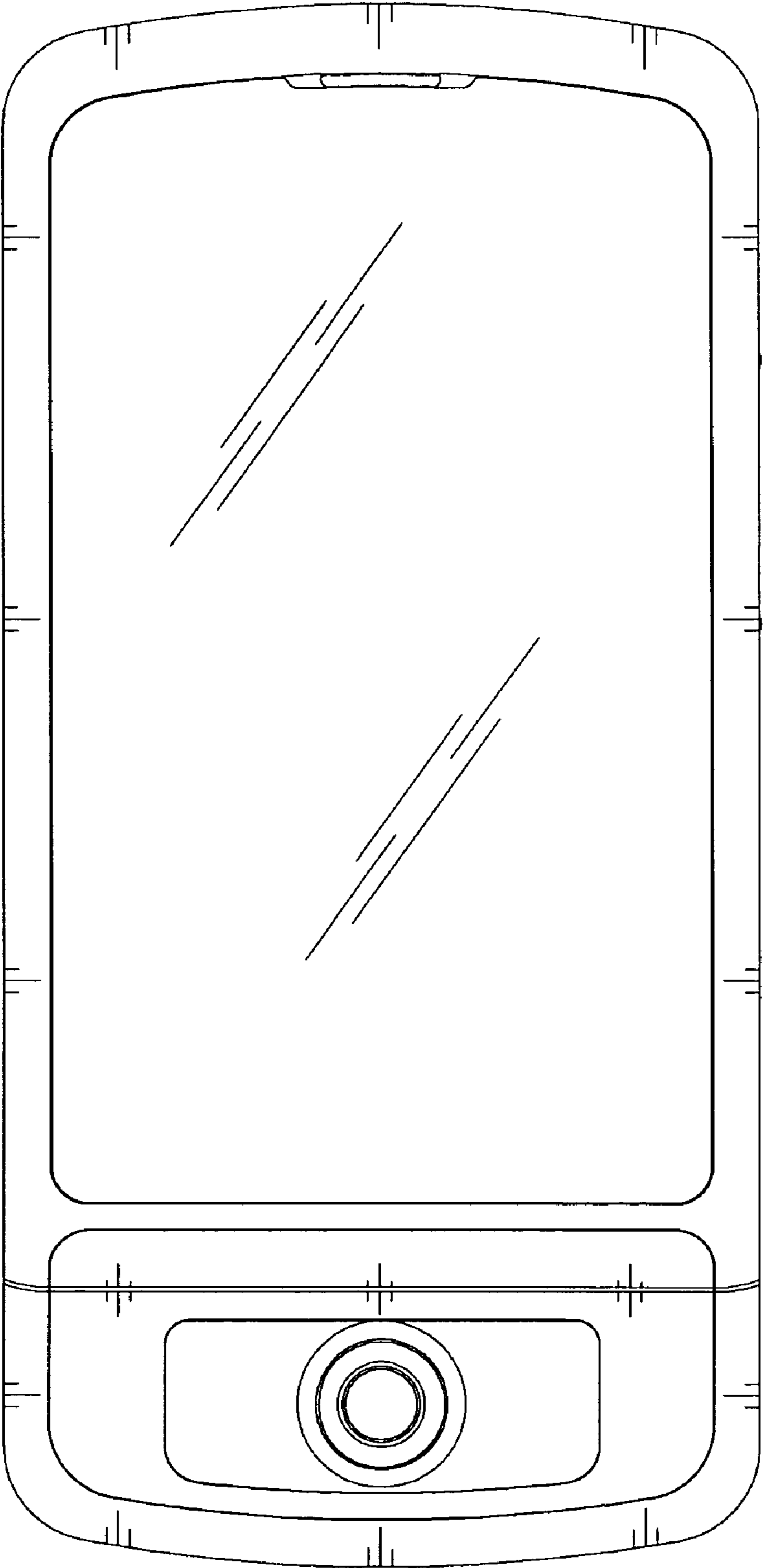

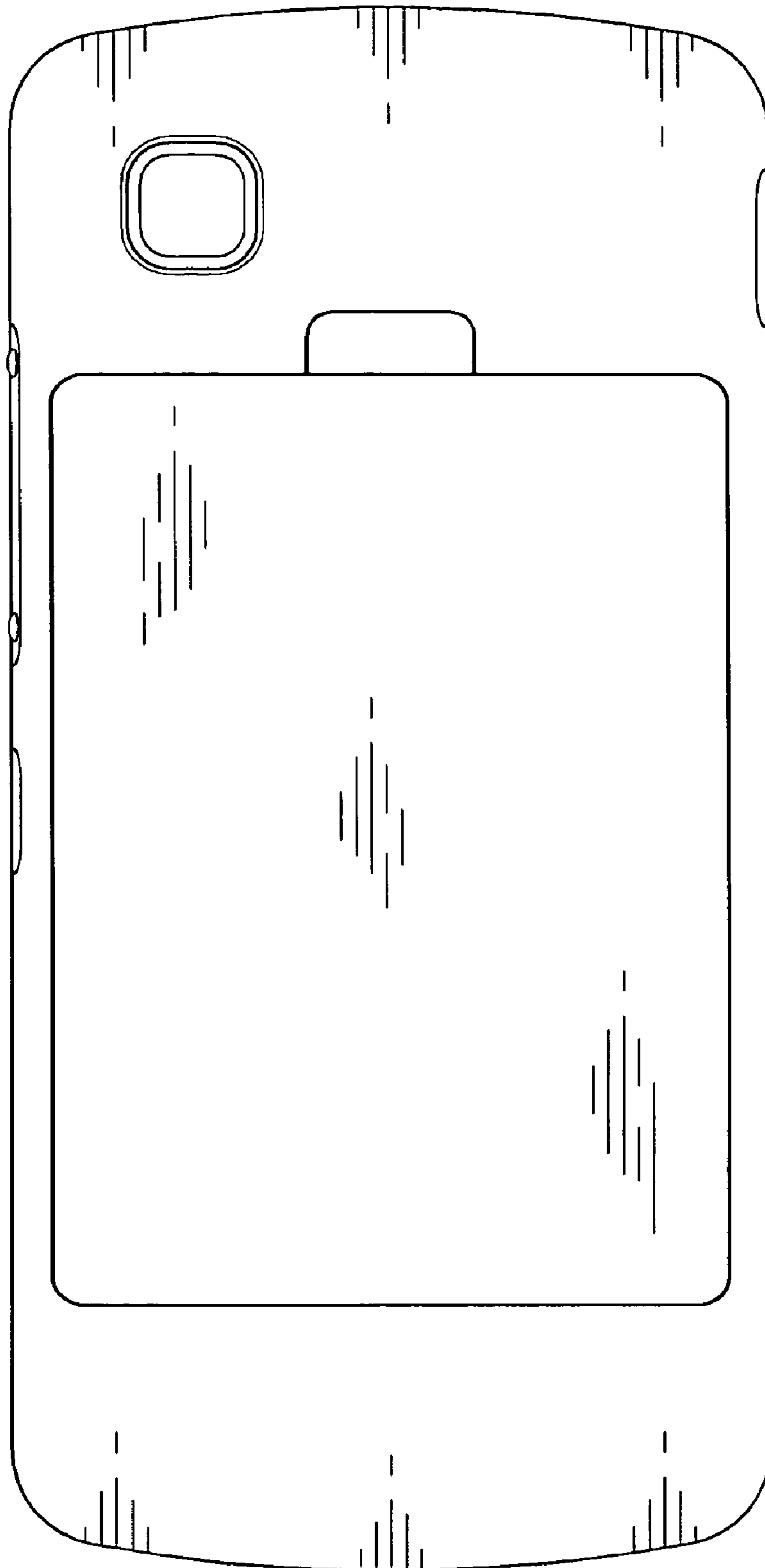

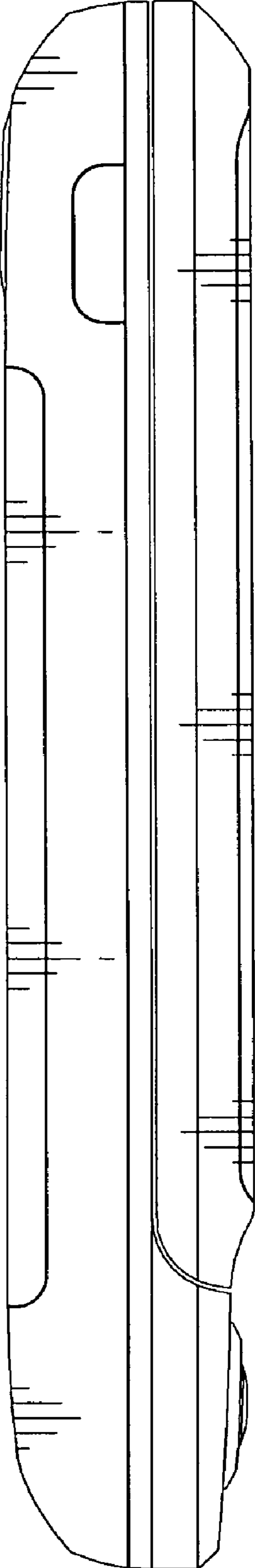

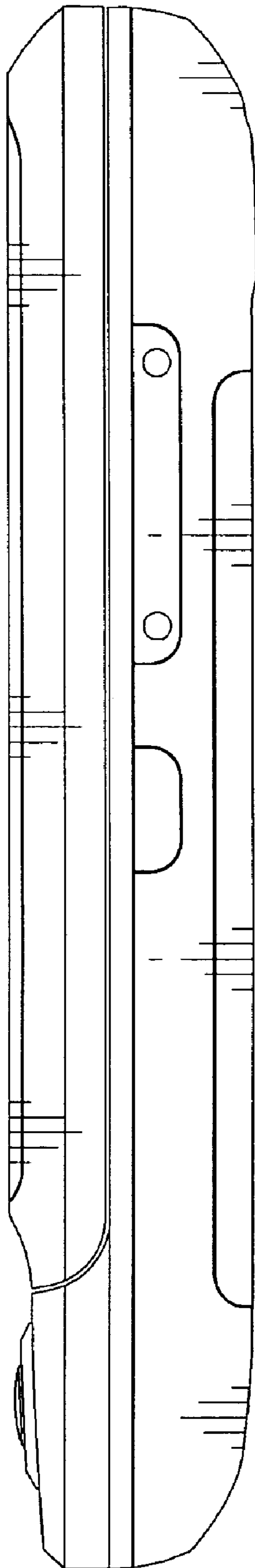

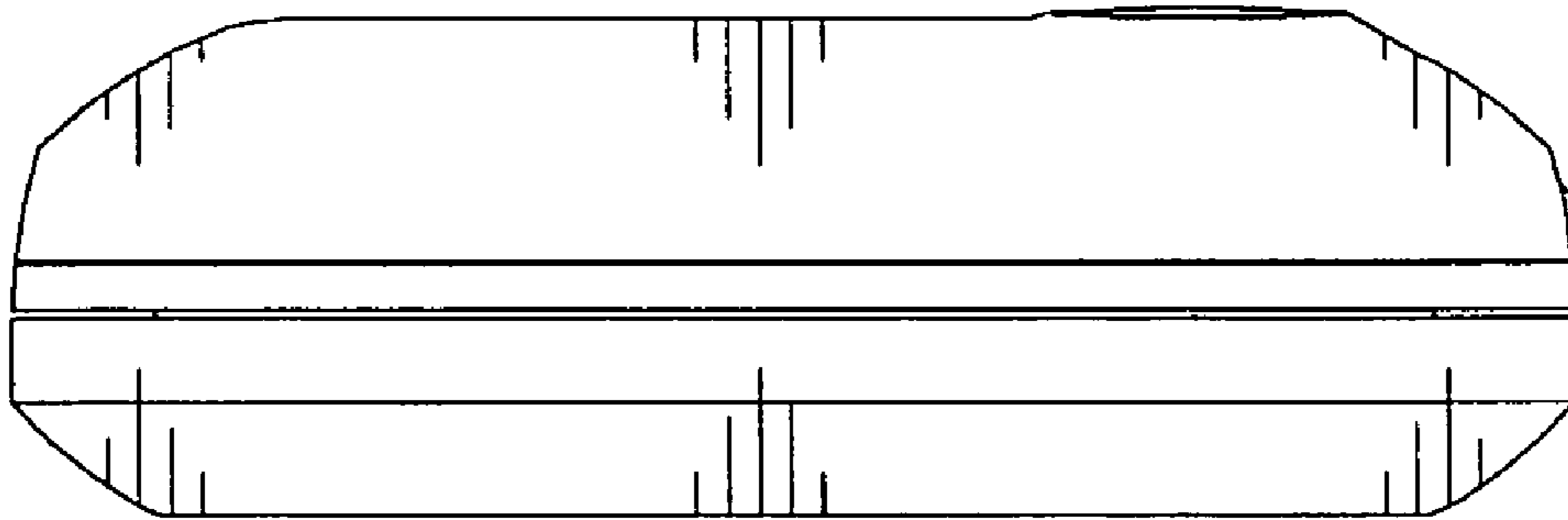

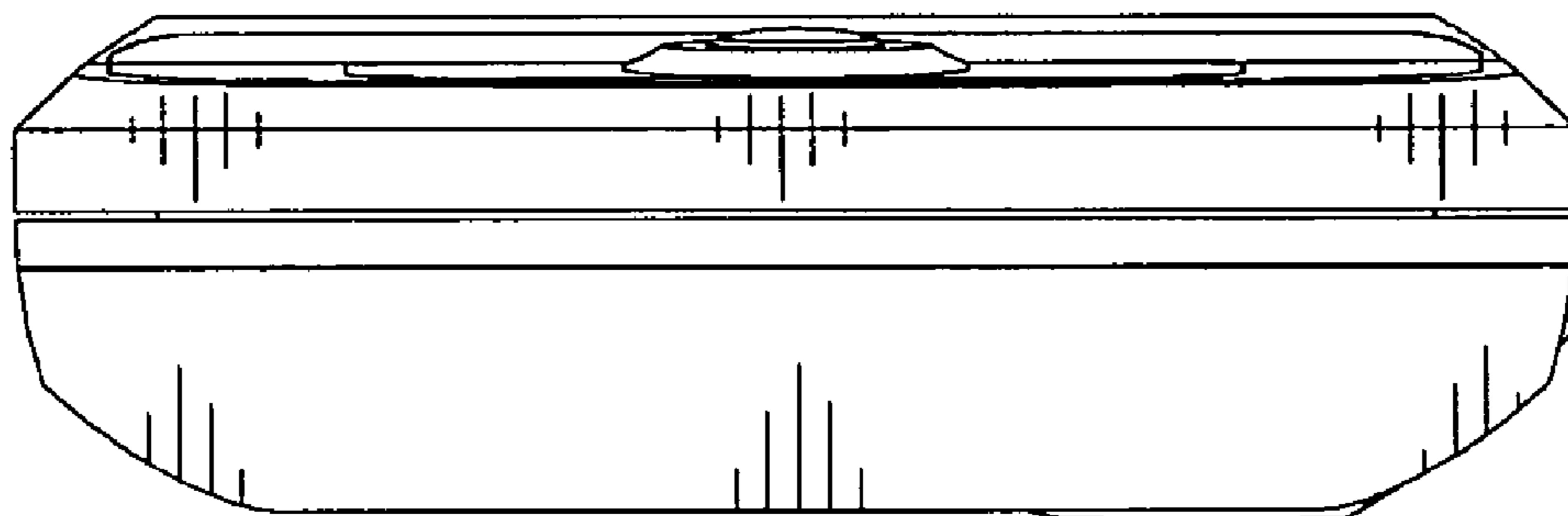
