FIG. 4 is a third side view thereof;

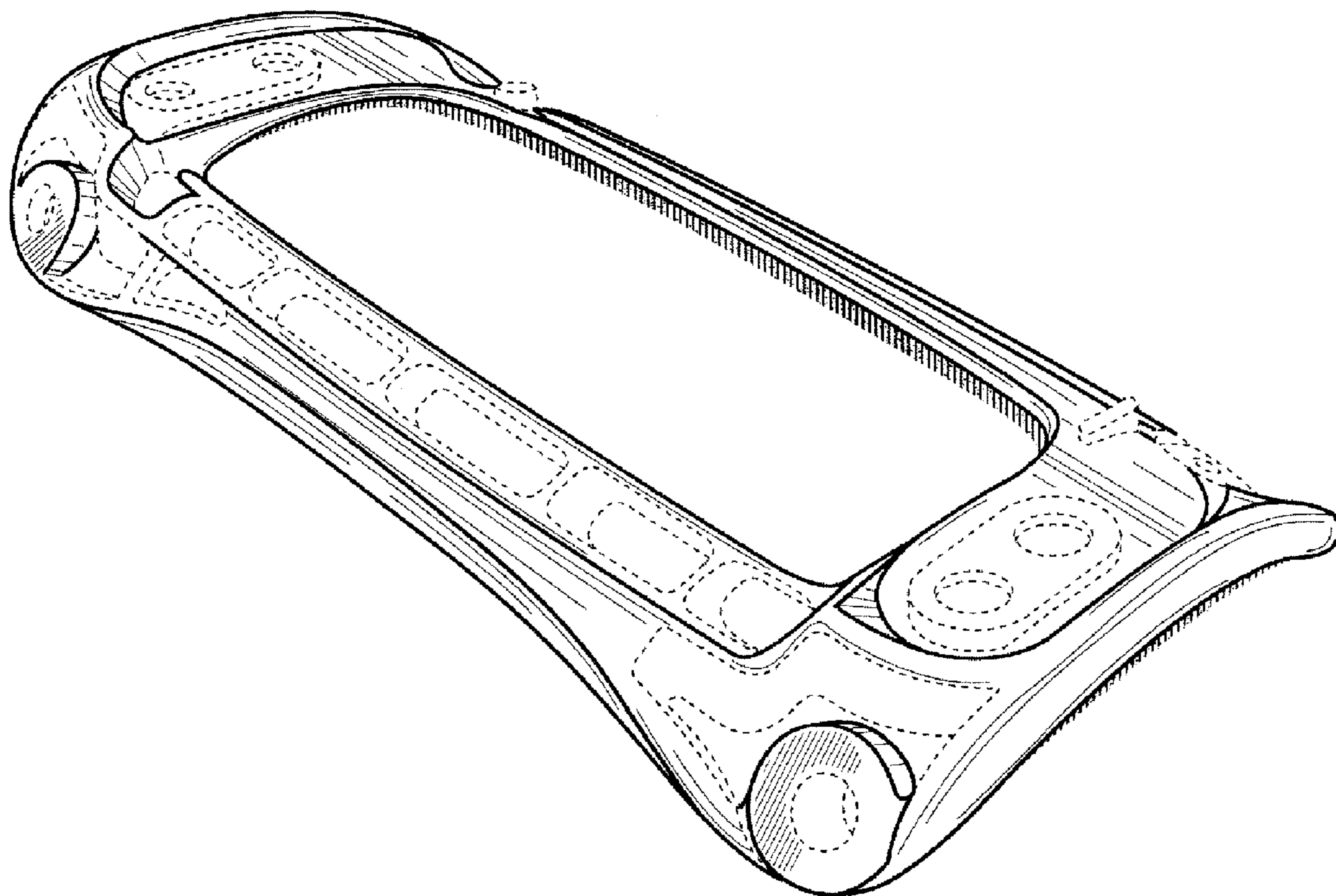
FIG. 5 is a fourth side view thereof;

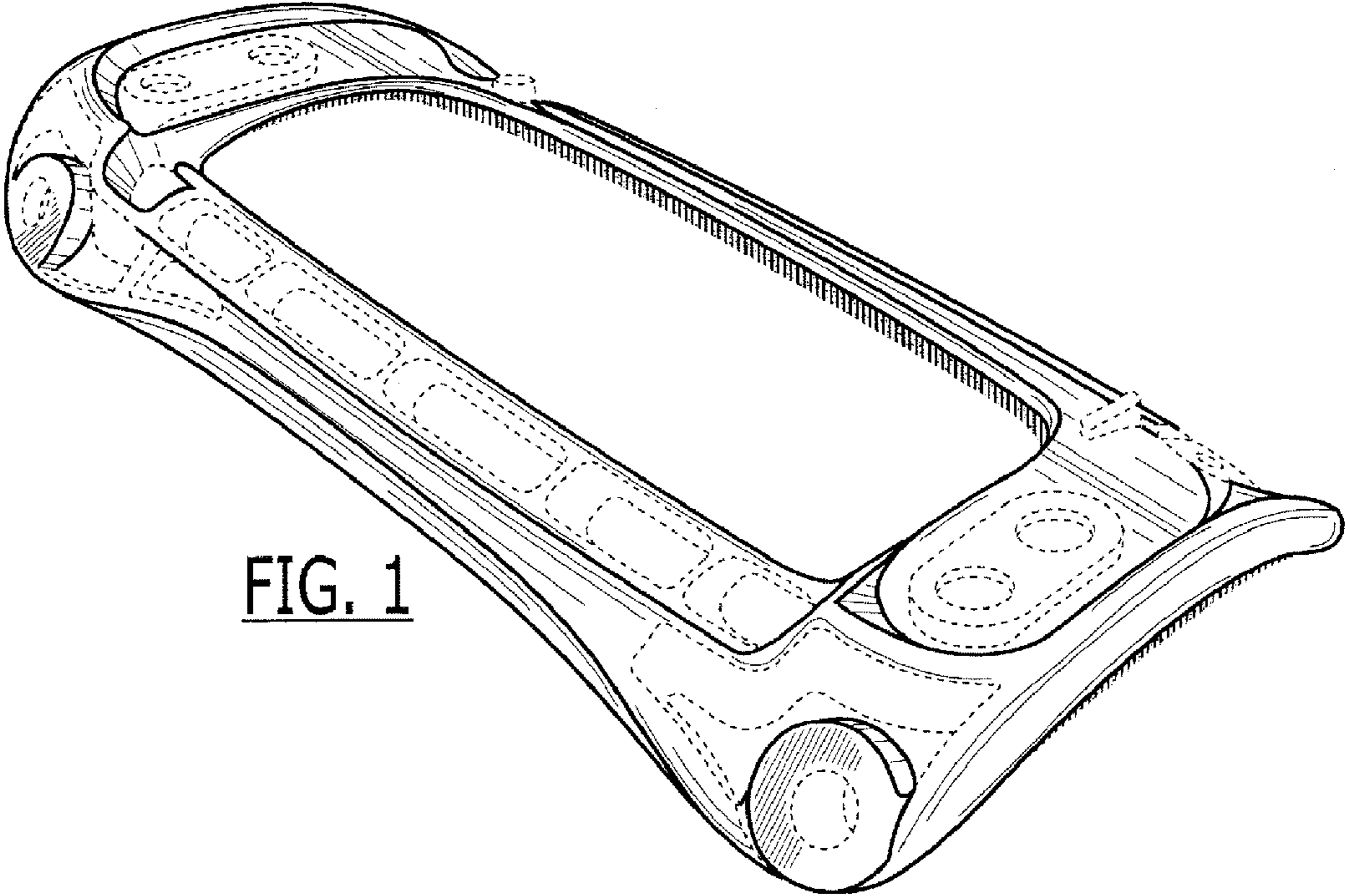

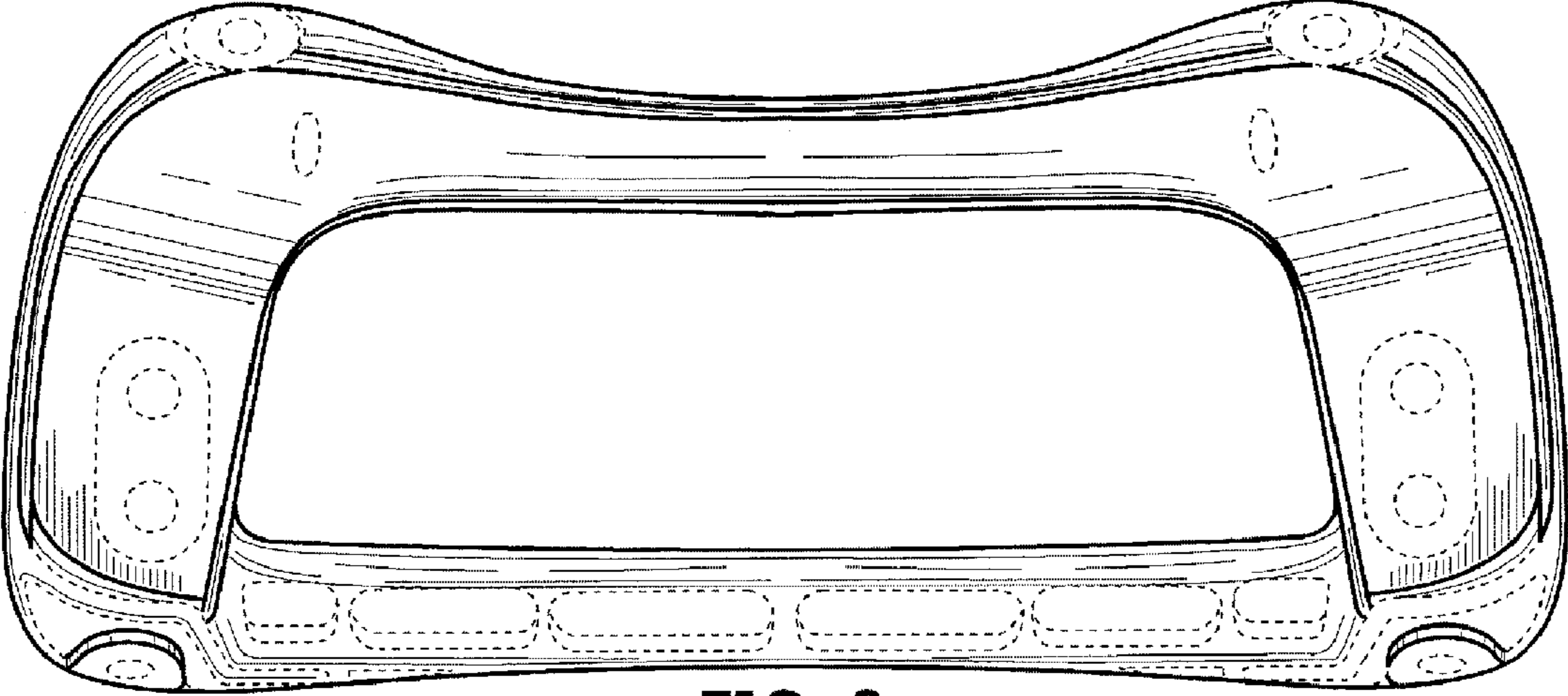

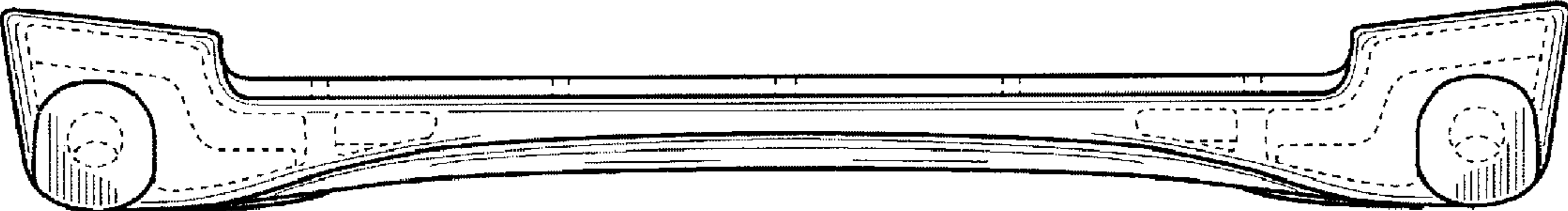

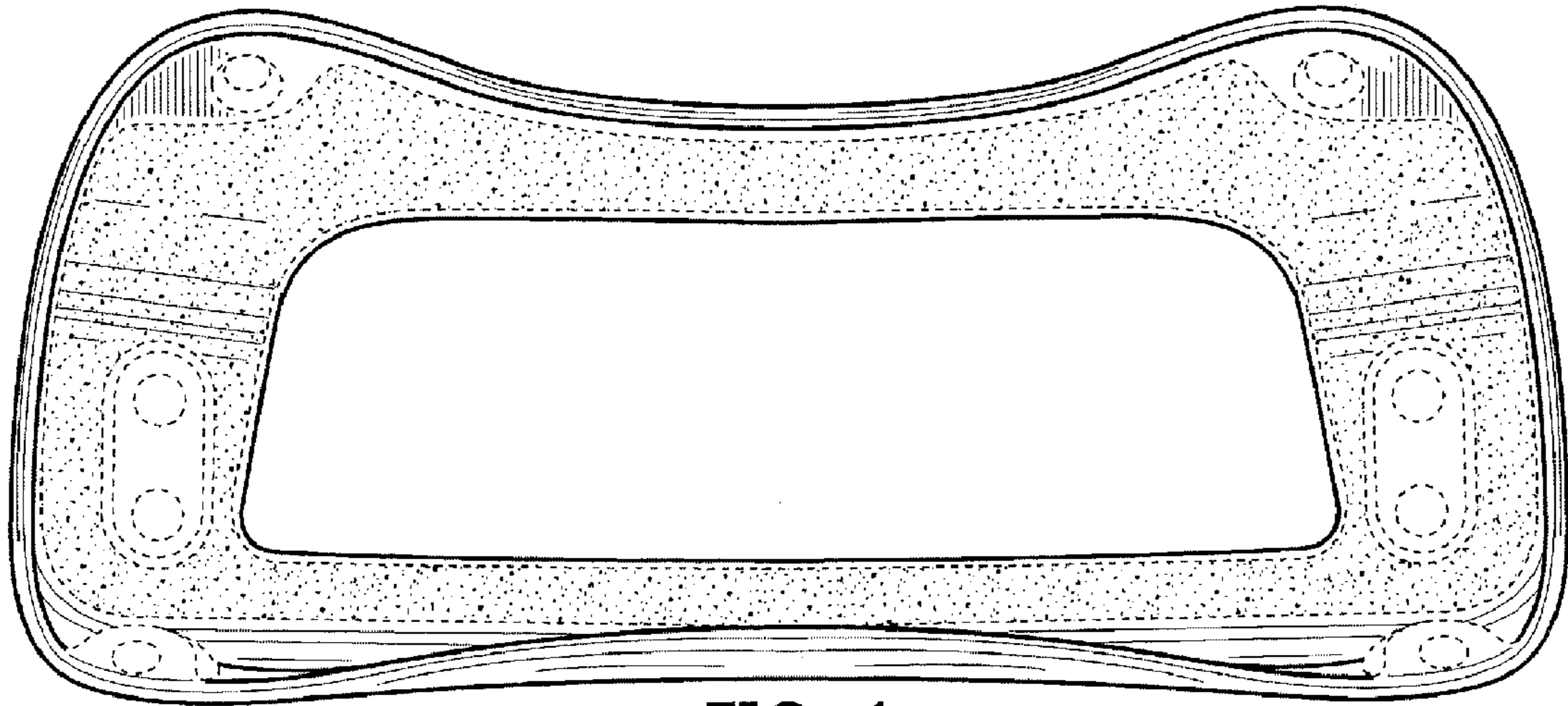

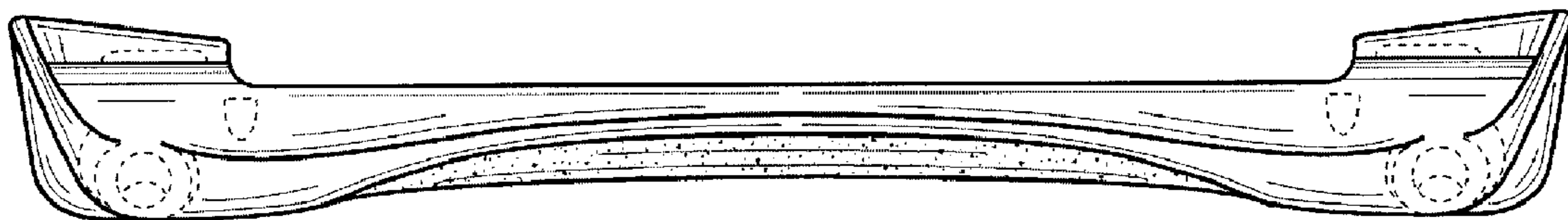

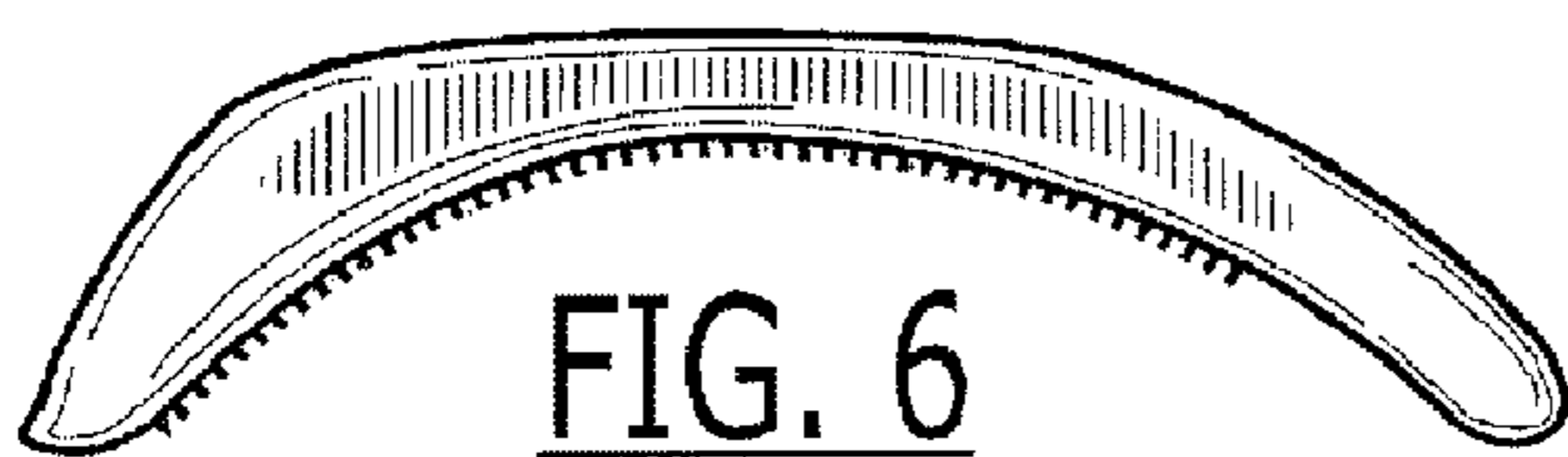

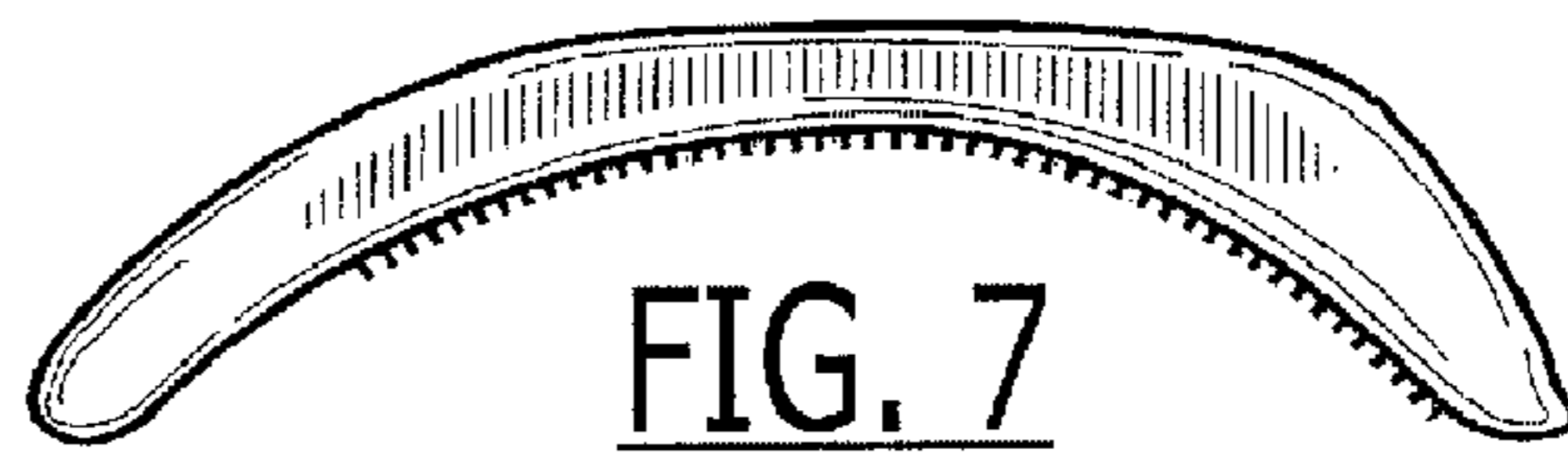
