(57) **CLAIM**

The ornamental design for a highlighter, as shown and described.

**DESCRIPTION**

FIG. 1 is a lower front left perspective view of a highlighter showing my new design;

FIG. 2 is an exploded front left perspective view thereof;

FIG. 3 is a front elevation view of the highlighter shown in FIG. 1, with the cap removed and placed on the opposite end of the highlighter;

FIG. 4 is a top plan view of the highlighter shown in FIG. 1;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a front elevation view thereof;

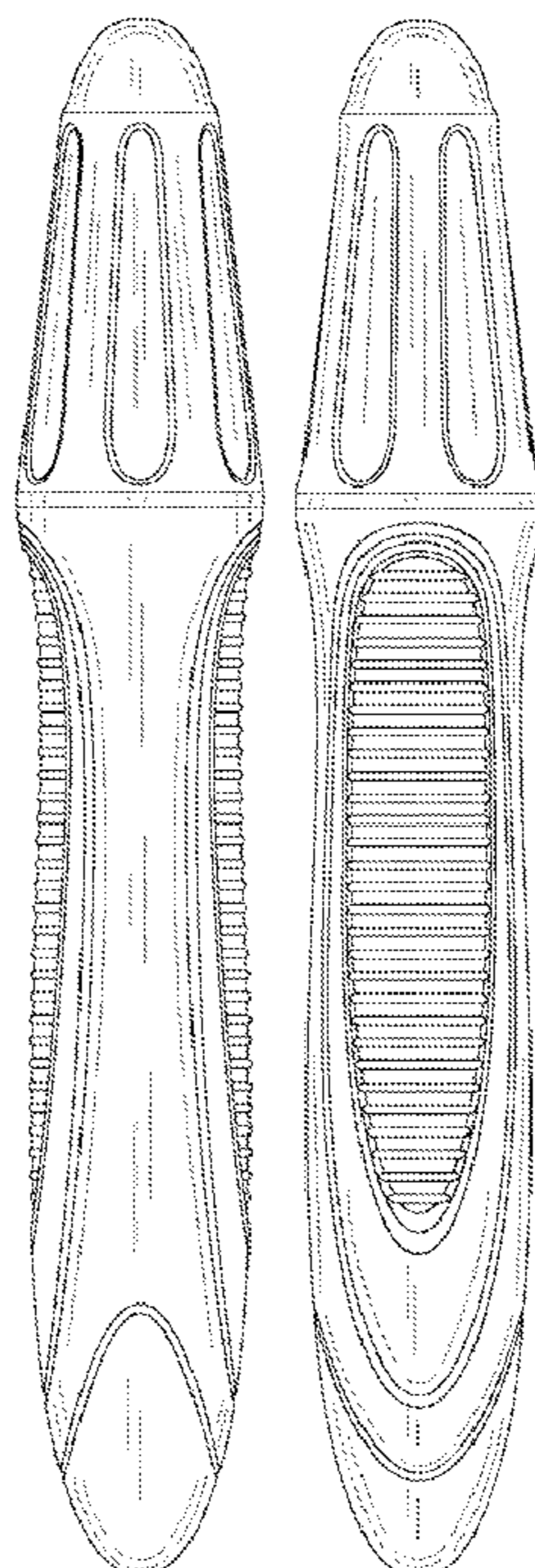
FIG. 7 is a right side elevation view thereof;

FIG. 8 is a rear elevation view thereof; and,

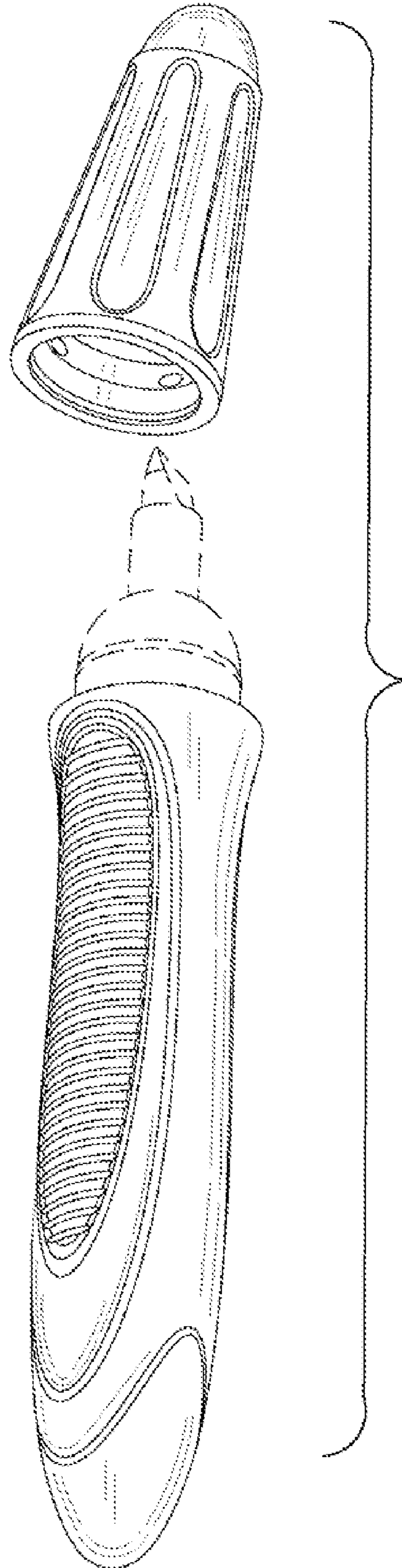
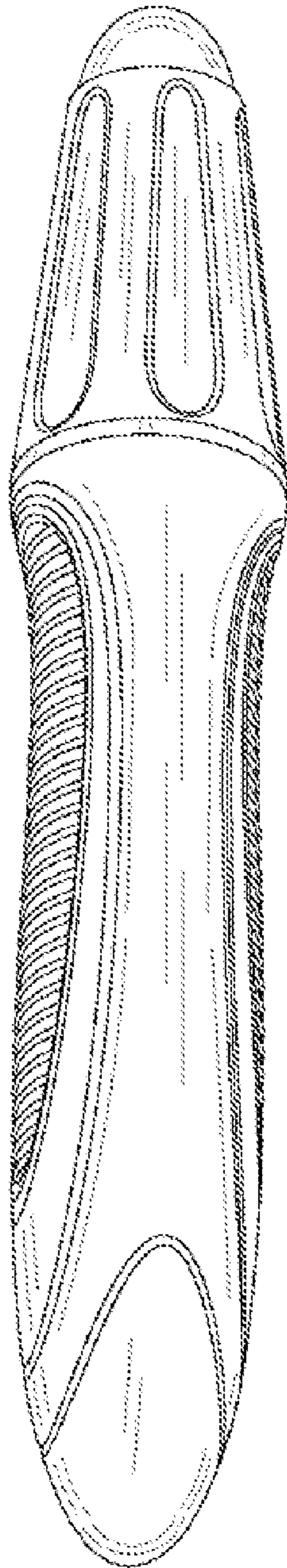
FIG. 9 is a left side elevation view thereof.

The broken lines shown in FIGS. 2 and 3 illustrate environment and form no part of the claimed design.

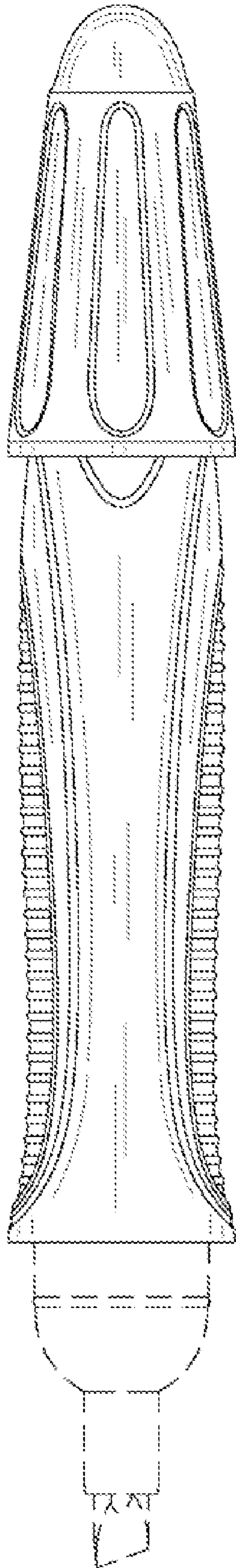

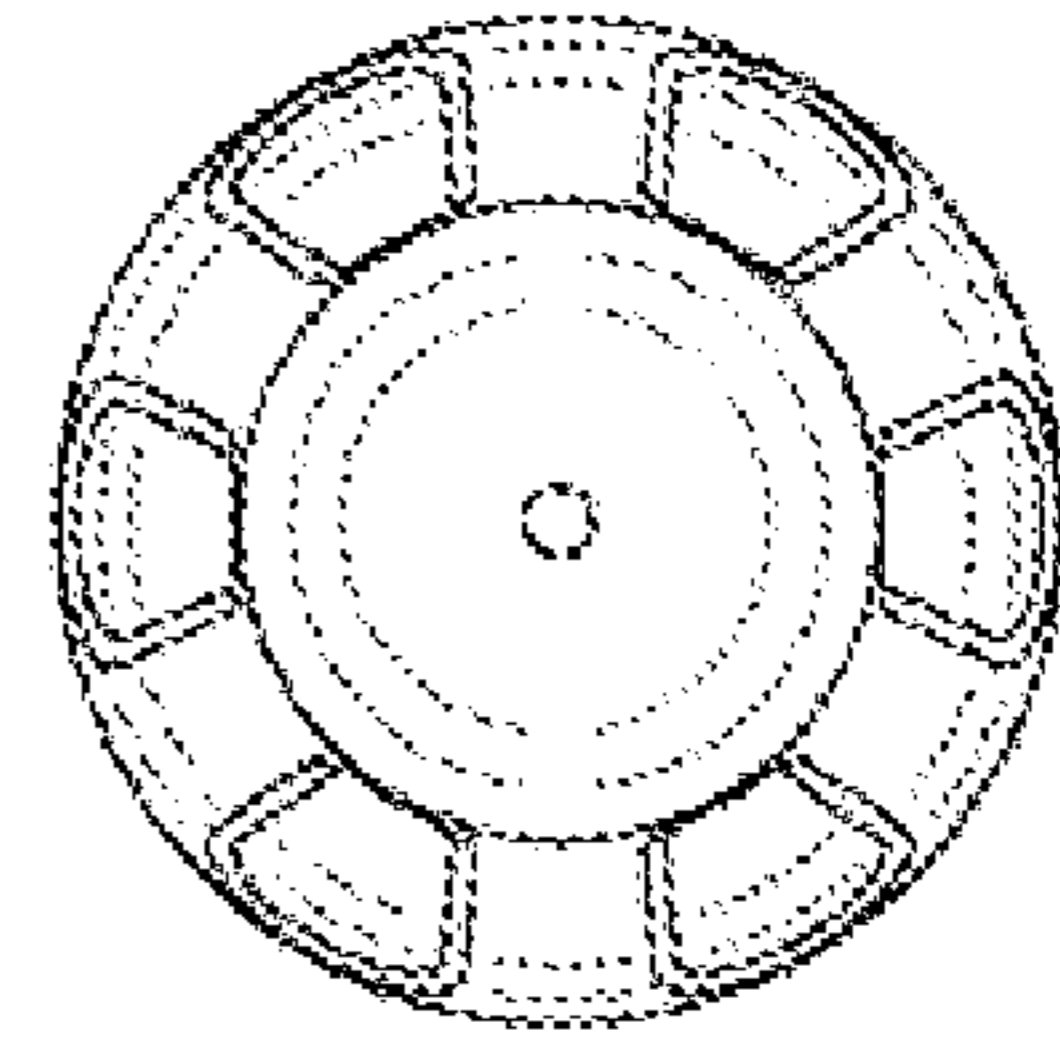

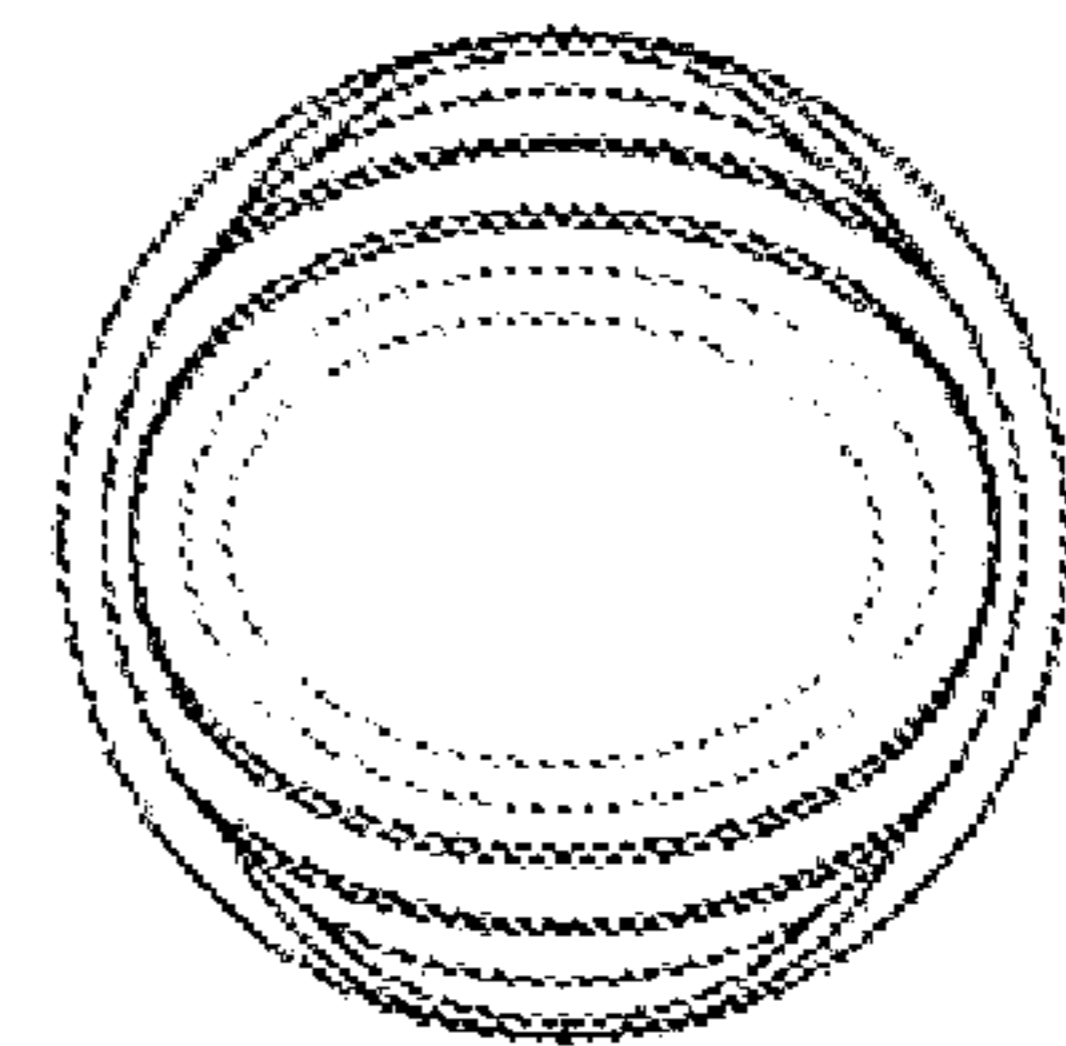

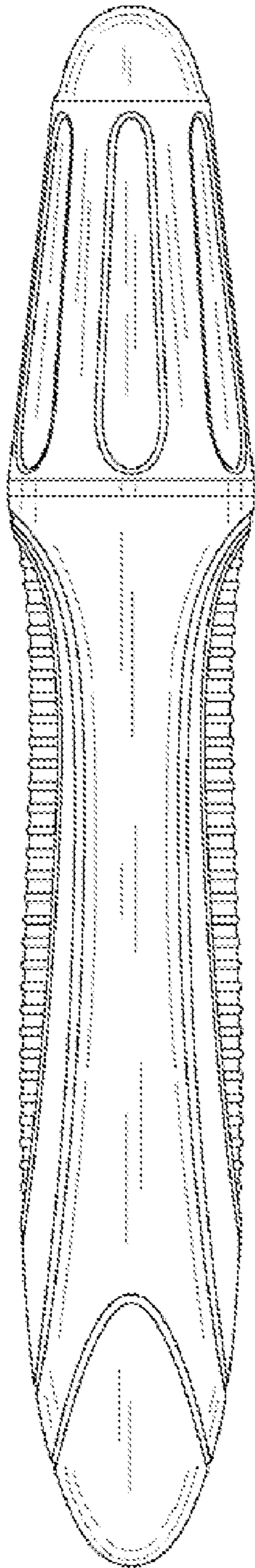

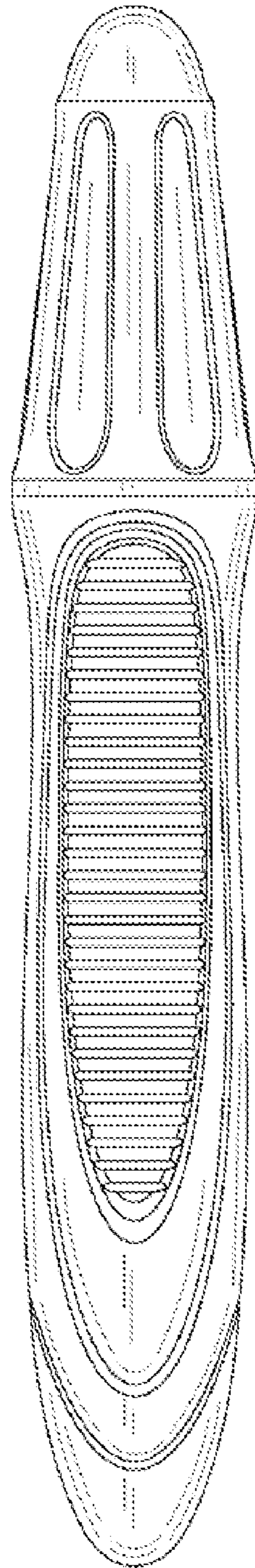

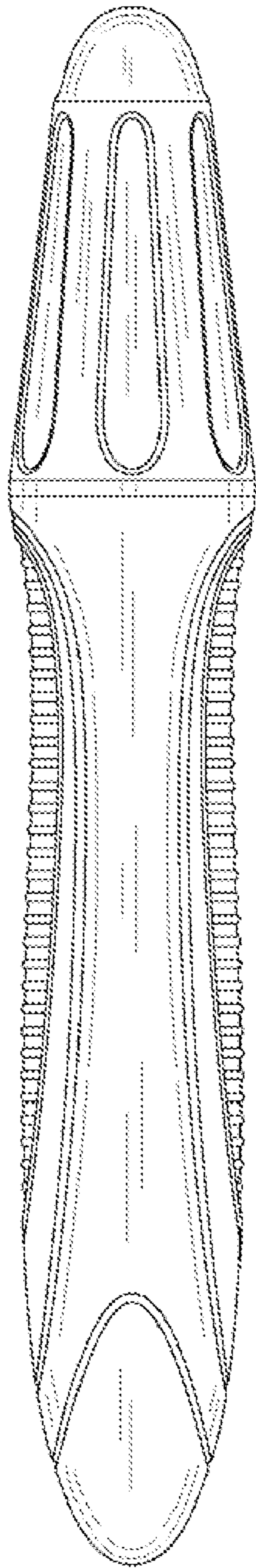

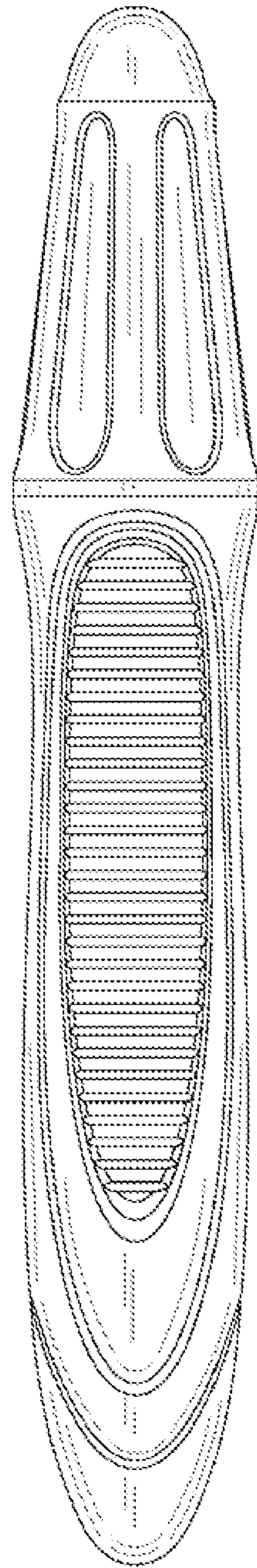
