hook and propeller.

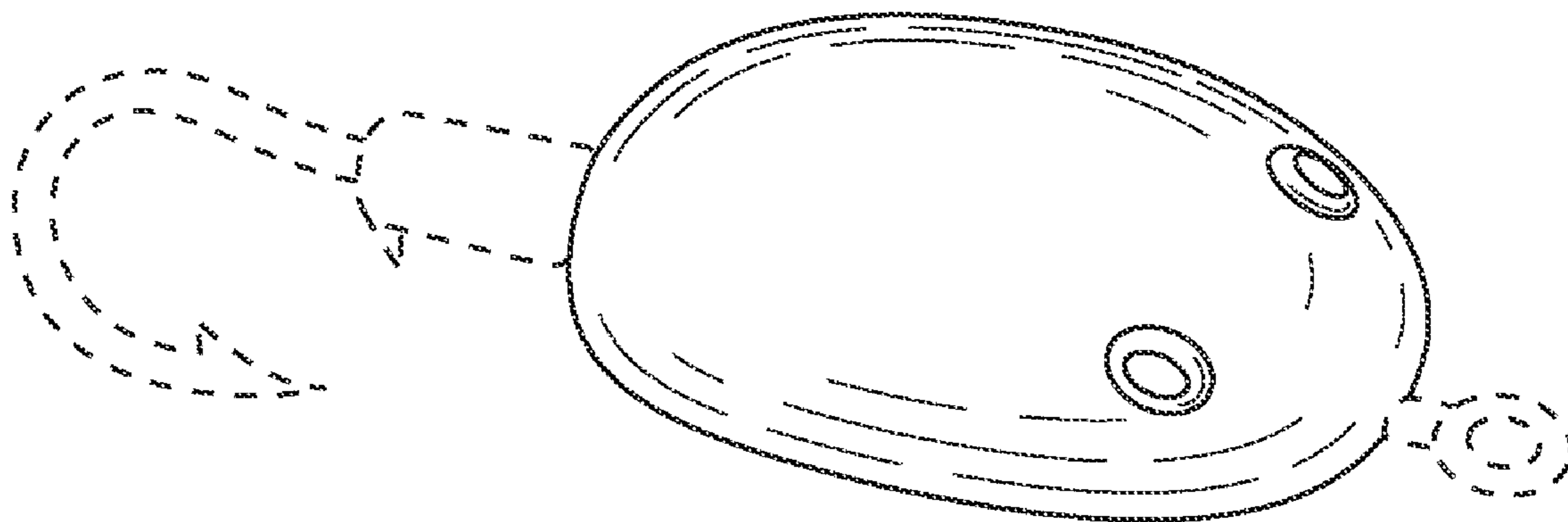

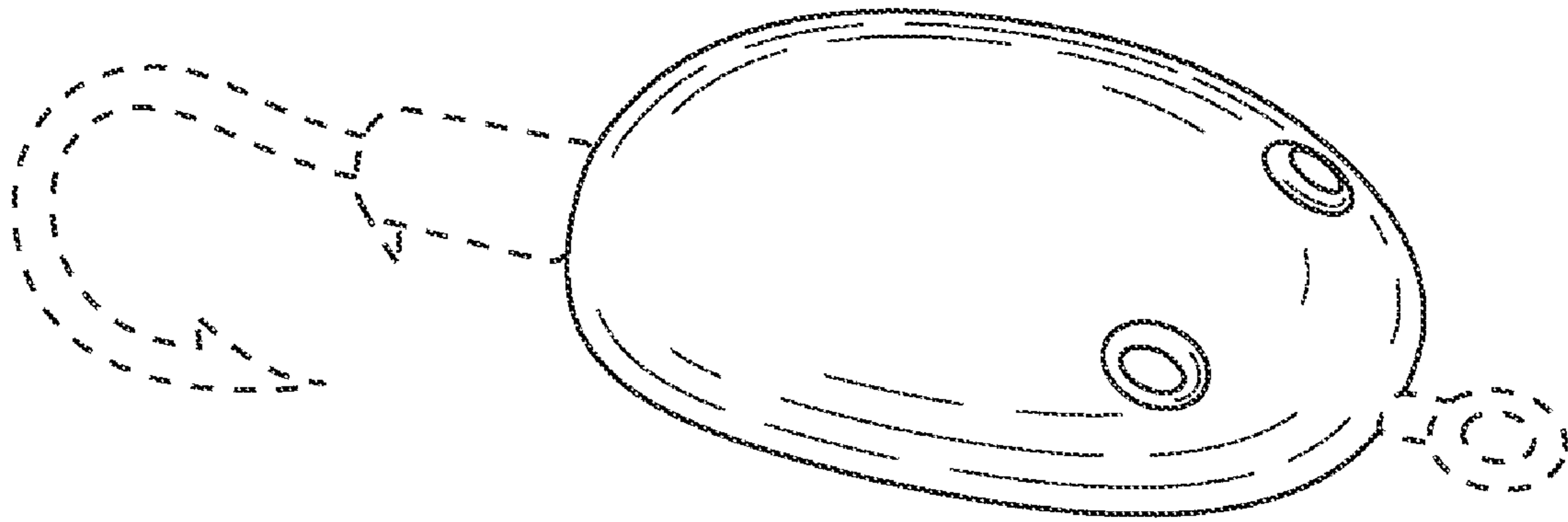

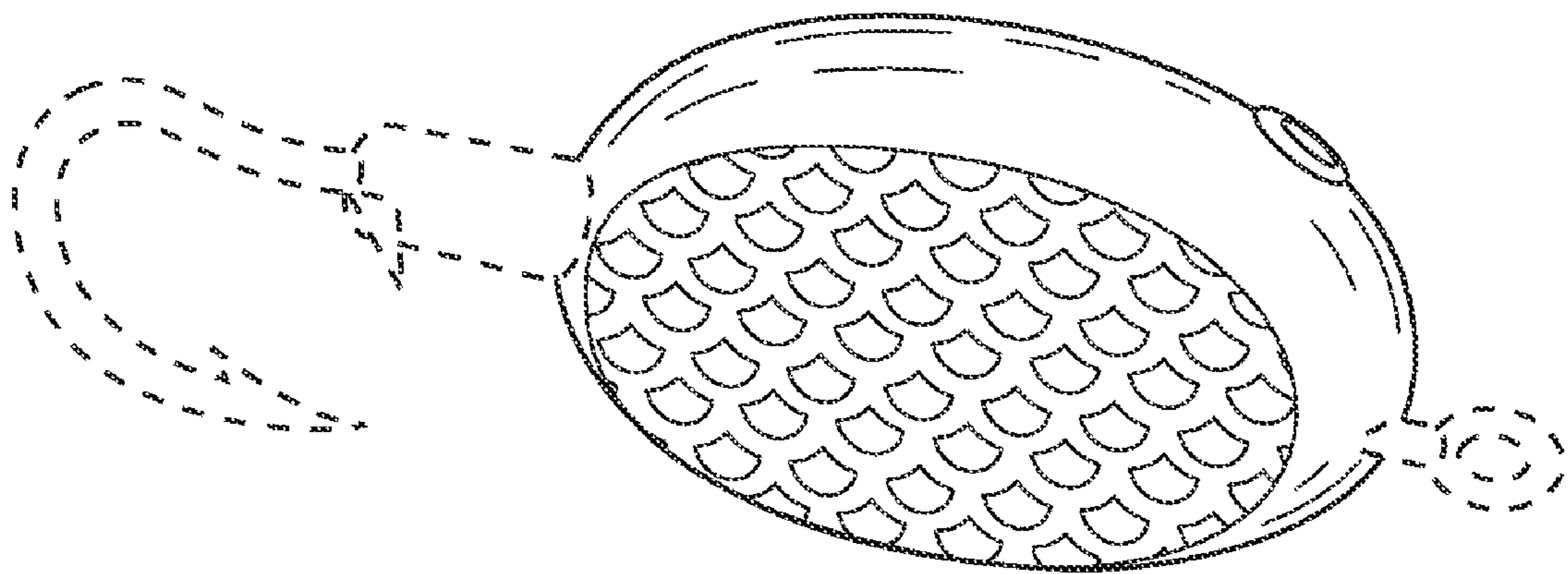

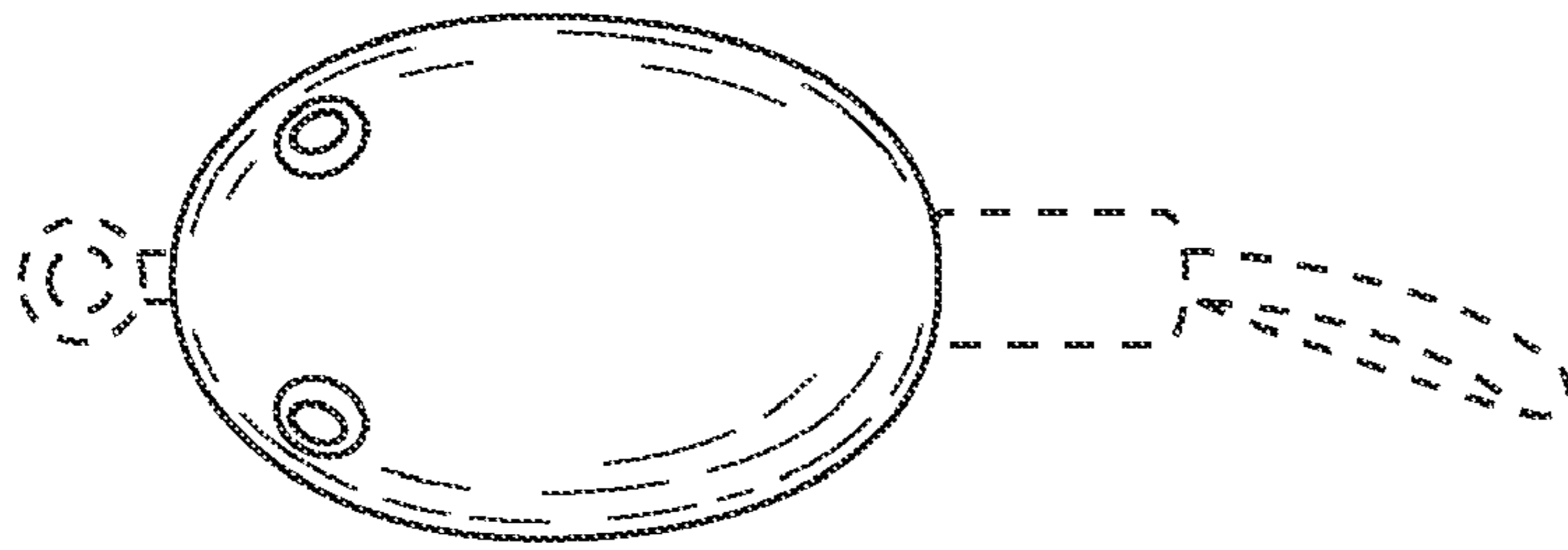

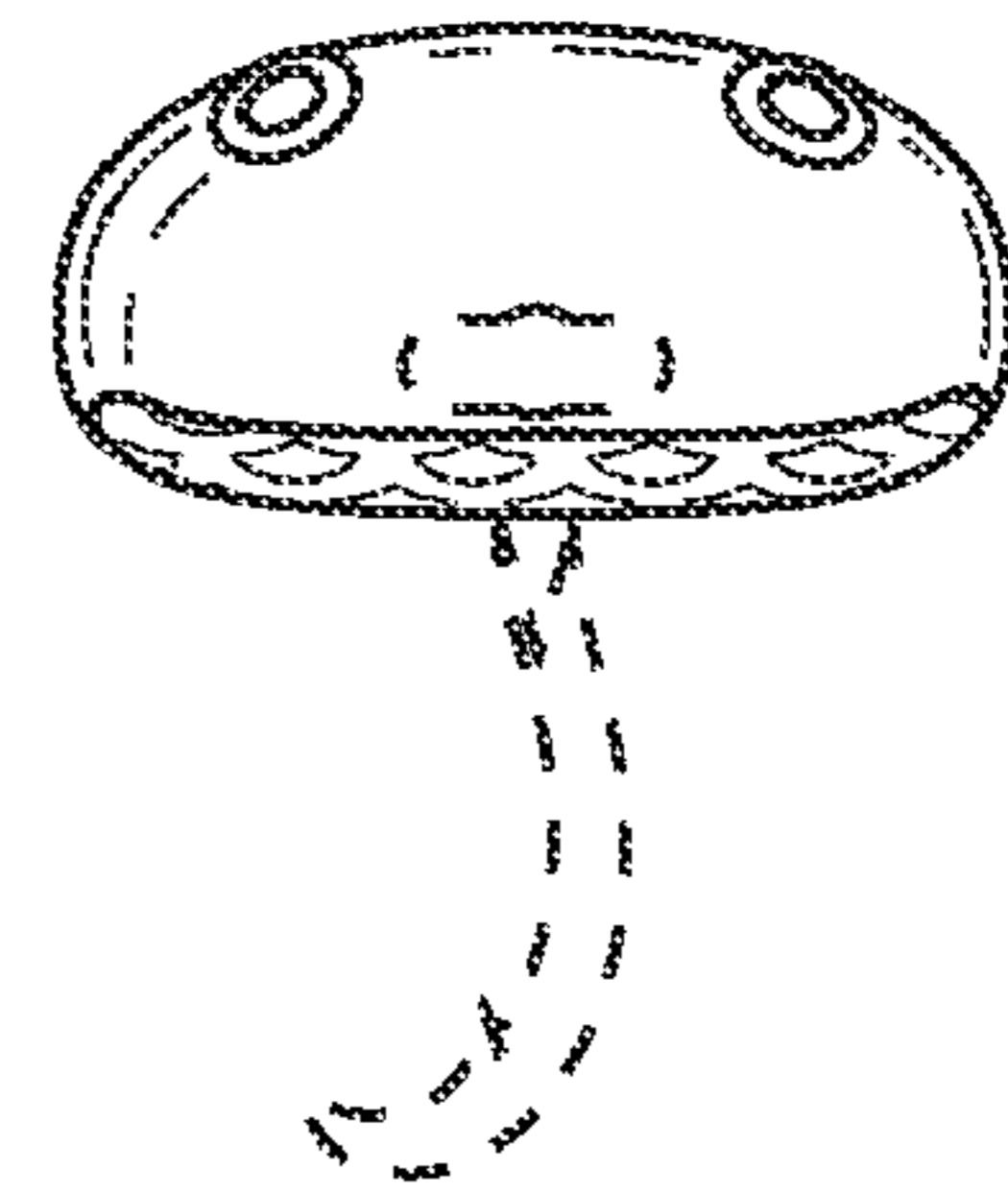

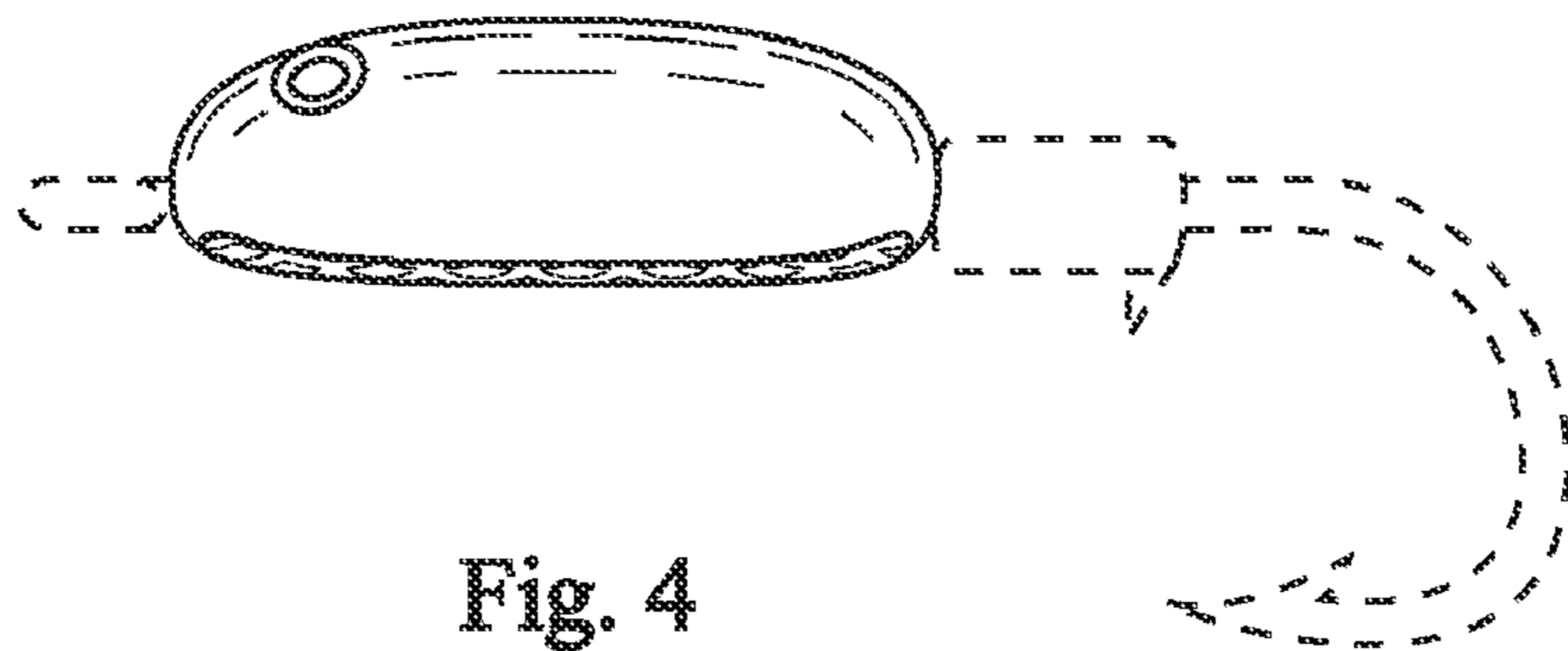

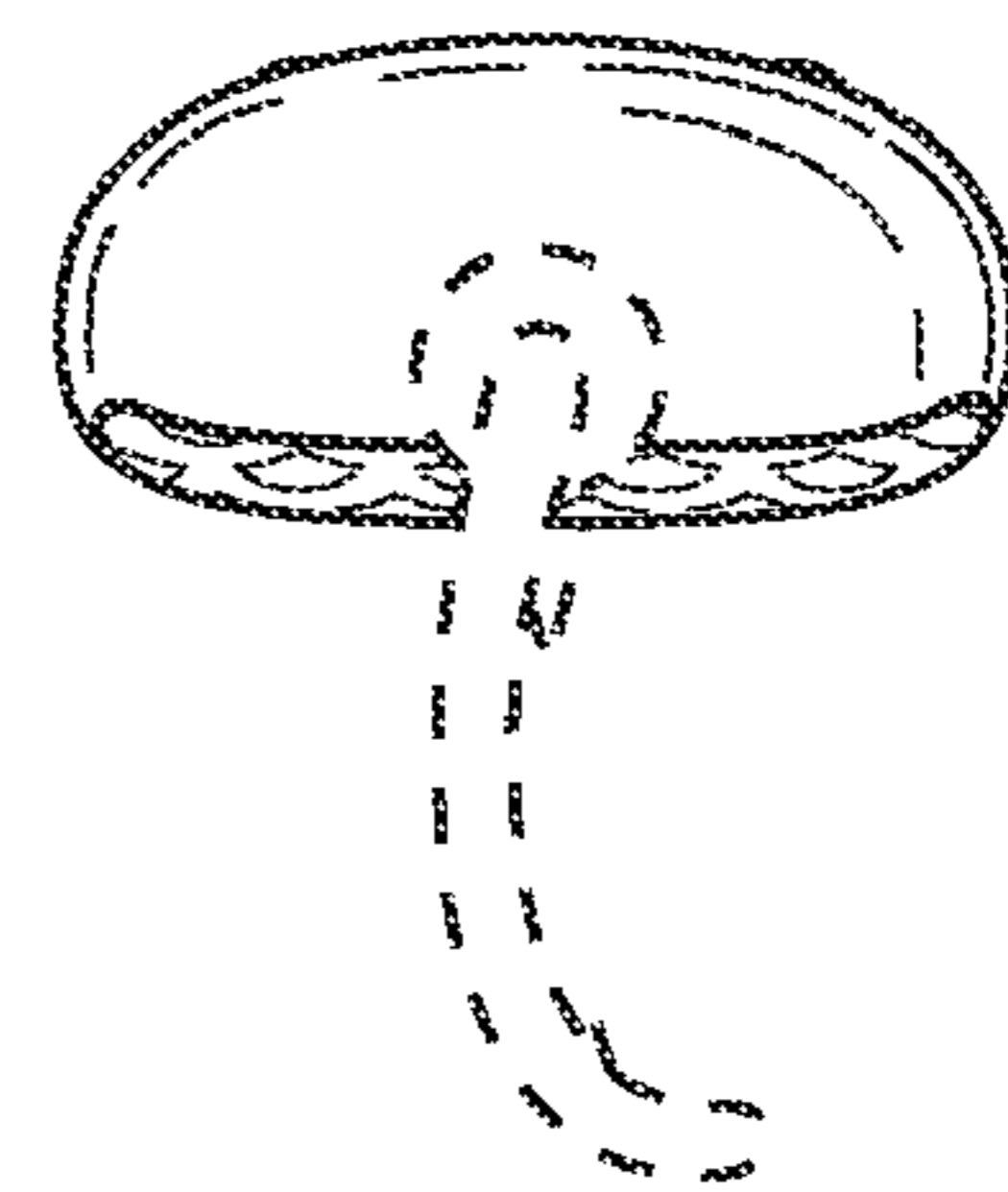

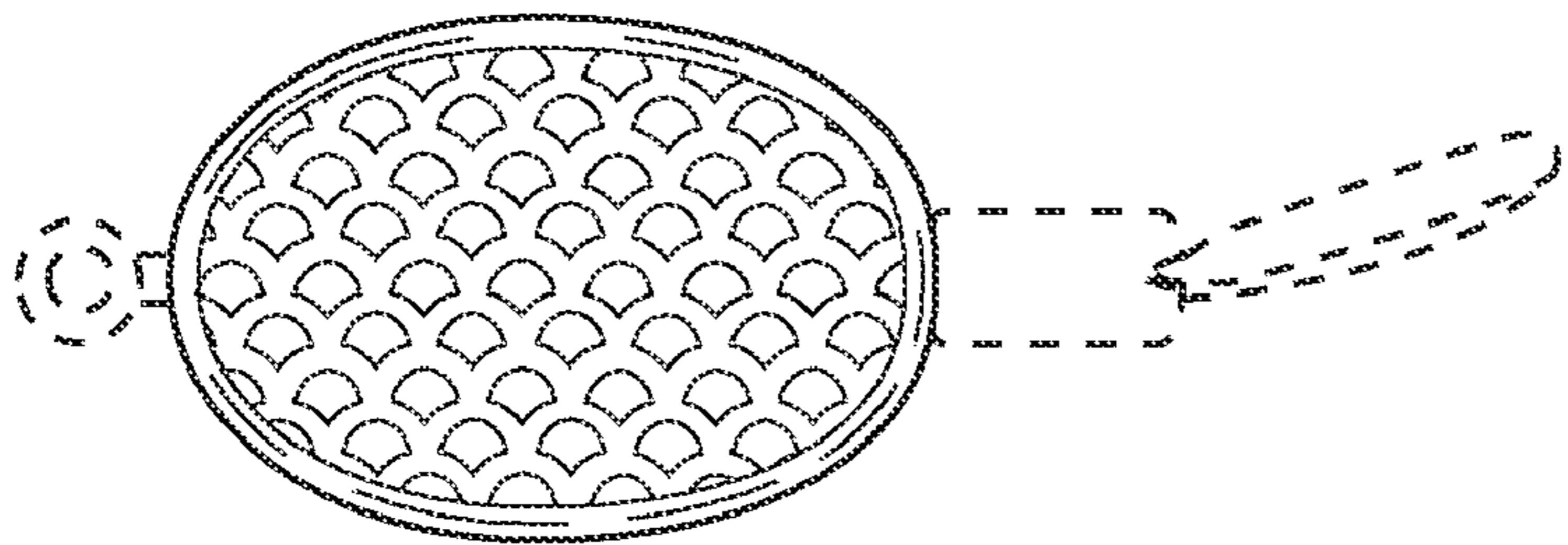

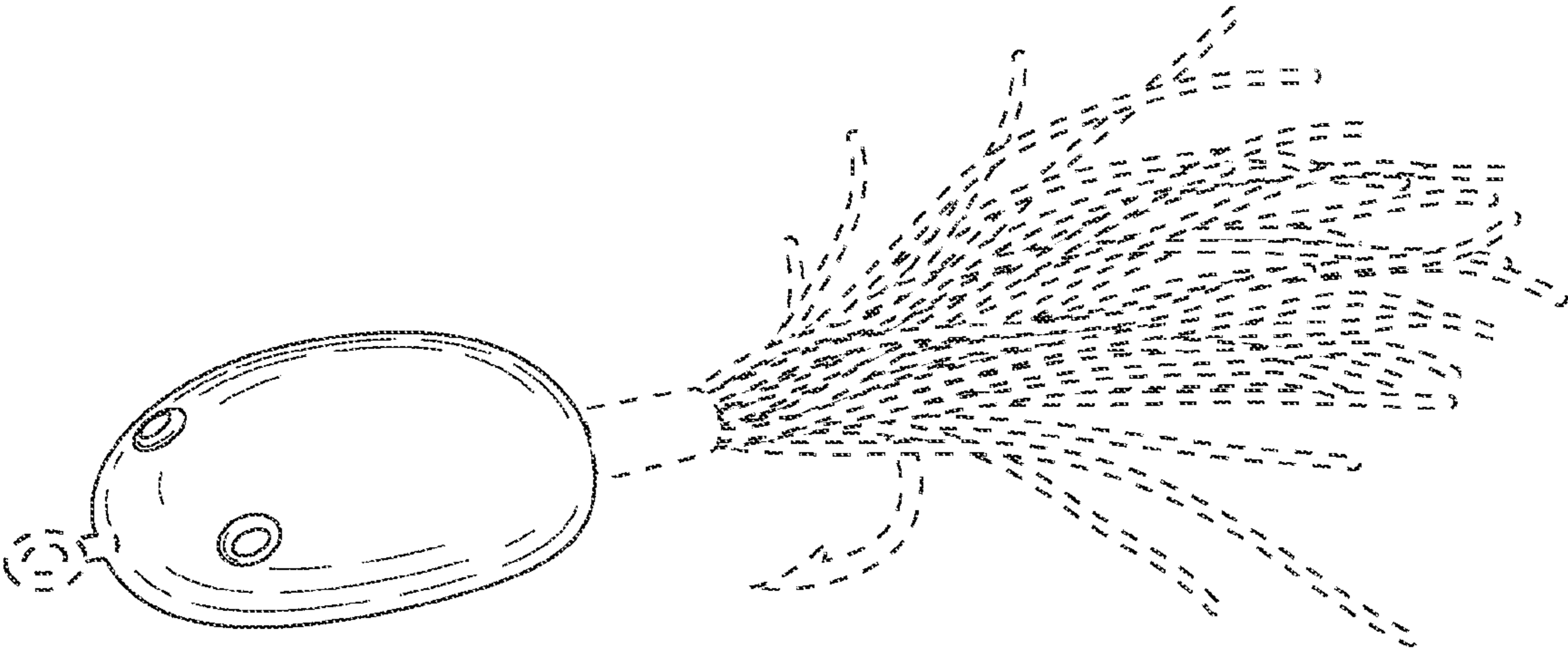

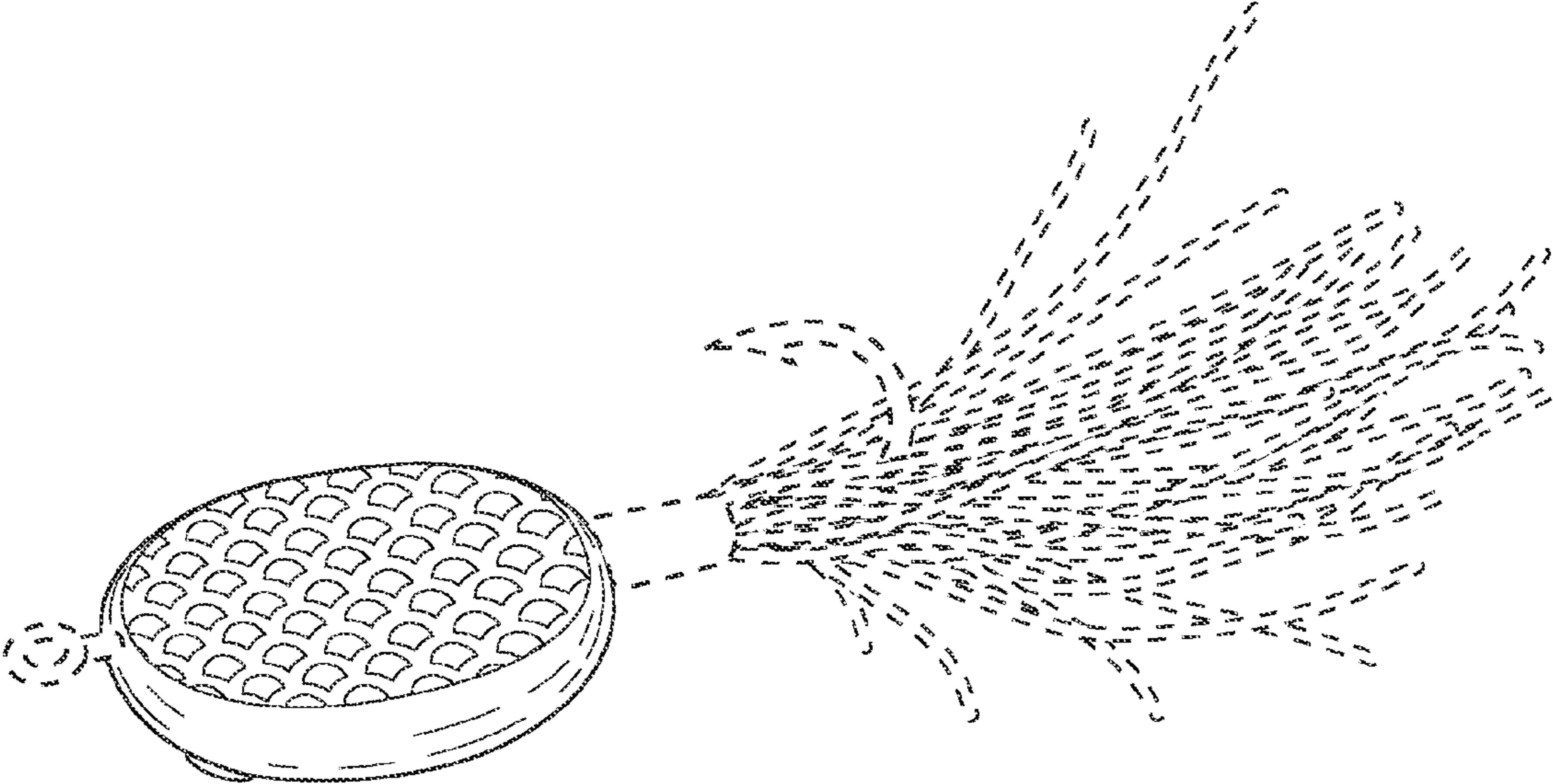

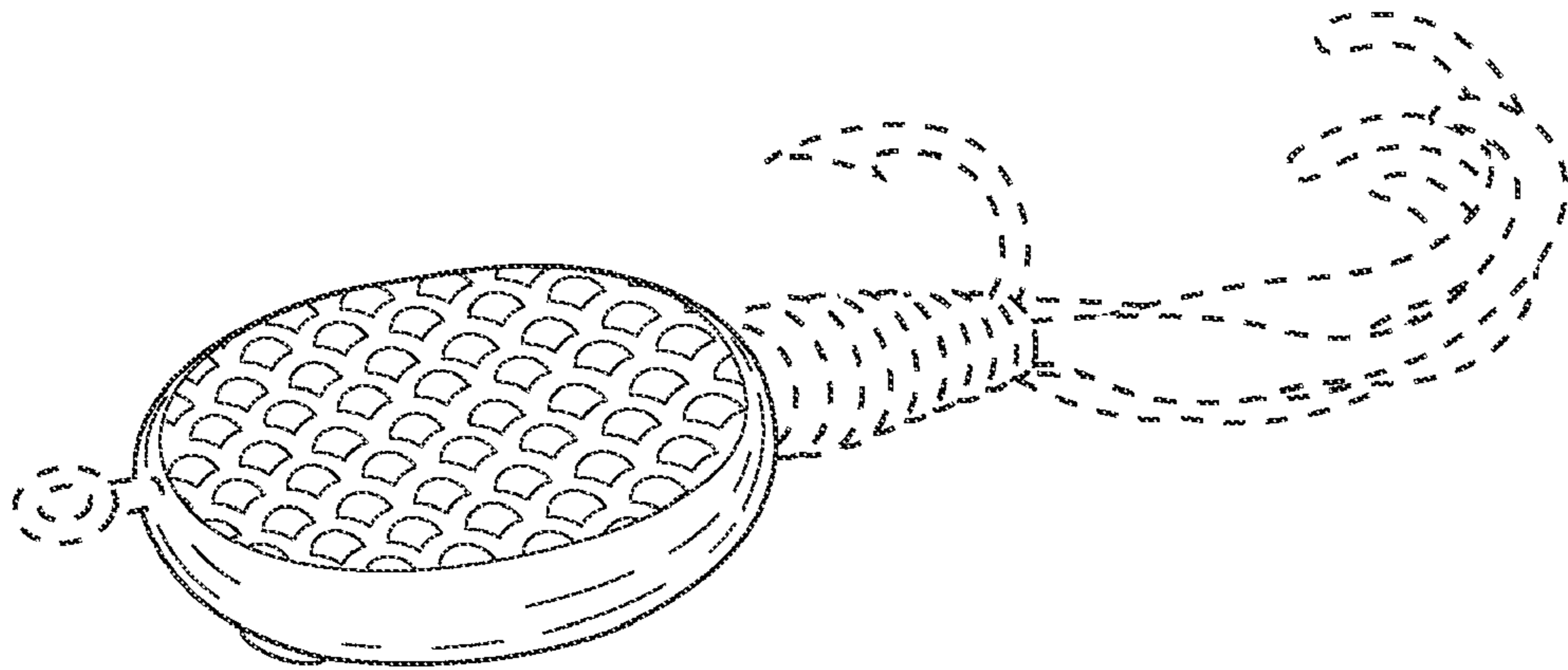

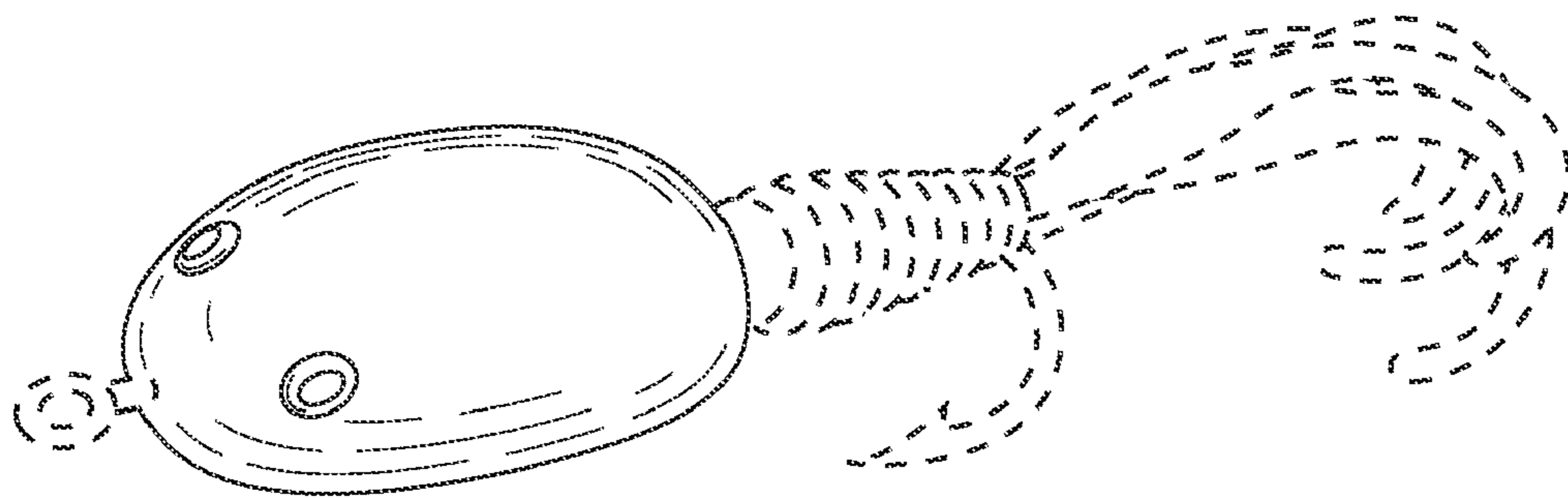

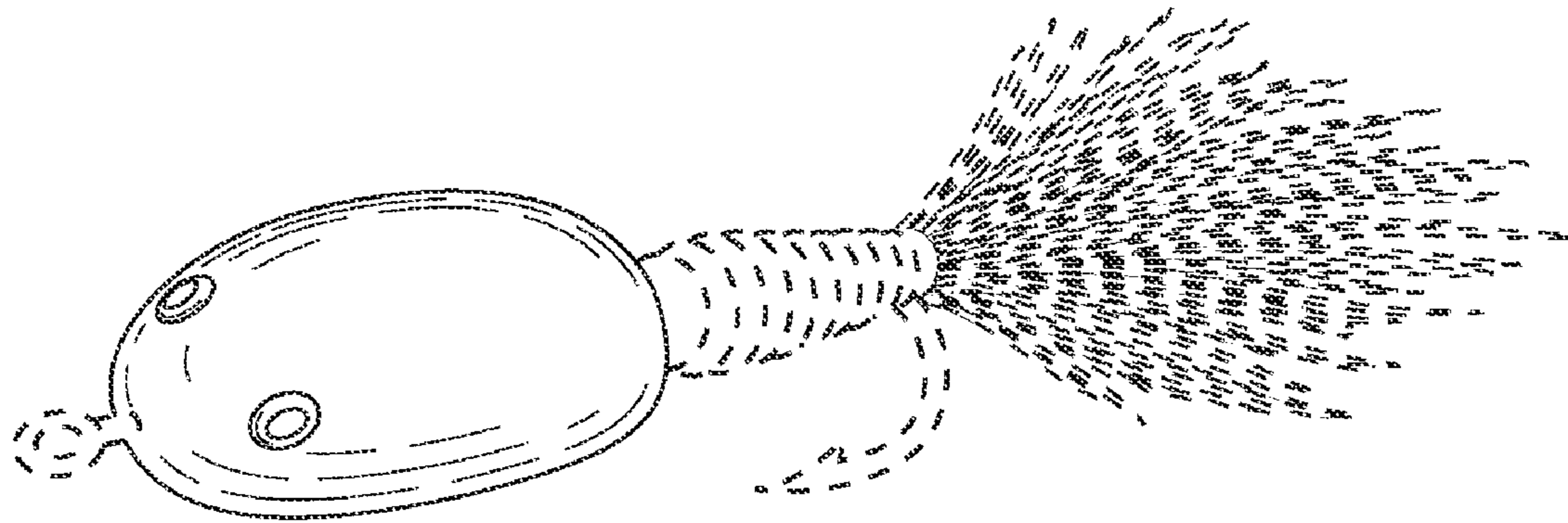

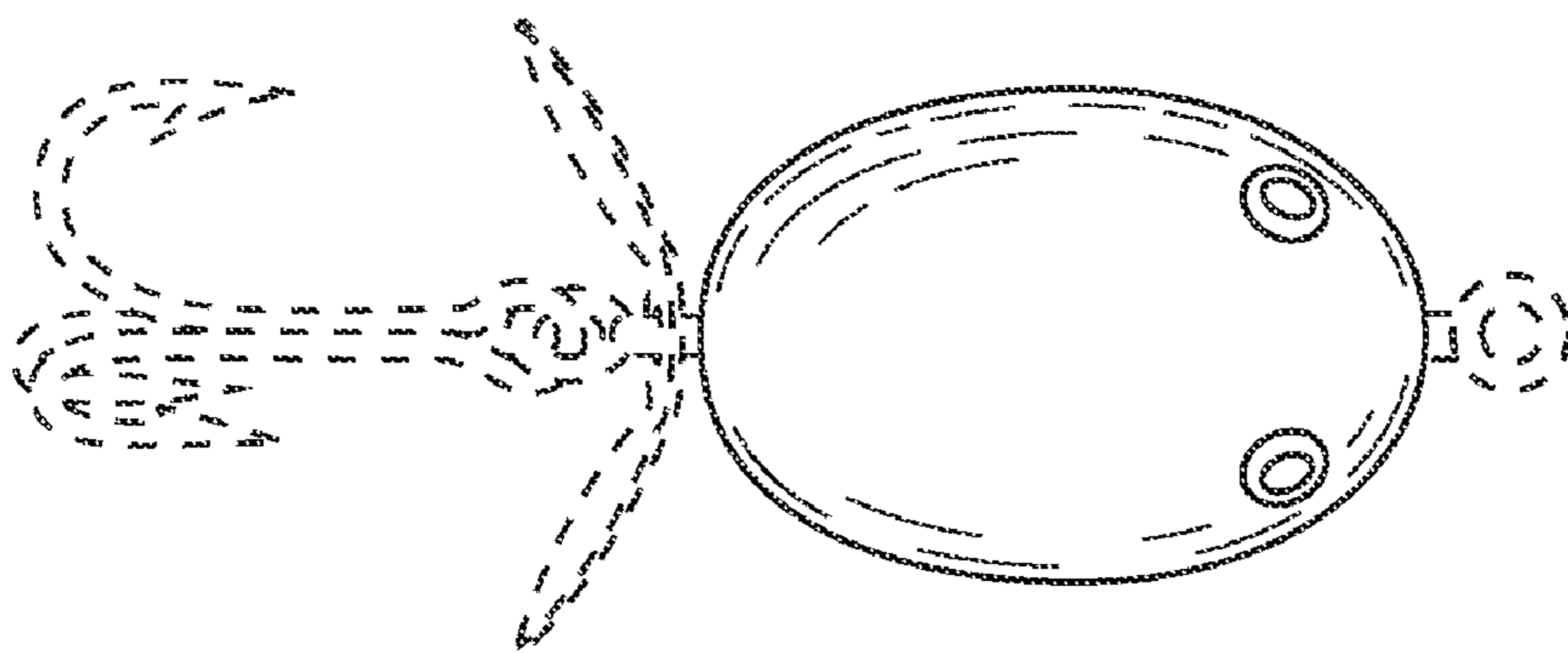
