(57) **CLAIM**

The ornamental design for a grille for a ceiling ventilating fan, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top, front and left side of a grille for a ceiling ventilating fan showing our new design;

FIG. 4 is a right side view thereof;

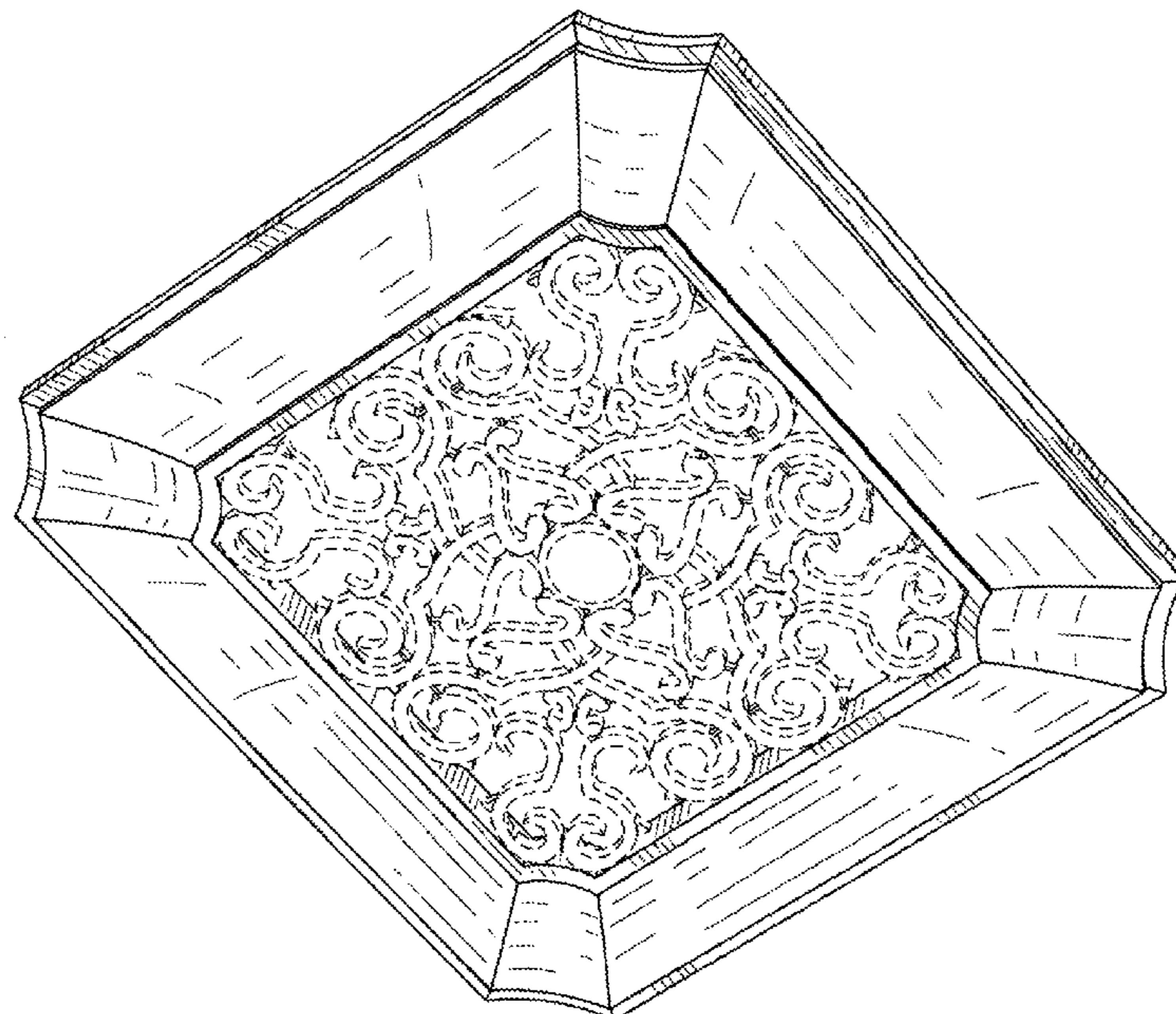
FIG. 5 is a top plan view thereof;

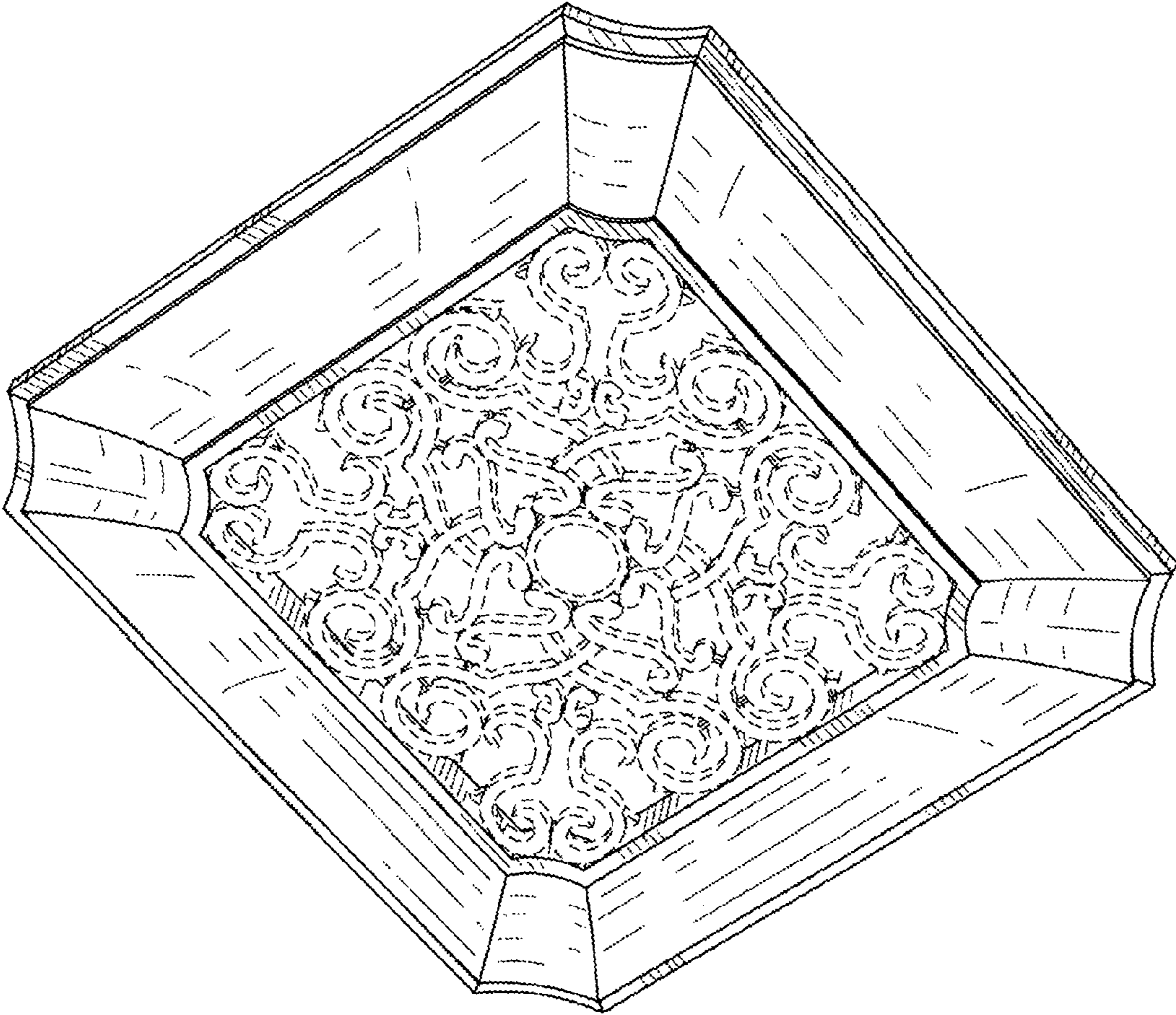

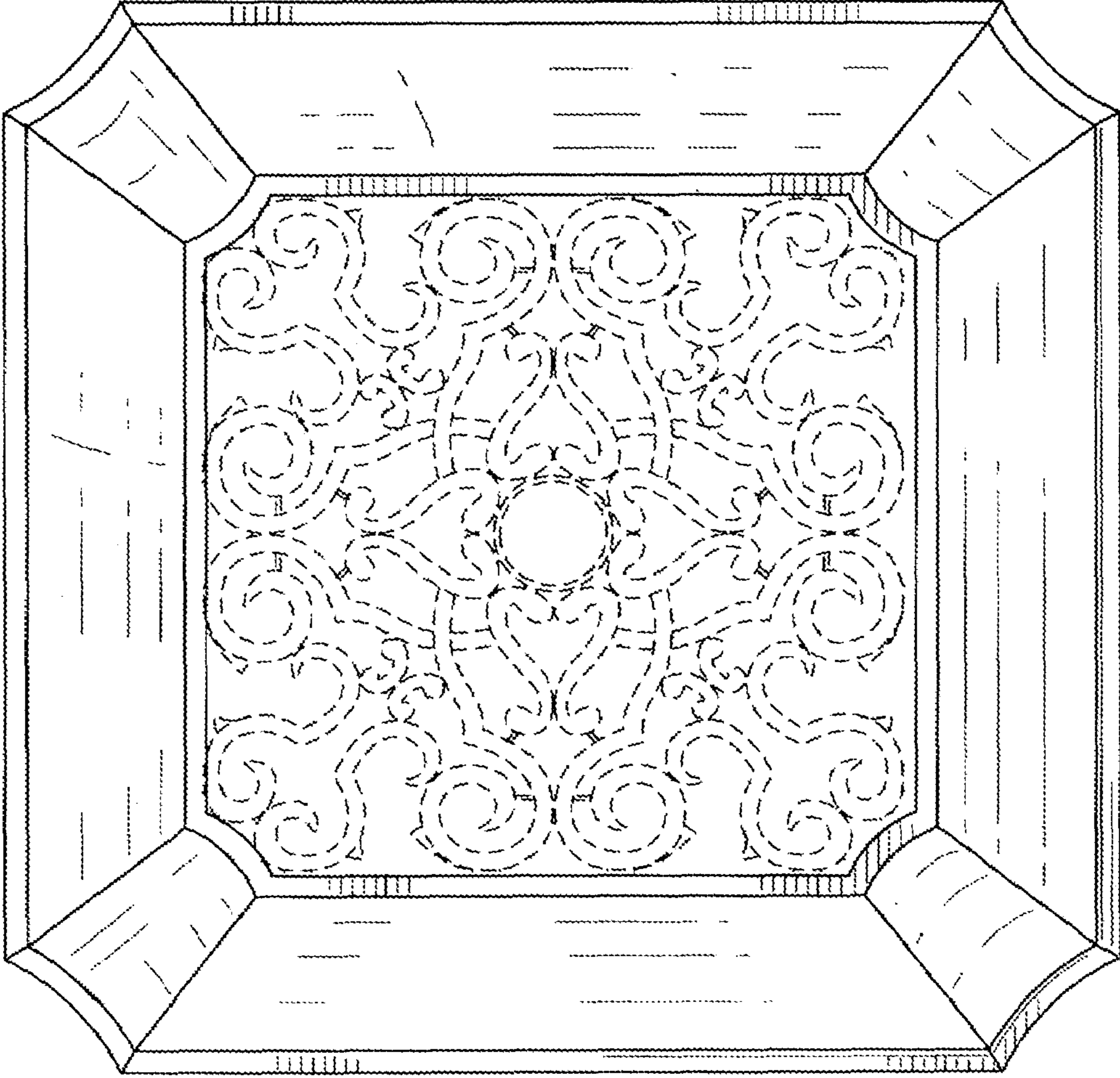

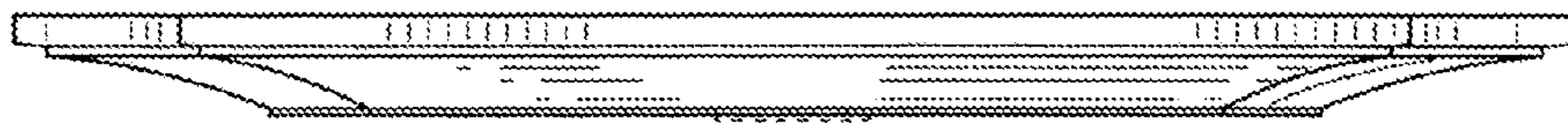
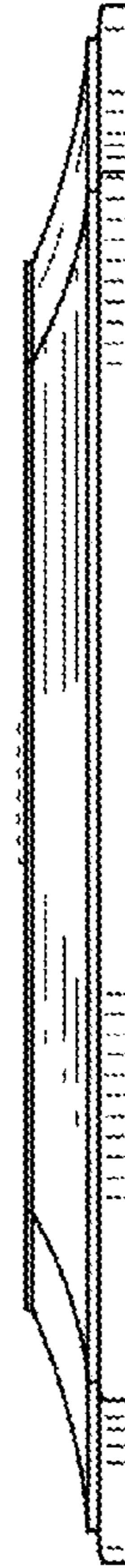

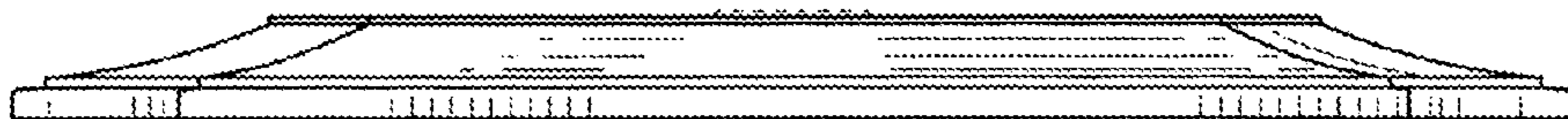

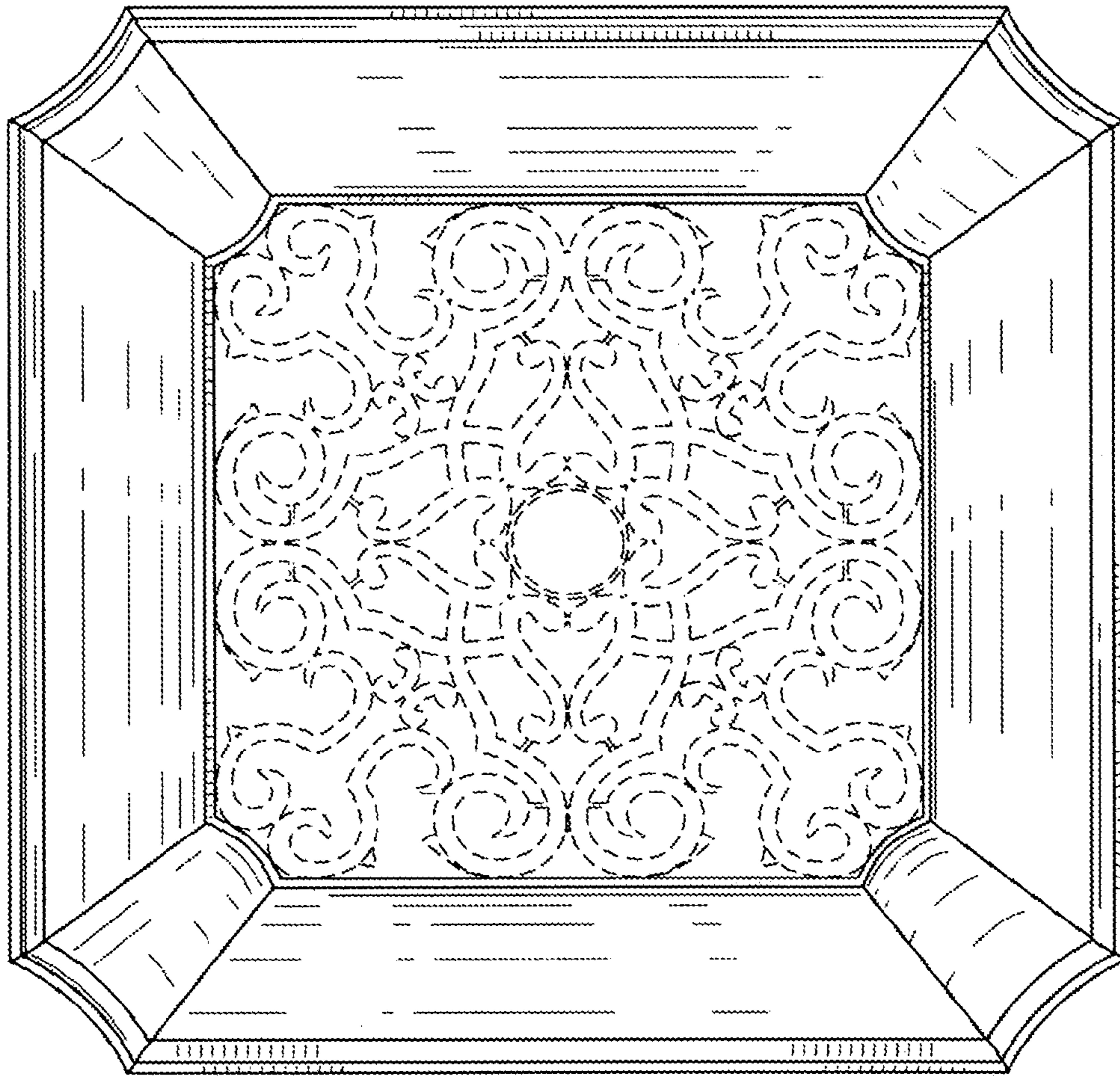
