The ornamental design for a surgical implant, as shown and described.

DESCRIPTION

A surgical implant used to fuse spinal vertebrae.

FIG. 1 is a top perspective view of a surgical implant showing my new design;

FIG. 7 is a bottom perspective view thereof;

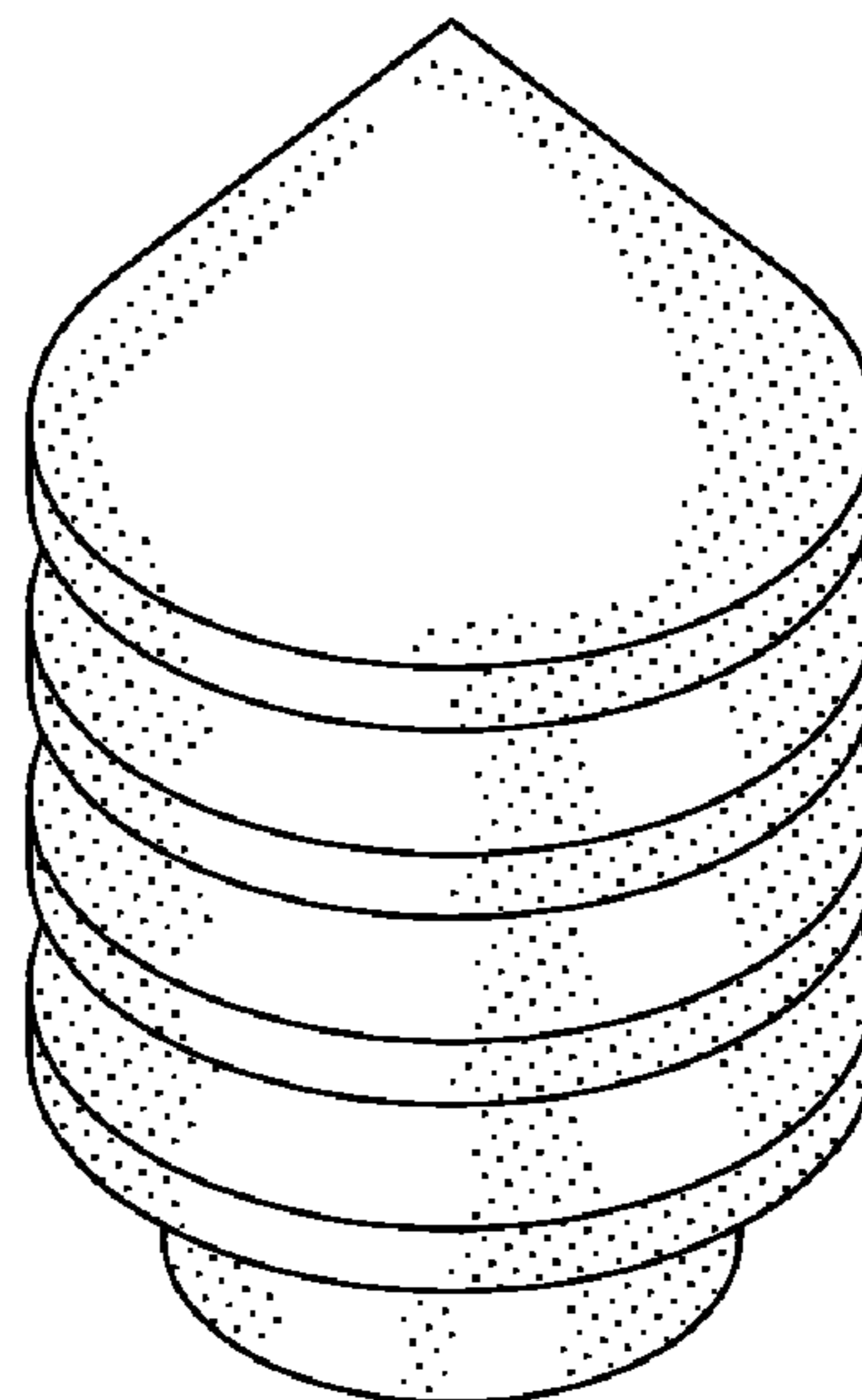
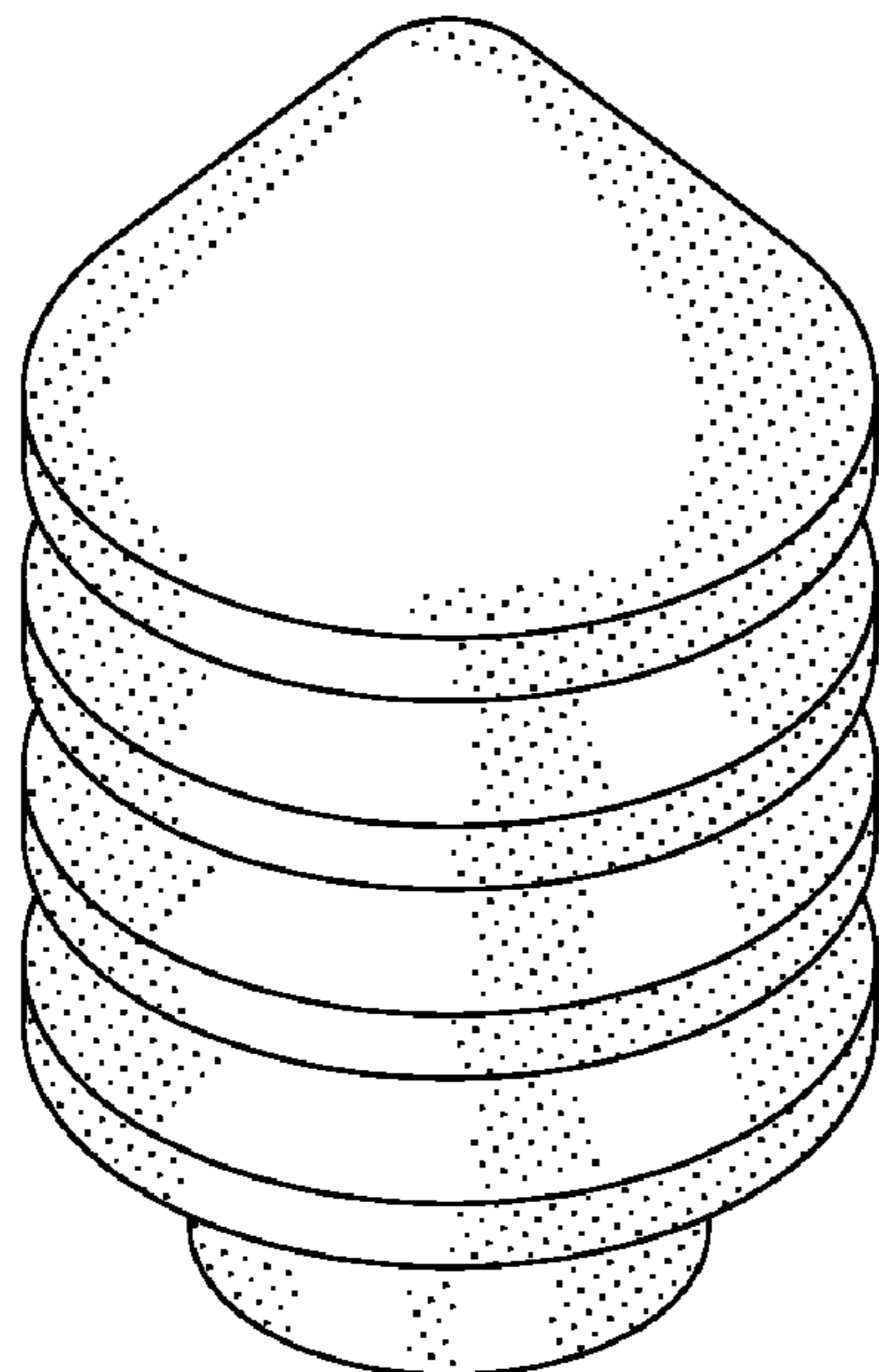
FIG. 8 is a side elevation view thereof;

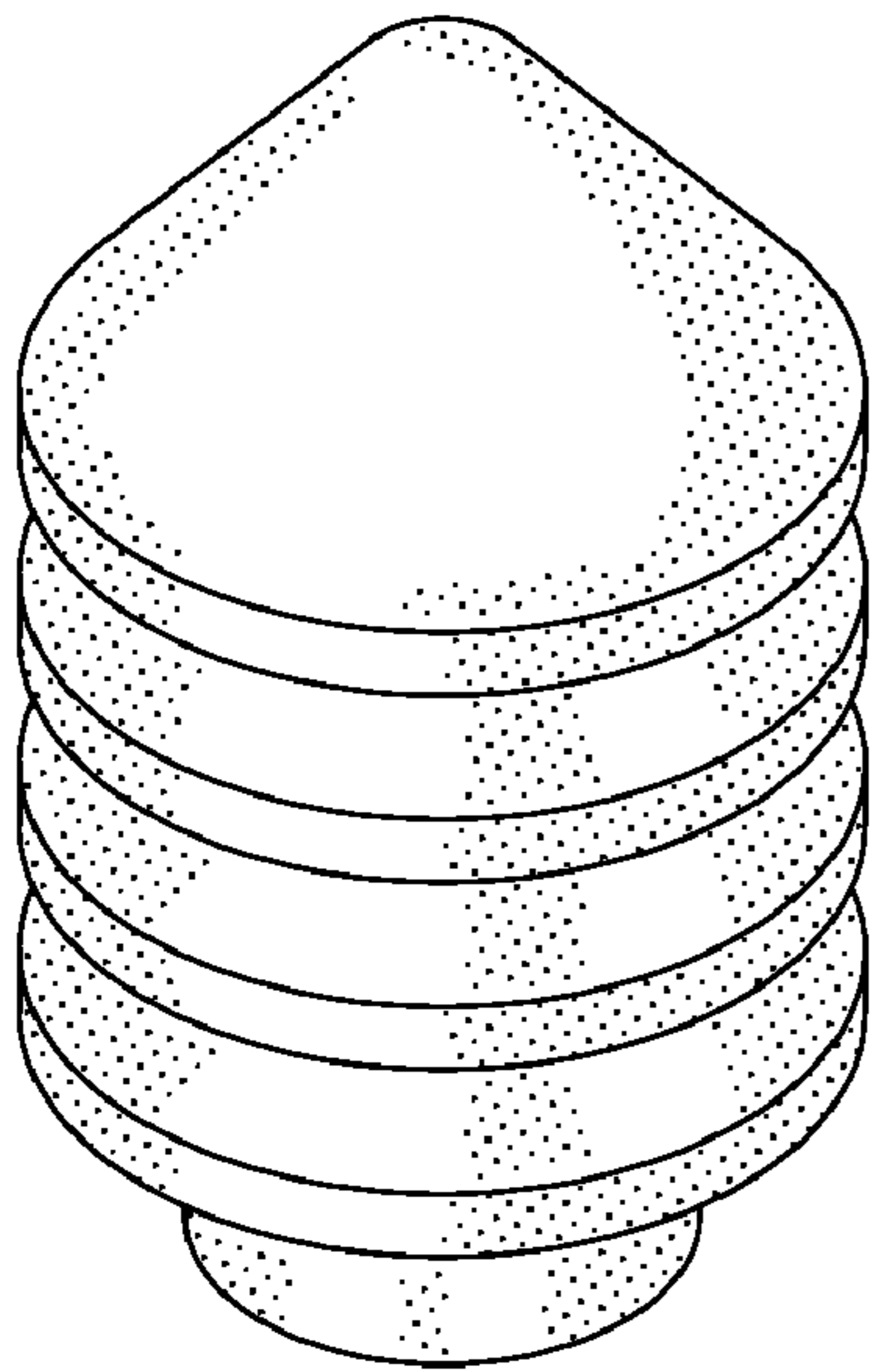

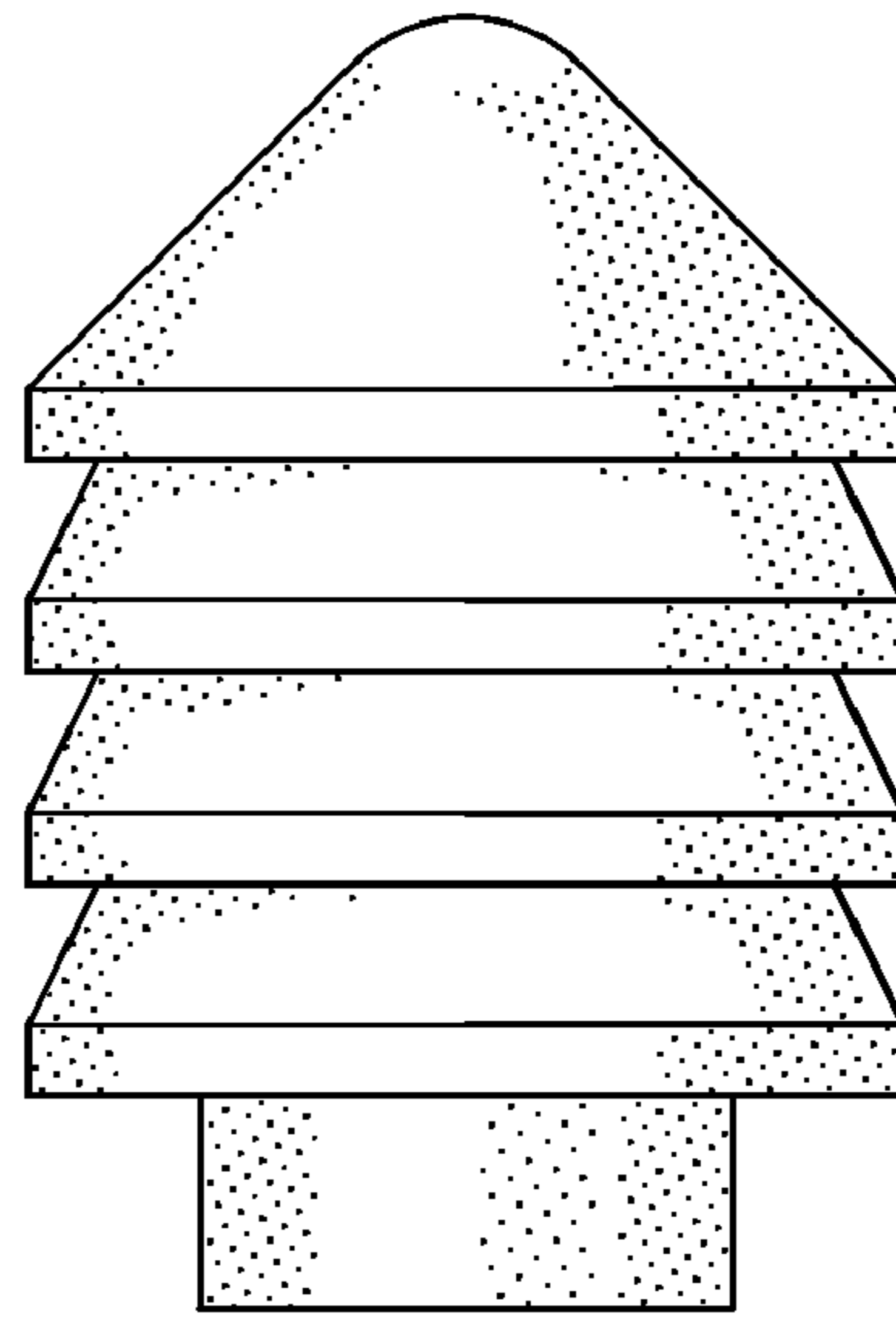

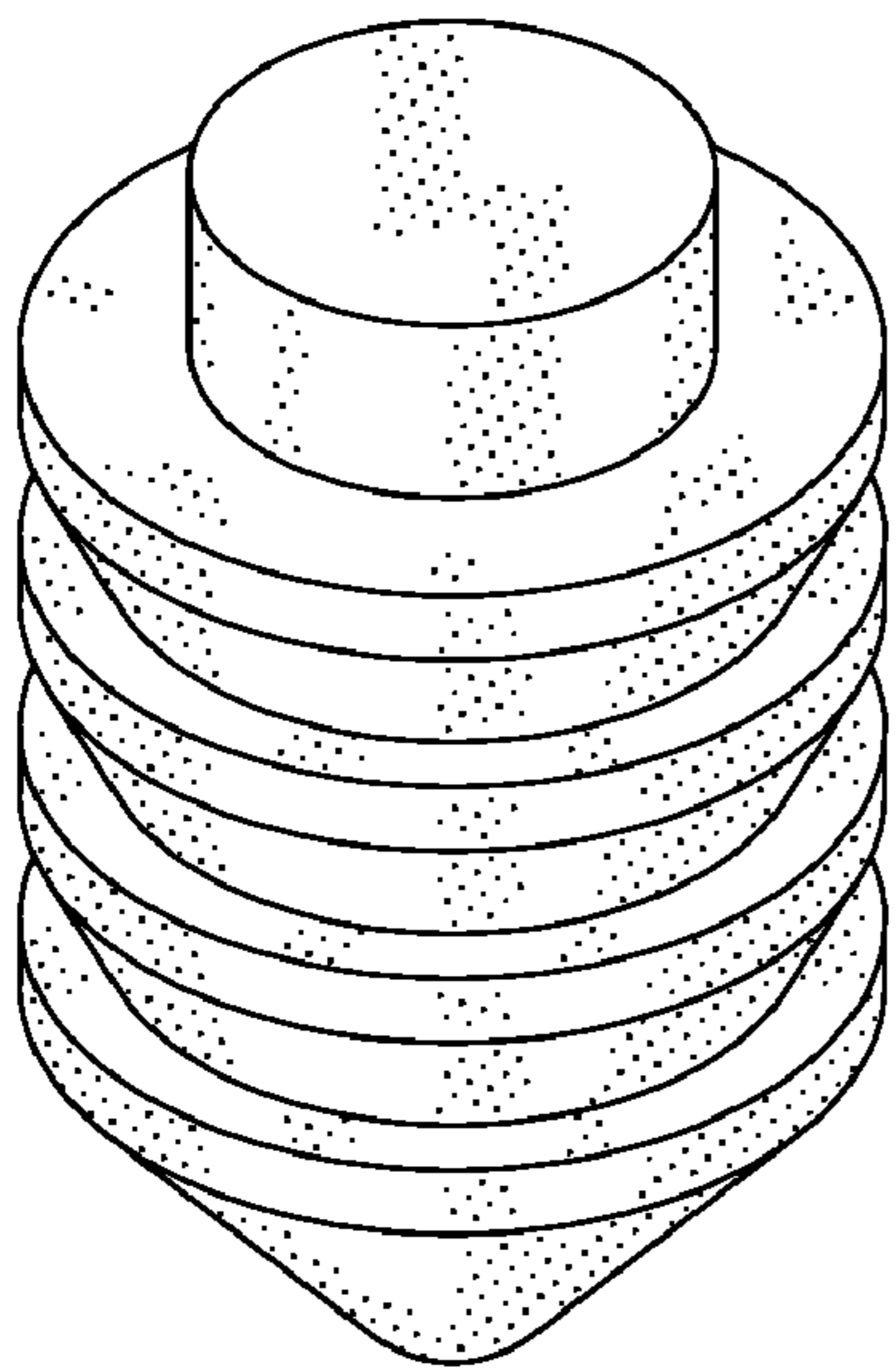

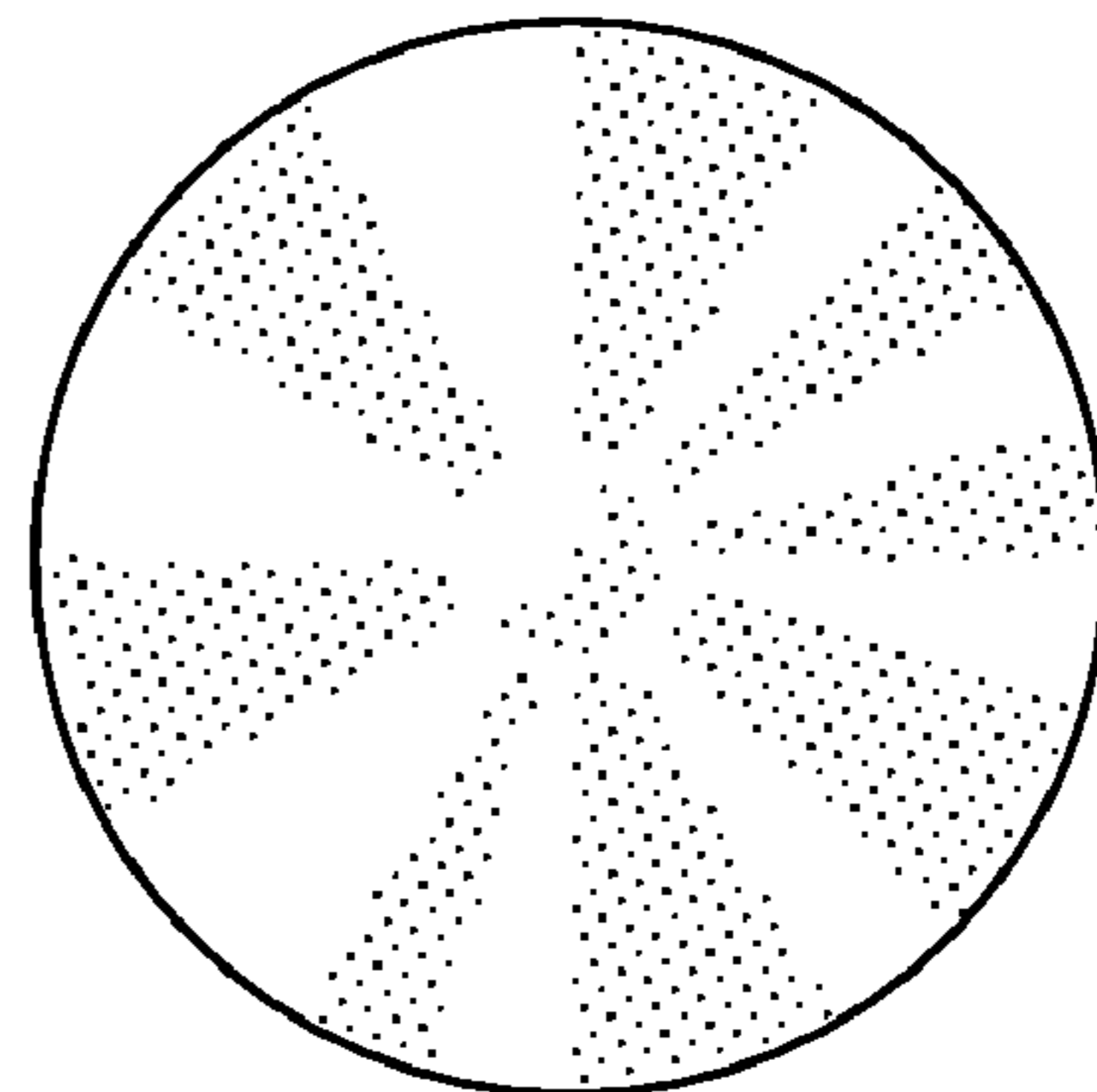

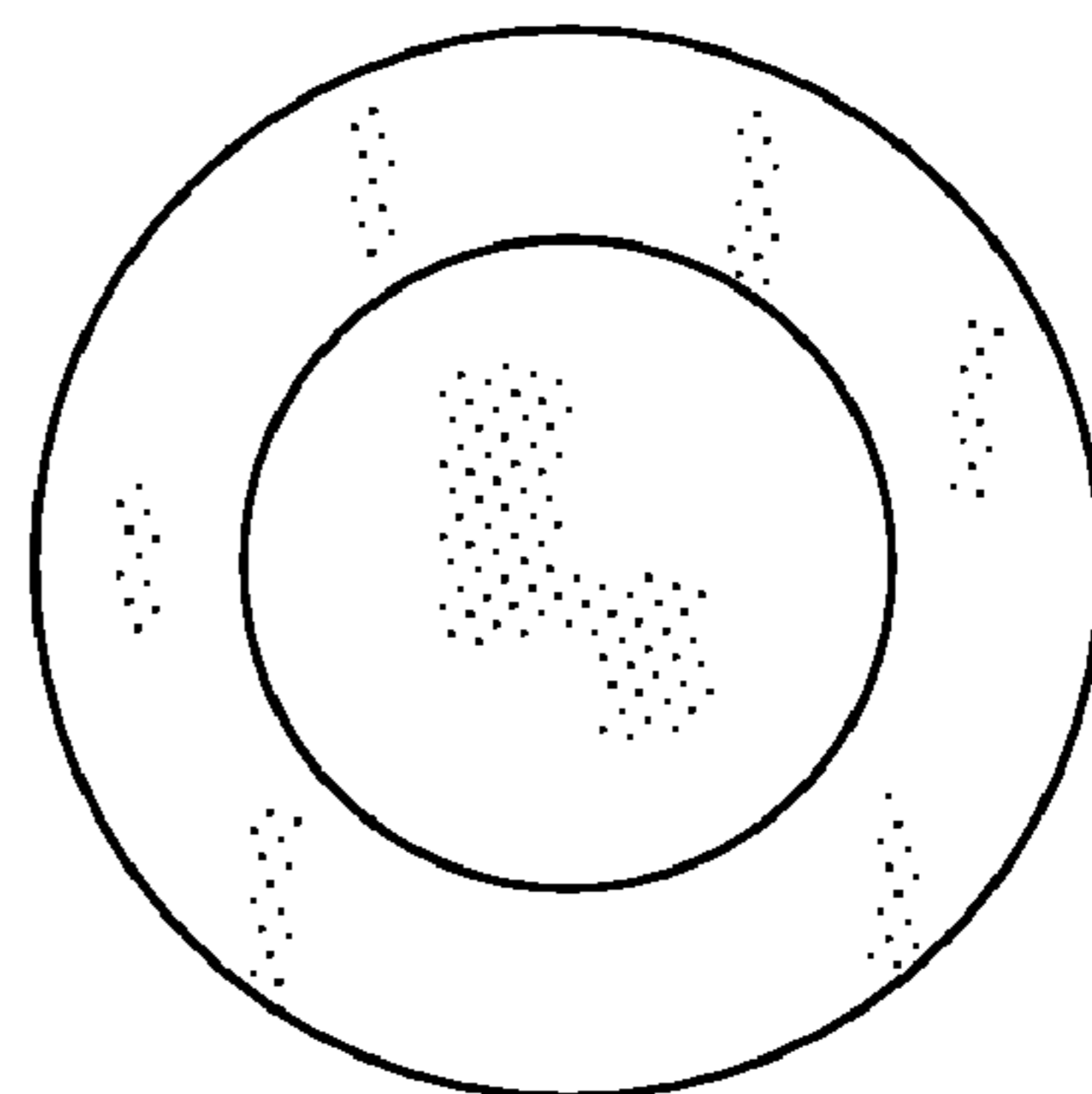

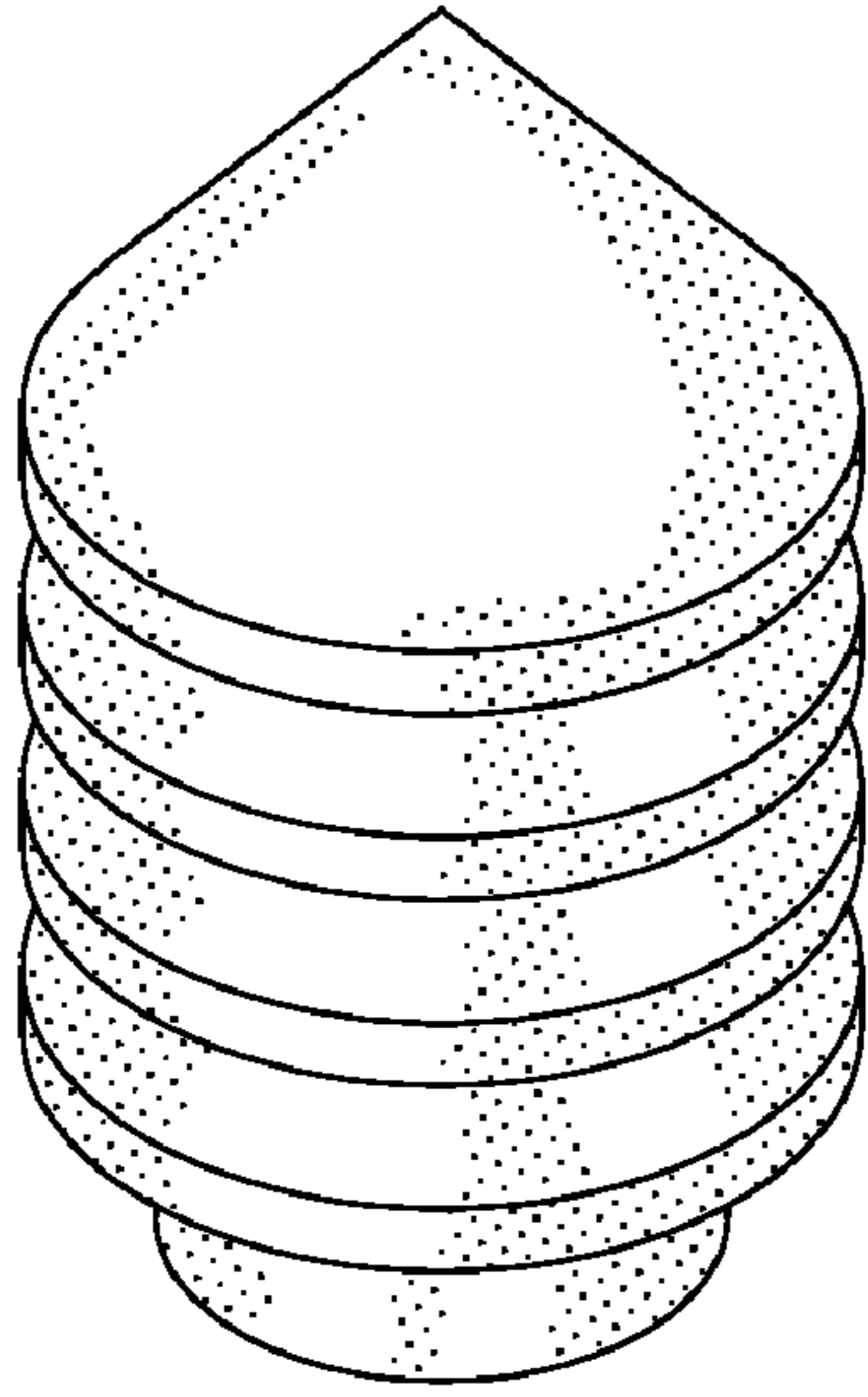

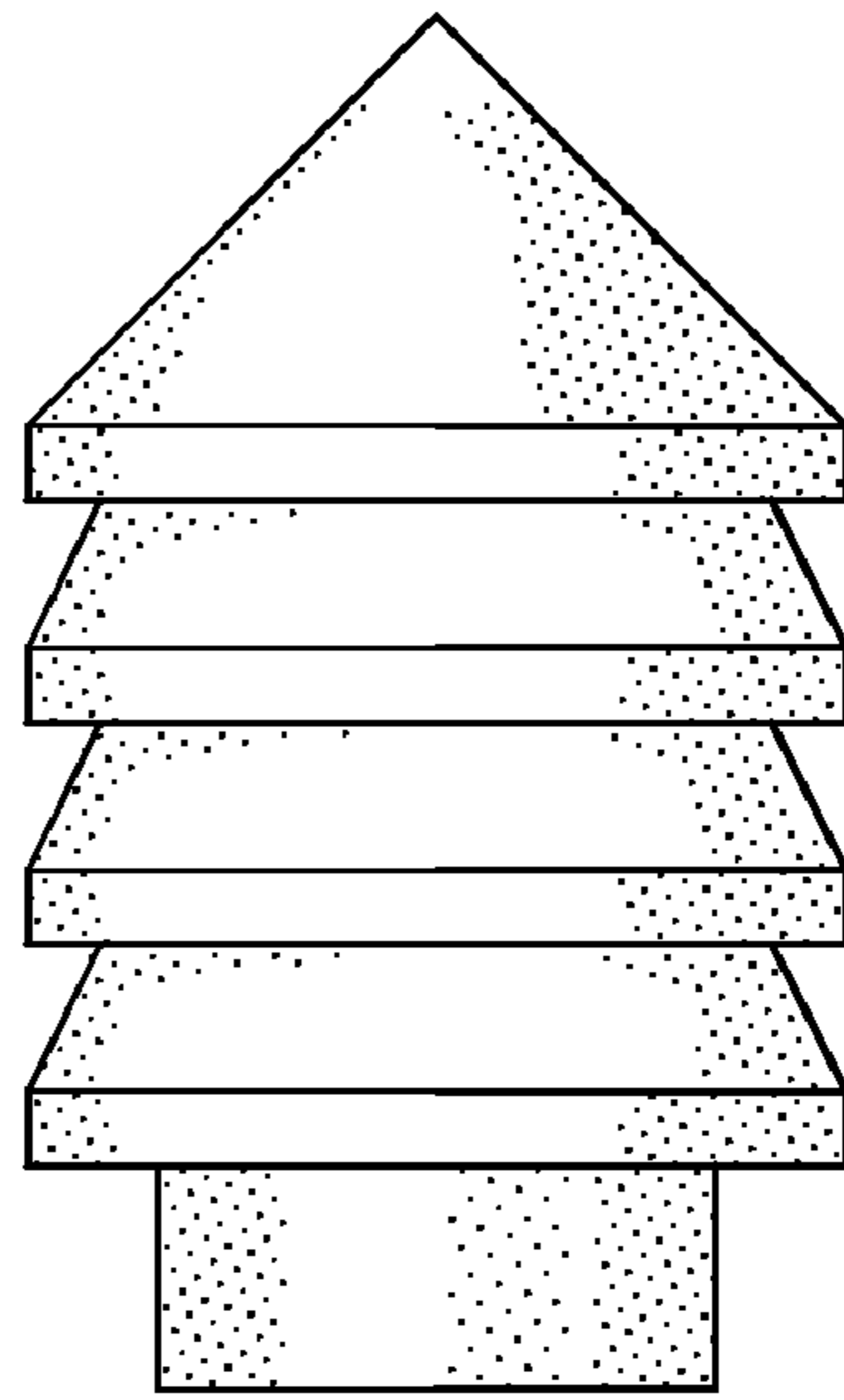

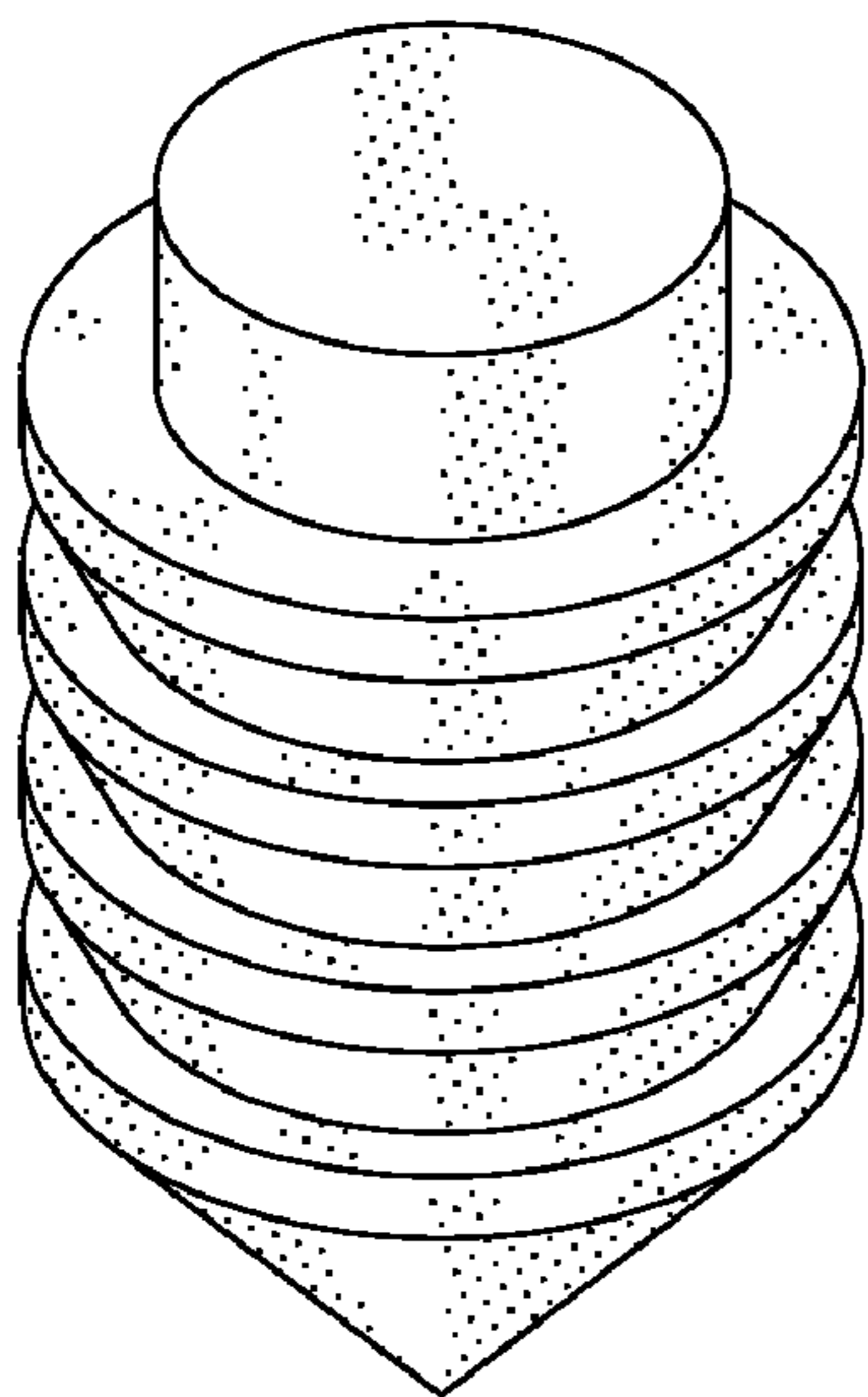

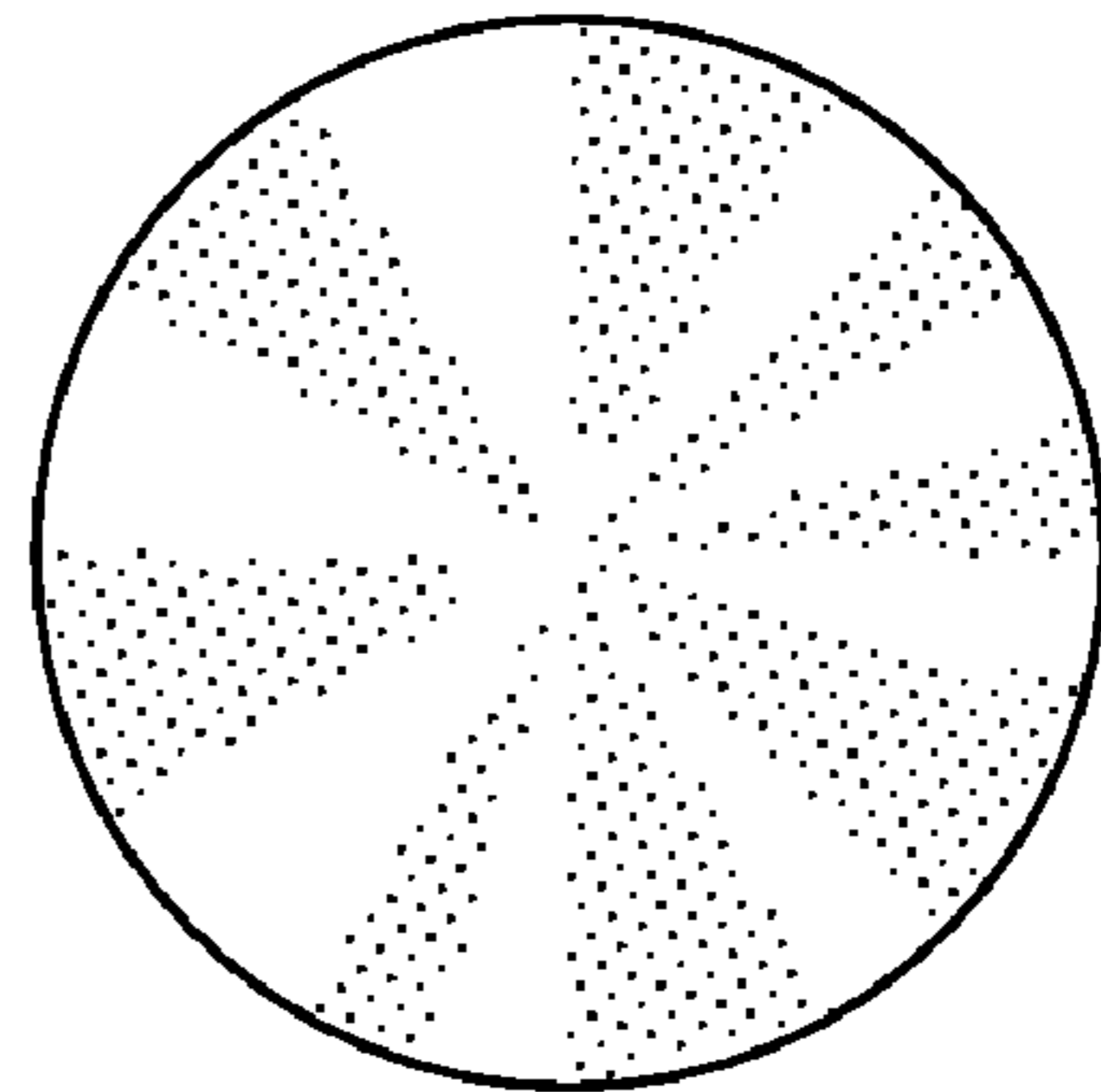

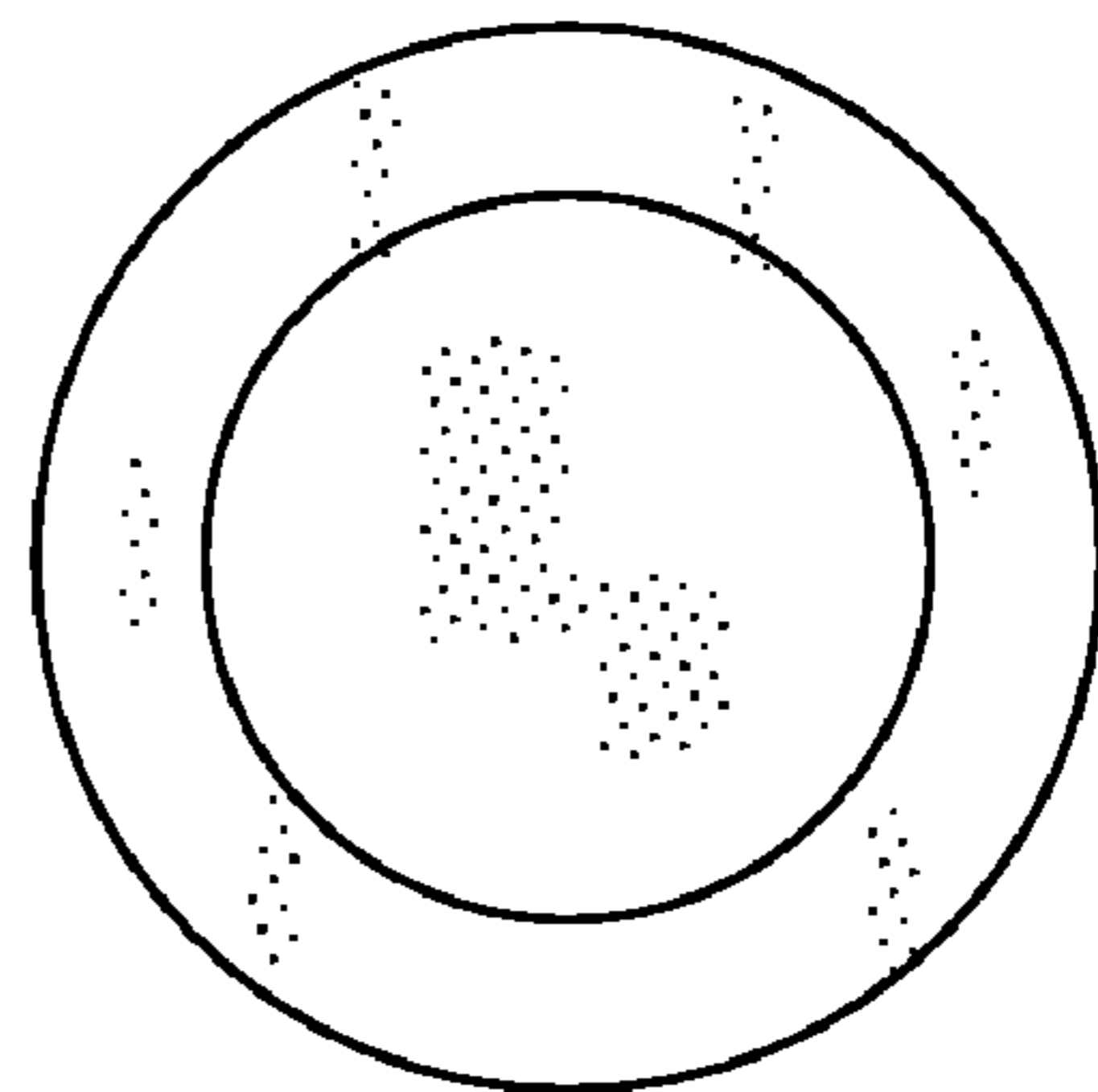
