DESCRIPTION

showing our new design;

FIG. 2 shows a rear elevation view thereof;

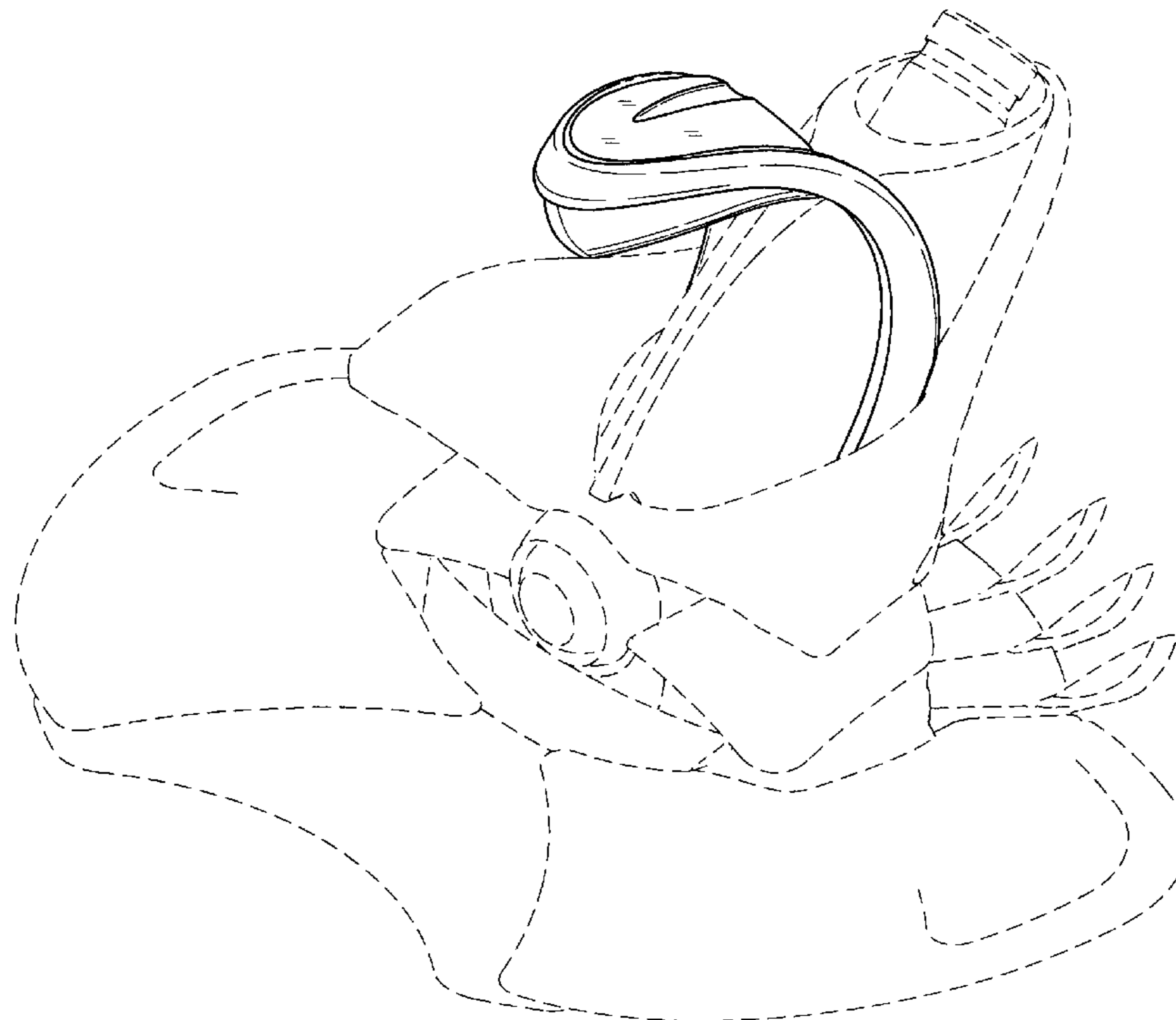
FIG. 3 shows a left side elevation view thereof, the right side

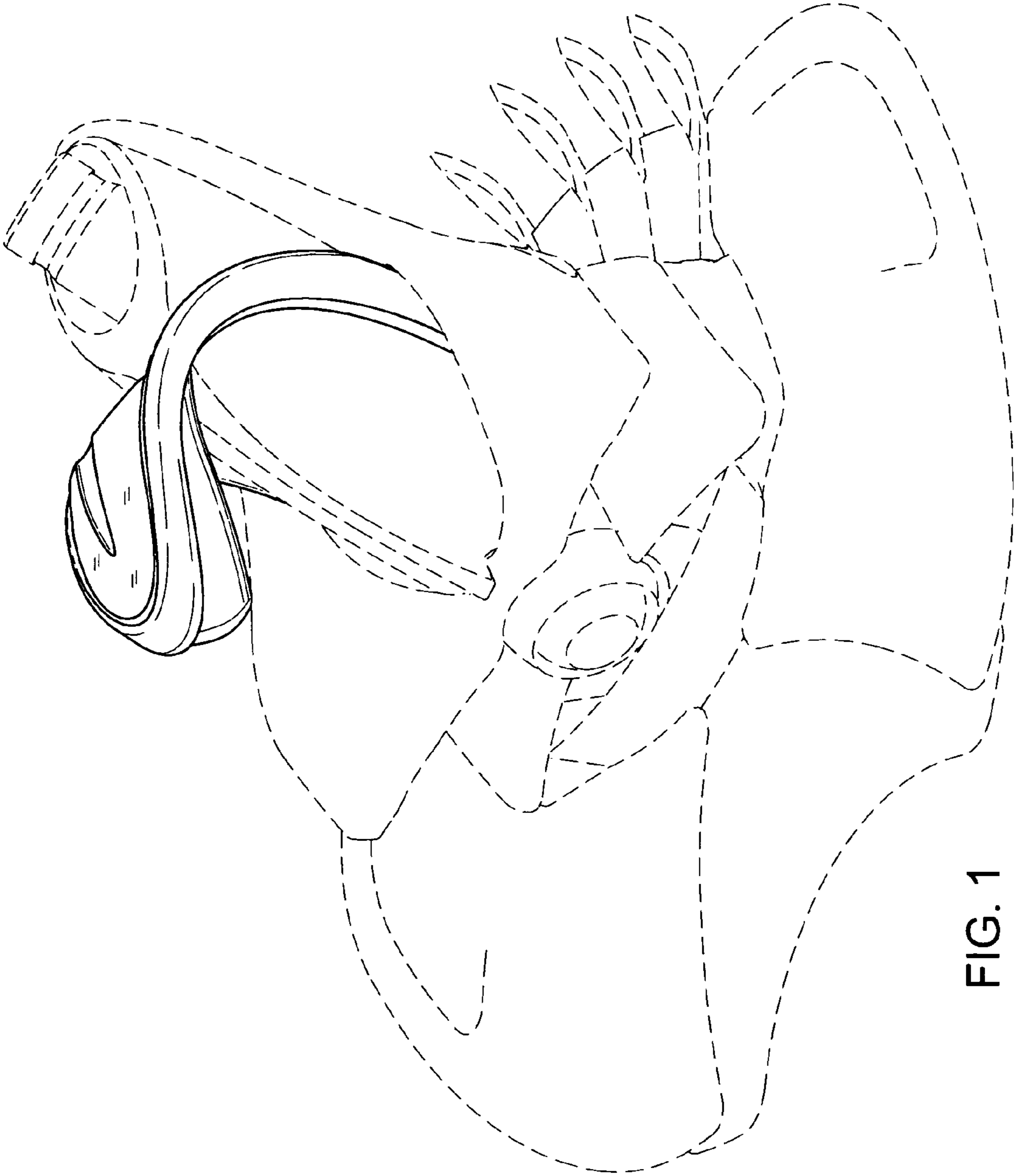

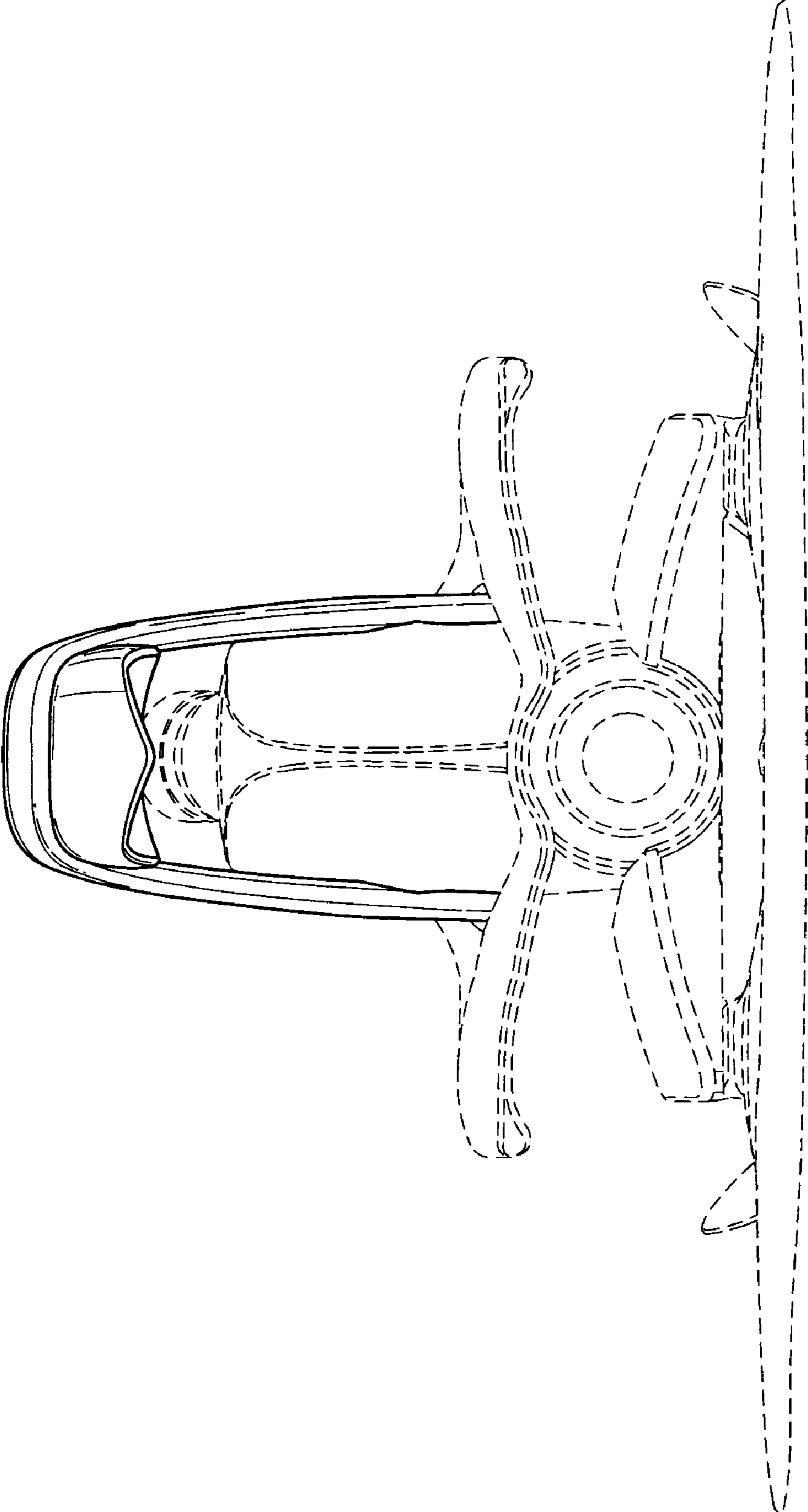

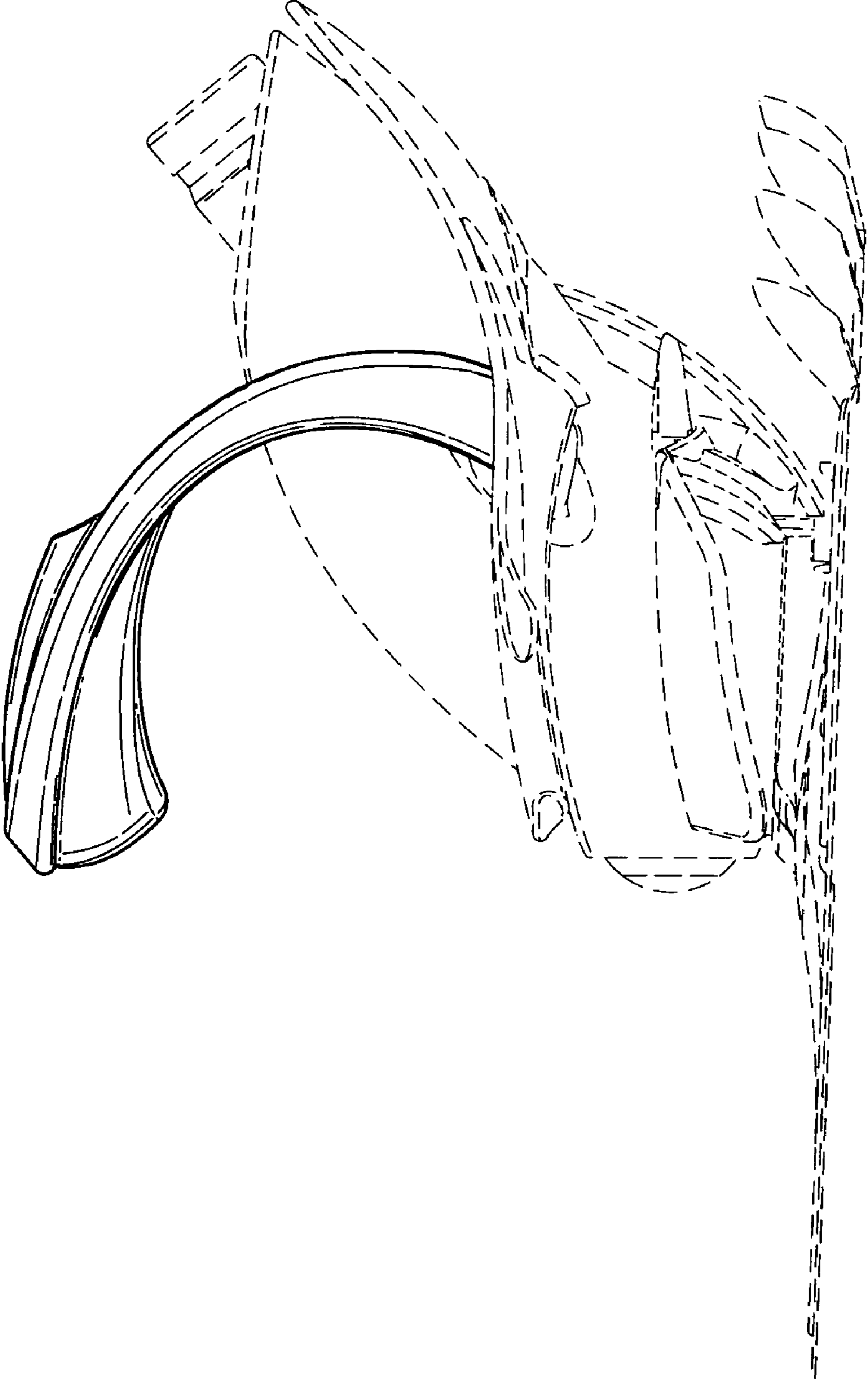

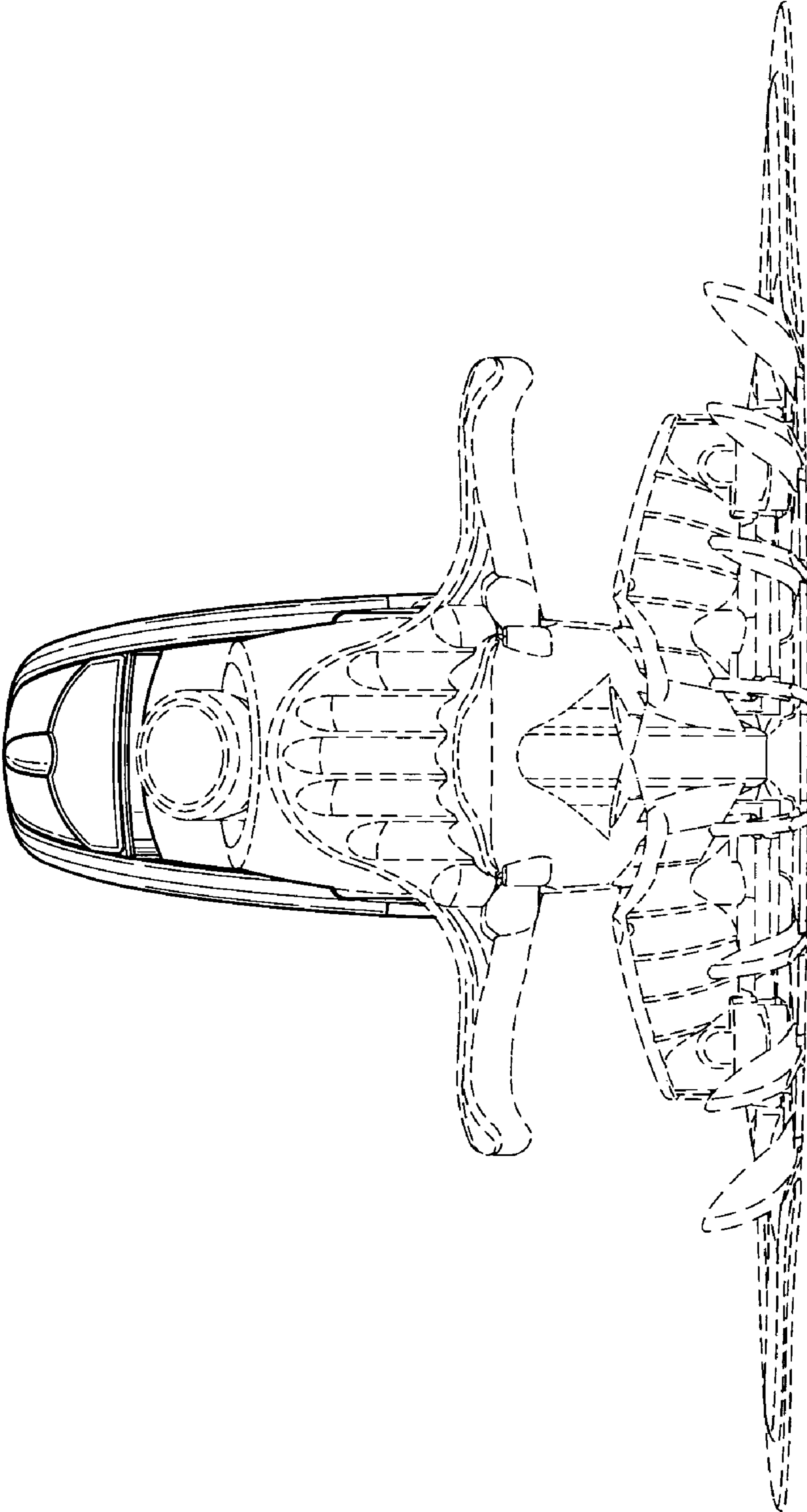

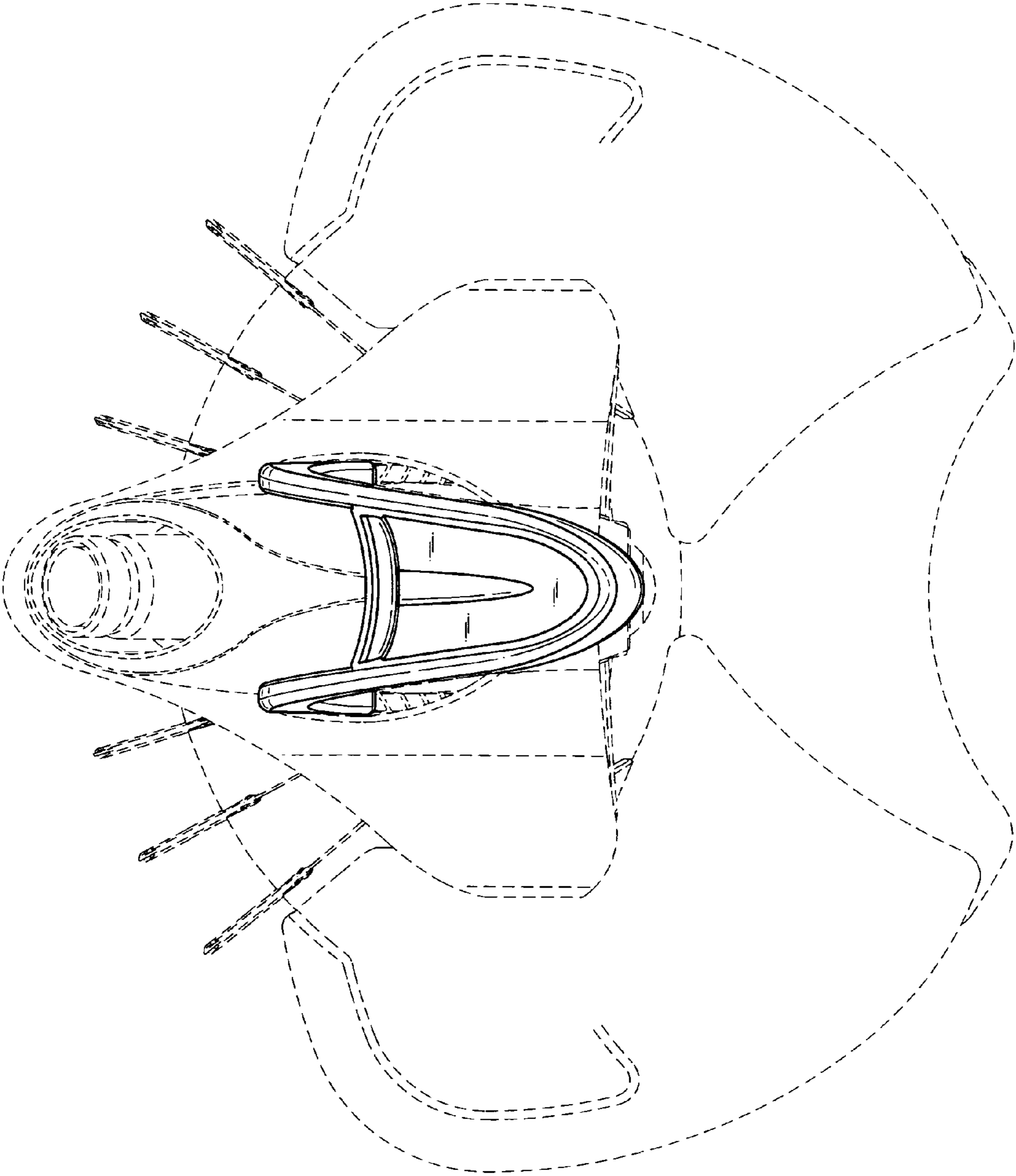
