(57) **CLAIM**

The ornamental design for a food product, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view showing my new design of a food product;

FIG. 2 is a top view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a front view thereof, the rear view being identical thereto; and,

FIG. 5 is a left view thereof, the right view being identical thereto.

The stipple shading in FIGS. 1–5 is for illustrative purposes only and does not represent any particular surface ornamentation.

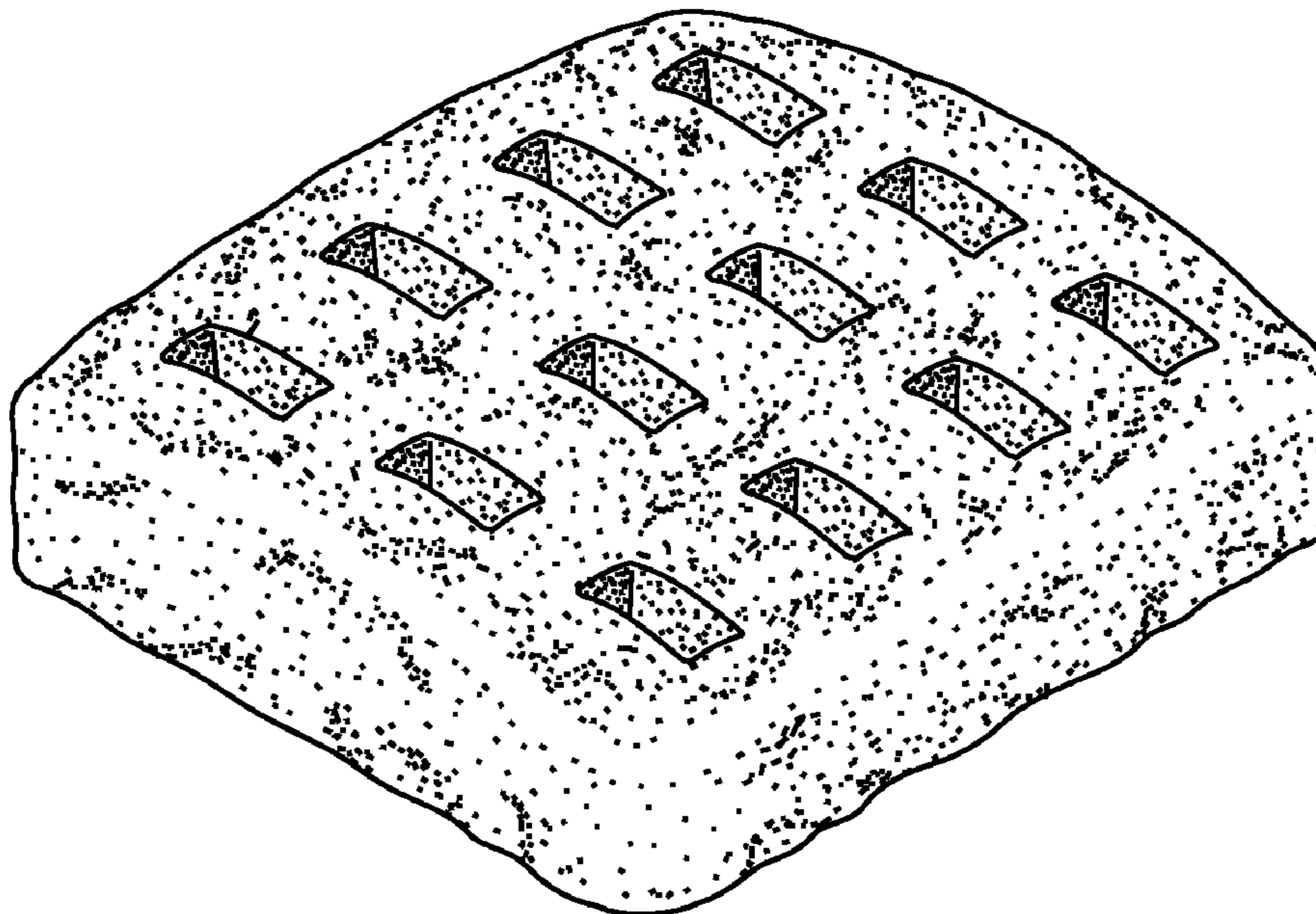

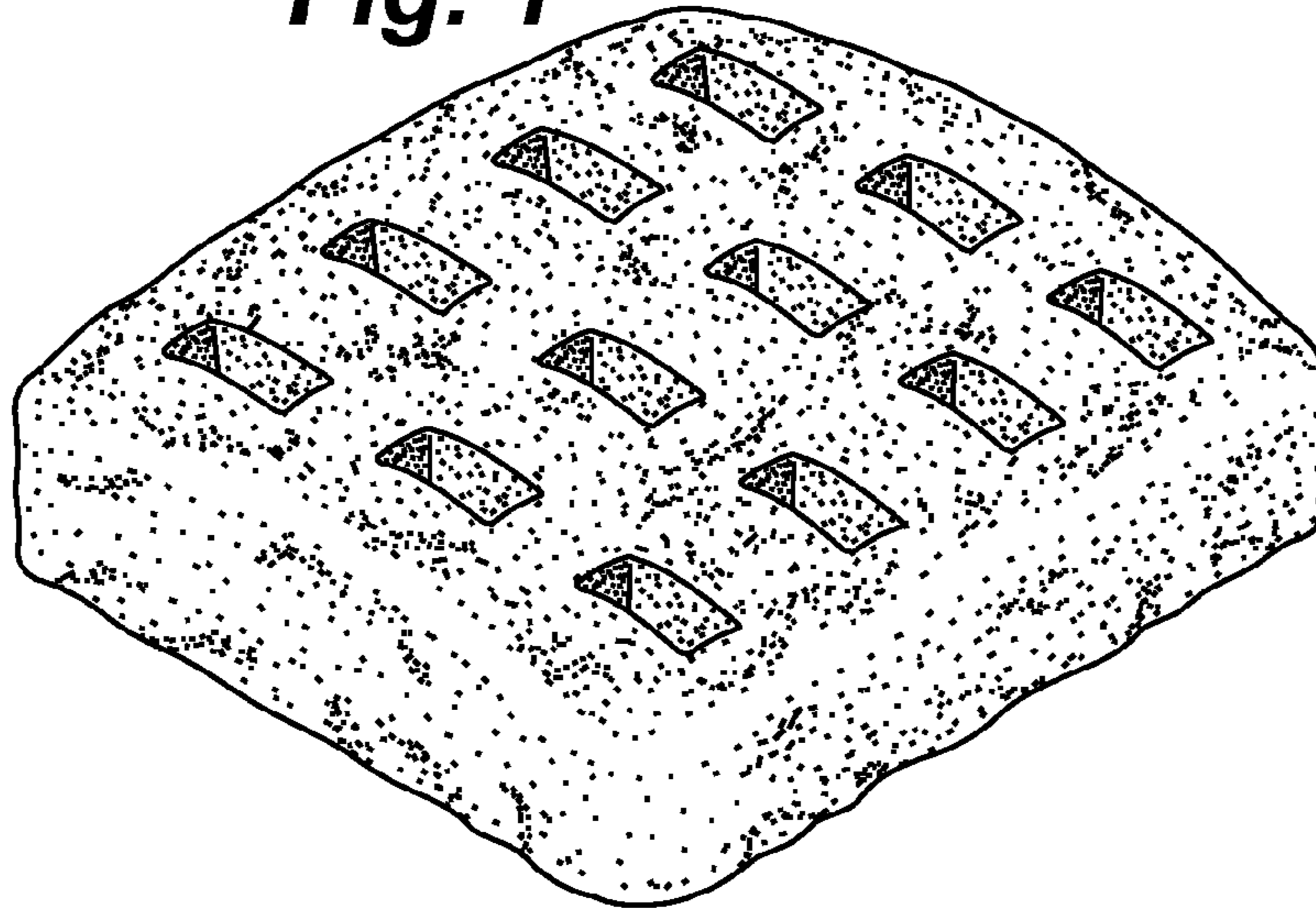

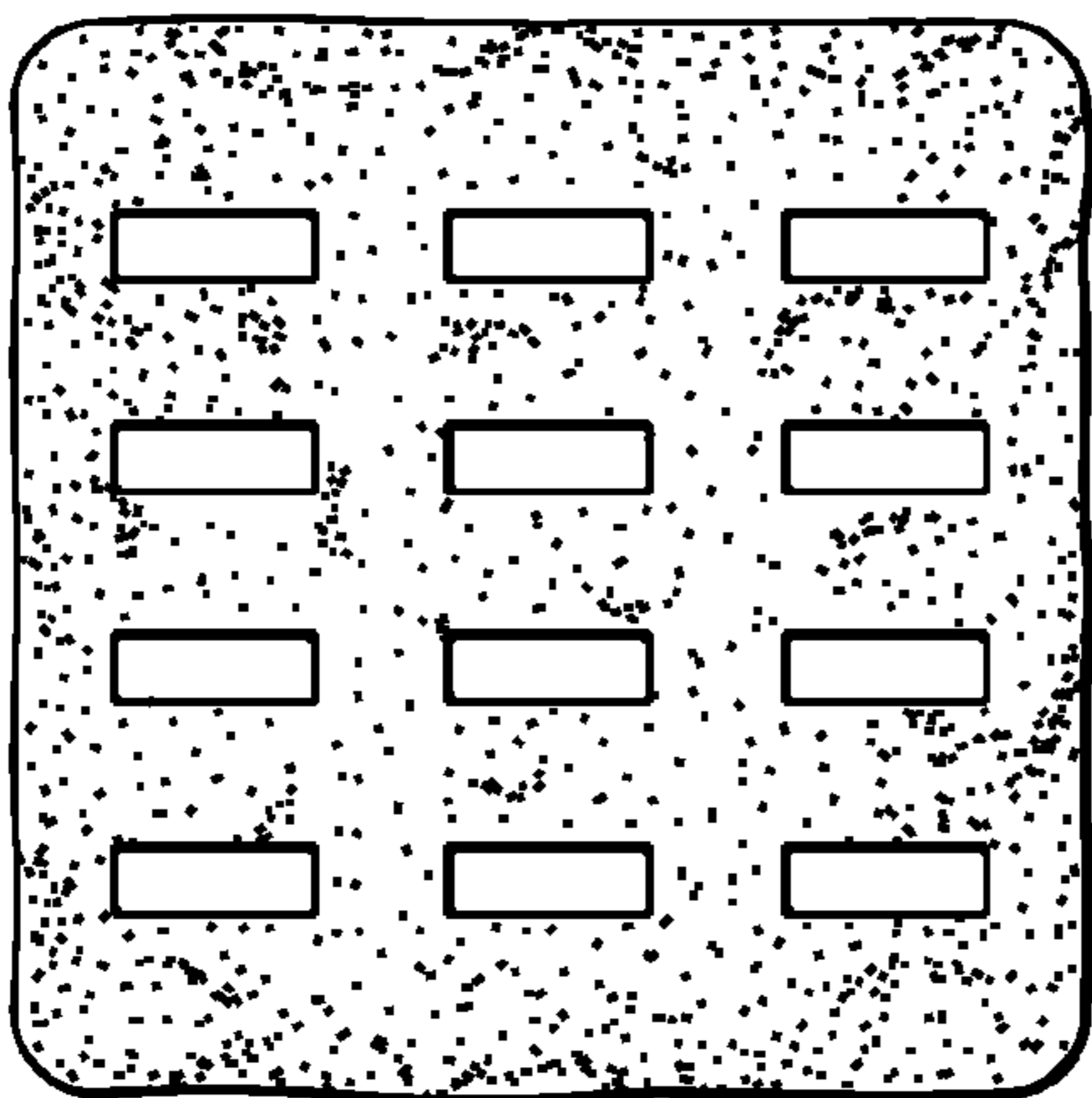

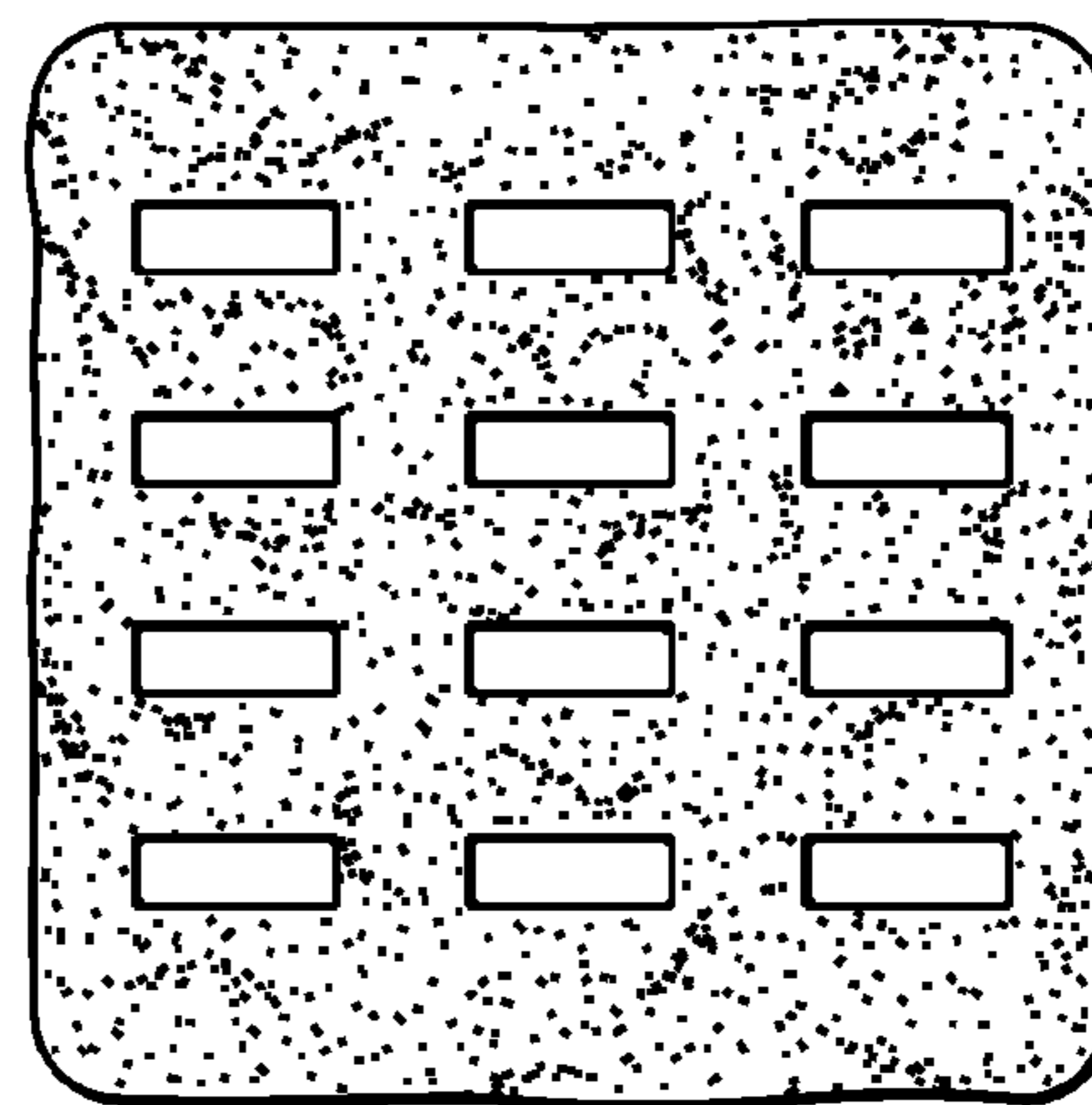
