(57) **CLAIM**

The ornamental design for footwear upper portion, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the footwear upper embodying the new design;

FIG. 2 is a top view thereof;

FIG. 3 is a right side view thereof;

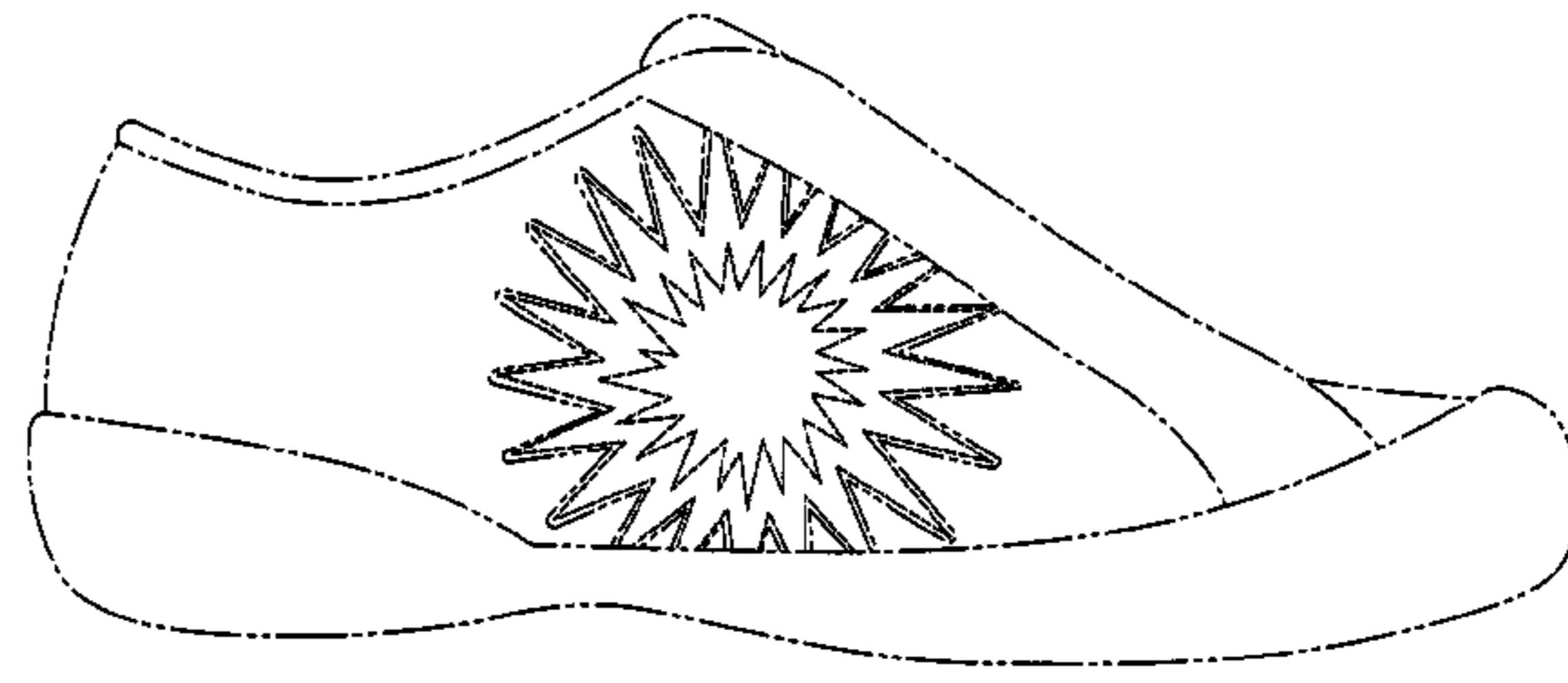
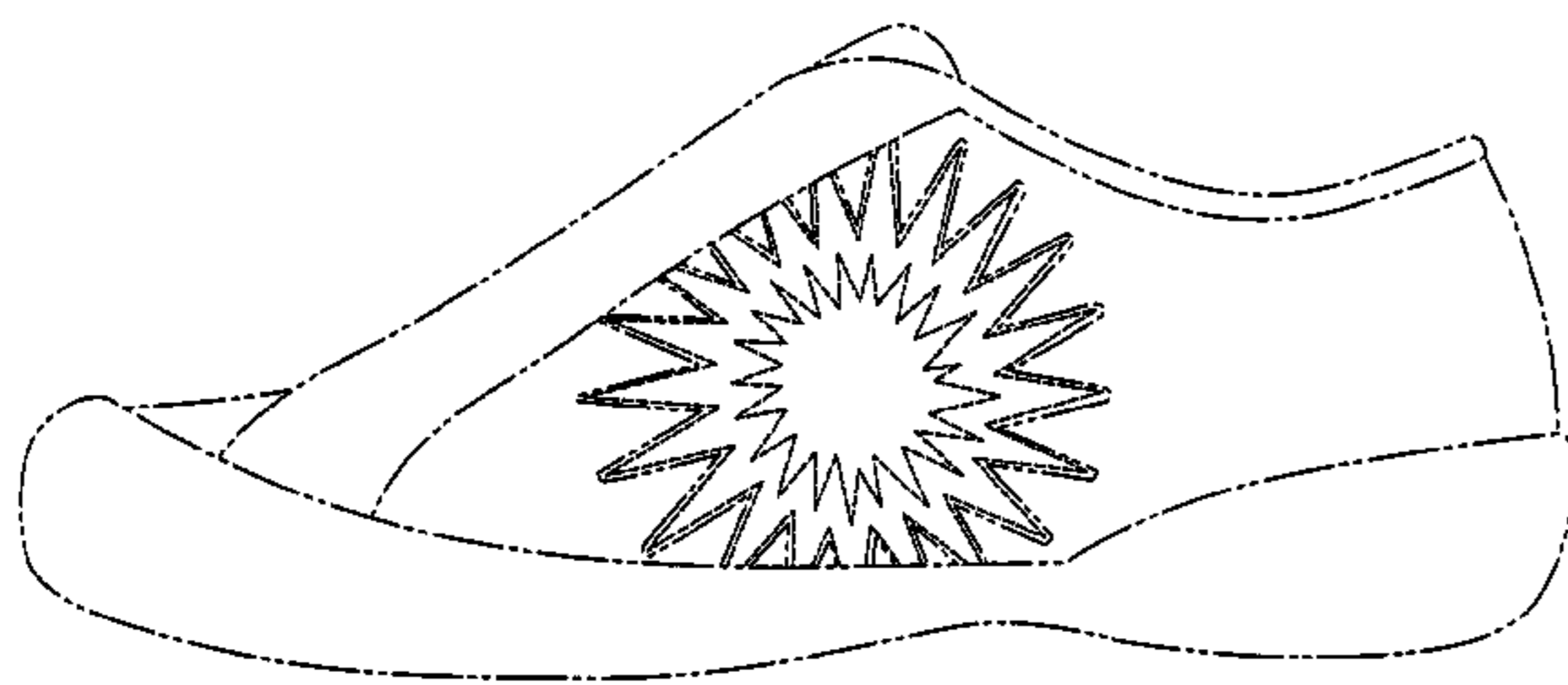
FIG. 4 is a left side view thereof;

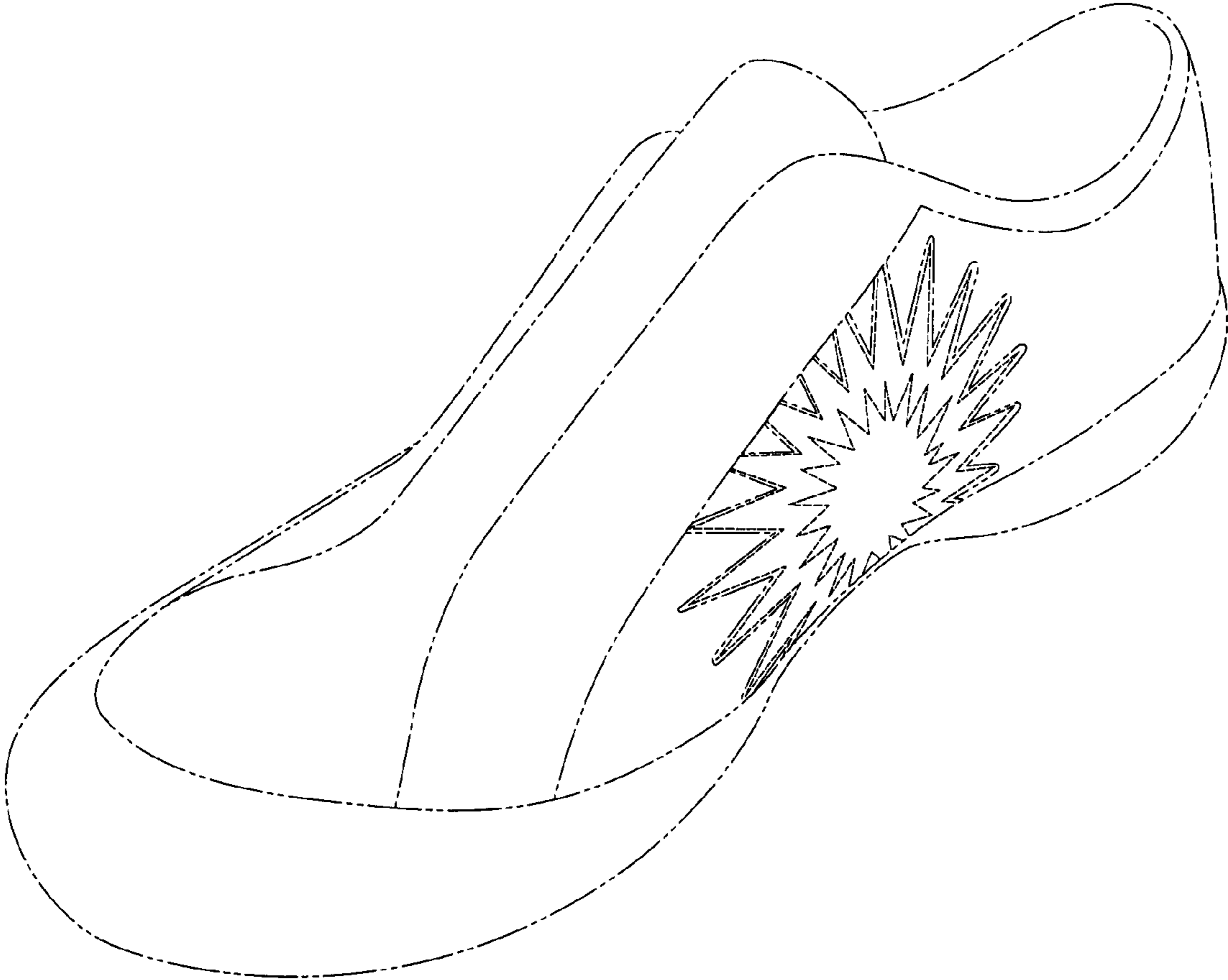

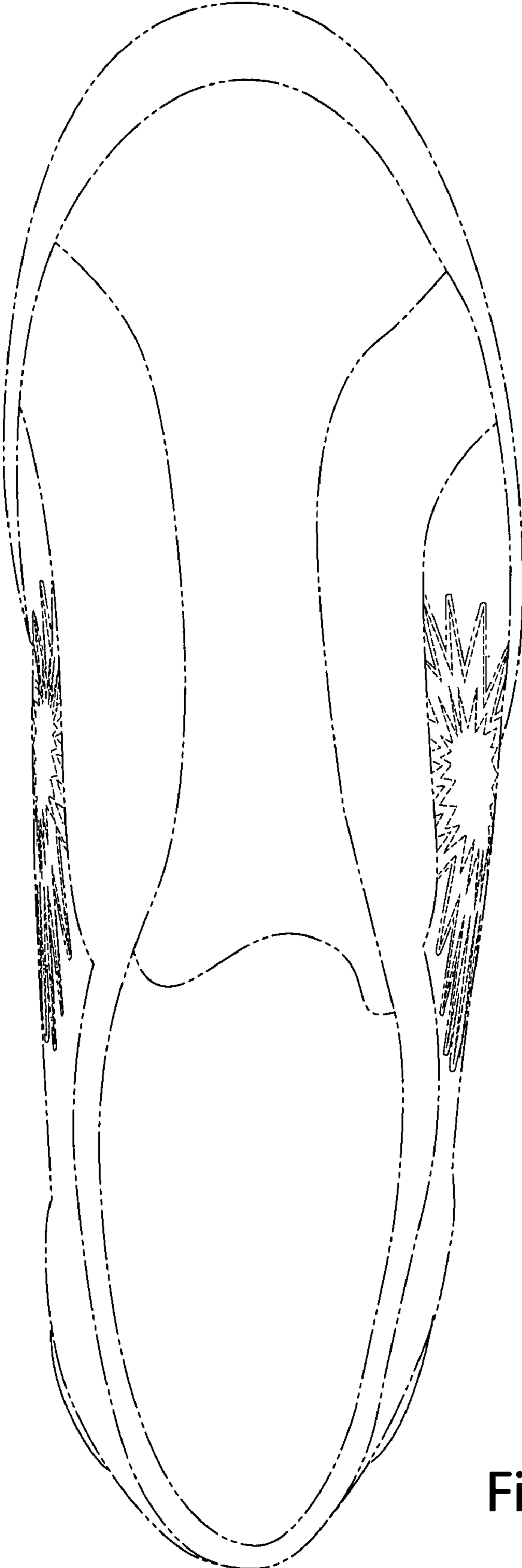

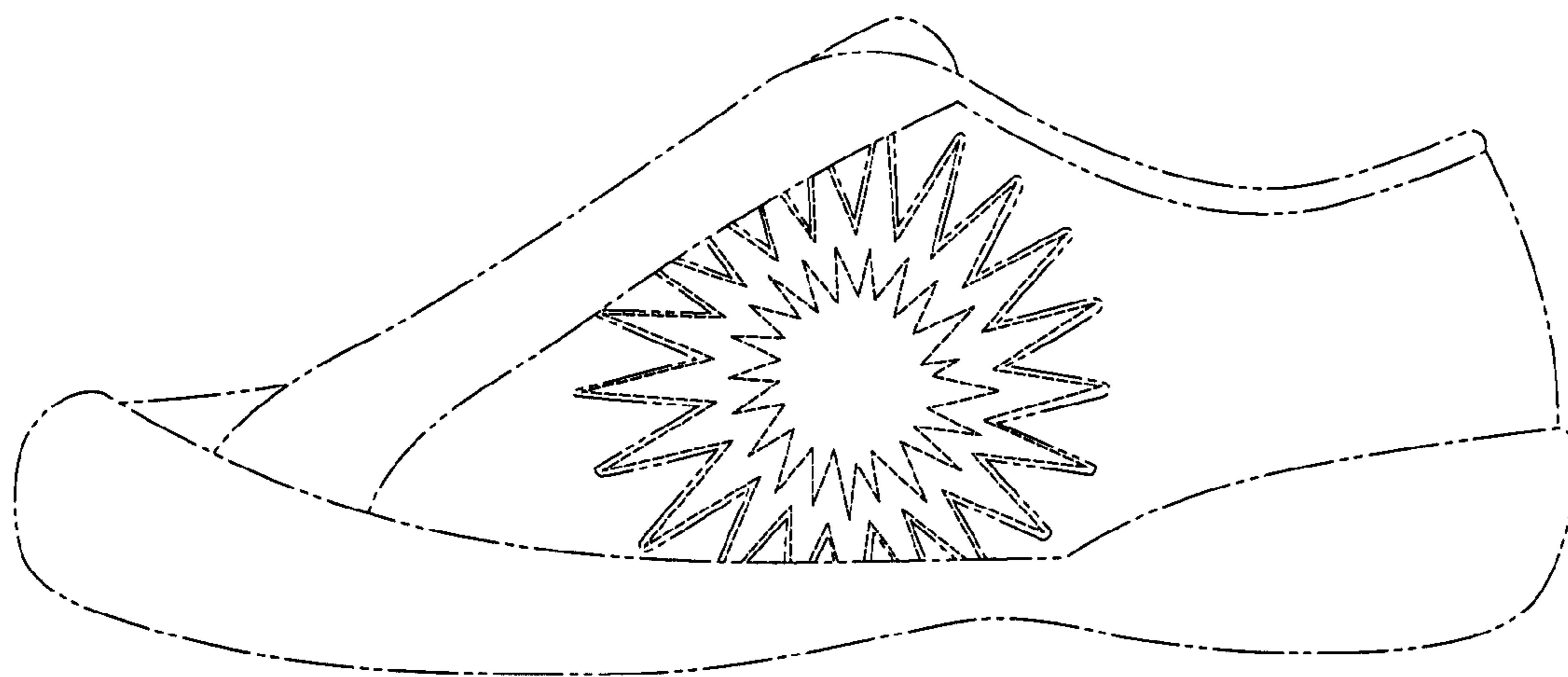

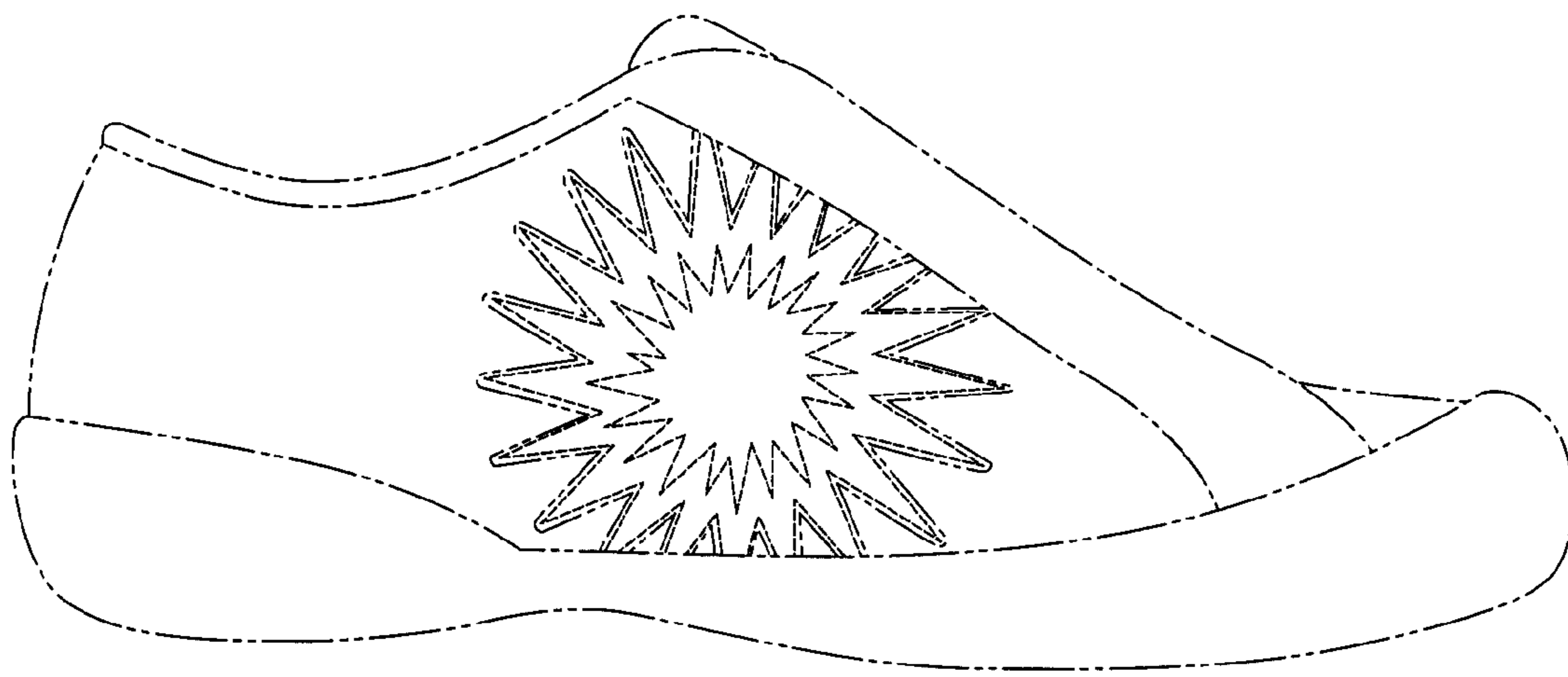

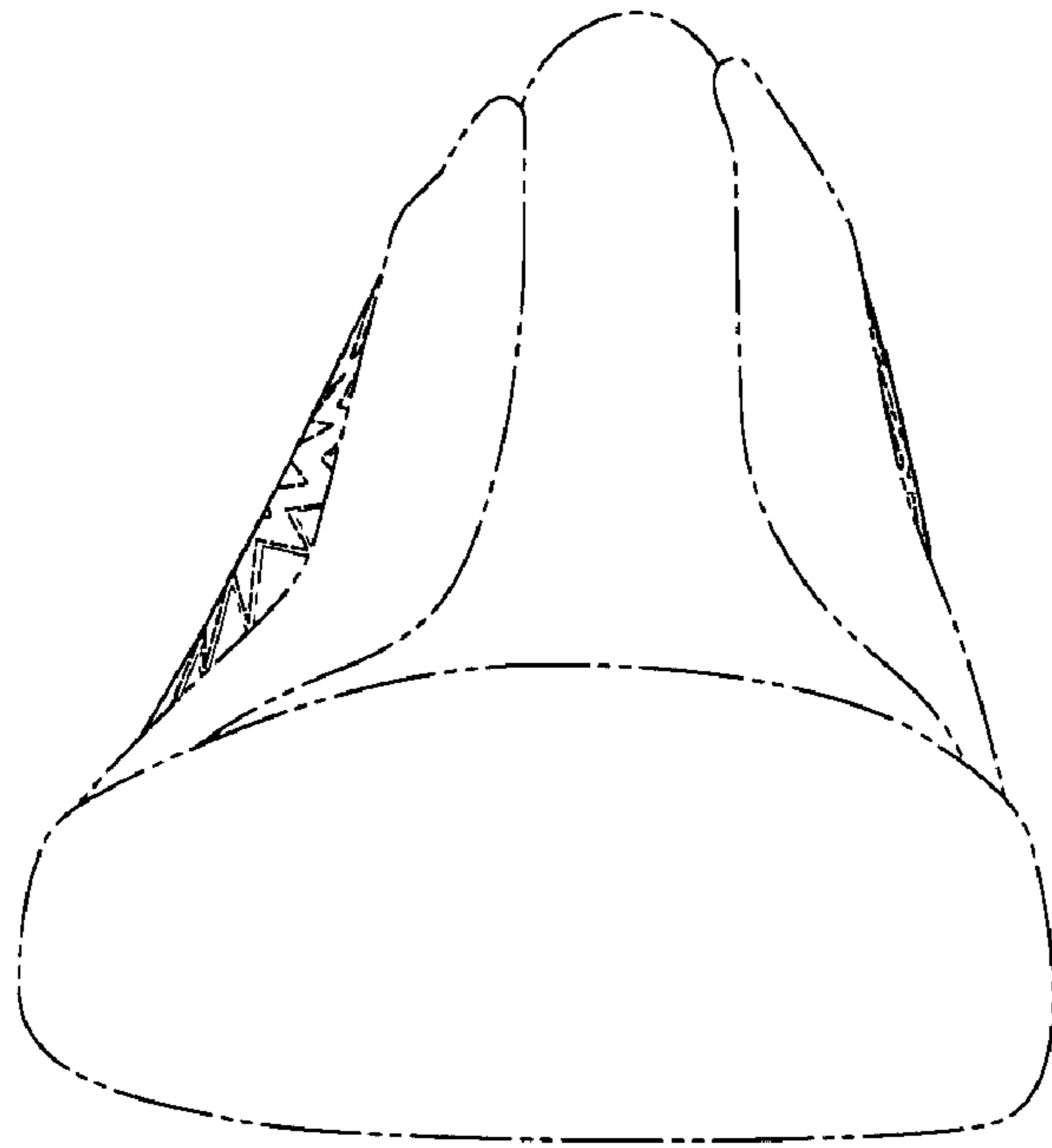

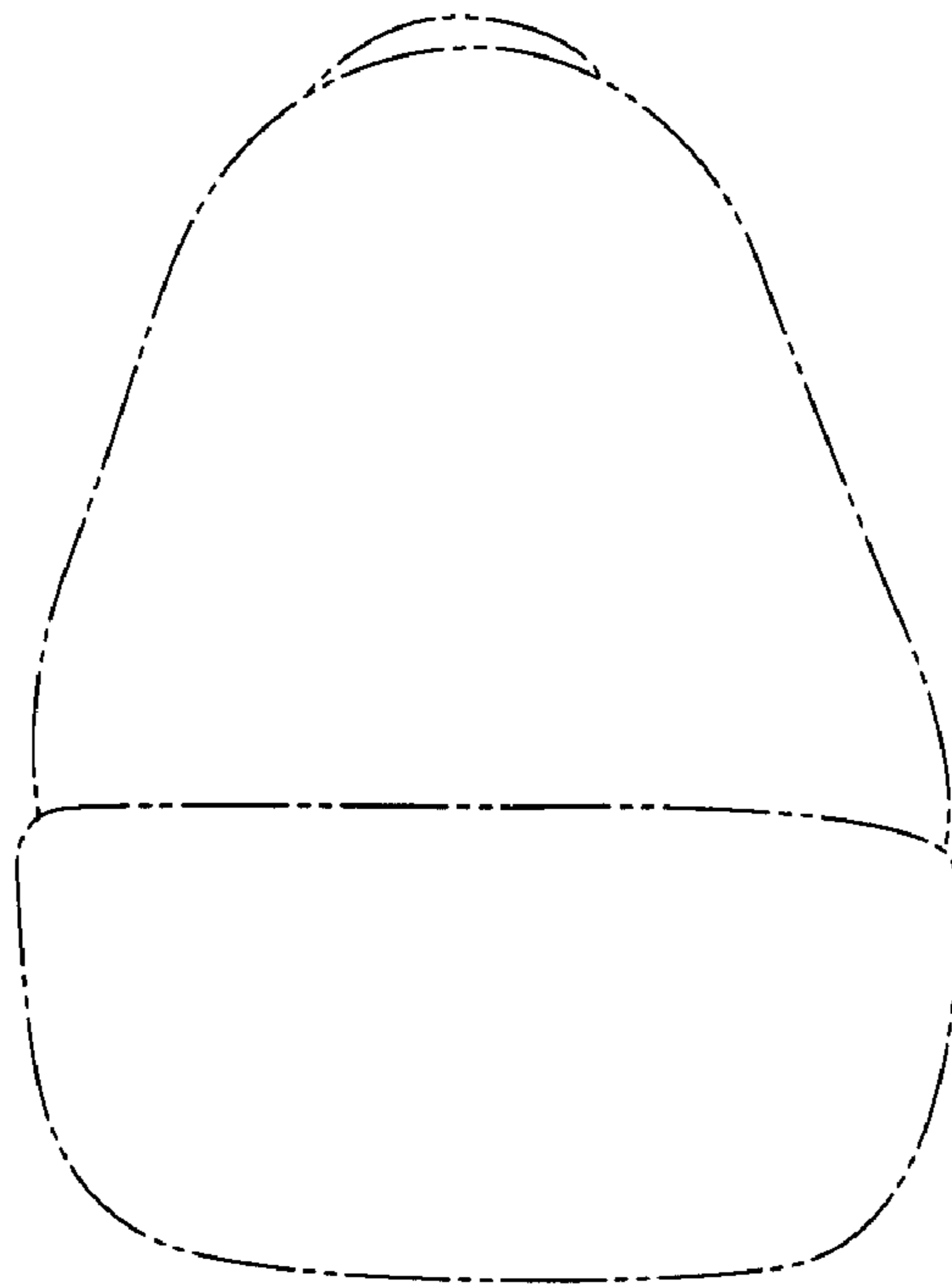
