(57) **CLAIM**

The ornamental design for a belt-mounted tool holder, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the belt-mounted tool holder embodying my new design,

FIG. 2 is a rear view of the tool holder,

FIG. 3 is a left side view of the tool holder,

FIG. 4 is a right side view of the tool holder,

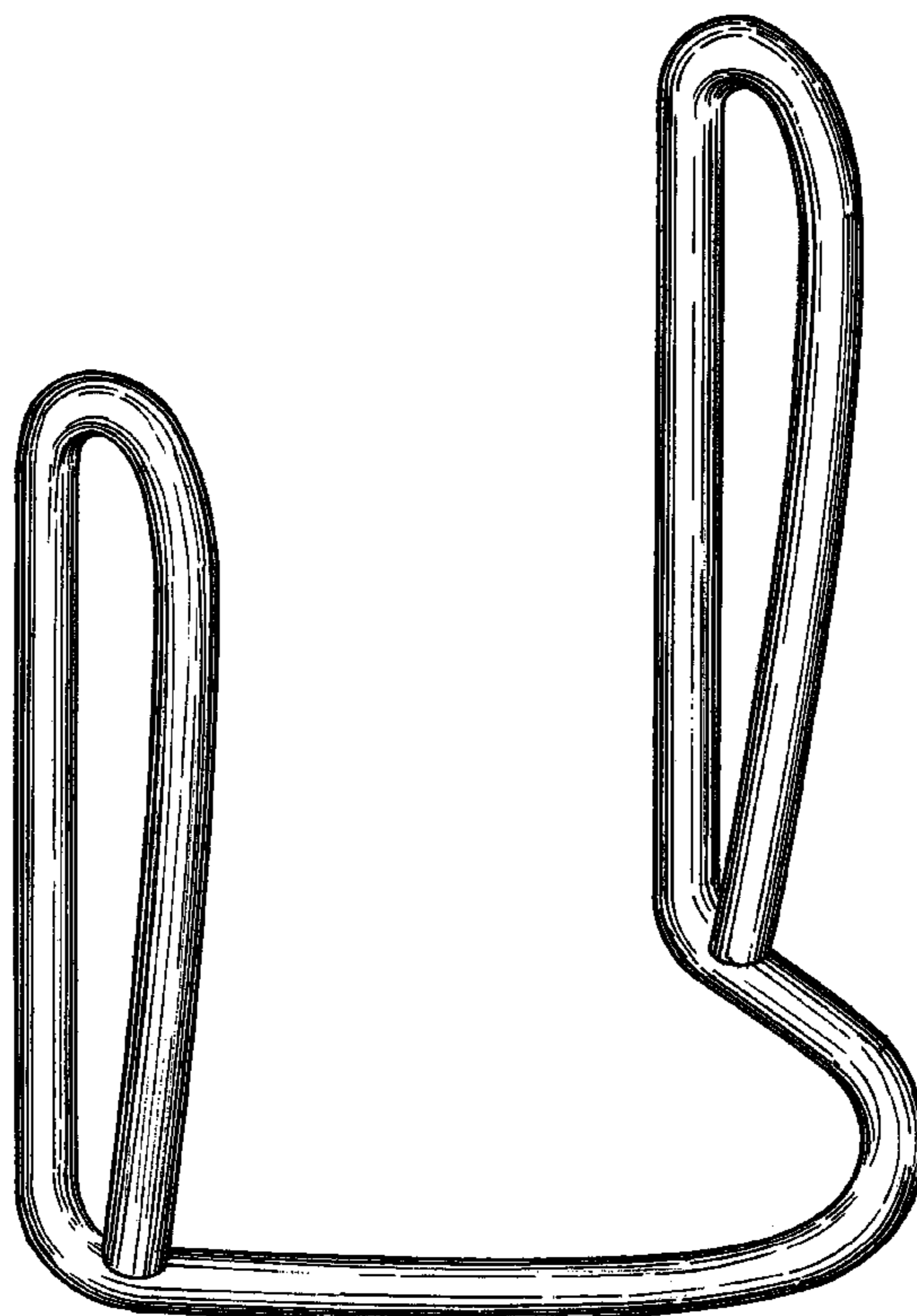
FIG. 5 is a top view of the tool holder,

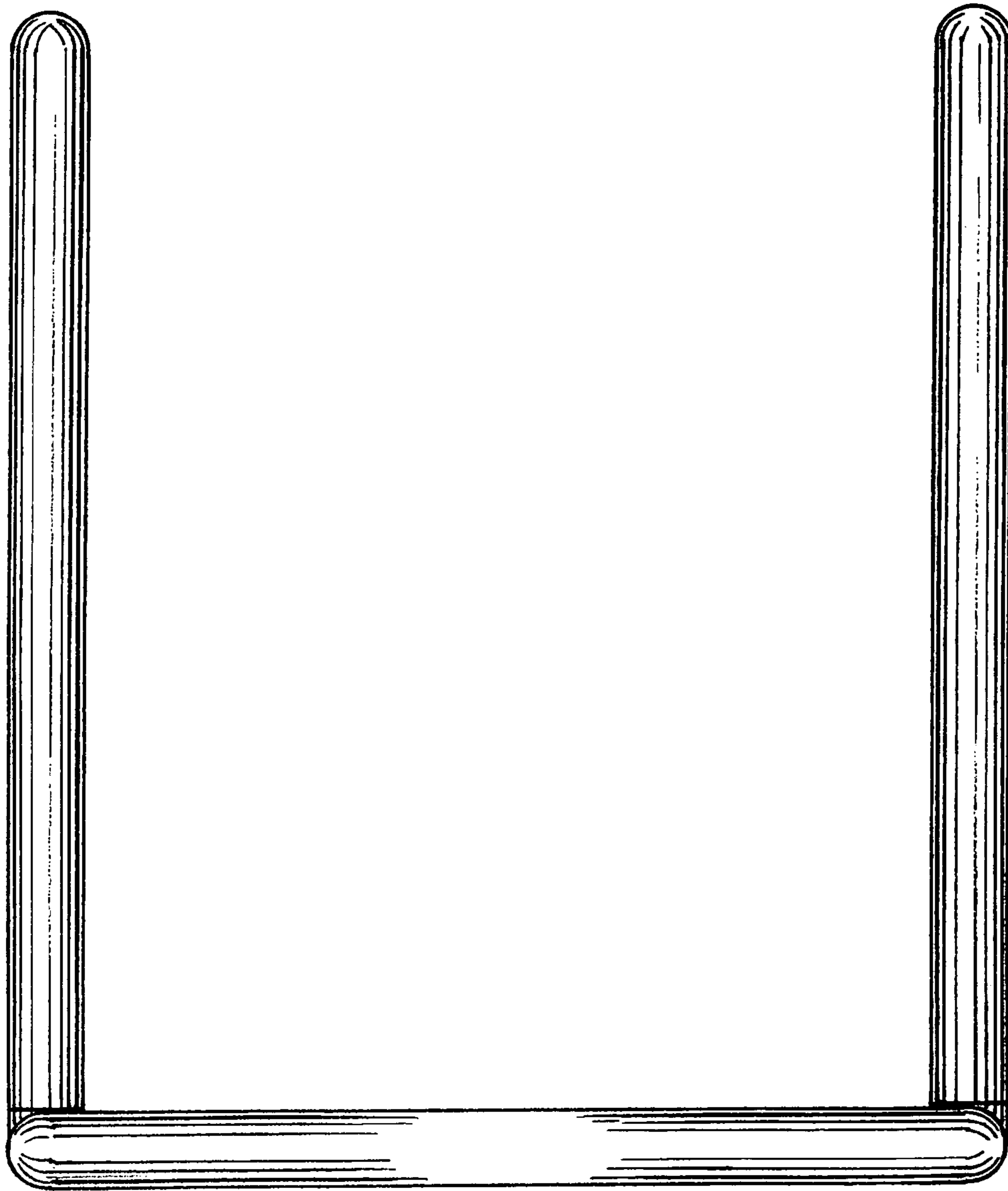

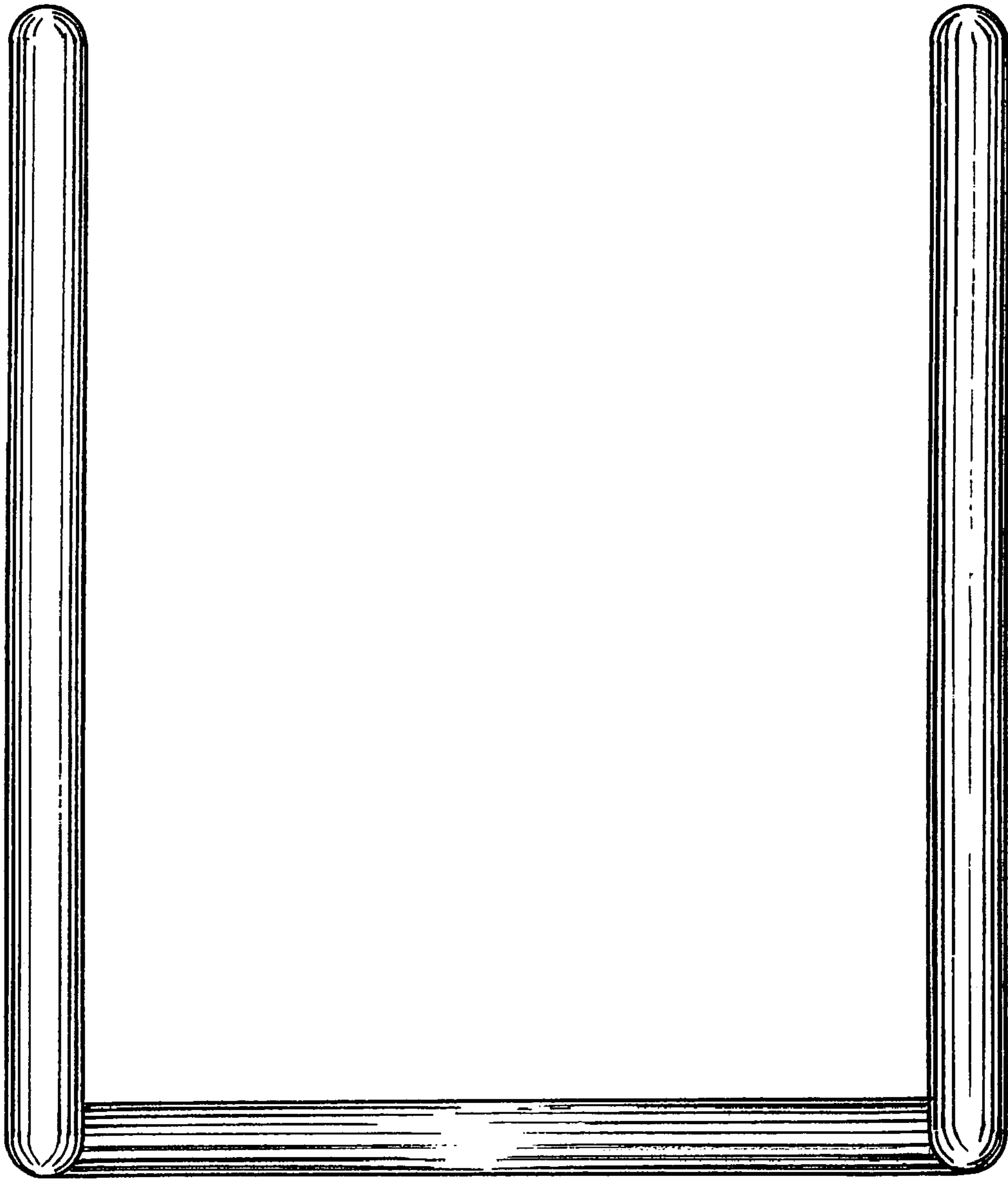

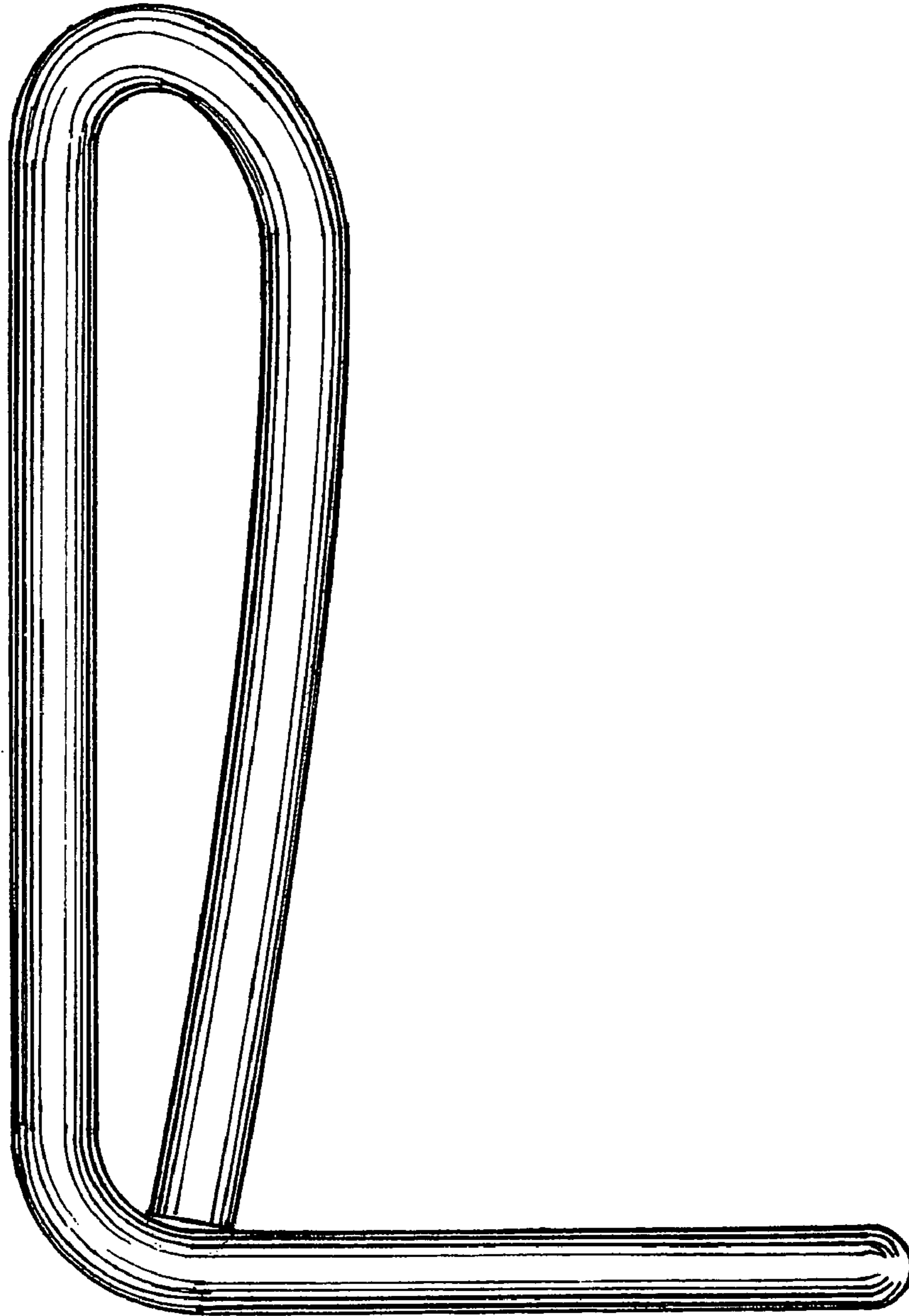

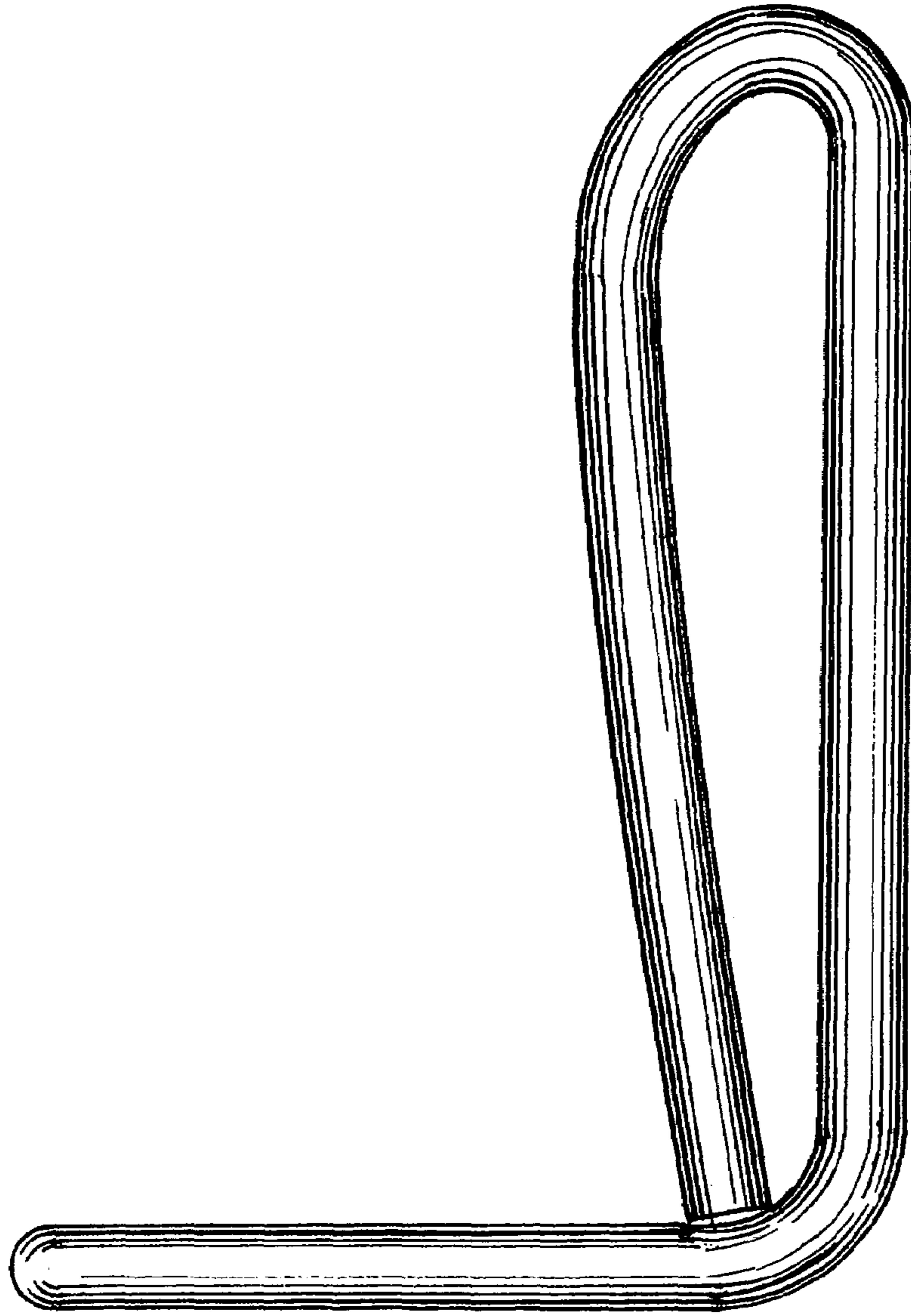

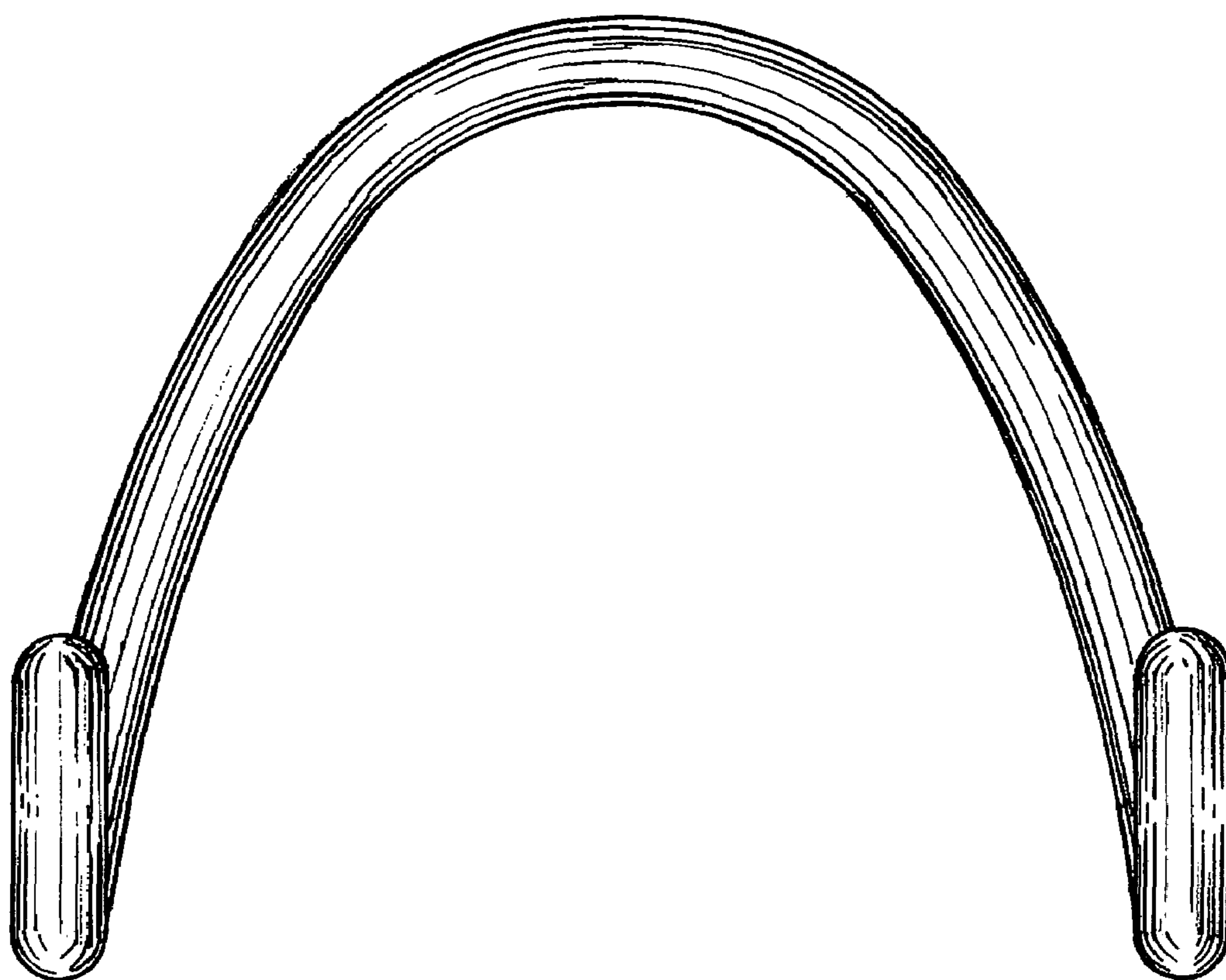

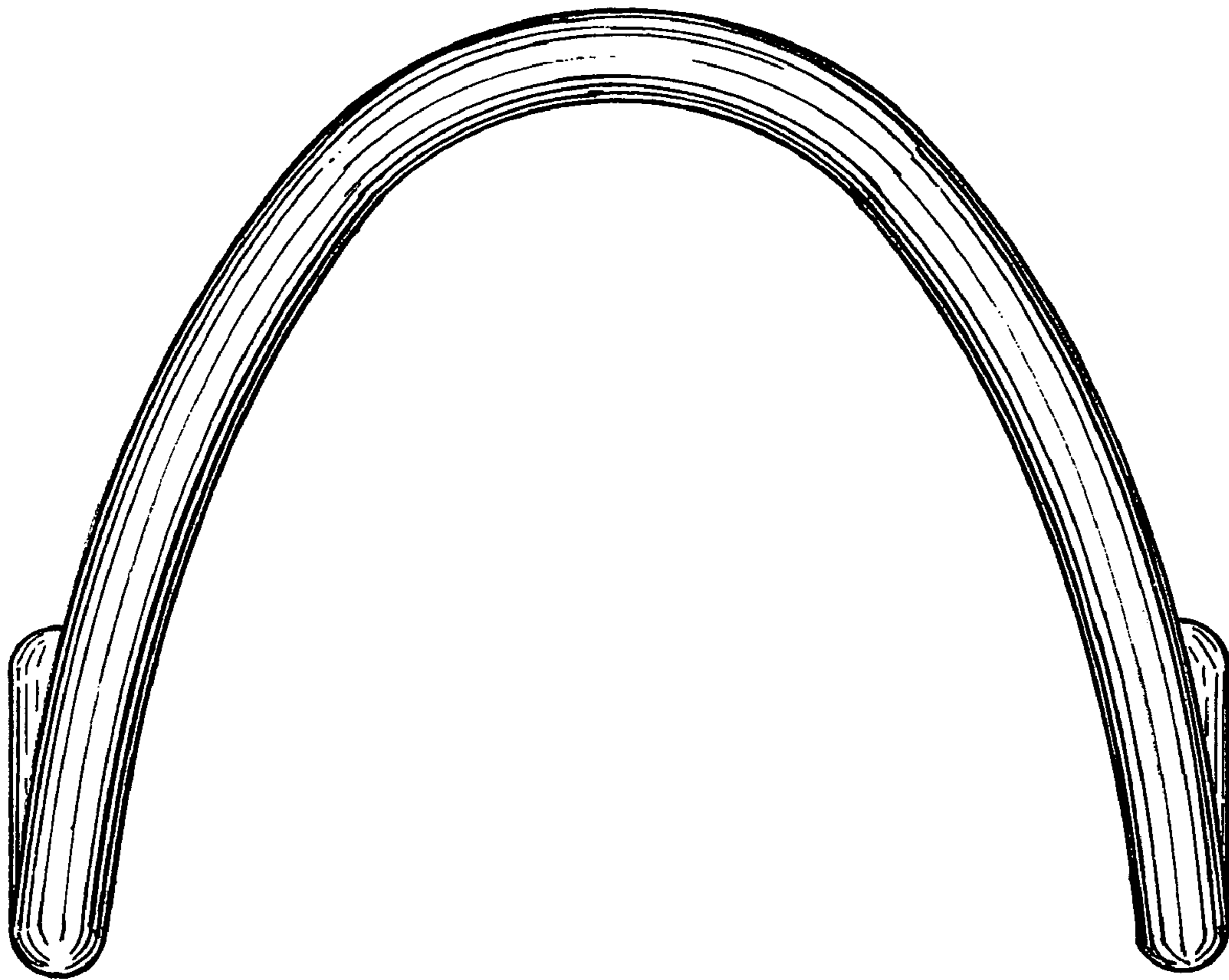

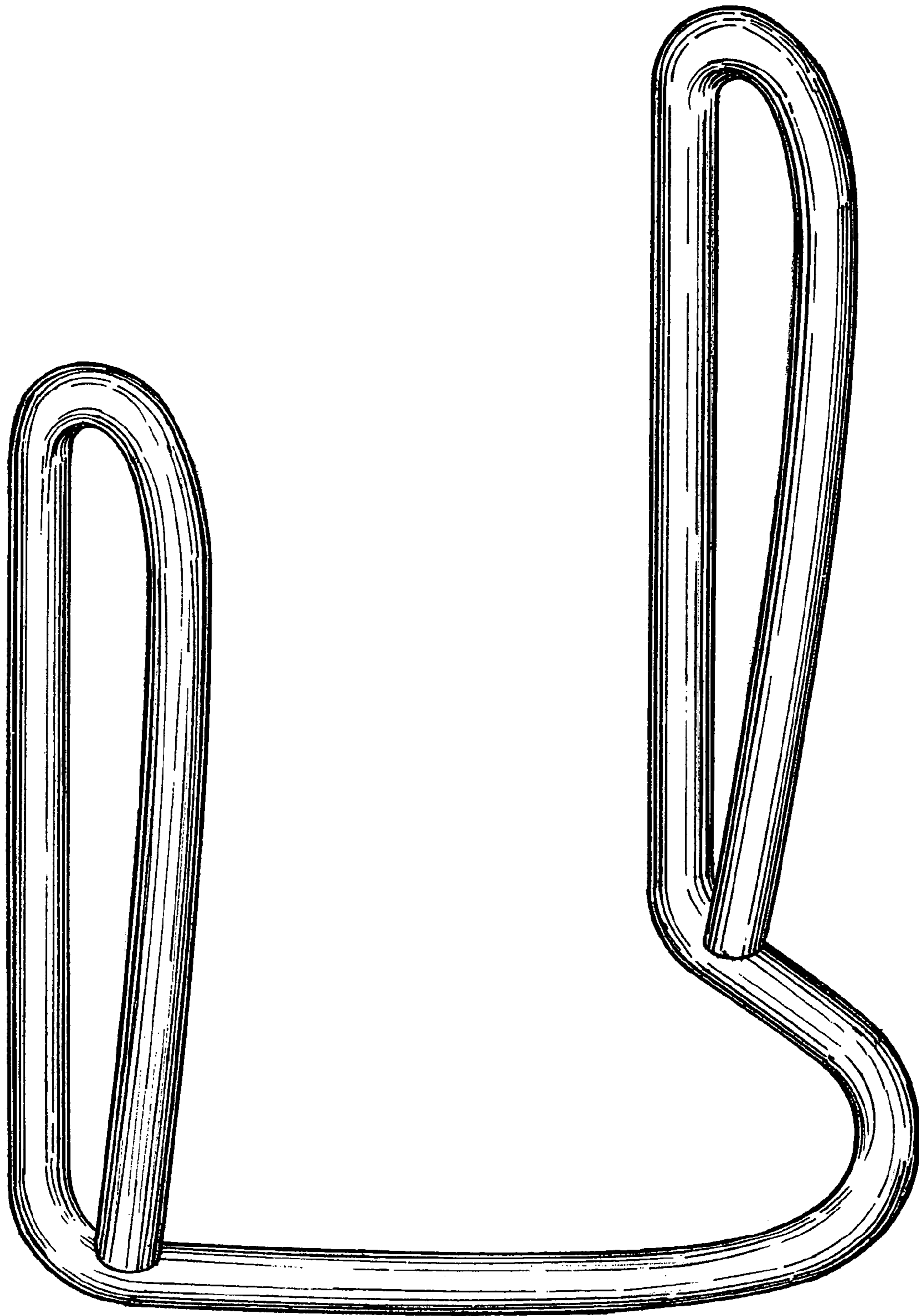

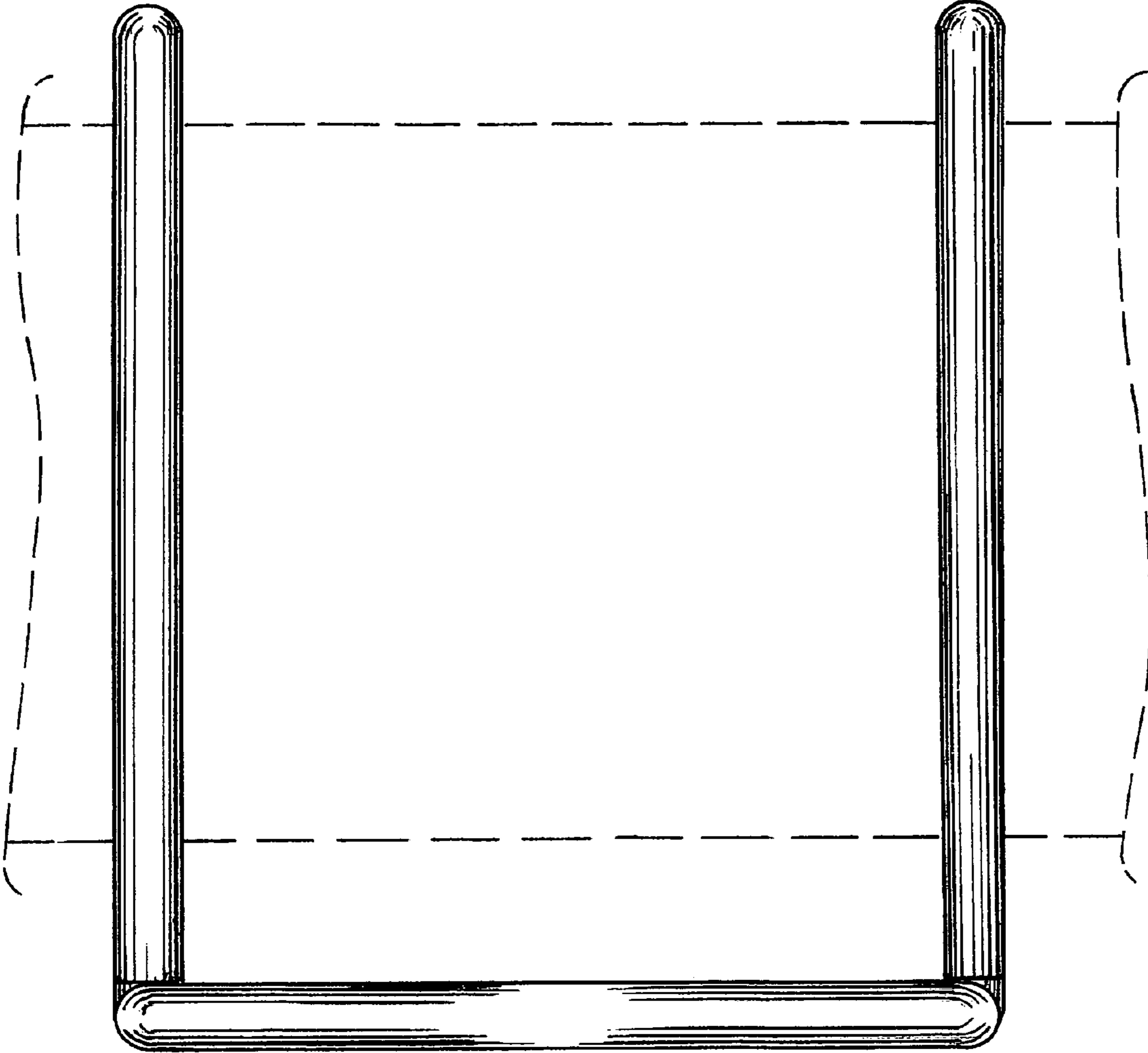
