FIG. 2 is a top view of the mascara brush of FIG. 4;

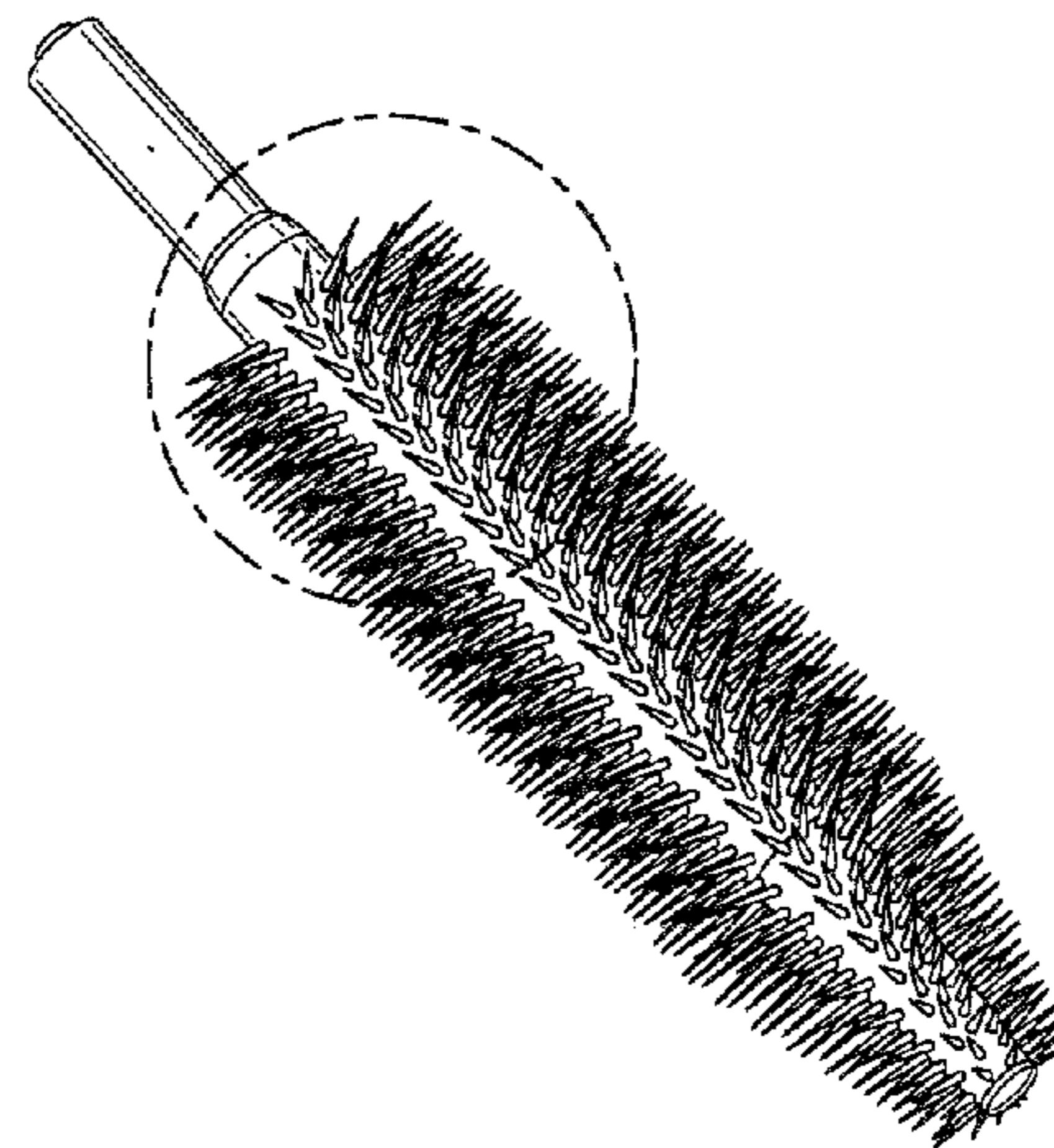
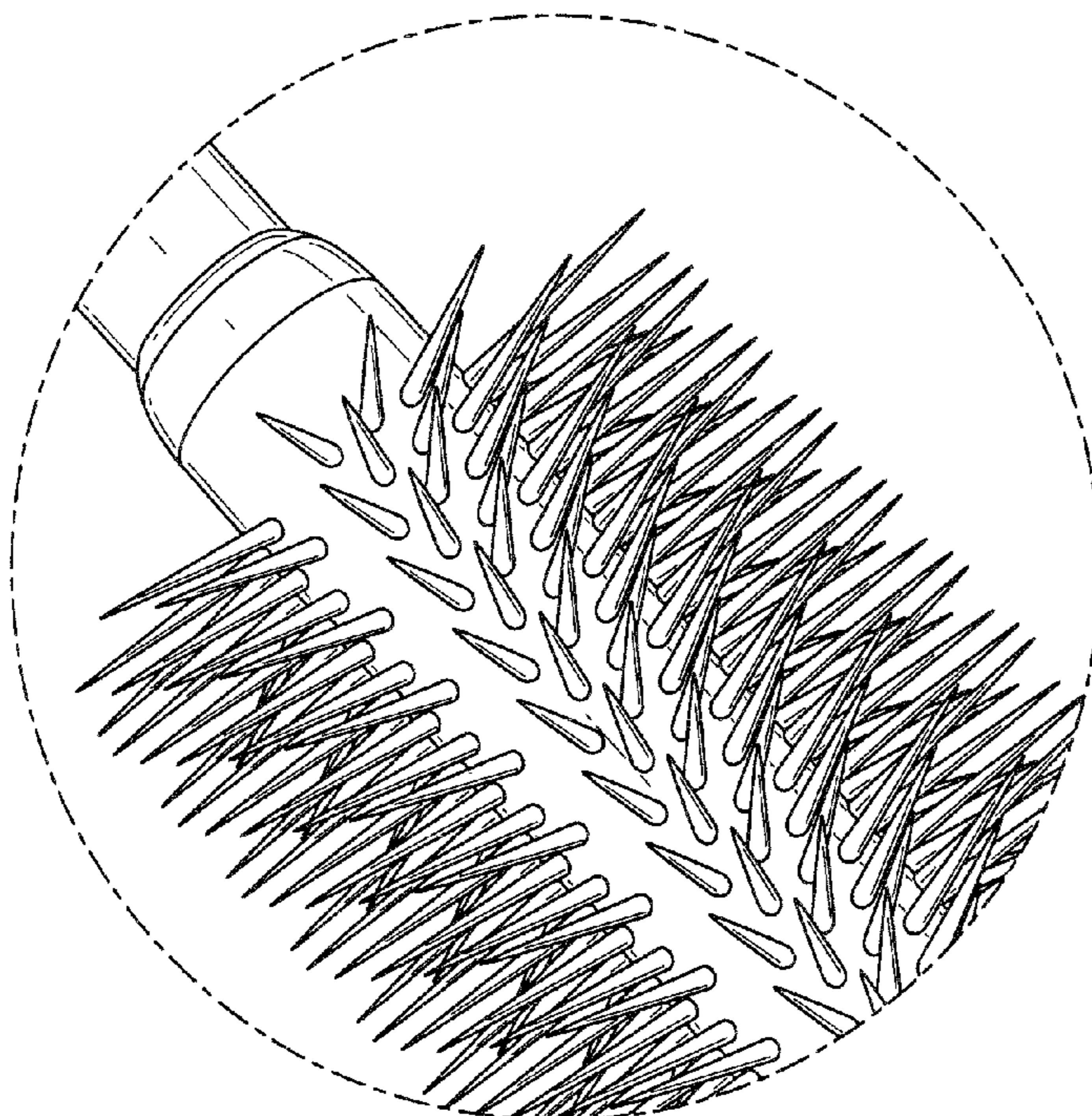
FIG. 3 is a rear view of the mascara brush of FIG. 4;

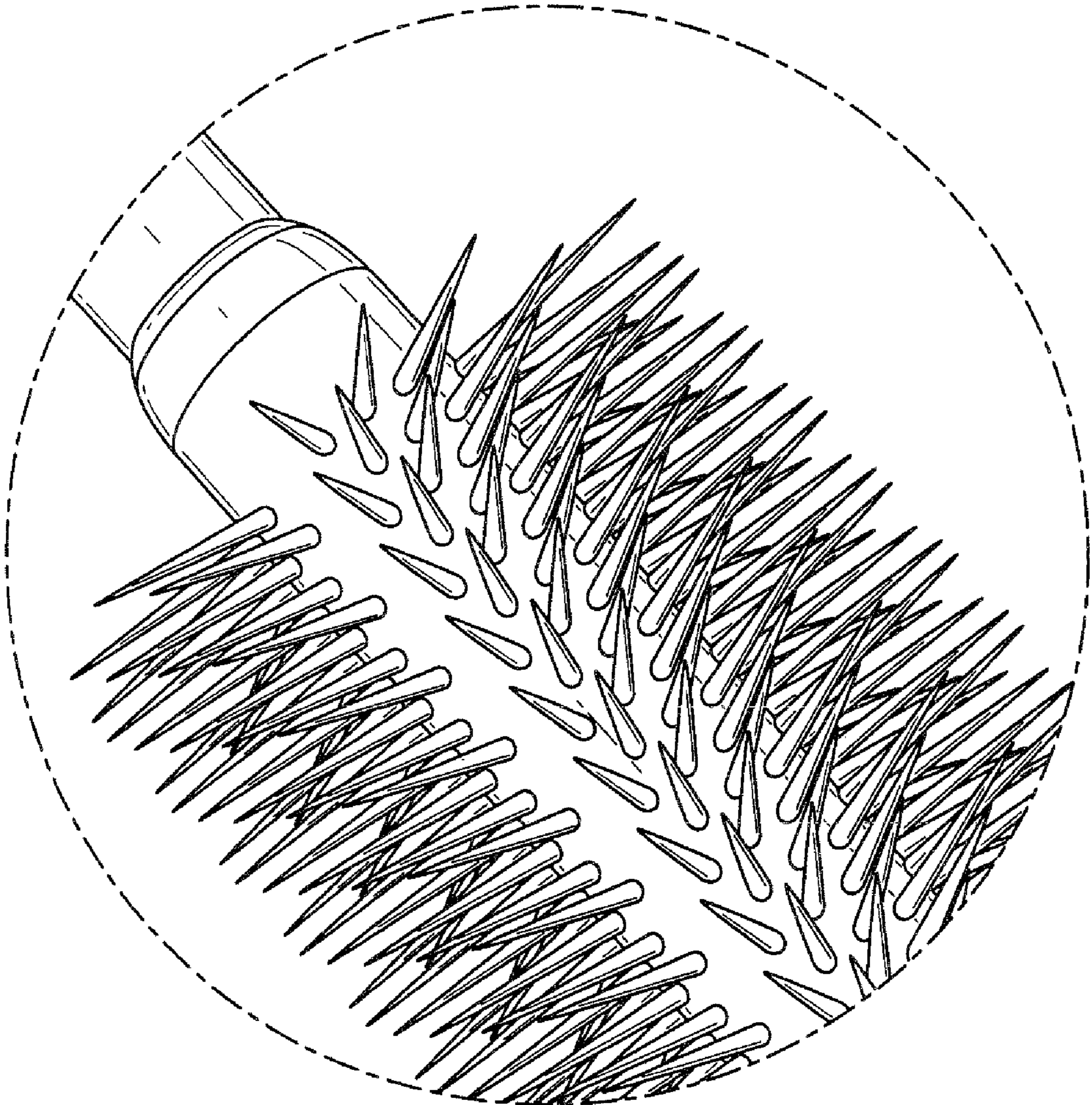

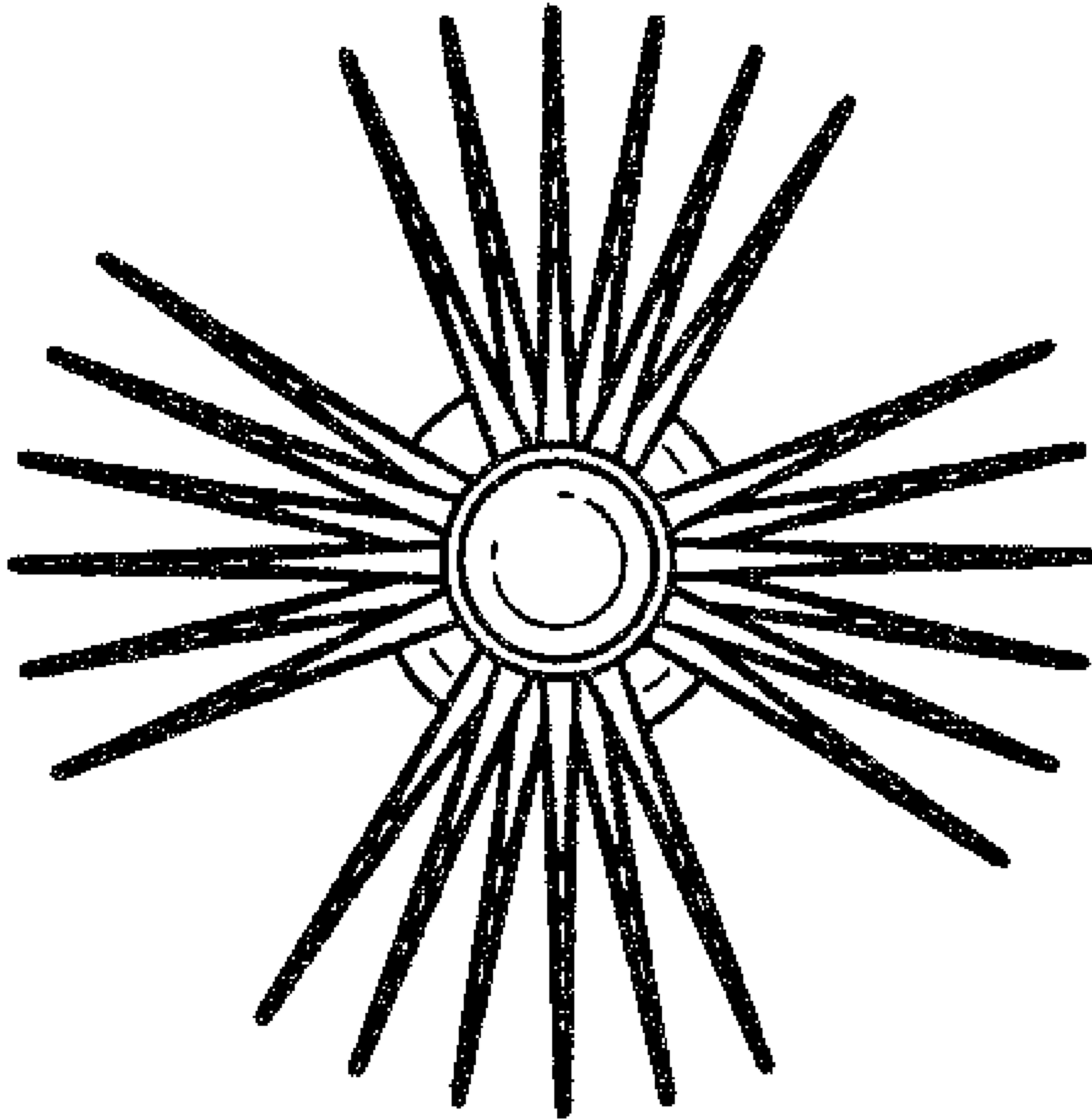

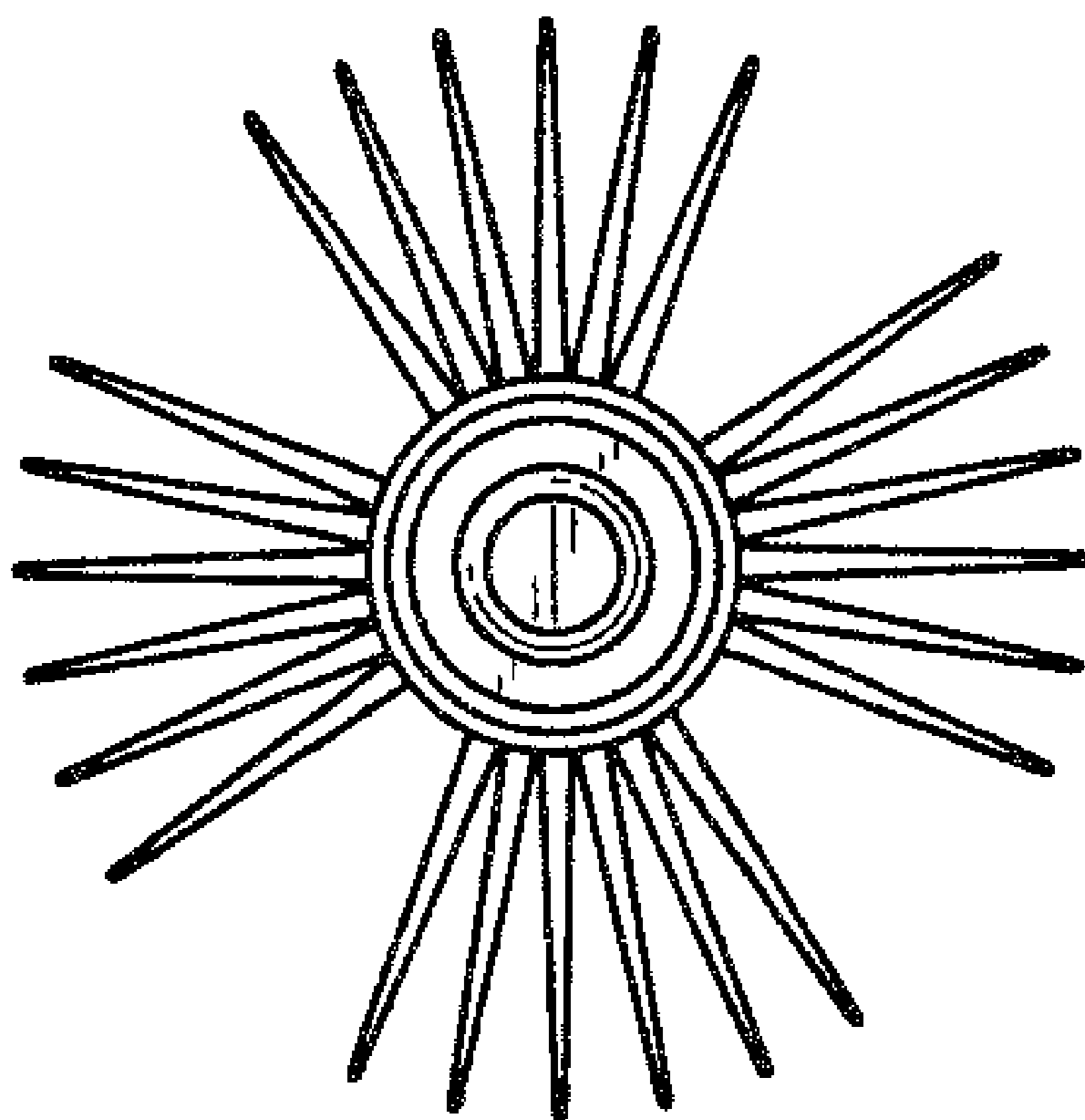

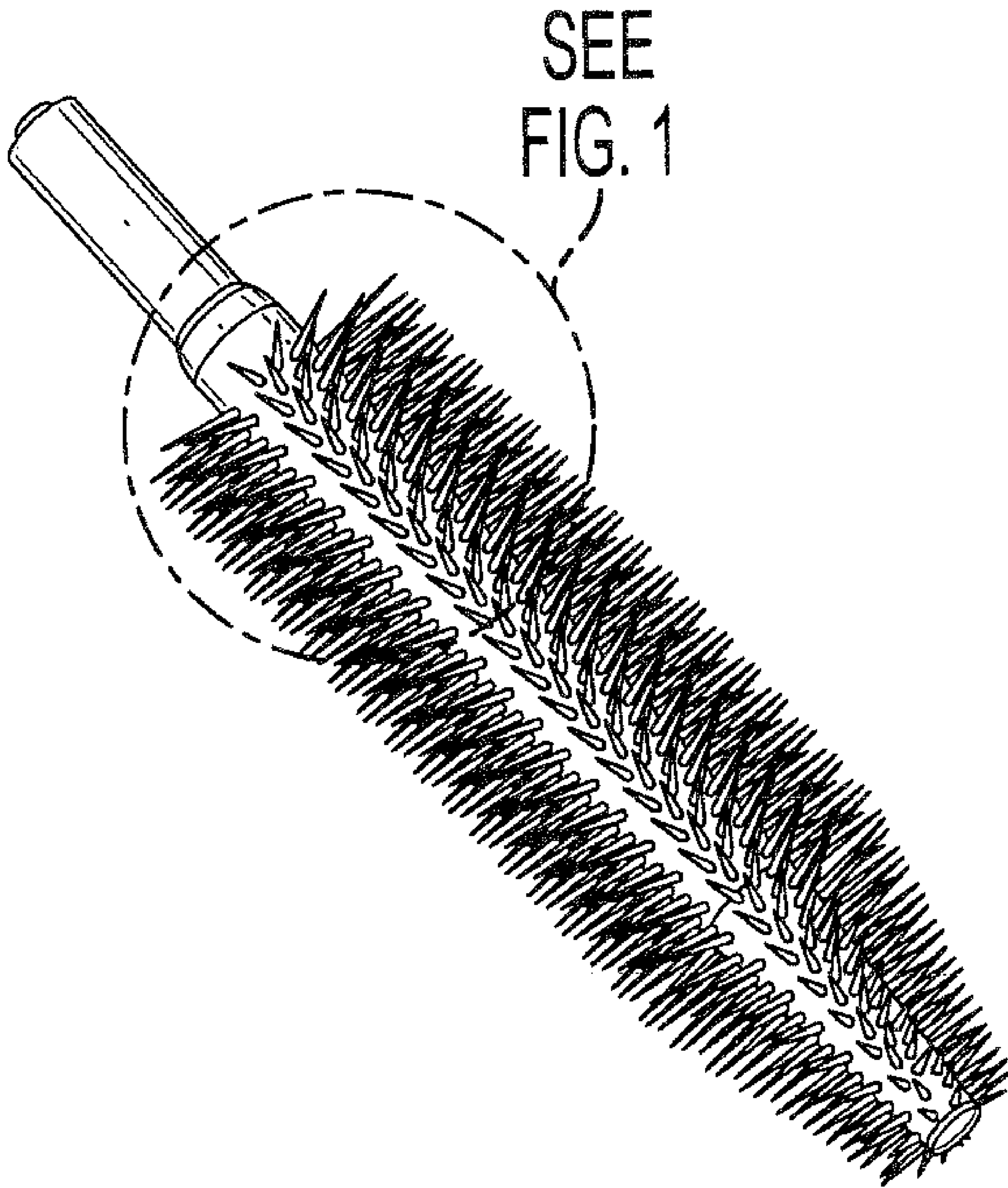

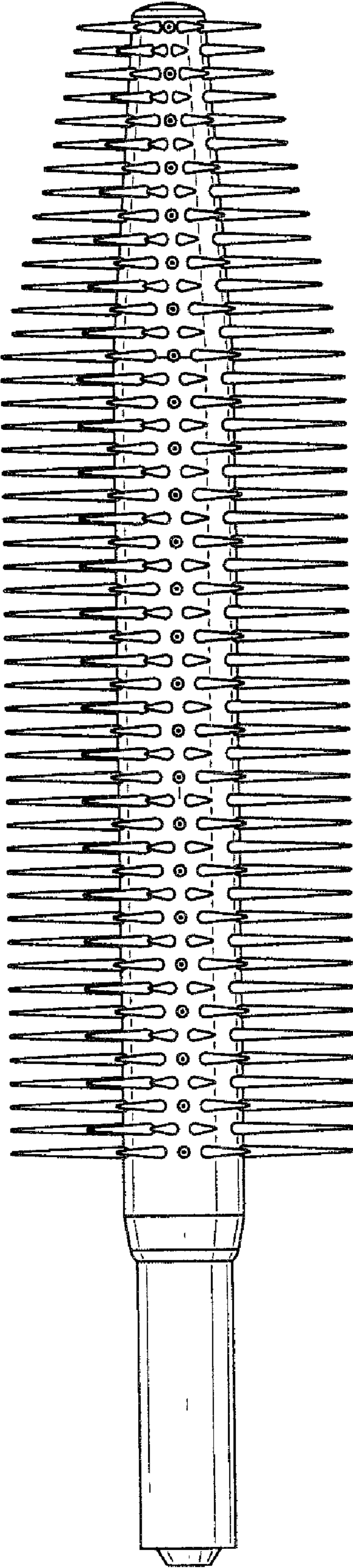

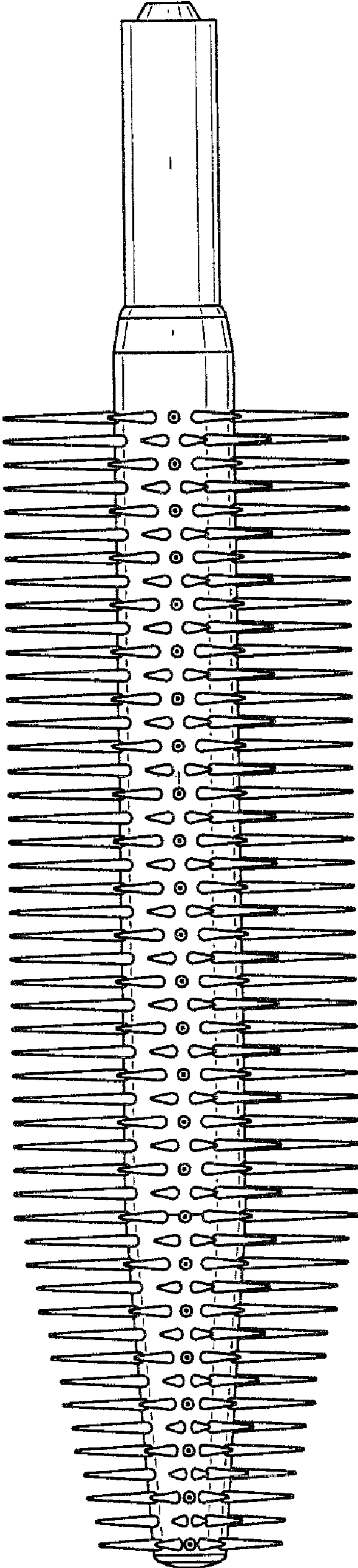
