**DESCRIPTION**

FIG. 1 is a front-side perspective view of a round-ended santoku knife showing my new design.

FIG. 7 is a top plan view thereof.

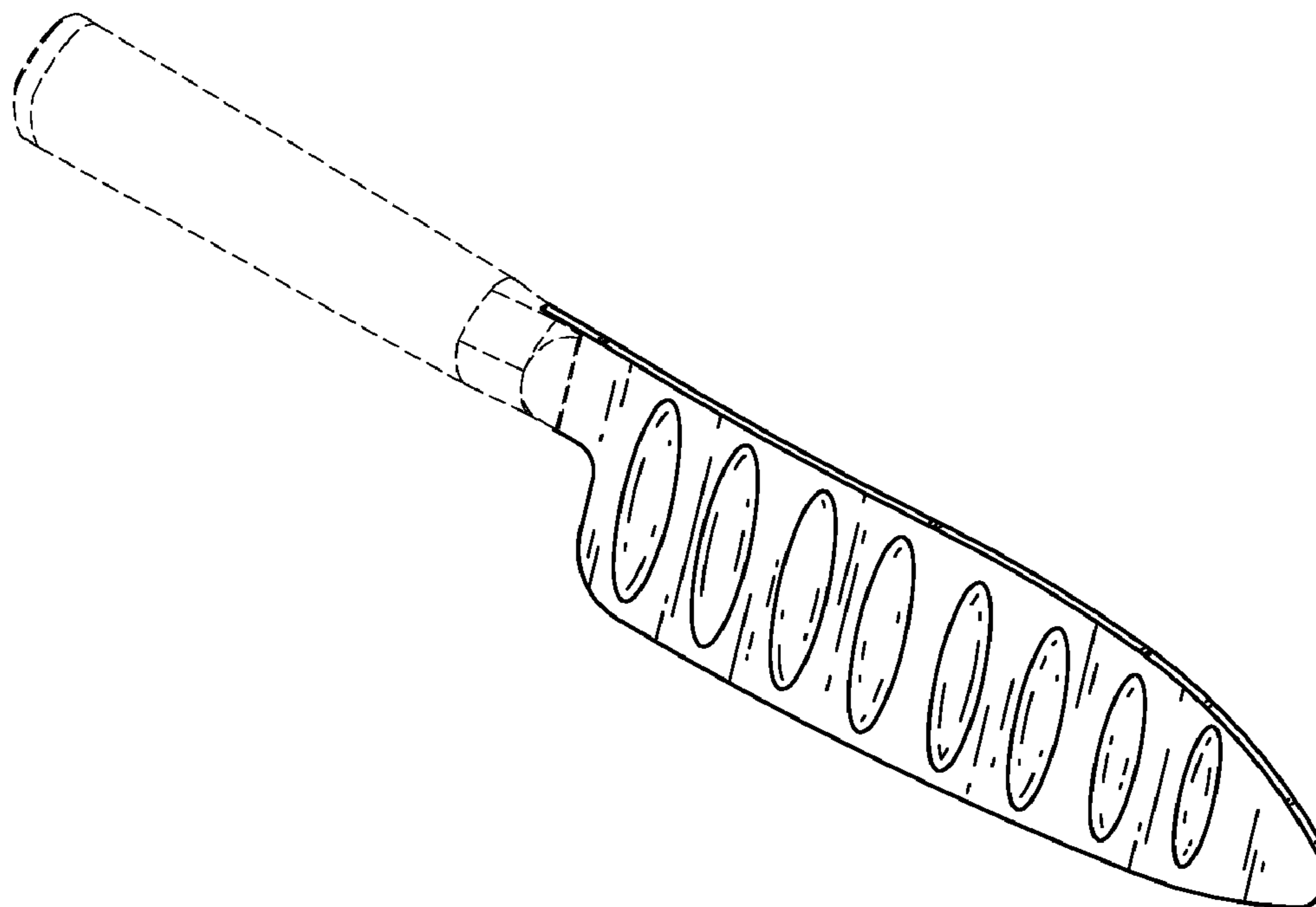

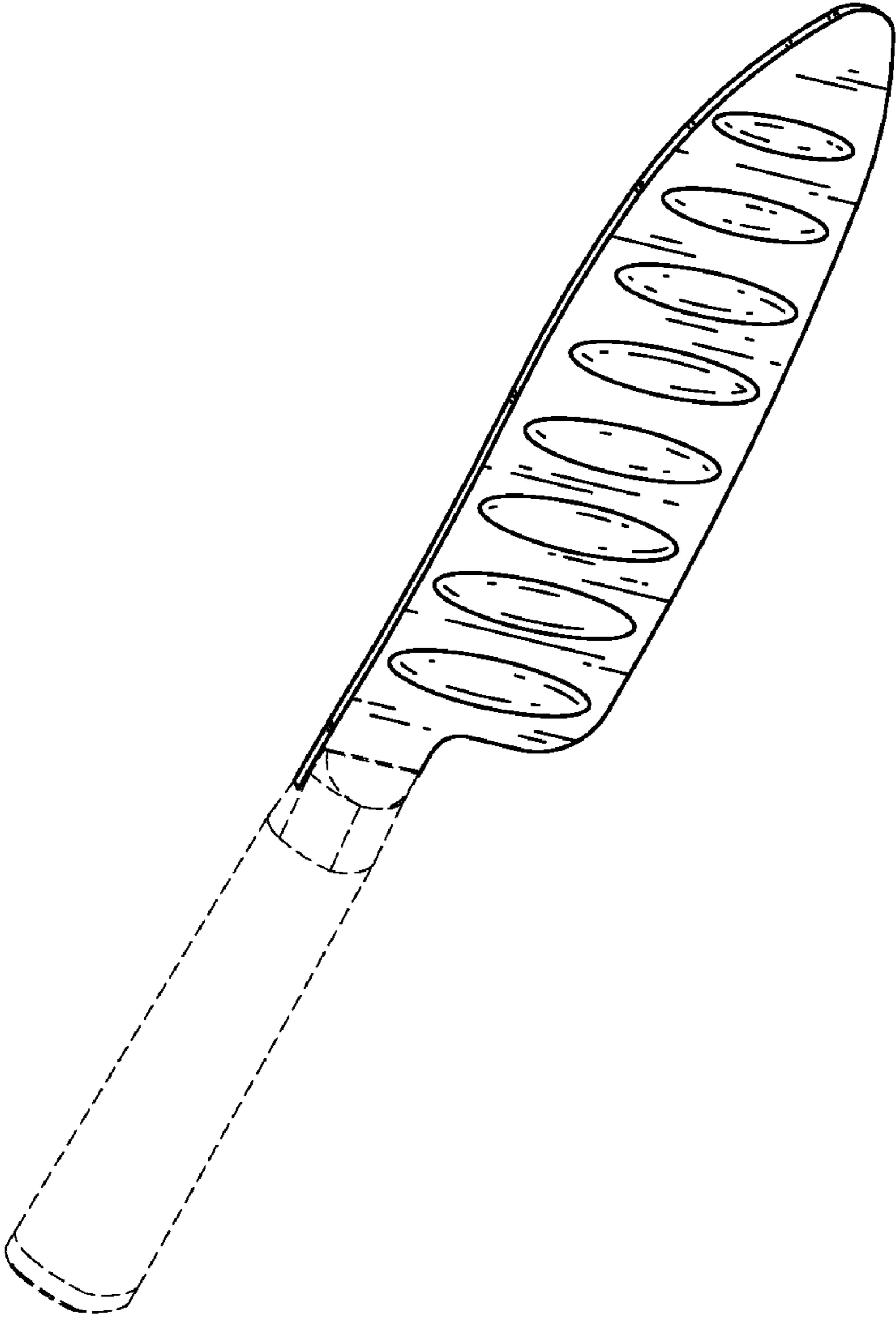

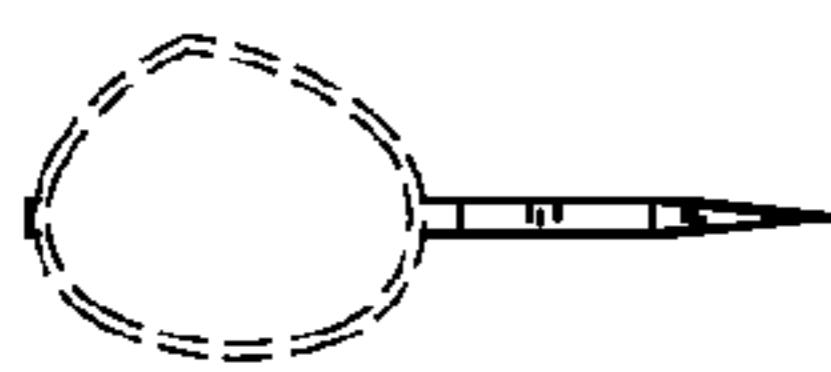

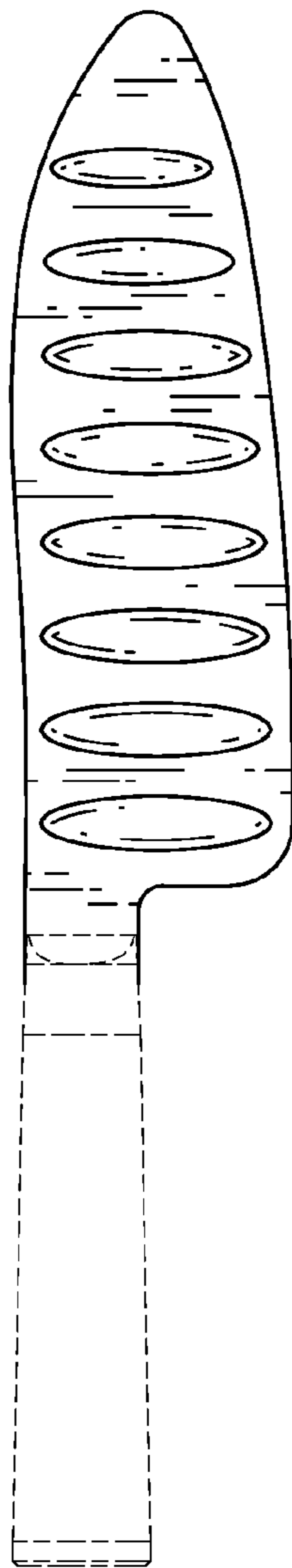

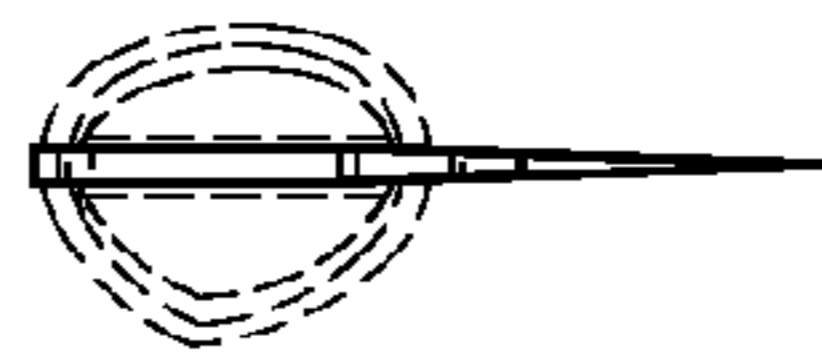
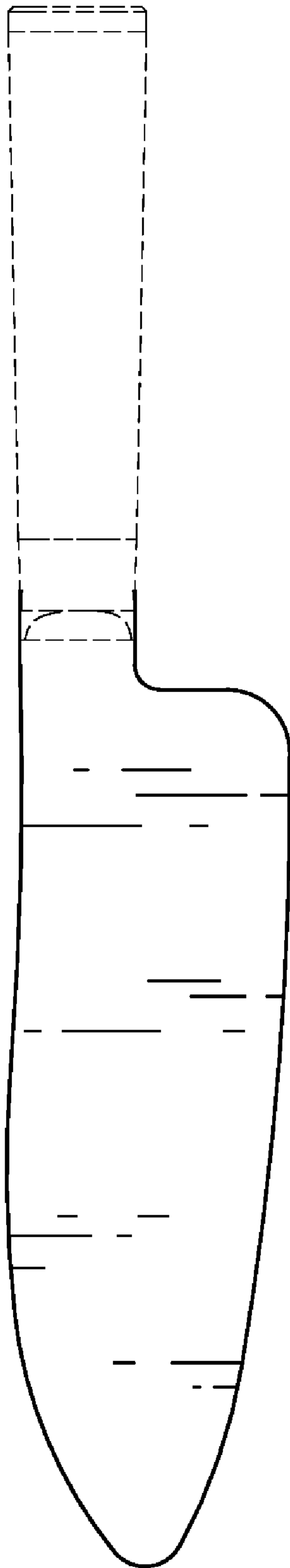
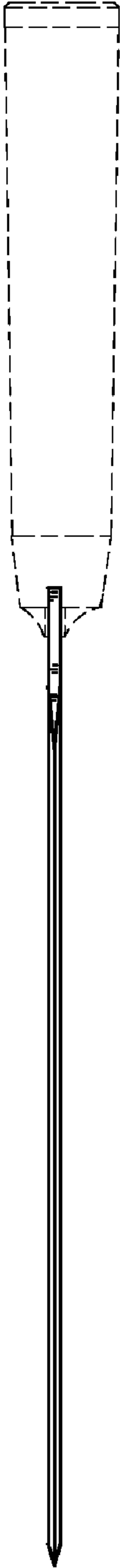


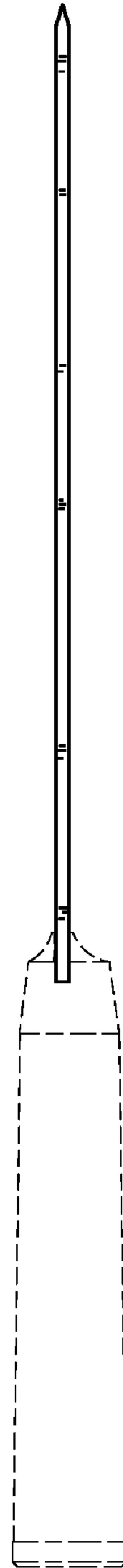
