The ornamental design for a packet dispenser, substantially as shown and described.

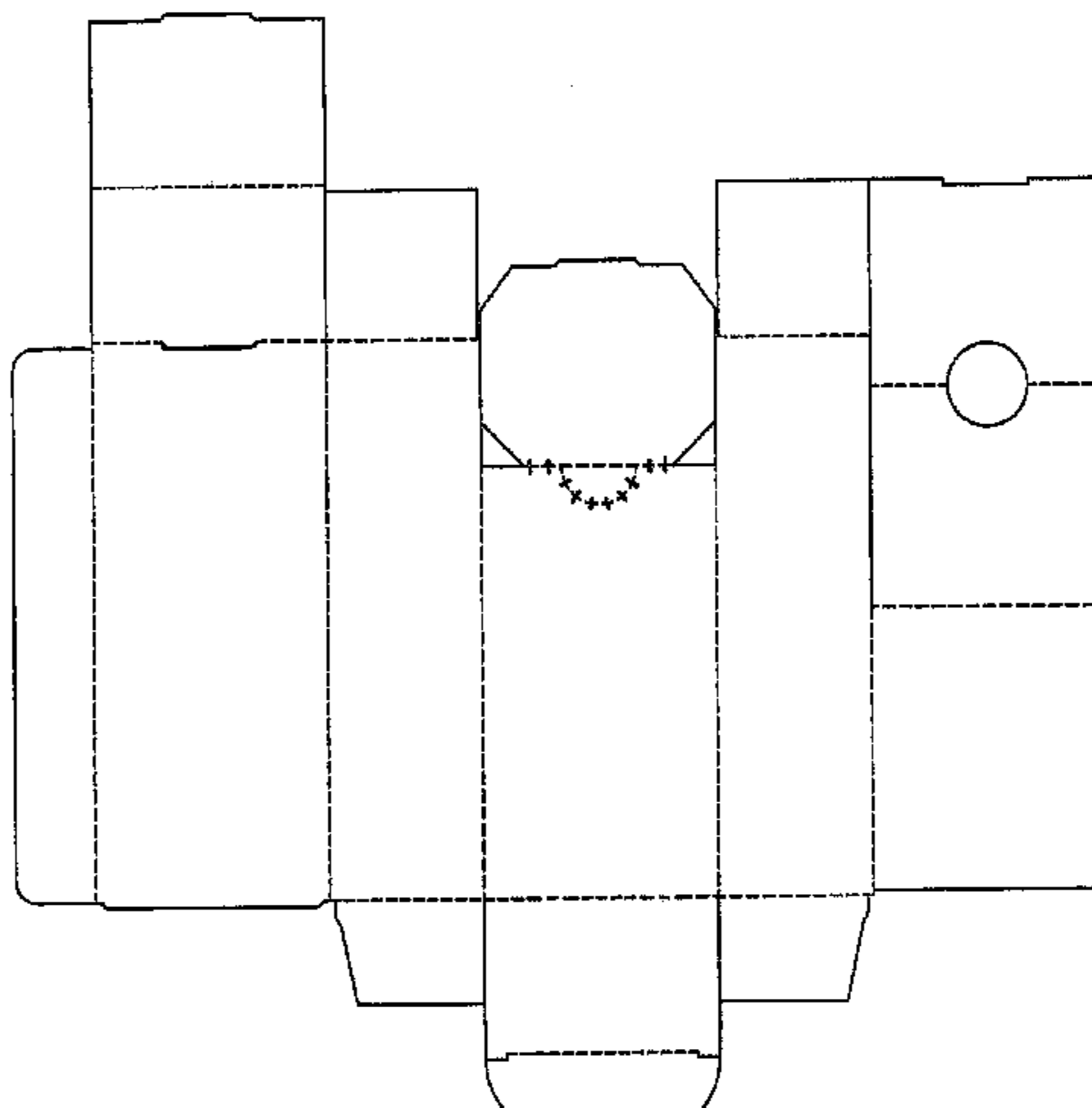
DESCRIPTION

FIG. 1 is a plan view of a packet dispenser; and,

FIG. 2 is a plan view of the opposite side of the packet dispenser of FIG. 1.

The dashed lines represent claimed fold lines. The cross-dashed lines represent claimed tear or severance lines.

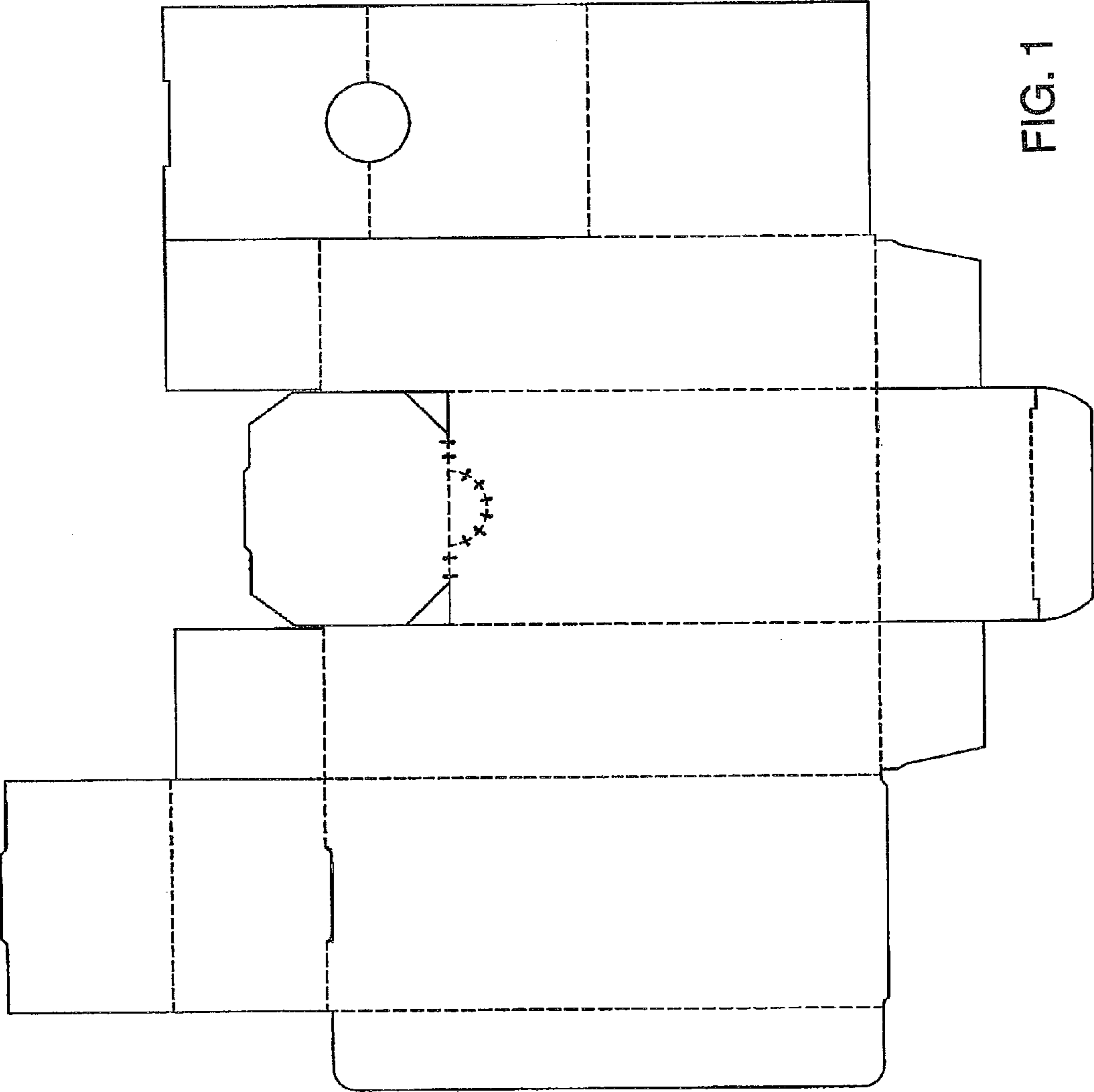

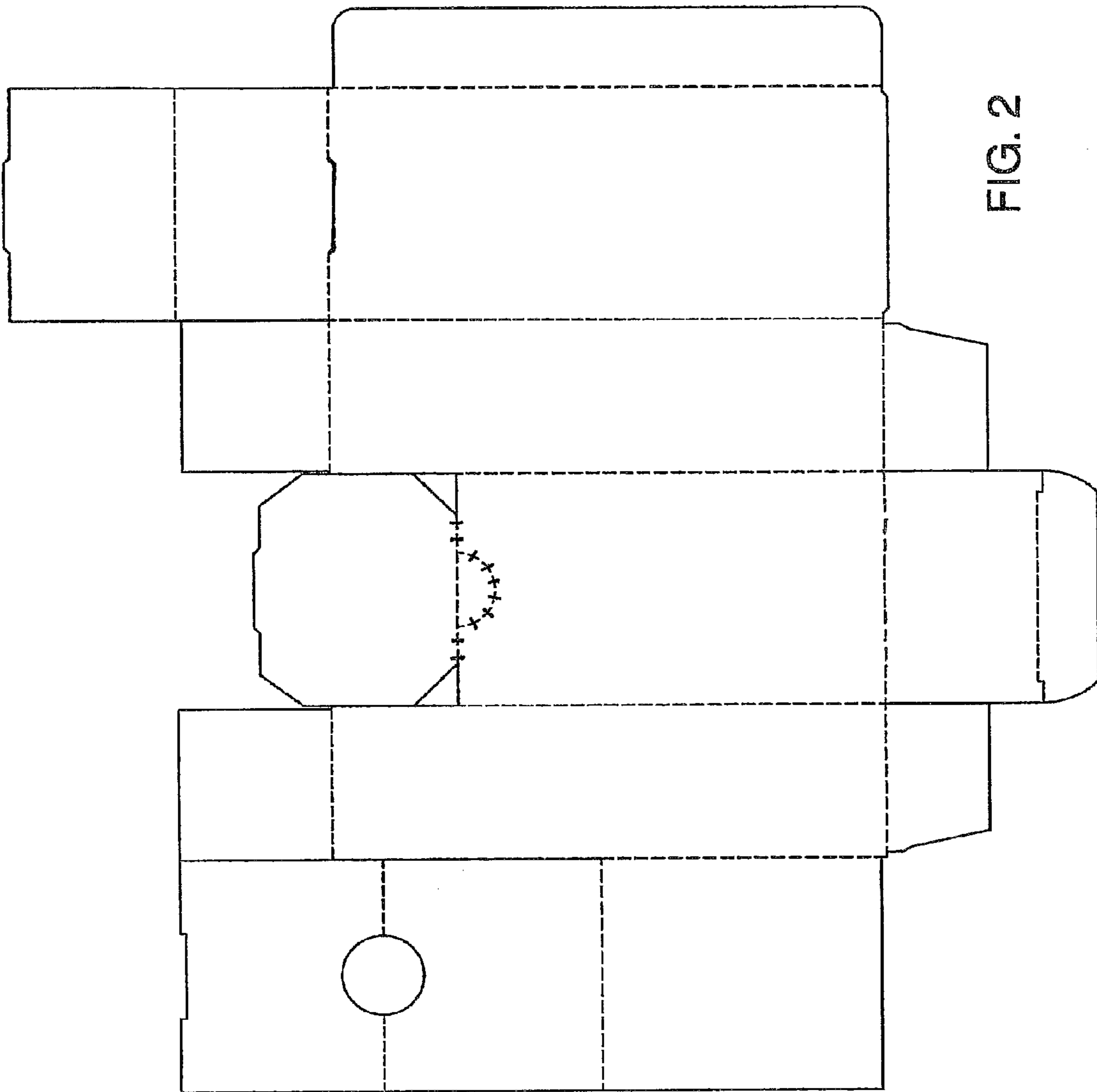
