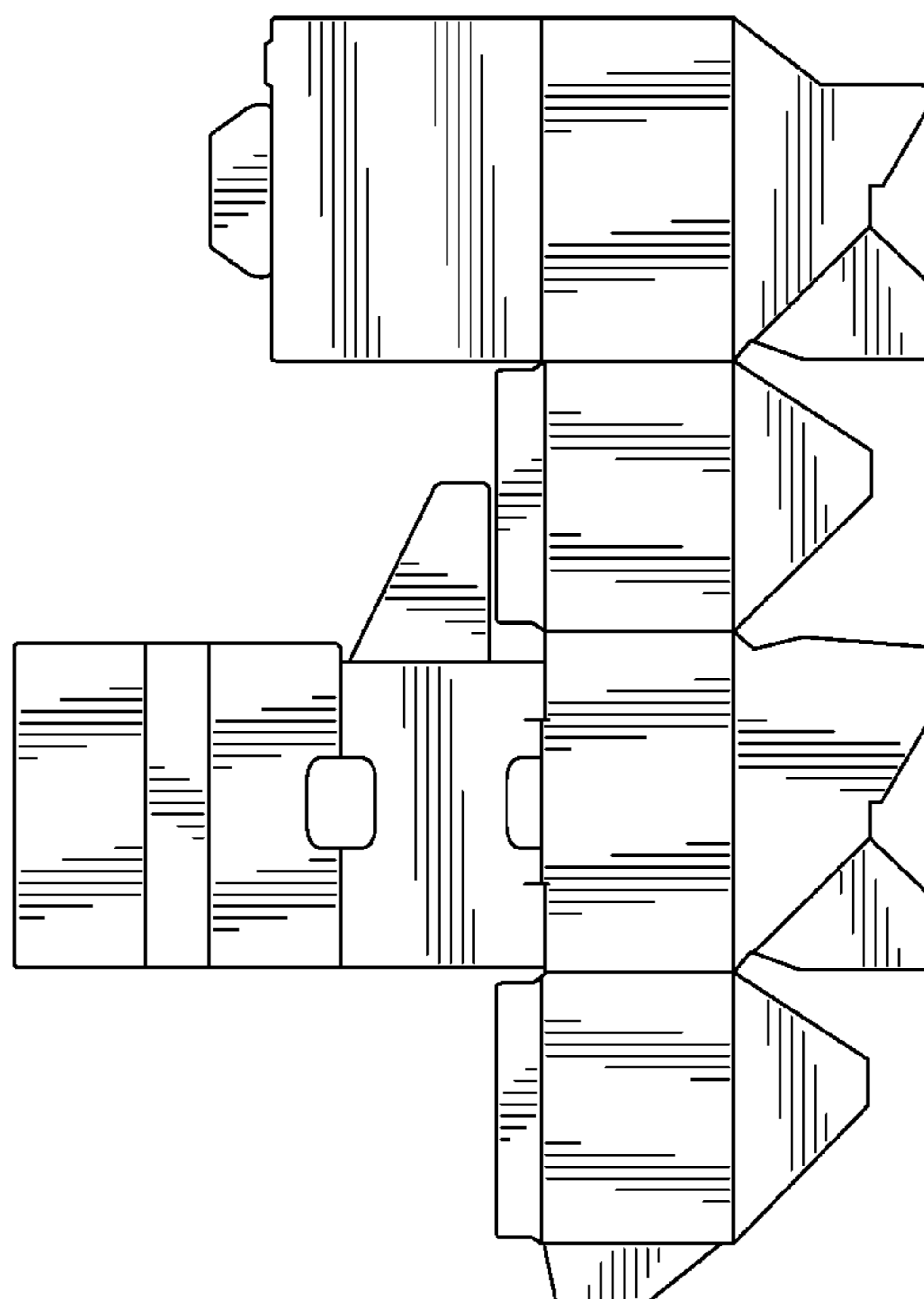
The ornamental design for a box blank, as shown and described.

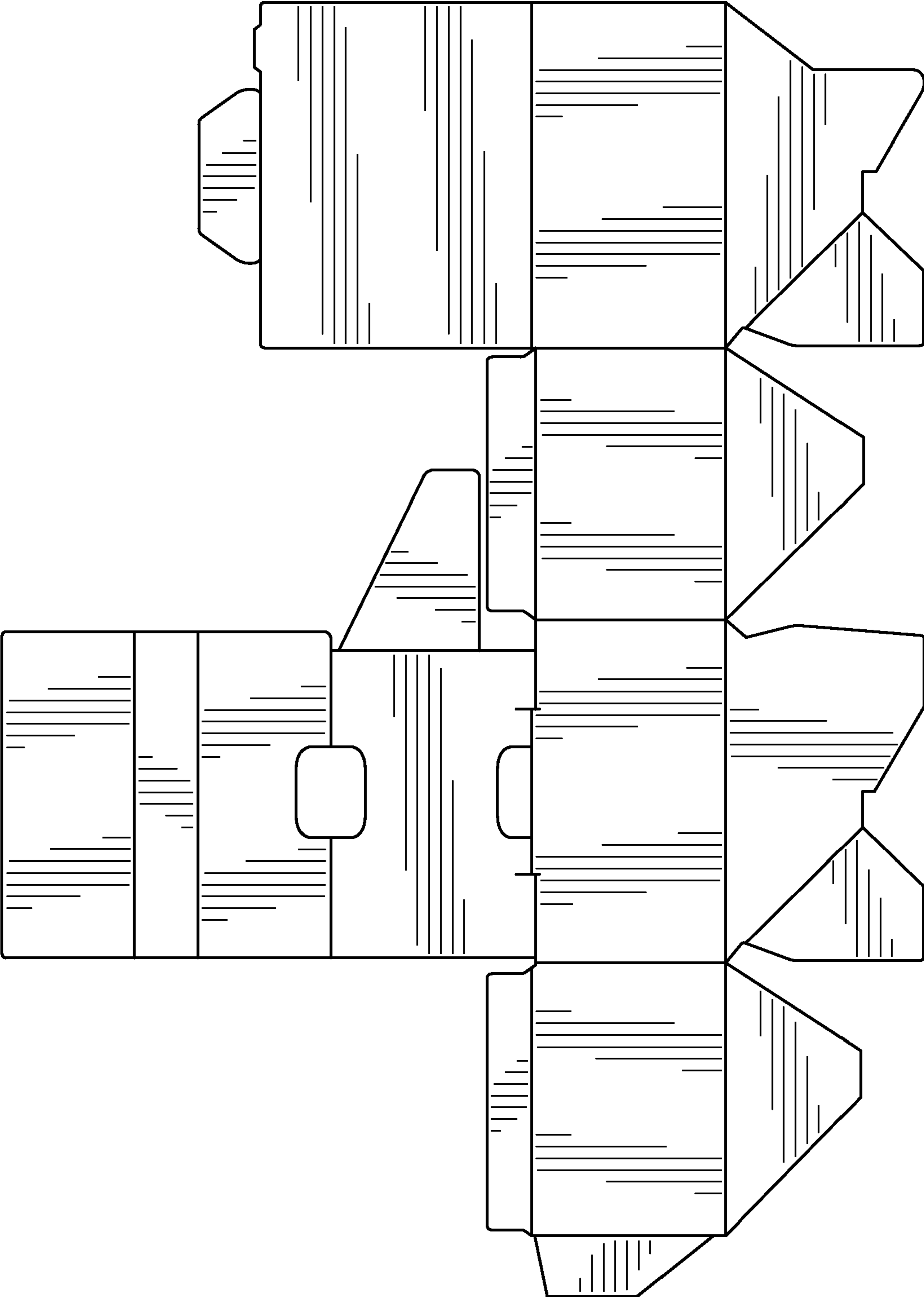

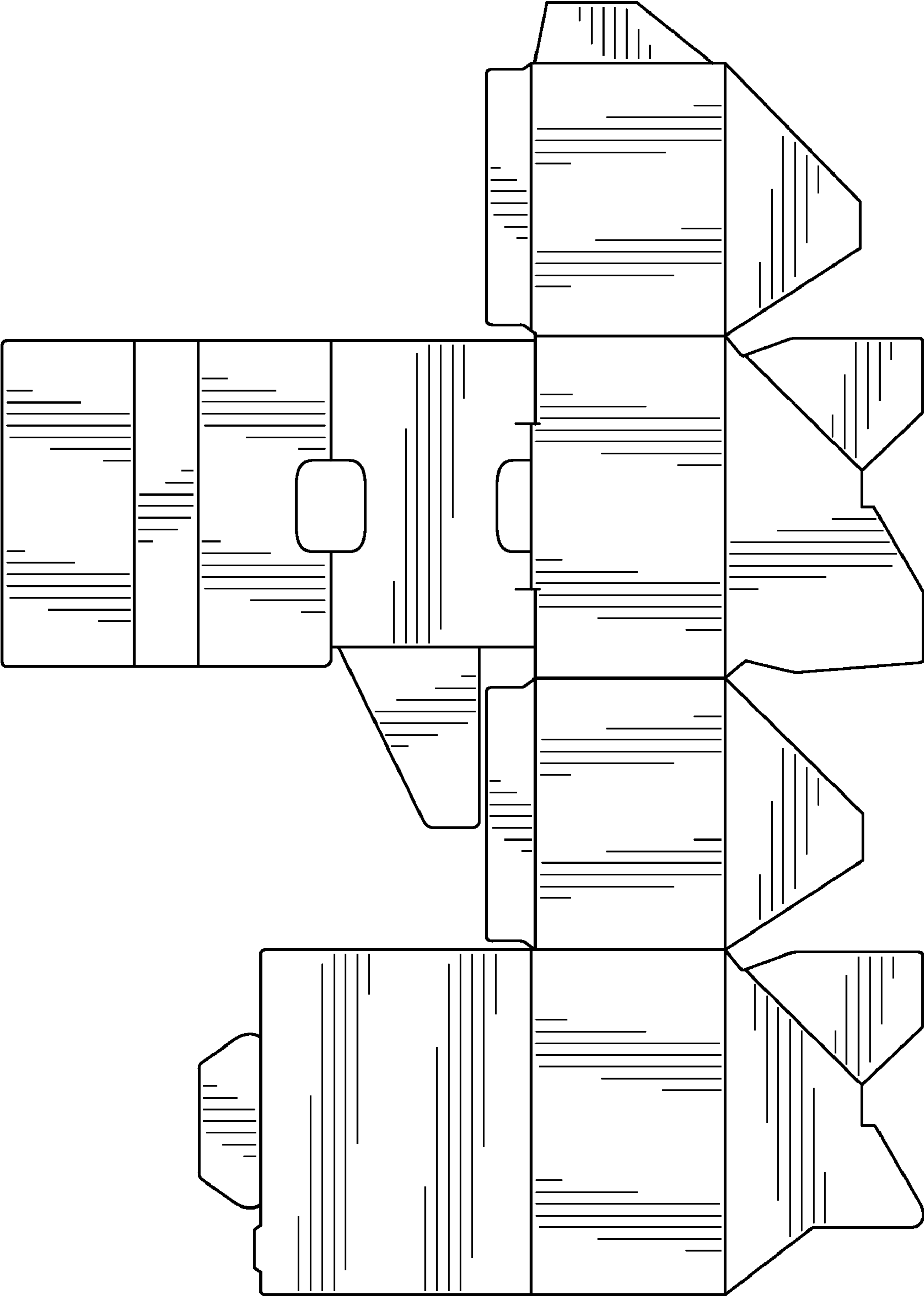
