DESCRIPTION

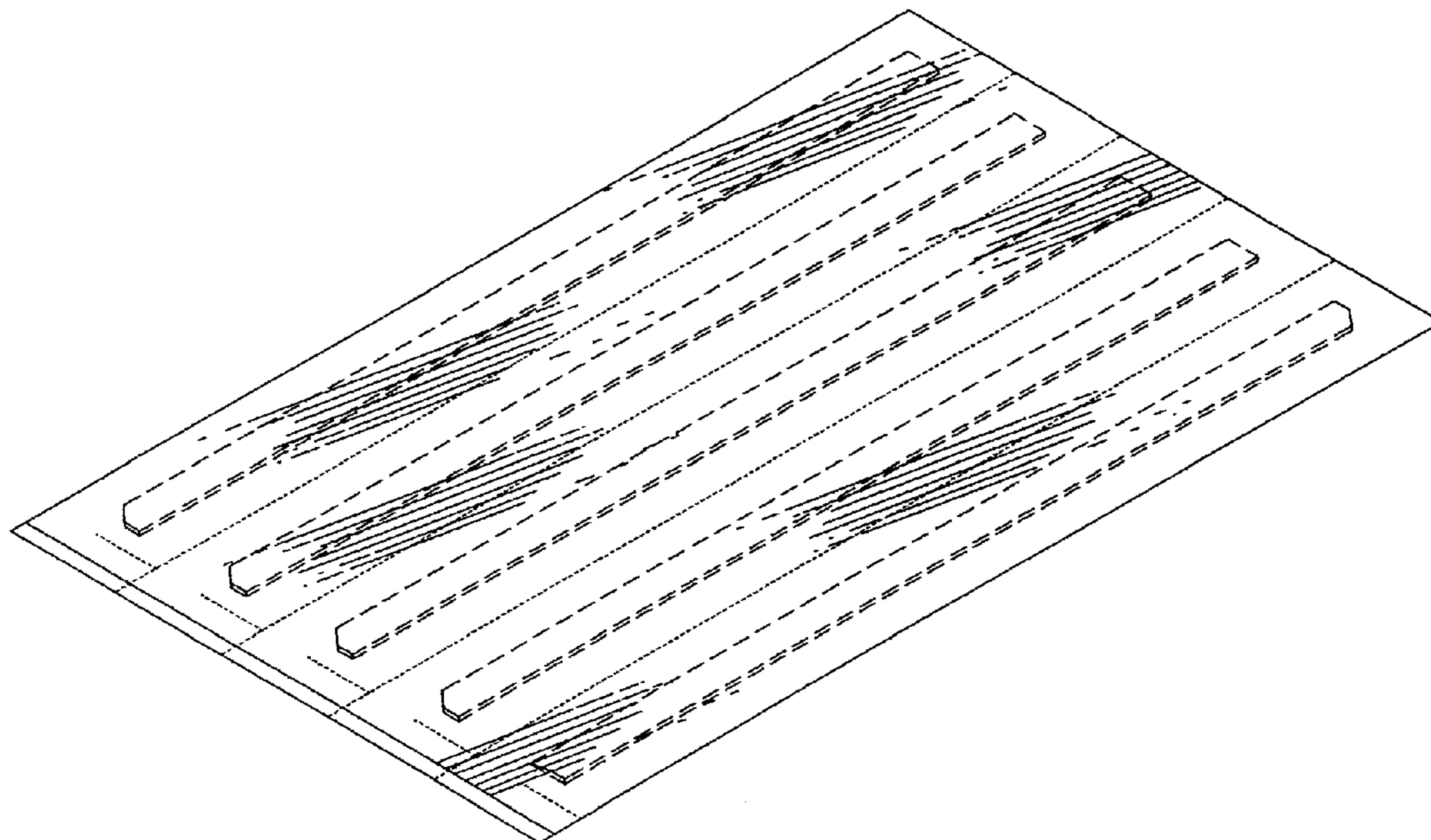
FIG. 1 is a perspective view of the cutting blade sleeve showing the new design;

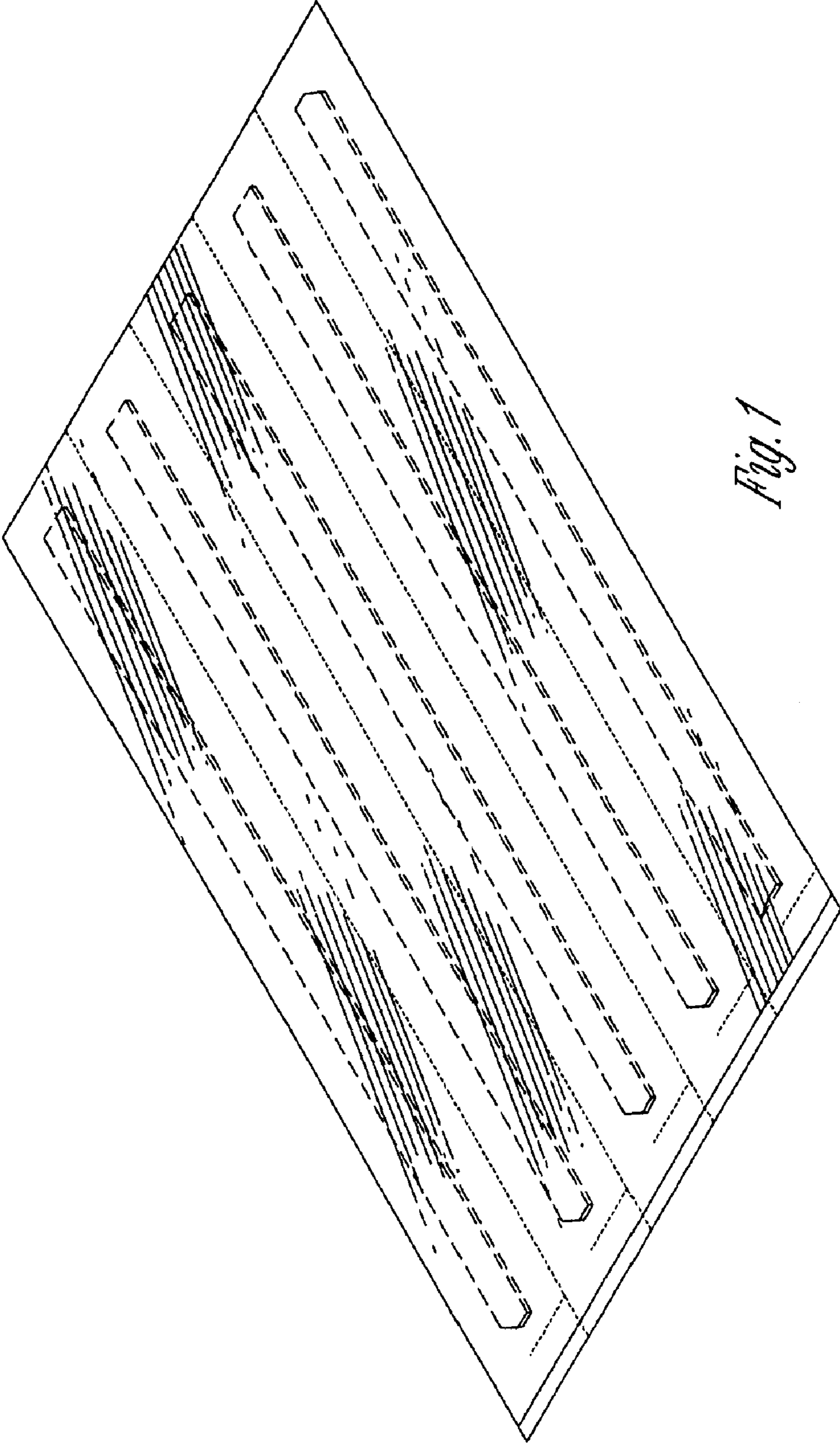

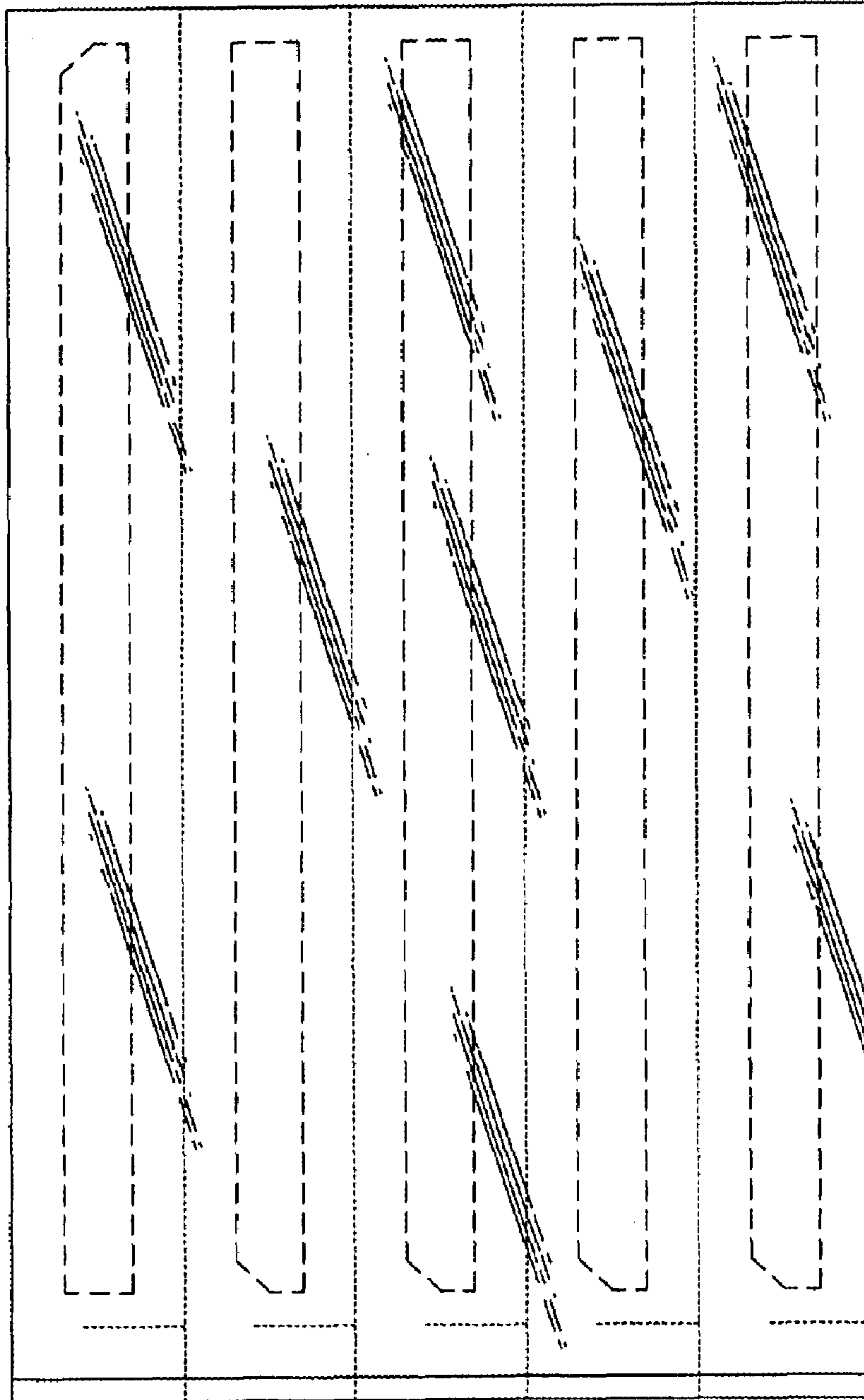

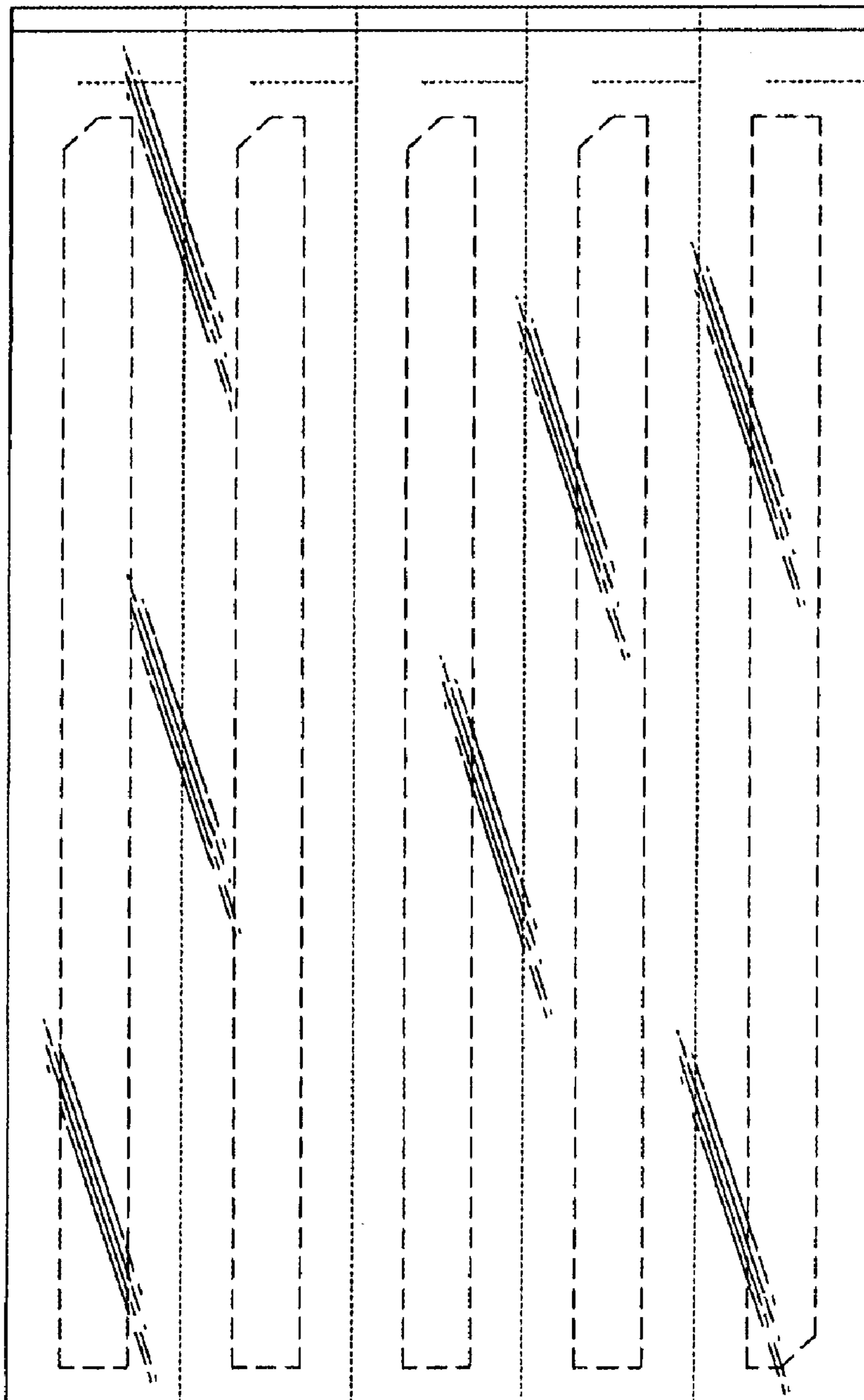
