FIG. 11 is a perspective view of a drink pouch in accordance with an embodiment of the invention;

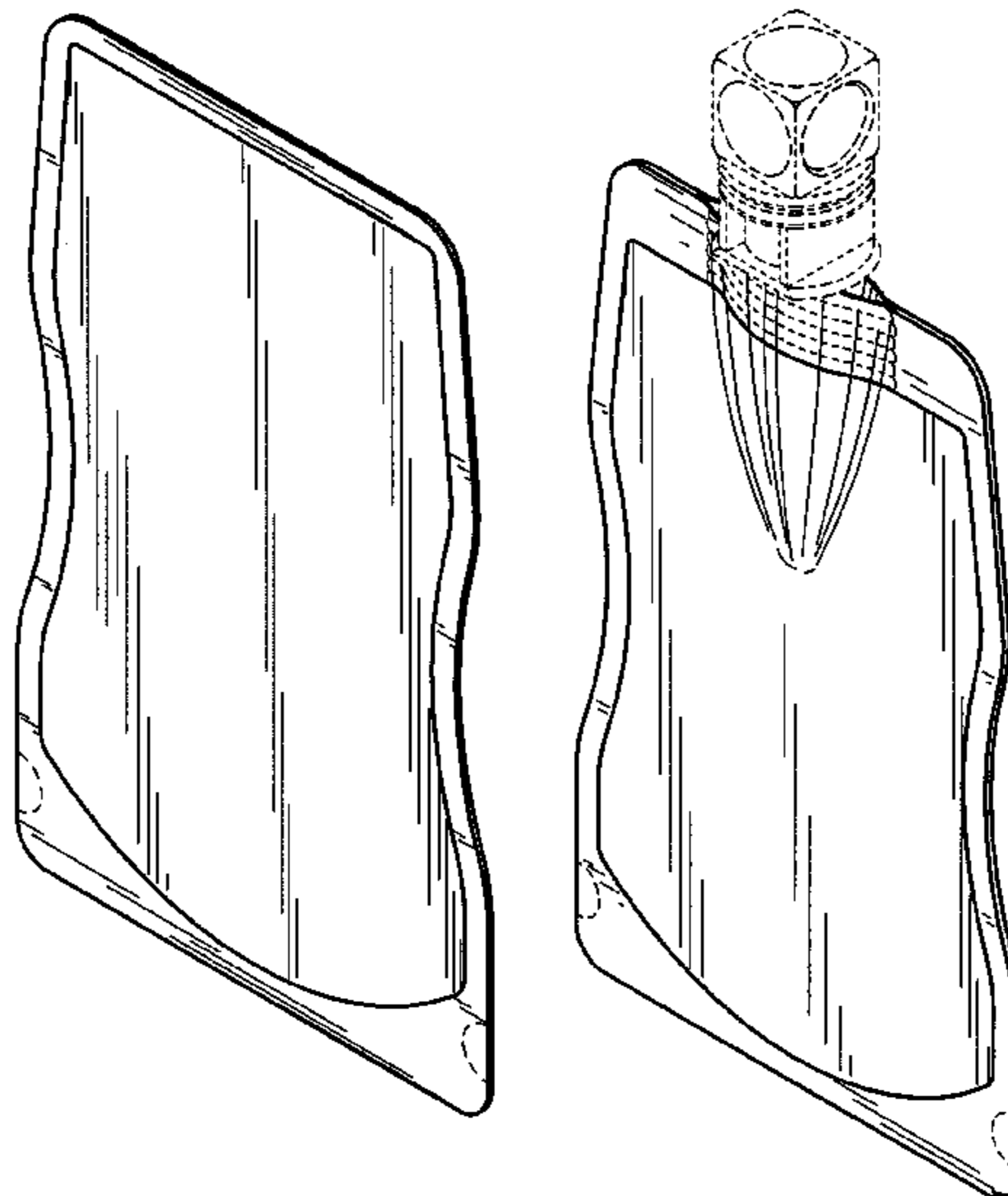
FIG. 12 is a front elevational view thereof;

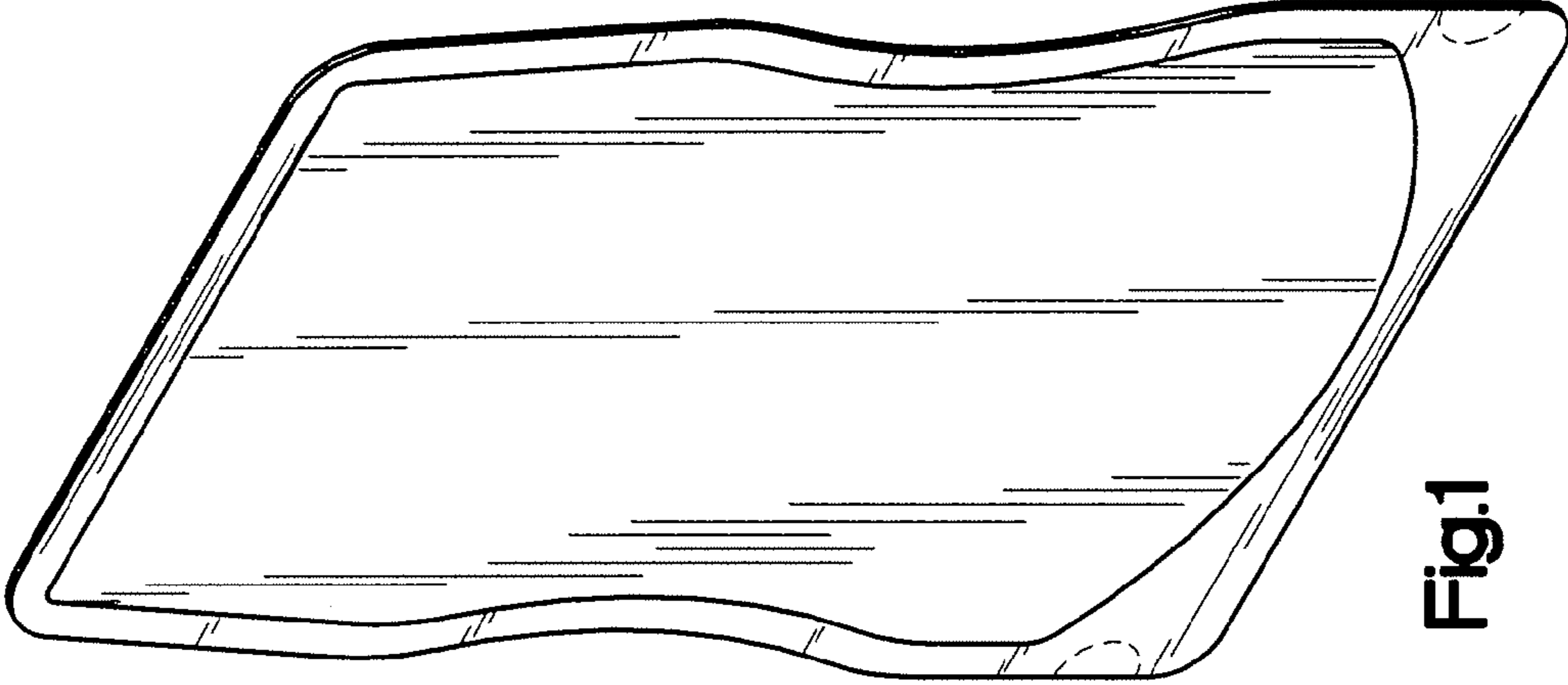

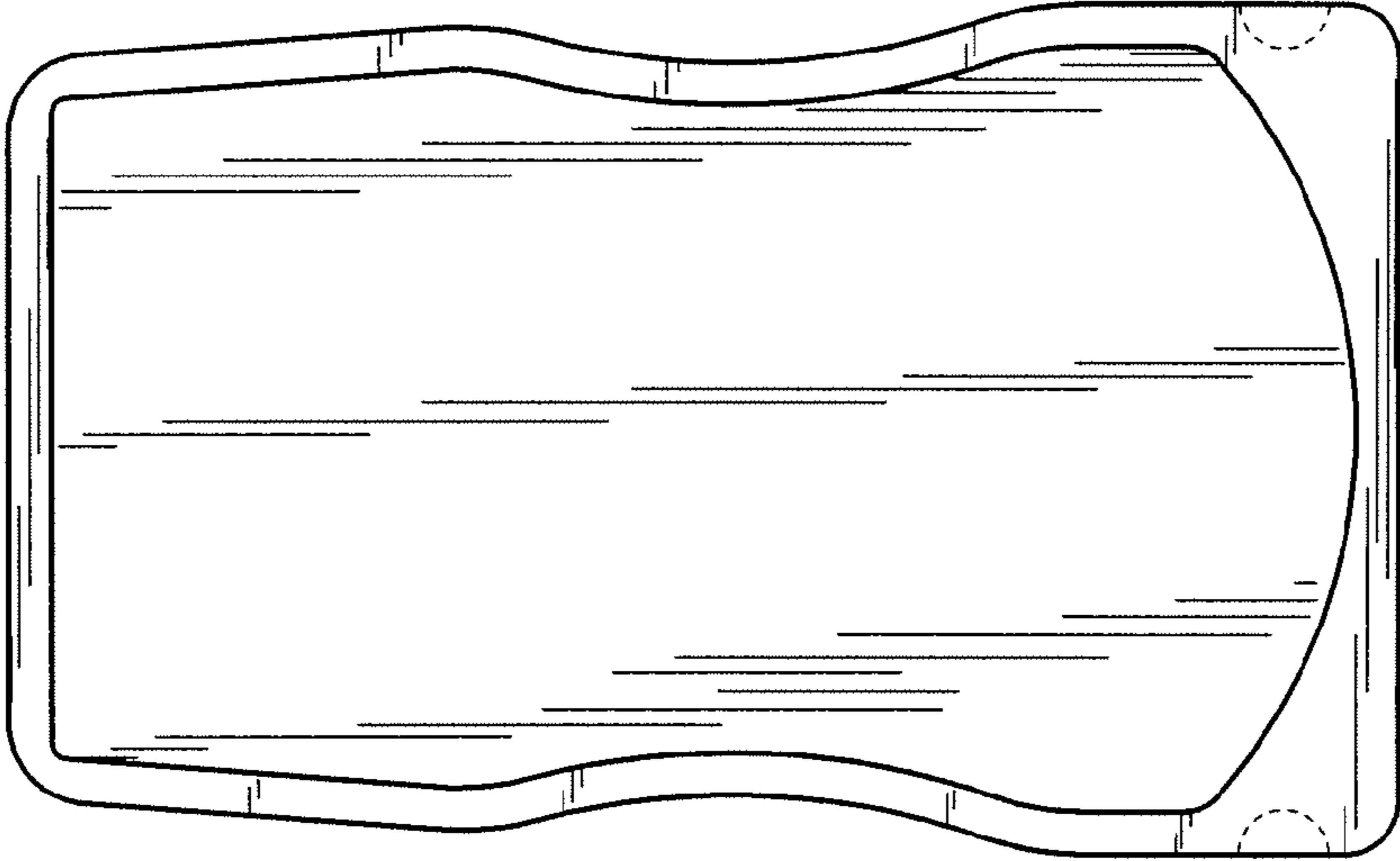

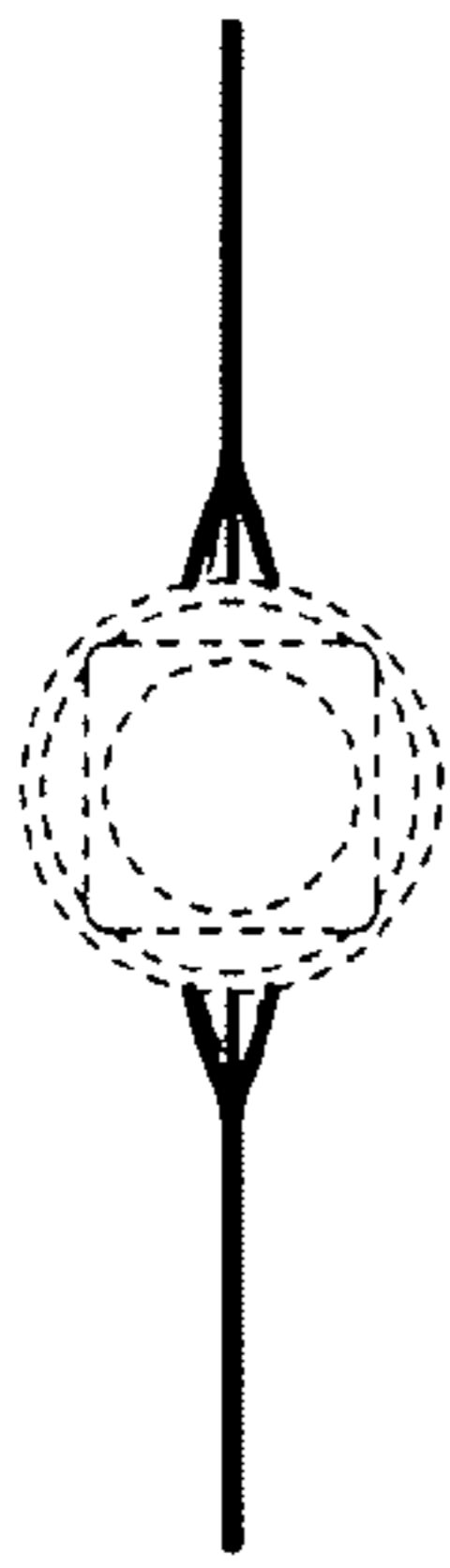

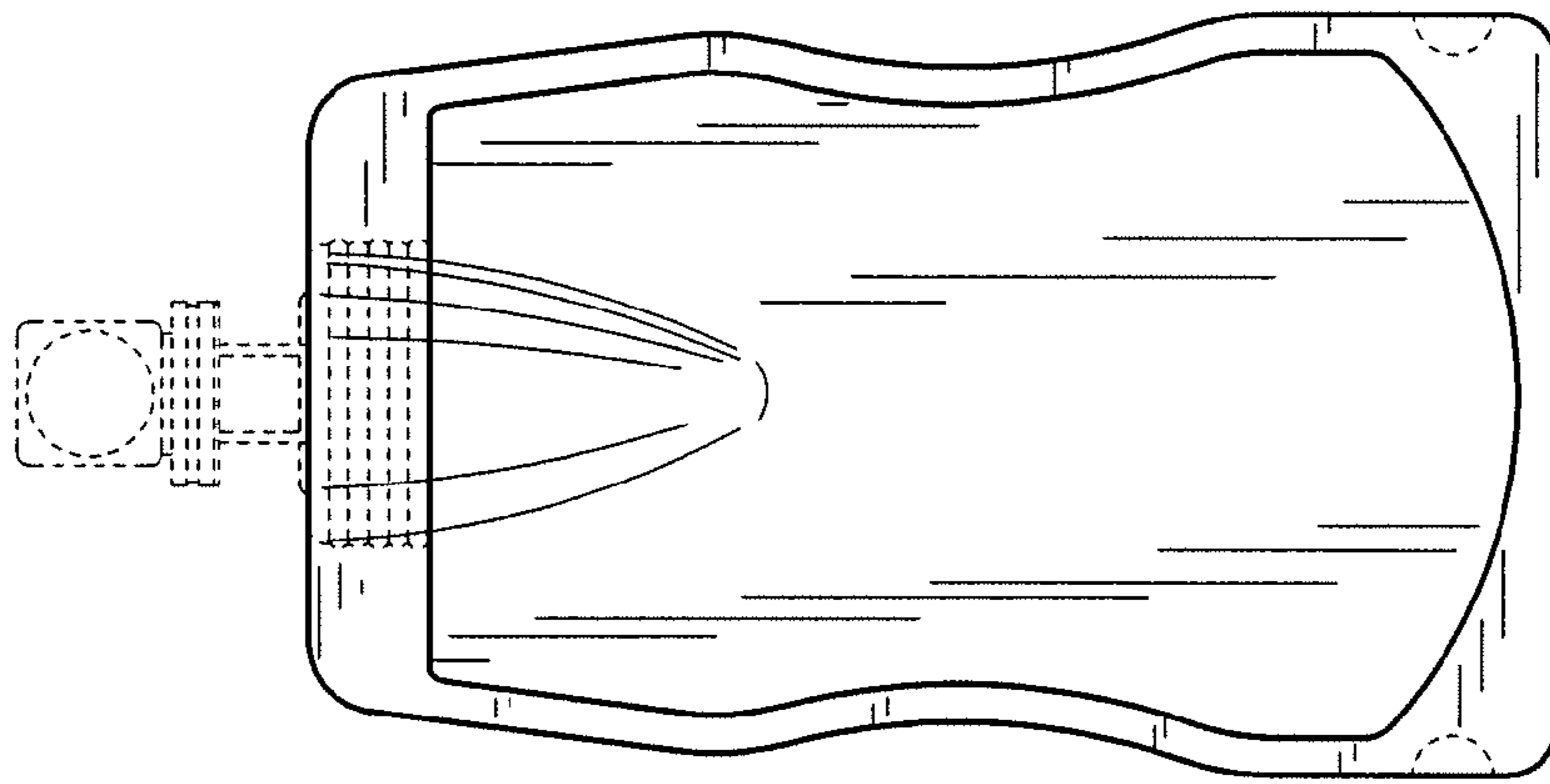

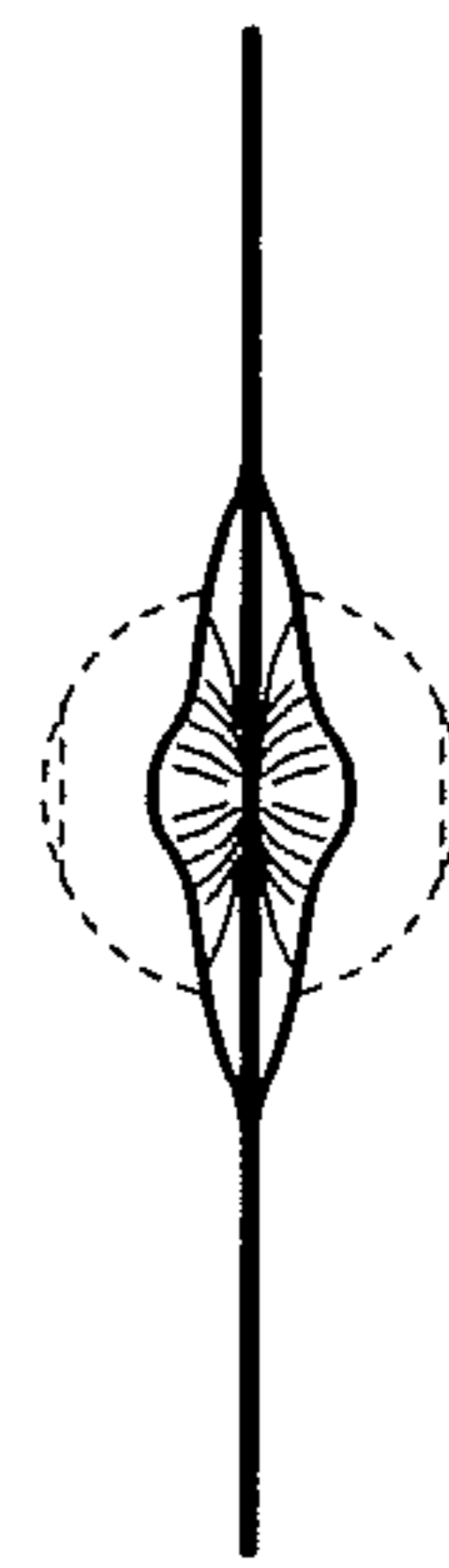

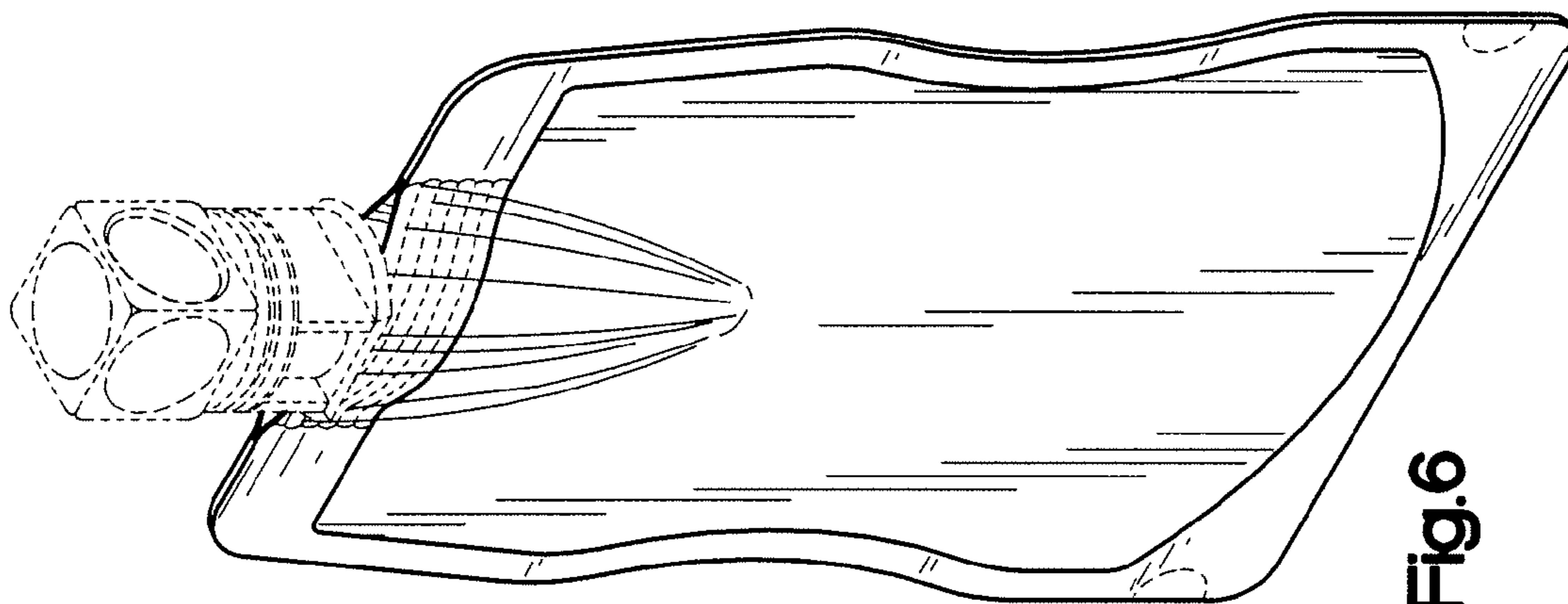

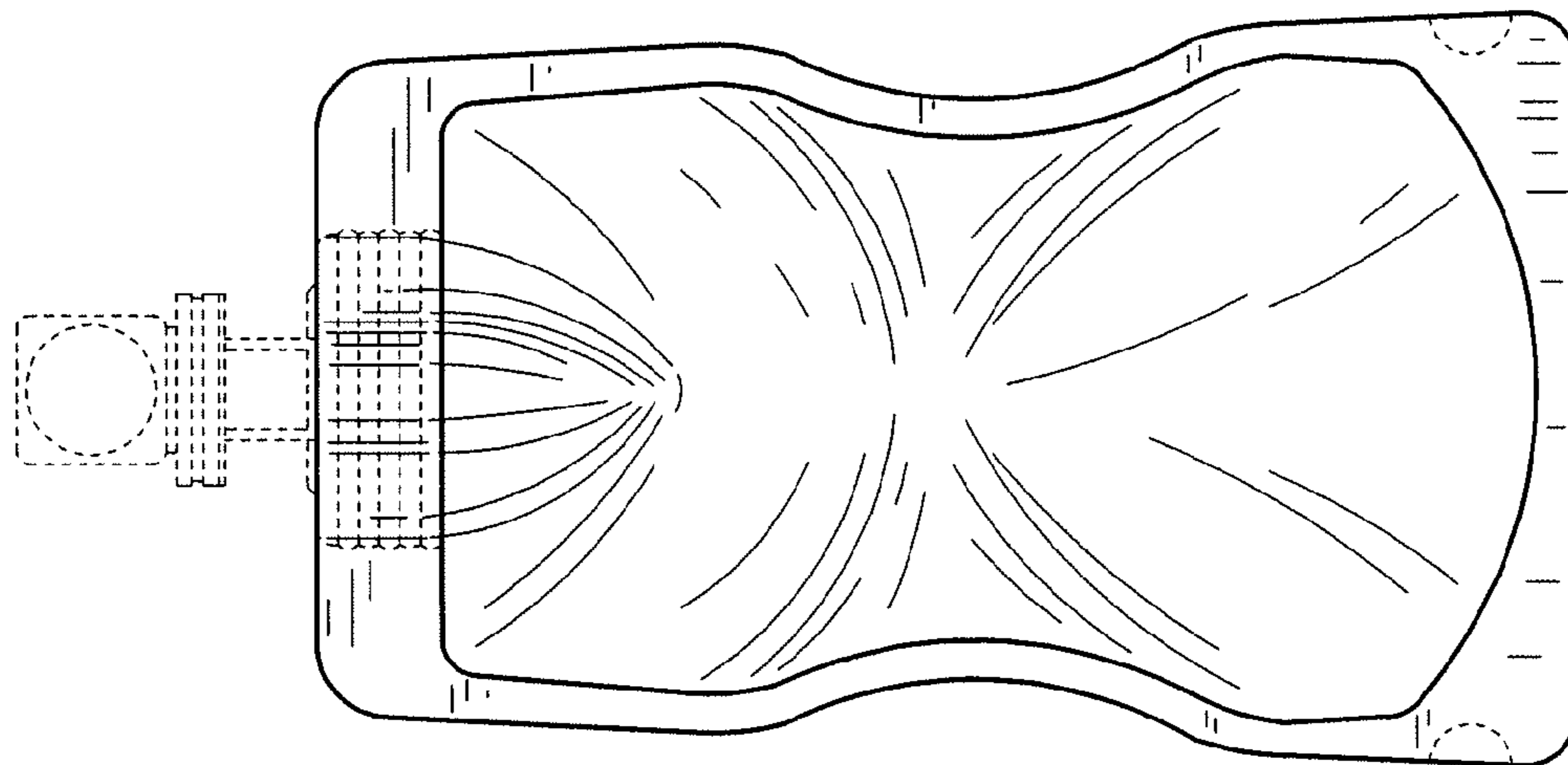

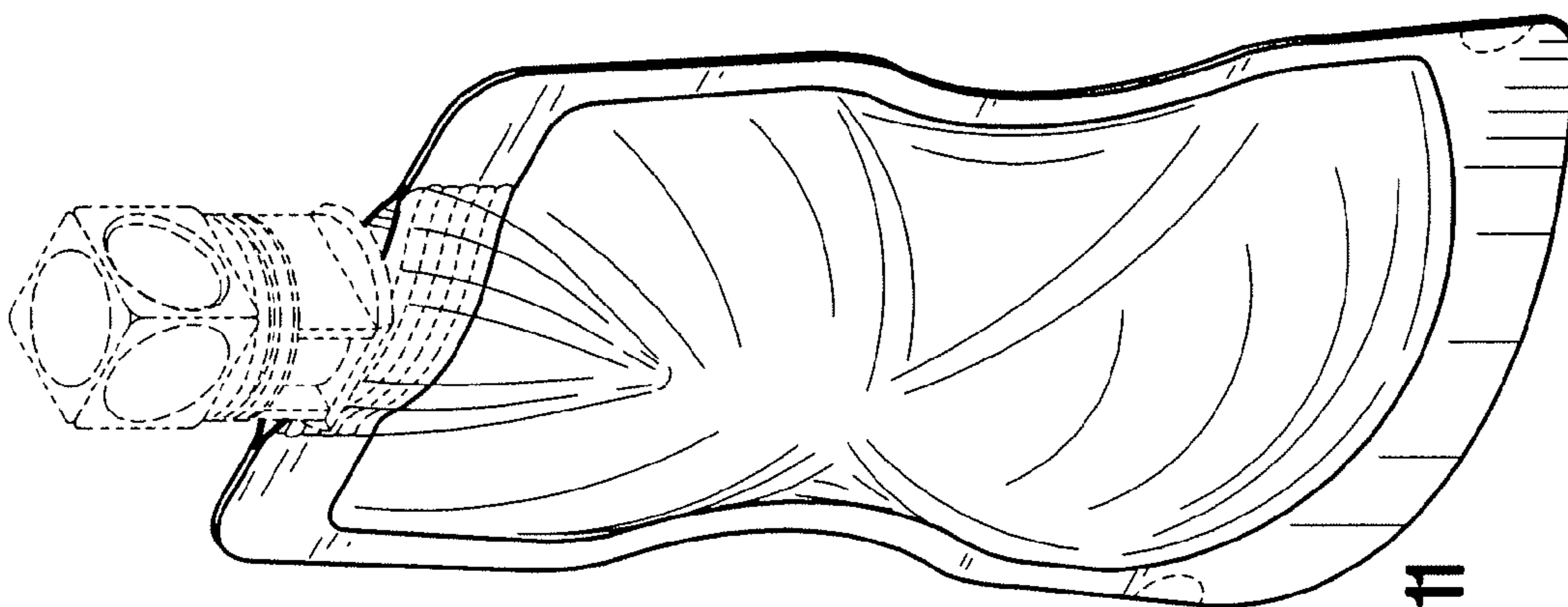

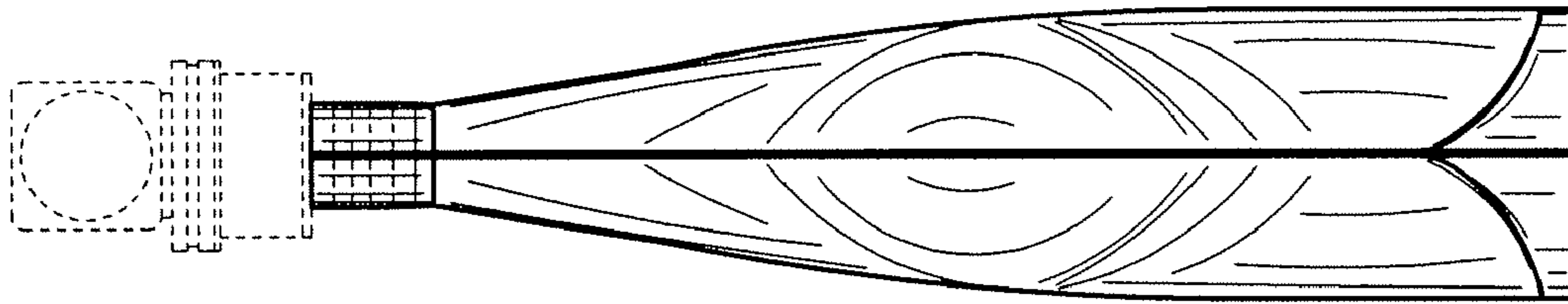

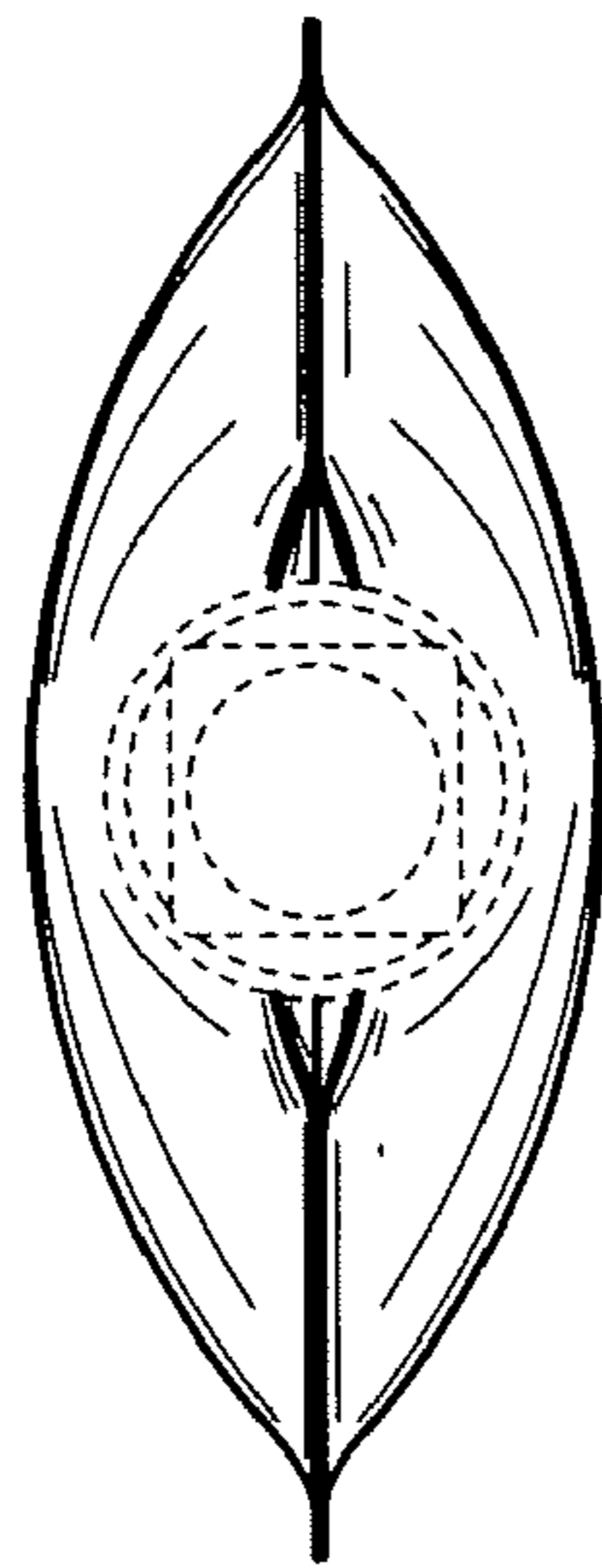

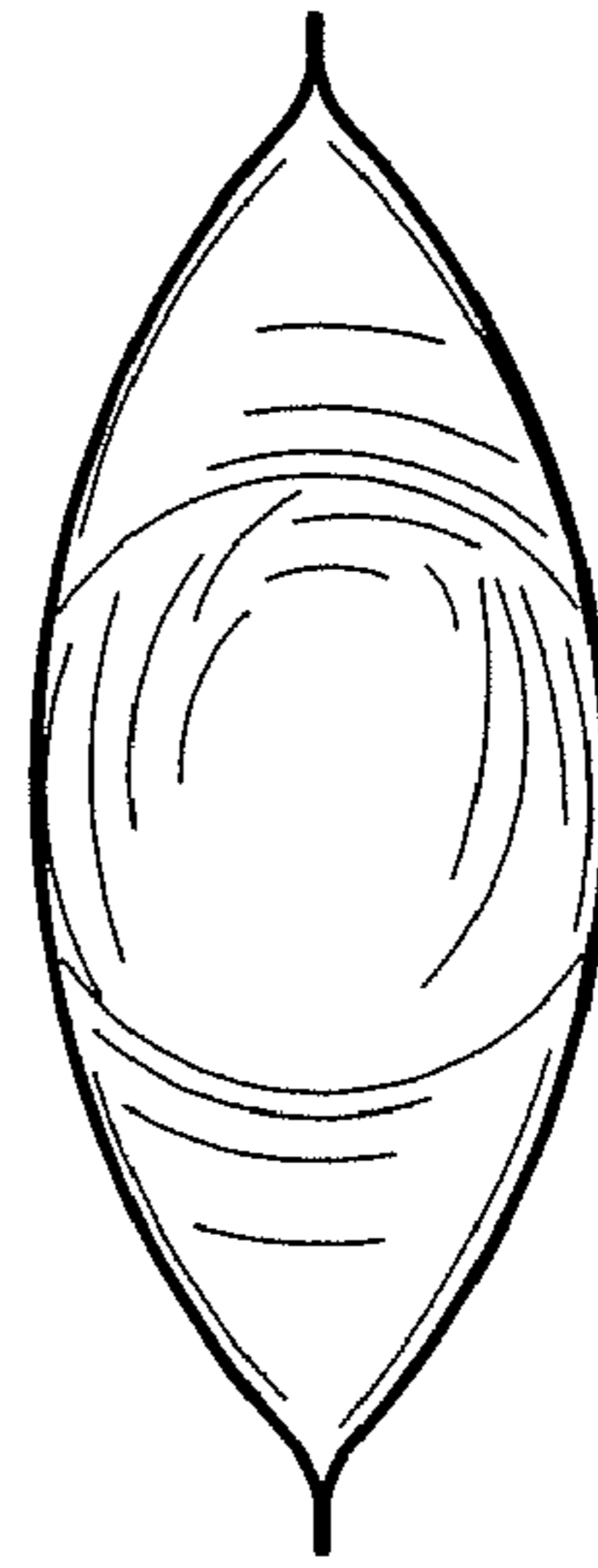
