(57) **CLAIM**

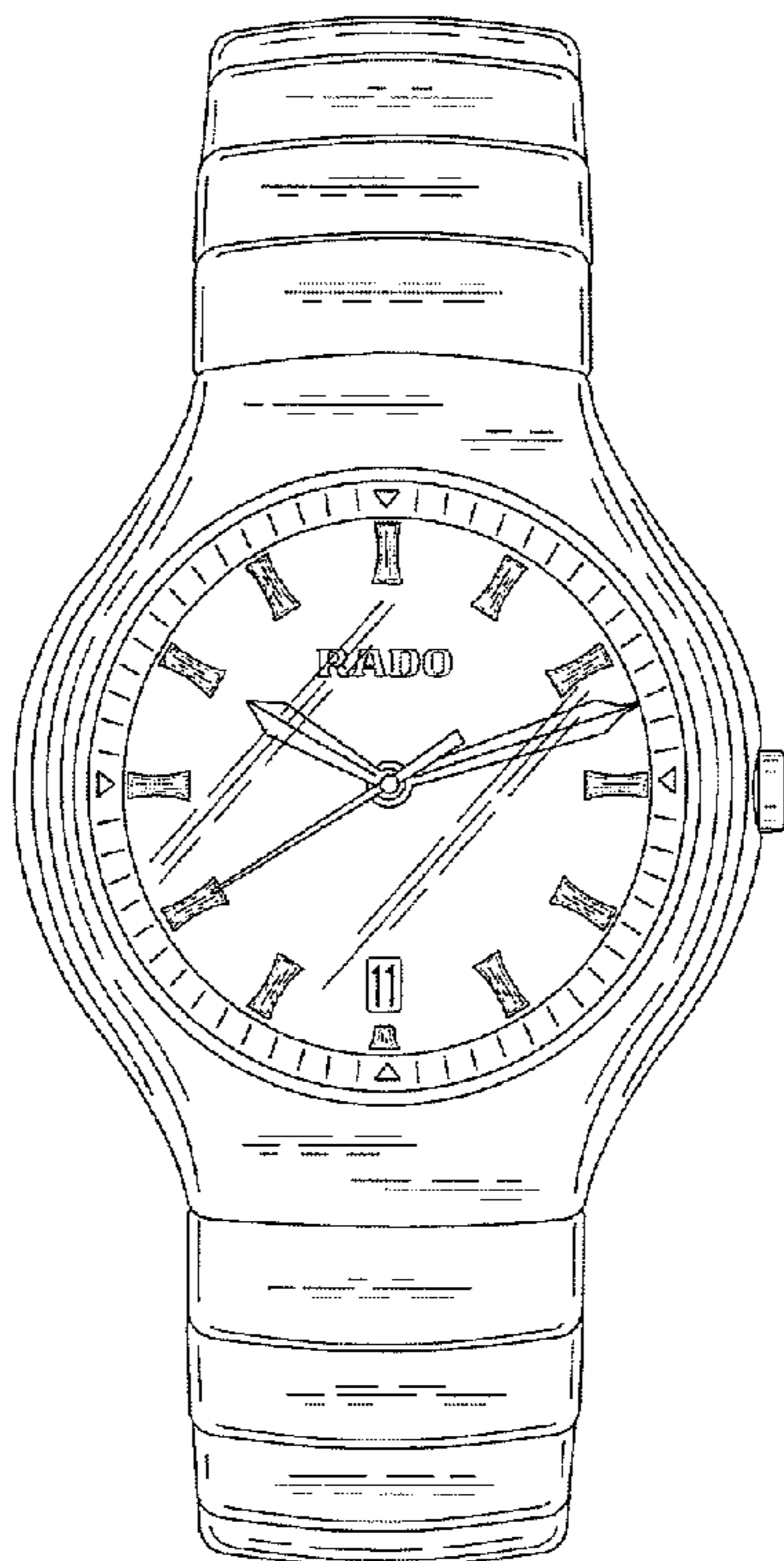
The ornamental design for a wristwatch, as shown and described.

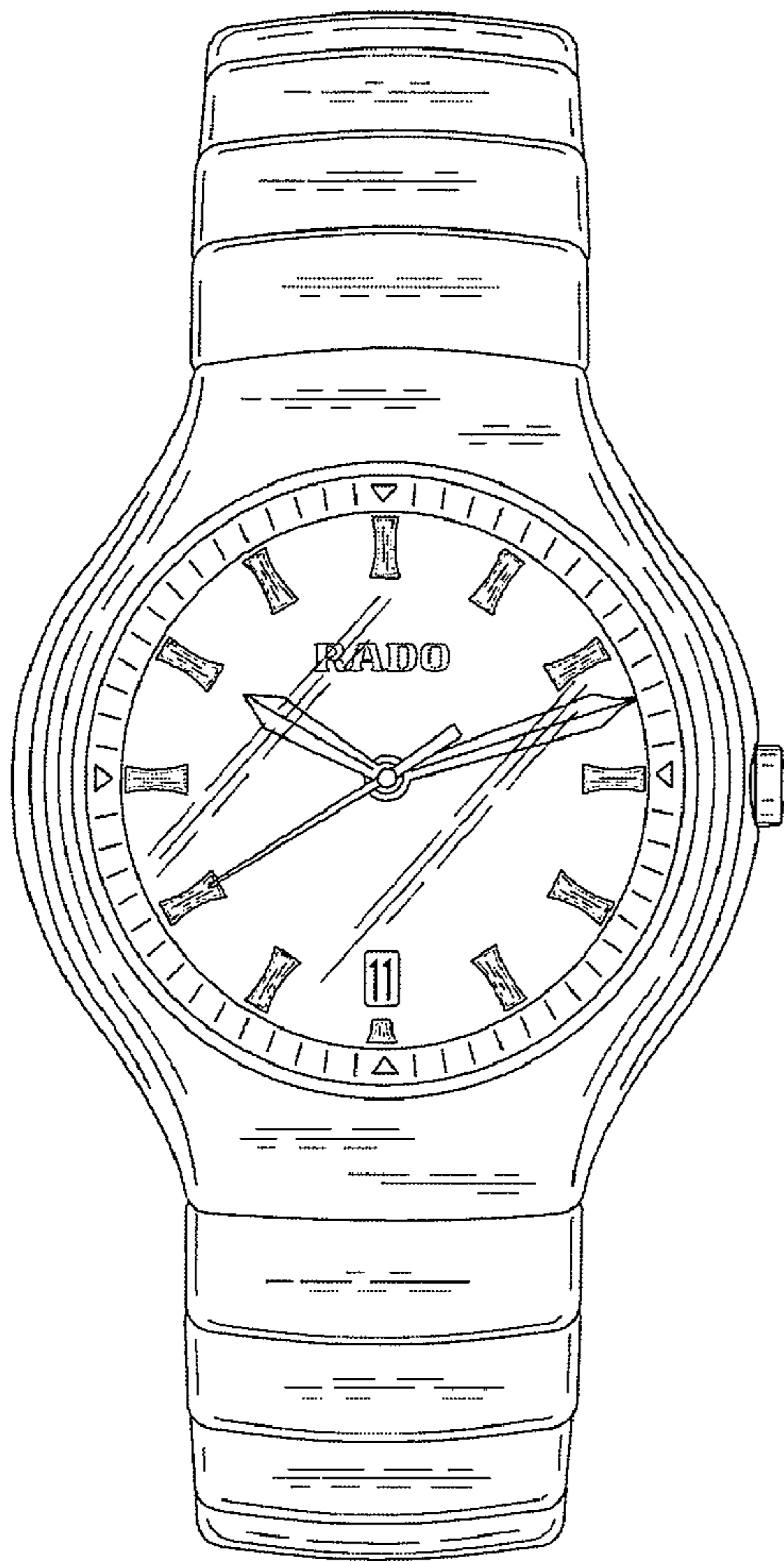

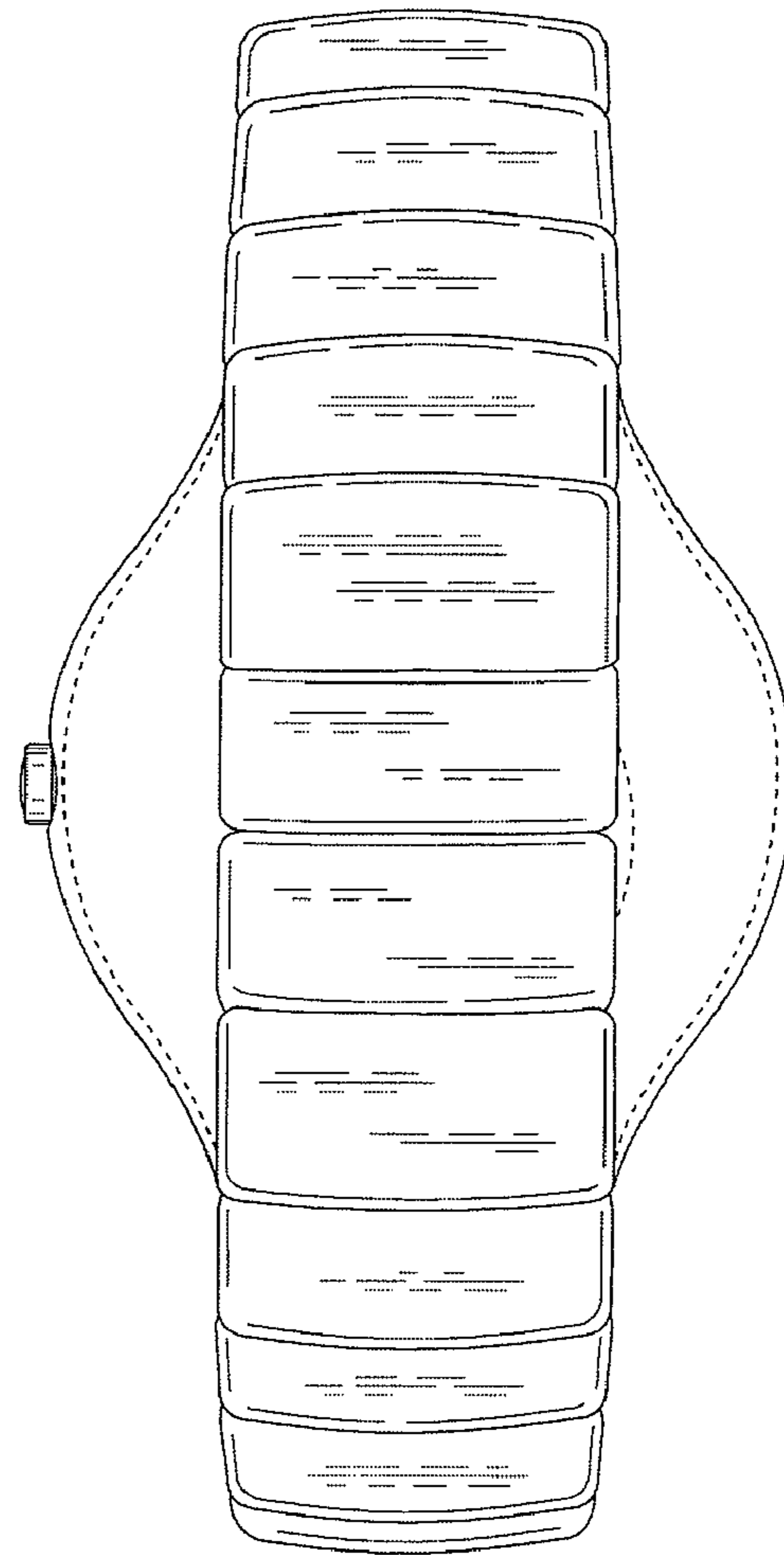

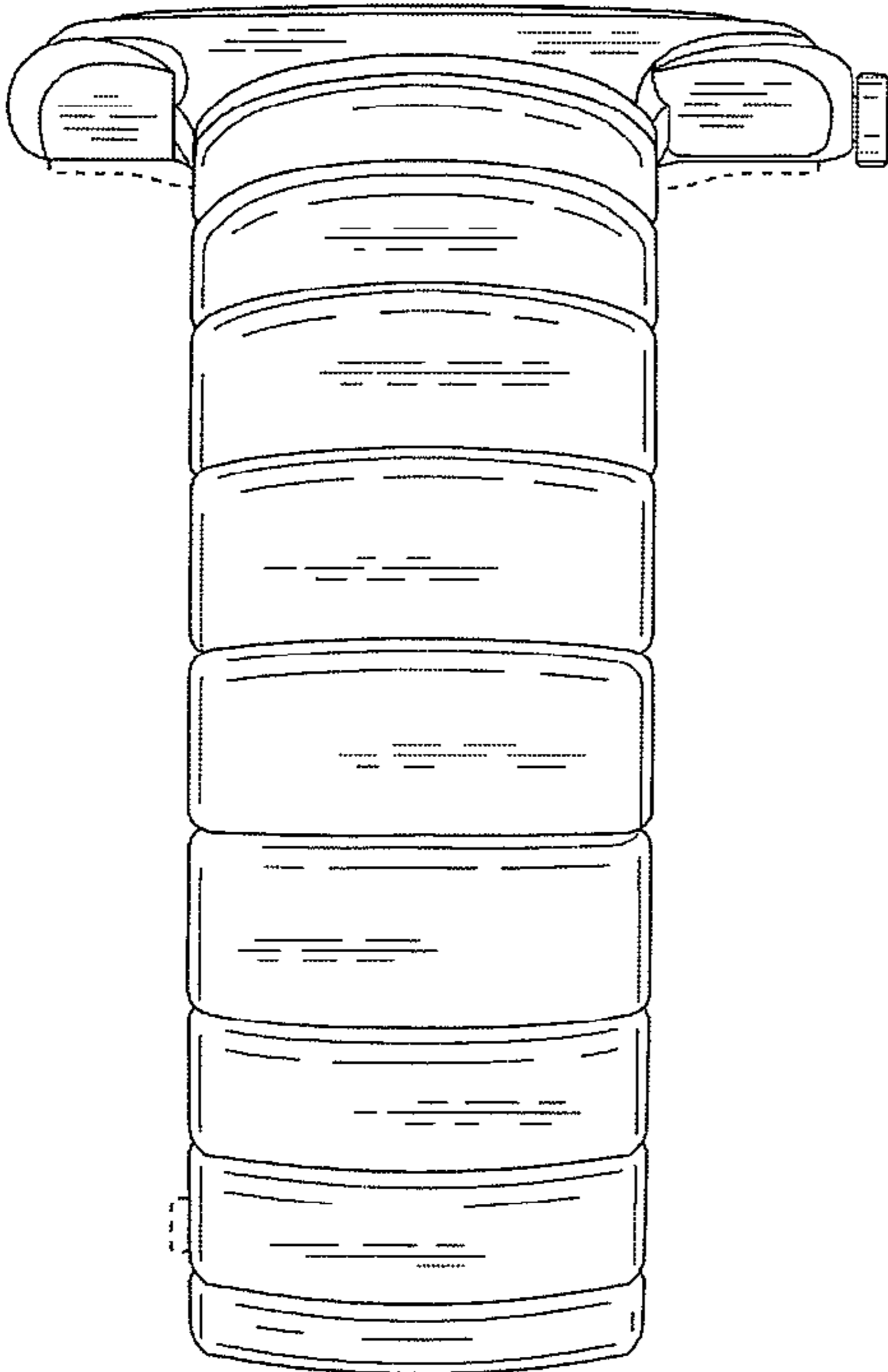

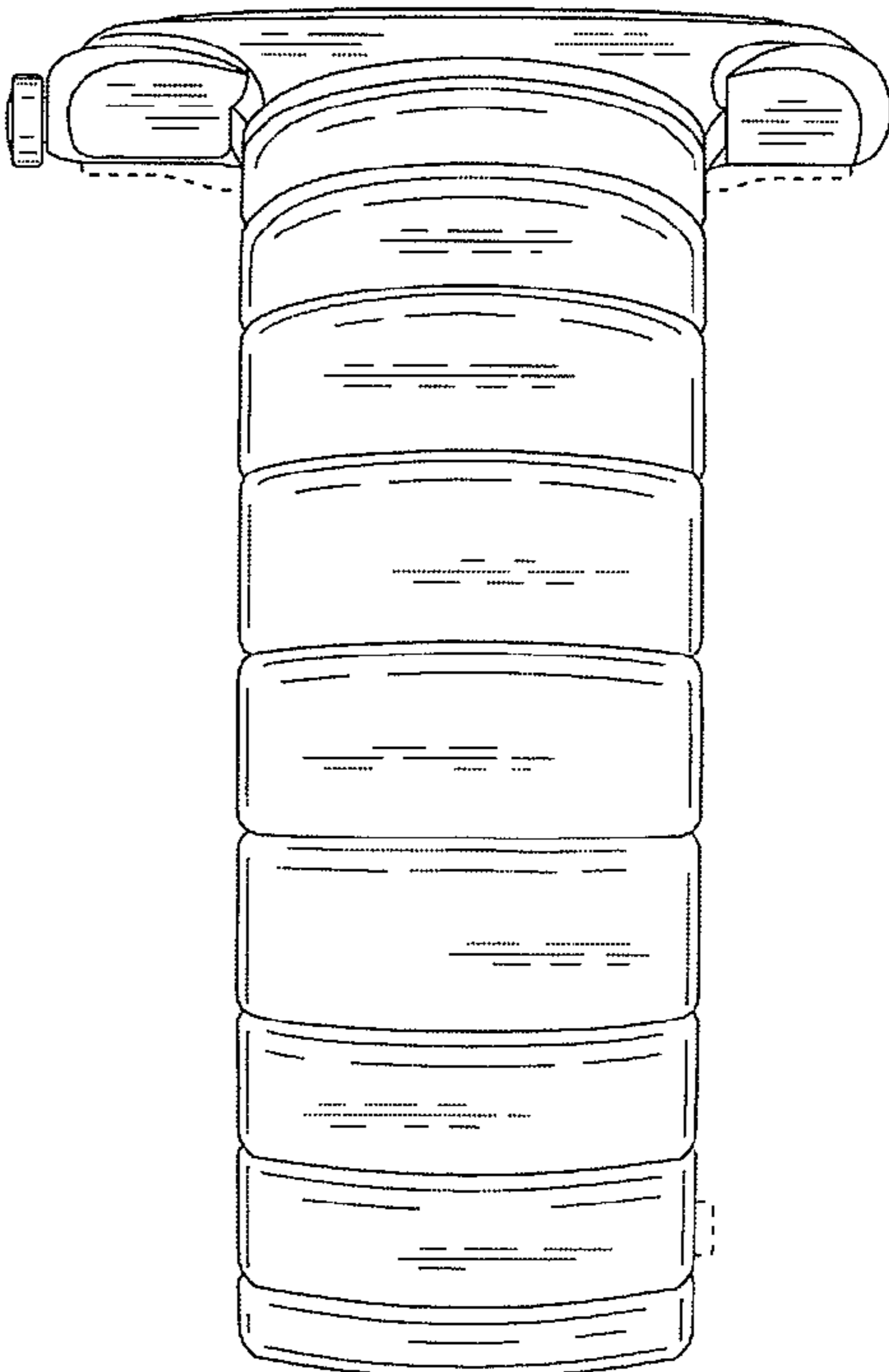

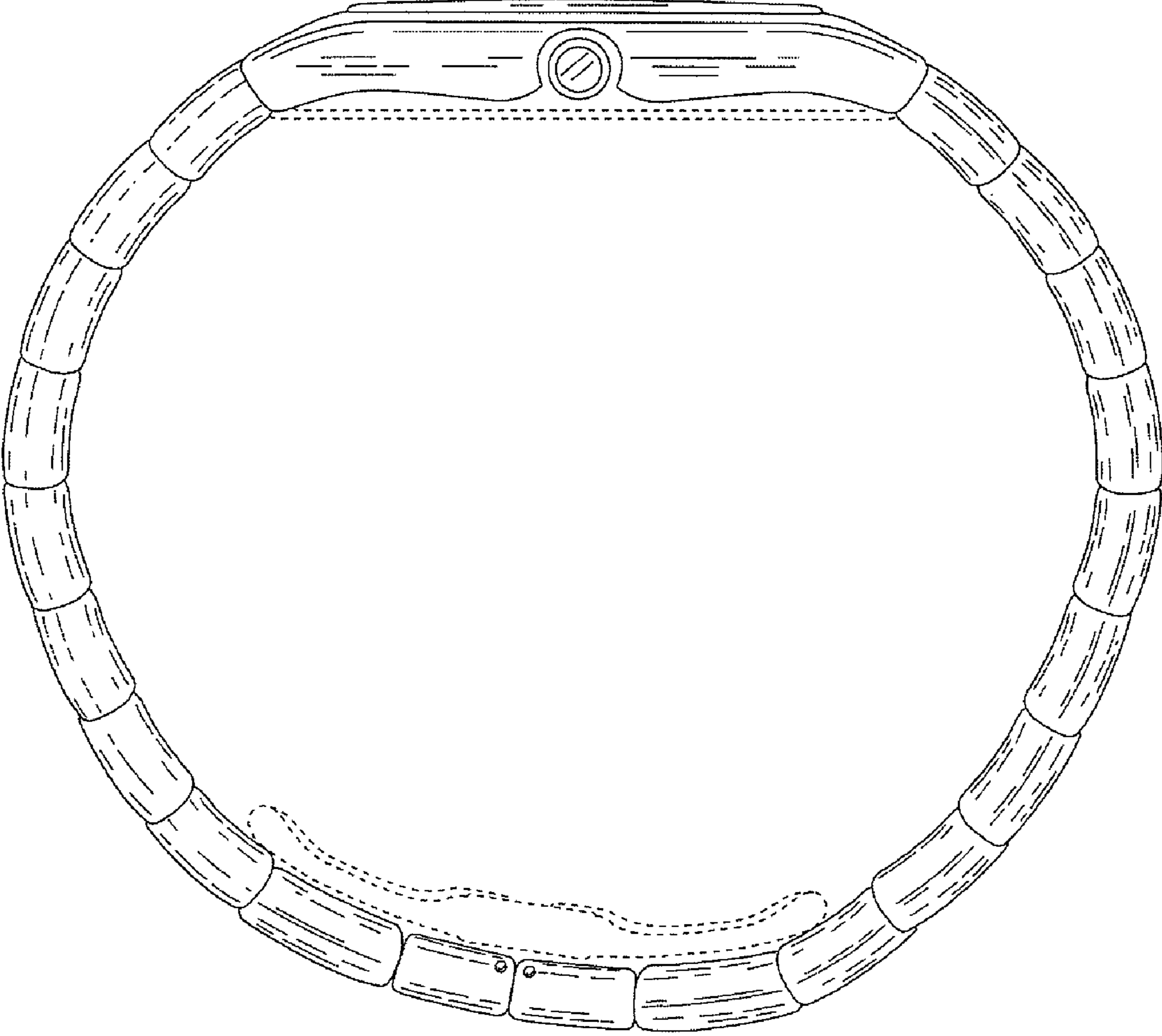

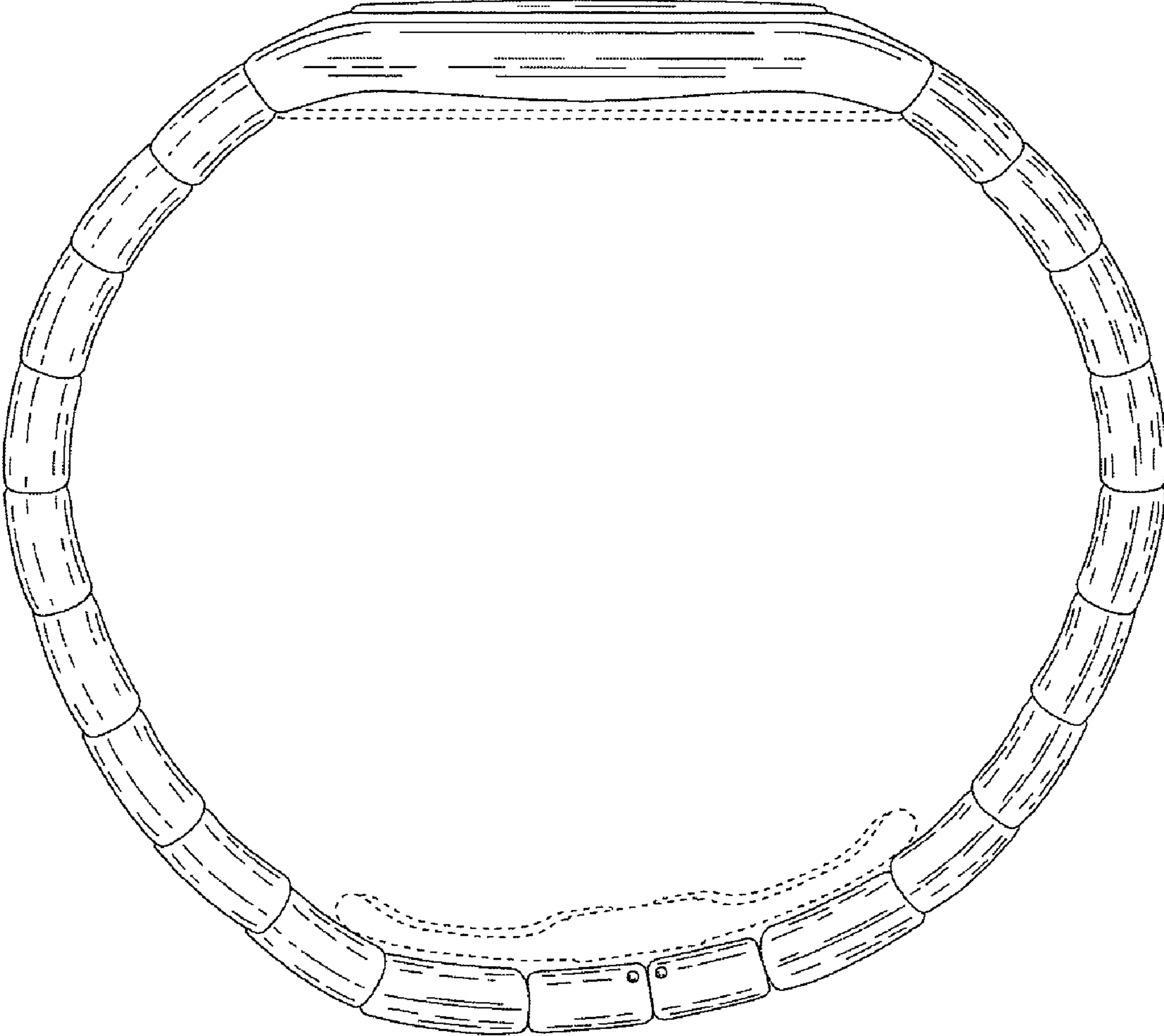

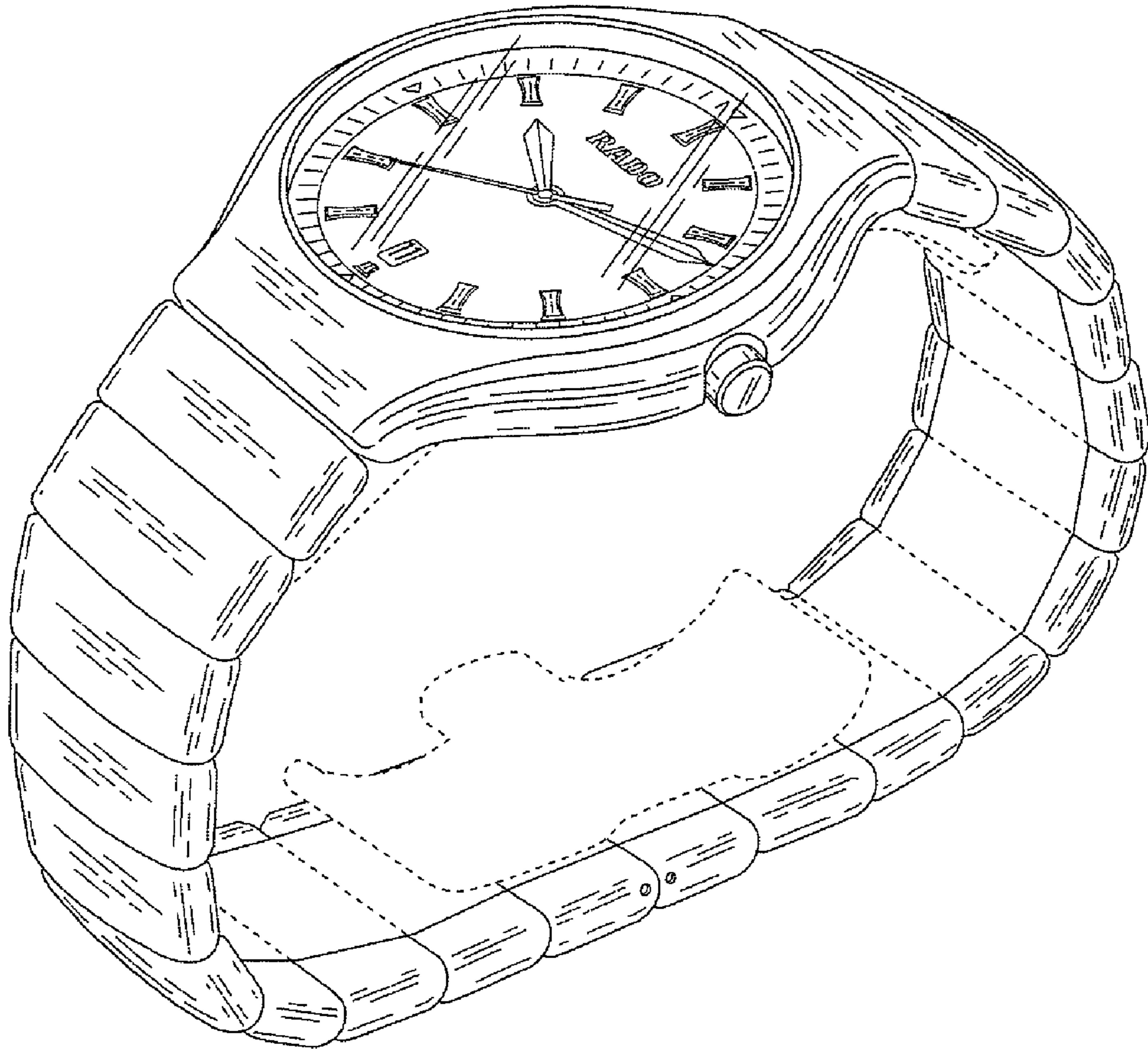
