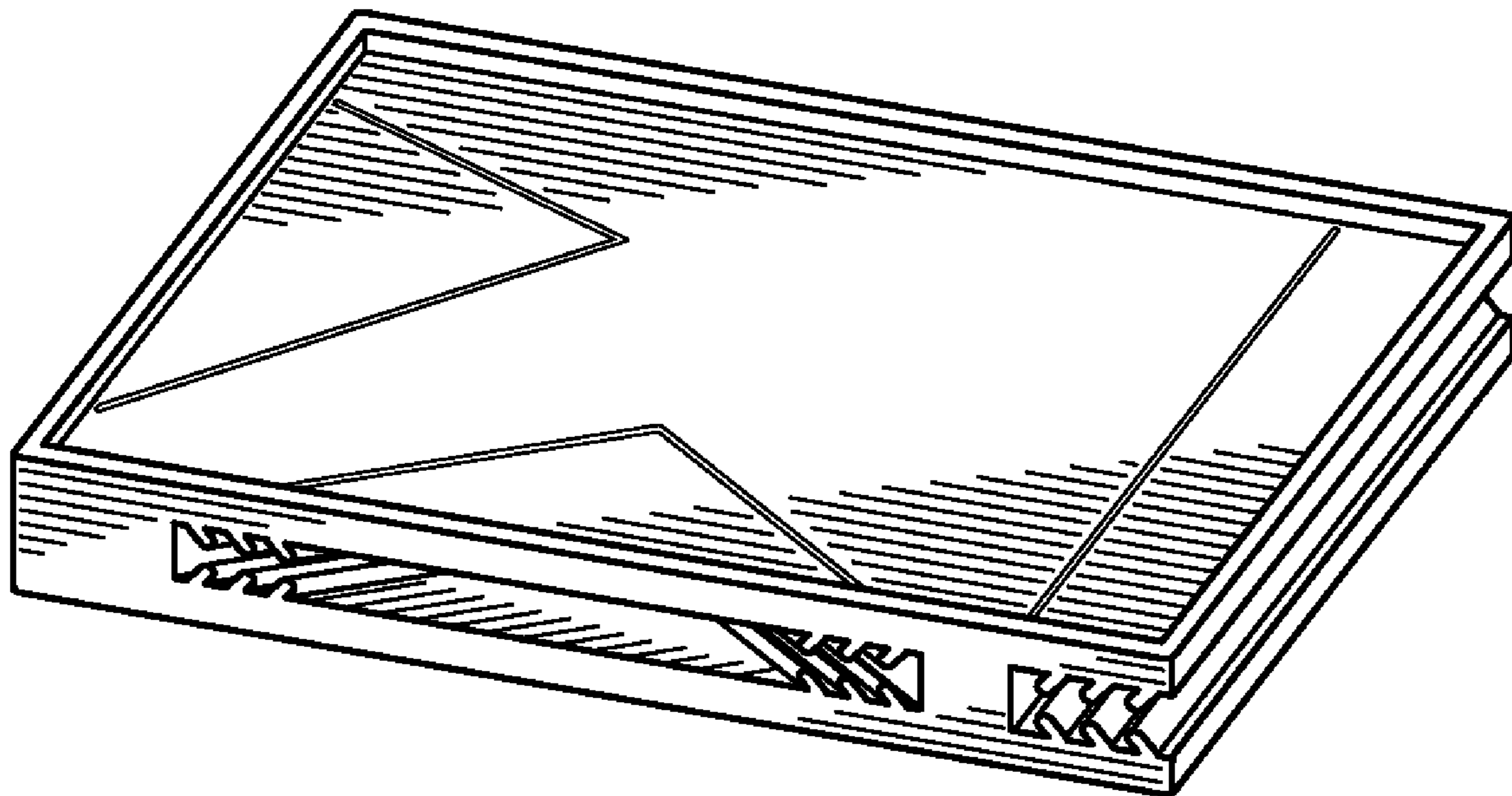
(57) **CLAIM**

The ornamental design for a quilter's cutting ruler angle guide, as shown.

DESCRIPTION

FIG. 1 is a top, front and left-side perspective view of a quilter's cutting ruler angle guide embodying my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a left-side elevational view thereof; and, FIG. 7 is a right-side elevational view thereof.

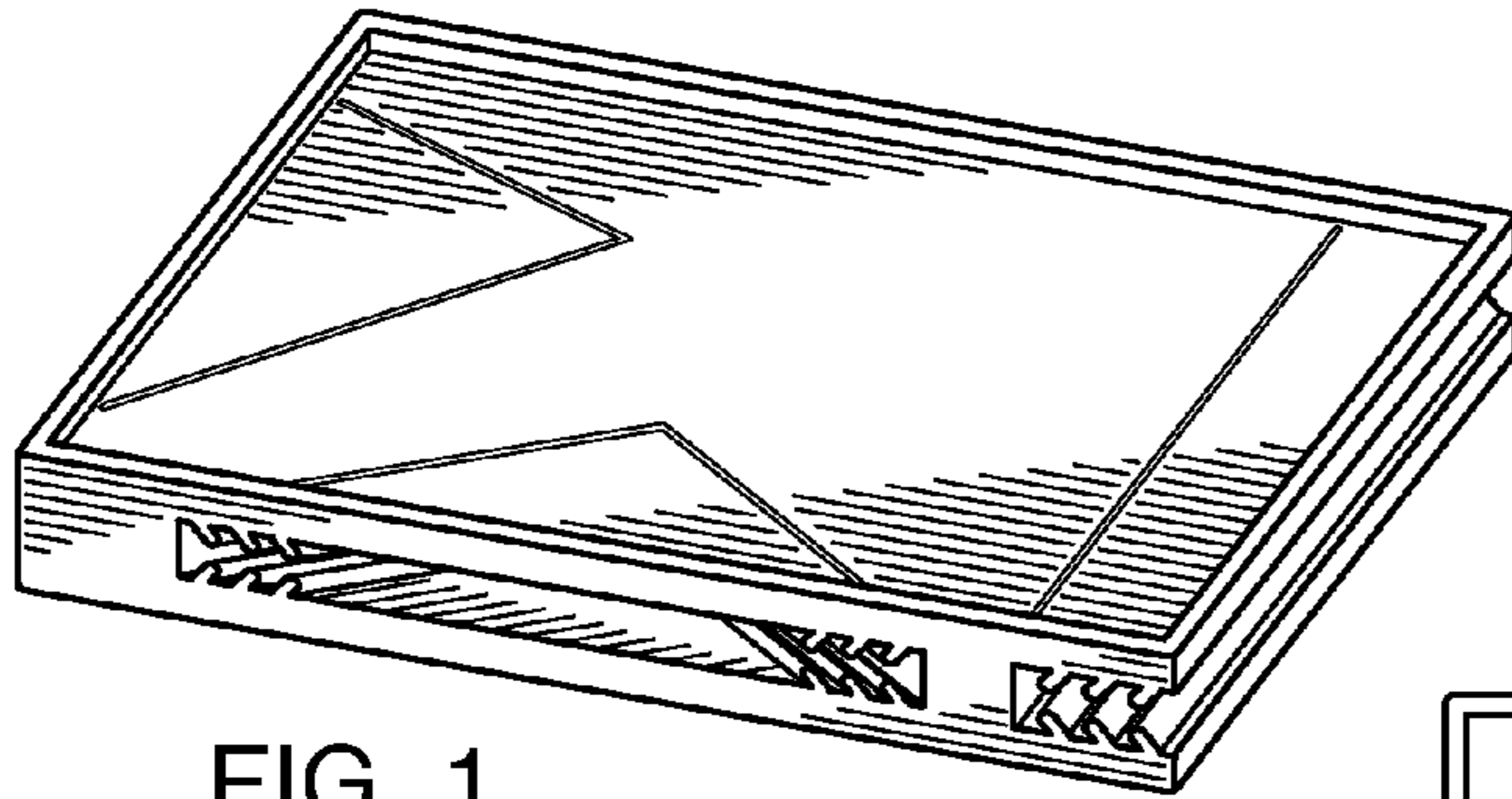

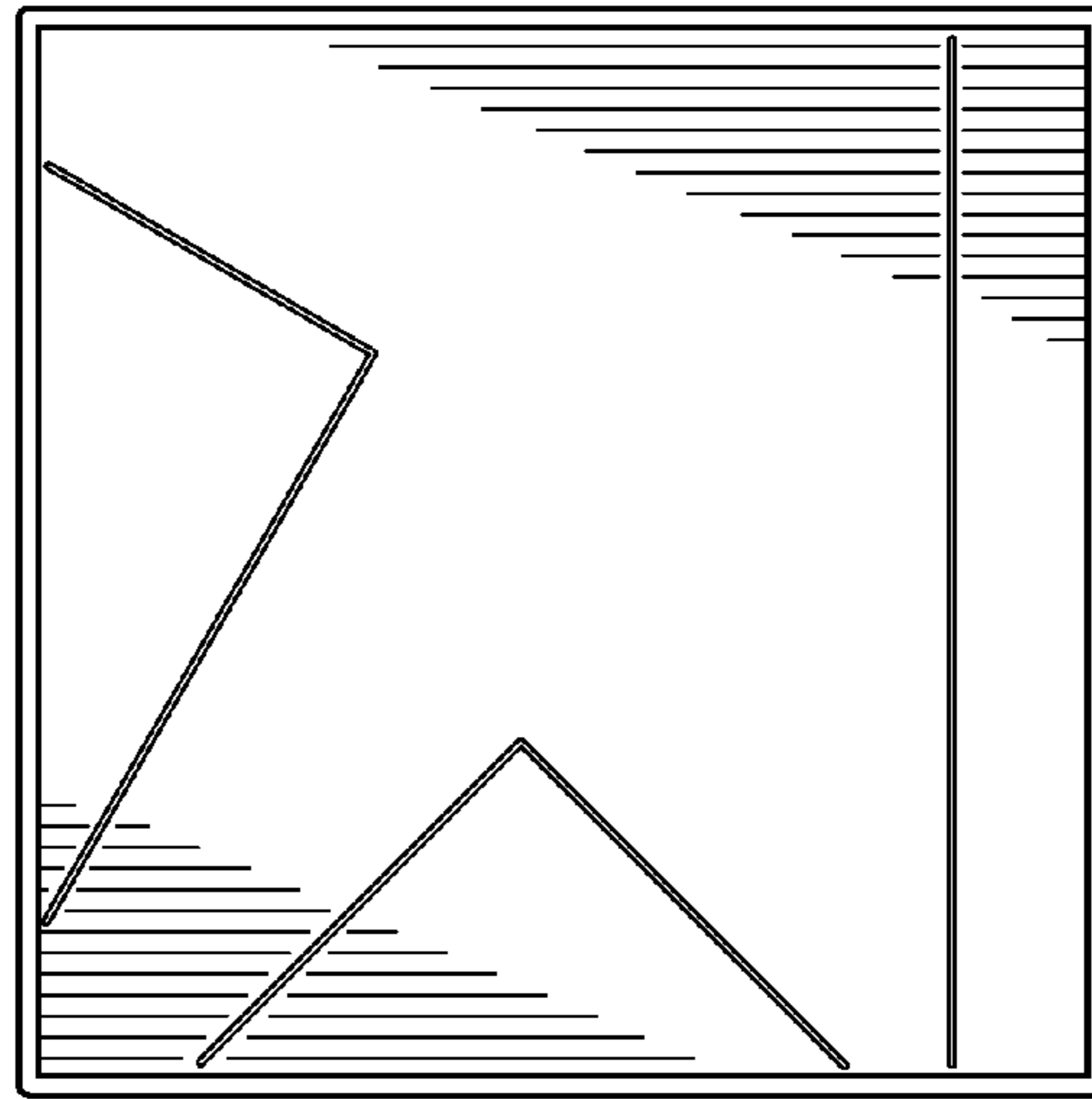

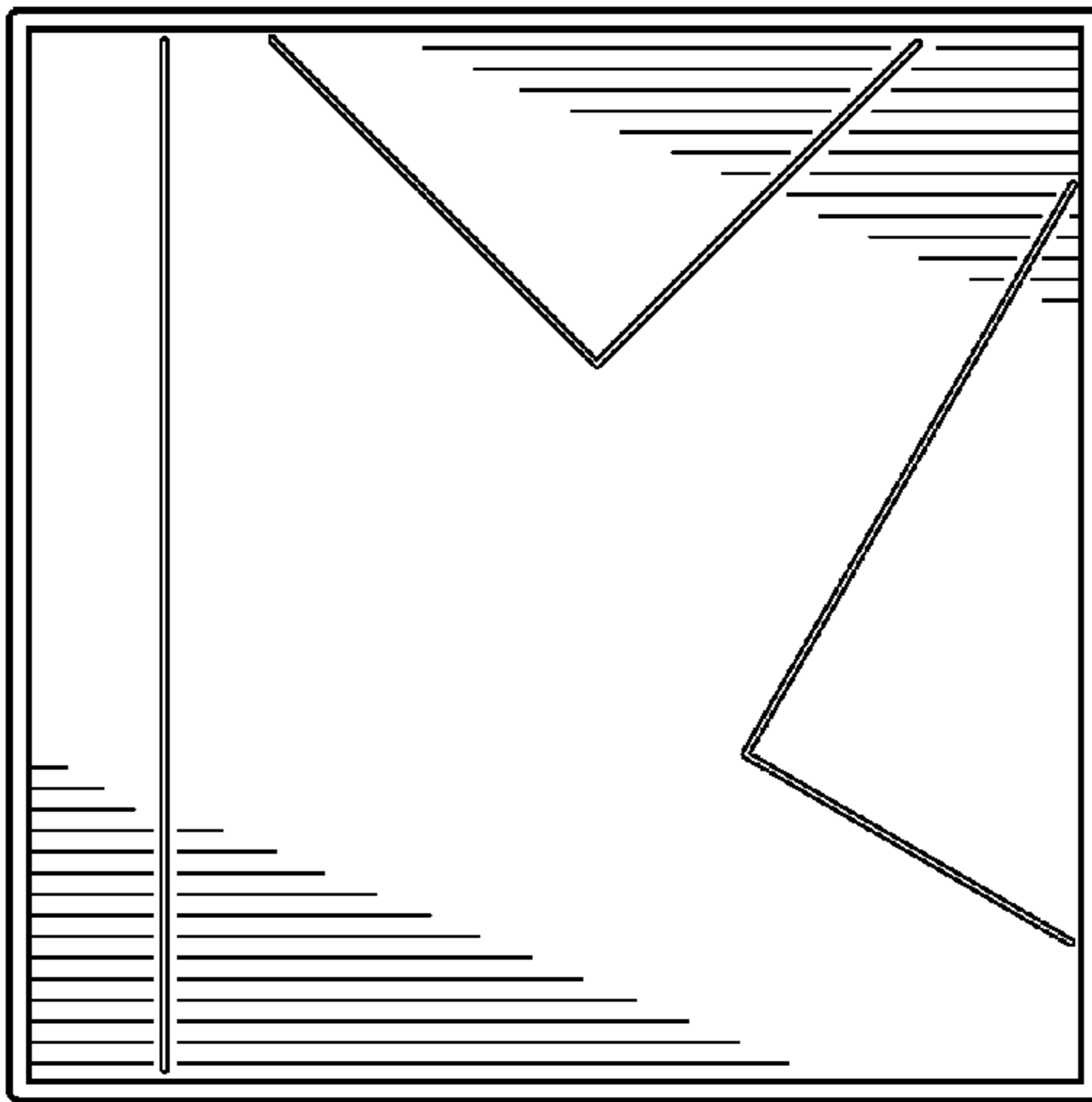

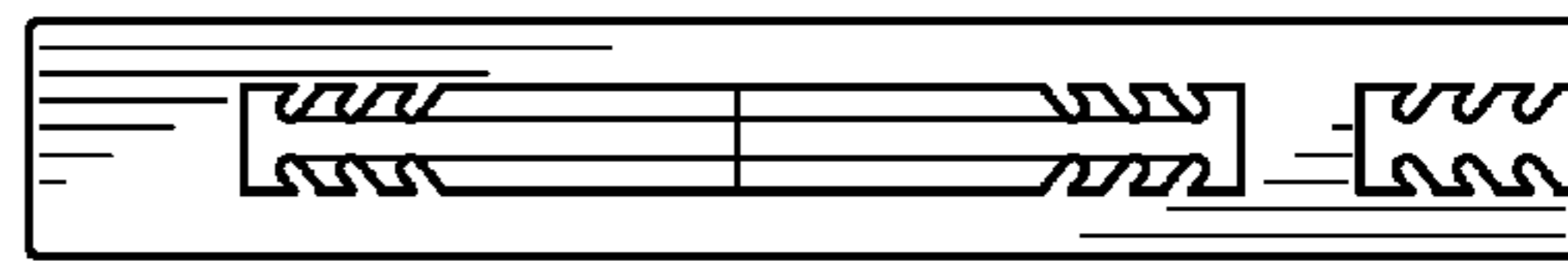

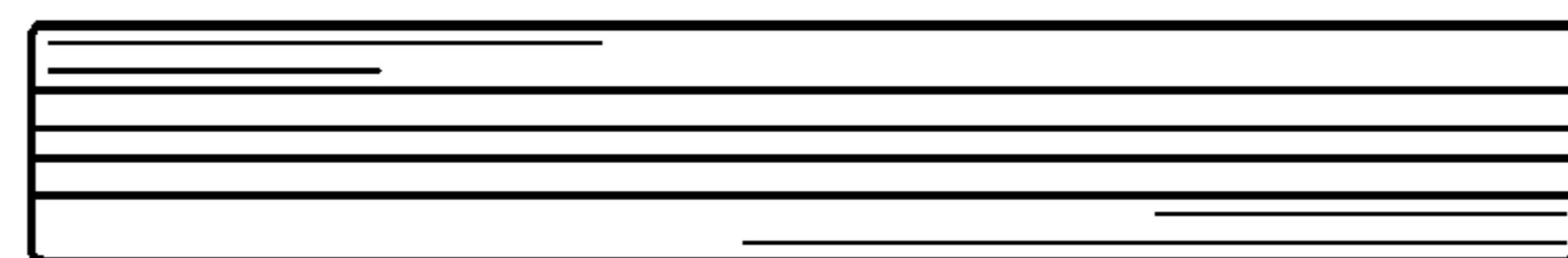

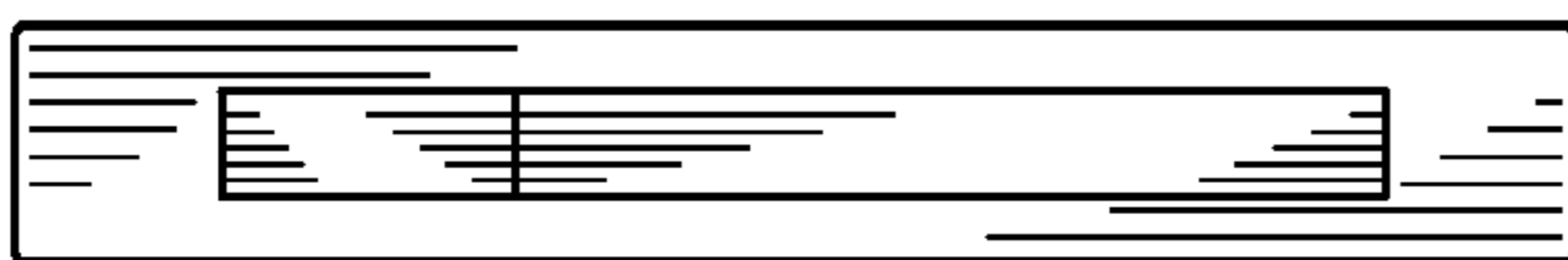
