The broken-line features in the figures are for illustrative purposes only and form no part of the claimed design.

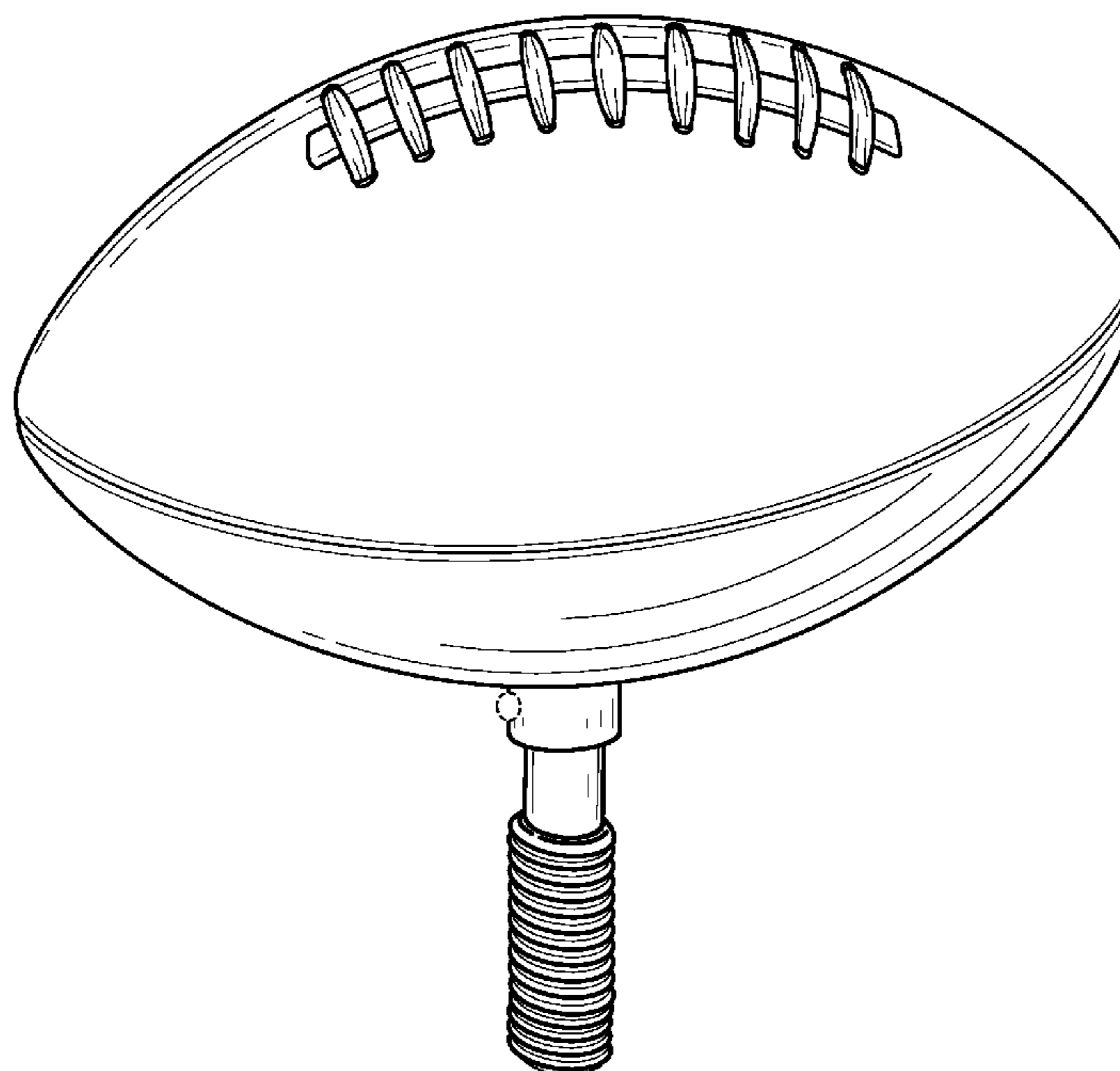

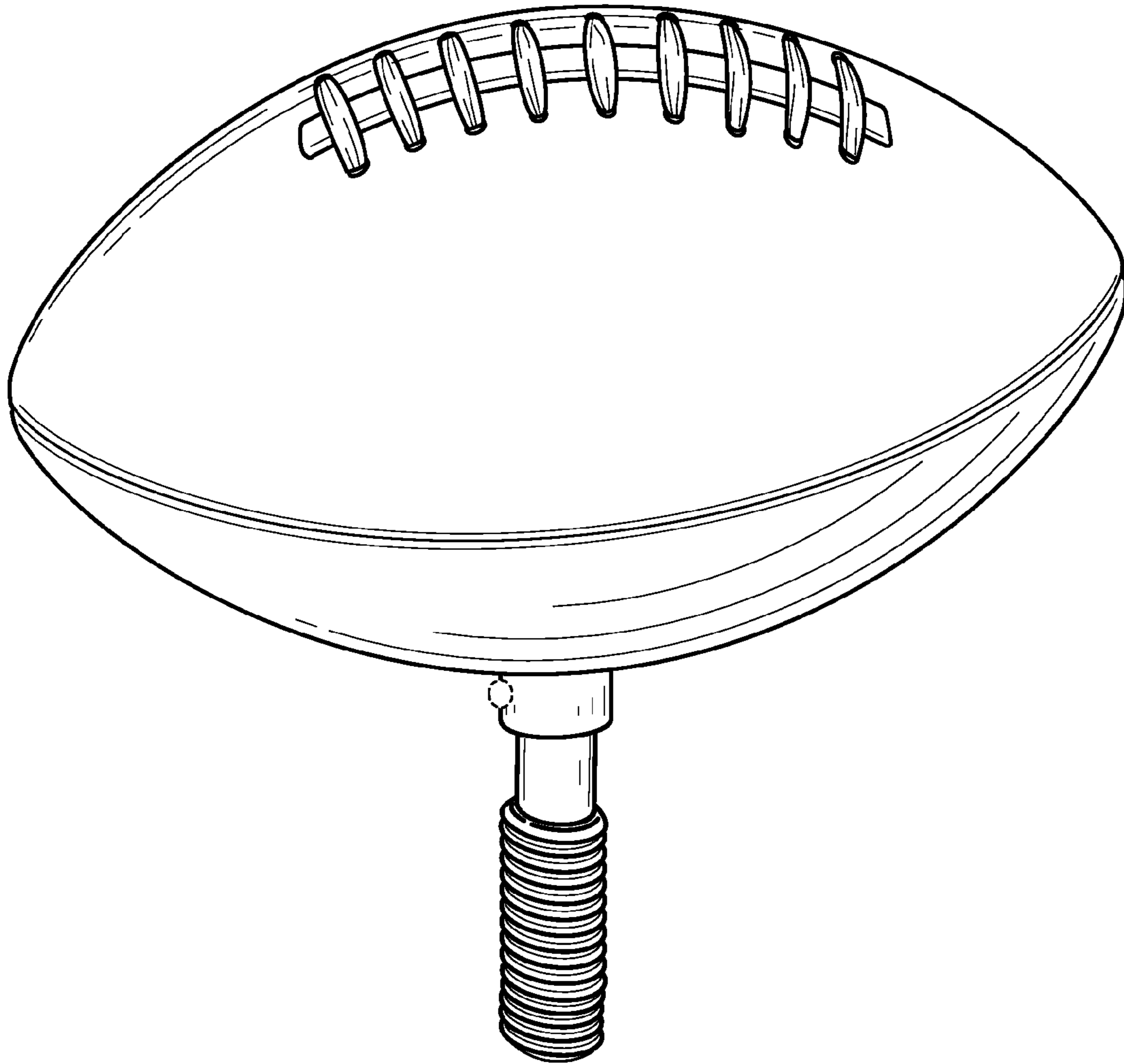

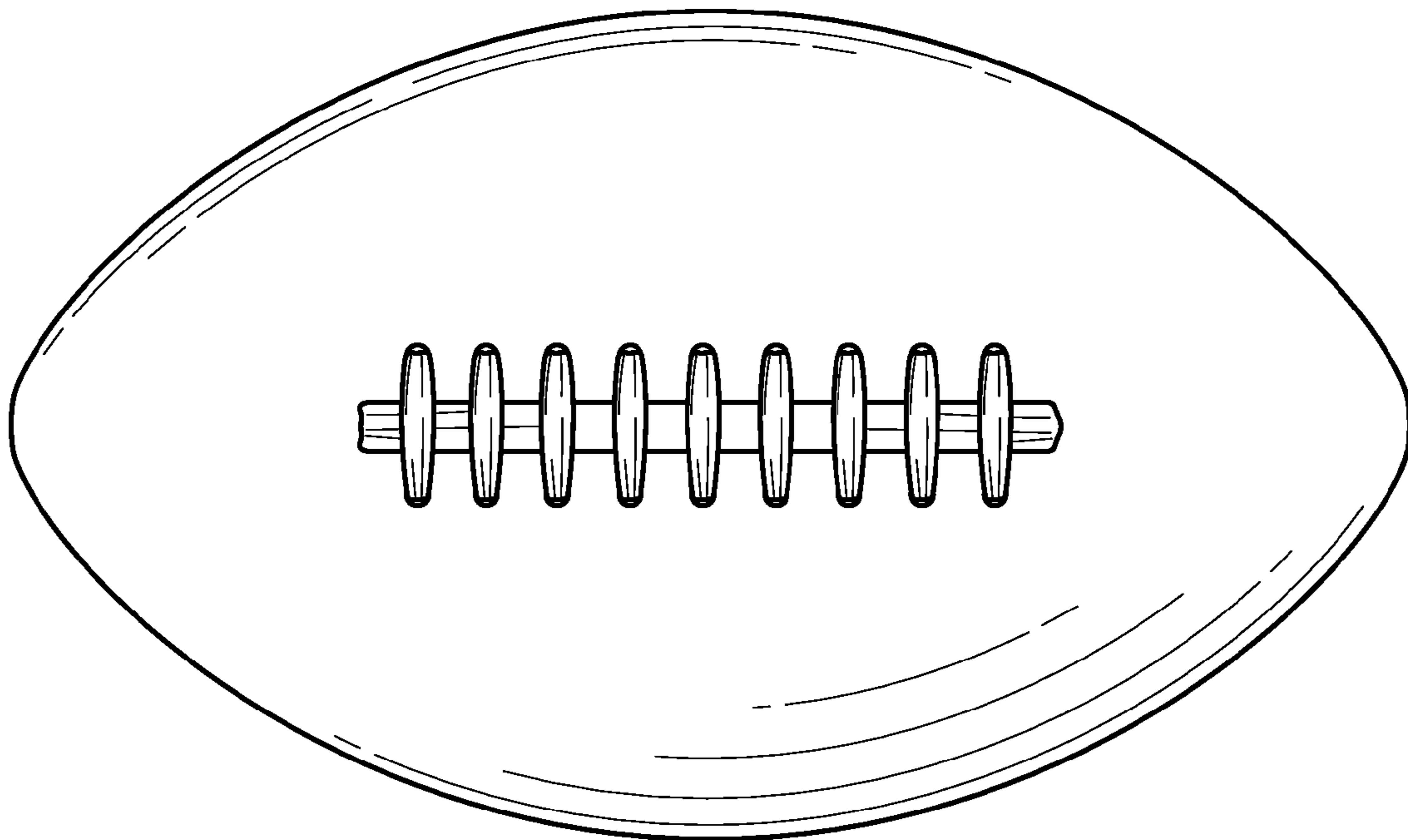

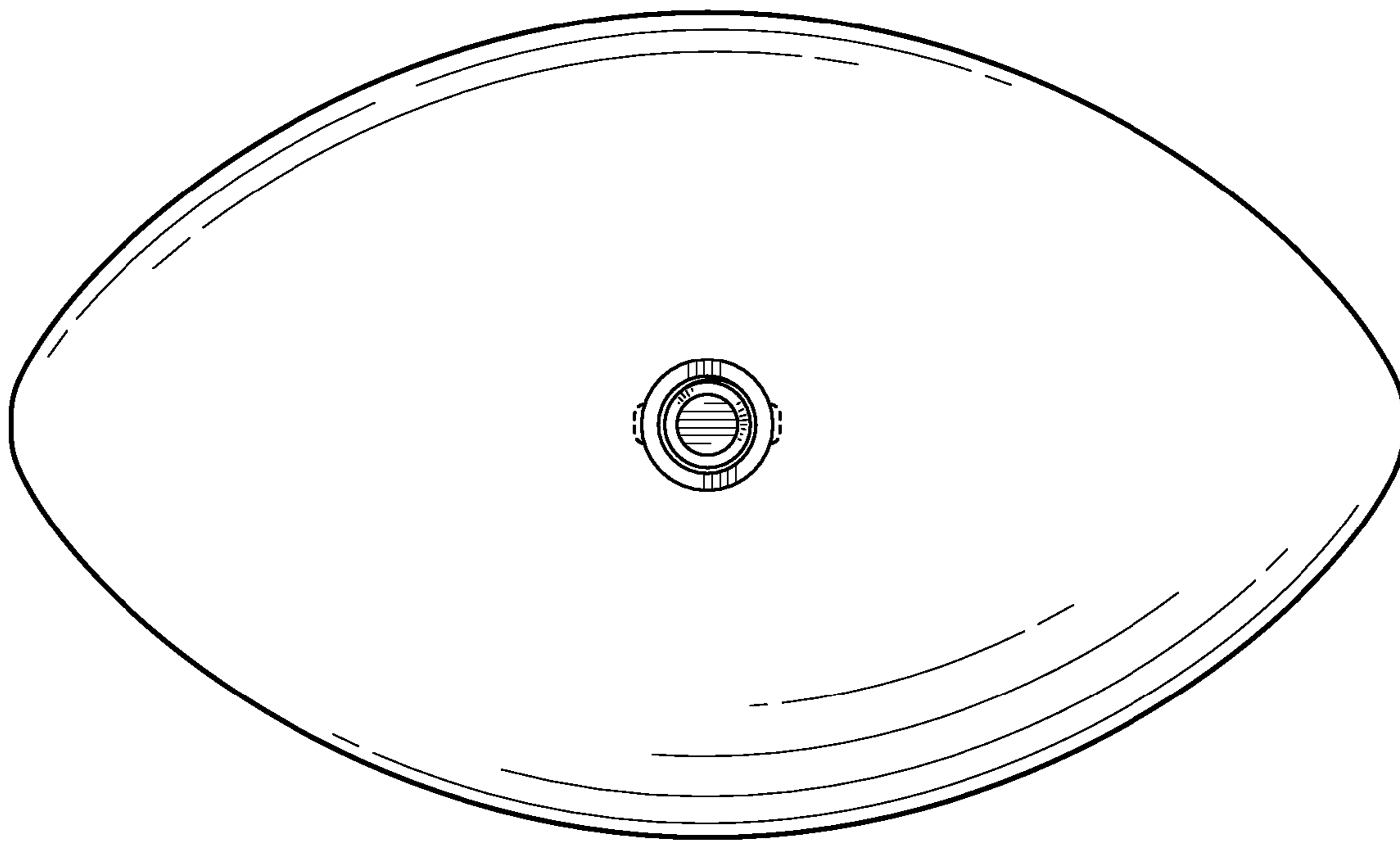

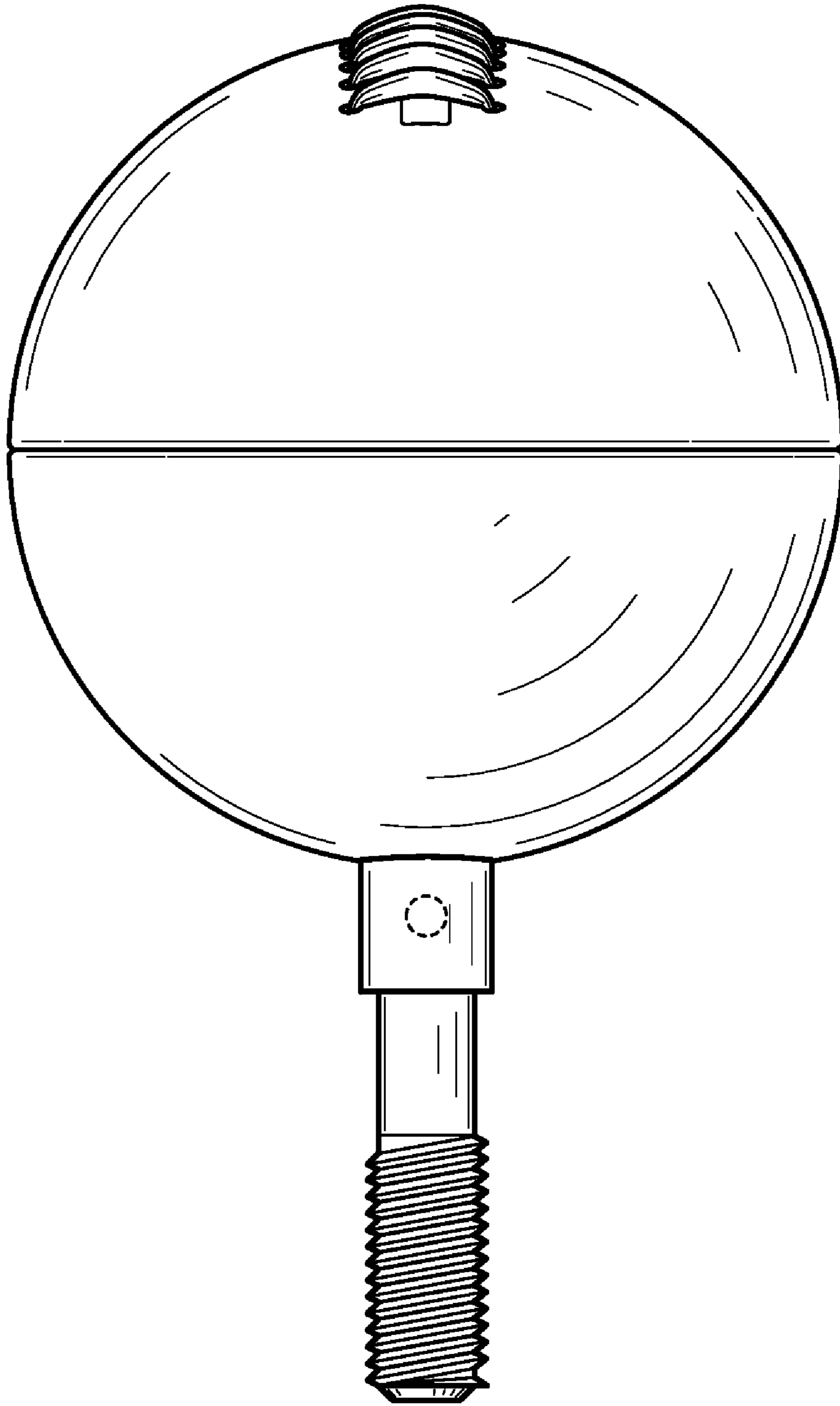

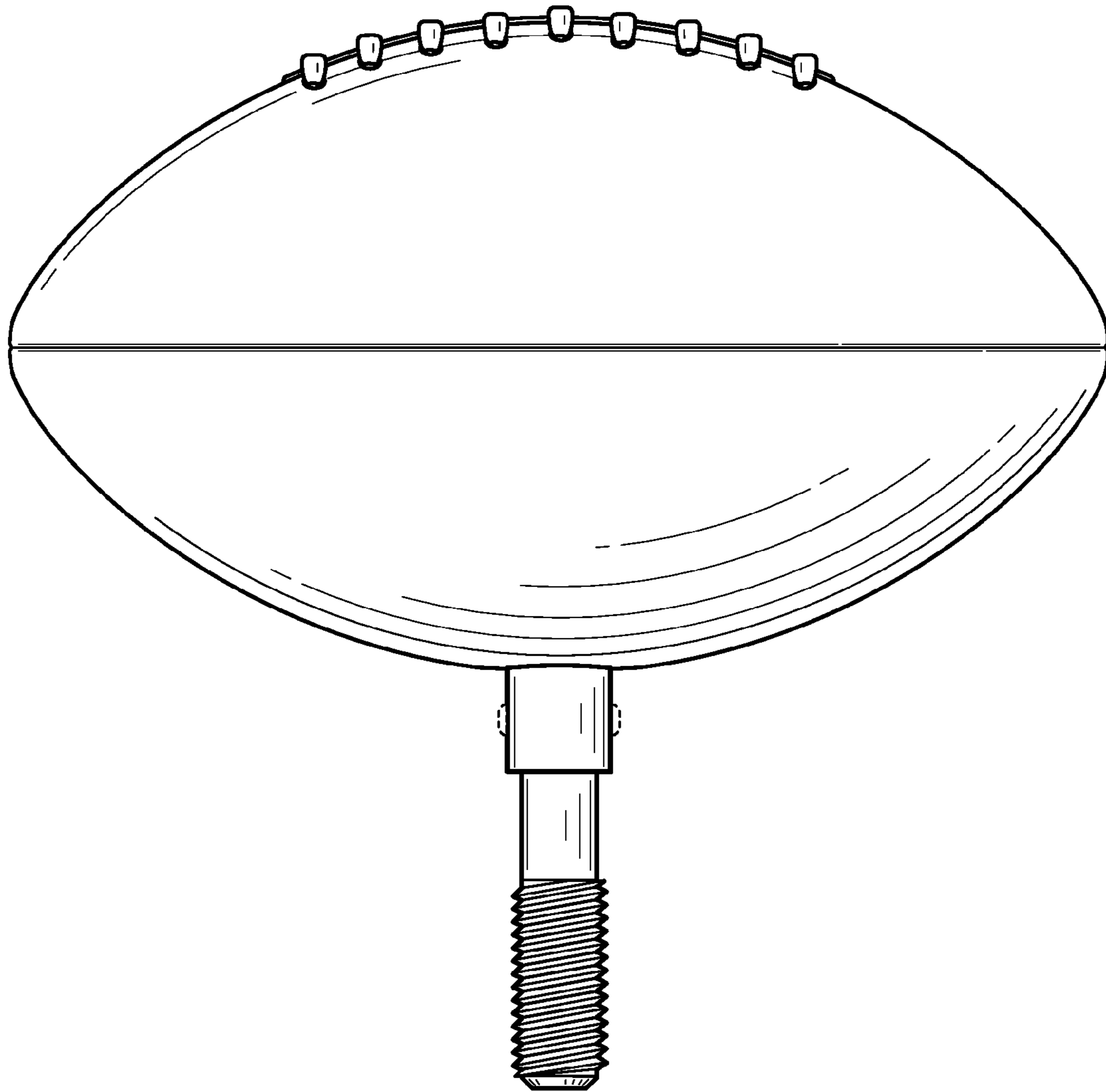

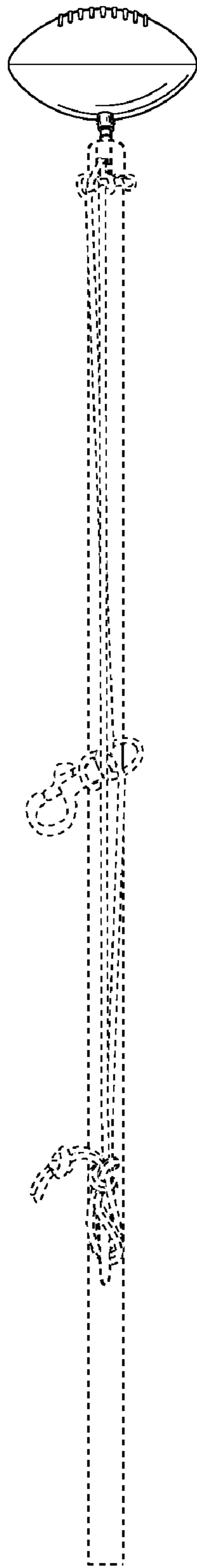

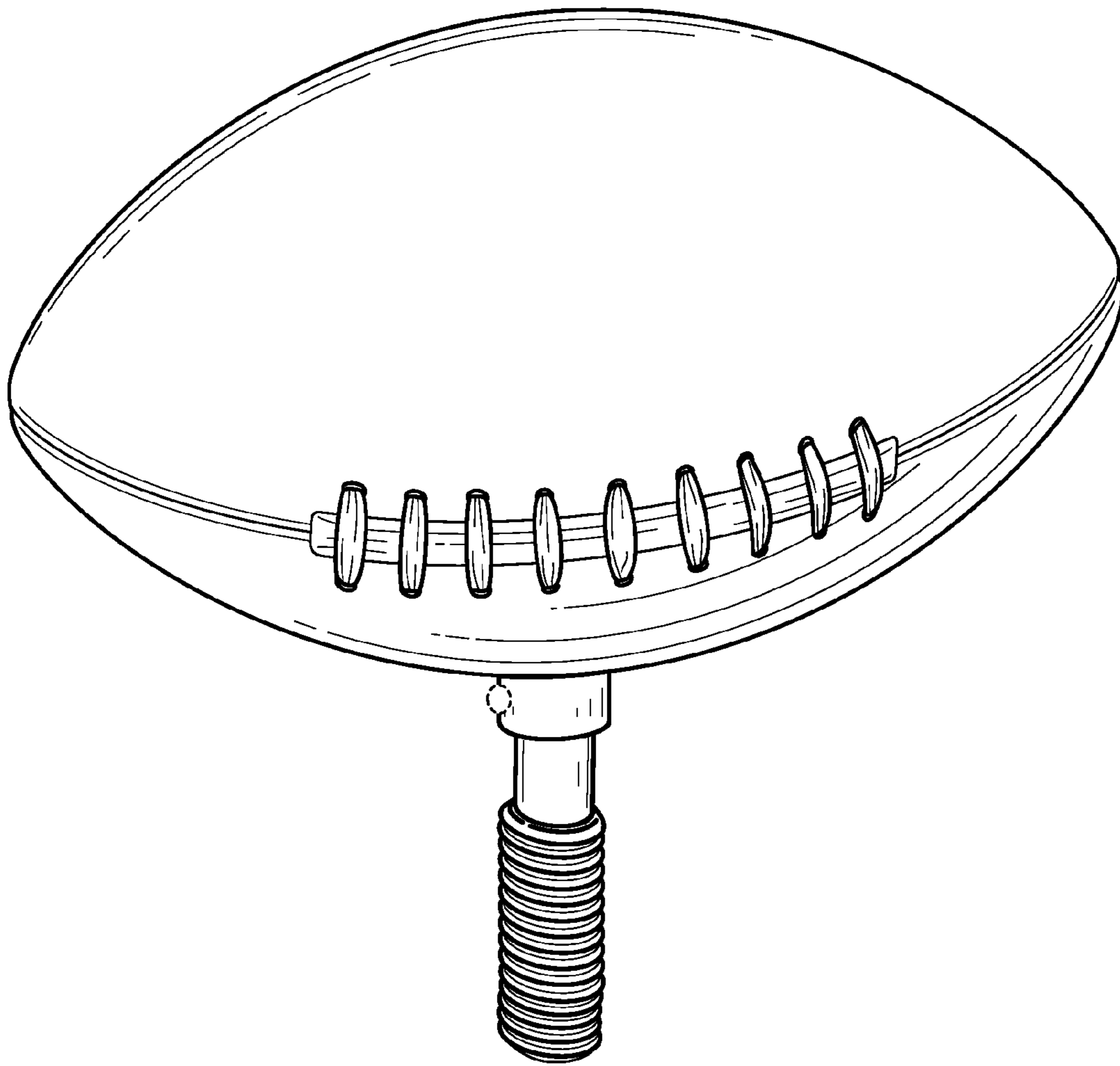

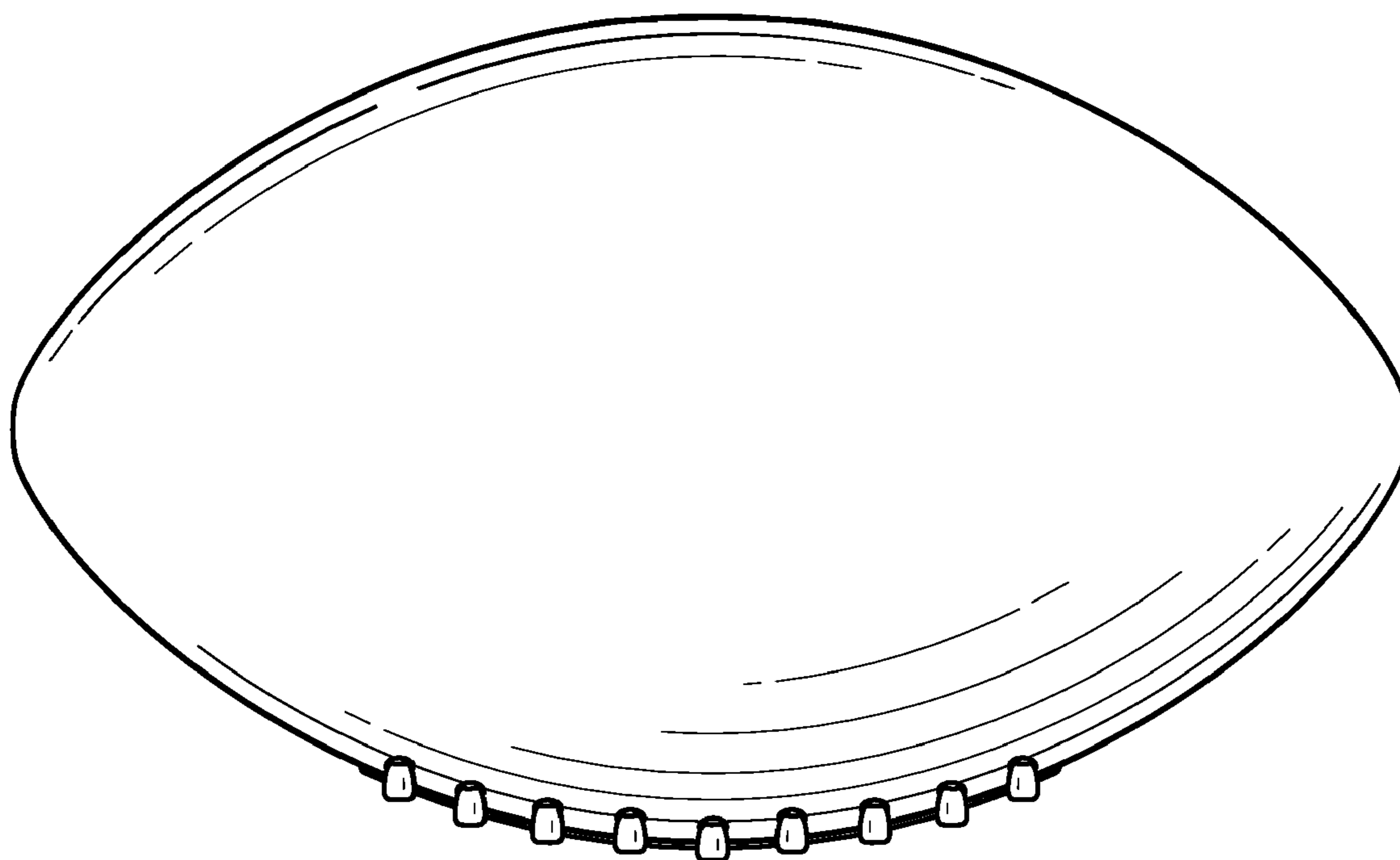

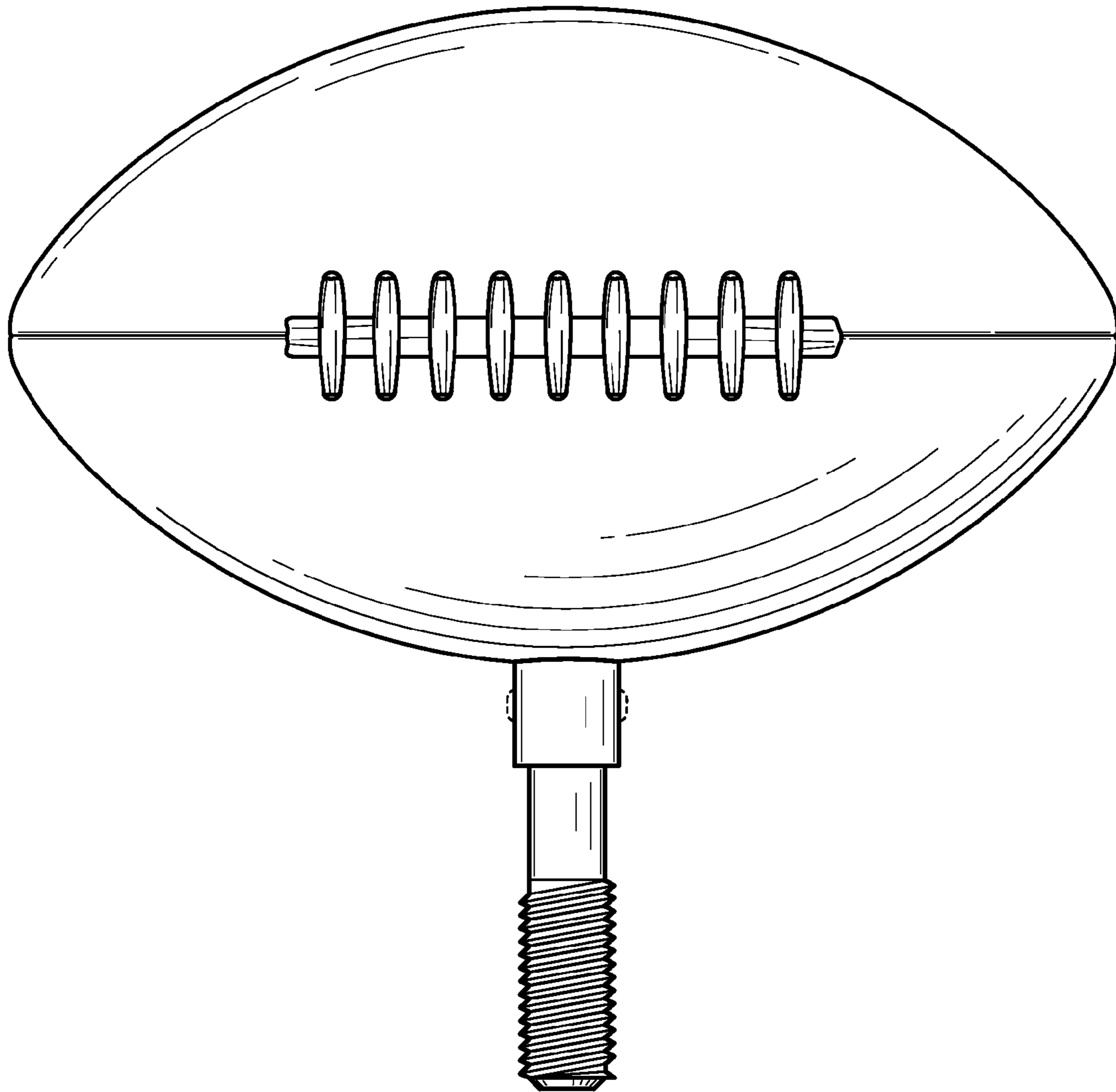

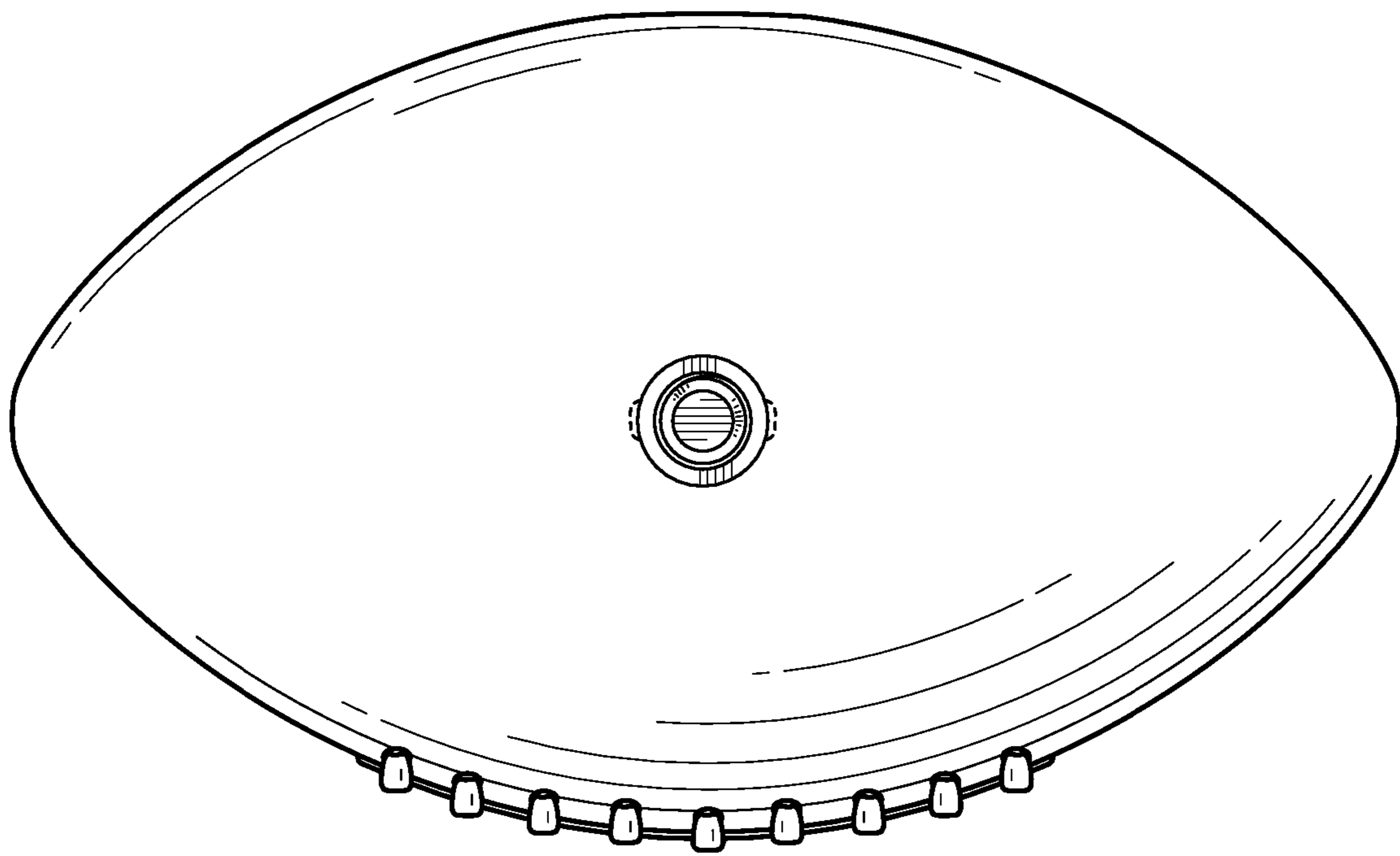

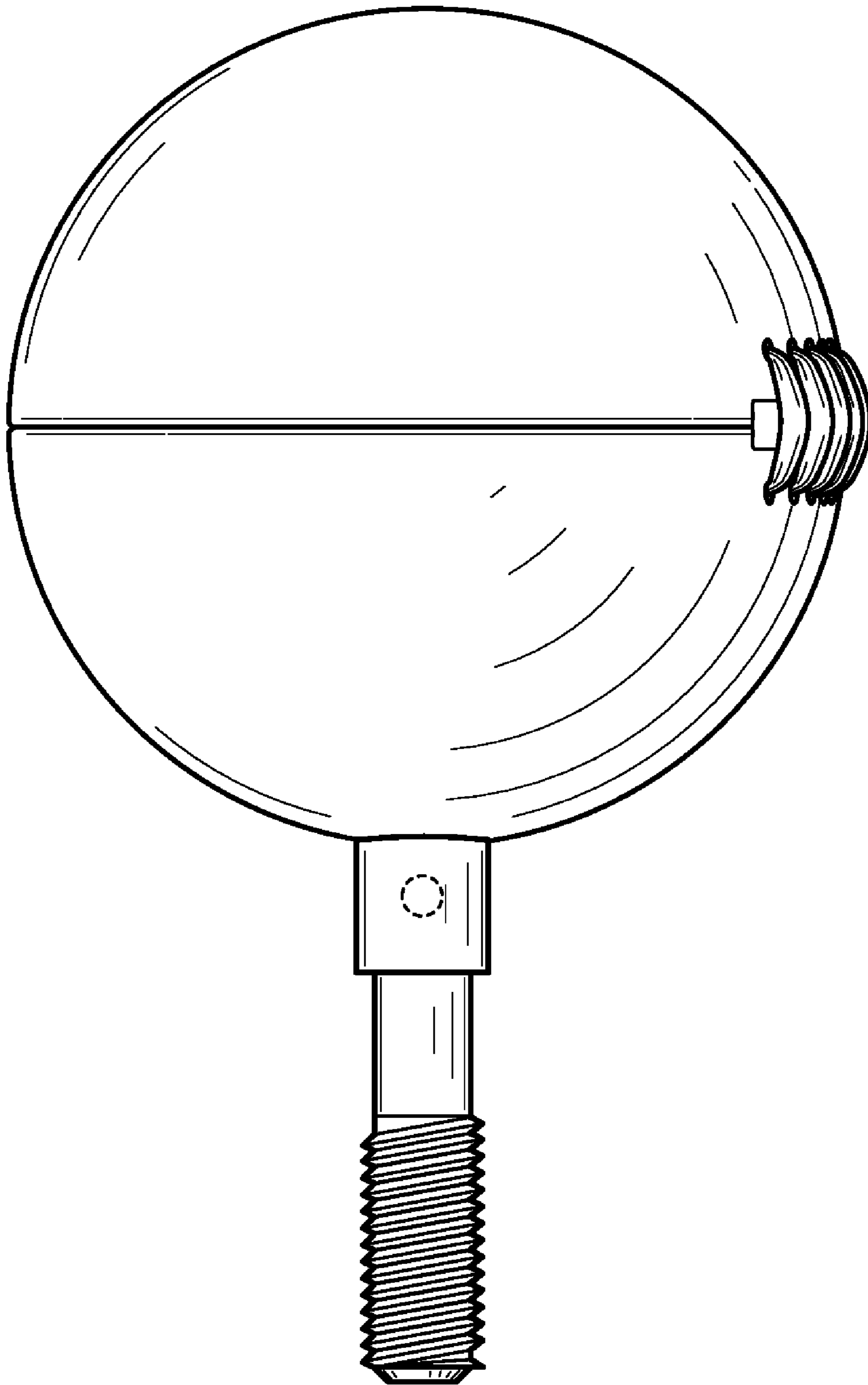

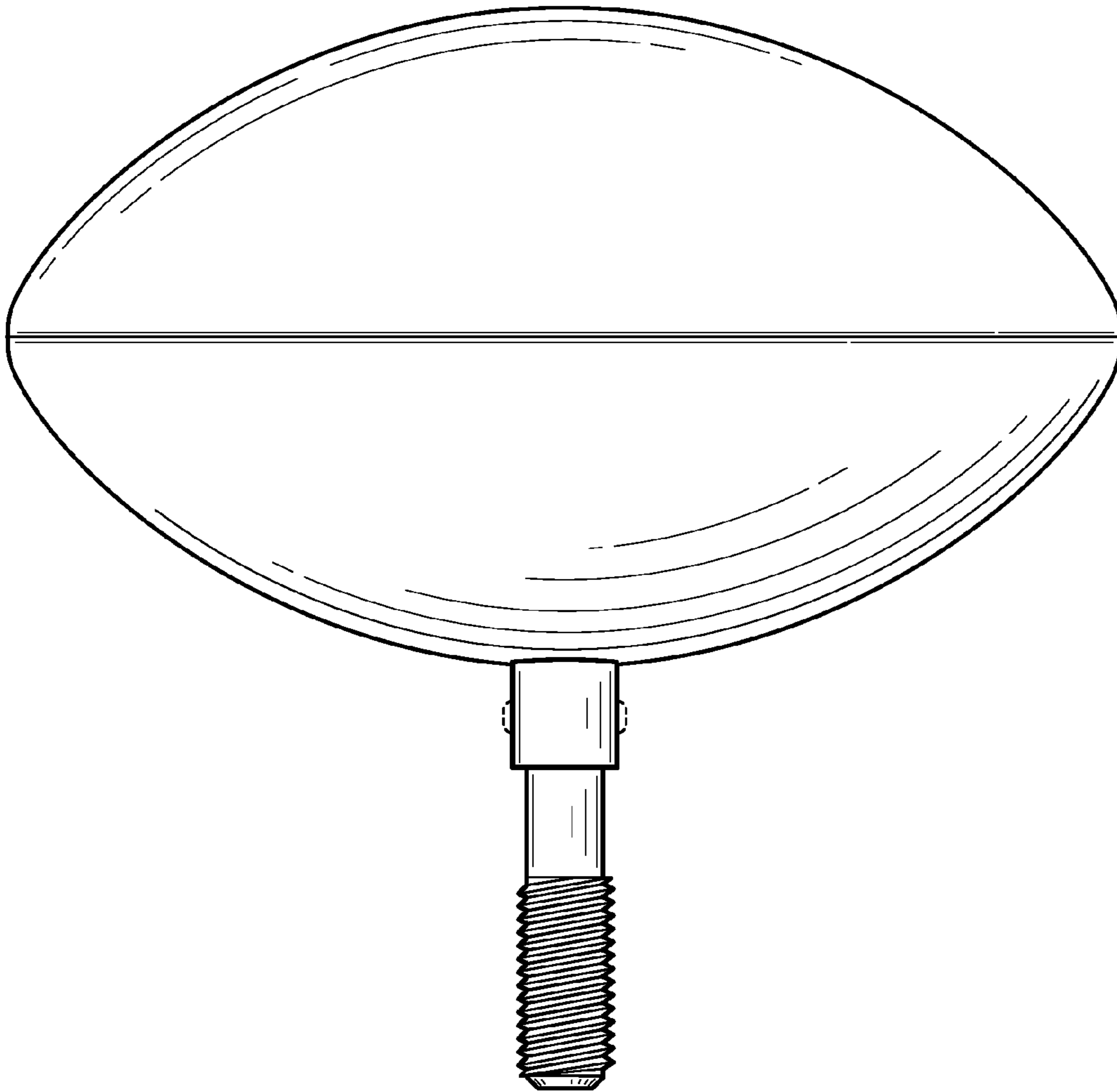

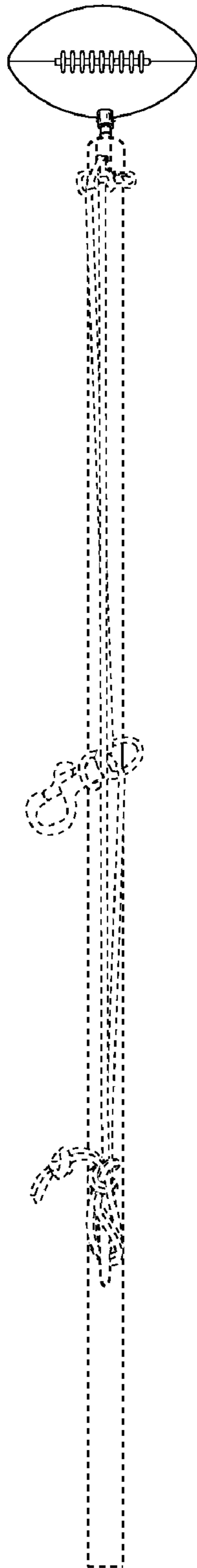
