(57) **CLAIM**

The ornamental design for a control lever for watercraft, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of one embodiment of the control lever for watercraft showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is an elevational view of one side thereof; with the other side view being a mirror image thereof;

FIG. 5 is a top plan view thereof; and,

FIG. 6 is bottom plan view thereof.

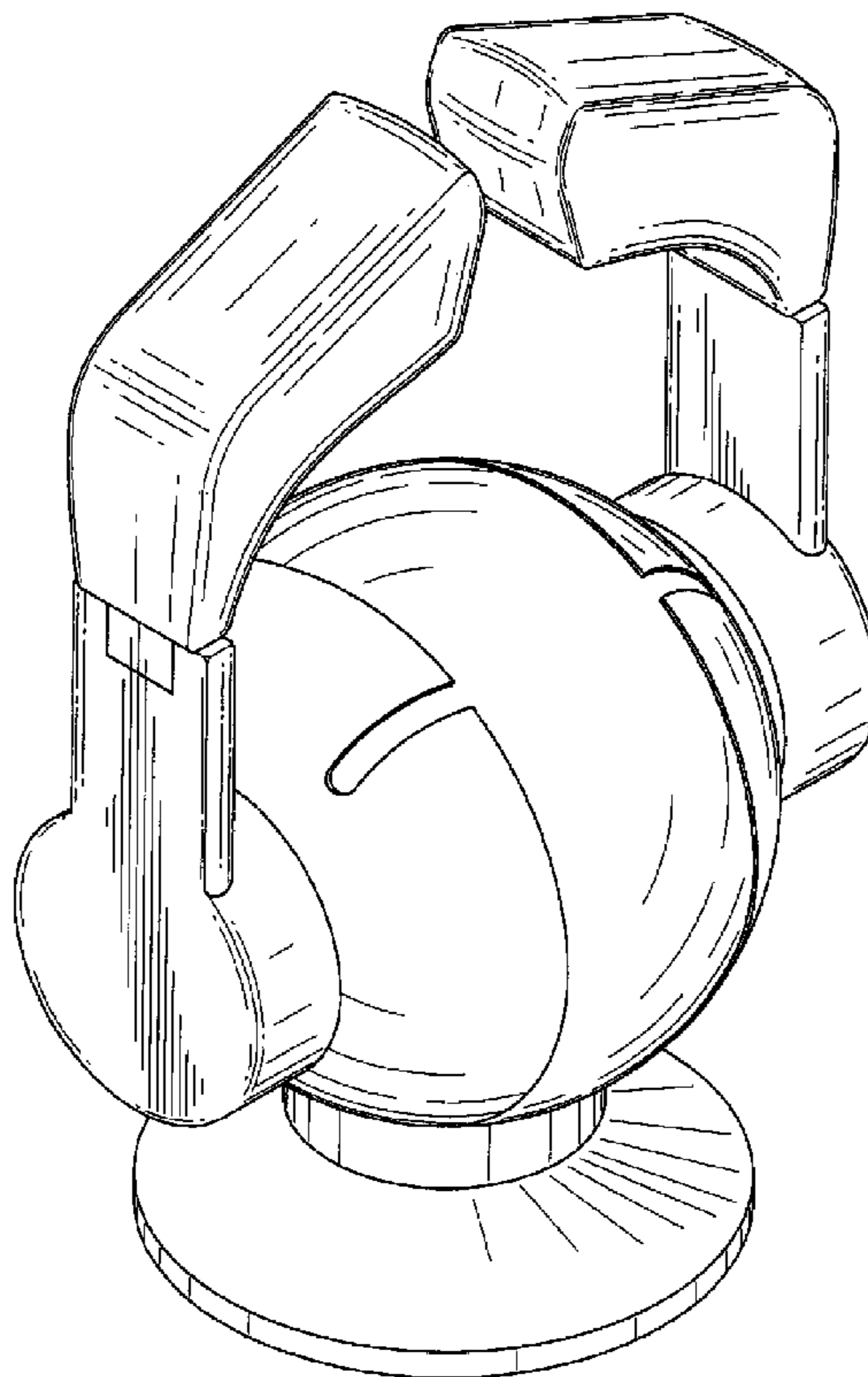

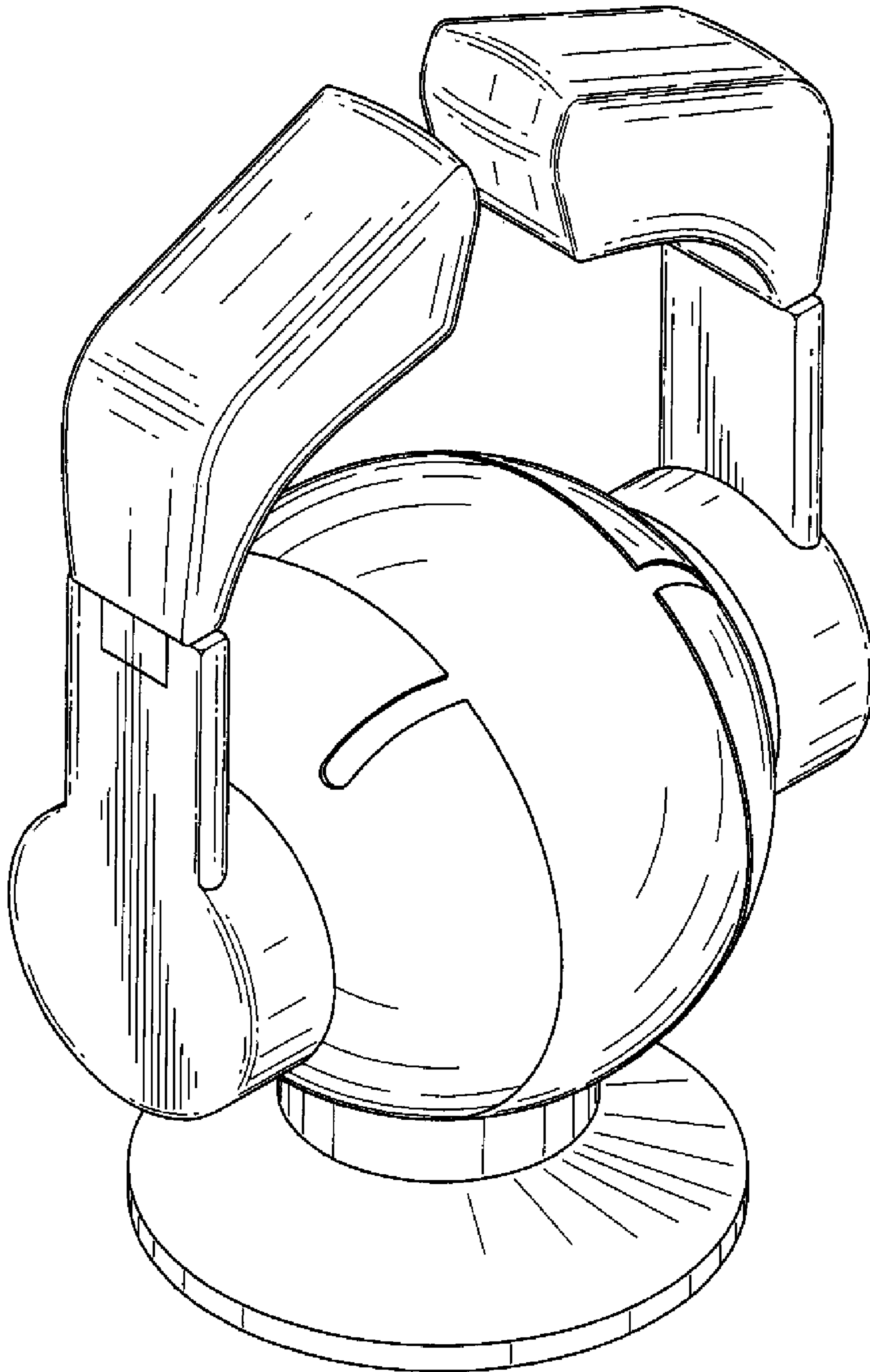

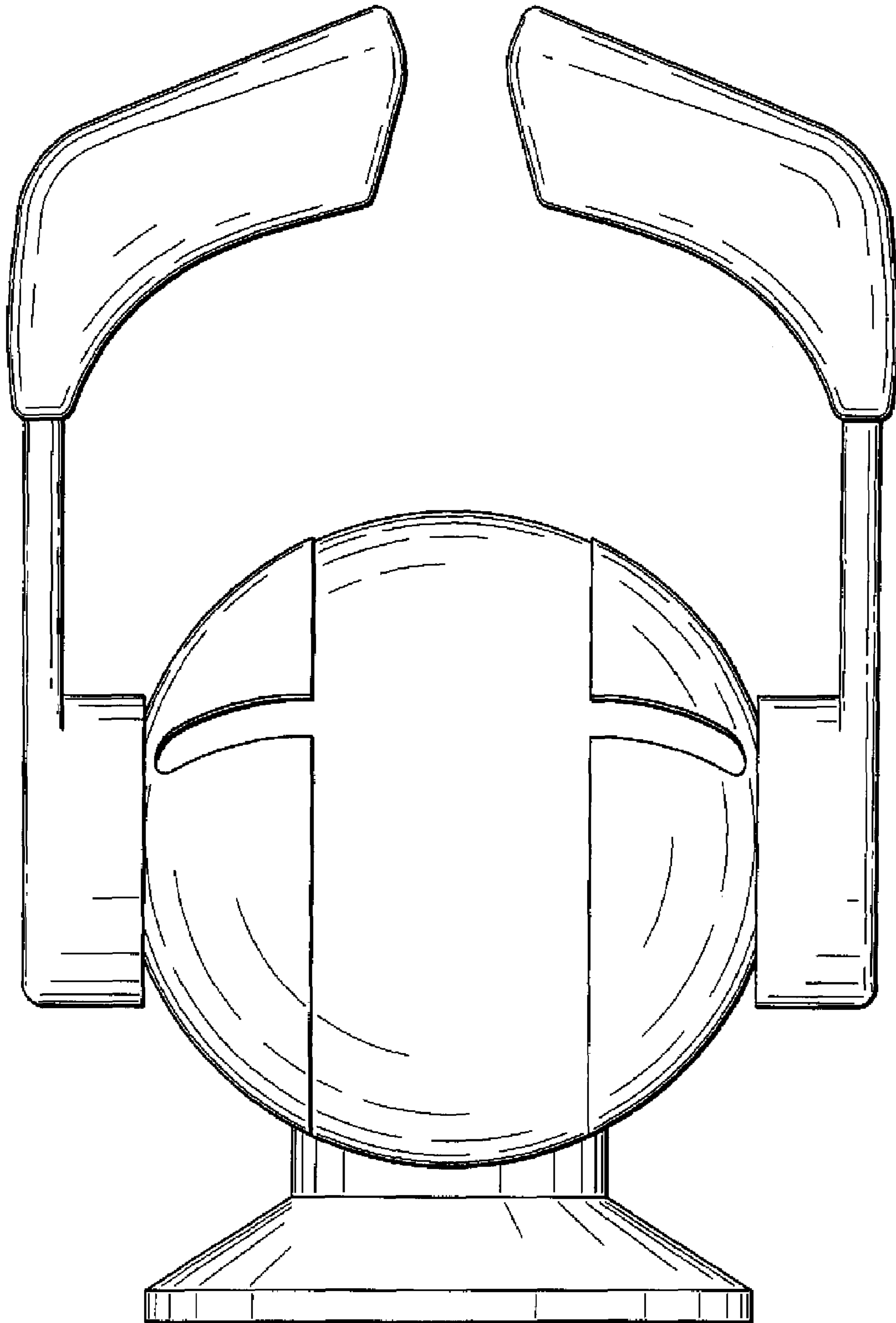

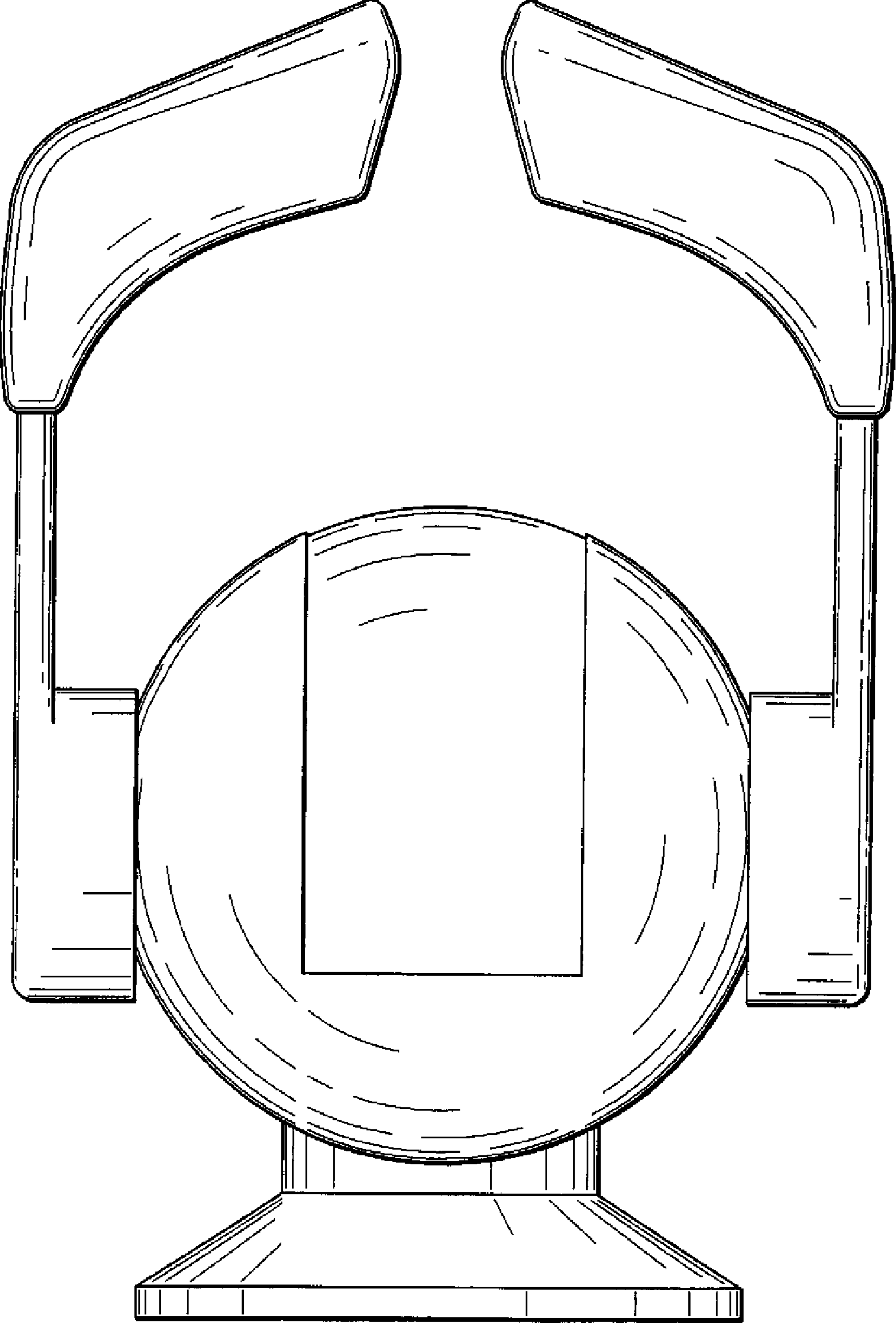

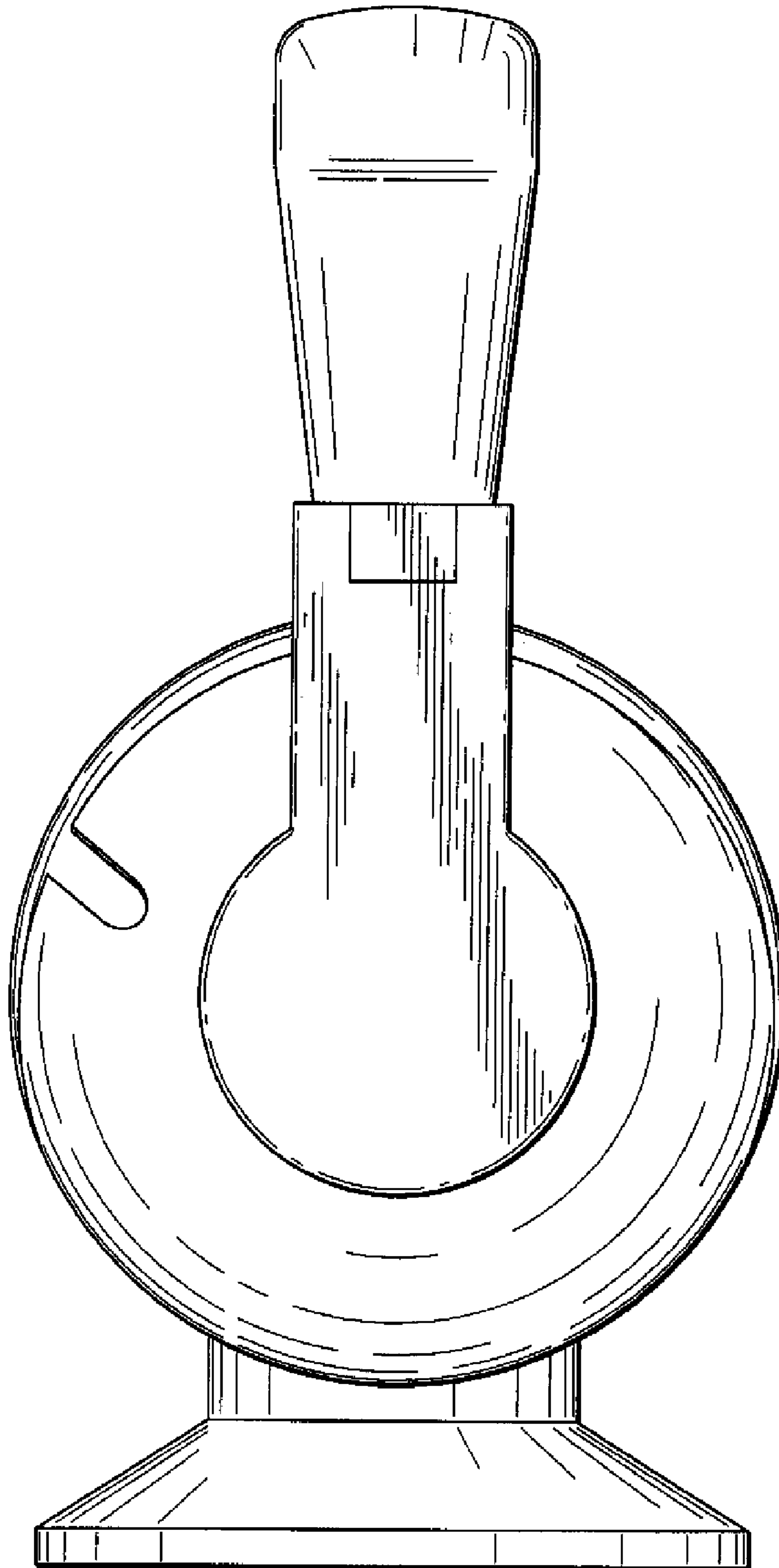

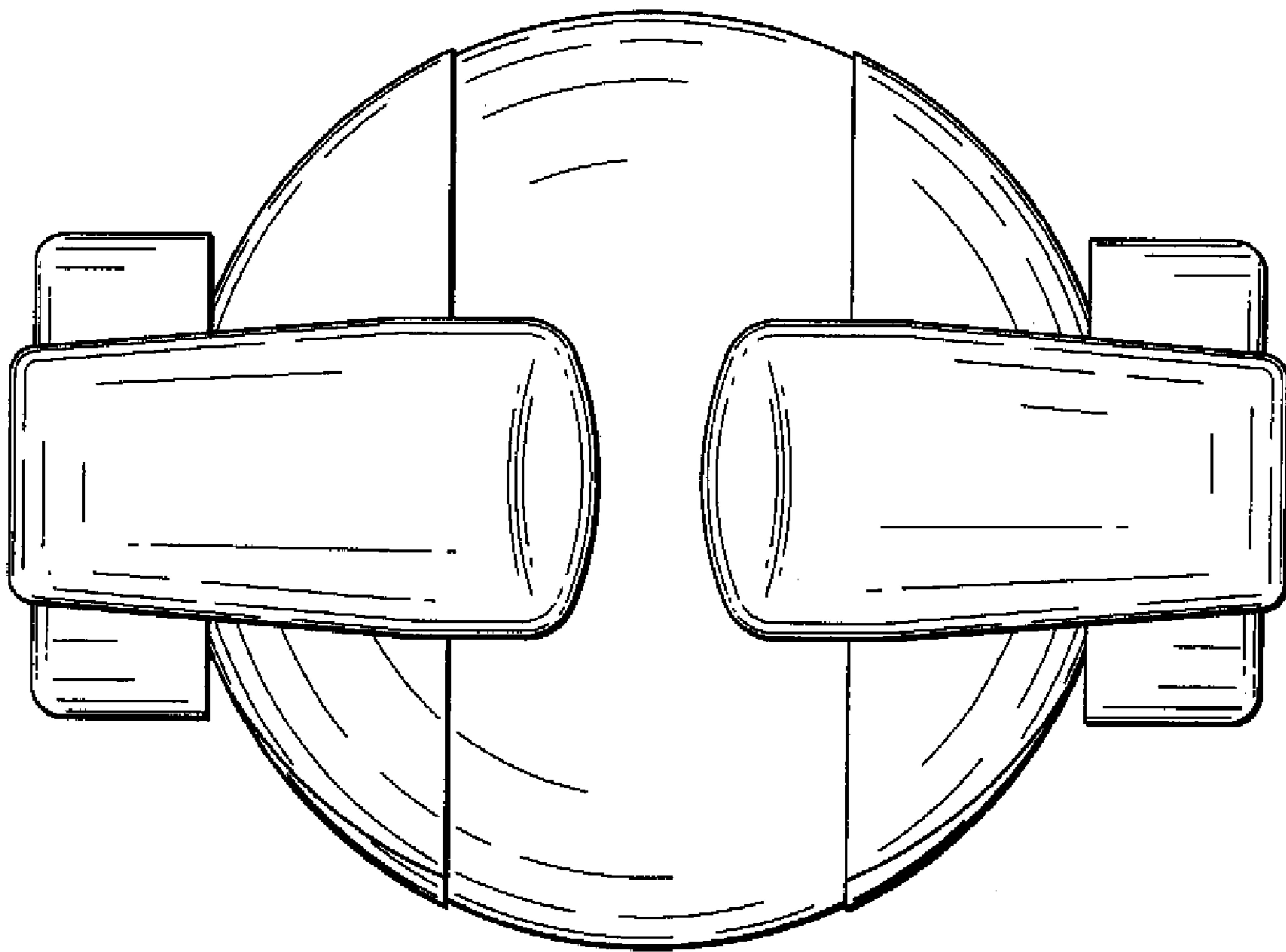
