The ornamental design for a pick-up truck cover, as shown and described.

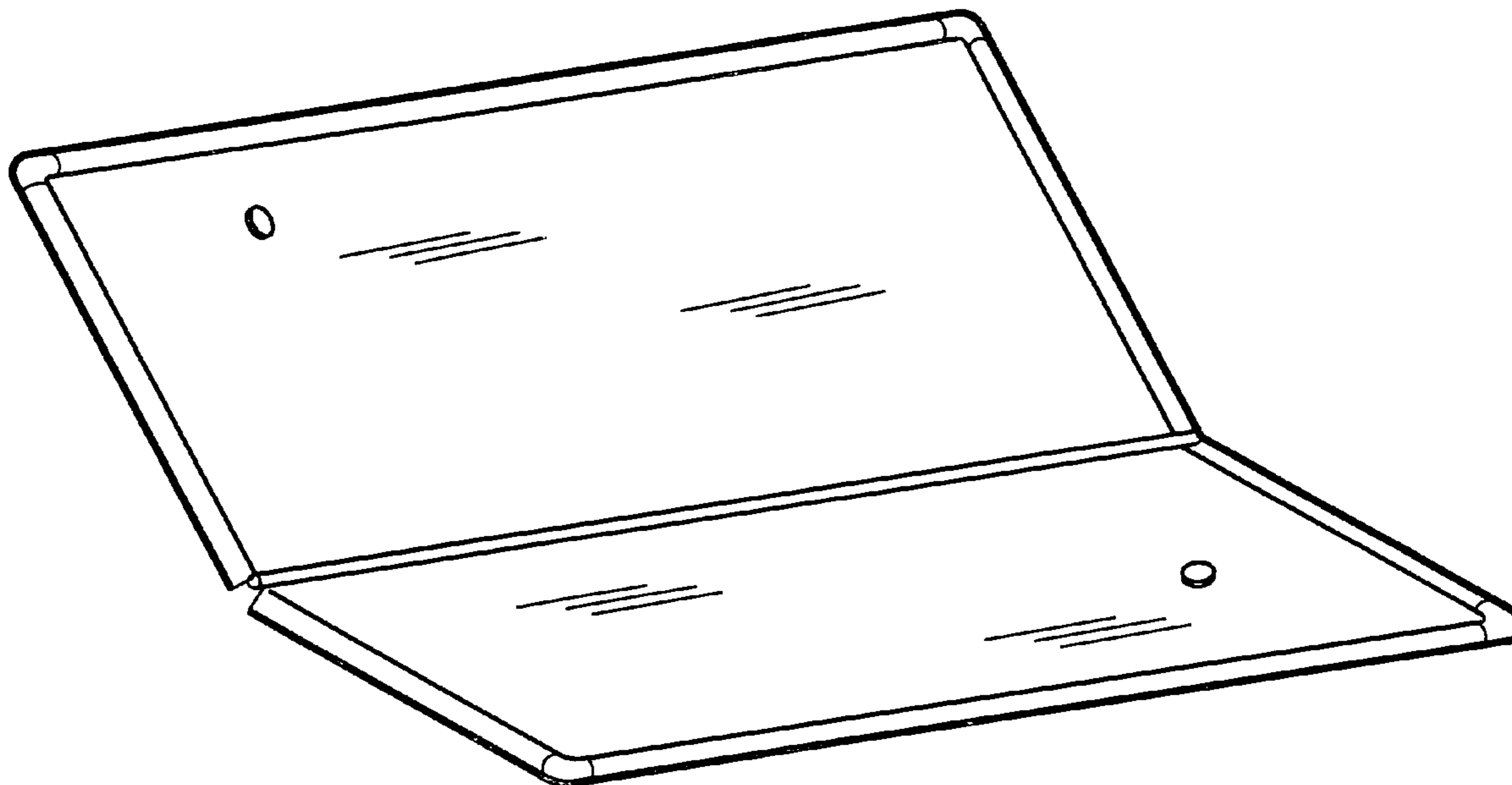
**DESCRIPTION**

FIG. 1 is a perspective view of a two-panel pick-up truck cover having one panel in an open position and the other panel in a closed position showing my new design; and,

FIG. 2 is a bottom view of the pick-up truck cover.

In drawing FIG. 2 the broken lines depict elements of the underside of the pick-up truck cover that form no part of the claimed design.

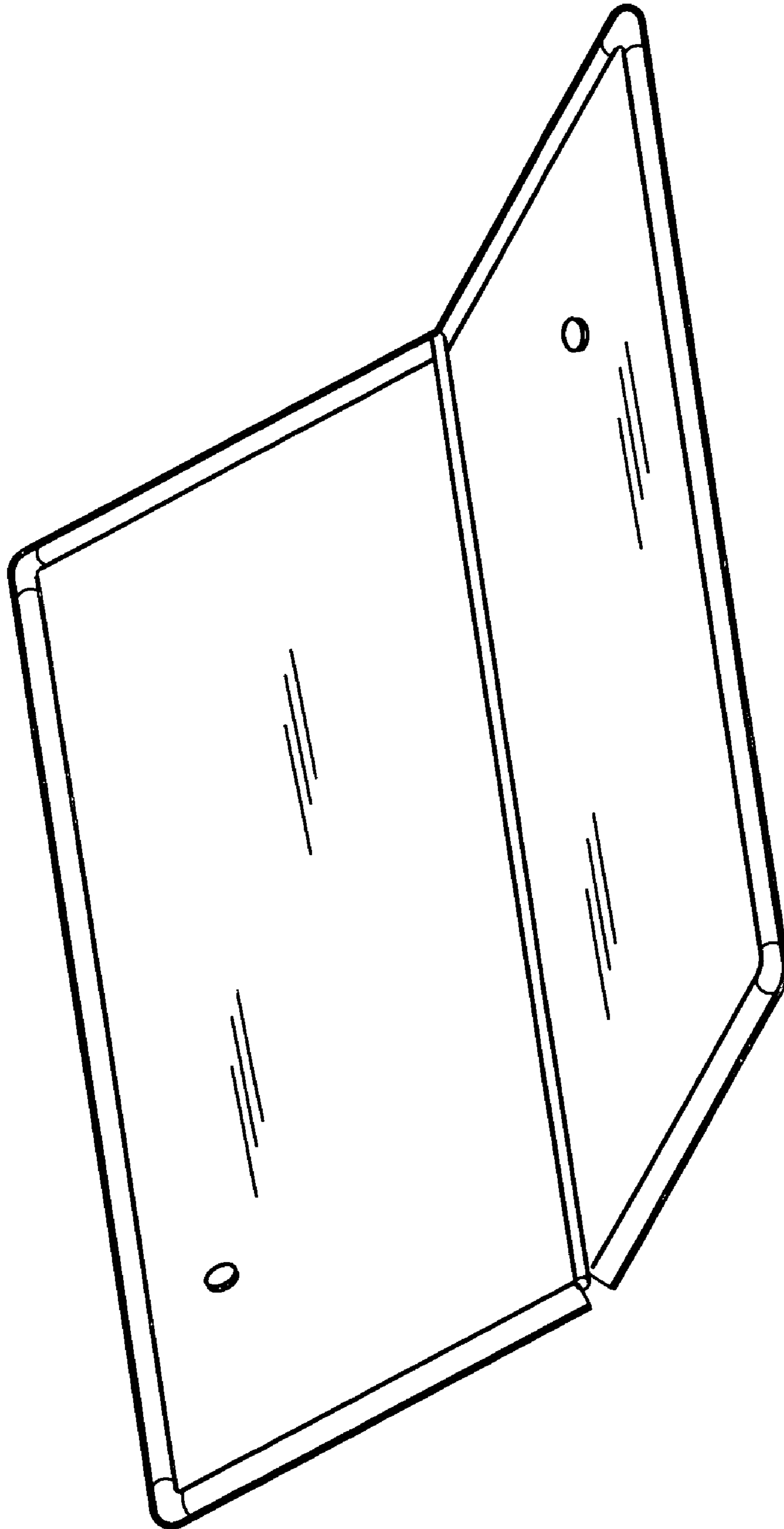

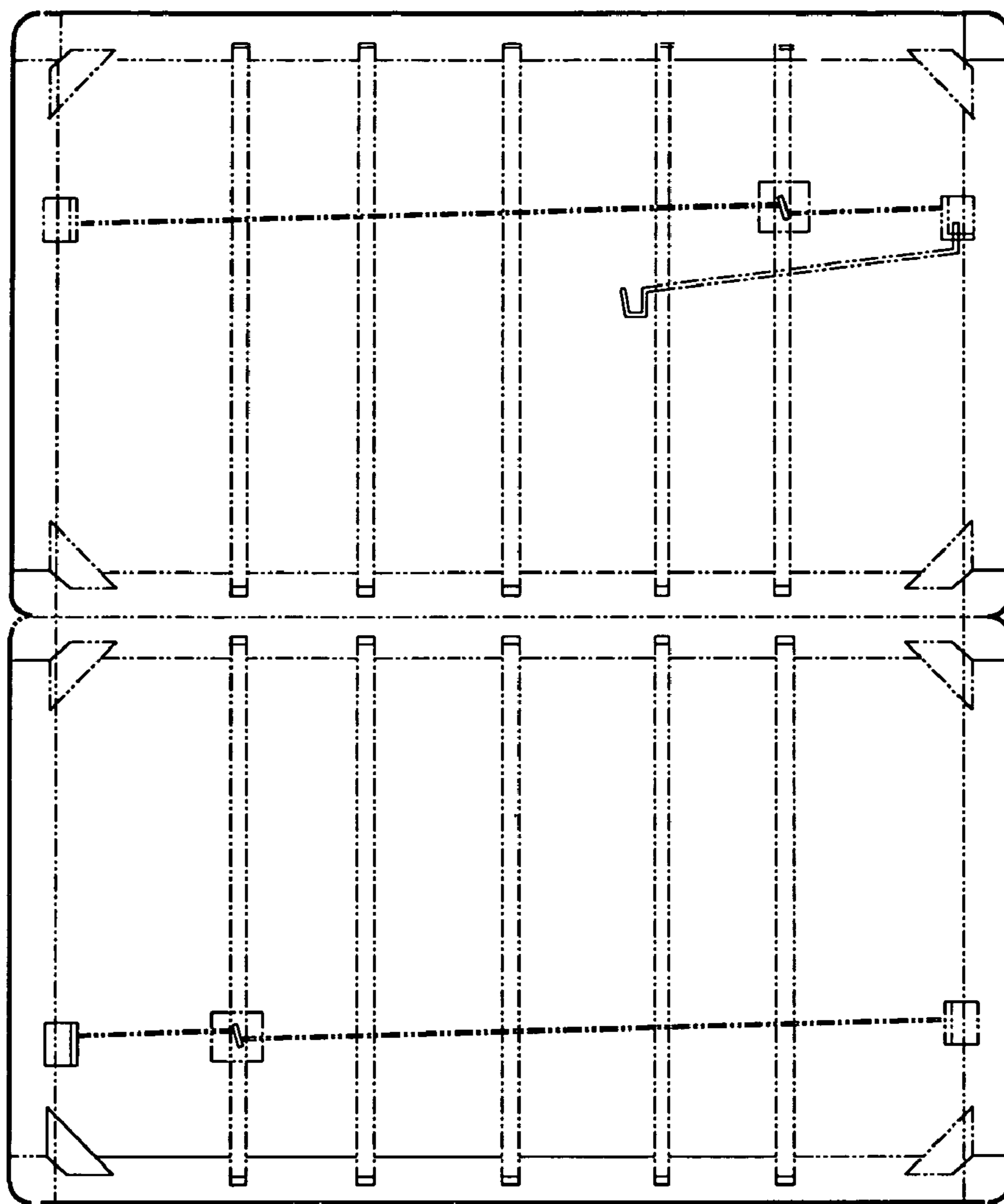
