(57) **CLAIM**

The ornamental design for a writing instrument with sheet dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing the new design for a writing instrument with sheet dispenser where a sheet assembled in a dispensing portion is shown in phantom.

FIG. 2 is a top plan view thereof;

FIG. 3 is a right side view thereof, the left side view being a mirror image;

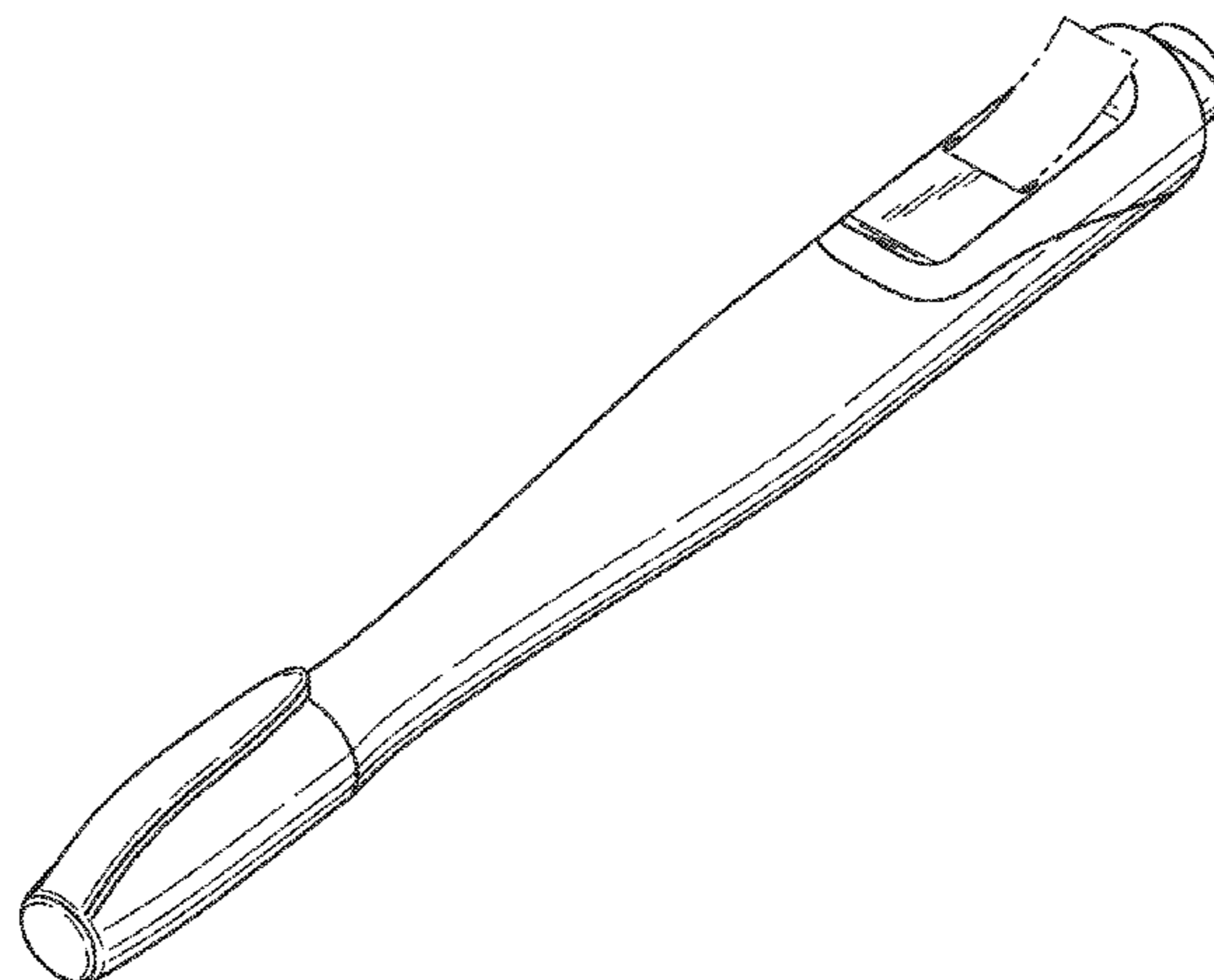
FIG. 4 is a bottom plan view thereof;

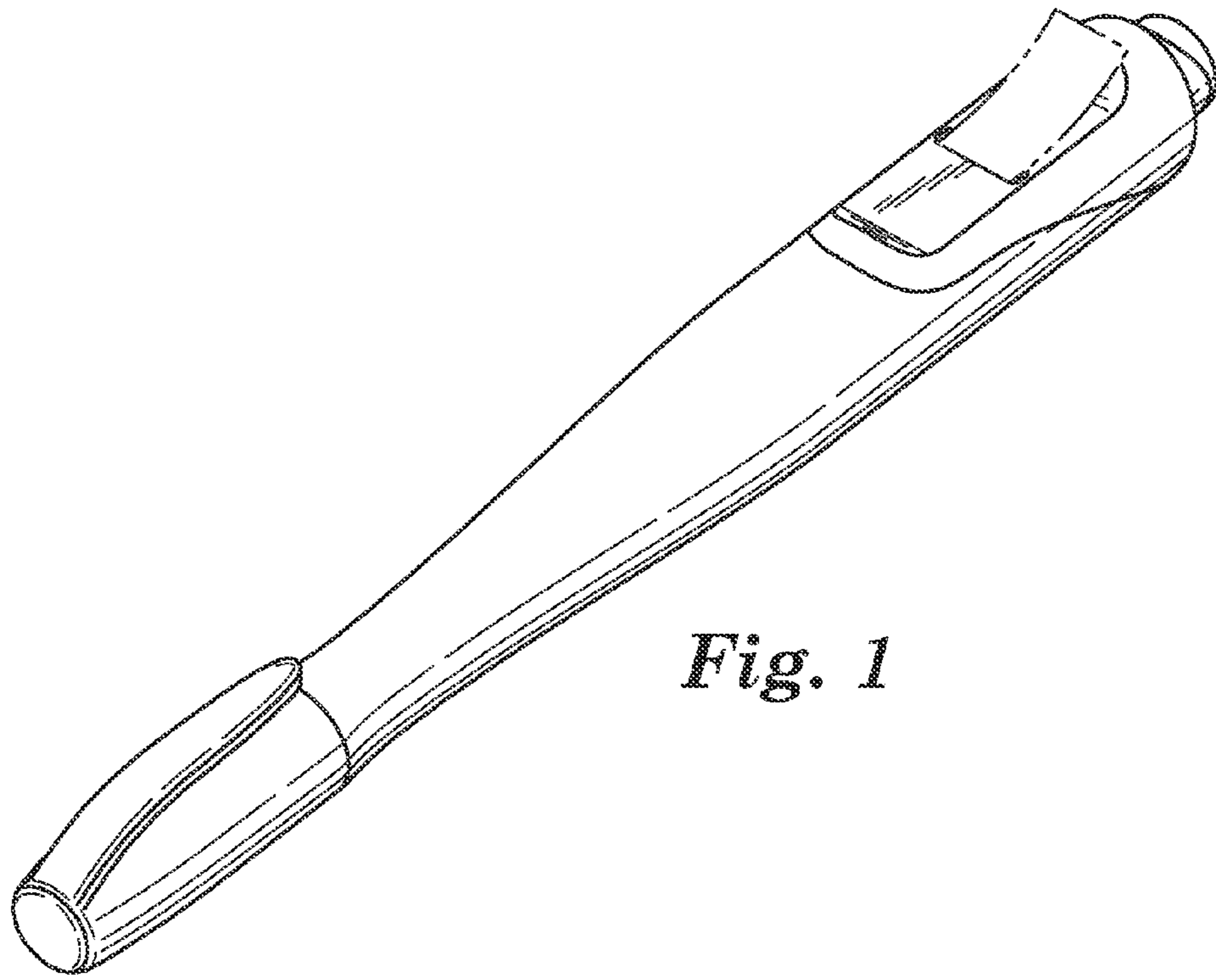
FIG. 5 is a rear view thereof; and,

FIG. 6 is a front view thereof.

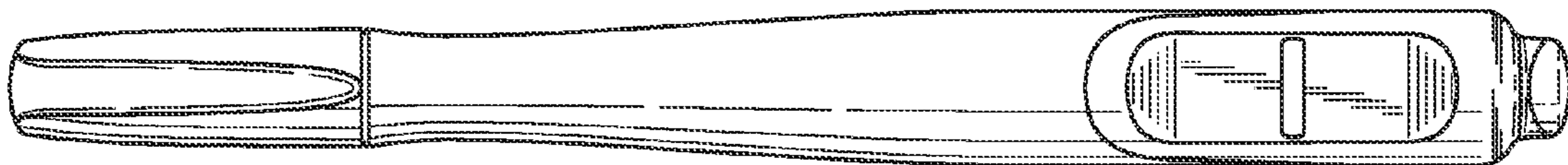
The broken line showing of a sheet in FIG. 1 is included for environmental purposes only and forms no part of the claimed design.

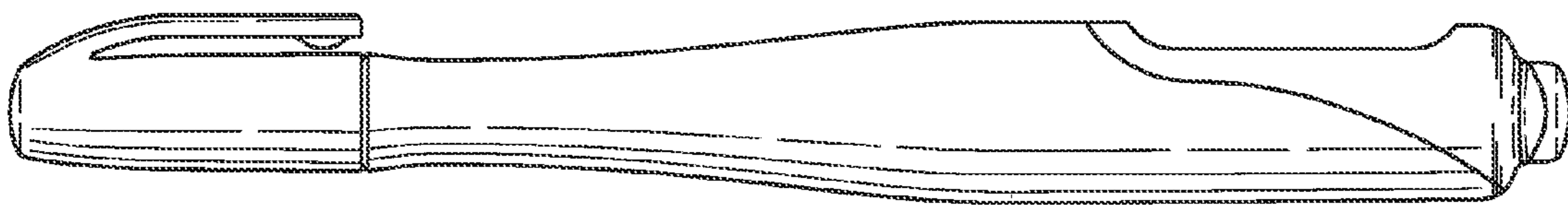




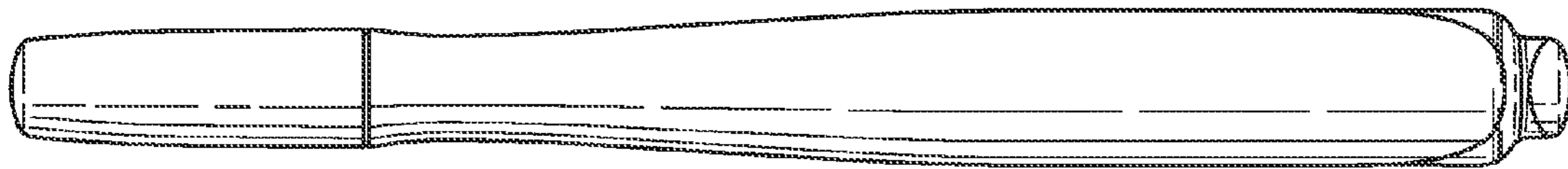

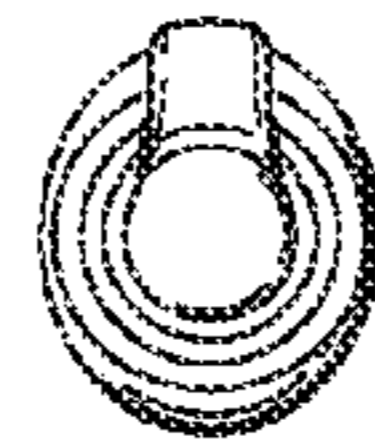
