(57) **CLAIM**

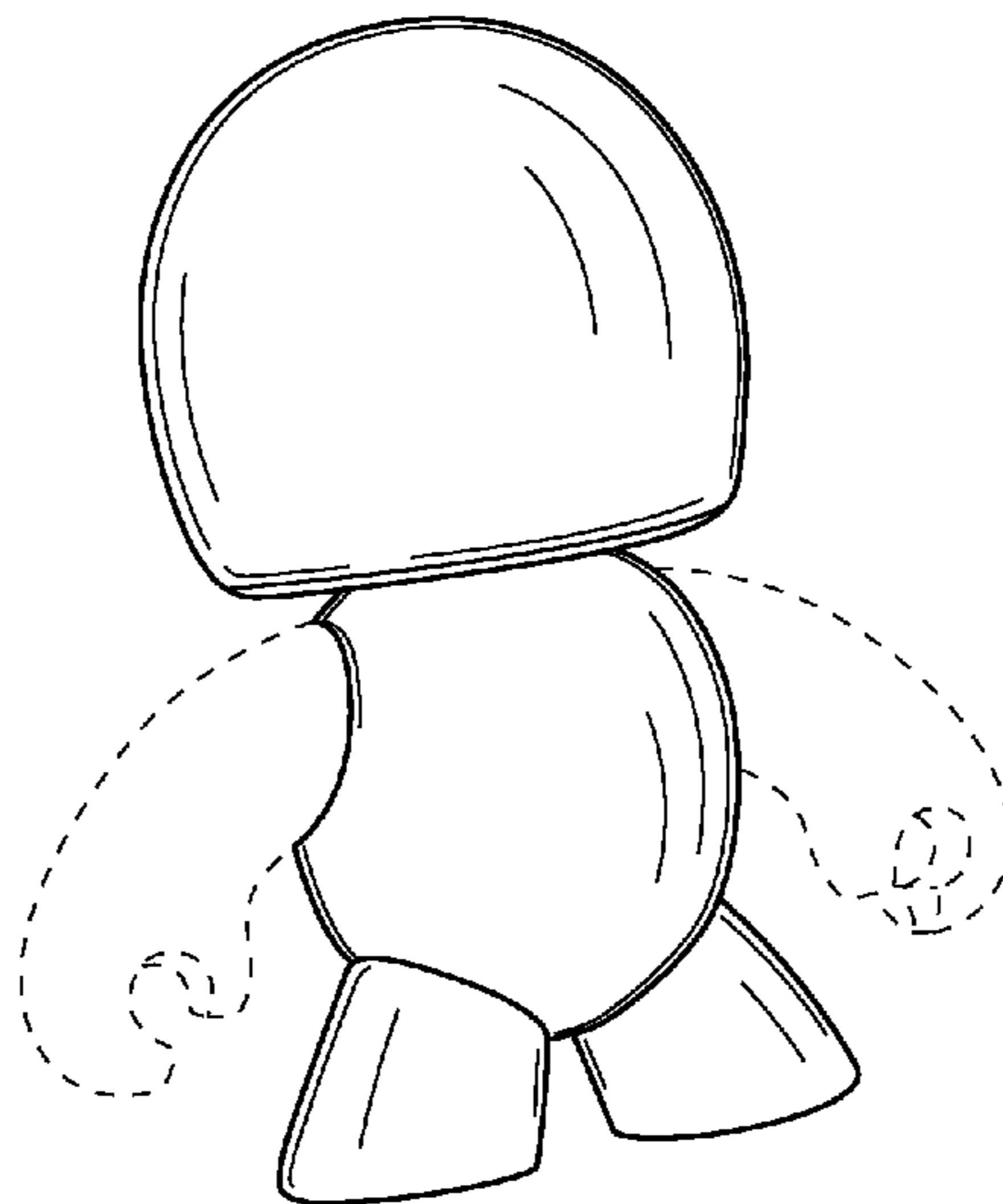
The ornamental design for a doll, as shown and described.

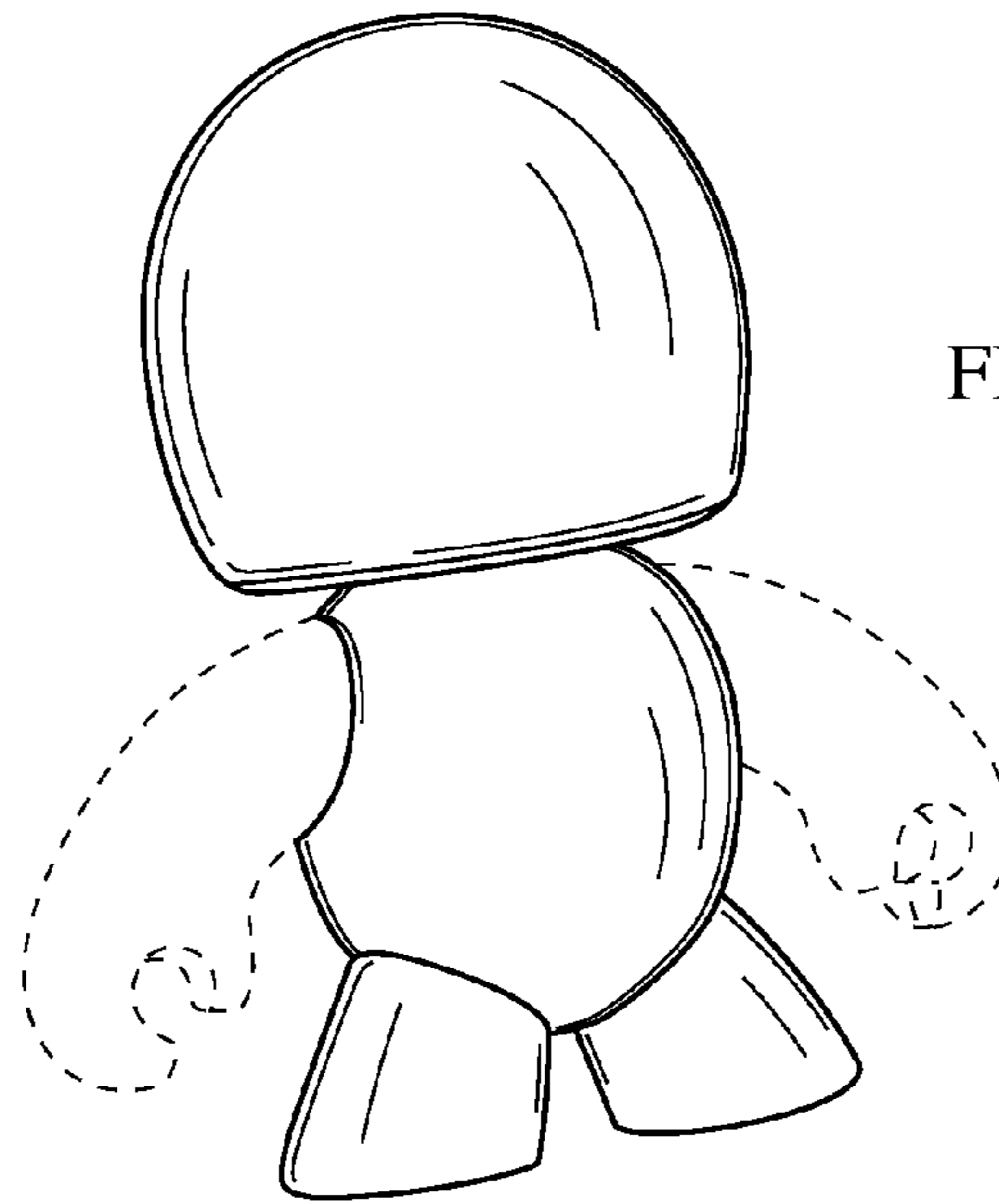

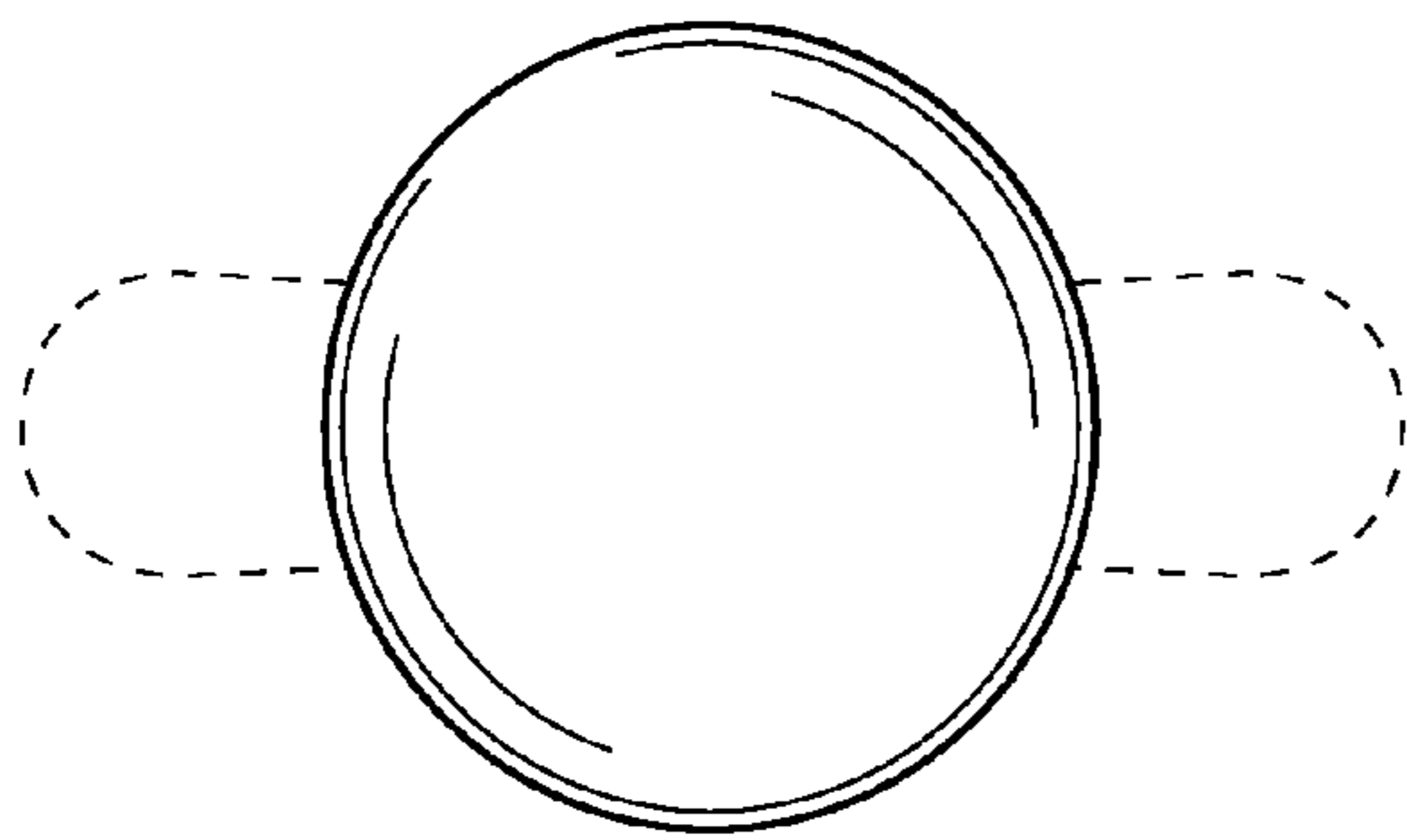

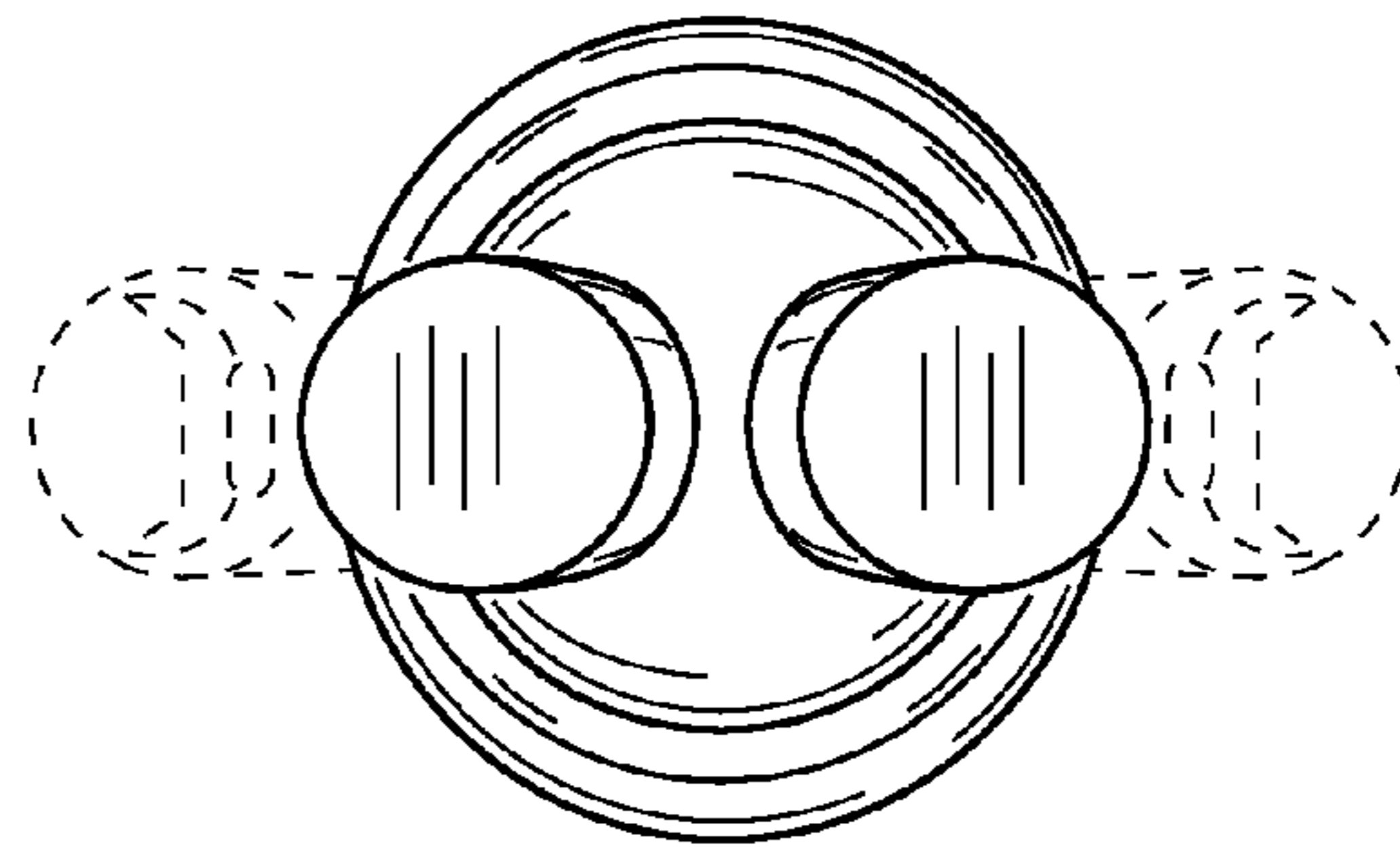

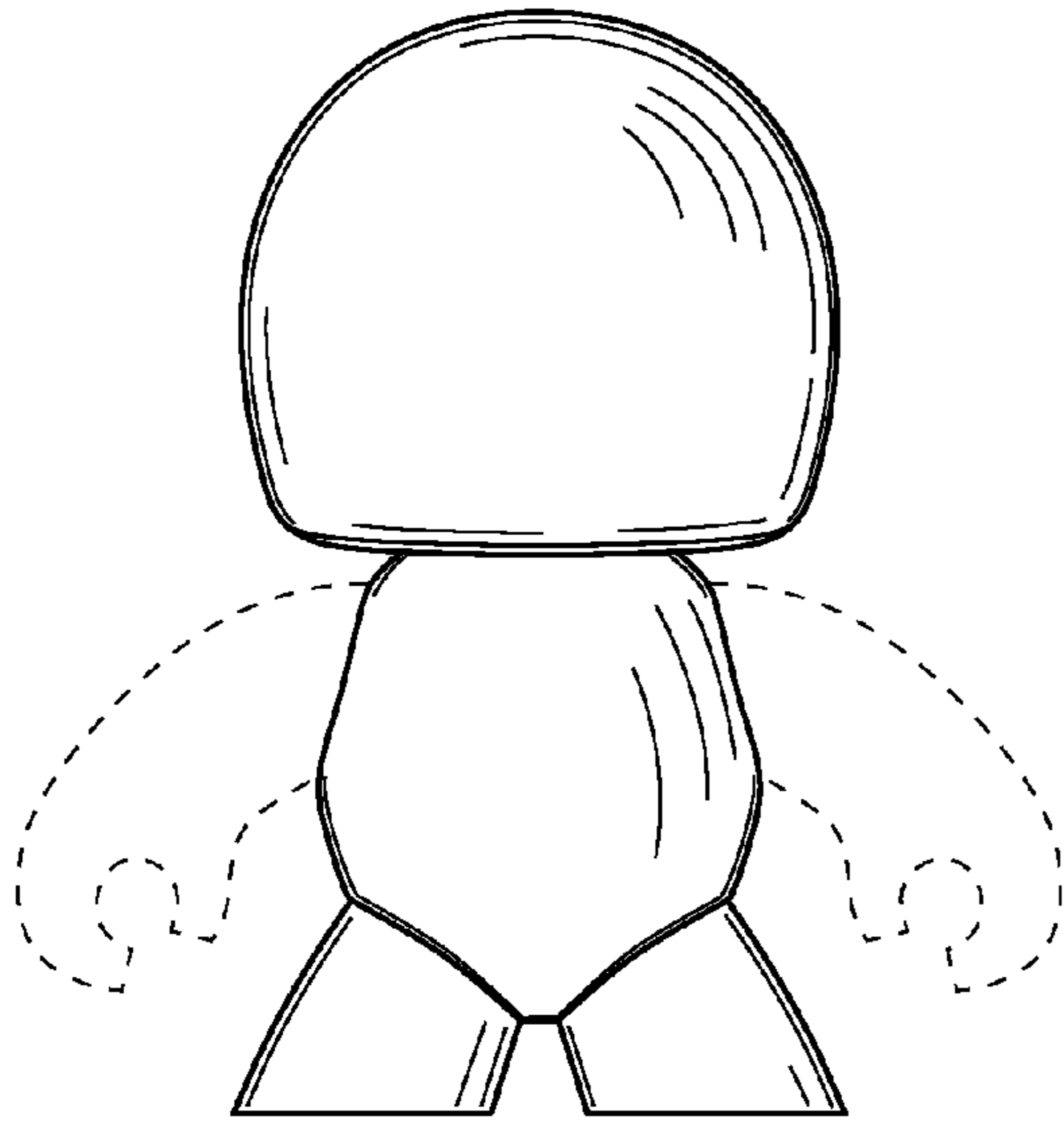

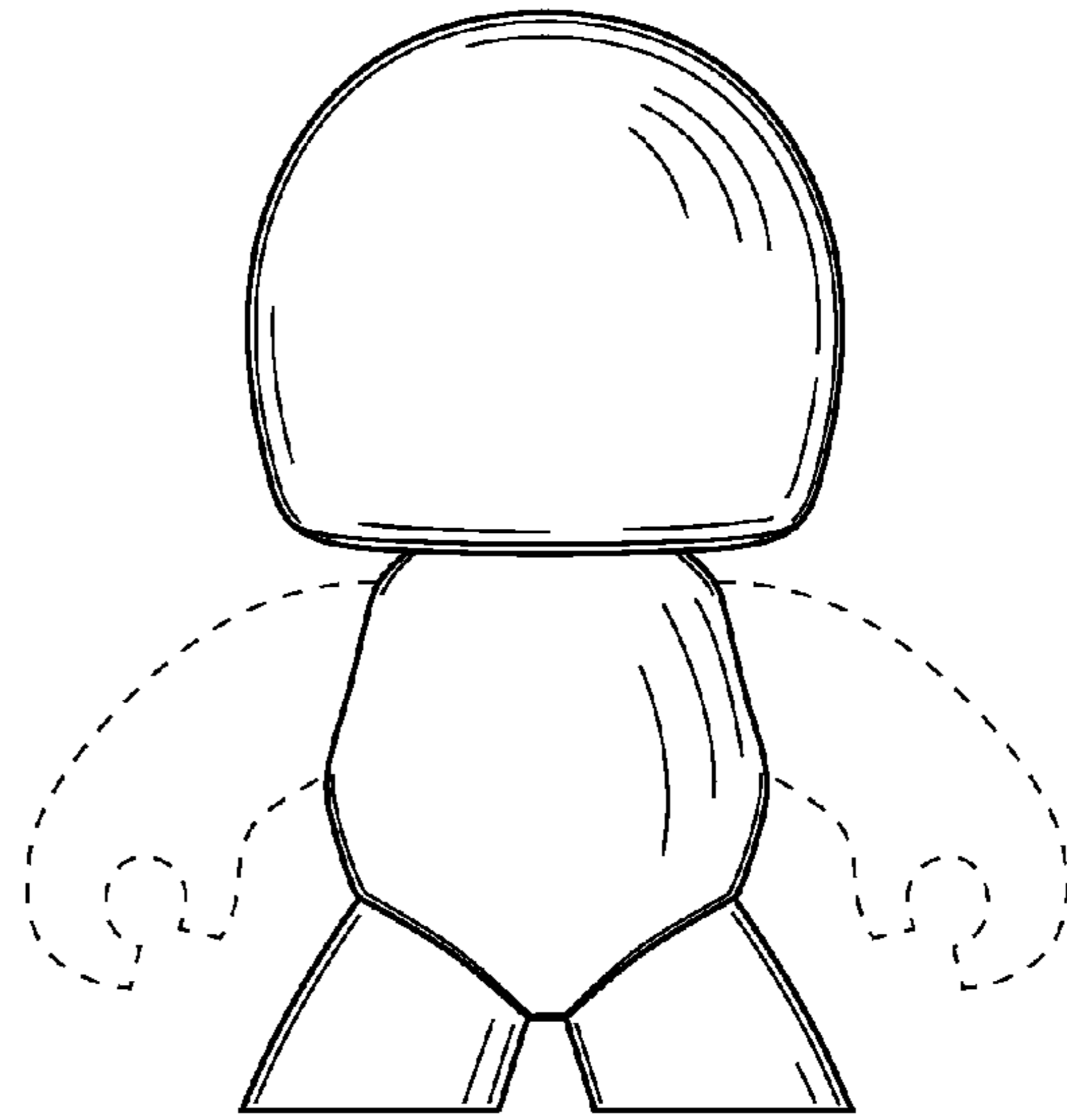

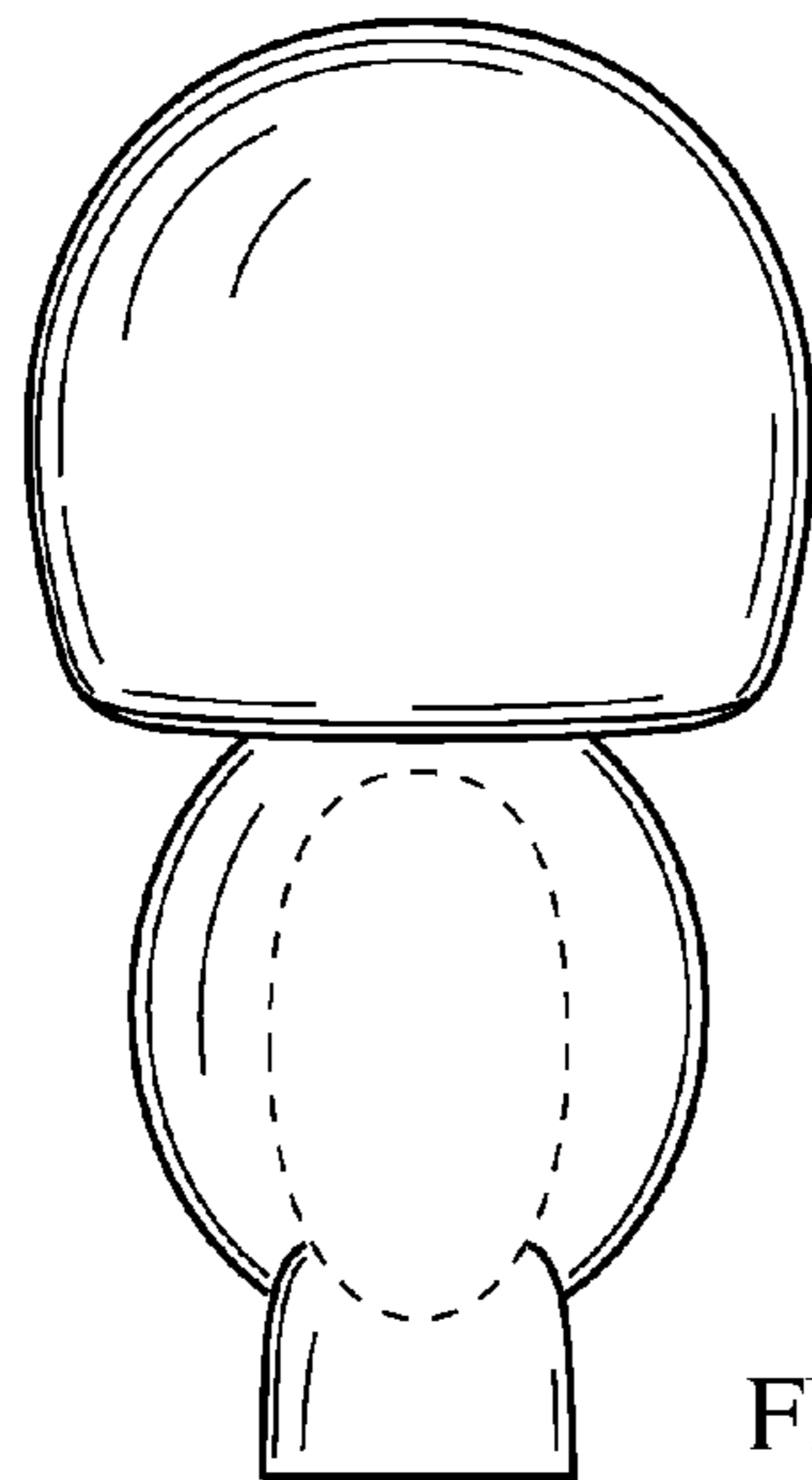

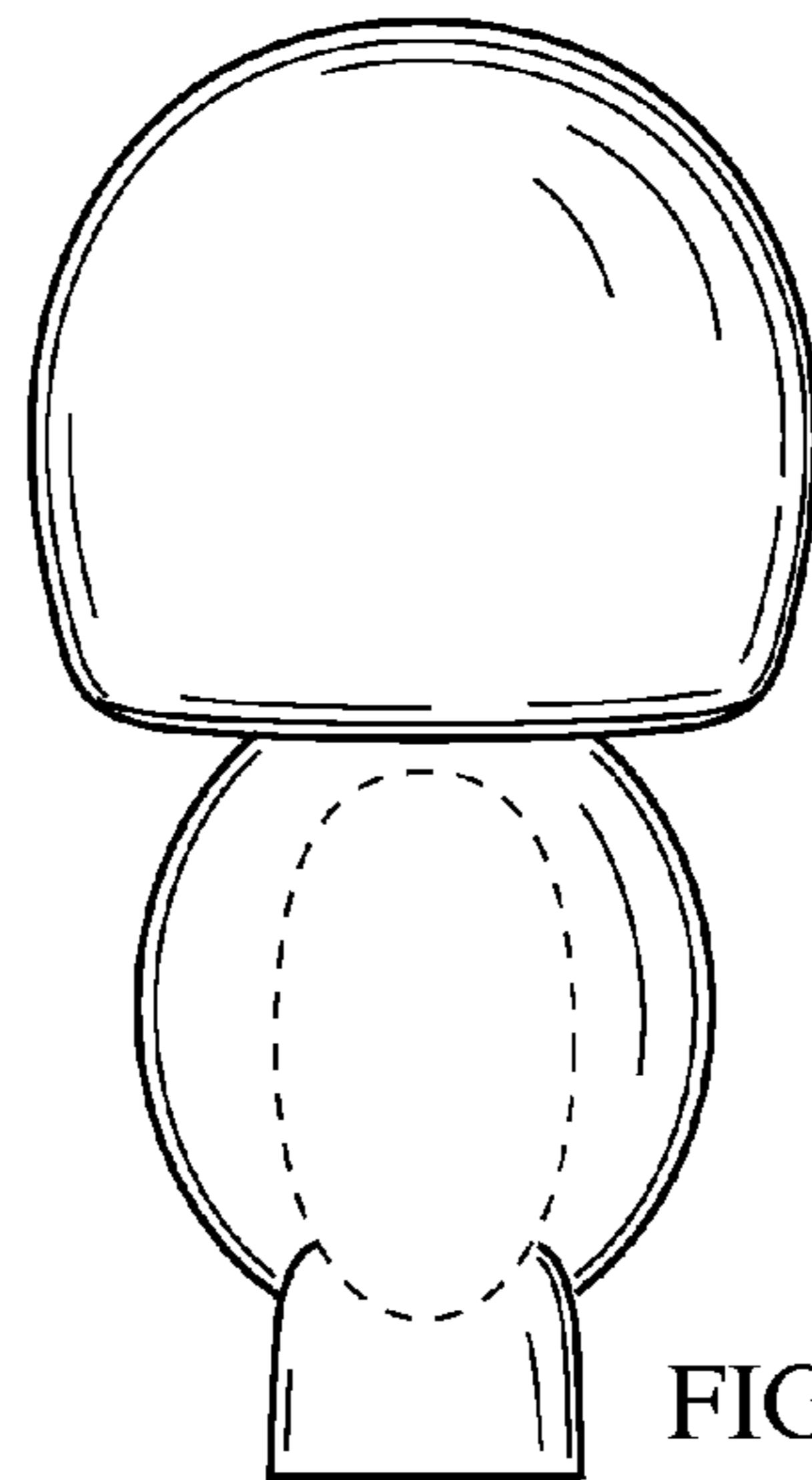
